ADDRESS

Delivered by Dr. M. Blumenthal, President of the Sabbath Observance Association, before the Congregation Zichron Ephraim, East 87th Street May 10, 1900.

Ladies and Gentlemen, Friends, Israelites:—It is with especial pleasure that, as President of the Sabbath Observance Association, and its name, I bid you welcome in this building, consecrated to the service of God and the expounding of His sacred Law.

There is no place so fit for our association to appear in its work recalling the recalcitrant and those forgetful of their most sacred duties than the temples dedicated to the same holy purpose. And it is due to the recognition and appreciation of this fundamental principle by the worthy authorities of this congregation and its learned and pious Rabbi, that we have the privilege of meeting you here.

Let us make good use of the opportunity for the advancement of our cause.

Permit me then to say, that it is only three months since the first step was taken in organizing this Association, to be composed of men who sanctify the seventh day Sabbath by abstaining from their every day pursuits and dedicating it to the service of God and the contemplation of His works.

As the expression of the object of the Association and in order to explain it to the public, and thus give the reasons that make it necessary, the following "Declaration" was adopted, presenting in the most concise and emphatic words, the

motives that underlie the action, and most assuredly, justify it.

DECLARATION.

Adopted Feb. 11, 1900—Adar 13 5660.

"The prevailing public desecration of our holy Sabbath, has become such a crying evil, and the neglect of its observance is proving so deplorably destructive of that religious family life and domestic happiness once proverbial and characteristic, that it has become a sacred duty to make again an effort of stem the tide that is leading our people to destruction, notwithstanding their material prosperity!

To many of us, who are yet inspired by love for our Holy Religion and patriotic

there is necessity for such an association; that so many of the house of Israel should be forgetful of their first and highest duty—obedience to God's Law, and oblivious of the glorious mission confided to them, to be the missionaries of eternal verities to other nations and races.

Sad to think that now, after the lapse of nearly 19 centuries, weary, dreadful ages of persecution, misery and injustice; of horrors and degradation unspeakable, endured as a punishment for individual and national sins, chiefly those of forsaking God's law and practicing shameless idolatry—we should not yet have learned the lesson so painfully taught—but now, again fall back into the old sins of God forget-

and happiness they possess, in short, for Life and all it means—forgetful of their duty to society, to their own families and to themselves—rush onward to the goal, Death, that awaits them with untailing certainty, without halting at least once a week on the day consecrated to thankfulness to God, and calm, rational reflection and self-examination.

A very demon-spirit of unrest and ambition seems to drive on our rich and prosperous ones to accumulate greater and ever greater wealth, heedless of the bad example they are giving, regardless of their drawing the young and dependent into the whirlpool after them; into the maelstrom of religious indifference and

the well recognized fact, that the enforced and continued violence to their honest conviction, repeated Sabbath after Sabbath, tends gradually to deaden the very sense of sinfulness and remorse in their young and impressible natures, and for such results the irreligious and conscienceless employer is responsible!

Only think of it! On one Shabbas the boy is Bar Mitzvah. He avows himself in all sincerity and solemnity, often sanctified by the tears and blessing of his parents, a believer in the divine law of Moses, promising to live up to its requirements and commands, and on the very next Sabbath he is probably in the employ of a coreligionist, either up or down town, flagrantly and shamelessly desecrating it, under the tutelage of a derelict Yehudi!

Fathers, mothers, wives, sons and daughters! Is it possible that such a condition, so saddening and humiliating, is to continue? Can we calmly and unmoved look on and see the very foundations of religion and of healthy social conditions thus undermined?

Shall we wait indifferently until the old-time family love, and adherence to the greatest treasure of the world entrusted to us, have fallen into decadence, or is it not our duty to unite in forming a strong body of the faithful who will stand together boldly and staunchly in defense of our Holy Sabbath?

Who will not alone themselves dedicate the Sabbath to God—Kadosh L'Adonai—but will labor to induce all self-respecting Yehudim to join us. Let fathers, husbands and sons refrain from following their week-day avocations, but with their families go to the house of God to offer up thanks of grateful hearts—in place of sacrifice.

And let our mothers, wives, sisters and daughters consecrate anew the home every Sabbath eve and day.

Illuminate as on a feast your rooms, be they elegant or humble; honor the day by a spirit of religion; make it the happiest day of the week, free from cares and sorrows, devoted to holier and elevating thoughts and ideals, and as the Angel of Love and Peace hovers over the entire household, sweetening the very surrounding atmosphere, you will indeed feel that God has helped your home!

What else is this prevalent disregard of our Sabbath to be ascribed to, but the mad race for wealth, for material prosperity, and gratification of animal passions conjoined with loss of faith, a lack of trust in our Merciful Father—the unworthy fear that the Beneficent Creator cannot or will not provide for those who honor Him and obey His laws?

Mercifully as He sustains even the sinner (through His enduring forbearance, allowing him to prosper for a time) our trustless brethren, forgetting the debt of gratitude they owe, for every breath they take, for every morsel they eat, for every good

abnegation, where so many, once hopeful and happy, have been wrecked upon the cliffs of infidelity and skepticism.

Yes, it is mortifying fact that large and wealthy employers, by desecrating the holy Sabbath themselves, not alone have themselves to answer for, but likewise for tempting all their employees, nay, practically compelling them, under penalty of dismissal, to violate the Fourth Commandment.

You need not be told what an unfair advantage is thus taken of the helpless and young! How many of these wanting in that entire-trust in God, which they should have, fall into the tempter's snare with sorrowful and aching hearts.

The Beth Israel Hospital is the only hospital in the lower east side supported by private contributions. It is located where most needed and in the most densely populated district in the world.

The demands upon it since its establishment in 1890 have been ever increasing; so much so that more modern and commodious quarters must now be provided.

With the aid of the generous public this result will be accomplished.

Even in its present inadequate building at 206 E. Broadway, with accommodations for only 28 beds, and insufficient dispensary facilities, there were received during the year ending September 30, 1899, 501 patients, whose average stay was 20 days.

In the dispensary during the same period 37,000 prescriptions were given to 20,000 patients.

The proposed new building with its modern equipments will, when completed, accommodate about 100 patients, and have ample and modern dispensary facilities and will in a measure meet the great demands of the locality.

The hospital has been and will be non-sectarian.

It is with deep regret that the Hebrew Standard announces the death of Liberman Libman, who died at his home, No. 56 East 92d street, on Tuesday the 15th.

As a philanthropist, Mr. Libman was known throughout the States of the Union, and was often praised in the daily papers of the different States for his charitable doings. Among the poorer classes of the East Side of this city, where Mr. Libman distributed most of his charity, he was commonly known as "Our Good Libman."

Educational Alliance.

From the seventh annual report of the Educational Alliance we glean the following:

The receipts were \$34,961.19, and total expenses \$39,320.16. The budget for the year ending June 30th next provides for gross appropriations \$43,462, exclusive of the work turned over by the Hebrew Free School Society.

The membership at the end of the last fiscal year of the institution was 1,218, as against 1,207 for the corresponding day of the preceding year. The roof garden was opened to the public from June 24 to September 10, 1899, and the total attendance was 227,647, making an average daily attendance of 3,488. The report contains a review of the various educational, social and religious departments of the Alliance as well as some other fields of its labors.

In the course of the year the organization undertook the establishment of a legal aid bureau.

Altogether the work at the Alliance has been eminently satisfactory to the Jewish public.

Hebrew Orphan Asylum.

The Betty Brühl Memorial day, the annual fête day of the Hebrew Orphan Asylum, which takes place next Sunday, May 27, will have in store many pleasant surprises for the children of the institution. 
