RABBINICAL SCHOLARSHIP

V.

Come now and, in a fair and impartial spirit, let us reason together:

"The Rabbis of America developed reform to its present state," say you. They who ministered to the spiritual needs of the American congregations in the leading cities were, without doubt, men of scholarship and mental ability. Some are said to have come to these shores because their mental powers were restricted by certain set and defined theological opinions to which they had to conform all their thinking processes. Others felt hampered by the lack of freedom of speech and the general censorship exercised over speech and writings which prevailed in Europe. Men of that stamp are not adventurers. Their rebellion against unnatural limitations of thought and speech mark them as of high calibre. They were therefore earnest and sincere in their desire to work out the destiny of reform Judaism upon these shores. They encountered opposition. In the main, however, the individu-

als of congregations were likely to reform themselves and the scholar rabbis simply applied these liberal souls with ammunition for argument against their more conservative brethren.

To make this point clear, let us say that the Rabbis did not originate reform on this continent, but the people did. All that the Rabbis had to do, was to outline a system based on theory, sanctioning the negative stand which many individuals took, with reference to the forms and ceremonies hitherto observed as religious essentials.

Many of our people who emigrated from some small city in Europe were bound down to orthodox observances by public opinion, by the fear of excommunication, or of being branded as heretics, or being disowned by kith and kin. The form of government in Europe and the mode of regulating contributions to churches by a system of taxation made every Jew a good citizen and some Jews orthodox in action and non-believers in thought.

The unwanted freedom which the immigrants enjoyed upon their arrival and subsequently, led many a one to become a scoffer or simply a non-observer of that which he had been in the habit of associating intimately with his idea of religion. He began by discarding one form and ended by shaking himself free from all obligations to perform his *devoir* in the matter of daily prayer with the accompaniment of the *T'phillin*. The dietary laws were no longer sacred institutions and he enjoyed violating them.

The same phenomenon is to be daily observed among our newcomers from Russia, Roumania and Hungaria. The air of liberty intoxicates them and in a frenzy of freedom many of them become skeptics of the worst kind, really religious nihilists. Who would have thought: it possible that the men coming from the very hot-beds of orthodoxy would tolerate such Sabbath breaking as any stroller through Grand Street on a Saturday can witness? The peddlers, vendors, store-keepers and buyers all would have been shocked in their native land to have countenanced such wholesale evidences of irreligion in their midst, aye, might even have taken part in the stoning of the miscreants, the horrible *Po'sh'ai Yisroel*. And yet here they are, a short time after landing on these inviting shores, transgressing the laws which they were taught from infancy to hold sacred and to die for. And as one *Averah* leads to another, so one form or ceremony violated or unobserved gradually means the shaking and uprooting of the whole system of customs established in the *Shulchan Aruch*.

Pray, what Rabbi taught these people reform? What reform preacher inoculated them with the poison which some people claim the Rabbis are so lavish in dispensing? Has Dr. So and So had such great influence in changing the laws of these people so suddenly? Did Rev. Peloni instill the noxious fluid into their circulatory systems? Or did the great rabbi-scholars who preached thirty or fifty years ago

teach them that the essentials of religion are one thing and observances another? What great ethical culturist has been inspiring them with the belief that reading and writing, spelling and arithmetic, making a livelihood and not begrudgingly dependence and mere study of the law, constitute education in the highest sense?

Then, forsooth, the circumstances have not changed much in these many years. For human nature was the same a half century ago as it is to day. And the peddlers who roamed through the towns and villages of the various States of this country, with a pack on their shoulders had to encounter well nigh insurmountable difficulties in the observance of the dietary laws and in many other respects. Did they consult a reform rabbi before eating their first piece of forbidden meat? The first morning they could not, or dared not, lay their *T'phillin* was a memorable one and oftentimes proved a crisis in their spiritual lives. God did not strike them down with His thunderbolts, and the teachings of their childhood days were proven false.

What followed from these experiences is easily seen by the numbers of Jews who have lived in New York City without identifying themselves with any synagogue, though every shade of belief is represented there, by the numbers of Jews who for years seemed to be co-religionists only in name, by the numbers of Jews who have been and are ready to dance attendance upon any propagandist like Ingersoll, Adler or Dixon, by the numbers of Jews who are ready to decry Judaism as a misfortune as Heine once did?

Did the reform rabbis bring this about? They are wrong who claim it for them either as a merit or demerit. To their credit be it said that by their liberal attitude, they encouraged men in the belief that even non orthodoxy did not interfere with Jews remaining Jews. We think that the great work of a man like Wise consisted in this. He brought within the fold all those people who, owing to their adverse surroundings, thought themselves outside the pale of Judaism, being unable to practice the minutæ of the law and the code. The services rendered by the reform rabbis was rather of the nature of legalizing, as it were, non conformity with what was thought absolutely necessary. They in this wise reclaimed those who thought themselves lost to the body of Jews and issued a warrant for their retention within the lines of all who seemingly had strayed away.

And many a good soul was made happier for it, many clung to their faith though they could attend neither service nor worship, hear no Hebrew prayer and have no teacher for their children.

The reform rendered thus no inconsiderable service to the cause of Judaism in this country. They thus lent their sanction to and took under their especial wing of protection the large body of non-conformists. They of course supported their standpoint with arguments. And here scholarship was needed to find justification for this most liberal aspect of Judaism.

The theology of the opposite camp had to be met and a new theology developed along tolerant lines. The old sources amply vindicated them; abundant proofs were found to justify them in their noble endeavors to reclaim the numberless "lost, strayed or stolen."

Not enough credit has been given the reform rabbis for their work in this direction. And the results of their tolerance have been seen in the countless temples erected in small cities where the Jewish population might easily have lost itself and its characteristics in the despair of being considered non-Jews. Wise's weekly papers and himself seemed to penetrate every nook and corner of the broad West. He kept one or two or three or more Jewish families of the small towns in touch with Jewish affairs at the large centers of commercial activity. The Bloch Publishing Company became the authorized source of publications Jewish, and their printed matter reached every household and was widely disseminated. All these influences had, as we have been trying to show, the one effect of making reform Jews out of those who did not or could not observe their religion in the manner they were taught in Europe to keep it.

The harvesting period came. For as soon as a *Minyan* was formed, services were held in these neglected communities. And as soon as they possibly could, they built a synagogue and engaged a Rabbi, who preached, conducted services, organized Sabbath Schools and labored for the spiritual welfare of his communicants.

Had reform not countenanced or condoned lapses in religious observances, all this might not have been. Strict orthodoxy did not dare do what reform easily could do.

The *Al Moghreb Al Akhsa* of Tangier states: "Mulsi Arafah, the Sultan's Khalifa at Fez, and the two Governors of that capital, on the 9th of August, had a meeting with the Rabbins at the Viceroy's palace. Kaid Abdesadak accused the Jews, particularly protected and foreign Jews residing at Fez, of being boldly disrespectful to the Moers, and of ignoring the old submissive practices, such as visiting barefooted the Mohammedan quarters, while now they were not only riding through the city, but also making unnecessary show of firearms. Kaid Abdesadak stated that if this state of affairs were not discontinued he would report it to the Sultan. The reply of the Chief Rabbi was that there might have been one or two cases of foreign Jews using arms and even observing imprudent conduct, but as a general rule the Jews residing in Fez continued to be submissive to the authorities, and, without showing uncalculated humility, they were highly respectful to all Mohammedans, their institutions and ruler. This was testified to by the Rabbins with reliable proofs, and even Mohammedan evidence bearing on the matter was adduced. Kaid Abdesadak withdrew his complaint, and thus the meeting was brought to a close to the satisfaction of all present.

TWO NOBLE JEWS.

Two Barons de Rothschild have died recently—one in England and one in France, and each left a will not only eccentric, but overwhelming in its generosity.

The French baron, Adolphe de Rothschild, leaves 60,000 francs a year to the commune of Boulogne, to keep up as a public park the Rothschild farm, should the Rothschild family ever give it up. The other legacies in money amount to £800,000. All his precious curios in ivory, etc., miniatures, paintings and snuff boxes go to the Louvre, as well as his Damascus weapons and arms. Twenty thousand pounds goes to the creation of a sort of "Queen Anne's fund," but is to be used to help poor Roman Catholic priests, Protestant pastors and rabbis. The testator puts in a special remark that he hopes that this act of toleration will find many imitators.

Twenty thousand pounds is left to the Prefect of the Seine for the poverty-stricken inhabitants of Paris; £6,000 to the Society for the Protection of Animals, who are asked to use it so far as possible in preventing broken-down horses being laden beyond their strength; £14,000 to the charity bureau of Paris; £16,000 to found a grand hospital for eye diseases, similar to one he had founded some years ago at Geneva, only on a much larger scale.

Never were directions given more clearly as to the way in which every legacy should be given. Sixteen hundred francs a year are to be given to 40 poor working girls; £10,000 to the Temperance Society; £6,000 to the poor children of Boulogne, and various generous legacies to hospitals.

One of the strange orders in the baron's will is that £92 a year is to be devoted to each horse in his stable as long as it lives, with interdiction to kill any, unless it should be suffering from pain that would make its death merciful. Four thousand pounds a year to the old couples who are in the asylums of Les Petits Menager, and a hundred pounds a year to another asylum.

The strange part of the baron's will is that though he was distinctly a Jew in his religion, very little money is left exclusively to Jewish charities.

Finally, he ends his will by a clause in which he begs his executors to bury him as early in the morning as possible, so that his funeral be not a cause of public inconvenience.

Baron Adolphe has made a will by which many institutions and many individuals will be helped and blessed, but he did not wait till people should be benefited by his death. His life was one of constant charity, and hundreds of thousands of pounds were given away every year, so that in spite of his legacies, he will be missed and mourned for by those whom he aided in life.—H. J. S., in *Detroit (Mich.) Tribune*.

that section eighteen of article three of the Constitution be amended to read as follows: § 18. The Legislature shall not pass a private or local bill in any of the following cases: Changing the name of any person. Laying out, opening, altering, working or discontinuing roads, highways or alleys, or for draining or otherwise improving land. Locating or changing county seats. Providing for changes of venue in civil or criminal cases. Incorporating villages. Providing for election of members of boards of supervisors. Selecting, drawing, summoning or empowering grand or petit jurors. Regulating the bank of interest on money. The opening and conducting of elections or designating places of voting. Creating, increasing or decreasing fees, percentage or allowances of public officers, during the term for which said officers are elected or appointed. Granting to any private corporation, association or individual the right to lay down railroad tracks. Granting to any private corporation, association or individual any exclusive privilege, immunity or franchise whatsoever. Granting an exemption from taxation on real or personal property. Granting for building bridges, and chartering companies for such purposes, except on the Hudson River below Waterford, and on the East River, any construction forming a part of the boundaries of the State.

The Legislature shall pass general laws providing for the assessment of this section, and for all other cases which in its judgment may be provided for by general laws. But no law shall authorize the construction or operation of a street railroad except upon the condition that the consent of the owners of one-half in value of the property bordering on and the consent of the local authorities having the control of that portion of a street or highway upon which it is proposed to be constructed, and the consent of such property owners cannot be obtained, the Appellate Division of the Supreme Court, in a department in which it is proposed to be constructed, may, upon application, appoint three commissioners, who shall hold a public hearing of all parties interested, whether such railroad ought to be constructed or operated, and shall determine and certify to the court, to be held in lieu of the consent of the property owners.
