LIGHT ON ANCIENT PEOPLE.

Chronicles of days long before those of Abraham have been unearthed from the desert sands of Mesopotamia.

Dr. Herman V. Hilprecht, curator of the Babylonian section of the University of Pennsylvania Museum, returned recently from Asia Minor, and told of the discovery of the library of the Temple of Baal at Nippur, of which the Bible has told. In its records of a civilization dating back to the time when Adam and Eve were supposed to have lived in the Garden of Eden, of which the world before had not had certain knowledge. Dr. Hilprecht regards this discovery as perhaps the most important archaeological work of the nineteenth century.

Dr. Hilprecht arrived in New York lately on the Kaiser Wilhelm der Grosse, after a year's absence from America, bringing photographs and relics showing the nature of his discoveries. He came to Philadelphia in the afternoon.

Speaking of the discovery of the Temple of Baal or Bel library, he said: "Hitherto we have possessed nothing more than the knowledge of the probable contents of such a library, from copies found in the Royal Library of Ashurbanipal of Nineveh, which was discovered sixty years ago. This Royal Library, however, was a compilation of documents gathered from all over Babylonia, so far as was at that time known.

"The library of clay tablets unearthed this year at Nippur contains writings not only in the characters used 2,200 years before the Christian era, which were the very latest in the collection, but the majority were in cuneiform characters peculiar to the more ancient writings. They cover every branch of the literature of that early period long before the day of Abraham, and tell of a civilization of which no word has come down to us."

He explained that Nippur before 2200 B. C. was the capital of Northern Babylonia, but it was then sacked by the Elamites, and Babylon arose as the chief city of Babylonia.

"Only one wing of the library has been excavated," he continued, "and almost 18,000 documents have been rescued from the ruins this year. They were made of unbaked clay, and therefore suffered considerably by the collapse of the building, and by the humidity of the ground. We have all the fragments, however. They are now on the way from Bassora to Constantinople, where they will arrive in the course of six months.

"Among the valuable documents are lists of words written in two languages—Sumerian and Babylonian—grammatical exercises, chronological lists, hymns, written in terms closely approaching the Old Testament, psalms, proverbs, astronomical and astrological texts, tablets giving an inventory of the Temple, the different gods worshipped, and the income of the temple.

"All these are invaluable contributions to our knowledge of the ancient world, and they will considerably increase our knowledge of the two most ancient languages of the human race.

"They will largely affect our knowledge of the life, the religion, and the arts of the Hebrews, whose earliest roots are bound up with the history of Babylonia. The library of the Temple of Nippur was

lost to human knowledge about the time that Abraham went out of Ur into Palestine, and it gives us a clear historical setting for that important event. We will be able to tell what is purely Babylonian and what is purely Hebrew.

"Through other discoveries we have made, my former discoveries and researches about the time of Ezra and Gehemiah have received a new impulse by reason of tablets we found, together with some two hundred boles. The arguments are conclusive that the large mass of Jewish exiles transported by Nebuchadnezzar after the destruction of Jerusalem were settled at Nippur and alongside the canals in the neighborhood.

Nippur, Dr. Hilprecht said, is seventy miles south of Bagdad, and almost east of the Afzei swamps, inhabited by trouble some Bedouins. The ruins form a large mound, rising 100 to 200 feet above the desert, irregular in shape. A person can walk around this mound in an hour and a quarter. A stream divides it into two parts.

On the eastern side is the temple of Baal, with the residences of the priests and the temple library. On the western side the people lived. Excavations have been carried on by about four hundred native workmen, superintended in gangs by experienced archaeologists.

An interesting find was the great eastern gate of Nippur, which dates from the fifth millennium B. C. The system of fortification of that period was revealed, and at the foot of the walls were found weapons used by the inhabitants. Baked clay balls were used as missiles.

While digging for walls Dr. Hilprecht came across a great building entirely below the desert. It was more than six hundred feet long on the front, and at least two stories high. On the top of it were ninety feet of rubbish. From indications and objects found, including children's play things, Dr. Hilprecht believes this building could not have been erected later than 4,000 B. C. He regards this discovery as the chief result of the expedition.

In the western centre of the southern mound of the temple he found the great library of tablets arranged in shelves of unbaked clay.

They contained grammatical sentences written half a dozen times, as by a pupil practicing with them. Then there were lists of names and tablets on kings, following one another, and telling what the king did each year. There were astronomical, astrological and mythological tablets.

Thousands of tombs were excavated and examined. Most of these were of 500 to 600 B. C. There were others as far back 2,000 B. C. One tomb, Dr. Hilprecht is certain, belonged to the fifth millennium B. C. It was found far below the lowest trench of the temple. The burial was long before the days of Solomon. Many objects of gold and silver were found in connection with it.

Anti-Semites' Row at Autenil Races.
Last Saturday a lively incident took place at the Autenil races at Paris over the entry in the military steeplechase of the Hebrew Captain Coblentz, whose treatment recently by brother officers at the military school in Fontainebleau led to severe disciplinary measures on the part of General Andre, Minister of War.

The anti-Semites had announced that they would make trouble if Captain Coblentz insisted upon riding, and the police had taken precautions.

Captain Coblentz mounted upon his horse Eastern Star, was greeted with insulting cries immediately upon entering the track. He promptly took out a visiting card and asked if there was any one present who wished to exchange with him. No reply was forthcoming.

Captain Coblentz rode in the race but was not placed. When he returned to the paddock hostile cries were again raised. His friends retorted with shouts of "Vive la Republique!" and "A bas les Clericals!"

Several scuffles followed, but the police quelled the disorder. A nationalist municipal councillor and a Hebrew who exchanged blows were arrested but were afterward released.

Latest Echo of the Dreyfus Affair.

Captain Coblentz, who is an artillery officer, was recently transferred to the Fontainebleau Ecole d'Application from a northern garrison. Upon arriving at Fontainebleau he left cards on his comrades, but his calls were not returned, and one officer, Major Duval de Granville, undertook to express to the Minister of War the feelings of other officers, who had decided to adopt toward Captain Coblentz, because he is a Hebrew, an attitude calculated to make his stay among them intolerable. In view of this General Andre punished Major Duval de Granville with fifteen days' imprisonment, in addition to sending him from the school to a regiment in the provinces. The Minister of War also sent six other officers back to their regiments.

The Paris correspondent of the London Times, commenting upon the incident at the time, said:

"There is no question of the Dreyfus affair involved. It is solely because of anti-Semitic passion, and a question of extreme importance arises. If French officers refuse to tolerate Hebrews in their ranks, the Hebrews can no longer be allowed to enter St. Cyr or the Polytechnique or the Ecole Centrale, since with rare exceptions, in the case of the Polytechnique, all the pupils of these three schools on leaving become infantry, cavalry or artillery officers. "On the other hand, there is no reason why private soldiers should be less fanatical than their officers, and why they should tolerate Israelite corporals and sergeants. The only possible conclusion, therefore, is that, in order to avoid a state of things so impossible in a country where military service is compulsory, all members of the Hebrew religion must henceforth be exempted from military service."

The topic was fully discussed, and the questions that were raised by different members of the audience were most satisfactorily answered by the lecturer. The meeting broke up at a late hour, the members declaring it to have been one of the most successful meetings the society has yet held.

The next regular meeting of the society will be held Sunday, Nov. 18, when the second lecture of the course will be delivered by Rev. Dr. Bernard Drachman on the topic, "The Ethics of Judaism." As usual, the lecture will be followed by discussion.

The Ladies' Fuel and Aid Society.

The circular, in connection with this society's coming affair on New Year's Eve, which is addressed to the charitably inclined of this town, we find the following part thereof most impressive: "In making this our annual appeal, we hardly believe it necessary to dwell upon the merit and amount of good the Ladies' Fuel and Aid Society has accomplished.

Montefiore Hebrew Society.

Last Sunday afternoon an enthusiastic gathering was assembled at Liberty Hall, Westchester avenue and 156th street, to witness the dedication exercises of the Montefiore Hebrew Society. The object of this organization is to establish a school in which the many children of that neighborhood will be offered the means of getting a knowledge of Hebrew, Jewish history and the principles of their religion.

Among those who addressed the audience were: Rev. Dr. H. P. Mendes, Messrs. J. Magnus, E. Edelstein and Freudenberg, and Mr. Nathan Wolf, of the Jewish Theological Seminary, who will be the principal of the school. The exercises were interspersed with excellent music, at the conclusion of which refreshments were served.

Young Men's Hebrew Association.

Friday evening will witness the inauguration for the first time in the history of the association of religious exercises for young men and friends of the association who desire to attend. Mr. Rudolph Coffee, of the Jewish Theological seminary, has been selected as leader, and will conduct the same every Friday evening. President Menkin will deliver the address of welcome.

Prominent ministers and laymen will be invited from time to time to deliver moral talks on these evenings.

During the month of October the attendance reached a total of 12,187, being an increase of 8,898 over the same time last year.

At the monthly board meeting, 126 active, 21 patrons, 130 associates, and 45 junior associates were elected to membership.

On Thursday evening, November 15, a gymnasium exhibition will be held in the building, at which time the all-round championship of 1900, will be decided. Admission will be by card only, owing to the limited seating capacity.

To-morrow night's illustrated lecture will be given by Mr. Gerhard J. Shilling, who will take as his subject, "Burmah."

The lovers of music on the east side have a treat in store for them which is to be provided by the directors of the Educational Alliance. Commencing with this Sunday evening, a series of Sunday night concerts will be inaugurated by an orchestra of twenty selected musicians under the direction of Mr. Franz Kaitenborn. On Tuesday evening there will also be inaugurated a series of entertainments which will be free, and will consist of varied programmes such as lectures, stereopticon views, amateur theatricals, etc.

When plants are grown in dry air, their stems and leaves have a more complicated structure than when the air is moist.

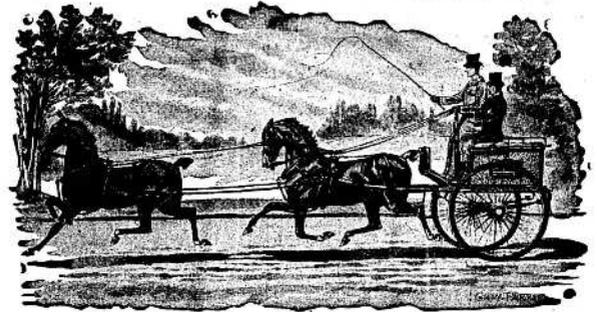

THINGS IN STORAGE.

FORTUNES LOCKED UP IN FIREPROOF BUILDINGS.

The First Big Warehouse Fire in New York and Its Tragic Consequences—The Moving of Family Belongings Reduced to a Science.

"Fireproof storage buildings in New York are of comparatively modern origin," said the proprietor of a large storage warehouse to a New York Mail and Express reporter. "The first storage house in the city which I can recollect was erected in 1867 by John H. Morrell at the corner of Fourth avenue and Thirty-second street, adjoining the stables of the Fourth avenue railway line. When Morrell's business had reached a flourishing condition, an immense fire destroyed the car stables and Morrell's establishment, ruining him financially. Immediately the public set up a great howl against storage houses, and the men who had followed Morrell into the business suffered severely.

"One Mme. Desgarrans had stored several trunks in Morrell's establishment. She had come to America to claim a part of the estate of her granduncle, a rich planter of Louisiana. On the very day of Mme. Desgarrans' arrival in this country she received notification of the dangerous illness of another American relative who lived in Boston, and after leaving directions that her trunks should be stored at Morrell's she immediately set out for the Massachusetts capital.

"On her return to New York she sent an order to Morrell charging him to forward her trunks to her hotel. The answer came back that during her absence the storage house, with all its contents, had been destroyed by fire.

"Mme. Desgarrans was in her room when the note informing her of the loss was brought by a servant. She read it partly through and, suddenly uttering a shriek, fell to the floor senseless. On recovering consciousness she was found to be violently insane and died three weeks later in her room at the hotel.

"The very evening of her death workmen who were clearing away the ruins of Morrell's establishment discovered one of her trunks—a little, square, black leather one. It had become wedged in among a mass of bricks when the walls had fallen, and, excepting that it was scorched, had suffered no injury.

"In this trunk were found all of the papers identifying her as the grandniece of the planter, and in a little box, tied with white satin ribbons, were nestled two golden curls, a tiny pair of baby shoes and a large gold ring. Wrapped about the ring was a slip of paper on which was written in French, 'All that is left of my darling child and husband, who were buried to death at sea, April 23, 1860.' I was with the man who found the trunk, and both of us shed tears as we looked over the things.

"But there need be no danger of such fires nowadays, when the first class storage houses are as nearly fireproof as buildings can be. People with up to date ideas recognize that their household effects are far safer in our hands than under their own eyes, as a properly conducted storage house does not know what theft, breakage and fire mean. It would be impossible to say what is the value of a storage house and its contents during the busy season, but when one knows that 12 trunks in one of our compartments are insured for \$20,500 and that there are 200 other compartments in the building it is apparent that the contents represent a fortune."

It is not generally known, but a man in this city may at any time have a mind to, without moment's notice, send orders to a first class storage and packing concern to have the entire furnishings of his home moved from 203 Blank avenue, New York, to 44 Dash street, London, or any other place of consequence, for that matter, and he can walk off to the first transatlantic steamship, his wife on his arm, with the positive assurance that as soon as space and time will permit everything, from pins and needles to carpets and sideboards, will be transferred from New York to London without the loss of a tack or the breakage of a wineglass.

This is not conjecture, but fact. It has been done time and again. The larger storage warehouses, by means of their perfect organization of professional packers and movers, have reduced the business to a science.

When an order is received at the office, an inspector is immediately sent to make an estimate, who can tell by simply walking through a house how many vans will be necessary to remove the furnishings and how much to the penny will be charged for the storage. After the inspector follows the large vans, with trained packers and movers. The packers are divided into two classes—those who pack the wagons and those who prepare the contents of the house for the wagons. The latter class is subdivided again into those who handle delicate china and bric-a-brac and the packers of the heavy furniture and carpets. Special men, also, are kept whose exclusive duty is to take care of pianos and organs.

When the goods are in the wagons,

they are moved to the storage house, where immense elevators, capable of taking vans without unloading, run from the basement to the top of the building. Rooms are set apart on each floor for the unpacking and examination of baggage.

After each article has been examined, to make sure that it has not suffered in transit the goods are carefully stored away in the apartments allotted to them and the keys of the apartments placed in the office safe.

If a packer discovers an imperfection in any article he is handling, he immediately reports the fact to the inspector, who makes a memorandum of it on the spot. This is to prevent any misunderstanding with the owner in the future. When a packer or mover breaks anything accidentally, he must immediately report it. When he does this and shows the injury to have resulted from an accident, no deduction is made from his salary, but should he neglect to report the matter on the first occasion he is docked for the amount, and on the second occurrence of the kind he is discharged.

INVENTOR OF "LOG ROLLING."

Senator Sawyer Originated That Effective Form of Legislation.

Senator Philetus Sawyer was the inventor of that form of legislation known as "log rolling." It was the practical result of his ability to accomplish things. He never cared for show. He never made a speech in his life, but no man enjoyed the sensation of success more keenly. What he undertook he carried out, and if he couldn't do it in one way he did it in another. He had a large share of that faculty the Yankees call "contrivance," which enabled him to devise means for accomplishing his purpose that would not have suggested themselves to any other man. The "log rolling" method of legislation was suggested to him by the familiar habits of the lumbermen in his own country, who help each other roll the logs from the winter camp to the banks of the nearest stream, where they can be caught by the spring rise. It was the application of this neighborly practice which enabled Mr. Sawyer to secure legislation that could not otherwise have been passed, and he gave the method its name.

Wisconsin needed a good deal of legislation when he first came to congress, and Mr. Sawyer secured more than any 40 other men could have done. He let his bills accumulate until toward the end of the session, when he would take up the calendar and make memorandums of various measures in which influential men in the house and senate were interested. Then he would call them together at his house or at his committee room and say: "Boys, we've got to do a little log rolling if we get our timber to the mill this session." The result would be an agreement to stand by each other and throw all their combined influence in favor of a list of bills which he had made out and handed to members of the combine. The work was conducted in secret and was almost always successful, so that the habits of the Wisconsin lumberman now prevail in every legislative body in the world.

The river and harbor appropriation bill originated in that way. Formerly a separate measure would be passed for each river or harbor that required improvement, but under Mr. Sawyer's log rolling system the members of congress interested in such appropriations organized a trust, which finally grew into a regular annual appropriation bill and a special committee to frame it.—Washington Letter in Chicago Record.

PARSON; FOX AND HOUND.

The Man Who Was Short a Hound Made the Parson Own Up.

The politician told me this story after we had concluded the interview. He told it to illustrate a point in his interview. No matter what the point was, the story will apply to a great many points.

"Our minister," said he, "supplies for a church over in the back part of the town and drives over there every forenoon. The other day, in the course of his sermon in the back part of the town, he used this illustration: "As I was driving here this morning, brethren," he said, "I heard the deep bay of a hound on the hillside near, and, looking up, I beheld a little fox running. "But though the fox was running hard and fast the hound was making great plunges through the snow and was gaining with every leap, and at last the hound overtook the little fox, and that was the end. "Thus, brethren, does sin with horrid bayings pursue mankind, ready to slay and devour and destroy," etc.

came one to the pulpit and twirled his hat in his hand and asked if he might have a few moments' conversation with the parson. So they retreated to one side.

"You spoke of seeing a hound this morning, elder," said the man. "Would you mind telling me how that hound was marked?"

"I can't say that I noticed," replied the minister, hemming and hawing.

"You see, elder, I have lost a hound," continued the man, "and I thought you might be able to help me a little in finding him."

"My dear man," said the elder, straightening himself and patting the other's shoulder, "that was an imaginary hound for the purpose of illustration."

"And," continued the politician, "I know something about these imaginary hounds in politics. I've pulled my old wallet many times to buy meat for 'em."—Lewiston Journal.

The Forbidden Fruit.

The botanical curiosities of the island of Ceylon are replete with varied interest. One of them is "the forbidden fruit," or "Eve's apple tree." Its native name is Diwi Kadura, Kadura signifying "forbidden" and Diwi "tigers." The flower of this extraordinary production is said to emit a fine scent. The color of the fruit, which hangs from the branches in a very peculiar and striking manner, is very beautiful, being orange on the outside and a deep crimson within. The fruit itself presents the appearance of having had a piece bitten out of it.

This circumstance, together with the fact of its being a deadly poison, led the Mohammedans on their first discovery of Ceylon, which they assigned as the site of Paradise, to represent it as the forbidden fruit of the garden of Eden, for although the finest and most tempting in appearance of any it had been impressed, such was their idea, with the mark of Eve's having bitten it to warn men from meddling with a substance possessing such noxious properties.

A Tree That Yields Electricity.

A German authority recently announced the discovery of a tree in the forests of central India which has most curious characteristics. The leaves of the tree are of a highly sensitive nature and so full of electricity that whoever touches one of them receives an electric shock. It has a very singular effect upon a magnetic needle and will influence it at a distance of even 70 feet. HIS TEETH WERE HIS OWN.

And Yet the Facts Were Rather Out of the Ordinary. Four or five traveling men around the hotel stove had been talking about teeth, when one of them got up and, saying "Good night," went off to bed. "Did you notice what fine teeth that party had?" said a man from St. Louis. "He won't acknowledge they are false, or rather he insists that they are his own, and yet he doesn't quite tell the truth. My brother is a dentist in Kansas City, and this man lives there, and my brother does his work for him. Not that he tells me anything, but merely as an incident, for everybody who knows the man knows the circumstances. "His teeth are his own, and at the same time they are false. You don't understand, so I'll explain. He always had unusually fine teeth, but about five years ago they showed signs of Riggs' disease, an affection which causes the gums to recede from the roots, leaving them exposed some distance down from the unenamel surface. In aggravated cases or where the person is very sensitive the disease is very painful, and it is almost impossible to relieve it. To cure it is practically impossible, for the gums will not grow back again. "This man was of the sensitive kind, and although physicians and dentists tried their skill on him they could do nothing, and he suffered so that at last he told my brother to extract every tooth in his mouth and put false ones in for him. As nothing else could be done, my brother followed instructions and pulled every tooth. They were all in perfect condition, and as my brother looked them over, regretting that his patient was forced to give them up, a novel idea occurred to him which he at once told to the other man, who agreed to it willingly. This was that instead of making artificial teeth, as was the usual custom, these same teeth be used exactly as if they were artificial. "My brother, who is a first class dentist always, was more than ordinarily careful on this job, and when he had mounted the teeth in a plate measured to a hair's breadth and slipped them into his patient's mouth they fitted as if they had grown there, as it were, and now there isn't one man in a thousand can tell that they are false, if indeed false they are. At the same time there isn't any more Riggs' disease to trouble him."—Washington Star.

Glimpses of Browning.

In the life of the late Archbishop Benson is given the following extract from his diary, written just after Browning's funeral: "I wonder whether I have anywhere put down a walk with Bradley and Tennyson. Bradley had been reading me 'The Grammatian's Funeral,' and he said, 'We'll ask Tennyson whether Browning's writing at large is poetry or no.' Tennyson's answer was, 'I'll think about it.' In a walk a week later, apropos of nothing, he observed, 'I have thought, and it is.' We had no idea for the moment as to what he spoke of. "A. told me that he stood by Browning at a late funeral in the abbey, and that Browning said, 'When the Lord's Prayer began I looked at Huxley and grinned. I said to myself, 'That means something to me, and to you it means nothing.'"

Miles and the Reporter.

"General Nelson A. Miles always did like to have fun with new reporters," said an old newspaper man. "I remember some years ago he told an unfortunate Washington correspondent a long story about a new gun metal that some genius in Oklahoma or Kalamazoo was supposed to have just discovered. THE DOMINIE.

Rev. J. C. Brooks, brother of the late Bishop Brooks, is at work upon a collection of the bishop's letters. HOUSEHOLD HINTS.

Use borax or ammonia instead of soap in washing blankets. This will keep them soft and help to preserve the brightness of the colored stripes. The wise woman does not attempt to save washing by using clothing, towels, napkins, etc., till they are very dirty. The extra rubbing they require balances the work saved and proves poor economy because of the additional wear on them. Blood stains are about as difficult as any to get out. Here starch comes into use. Make a thin paste and spread on the stain. Leave it to dry. Then brush off. Generally the stain will go with the starch. The worst stains, however, will require several applications of the starch. TOWN TOPICS. The Philadelphia street railways are to have smoking cars. Better make it sleeping cars.—Louisville Courier-Journal. Work is to be rushed on the Chicago postoffice, and our children's children, if not our children themselves, may live to see it completed.—Chicago Post.
