Lucas A. Steinam Memorial Building of the Hebrew Technical Institute.

The Lucas A. Steinam School of Metal Working of the Hebrew Technical Institute has just been completed and the dedication exercises were held Wednesday evening the 26th inst.

At the annual meeting of the Hebrew Technical Institute in January 1901 announcement was made that Mr. and Mrs. Abraham Steinam desired to found a memorial for their beloved son, Lucas A. Steinam, and that they wished to erect a school building to be known as the Lucas A. Steinam School of Metal Working of the Hebrew Technical Institute.

A fund of one hundred thousand dollars was created, a part to be expended in purchasing a site, erecting the building and equipping the metal working shop; the balance to form an endowment the income of which should be applied to the support of the school.

The new building was begun June 1st, 1901, under the direction of Mess.

ing that it is especially devoted to regular school and scientific studies, while the mechanical arts are to be taught in the shops of the Lucas A. Steinam Building.

The new structure fronts on East Ninth Street, fifty feet, and is six stories high; it is fire proof throughout and its facade is constructed of limestone and grey brick.

In the basement of the building is contained the heat, light and power plant of the Institute, including a Corlies steam engine and a Nash gas engine driving the dynamos which light the buildings and supply all the shops with power.

The Auditorium on the first floor has a sloping floor and seats 225 persons with full view of the lecture platform.

On the second floor is the machine shop, fully equipped with lathes, milling and planing machines and all accessories.

The wood turning and pattern making shop is on the third floor and is fitted with benches, tools, lathes, saws and other articles necessary to form a complete equipment.

The carpenter shop is on the 4th floor.

The mechanical drawing room is on the fifth floor, while the forge room and the moulding and casting rooms are on the sixth floor.

My Actual Mission in the United States.

BY MR. NISSIM BEHAR

(Mr. Nissim Behar, representative in America of the Alliance Israelite Universelle, whose headquarters are in Paris, has forwarded to us the following statement, prepared originally for Mr. Bianke, a correspondent of several St. Petersburg journals.—Ed.)

I have been sent to this country by

I began my work among the Jews, especially the students and intellectual class; many of them originally from Russia, showing them that it is their duty to think of their oppressed brethren, and also of all those who suffer from religious intolerance.

While visiting the numerous Jewish societies, I was struck by the intellectual and moral superiority of this youth, through their devotion to studies of economic, scientific and literary questions. This explains why the Jews of this country are successful in all branches of human activity.

Then I thought, if only a portion of this mental power — of invincible will, be applied to the Jewish question, and to the larger problem of universal emancipation, we would certainly make a good step towards reaching the desired end.

I therefore started the propaganda, going from one club to another, asking for their cooperation to help this cause by having each society represented by delegates.

Eighty-three societies already sent one hundred and fifty-eight delegates, and a number of other societies are waiting to be allowed to join

this movement.

This Federation has adopted the name of "Israelite Alliance of America."

the Alliance Israelite Universelle, in order to obtain the support of our coreligionists in its great educational work. For more than a year I have been in daily contact with Jewish life on the East Side of this City; I have witnessed the overwhelming burdens of this Jewish community caused by the unregulated influx of Jewish immigration; I, therefore, arrived at the conclusion that the actual solution of the Jewish question is, to better the condition of our brethren wherever they live, and to obtain for them the right to live in any part of the Russian Empire, which to the Russian Jew is his legitimate home. Though the development of the United States depends, to a great extent, upon immigration, yet a compulsory emigration brought about by mediaeval measures, creates problems and great difficulty for this country.

America, thanks to its liberal institutions, being now the greatest power in the world, has also the duty to use this power on behalf of universal emancipation, and its voice, the voice of a friend, will certainly be heard by the Russian Czar.

But this government must follow the opinion of the country; and it is to create this public opinion that I have taken upon myself, to rouse up the righteous-loving people of this country.

We hope that the time be not distant when any American citizen, though Jew, will be allowed to enter Russia, and even live there established in business.

We hope, that as Bishop Potter spoke last year to the American Jews at a public meeting, viz. "Make America your holy land, and Washington your Zion," likewise the Russian priests will realize the necessity for addressing such words of love to our Russian Jews.

Then Russia, like this country, will no more need loans; then this great and sympathetic Slavic nation will be on the same level of progress and enlightenment as America.

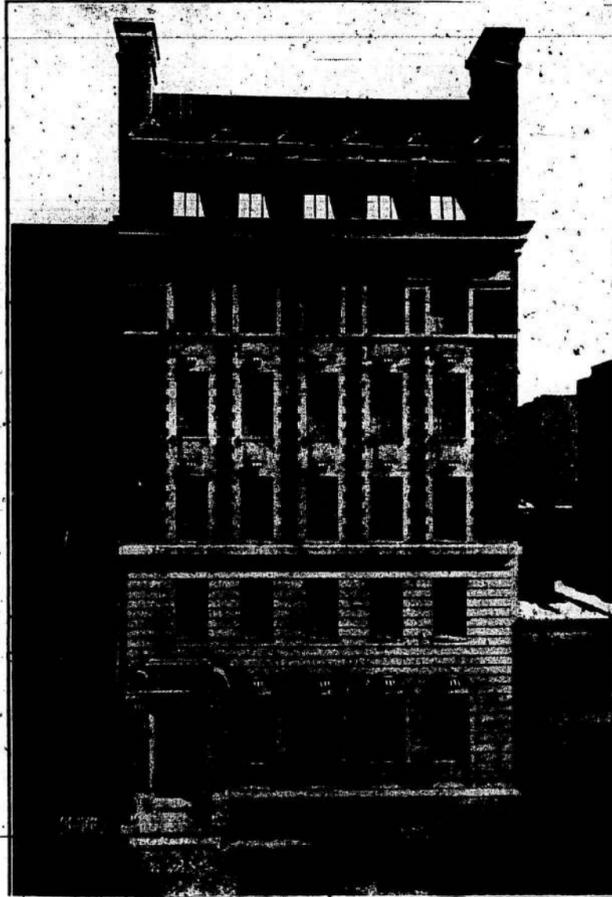
She invested her spare Change in Pink concert Tickets and Salted Peanuts.

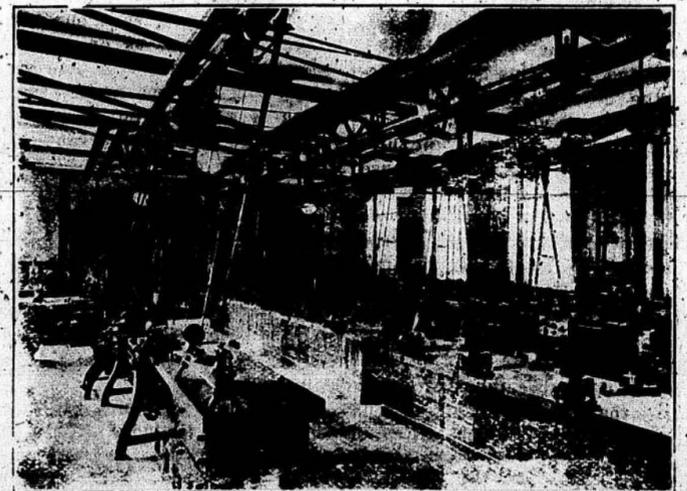

"Guard and Remember."

My Dears. Did it ever occur to you to try to realize what sort of a place this world would be if we were forced to work every day of the week, without having any day of rest, year in and year out, from the beginning to the end of our lives?

Think of it! Soon the workman would find himself going to bed tired and weary, and rising again in the morning insufficiently rested. He would lie down tired, and rise up weary. And there would be no hope for him! As day followed day, and month succeeded month, and old year changed to new year, there would be no rest, no change, no respite. Only in the grave would he see any hope of throwing off the horrible burden of the ever-renewed daily task. Soon, I think, people would be trying to escape the dreadful tyranny of the taskmaster by rushing to death in the hope of evading the torture which life would soon become.

If you only faintly realize this, you will then begin to see what a beautiful gift from God the weekly "Sabbath"—the day of rest—is.

The importance of the Sabbath is often dwelt upon in the Bible, and the command to observe the Sabbath is the fourth of the "Ten Utterances." Now, these "Ten Utterances" are to be found twice in the Torah, once in Exodus, chap. xx., and again in Deuteronomy, chap. v. The Fourth Commandment differs in these two versions, and the difference has been noted by our sages and teachers, a very important lesson, indeed.

The direction in Exodus begins: "Remember the Sabbath day to keep it holy." That in Deuteronomy begins: "Guard the Sabbath day." In the first version the reason is given that, because God made the world in six days and rested on the seventh, therefore we must "remember" to sanctify it. In the second version we are told that, because we were slaves in Egypt and God delivered us from that slavery, therefore we must take heed to observe it.

When we make "kiddush" on Friday night we remember these two reasons, and we thank God for having given us "the inheritance of the Sabbath as a memorial of the Work of Creation," and we go on to say, "for it is also the first of the holy assemblages in memory of the departure from Egypt."

We thus have to observe the Sabbath for a two-fold reason. We have to remind ourselves of the first beginnings of all things in this world; of the great Eternal Creator and Universal Law. And we have to remind ourselves of our own beginnings as a nation; of our

emancipation from slavery—slavery of the body, mind and soul.

The Jew is especially commanded, in the Torah—Exodus xxxi.—that he must guard the Sabbath, "for it is a SIGN BETWEEN ME AND THE CHILDREN OF ISRAEL FOREVER," that God made the world in six days, and on the seventh he rested and was "refreshed." We repeat this passage every Friday night just before the "Amidah." Some people don't like the translation "refreshed," and read the Hebrew word by another phrase, such as, "ceased from work" or "was satisfied."

I suppose they are afraid to render the Hebrew שבת literally, because it would demand a lot of explanation. People might ask: "What? God is able to do everything by His will; how then can He need to be 'refreshed'? Can God grow weary? Does He need recuperating?" The answer is: "Of course not! The statement in the Torah is meant for man's benefit and not for God's. So holy, so important, is the Sabbath that without it we should be apt to let God in us abandon our souls, and we need constantly to 'refresh' God within us. Therefore, let us believe that by renewing our ties with God every week we are repeating the story of the Creation—repeating it in our own hearts and souls!

Observe that, as Jews, we are bidden to remember that the Sabbath is the everlasting sign of God's covenant with our people. But if we look closely at the wording of the Fourth Utterance in the second version—that in Deuteronomy—we will see that not only we are ordered to let our servants, our guests, our relations, ay, even our beasts of burden, rest with us on the Sabbath day. This is ordered in both versions, but in the later one a very important reason is given: "So that thy man servant and thy maid servant may rest just as thou dost."

We must keep the Sabbath holy, because God so ordained it; we must keep the Sabbath holy to remind us of God and to refresh our souls with God; we must keep the Sabbath holy because it is the sign of God's covenant with us; we must keep the Sabbath holy for the sake of the example to those dependent on us.

And now you may ask: "How can the Sabbath be a reminder of the deliverance from Egypt?" There is a very pretty legend about that. When Moses grew up at the court of Pharaoh he was regarded as a very great prince and was very influential there. But he never forgot his own people. He went among them. At first he was quite surprised to notice how badly they were treated. He questioned them about their lives, and when they told him all the dreadful burdens they bore his heart grew hot within him. "Do you never rest?" he asked. "Have you no day for yourselves?" "None," was the sorrowful reply. "From year's end to year's

end we never know a day of rest. We are worse off than beasts of burden. Our lives are one long misery!"

Then Moses went to Pharaoh and said to him: "You are acting very unwisely, even from the business point of view, to make your Hebrew slaves work without any holiday. Human beings must have periodical rest or they break down under the burden of their work. I would advise that you let your Hebrew slaves rest at least one day each week. You will then find them work better and last longer." Pharaoh saw the wisdom of this and granted the weekly rest.

The people, then, who have no day of rest are the worst of slaves and below the condition of beasts of burden. The first sign of the free man is that he has a periodical day of rest for himself which none can take from him. It is necessary for his health's sake; it is necessary for his heart's sake; it is necessary for his soul's sake! And he is the worst of slaves if he lets anybody deprive him of it.

If that be the case, what sort of slave is he or she who voluntarily gives up the Sabbath for the sake of gain? You know, my dears, I have often spoken to you about the necessity to begin observing the Sabbath as early as possible. No one asks you to work, yet I notice that many of you, instead of keeping the Sabbath holy, will voluntarily break your Sabbaths through sheer thoughtlessness.

"The Bible says that he or she who breaks the Sabbath shall surely die the death." And it is perfectly true, too. The death of all the finer instincts and feelings of humanity—the higher impulses of the soul, the striving after God—most certainly follows the neglect of the Sabbath. I have said that nobody wants you to break the Sabbath, while you are here. But even should anybody ask you to do anything that would desecrate the Sabbath, I tell you that you must not obey, no matter who it is that asks you. How much less are you to be excused if you break the Sabbath of your own free will!

Of course, I don't mean this as an excuse for disobedience or dirt or untidiness. The dirty, untidy person has already desecrated the Sabbath by his or her neglect of cleanliness and neatness. All that is really necessary for health, cleanliness and real comfort not only may be done by you on the Sabbath, but should be done more readily on that day than on any other. For neglect of those things makes any day unholy. How much more so the Sabbath!

Now, many of you have at times asked me what you are to do when you go out into the world and find that you must work on our Sabbath or you cannot earn your living? I feel that I must answer that question publicly from this pulpit. You have heard me tell you how keeping the Sabbath is the holiest of duties. Now, hear me tell you that it is

better to work on the Sabbath and maintain your independence of others' help than to observe the Sabbath and live on charity. "Make your Sabbath like the week-day and do not be dependent on others," is the teaching of one of the Sages in the Talmud. But here I want to warn you that you must make a fight to keep your Sabbath. Don't give in to the first temptation. Too many of us pretend that we have to work on the Sabbath when, in reality, there is no such necessity. You will have to prove to God and your consciences that there was absolutely no alternative between begging your bread and earning your living on the Sabbath.

I am always very sorry when I see a Jewish boy, employed by a Jewish master, breaking his Sabbath. But I think the master is most to blame. For the commandment is distinct that not only he must observe the Sabbath, but that he must let all those connected with or dependent on him have liberty to observe the Sabbath.

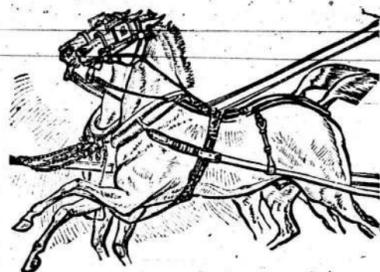
I know, my dears, that there are many very good and able men who, in my place, would insist that you must never break the Sabbath, no matter what the consequences. But I think that the Sabbath is the sign of the free man, and no man who does not live by his work is a free man even though he makes Sabbath every day in the week. That I think is the meaning of the verse in the first part of Genesis, which says that "God blessed the seventh day and hallowed it, because He rested thereon from all His work which He had created—to do." He rested after work—which was to continue. Man shall only rest on the Sabbath day after a week's work, with the intention of going on with his work after the rest.

As to the Jew who wilfully breaks the Sabbath without the smallest cause, what can be said of him but that he is ungrateful to God, unworthy of his high birth, and unfit for his high destiny? He does great harm and is an injury, not a help, to his people.

"Remember and Guard" the Sabbath day. "Remember" what it is for! That we owe a day to God. That we must, in the midst of all the struggle to maintain our place and establish ourselves in this world, "remember" that there is another for which we must prepare! I don't mean that we should go about with long faces and sour looks! No. Let us be glad that the world is so bright, that there is so much love and joy in it; that God is above us! Let us go out into the forest and the field and admire God's beautiful world. That is one very good way, indeed, of "Remembering" the Sabbath—by remembering the beautiful world God has made.

"Guard" the Sabbath! For it is the noblest heritage of our people. It is the perpetual covenant between us and God. It is God's everlasting sign between Him and us. Guard its holiness and its beauty for ourselves and for all others in this world. As the poet says: "The One-God caused us to

hear 'guard' and 'remember'—two orders in one utterance." For by "guarding" the observance of the Sabbath, we are able to "remember" our duty to God, to ourselves, and to our neighbors.

Dedication of the Lucas A. Steinam School of Metal Working.

The Lucas A. Steinam School of Metal Working, which was erected by Mr. and Mrs. Abraham Steinam in memory of their beloved son, was formally dedicated and turned over to the trustees of the Hebrew Technical Institute on Wednesday evening, the 26th inst. Illustrations and a description of the building, which is located at 225 and 227 East Ninth street, will be found on the first page of this issue.

There was a large assemblage present, among whom were many of our coreligionists interested in the welfare of the institution and other communal affairs. The exercises began with a cello solo, artistically rendered by Mr. P. Keifer. Mr. Jacob H. Schiff made a brief opening address, followed by Rev. Samuel Schulman, who offered prayer. Mr. Abraham Steinam, the generous donor, then delivered the keys of the building to Mr. J. B. Bloomingdale, the president of the Hebrew Technical Institute. Mr. Steinam said:

"It is a very great privilege and a peculiar personal satisfaction to deliver to you as the president of the Hebrew Technical Institute the keys of this new building, which has been erected as a memorial to my deceased son. I have watched for many years the work of the Hebrew Technical Institute, and since 1888 I have been actively interested in that work as one of your directors. It was, therefore, through personal knowledge of the institution and of what it has done that Mrs. Steinam and myself came to the conclusion to select the Hebrew Technical Institute as the beneficiary of a fund which we had determined to devote to some good cause in memory of one whom we had loved and lost. There can be no better way of honoring the dead than by doing good to the living, and surely no greater good can be done to the living than by providing education for worthy children who would otherwise be unable to secure it. It is my hope and the hope of my wife that in this beautiful building many generations of young men will, as time goes on, be trained to the performance of useful and honorable work, and that as a result opportunities will be broader and lives be made happier for themselves and for those who come after them. If that should be, then all the hope and pride and loving memory which the brick and mortar of this building hold for Mrs. Steinam and for myself will not have been in vain, and the good herein to be done for other lives will at least to some extent compensate us for the loss of him whose memory this building perpetuates. With the honest prayer for many years of prosperity to the Hebrew Technical Institute, the guardian of the Lucas A. Steinam Memorial Building, and for a constantly widening and growing circle of good work to be done in that building, I hereby hand you the keys, and transfer the building to your keeping."

Mr. Bloomingdale in responding said: "In accepting this trust on behalf of our beloved institute I fully realize our responsibility and obligation to you and Mrs. Steinam and to the whole community; because this magnificent and completely equipped building is a gift to the world and to posterity. In the impregnable future, many skilled workmen are to receive their first training here; I cannot refrain from expressing my pride, that having been actively connected as you have been with the management of the Hebrew Technical Institute for many years, you have made it the agent to administer this important trust. You did not decide hastily; you considered well; for many years you have contemplated the erection of an educational institute as a memorial to your beloved son, Lucas A. Steinam; you connected yourself with this institute very shortly after his lamented death, with that object in view, and you have decided that the most worthy monument you could erect to his memory is to help to put within the reach of every poor boy the means of a useful and practical education; I have no misgivings as to the future. I trust that the institute for many years to come will have the benefit of your mature counsel, and the services of those who have brought it to its present stage of usefulness, and that the public will come to realize even more fully than it now does its beneficial work, and that they will respond, as they always have, to the necessity of increased support.

"We now have thanks to your generosity and public spirit, a fully equipped

school, second to none in the world for instruction in the rudiments of the mechanic arts to boys of 13 to 16 years of age, and it remains for us to prove that we are equal to this increased responsibility. In my last annual report, as in my previous one, I referred to the overcrowded if not dangerous condition of our shops; that condition, through you, has been remedied; every boy in every class and in every shop works under the most favorable conditions.

"How the heart of our late lamented president, Mr. James H. Hoffman, would have leapt with joy had he been spared to see his cherished dream realized so beautifully.

"In conclusion, we hope with this fine building and the fund provided for its maintenance, and with increased aid from our friends, the public, the Hebrew Technical Institute will become a full sister of that great institution founded by that other great philanthropist, Peter Cooper.

"On behalf of the Hebrew Technical Institute allow me to express my most sincere thanks to you and Mrs. Steinam for this splendid indorsement of our work.

"As you have scarcely had time this evening to visit our shops and class rooms, I cordially and urgently invite you to visit the school while it is in actual operation, at your leisure, feeling sure that it will be of great interest to you and assuring you that it will greatly encourage us."

Mr. Bloomingdale's remarks were followed by a basso solo by Mr. Joseph Baernstein.

Hon. Seth Low, mayor of New York City, was introduced and received with cheers. He made a brief, able address, and was followed by the president of the borough of Manhattan, Ho. Jacob Cantor, whose address, as did Mayor Low's, elicited prolonged applause. The exercises were concluded with solos by Mr. Keifer, an address by Prof. Morris Loeb and benediction by Rev. Gustave Gottlieb.

During the course of the evening the women's committee held a reception in the school building, where some of the classes were at work, and the results of the past year's work were displayed.

The present enrollment of the institute is 175 boys.

The Problem of the Ghetto. VII.

(Analysis of articles: I. The unprecedented gathering of Jewish refugees in New York. Reason why special help is needed. Help now given is of two harmful kinds: (1) the pauperizing aid of the foreign Hebrew and (2) the callous quasi-scientific help of the charity-organizer. II. Why the Jewish charity-seeker is at once a far more hopeful and a far more difficult subject for the almoner's care than the ordinary. Why a new stand-point is necessary for the almoner. III. Why the leverage of a common religious belief is absent. Why the foreign Jew sees every preconceived ideal of morality and religion topsy-turvy here. IV., V. and VI. Why there is a graver social evil among the immigrant Jews in New York than there should be. The necessity to avoid exaggeration.)

What have we substituted for this remedial action? Let the story of the recent municipal campaign supply the answer. We have seen how grossly the dimensions of the evil have been exaggerated. We have seen how the very existence of the evil is a reminder of the terrible dragonades which the Jews of Eastern Europe have been suffering for the last twenty years.

Their story has aroused the indignation of the civilized world. Compassion and sympathy are theirs in every heart capable of conceiving the ideals of justice and love of humanity current in our day—in every heart and in every civilization save, apparently, those of their brother Jews.

Three and a half years ago, the present writer, then a recent arrival in America, while editing a local Jewish journal, discovered an undue manifestation of the social evil in the East Side and, after a little inquiry, had a very shrewd notion of the facts of the case.

The remedy was obvious and very simple. A previous social purity campaign, conducted with the unwisdom, blind zeal, and crudity usual in such campaigns, especially when engineered by advertisement seeking clerics, had closed the resorts where the poor wretches plied their calling. They were dispersed throughout the poorest quarters of the city. As we have seen bitter poverty—and not immoral tendency—is the great tap-root of the evil and female example its greatest fosterer.

Jews are, at best, only a little better-disciplined than their neighbors. They are, on the average, much poorer. It was an inevitable result that the evil should spread, and spread it did. But the laws of the State make the owners of the houses, used as lupanars, and the police of infected districts, responsible. Make the police do their duty and punish the owners of reeking, filthy, unsanitary houses, where flats on the second-floor might be hired for eight or nine dollars a month, while "stoop-flats" brought \$30 and \$35 per month. That was the obvious course.

But three-and-a-half years ago there was nothing to be gained by an outcry save the benefitting of the infected districts. Twelve months ago the campaign began. There was then the possibility of making political capital out of it. The whole story is recent history. But mark this fact! At this very moment, conditions are hardly one whit better. Yet no outcry is made! We cannot but view with the most cynical contempt—and the profoundest distrust as to the motives of—loud-mouthed reformers and sociological quacks who apparently take up the question for what they can make out of it, and for that only.

Reformative influences, entirely untainted by selfish motives, should be brought to bear. But let there be no extravagant and unrealizable hopes for any absolute suppression of the evil. We must simply go back on our false tracks. We must clear the poorer residential districts of this evil. School boys of fourteen or fifteen cannot longer be subjected to solicitation on their way to and from the classrooms. Girls, of twelve and fifteen years of age, must no longer be liable to diabolical suggestions of a life of pleasure, ease and luxury if they adopt a profession about the facts of which they are as ignorant as of the latest speculations of the scientist in his laboratory.

But these punitive and reformative agencies must not fall into the hands of the professional sociologist and self-seeking *soi-disant* philanthropist. There is a very simple and readily applicable machinery which shall be indicated and its organization and working explained in a later article.

Mrs. Esther Herrman.

The meeting last Monday afternoon to arrange a demonstration in honor of Mrs. Esther Herrman was a remarkable tribute to her nobility of character and her peculiarly attractive personality. The key-note of the speeches made was not so much one of esteem and gratitude—though there was no lack of expression of those sentiments—but it was one of love. "We all love Mrs. Herrman," said one and all. There were representatives of Sorosis and of the Christian Women's Purity Association. Orphan Asylum delegates mingled their voices with others from Women's Clubs. Stories were told of how one severe winter one thousand shivering newsboys were the glad recipients of new warm overcoats, the gift of Mrs. Herrman. She who gave \$10,000 cash to this and that association, had suppressed her carriage and horses and given the money to the poor. "The cars are good enough for me," quoth she cheerfully.

Representatives of Jewish associations were present but very wisely took an attitude of simple acquiescence whatever the non-Jewish representatives, who were six to one, agreed upon. We call on all who wish to do honor to a good and noble Jewess, and all who have benefitted by her catholic charity, to take part in the movement.

The presentation is to be made at a banquet given to Mrs. Herrman on April 17th. Time is limited. Prompt action should be the rule.

Some years ago, while Baron Rothschild and a nobleman friend were taking a pleasure trip along the Rhine, a young lad on the boat noticed the end of a silk handkerchief sticking out of a corner of Rothschild's pocket. Turning to his chum he said:

"If I could only get that handkerchief! Think how much it must be worth!"

"Try to get it, then," said his chum, with visions of fabulous value of a Rothschild handkerchief.

So the lad took the end of the handkerchief between his fingers and gently tugged at it. At this point the nobleman turned to the Baron, and whispered:

"Baron, that boy beside you is taking your handkerchief."

"Let him alone," said the Baron. "We all had to start small."

The Lucas A. Steinam Memorial.

Last Wednesday evening the formal dedication of the "Lucas A. Steinam School for Metal Working" took place in the auditorium of the institution at 225-7 E. Ninth Street. This is a memorial building erected by Mr. and Mrs. Abraham Steinam in memory of their deceased son, whose name is perpetuated in that of the building.

A reception, with prayers, addresses and elegiac music, gave a fitting tone of ceremonial to the occasion. Hon. Seth Low, Jacob A. Cantor, Jacob H. Schiff, Joseph Bloomingdale, A. Steinam and Prof. Morris Loeb delivered the addresses. Rev. Dr. Schulman opened with prayer and Rev. Dr. Gottheil pronounced the closing benediction.

So princely a method of marking their sense of their great loss redounds to the credit of every one concerned. The memory of the beloved dead is kept green while the building stands and while its happy influence is felt in the brightened homes and improved outlook of the poor. Our community can count itself happy in the possession of such members as those who gave the Steinam Memorial Fund the munificent sum of \$100,000. We can dole with the bereaved parents in their heavy loss, while we felicitate them in having the will and the means to make their loss the gain of the poor in so worthy and wise a manner.

The New Manager of "Elmira."

If great common-sense, joined to largeness of heart, practical knowledge of frail humanity and experience in worldly affairs, are qualifications for the position of Manager of the Elmira Reformatory, then in Mr. Henry Solomon, of New York, who has just been nominated to the said position by Gov. Odell, an excellent choice has been made.

He has always been a generous donor to charities and has given unsparing personal service in addition. The Montefiore Home for the Aged and Chronically Sick; the associations for aiding immigrant Russians; the Jewish Prisoners' Aid Society have been the objects on which his personal service have been centred, but he has always been a large donor to all charitable effort.

There has been a great deal of public dissatisfaction with the recent administration of Elmira's affairs. Mr. Solomon's qualities of mind and heart are just those which will guarantee this State against any repetition of what has been of an unsatisfactory nature.

His quick intelligence and practical mind will soon put him in complete *au fait* with the organization of the Reformatory. We have every reason to congratulate Gov. Odell, Mr. Henry Solomon and the Elmira Reformatory on the latest appointment.

The Mirror.

Let Prof. Schechter beware! Moses P. Jacobson—he who but recently “understood Christ”—of Montgomery, Ala., has declared war against him! War! Bitter, cruel, bloody War! Ah, little does Schechter, sitting at ease in his cloistered cubicle in Cambridge, realize what it shall mean to him when Jacobson—Moses P., he of Alabama—shall unbury the hatchet, don his war-paint, and set out on the trail of the learned scalp that fits Schechter’s head so snugly!

I have recently ‘let-up’ on Bro. M. H. Harris. I have bowels of compassion. For Harris has been for quite some weeks the object of Moses P. Jacobson’s attacks. Harris is probably unaware how savagely M. P. J. is grinding his teeth at him, with what ferocity his wild eyes glare at him! Moses P. is, indeed, a fearful antagonist. Shreveport shudders and Mobile moans when he utters his awesome roar of anger!

The statement I made recently that the Reformers are the most liberal supporters of our communal institutions; and outnumber the orthodox subscribers to the HEBREW STANDARD three to one, reminds me that Dr. Illiwizi once said: “According to the Torah, the Reformers are in duty bound to pay for everything, because it is written

which can be translated: “These shall give; all those who have transgressed the ordinances.”

Herman Warszawiak has recovered his spirits, momentarily daunted by that unlucky venture in the hat factory line in which he sank the 50,000 francs and the confidence of Anenka Nicolas of San Remo, Italy. He has risen again, bobbed up serenely, on a Texas oil-gusher.

His new hope is, as he expresses it in a circular—so widely-issued that Labouchere, of London Truth has got hold of it and speaks disrespectfully of our own Herman—“that when you purchase the stocks and make large profits you will give of this a certain percentage to the maintenance of the Lord’s work under our care and thus do a double good.”

What “double good” is not stated. Possibly the double good is filling Herman’s pockets and of realizing that you are helping the poor of his person. But Herman is cautious. It may be that he has not yet passed through the shadow of the San Remo insolvency. In any case, he is not the ostensible vendor of the shares. No, it is his bosom friend and ghostly counsellor Rev. J. G. Patterson, formerly of East Harlem. He left the pastorate because of a sordid, soul-less butcher and the bill of the butcher. A large bill, a long bill, a sharp, cruel, unpaid bill of \$463 for meat supplied—no doubt for the poor.

Warszawiak, as a converted Jew and Missionary to the Jews, doubtless regards himself as an anointed one—a messiah. It is therefore in keeping that he should find hope of much unction in the *Shemen ha-mosheach*—even though he has flouted the *שמן המשיח*—the *Shemen ha-mishchah*—of earlier belief. Perhaps his new *k'du-*

shah is “Oily, Oily, Oily”—but I beg pardon!

The speculation is not a bad one. Warszawiak sells the shares and pockets a commission as broker. Any one fool enough to buy them might easily be fool enough to feel disposed to send him a donation, in anticipation of profits—if they wait to realize the profits poor Warszawiak might possibly starve—towards his work. His main work, and that of his reverend supporter, seems to be to rake in a few dollars for his own beloved self and his family. Altogether, we congratulate the Presbyterians on their brilliant convert.

The *Jewish World* of London has recently taken to giving front page ‘line’-drawings of a decidedly original and very interesting nature. They are mostly devoted to illustration of gymnastic exercises indulged in by the youthful Jewry of London. The artist is conscientious. From his sketches we get a fine impression of the result of physical training on the adolescent Jewish frame. Never before, and nowhere else, has there been seen such distortions, such wryness of the human form divine.

Rev. Dr. Reuen Thomas of Boston, stirred up a hornet’s nest about his ears by a sermon four weeks ago by saying that Jews are all Shylocks, “who at any cost would have their pound of flesh,” and denounced them as mean and shabby and often conscienceless in trade. Consequently they have been ostracized everywhere. Reuen Thomas has recanted. He is now a very “doubting Thomas” about his own ability. He has passed some weeks in *reuen* his outbreak.

The excuse he made was that the remarks occurred in a series of Lenten sermons. Some of our Jewish contemporaries profess not to see the point of explanation. How dull they are! Is it not obvious that a very conscientious parson—especially in Boston—*might fast too much* in Lent? Consequently it would not be unnatural if he became *much too fast* in Lenten discourse.

“Boston was the scene of our own Lee K. Frankel’s exploit in the same direction. I would suggest that he shake hands with Thomas but for one reason. The latter admitted his error and made some sort of apology for it. The former has not, so far, had the grace to do either. Thus Thomas is much the worthier of the two.”

Here’s an item from the *Jewish World*, of London: “A lady, commenting on the

in the Atonement prayers, is certain that it can only mean the four Mrs. Bethdin, viz, Mrs. Adler, Mrs. Gaster, Mrs. Bernard Spiers and Mrs. Susman Cohen.” Not at all bad! Score one for our English contemporary.

Attorney Millard Fillmore Brown is a very interesting individual. His home is Buffalo, and the City on the Lake has every reason to be proud of him. We hope it is sufficiently so. We hope it realizes that few American cities have the counterpart of Brown. The possession of Brown by Buffalo is calculated to turn other cities green with rage, black with wrath, yellow with envy and white with intense

emotion. For Brown does not like Jews, and he publicly expresses his dislike.

He has a client whom a Jew is suing for \$100 on a bill. The defendant won in the Justice’s court. Appeal to the municipal court was made. A jury was about to be empanelled when Brown discovered that three of them were Jews. He immediately charged the impanelling constable with securing them of *malice prepense* against his client. “I do not want Jews on this jury,” shouted the valiant Brown.

Brown may have thought that his duty to this particular client demanded this course. His client, in that case had a fool for his attorney. Or Brown may object to Jews on general grounds. In that case his client was in even worse condition. Altogether, Brown is a great curiosity. Somebody should stick a pin through him and fasten him to a varnished card. He should be labelled and put into a museum with other rare insects.

There were some hot exchanges between the Constable and Brown. The Constable clinched matters by saying: “Your charges are groundless and would not be made by a gentleman.” We warmly approve of that Constable’s reasoning and think him a man of great shrewdness and insight. He reached bed-rock truth this time. Brown is *not* a gentleman.

The Charity-Union Craze.

All charity organization is excellent when it organizes charity. When it merely acts as a tyrannical dictator alike to charity-giver and charity-receiver, it is damnable. Let our St. Louis friends note this opinion.

A crowd of good-hearted people get together to aid the poor. Their work overlaps. That is mischievous. They leave fields untouched. That is also mischievous. Inexperienced and impulsive, they foster *schmorrning*, while real distress is overlooked. That is the worst of all.

Charity organization steps in and acts as *amicus curie* between the overlapping bodies. That is good. It directs attention to neglected areas. Also good. It suppresses the schriorer and discovers the really distressed. That is excellent. It inquires, and records the results of its inquiry, not only into individual cases, but into the whole question of the many-sided problem of charity. That is best of all.

Obviously, however, when a fool or a stubborn, self-willed tyrannical dictator—who has wholly lost the original impulse of kindness—gets charge of things he becomes a mischievous intolerable nuisance, and some muscular man with a large foot, shod in a thick boot, should be invited to step forward and kick the nuisance into the limbo of contemptibly dismissed frauds and failures.

We seem to want the fool-killer and the fraud-kicker badly, both in New York and in St. Louis!

LITERARY.

Twenty-Six and One

By Maxime Gorky, with a preface by Ivan Strannik. J. F. Taylor & Co., New York, 1902. \$1.25.

Here are three more of Gorky's admirable short stories. They show us Russian humanity, in the rough, unpolished, uncouth, rugged—but vivid, real, living. We cannot love the creatures of Gorky's creation—or rather the types he has faithfully copied for us, for the vraisemblance is unmistakable—but we cannot deny their reality. They are human beings such as all that we know of Russian conditions makes us ready to accept.

The first of the three short stories, "Twenty-Six and One," from which the book takes its title, is perhaps the most remarkable and attractive. The picture of the "sweated," sweating, overworked, underpaid bakers and their scarce-formed and only half-realized adoration of the self-willed fresh young beauty, Tanushka (Tanya), is striking and realistic in the extreme. There is something very touching in the story of the love and pride the rough men conceived for her who formed the one touch of brightness and romance in their lives. The touch of tragedy in their dismay, when they begin to suspect that she is but human and very feminine is very artistically wrought.

The second story, "Tchekache," is finely-written and displays all Gorky's peculiarities of genius—for genius he undoubtedly possesses. There are those who make comfort in describing him as "a raw, rancid Russian." He is strong, unconventional, uncompromising. But "raw" or "rancid" he certainly is not. "Tchekache" and Gavrillo are Russian peasantry, rough, with elemental passions, and in revolt against their conditions. But they are genuine human beings.

The concluding story, with the fickle Malva for its heroine, is as remarkable a story as the other two. Her three lovers are sketched with the firm, unerring touch of a master. Like the others, the tale is unpleasant. Like them also, it is undeniably real and life-like. Gorky's art is consummately realistic. It would have been the easiest of matters to have conventionalized the stories and made them fit the accepted pattern of young-lady-like conventionalism. But Gorky's love for his art is too conscientious to permit him thus to play to the gallery.

How to Attract and Hold an Audience

By J. Berg Eisenwein, A. M., D. D., New York. Hinds & Noble. \$2.00

This is a work which is intended to analyze and explain the orator's art. It is exceedingly well-written and practical and should be a *bad-mecum* for every clergyman, spell-binder, or other public speaker. We are not at all sure that we altogether admire the few selections in the appendices. But we do admire the clear and thoughtful exposition of the "public discourse"—how to conceive, arrange, build up, and deliver it. The chapters on the art of reasoning, on logic and on rhetoric are admirably brief and clear, yet sufficiently comprehensive and very valuable. Dr. Eisenwein has evidently made a very special and practical study of the art of speaking, and his rules, hints and methods are fresh, original and extremely useful.

The Religion of Israel

By Rabbi Julius H. Greenstone. Published by the Hebrew Sunday School Society, Philadelphia, 1902. 50 cents.

This is a useful little text book for the teacher of Hebrew and religious classes. In his preface the compiler acknowledges his debt to Dr. K. Kohler's "Guide for Instruction in Judaism" and to Friedlander's "Jewish Religion." The plan of the book is well-conceived and well carried out, and, while perhaps it leaves room for something to be said, it may, on the whole, be pronounced to be, practically, a great improvement on its predecessors. Its aim, of being a compendious yet simple and easily mastered handbook of ethical and ceremonial Judaism, must be pronounced to have been successfully attained. It should be of great use to teachers and could be widely adopted for class work. In the ever-growing condition of ignorance of Jewish ideals and practices, which seems to be the chief menace of our day, such works as this of Rabbi Greenstone cannot be too widely diffused.

Ta'anith Esther and Purim.

In the Congregation Kullam Ahubim both of these days were observed with sincerity and devotion. All the prayers were recited and in no perfunctory manner; all the Pentateuchal portions were carefully read from the scrolls, as well as the Book of Esther on Saturday night and Sunday morning.

This congregation seems to have min-hazem (customs) not found elsewhere—in other words a Shulhan Arukh of its own. For there the writer saw and heard what no man ever witnessed in any other Jewish place of worship.

After the service, including Alenu, had been recited on Thursday morning, a Maggid stood in front of the Holy Ark and delivered a lecture on the meaning of Ta'anith Esther—"Why do we fast to-day?" He told in brief the history as recounted in the Scripture until he came to the choice by Haman of Adar 13th as the day upon which he might destroy all the Jews in Xerxes' empire. He depicted the feelings of the members of the slandered and threatened nation, their fasting for three days in response to Esther's request. He then portrayed the incidents of the day on which the Jews stood up for their lives and saw the downfall of Haman's party. That day was one of anxiety: they knew not for certain whether the king's soldiers might not have received counter-instructions to assist their enemies; they fought with a desperation that gave energy to defense, but with wise forethought they refrained from seizing the spoil which royal decree had said was theirs. Such a day as the 13th of Adar is continually threatening Israel's life, owing to that jealousy which cannot see them prosperous, whether they deserve it or not. It was natural and right for our sages to appoint this day for fasting in all the lands and in all the period of our exile. V'hayu chayekha teluyim lekha minneged—your life shall be one of suspense, until the Lord's annointed come and put an end to your misery, leading you back to the ancient home. Until then we must feel that history repeats, or, I should say, continues itself, inasmuch as man is not essentially different in any generation from what his ancestors were hundreds and thousands of years ago.

I hear some have urged that this fast is not so obligatory, as those of the fourth, fifth, seventh and tenth months mentioned in the prophecy of Zechariah, forsooth because this man of God did not render any decision with regard to the fast of Esther. Let them examine the matter through historical spectacles and they will observe that Ahashverosh, known to the Greeks as Xerxes, ascended the throne many years after the incident mentioned. Moreover, if in spite of Zechariah's abrogation (for the time of prosperity), the sages after our second Temple's destruction restored the ancient fasts, had they not sufficient authority to add a fifth in the twelfth month, a period of suspense followed by one of absolute security and unalloyed happiness? A youthful preacher once selected as his topic, "Doubt and Faith Both Holy"; he might with equal right have chosen, "Distress and Joy Both Sacred." In the presence of grief we stand in awe, fearful to open our mouths in indiscretion, when we witness mouths in indiscretion; when we witness the pleasure of fellow-beings. Suspense may be considered the balance on which grief and joy are poised, which shall eventually through external pressure outweigh the other? In a period like this, on a day like this, the Jew who feels for his people, cannot be indifferent to the precarious condition of his coreligionists who suffer by reason of their race and faith—not knowing indeed what an hour may bring forth.

Of the Holy One the prophet Isaiah writes: "B'kol tsaratham lo tsar—in all their distress He was distressed;" in another place he writes, "Kimsos hathan al kallah yasis alayikh Elohayikh"—"as the bridegroom rejoices over a bride, will thy God rejoice over thee." If this be true of the Creator, how readily can we understand that only He is deserving to share Zion's glory, to enjoy her prosperity, who felt with her in misery, only those may feast with her who fasted with her, whether on a thirteenth or an eleventh of Adar.

The elasticity of the Jewish race, its recovery from depression was best exemplified by the short, witty homily delivered in this synagogue on Sunday afternoon. The Maggid ordinarily speaks for two and a half hours, but this being

an extraordinary he spoke on what he called Mitzvath Akhlah u-Shethiah—the rule to eat as much and to drink as much as one can on Purim. In this case he meant to practise what he preached, and we have no doubt that he carried out his intention.

In the Jewish World.

Rabbiner Dr. P. Neustadt has died at Breslau, after a long illness. He was a strict follower of traditional Judaism.

The King of Denmark has created Herr Siegmund Lautenberg, Director of the Residenz Theatre in Berlin, a Knight of the Dannebrog Order.

On the occasion of his birthday, the King of Wurtemberg conferred an important decoration on Professor Dr. Adolf Gerstmann, Dramatist of the Royal Court Theatre, Privy Court Councillor and Court Bank Director Edward Kaula, and Court Councillor Arthur Kaula.

Dr. Aschkenaze has been elected as Rabbi of Christiani. The appointment is for life.

A new society of Jewish university students with Zionist leanings, called the "Maccabaea," has been established in Breslau.

The inhabitants of Franzabad have opened a subscription for the erection of a monument to the Jewish physician, Bernhard Adler, who has established the reputation of this watering place.

Silk City Lodge, I. O. E. A., of Paterson, N. J., has disbursed \$1,120 among nineteen members of the lodge who sustained loss through the recent flood which visited Paterson.

The National Conference of Jewish Charities will be held in Detroit, Mich., in conjunction with the National Conference of Corrections and Charities, and not in Milwaukee as originally intended. The dates for both conventions will be 27, 28 and 29.

In consequence of the machinations of the Clerical Party, a number of students held hostile demonstrations against the Jewish deputy, Vaszony. The deputy Korow, having interpellated the Minister of Public Instruction, he energetically condemned the anti-Semitic tactics.

The degree of LL.D. has been obtained by examination by Mr. Advocate Manfred Nathan, B.A., LL.B. Mr. Nathan is the only practising barrister in South Africa holding this degree, which is the highest the University of the Cape of Good Hope has in its power to bestow.

Surgeon Hyman Cohen, U. S. A., who is now stationed in the Philippines, has recently been promoted to the rank of captain. Captain Cohen is 26 years of age and is a graduate of Dickenson Lodge and the medical department of Baltimore City College. He is a son of Mr. Morris Cohen of Washington, D. C.

A considerable number of coreligionists have been appointed Officers of Academy and Officers of Public Instruction. Among the latter are: Baroness James de Rothschild, M. Georges Beaucaire, Sub-Prefect of Arles; M. Jules Leitner, Artist of the Comedie Francaise, M. Emile Levy, Grand Rabbi of Bayonne; M. Gabriel Valbregue, Chief Editor to the Prefecture of the Seine; and M. Victor Isaac Weyl, Publicist and Dramatic Author.

The Montmartre District of Paris has lately been the theatre of some horrible murders. Last Saturday the owner of an old curiosity shop, Madame Elizabeth Dreyfus, was found dead among her bric-a-brac. Madame Dreyfus, who was of Bavarian origin, had occupied her shop for the past eighteen years, and was well known among artists, curio hunters, and dealers in old pictures, gems, medals, and miniatures. She was supposed to be very miserly in her habits, and usually lived alone at the back of her shop. An old servant, whom she had had for some years, recently left, but was in the habit of visiting her nearly every day. This person, a woman named Lecocq, called to see her former mistress yesterday afternoon, but found the door fastened. She immediately informed the concierge and the nephew of Madame Dreyfus, who managed to get into the shop. The poor woman had been gagged and strangled. A thick cravat was tightly tied around the woman's neck, and it was evident that death had ensued promptly. The crime had been committed for the purposes of plunder. The deed is supposed to have

been done by one person, and the concierge of the house in which the shop is situated saw a fair-haired man, about thirty years old, leaving the establishment of Madame Dreyfus. No further clue has been found to this new mystery.

M. Drumont, who is a candidate at the General Election for the Chamber of Deputies, is being strongly opposed at Algiers which he seeks to represent. A number of Councillors General, Municipal Councillors and financiers are running against him M. Colin, a Professor of Jurisprudence.
