The Modern Dispersion.

The full importance of contemporary events is rarely appreciated. History remains to most men a sealed book, unless it deals with the remote Past. The rulers and teachers, the sages and prophets, are those who are able to measure present occurrences in the light of the past and foresee the future in the light of both.

Every Jewish child knows and understands the story of the Exodus; of the Babylonian captivity; of the Assyrian wars; of the destruction of Jerusalem; of the Diaspora; of the expulsion from Spain. Each of these epochs furnishes materials for a sublime Epic, and the materials have been

freely employed by poets and minstrels.

The heroism of achievement and endurance, so prominent in Jewish history, appeals to all men strongly, to Jews irresistibly. At some time in the life of every manly boy, he has deplored that he did not live in the age of Chivalry; that he was denied the triumphs and glories of knight errantry. The manly Jew at all times envies those who were enabled against Egyptians, Babylonian, Syrian, Roman or Spaniard, to exhibit in action or martyrdom the indestructible spirit of his race. There is a peculiar charm about past occurrences. They come, filtered, to us through the souls of historians, poets, artists and musicians. Their curious features have been eliminated, and what is left offers no fence to the aesthetic or artistic sense.

The history of the present lacks these advantages. It has not been set in artistic order. It has not been freed from its obnoxious elements. It has not been refined. It is unsettled, crude, nauseous; full of grime, dirt, blood, sweat and offal. When we see the soldier from his camp, living in filth, infested by vermin, violating the laws of health, ignoring in speech and conduct the precepts of morality, made coarse and growing coarser by his environment, we are prone to call him a degenerate. We contrast him with the heroic men who fought for our liberties in the romantic ages of the past. But the heroes of the past, however they appear in song and story, were in their day like unto the unattractive men we now decry, and the latter in times to come will be secured and take his place along with the others in the chronicles of the heroic dead.

It is not only a canon of taste, but also a law of justice, which makes the historian deal mainly with the virtues and lightly with the shortcomings of mankind. To err is human. Sinfulness, if not inherent and original, is so common that it is not distinguishing. It is always in evidence and moves along an easy downward path. Virtue, on the other hand, while abiding in every soil, is repressed by selfishness and must ever struggle upward along thorny ways. When it is in evidence, it is, therefore, a distinction. In the final judgment of men, what good they have done and what evil they have resisted must be the controlling consideration. The rewards of virtue cannot with justice be withheld, because with virtue is commingled the infirmities common to mankind. The Pentateuch has doubtless left unchronicled many sins that might with truth be imputed to its great characters, and even as it is of none of its notables can it be said he was faultless. Yet we revere and love them, not for their faults, but in spite

of them, and because, in their lives, if Virtue was not always the exclusive possessor, it was their dominator.

In dealing with our contemporaries, we are not so just. We are apt to magnify the faults of others by comparison with our own virtues, and to belittle their virtues, by comparison with our own imperfections. Instead of employing a standard by which to measure them and ourselves alike, we make standards of ourselves and condemn all who fall short of, or go beyond it. This infirmity is largely responsible for the failure to appreciate the great historical crisis through which the Jews are now passing, and the duties arising therefrom.

During the past twenty three years, the world, without understanding it has witnessed a radical change in the situation of the Jews. It is still in progress and will doubtless continue to be for many decades. In some respects it is similar to the Exodus, but more properly speaking, it is the Modern Dispersion.

During many generations the majority of the Jews have dwelt in Russia, Galicia, Roumania and Hungary. In Russia and Galicia alone, their number reached almost five millions. It is needless to dwell on their conditions. The story is well known. Suffice it to say that a little over twenty years ago, the Jews began to leave these countries in large numbers, and that since then there has been an interrupted flow to the Orient, to Western Europe, to South America, and last, but not least, to the United States.

During the period under consideration, ten per cent. of the Jews of the world forsook their native homes in Eastern Europe and took up their abode in this country. At the present time, this influx to the United States equals or exceeds annually, one half per cent. of the world's total Jewish population. Add to this number those who settle in Western Europe, the Levant, the West Indies, Central and South America, South Africa and Canada, and we can readily foretell that within the first half of the twentieth century the Jewish centre of gravity will be far removed from Eastern Europe. Indeed, since the stream to the United States grows larger with the passing years, we may count with some confidence that in this century the majority of the world's Jews will have established their domicile here, or certainly on the Western Hemisphere. The migration from Eastern Europe in our day is strikingly like the migration from Spain at the end of the fifteenth century, except that in the expulsion from Spain, not over three per cent. of the world's Jews were involved, while now considerably more than one-half are involved.

In short, the present dispersion has

all of the tragic and romantic features of the Spanish expulsion, is impelled by an equal intolerance, endured with equal martyrdom, but exceeds it in interest and importance, because Spain only had, at most, three hundred thousand Jews, while Eastern Europe is driving forth five millions.

The effect of the expulsion from Spain need not be more than mentioned. It is a well known historical fact. What is important now to study is the effect of the immigration now in progress. It must not be belittled because the immigrants are poor, ignorant, superstitious, narrow, untidy, or otherwise unattractive. The Jews who fled from Egypt were infinitely below the standard of these. Those who were driven from Jerusalem by the Romans were not superior to the Jews who are now on the march. Even the Spanish refugee, around whom glows the halo of romance, had the shortcomings of mankind in full measure. Nor can we make unfavorable comparisons by weighing the causes of the various migrations now under consideration. It may be conceded that the Czar is not a monster, and that the Russians are consciously unjust to the Jews. The same may be conceded to the King of Roumania and his subjects. It may further be conceded that the Jews in Russia and Roumania are undesirable and even obnoxious from a view point we do not occupy, and which, if erroneous, is nevertheless believed to be correct.

Must we not concede as much to Pharaoh, to Rome, to Spain? Even as we know the past, such concessions are demanded, and let us not forget that we know the past only from viewpoints variant from or opposite to those of the Egyptians, the Romans and the Spaniards. They had their sides in the argument, just as Russia and Roumania now have theirs. History has condemned the views of Egypt, Rome and Spain. It will doubtless condemn Russia and Roumania. Its judgement has not been based in the former, nor will it be in the present cases, upon the impeachable virtues of the Jews among men, but simply and solely on the fact that they were and are members of the human family. It was and is unjust to oppress them, not because they were or are better than their oppressors, but because whatever their failings, they are human beings, and as such entitled to humane treatment. Any other view is poetical, sentimental and romantic, but it is misleading and unjust.

The verdict of the historian, however, need not trouble us now. Our task is to see now what the historians will easily make out when time gives a prospective and the atmosphere is clear of dust and smoke and conflict. What is our verdict? and how will it effect our conduct? Such questions

may not be regarded as academic by any one, certainly not by Jews. To him, wherever he dwells and whatever his condition, these questions are pressingly practical. What is his view on the Modern Dispersion, and how will that view impel him to act? How will the American Jew, and especially the well-to-do and cultivated American Jew, respond?

The problem is not a little complicated by prejudices of various kinds. The Jews are favorites only of God. Their fellow-men, for one reason or another, or no reason at all, refuse to endorse the decree of Heaven, which has singled Israel out as a peculiar and chosen band. Even though the rejected stone has again and again been divinely honored as the chief cornerstone, it has been denied recognition by man. This lack of atonement between man and God is, however, not unique. There are other differences as well.

The Jews do not regard anti-semitism with contentment or patience. On the contrary, they resent it as a gross injustice. But they have grown accustomed to it and meet it as an inevitable evil. United against the hostility of the world, the Jews draw comfort from one another and the splendid heritage left by their ancestors. There exist, however, prejudices among the Jews themselves, which to the Gentile at least must appear marvellous.

These prejudices are based on many classifications, not now necessary to be considered. The one classification of greatest importance is that which sets on one side the Jews of Western Europe and the United States, variously called the Reformed, the Modern, and the German and American Jews, and on the other hand the Jews of Russia, Galicia, Roumania and other Eastern European countries, variously called Russian, Polish, or Orthodox Jews. For convenience, let us call the former Western and the latter Eastern Jews.

As a rule, the Western Jews have absorbed Western civilization, and bear lightly or not at all the yoke of the Torah. As a rule, to the Eastern Jews Western civilization is yet unknown, and they adhere to the same religious views and practices which prevailed centuries ago. The Western Jew has a modern education and speaks with facility the language of his native land; the Eastern Jew's education is largely religious, and his mother tongue is the jargon known as Yiddish. The points of difference between the Eastern and Western Jews are numerous and important, but not so much so as each believes. The prejudices of each against the other magnify the differences and the faults which each ascribes to the other on account thereof.

2 CHRON. 7: 11, TO THE END; 1 KINGS, 10.

In the Jewish World.

Williamsport, Pa., will soon have a new synagogue.

Another new synagogue is in contemplation at Worcester, Mass.

The Mount Sinai Jewish Hospital of Milwaukee was formally opened on Sunday last.

The new Hebrew School of the Sons of Abraham, of Worcester, Mass., is to cost between \$7,000 and \$8,000.

The social and bazar recently held by the Young Ladies' Temple Aid Society of Schenectady, N. Y., was a financial success.

The second annual meeting of the Federation of Jewish Charities of Philadelphia, Pa., was held this week at Mercantile Hall.

The United Hebrew Congregation of St. Louis is about to purchase the edifice formerly occupied by the Mount Cabanne Christian Church.

During the last year the Associated Jewish Charities of Chicago expended nearly \$150,000 in its relief work, of which \$2,953 was used for expenses.

The Sons of Zion of Holyoke, Mass., have appointed a committee to devise means and plans for the erection of a synagogue to cost about \$15,000.

The fourth annual meeting of the Boston Helping Hand Temporary Home for Jewish Children was held last week at the Baldwin Place Hall. There was an attendance of over three hundred members.

Plans have been submitted for the new

synagogue edifice of the Temple Beth Israel of Grand Rapids, Mich., and it is expected that the building will be completed and ready for occupancy by September.

Rev. E. Friedlander, late of Montreal, has been elected Rabbi of the Anshe Emeth, of New Brunswick, N. J. Rabbi Friedlander's call was unsolicited and his election unanimous. He will enter upon his duties on June 15.

In the will of the late Alexander Frank, of Baltimore, probated last week, the Hebrew Benevolent Society, the Hebrew Orphan Asylum, the Hebrew Hospital and the Hebrew Ladies' Sewing Society of this city were named as legatees each for the sum of \$500.

The Jewish people of Faulkner, Mass., having organized a congregation under the name of Agudas Achim, have purchased a lot of land and are about to erect a synagogue edifice, which will be built of wood and cost about \$5,000.

The cadets of the Hebrew Educational Society of Brooklyn held a "military night" last Saturday night in the society's auditorium. Nathan S. Jonas, Esq., delivered a very entertaining address.

Arrangements for the sixth annual convention of the American Zionists, to be held at Pittsburg, Pa., from June 6 to June 9, inclusive, are about completed. The plans, outlined by the convention committee, consisting of representatives of the six local societies, are elaborate and contain many features of interest. A mass-meeting, over which Judge Josiah Cohen will preside, will be held at the Bijou Theatre Sunday evening, June 6.

The Colonial Office of the British government has formally recognized the jargon Yiddish as a European language. In the rush of aliens to South Africa many German and Polish Jews were rejected by the immigration authorities because they were unable to answer the questions put to them. The chief rabbi of London then petitioned the government to recognize Yiddish as a language and appoint interpreters, so that injustice might not be done. Henceforth declarations in Yiddish will be received at the Cape.

Session of District Grand Lodge No. 1 at New Haven, Conn.

The reception tendered was a hearty one. Many of the best known citizens of New Haven were present at the hotels to greet the delegates. Saturday evening was spent in social chat. The harmony prevailing in the District was made patent by the absence of electioneering of any kind.

On Sunday morning the session was opened in the spacious hall of the Harmonic Club, which club placed its handsome house at the disposal of the Grand Lodge. President Jacob B. Klein opened the session, all the officers, members of the general committee being in attendance, as well as a large number of Horeb Lodge, and as the session was a public one, many of the residents of New Haven, and a large number of ladies were present. Immediately after the report of the committee on credentials was received a large number of Past Presidents were initiated into the Past Presidents' Degree.

President J. B. Klein then read his message, which reviewed the work of the District during the past year, and contained much interesting matter. The report, which was received with an ovation, was voted as the best document of its kind ever presented to the District Grand Lodge.

The officers were installed in the absence of President Leo N. Levi, who attended the session of District Grand Lodge, No. 2, at Cleveland, O., by S. Suzberger, assisted by Hon. M. Ellinger, Brother Ellinger delivering a most eloquent charge.
Messages of congratulation were received among others from District Grand Lodges, Nos. 2 and 6, which met in session on the same day, the former in Cleveland, the latter in Omaha, Neb., from the Grand Lodge of the Independent Order Free Sons of Israel, from President Leo N. Levi, the Isaiah Ladies' Auxiliary Society of the City of New York, and many of the subordinate lodges.

The privileges of the city were also extended to the visiting delegates by Mayor Studley of New Haven.

A bulletin, addressed to the lodges of the order, respecting the outrages in Kishineff, Russia, was read, and was received with tumultuous applause. A subscription was then taken up for the aid of the distressed in Kishineff and in fifteen minutes the sum of \$1,050 was raised, and with an enthusiasm which was most remarkable. This sum was increased subsequently by Horeb Lodge

of New Haven, by \$200, making the collection \$1,250.
The dues for members between the ages of eighteen and twenty-five shall be one-half the dues for present members, and the dues of such members to the Home and Grand Lodge shall be one-half the dues of members above the age of twenty-five.
The sum of \$300, the contribution to the Technical Institute, was voted for the coming year.
It was voted unanimously to acquire cemetery grounds for the lodges of District No. 1, to be known as the cemetery of District Grand Lodge No. 1.
The Committee on Intellectual Advancement was increased to one member for each lodge.
A resolution respecting the sufferers in Kishineff was passed calling upon the community of all creeds to assist in preventing crimes of such a nature as have taken place in Kishineff.

Bulletin No. 7, which has just been issued by President Leo N. Levi, reads as follows:

To the Members of the Executive Committee and the Presidents of the American District Grand Lodges of the Independent Order of B'nai B'rith: Brethren—The recent massacre of Jews at Kishineff, has aroused great excitement, and, as usual, when excitement prevails, errors of lasting influence are likely to be committed. To the end that the B'nai B'rith—the great, world-wide, permanent representative Jewish organization—may not be hereafter embarrassed or crippled in its usefulness by mistakes in this crisis, I beg through you to lay before the subordinate lodges the following facts and considerations:

When the massacre was first reported the Executive Committee, through one of its members, Hon. Simon Wolf, applied to our government for an official report of the reported event, containing a list of victims, a statement of the relief required and the manner in which it could be afforded without giving offense to Russia. The Secretary of State cabled for such a report, and under date of May 9, 1903, furnished a copy of the cablegram received from Ambassador McCormick at St. Petersburg. It is as follows:

"It is authoritatively denied that there is any want or suffering among Jews in Southwestern Russia, and aid of any kind is unnecessary. While the offer and spirit in which it is made is appreciated, it is gratefully declined."

All of the Jews in Russia, however, cannot or will not emigrate. Their status there will always present a grave problem. Their fate will depend finally upon the ruler of the Russian Empire. To his sense of justice and to the humane spirit which he has so often manifested the Jews must look for protection when ignorance, prejudice and lawlessness assail them.

In the prevailing excitement let us preserve our calm, keeping in mind the future as well as the present. Let us do nothing and say nothing that will cut us off from the right to make a dignified and manly appeal in the name of humanity to the dignity and manhood of the Czar. When the Executive Committee of the Order convenes this summer such an appeal will be considered, together with plans for having it indorsed by the general public and properly presented.

It is going to be quite a unique affair, as the gentlemen are to be attired in the regulation Summer garb of flannel trousers and negligé shirt, and the ladies are to wear white shirt waists and white duck skirts. A large gather-

ing is looked for, as the affair has been thoroughly advertised, particularly on the East Side, where the league has its headquarters. The league's membership is increasing, and every week three or four new members are initiated. The rooms of the league are at the Home, 40 Gouverneur street. Visitors are welcome at the weekly meetings, which are held every Tuesday evening.

Young Women's Hebrew Association.

Dr. Levine spoke on "Peace" last Friday evening. The choir of young ladies prepared by Miss Singer, for the first time last Friday evening rendered hymns.

The first aid to the injured class, which graduated every member under the instructions of Dr. W. Rodgers, will be awarded diplomas this week.

Last Sunday morning Mrs. Mendes spoke of "Resting in the Lord."

On Saturday evening there will be a mass meeting for the sufferers at Kishineff. Prominent speakers will address the meeting.

On Sunday evening there will be a musical entertainment. Next Sunday evening there will be held the monthly social, and the evening will be devoted to patriotic exercises, and a large American flag, the gift of the beneficiary members of the institution, will be presented.

Hebrew Sheltering Guardian Society.

One of the major problems that have always confronted the Jewish institutions is the question of enabling the children to support themselves after discharge. This could not be effected except by means of a practical training in one of the occupations that yield compensation. This institution, recognizing the necessity for educating the children to a practical view of life, a few months ago began to experiment with placing out at trades and business a small number of college and high school boys. The children resided at the home and deposited their earnings with the administrative officers. When they had saved a snug sum they were discharged, and their little treasures proved handy in every way, enabling a poor parent or other relation to establish a little household or even giving the discharged ward a good beginning in a savings bank.

During the current week a large number of the boys who had been attending college and high school without any appreciable chance of benefiting thereby in after life were either sent to commercial positions, apprenticed to trades or recommended for admission to technical and trade schools. This was done out of consideration for the fact that none of the boys, if permitted to continue their higher education, would find things outside to their liking when discharged, some of them being likely to be called upon to help out indigent parents. Judging from the experience had, the present move will surely lead to successful results.

Young Men's Hebrew Association.

The closing exercises of the educational classes took place on Saturday evening, May 16. The exercises were opened with prayer by Mr. Rudolph I. Coffee, which was followed by a salutatory by Ferdinand L. Adler. Several essays written by members of the various classes were then read. A piano solo by Henriette Michelson and a soprano solo by Miss Fredricka Raymond were admirably rendered. The valedictory was given by Mr. Abraham Thorne, after which the president of the association, Mr. Percival S. Menken, made an address and presented prizes and diplomas. The closing feature of the evening was the singing of "America" by the audience.

On Sunday afternoon, May 17, the annual meeting of the association took place. Mr. Percival S. Menken read the reports of the various departments. The report shows great progress during the year in all undertakings. There was an increase of membership, receipts and in work accomplished. After the reading of the report addresses were made by Hon. Edward Lauterbach, Mr. M. Warley Platzek, Mr. J. H. Schiff and Hon. Isidor Straus. A resolution was presented and carried empowering the association to secure necessary legislation enabling it to extend the work and organize branches.

HELP KISHINEFF.

Special Appeal.

The full details of the horrors of Kishineff are too well known to our brethren for it to be necessary for us to repeat them.

We feel, however, that we should add the weight of our influence with you to spare no effort to raise funds for the relief of the suffering which has been so wantonly inflicted upon the unfortunate people, whose only crime is that they are steadfast to the God of Israel.

Strong in our belief that "Israel hath not been forsaken, nor Judah of his God—of the Lord of Hosts"—we ask you to appoint committees to call mass-meetings or, in whatever way may be most suitable to the circumstances of your congregation, do everything in your power to add to the storm of indignation against Russia's cruelty and swell the funds that are being raised for the healing of the sick and clothing of the naked and the feeding of the hungry of our coreligionists in that distressful country.

In co-operating with the Special Committee, that has been formed to take charge of this matter, of which our Vice President, Mr. K. H. Sarasohn, of the Jewish Daily News, is chairman, we feel sure that our people will joyfully answer our call. Yours faithfully,

The holy rite of confirmation will be administered upon the loyal children of the fashionable Reformers.

The proper way to stop the "get" scandal, is to heavily fine the so-called Rabbis who deceive those poor people and encourage bigamy.

The Board of Jewish Ministers is waking up. It gives promise to do some joint work, instead of having each member thereof labor exclusively for his own interests.

Communal problems as great and difficult as those affecting the Jews of New York will fail of solution, unless the ministers and leading laymen will bend all their energies to the task which, at present, is a most stupendous one.

In the farewell reception tendered to Dr. Kohler and his estimable spouse, the community realizes that a man of some note and distinction is about to leave a prominent pulpit for a call which appeals strongly to his temperament and inclination.

The Philadelphia Ledger says: "The Jews have a greater number of religious papers, proportionately, than any Christian denomination, and their papers are the best supported." The latter part of the statement will make some of our contemporaries smile.

Temple Emanu-El's Memorial Services for the deceased Dr. Gustave Gotthell constituted in every sense a garland, the individual parts of which were tender reminiscences, loving recollections, interspersed with the music of the choir of which he had just occasion to be proud, as he always was.

The phase which Jewish religious management has assumed in England may be severely condemned. But some of its features might well be adopted for our conditions here. Not the least worthy of these noticeable differences, is that which makes the congregational official in the British Empire secure in his position after a reasonable trial for a term of years.

So is the third book concluded on this Sabbath, and the words of greeting are הוֹק, הוֹק, וְנַחֲחוּקוּ "Be strong! Be strong! and let us strengthen ourselves!"

These words contain a world of expression. Oft and again these words are called out to a person struggling with fate; when the burdens press upon him heavily, and he pants and sighs under the unremunerative toil that he has to perform, leaving him almost despondent and faint. Then the words are given him by some in encouraging tones, "Be strong! be strong! don't despair!" or perhaps, the poetic message of comfort by Longfellow, so synonymous with this greets his ears:

"Be still, sad heart, and cease repining, Behind the clouds the sun is shining!"

There is nothing nobler, nothing higher in religious acts than to extend the warm hand of brotherly love to the failing, falling brother—to the distressed and needy one; but of what use are empty words, unaccompanied by substantial succor! "Be strong! Be strong!" What a mockery to utter them, and keep heart and purse tightly clasped! A loaf of bread does the hungry person more good than a thousand sweet encouraging words.

Still, it is the way of the world. There are thousands who cry, "be strong!" to those that need help, to one who will modestly give substantial help; there are again so many who depend upon the help of friends and relatives who, at the last moment, find themselves deceived and mistaken, as Isaiah has it:

אִישׁ אֶחָד יִשְׁעוּ עִוְרוֹ וְלֹאֲחָיו יֵאמַר הוֹק

"Every man should help another, but even a brother says only, be strong!"

Here it is where our text gives the wholesome advice: "Blessed is the man who trusteth in the Lord, and the Lord will be his trust."

But the words of our ritual has no reference to material affairs. In a divine service, we must understand, we deal with spiritual feebleness. We find, indeed, too many who want others to be strong and courageous, standing up boldly and fearlessly for their religion, while they themselves are derelict in their duties, careless in their functions and lukewarm in their faith. They admire the steadfast religionist; they respect and appreciate the בְּקִימָה וְזוֹמָה וְלֹא יִרְאוּן מִכָּל אָדָם "ones who are upright and fear no man in the performance of religious exercises," yet themselves are feeble and cowardly.

If they could but erase the distinctive features of their visage, if they could change the form of their countenance that betrays them—because of which they are recognized as Jews, what would they not give! A thousand set of Chanukah candles they would cast aside for one Christmas tree, they would prefer a few Easter eggs to all the serogim and lulovim. They feel highly flattered if some hypocrite remarks that they do not look like Jews, or do not act like Jews; as if the actions of a Jew were not throughout as hon-

orable and as honest as the best people of any religion.

Here it is where the words are most fittingly applied, הוֹק, הוֹק, "be strong! be strong!" Cast your fears away, and stand fast and bold for God and your religion. "Blessed is the man who trusteth in the Lord." But if we call to others הוֹק, let us apply to ourselves the הוֹק. Let us follow our own advice and strengthen ourselves. Let us not want others to be God-fearing and religious and we be Godless and irreligious. Take the strength from each chapter, each verse, each precept that we hear read in the Torah and when each of its books closes, let us strengthen each other as prescribed in the Torah, trusting in God if we need help and not confiding in man; for blessed is the man who trusteth in the Lord.

"Klein Aber Rein."

Just now it is the vogue to quote Einhorn, to give him credit for his work on behalf of Judaism in America and to almost deify the early Reformers of this country. In viewing the teachings of these dead heroes, the eulogists forget to inquire into the relation of the actual work done for the Jews of this promising land and the good that might have been accomplished, had Einhorn and his compeers seized upon the universal theory and not the particular and limited propaganda of Reform.

At one time in his career Einhorn uttered the memorable words, klein aber rein, in order to apologize for the paucity of membership in his Baltimore congregation. He was willing to influence the lives of a small number and neglect the vast majority whom he might have inspired by his fervid eloquence. To this day the traditions of that particular congregation are maintained, even though contrary to the wish of the leaders. While other congregations, sister bodies, are growing and advancing in strength and numbers, Einhorn's old charge remains disappointingly klein. As for the qualifying adjective rein, it is to be doubted whether the moral tone, the social life, the home-like virtues, the loyalty to the religion of the fathers, the patriotic feeling for this country, and even the intelligence of its constituent families, are superior, finer or purer than those cultivated by the other and decidedly larger congregations in the same city. It is decidedly more Radical, and the members heed not the rabbinical mandates nor observe the Biblical ceremonies. That congregation has a notoriously poor attendance on Saturday, and on Sunday it is but a trifle larger.

If religion is to be judged by its results on men and women, in what way are the "select few" of Einhorn's old charge to be thought better than their neighbors. They are no more charitable, make no more sacrifices for Judaism, lead no nobler lives, conduct their public and private affairs in no more approved fashion ethically. Why, then, should Einhorn have sought to segregate his followers on a religious basis from their brethren and declare them to be, therefore, a constituted body that was "klein aber rein."

This is but another of those fanciful conceits, and a sample of the farcical airs assumed by our would-be superior Reformers.

What Can We Do?

From the present outlook, it would seem that of money there will shortly be no dearth for the relief of the sufferers from the unspeakable tragedies recently enacted in Russia. The better substantial reports present us with a condition of affairs which reflects sadly upon the governmental policy and the bigotry of the Christian clergy. Both these elements favored and in a manner even encouraged the massacres and depredations committed wholly on religious grounds, for no other excuse is at hand to account for the outrages.

A protest from America would be timely. These United States, thank God, stand now before the world as a power making for international justice and righteousness. It is recognized as a humane advocate for the rights of man. And we have a grievance against Russia, on the score of the latter's discrimination against our passports when carried by a Jew. Congressman Goldfogle of our city has been attempting to fight along this line in order to bring the Jews of this country to the point of maintaining their rights to protection by the government and the government itself to the point of politely insisting that Russia honor its passports as it does those of other nations.

It is no longer a question of money. Relief will come to those who have been forced into want and penury and wretched despair. Strong pressure needs to be exercised for the prevention of future outrages of the most atrocious kind by infuriated mobs meeting with no check in their devilish work of destruction and annihilation. As co-religionists of the imperilled communities across the sea, we in safer port must exert ourselves, must stand as a unit, in declaring our abhorrence of the shocking crimes perpetrated in the name and for the glory of religion by a misguided peasantry and a most blameworthy clergy.

Secretary Hay startled the powers of Europe last summer. The same official as the mouthpiece of the President to the peoples of the world, can give utterance to a protest as strong and as forcefully sympathetic as was the one against Roumania, in the present crisis. It may assume a new form of international politics. But the twentieth century is likely to see many new developments in the carrying out of ethical theories, and the living up to but a part of the category of virtues preached as Christianity by those who profess that that religion is one of highest morality.

The counsel of hotspurs who are prepared to do violent things to the immobile Czar and his lieutenants high and low cannot be heeded just now when resolute and dignified action is needed to represent the indignant protests of America's humane populace, both Jewish and Christian.

The Governor of Kishinev has been deposed by order of the Czar. That is but a poor promise that future assaults will not be made upon Jews in such provinces where the government chief is willing to pay the penalty of office for countenancing the indulgence of a fanatical mob in a gloriously gory revelry involving such disastrous consequences as attended the recent massacres.

In Search of a Pulpit.

XVI.

The Lawyer in the Congregation.

The blight of materialism has settled upon communities even in their religious affairs. Congregations, like individuals, are "rated" high or low, according to the amount of wealth contained in them. A first-class congregation is one in which the "pick" of the business men of the community, the bankers and brokers, the captains of industry and men with the most extensive commercial relations, are members. Naturally, such aggregations of capital attract the best and most noted legal talent. Lawyers form, then, a most distinct layer in the composite stratum of a congregation, an admixture arguing for intelligence and culture, brains and enlightenment. When many attorneys are enrolled on the books of a religious organization, the rabbi regards himself as being in an exceptional congregation, as having charge of the religious affairs of a body which in point of intelligence and progressive thought must be regarded as one of the very first rank.

In provincial communities the lawyer is the factotum next to the minister. He may at one time have intended to become a rabbi himself. On the strength of that, he is all but an ordained minister, and assists the incumbent in the performance of minor functions, or deigns to give advice when he gets older and has established a good legal practice. He is the man of many scars, accumulated in battles against the opposing side on the subject of congregational policy. He is the man of many Orders. He is the orator par excellence of the lodges of the section of the country in which he has taken up his residence. Always introduced as the eloquent, silver-tongued orator, he begins to think himself a factor of no little importance and a faithful servant of Judaism. Usually holding high office he may become the arch dictator to the many servile followers who wait upon his opinion of the rabbi, so that they may follow suit in praising or condemning the man who occupies the pulpit by virtue of their suffrage.

It was my good fortune to have just such a lawyer in my congregation, a man most susceptible to flattery and adulation, one who traced every good work to his influence and might. No one could gainsay the fact that he was a power. The side on which he arraigned himself was surer of victory than the other. The "Judge," as many in a spirit of compliment termed him, could be won by either the senior or junior rabbi for any cause, if he was enlisted beforehand for its espousal by either the one or the other. Owing to his extreme vanity he was a perfect weather-vane, turning as the wind of flattery blowed at the moment. Being so fickle he could not be depended upon to yield unflinching support to either one or the other. The "Judge," as one of the highest dignitaries in the synagogue, wielded his undoubted power as momentary caprice or temporary feeling of self-satisfied vanity dictated. It could not be otherwise than that before long my "Bismarckian co-adjutor" in the pulpit would use this easily-led official against me.

And so it proved! By promising him the award of the highest office in the gift of the congregation (an offer

most tempting to this legal luminary, because of the implied compliment) a most bitter warfare was waged, with my own official head in the balance.

At one of the annual meetings considerable surprise was expressed at the manner in which certain men who had never before been interested in the welfare of the congregation showed their activity. A regular ticket had been made out and a copy handed to every doubtful member, so as to guide him in the selection of candidates for the offices. The meeting was unprecedentedly large. Our friend, the "Judge," was put in nomination for the Presidency. As the head of the congregation was a perfect gentleman and in every sense of the word an exemplary Parnass, the move for a change was not understood except in the light of a conspiracy. It afterwards transpired that my "Bismarckian co adjutor" had had caucus meetings, had gone around canvassing, had as the result of sundry interviews, made up a slate perfectly in accord with his own ideas, that is, one in which worthy and honorable trustees of many years' standing were to be deposed to make room for my "Bismarckian co adjutor's" minions and henchmen. One of the trustees openly declared that once, when on a Sunday he visited the Sabbath School, he was in all seriousness approached by the senior reverend doctor with the suggestion that, if he would vote and use his influence against the associate rabbi, he would be maintained in office, otherwise he would lose caste and office. He was made a victim of my "Bismarckian co adjutor."

But the "Judge" was not elected President, and I was not defeated as associate rabbi. But the senior rabbi strutted about like a peacock and was everywhere congratulated for his shrewdness and political fluency, for the masterly stroke of genius by which he almost wholly controlled the convention of members at the annual meeting. And the political star of the "Judge" was not ascendant then.

One of the spring holy days occurring on a Sunday, I had a splendid opportunity to lay before the congregation the logical alternatives of being wholly loyal and faithful to Judaism, or of being inconsistent Jews. This was made clearer by strong, direct language, pointing out how, where and when the improvement and change might be made. The address was the talk of the people wherever they met. My friend, the "Judge," was loud in his condemnation and denunciation. Asked his opinion by one man in a public conveyance with him, he replied in loud, stentorian tone, so that every one present could hear his pompous comments, that the doctor took advantage of his position, inasmuch as no one could answer him, and that it was not the part of prudence to assail the community when once in a while it assembles in a body.

"Withal did the "Judge" have his good points, and very strong redeeming qualities. If he could not be depended upon, he was generous to a fault. If he was "wobbly" in principle and character, he was exceedingly liberal. If he could be won over by flattery, he was overzealous in a good cause which enlisted his sympathy. He had a high opinion of the ministry and, sometimes, even expressed his regret at not having clung to the love of his youth. He also had strong

The altar of Reform has one horn (קרן אחד), of which in certain circles constant mention is made and the sacrificial victims are all tributes to the glory of Einhorn. The fabled unicorn has had his fame dimmed by the lustre of the never-to-be forgotten master who preached well but was as fallible as the rest of them, Hirsch (horn) and the others.

I have my own troubles with the self opinionated composer, who thinks he knows English better than I do. But my particular angel of fate never tampers with my presentation of facts. Therefore it must have been a wise and well-informed type-setter who described the *American Israelite* as "some unimportant organ of public opinion." The truth is hard to bear. Therefore my sympathies are all with Leo Wise, the publisher and "better-than-thou" editor of a Jewish journal.

Poor, poor, Hirsch! The much-abused Western Apostle is always being attacked in the Eastern Jewish press. He fondly imagines that the power of the Atlantic coast journalism is used for no other purpose than to belittle him or make him out an ogre of startling dimensions. It is not so bad as all that. Else he would never have received so flattering a call from Temple Emanu-El as he did a few years ago. Whenever he happens to speak in the East, he always comes out with his hobby about his being pictured as a monster of terrific proportions to the readers of Jewish papers.

Yet a man who is given credit for so palpably absurd an utterance as that the choir in a Jewish temple would sing "Let the King of Glory Enter" if Jesus were to come into a synagogue, is deserving of every castigation and form of lampooning from every writer of the Jewish press. And if he never said such a thing and was misrepresented, let him pitch into the Western press—which is responsible for ascribing the remark to him. Still, I think that as the Western Apostle his choir would be made thus to greet the advent of Jesus into Sinai Temple of Chicago.

I never did care for a man who, in

full possession of his faculties, knowingly and wittingly, after having the opportunity to carefully weigh his thoughts before uttering them, condemned another man, or embraced one line of thought, or held certain views, and when certain personal complications arose and personal interests were at stake, reversed their decision and radically altered their convictions concerning the man or the subject. It looks too much like lack of manliness and argues for want of sincerity either the first or second time.

Dr. Wise Always encountered the most hostile antagonism from within the ranks of Reform. The great Cincinnati leader was belittled by certain strong forces in the same party which with his characteristic desire for unification he was endeavoring to weld together in all its parts. He resorted to all possible diplomatic moves to force them into line. But they broke away soon after with nothing but harsh words against the man whose genius was great enough to overcome even their jealous enmity.

The odor of the incense now being offered at the altar of the Western Pope by quondam enemies is nauseating. The humility with which they now describe his greatness, the adulation with which they to-day picture his achievements, and the reverential homage which they now pay to the Reformer whose work they purposely and conscientiously obstructed with every possible form of hindrance, are sickening to the observer, and prove that even in theological circles an interesting game of politics is being played.

But a few short months ago, Hirsch was an admirer of Dr. Schechter. Since then the brother-in-law of the Western Apostle has been elected to the Presidency of the Hebrew Union

had denied the personality of Moses and had characterized the Bible account of the revelation at Sinai as a legend. What wonder that they had misinterpreted the restoration for which the orthodox Jew prayed. The preacher advanced powerful reasons to prove that the spiritual mission of Judaism would be far more successfully performed by Israel restored to Palestine than by a scattered people, persecuted or tolerated, and without a central authority.

A New Departure in Soliciting Life Insurance.

The following letter which has been sent out by the Mutual Reserve Life Insurance Company to its agents explains itself:

To Managers and Agents:

We have decided, after giving the matter very careful consideration, that it is for the best interests of the life insurance business generally to cease the publication and circulation of competitive and comparative literature, and we therefore write to advise you that we have definitely decided not to publish hereafter, directly or indirectly, nor to permit our representatives to publish, directly or indirectly, or to circulate, any literature or advertisements referring in any way to any other American life insurance company. For the purpose of making this rule the more effectual, you are hereby instructed that you must, not later than June 1st next, destroy all competitive and comparative material in your possession. (Of course you understand that this does not refer to any standard publication, giving information regarding all companies.)

Further, you must not encourage, aid or abet, directly or indirectly, any hostile criticism or attack of any kind in the press upon any American life insurance company. In order to impress you with the deep interest we have taken in this matter, and our determination to enforce the same, we feel compelled to say that any agent who fails to observe the above instructions will be subject to immediate dismissal or to make such amends as this company may deem proper. Agents and other representatives not under direct contract with the home office of this company, who are authorized to employ or contract with subordinate agents, must be notified at once of this understanding, instructed to adhere strictly to it and be required to sign an agreement that they will do so. This does not mean that if we are unjustly attacked by another company, or by its agents, we are debarred from defending ourselves. We have never failed to defend ourselves when attacked, and in the future we shall protect our policyholders against all unjust assaults which might affect their interests if not properly met, but no such assaults are expected. On the contrary, we have the assurance of our three largest competitors, the Mutual Life Insurance Company, the New York Life Insurance Company and the Equitable Life Assurance Society, that they have taken action similar to ours, and that they have sent instructions identical with these to all of their representatives, and we most sincerely hope that all other companies will adopt the same course and instruct their agents accordingly, with the view of putting the work of the solicitor upon the highest possible plane.
