### A Unitarian View of the Jew.

They are scattered throughout the nations of the world. To-day there are something like 12,000,000 of them, I am told. Half of these live in Russia; the largest number outside of Russia in any one place is found here in the city of New York. A wonderful people; a people who, without any land, without any rulers, has kept itself distinct, as the Gulf stream flows through, but does not mingle with, the waters of the Atlantic. Their traditions, their rituals, their religious ideals, as well as their love for their own people, have kept them compact and united; a sympathetic people wherever they are scattered. I wish to call your attention to some of the wonderful things that we owe to this people, to show you how Judaism is wrought into the life of all of us.

A babe is born; Jewish words are used in the rituals of his christening, and in New England, at any rate, for 200 years of Puritan history, the chances were that he was christened with a Jewish name. No other people on the face of the earth have given so many names to Christendom as have the Jews.

The child grows up. In the Sunday school, in the home, in the day school, in the church, he becomes familiarized with Jewish history and Jewish geography, until the chances are that he knows more about them than he knows about even his own history; the hills, the lakes, the rivers, the valleys, the

fountains, even the wells of Judea are familiar names to him, and across the stage of his childish imagination passes a procession of Jewish figures, sublime and noble.

The child grows up, and when the time comes for him to be married, again Jewish sacred words which make up, nine times out of ten, the marriage formula. He goes out into life and he meets with trouble and sorrow; he goes to Jewish words for consolation and peace. He prays for help, and Jewish words and Jewish formulas fall from his tongue. He is in joy, and the chances are that he recites some Jewish song of thanksgiving.

The time comes for him to die, and again he turns to Jewish sources of consolation, of resignation; Jewish prayers are the last, perhaps, that he hears; he looks forward to a Jewish resurrection; he peoples the other world with Jewish angels; he sees the great white throne on which sits the Jewish God.

This has been true throughout nearly the history of the Christian world. He goes to church, and if he knows where it comes from he recognizes that the church is the lineal descendant of the Jewish synagogue. And, to crown the marvelous story, for 1,500 years nearly all Christians throughout the civilized world have prayed to and worshiped a Jewish prophet as God.

Consider some of the achievements of this people in other directions. There is hardly a department of human thought or life in which you will not find a Jew somewhere in the very front rank. If you should select the six finest and most beautiful lyrics that the world has produced up to the present time the Twenty-third Psalm would be at least one of them. One of the greatest dramatic poems of the world is Jewish—the poetic poems of the world is Jewish—the Book of Job. Among the world's greatest composers, a list to be counted almost on the fingers of your two hands, you find two Jewish names—Meyerbeer and Mendelssohn.

It goes without saying that the Jewish race has produced the greatest financiers. If you turn to the department of philosophy, there are few names that stand higher in intellectual power, in moral enthusiasm in England than that of the Jew, Benedict Spinoza. Jews

disabilities were removed from the Jews in England, and I can remember when a condition like this existed: The leading financier was a Jew; the leading man at the bar in London, the most famous lawyer in the whole country, was Judah P. Benjamin, a Jew; the most famous judge of the Queen's Bench was Sir Geo. Jesse, a Jew; the Prime Minister was Benjamin Disraeli, a Jew. So that the moment opportunity was offered in England this marvelous people rushed to the front and occupied the highest positions in the national life.

If we turn to other departments we find that there are no more famous names among the world's philanthropists than those of Moses Montefiore and the Baron and Baroness de Hirsch. In ethics we admire Seneca, Marcus Aurelius, Epictetus, the writings of Confucius and many another moralist; and how do we praise them? We say that their ethical principles and teachings are almost, if not quite, as good as those of the Jews. That is the last word we can say in their praise.

And another thing I like to remember in justice to this people: I am told that there are no Jewish paupers in any country of the world left to be looked after by Gentiles; they care for their own poor. I am told, which seems to me to speak wonders for the Jewish character, that in no country of the world do you find Jewish women on the town. This is a remarkable record for one little people. Can you match it anywhere in the history of the race?

But we do not like them. When I say that I am speaking not a personal word, but on behalf of the general public. So far as I know, there is not a race in the world in the midst of which the Jews live where they are liked. There seems to be enmity, antagonism, whatever may be the reason for it, almost everywhere. You remember the popular verse:

I do not love thee, Dr. Fell,  
The reason why I cannot tell;  
But this alone I know full well,  
I do not love thee, Dr. Fell.

A great deal of the dislike of the world is summed up in that witty verse. There is another reason for the dislike. It remains over from those days of universal antagonism, when every tribe had to fight for its life. We instinctively dislike people who are foreigners, who are aliens. We do not feel quite at home with them.

Then it is certain that the Jew is pushing, that he is aggressive, that he makes himself unpleasant; he wants to get ahead of everybody else, and does not always take the most polite way to accomplish this end. That is true, I presume, of a great many Jews, but I question very seriously as to whether that characteristic is exclusively confined to them. When they do try to get ahead they almost always succeed; perhaps that is the reason we don't like them any better. We are willing to let a man get ahead of us if he stumbles and falls, but if he succeeds we don't like him.


Then it is said again that the Jews are vulgar, that they love display. That is true of a great many of them. I have met a good many in the course of my life who were almost as vulgar in the display of their ornaments and wealth as are some of the distinguished members of New York's four hundred, who come late in order to show themselves off in the boxes of the Metropolitan Opera House. I say the Jews are almost as vulgar in this display as they are. I don't like it in anybody, but I do not know why we should confine our dislike or the expression of it entirely to the Jews. And we must remember in explanation of this, if it is true, that the Jews are Orientals—that the Orientals universally love color, love beautiful ornaments, love this sort of personal decoration.

Again it is said that the one god of the Jew is money; that it is the only thing he really cares for—his money and the power that comes from the possession of it; and it is further said that he is not at all unscrupulous about getting it. The Jew is supposed to be universally dishonest; it has come to be a name with us for it, a proverb; to "Jew" another is to treat him dishonestly, is to squeeze out of him by any process that which he possesses and which you desire.

I have known a great many Jews in my life; some of the noblest, sweetest, simplest, most unselfish, most patriotic, most philanthropic, tender-hearted people I have known were Jews. I speak of this charge because it is popularly made; I do not indorse it. I have not had business experiences that enable me to speak with the authority of a business man, but I wonder whether this impression does not grow out of the fact that the Jews are congregated together in a city, that they are easily marked as Jews, and that we are very apt, if we have one unfortunate experience with a Jew, to attribute the same characteristic to the entire people. I do not believe there are any more dishonest men among the Jews than there are among any other race in the world; whether there are more of them I do not know. I have no right to speak on that subject.

There is another characteristic of the Jews which has been the chief cause, probably, of international hatreds, and that is nothing less than an insult to intelligence and a disgrace to civilization—that is the religious hatred, I said a moment ago that we Christians are nintenths Jews, both in our morals and our religion, and almost the only thing that

On Saturday, June 6, Mayor Low, in accordance with the law recently passed at Albany, appointed Julius G. Kremer of 213 East Broadway judge of the new Municipal Court to be located in the Fourth Assembly District.

For many years the Jews of this neighborhood, who were litigants in the District Courts, have had great difficulty in presenting their cause in the proper light. In many cases the judges were entirely ignorant of the Jewish language and customs, and were always compelled to accept the obscure, if not meaningless, translation of an interpreter.

But now, with the new appointment, old conditions will change, and the Jewish litigant may certainly feel at home in the court to be presided over by Judge Kremer. They will be able to express themselves in plain Yiddish and will be attentively listened to by one of their own kind.

Born and brought up all his life in the heart of the East Side, he is thoroughly familiar with the language, mannerisms and shortcomings of his race. Always kind-hearted, sympathetic and amiable, known at no time to speak ill of an enemy in and out of politics, he is admired by all his friends, and has truly earned for himself the title "Judge." Though but thirty years of age he has been practicing law for almost ten years and is well up in District Court practice. He received a thorough education, being graduated from Grammar School No. 75 in 1888, attended the City College of the City of New York and graduated from the New York University Law School in 1894.

Judge Kremer's father, Hillel Kremer, is an old and respected resident of the district; he is a prominent and active member of the Beth Hamedresh Hagadol as well as of all the leading worthy charitable institutions, and the son, like the father, is never wanting in any philanthropic movement.

In 1897 the James G. Blaine Club of the Fourth Assembly District, an organization composed of the representative Jewish merchants of the East Side, nominated Judge Kremer for Member of Assembly, and though he was not elected he succeeded in polling such a large number of votes as to cause the Republican party to recognize the Blaine Club as the regular Republican organization of the district.

We heartily congratulate the Mayor upon his excellent selection, for we know that Judge Kremer will add to the dignity of the bench to which he was elevated and that the East Side will hail his appointment with delight.

The Independent Order of B'nai B'rith has taken upon itself the mission of uniting Israelites in the work of promoting their highest interests and those of humanity; of developing, elevating and defending the mental and moral character of our race; of inculcating the purest principles of philanthropy, honor and patriotism; of supporting science and art; alleviating the wants of the poor and needy; visiting and attending the sick, coming to the rescue of victims of persecution; providing for, protecting and assisting the widow and orphan on the broadest principles of humanity.

The Executive Committee of the Order met on Sunday last at the Arlington Hotel in Washington, in annual session. President Leo N. Levi presided. There were present: Sol. Sulzberger, of New York, representing District No. 1; Jacob Furth, of Cleveland, representing District No. 2; Hon. Joseph D. Coons, of Wilkes-barre, Pa., representing District No. 3; Hon. Simon Wolf, of Washington, of District No. 5, and Hon. Adolph Moses, of Chicago, of District No. 6; Julius Bien, of New York, chancellor. A good deal of routine business was transacted. The Russian massacre, in reference to which a conference was held with President Roosevelt and Secretary Hay, received much attention. A memorandum, reciting the facts of the massacre at Kishineff and a petition to the Czar, in tentative form, was presented to Secretary Hay. In reply to the address, the Secretary said:

No person of ordinary humanity can have heard without deep emotion the story of the cruel outrages inflicted upon the Jews of Kishineff. These lamentable events have caused the profoundest impression throughout the world, but most especially in this country, where there are so many of your co-religionists who form such a desirable element of our population in industry, thrift, public spirit and commercial morality. No body can ever make the Americans think of the Jews as a class or as a race—we know them too well. In the painful crisis through which we are now passing the Jews of the United States have given evidence of the highest qualities—generosity, love of justice and power of self-restraint.

The Government of the United States must exhibit the same qualities. I know you do not doubt the sentiments of the President. No one hates more

energetically than he does such acts of cruelty and injustice as those we deplore. But he must carefully consider all the circumstances and then decide whether any official action can be taken in addition to the impressive and most effective expression of public opinion in this country during the last month.

You will have observed that no civilized Government in the world has yet taken official action—this consideration alone would bid us to proceed with care. The Emperor of Russia is entitled to our respect, not merely as the ruler of a great and friendly nation, but as a man whose personal character is even more elevated than his exalted station.

We should not be justified in assuming that this enlightened sovereign, who has given so many proofs of his devotion to peace and religious toleration, has not done and is not doing all that lies in his power to put a stop to these atrocities, to punish the guilty, whether they belong to the ignorant populace or to high official circles, and to prevent the recurrence of the outrages which have so shocked humanity.

In fact, all we know of the state of things in Russia tends to justify the hope that even out of the present terrible situation some good results may come; that He who watches over Israel does not slumber, and that the wrath of man, now, as so often in the past, shall be made to praise Him.

Accompanied by Secretary Hay, the delegation then went to the White House and laid the matter before the President. Mr. Roosevelt listened attentively to the statement made by Chairman Levi and replied as follows:

Mr. Chairman, I need not dwell upon the fact so patent as the widespread indignation with which the American people heard of the dreadful outrages upon the Jews in Kishineff. I have never in my experience in this country known of a more immediate or a deeper expression of sympathy for the victims and of horror over the appalling calamity that has occurred.

It is natural that while the whole civilized world should express such a feeling, it should yet be most intense and most widespread in the United States; for of all the great powers I think I may say that the United States is that country in which from the beginning of its national career most has been done in the way of acknowledging the debt due to the Jewish race and of endeavoring to do justice to those American citizens who are of Jewish ancestry and faith.

One of the most touching poems of our own great poet, Longfellow, is that on the Jewish cemetery in Newport, and any one who goes through any of the old cemeteries of the cities which preserve

the records of Colonial times will see the names of many an American of Jewish race, who, in war or in peace, did his full share in the founding of this nation.

From that day to this, from the day when the Jews of Charleston, of Philadelphia, of New York supported the patriotic cause and helped in every way, not only by money, but by arms, Washington and his colleagues who were founding this Republic—from that day to the present we have had no struggle, military or civil, in which there have not been citizens of Jewish faith who played an eminent part for the honor and the credit of the nation.

I remember once Gen. Howard mentioning to me the fact that two of his brigade commanders upon whom he had placed special reliance were Jews. Among the meetings of the Grand Army which I have attended one stands out with peculiar vividness—a meeting held under the auspices of the men of the Grand Army of Jewish creed in the temple in Forty-fourth street, Temple Emanu-El, to welcome the returned veterans of the Spanish-American War of Jewish faith.

When in Santiago, when I was myself in the army, one of the best colonels among the regular regiments, who did so well on that day and who fought beside me, was a Jew. One of the commanders of the ships which in the blockade of the Cuban coast did so well was a Jew. In my own regiment I promoted five men from the ranks for valor and good conduct in battle. It happened by pure accident, for I knew nothing of the faith of any one of them, that these included two Protestants, two Catholics and one Jew; and while that was a pure accident, it was not without its value as an illustration of the ethnic and religious make-up of our nation and of the fact that if a man is a good American that is all we ask, without thinking of his creed or his birthplace.

In the same way when I was Police Commissioner in New York I had experience after experience of the excellent work done—an excellent work needing nerve and hardihood, excellent work of what I might call the Maccabee type—in the Police Department under me by police officers of Jewish extraction.

Let me give you one little incident with a direct bearing upon this question of persecution for race or religious reasons. You may possibly recall—I am sure certain of my New York friends will recall—that during the time I was Police Commissioner a man came from abroad—I am sorry to say a clergyman—to start an anti-Jewish agitation in New York, and announced his intention of holding meetings to assail the Jews.

**To Co-operate with Hebrew Charities.**

About 200 societies were represented at a mass meeting held last Saturday night under the auspices of the United Hebrew Charities in the auditorium of the Educational Alliance Building, for the purpose of securing active co-operation between that organization and the various societies on the lower east side in the collection and distribution of funds for charitable purposes.

Resolutions were adopted at the close of the meeting providing for the appointment of a permanent committee of fifty to collect funds for the United Hebrew Charities from the east side contingent and to obtain a representation on the Board of Directors of that organization and a voice in the distribution of its fund for the east side societies.

Adam Rosenberg, a lawyer, presided, and the speakers of the evening included the Rev. Philip Jaches of the United Hebrew Charities, Justice Greenbaum of the Supreme Court, Nathan Bijur, Joseph Baroness, Morris Rosenfeld, Dr. Joseph Seff, the Rev. L. H. Maslansky and Dr. L. K. Frankel. Jacob H. Schiff wrote a letter expressing his regret at not being able to attend and declaring himself in sympathy with the work.

**For the Care of Dependent Jewish Children.**

Pursuant to resolutions of their respective societies, committees from the Hebrew Benevolent and Orphan Asylum Society, the Hebrew Sheltering Guardian Society, the Hebrew Infant Asylum, the Jewish Protectory and the United Hebrew Charities have formed a permanent committee to consider the question of the care of dependent and delinquent Jewish children who are at present or who may in the future become inmates of non-Jewish institutions.

The Jewish Protectory, represented by Messrs. Louis Marshall, Henry Solomon and Samuel B. Hamburger.

The Independent Order B'nai B'rith, through the chairman of its Executive Committee, Leo N. Levi, Esq., has expressed its willingness to co-operate with the Permanent Committee in furthering this movement.

In the belief that many of the above-mentioned children can be advantageously cared for in private Jewish homes, the committee is desirous of obtaining a list of the names and addresses of Jewish families in the State of New York who would be willing to receive such children either as members of the family or with payment for board for a limited period.

All applications for children should contain some statement regarding the location of the home, the financial conditions of the owner, the possibilities for secular and religious instruction for the child committed to the foster parents' care and letters of reference from the rabbi or local officer testifying to the good repute of the foster-parents.

The work of the Brooklyn Hebrew Gemilath Chasodim is shown in the report just issued by the president, Mr. N. Premsky. It is as follows:

Total outstanding loans to Jan. 1, 1903.....\$2,323.86  
From January, 1902, to January, 1903, the total income including members' dues, donations and benefits .....\$1,236.65  
Expenses ..... 614.99

Balance .....\$621.66  
Brought down.....\$2,323.86  
Total .....\$2,945.52

Of this last year we have in out-standing accounts.....\$2,377.50  
Cash on hand and in banks..... 568.02

Total .....\$2,945.52

During the year loans without interest ranging from \$5 to \$25 and amounting to the sum of \$10,913 were distributed to 1,030 needy sufferers, against \$7,486 to 741 individuals in 1901. Collections amount to \$10,219, as compared to \$6,711 in 1901. During the last four months from January to May 1, 1903, loans to the amount of \$4,970 were distributed to 475 individuals.

Three facts are easily deduced from the foregoing report:

(1) An increase in loans. (2) Increase in collections. (3) Increase in demands since the demands exceed the collections. The logical conclusion is that we cannot keep pace with the growing demands.

The loans are made to people who in their struggle for existence unfortunately meet with difficult circumstances and who, although ambitious, yet on account of the lack of a few dollars cannot continue in their various trades or professions. All precautions are taken to attend promptly to and respect the beneficiary. He does not receive a gift, but a loan, which strengthens his ambition and self-respect and does not—as in the case of charity—tend to encourage idleness and weaken his energy. The beneficiary is placed on equal footing with the benefactor and the loan urges him, in his endeavor to repay the sum borrowed, to strive for a livelihood and support his family. Thus you can readily see that the society stands not only for the most benevolent cause of helping a brother to help himself, but also encourages ambition and self-respect. We, therefore, in the name of suffering humanity appeal to every liberal-minded man and woman to aid us in our noble cause and to become a member of the society and thereby increase the funds to meet the increasing demands. With heartfelt thanks to all our members and friends whose kind assistance has enabled us to carry on our benevolent work during the past year, I remain,

**Israelite Alliance of America.**

The following is the first annual report of the Executive Committee of the Israelite Alliance of America since its organization, in January, 1902, which may be briefly outlined as follows:

In January of that year a meeting of delegates, numbering about 150, and representing over eighty societies throughout the city, was held at the Educational Alliance, at the solicitation of Mr. Nissim Behar. Among the prominent speakers who addressed this meeting were Mr. Nissim Behar, Dr. Henry M. Leipziger and Dr. David Blaustein. Sub-committees were appointed, and in May, 1902, a permanent organization was effected. At this meeting a constitution was adopted, containing the following preamble:

"Whereas, There exist in many foreign countries racial persecution and religious intolerance so cruel and inhuman as to arouse the indignation of all freedom-loving people; and

"Whereas, By reason of such persecution and intolerance certain American citizens are excluded from the enjoyment of well-recognized international privileges; and

"Whereas, The establishment of religious liberty and civil equality throughout the world is a characteristic of true enlightenment and in harmony with the spirit of American institutions;

"Now, therefore, we, as patriotic Americans, desiring to secure to all our fellow-citizens, of whatsoever race or creed, the enjoyment of well-recognized international rights and privileges and to remove the unjust discrimination against such citizens,

"Do hereby ordain and establish this society and this constitution."

And further set forth the following as its aims and objects:

"To study the problem and universal civil and political emancipation and religious freedom and equality in search of a solution thereof, and to extend our sympathy and aid to all movements directed thereto.

"To secure for American citizens, irrespective of race or creed, the enjoyment of all well-recognized international rights and privileges.

"To interest especially the American Jewish youth in, and encourage them to apply themselves to the study of American Jewish questions."

Work of propaganda along the lines indicated in the constitution was planned for various committees, who met from time to time and accumulated data relating thereto.

One of the most important problems which commanded the attention of the organization at an early date was the discrimination of the Russian government against American citizens of the Jewish faith, solely because of their religious belief, and in order to arouse public interest in the matter two meetings were held, respectively, on May 25, at Temple Rodeph Sholom, and on June 1, 1902, at the Educational Alliance.

At the first meeting addresses were made by Rev. Dr. Thomas R. Slicer, Hon. Samuel Greenbaum, Mr. David Lubin, Congressman Goldfogle and Mr. Nissim Behar, and at the second meeting Father Ducey, Hon. John DeWitt Warner, Dr. H. Pereira Mendez, Dr. David Blaustein, Mr. David Lubin, Congressman Goldfogle and Mr. Behar made addresses. Resolutions were adopted approving the action of the House of Representatives of the United States in inquiring into the attitude of the Russian government toward American citizens attempting to enter its territory, and respectfully urging the Executive and Congress to take all proper and necessary steps to remove such discrimination.

Both of these meetings were large and enthusiastic, and were fully reported in the public press. Copies of the resolutions were sent to the President, Secretary of State and all members of Congress of the United States, and many encouraging replies thereto were received.

Subsequently similar action was taken

by the Senate, calling upon the Secretary of State to furnish information on this subject.

In the Fall and early Winter of 1903 the organization directed its efforts toward securing new members and extending its influence. A committee was appointed to prepare a memorial on the Russian exclusion question, and a great deal of time and thought was expended in preparing this document, which is about to be published.

Meetings of delegates have been held from time to time throughout the year. Prominent speakers have made them interesting, and the same were favorably commented on in the public press.

**A Unitarian View of the Jew.**

*Continued from first page.*

distinguishes between the Jew and the Christian is the fact that the Christian has turned a Jew into a God, and hates his own people, who still insist that He was a magnificent man, the crowning name among the Jewish prophets, but still a man.

Suppose that the Jews did put Jesus to death nearly 2,000 years ago. Christians since that day, professedly in the name of the Jew of whom they have made a God, have put to death hundreds of thousands of men by tortures unspeakable, worse than any that were suffered that Friday afternoon outside the city on the cross. And think of the hideous absurdity of it—I know it is the foundation of Christian theology—the whole race damned because the first member of it sinned. Following that precedent, Christendom has held the Jewish race responsible for the crucifixion of Jesus for nearly 2,000 years. Suppose a clique, a group of men, did put Jesus to death; are the Jews to-day in Russia, the Jews to-day in Germany, the Jews in New York, responsible? This is visiting the sins of the father upon the children with a vengeance. And yet probably this religious prejudice, this religious hatred, has had more to do with the way the Jews have been treated than any other one cause.

Then the Jews are money-lenders everywhere. Take the literature of England; it is full of Jewish money-lenders, and they are always held up to obloquy. Why? I do not know. Here are the young noblemen, the scapegraces, who have gone from the country up to London, and who are calculating on the death of their father and their coming into the property, and who want money to waste on their mistresses, to gamble with, to drink with, to lead a roystering life; they cannot get it in any other way, so they go to a Jewish money-lender. And the Jewish money-lender is, of course, smart enough, as he makes a loan of this doubtful character, to ask a good rate of interest. Throughout English literature these Jewish money-lenders are held up to obloquy, and these young scapegraces are smart, fashionable young men. For which of the two do you feel yourself tingle with unspeakable contempt—for that kind of snobbish scapegrace or for the thrifty Jew?

The characteristics of the Jew in this matter come out here in New York. Jacob Riis tells us in one of his books that down on the East Side the Jew is sure to save money, no matter how little he is paid; he will starve himself, he will go without clothes, he will do anything, but he will save something. And by and by he owns the house he lives in, and the other people who haven't saved anything have to pay rent, and they hate the Jew who is thrifty and who has flourished.

To give another illustration. I shall cut across your reverence for Shakespeare, perhaps, in this one. I have been accustomed to say for years, that, in spite of his faults, if you leave out some of the lovely, beautiful, minor characters, the most decent character in "The Merchant of Venice" is Shylock. He is put upon and abused in every conceivable way and, after the fashion in English literature, is held up to ridicule. Portia's legal lore is clap-trap and quibble. In spite of his faults, the grandest wholly human character in the play is Shylock. And to show the drift of public opinion, the audience is expected to rejoice over the misfortunes of the tender, lovely, sweet Jessica, merely because she is the daughter of a Jew. Oh, I am ashamed of the human race when I face questions and problems like these.

No matter what the Jews may have been or what they may have done, I can match you their faults in all the other races. But grant that the Jews are all that anybody says they are. I want you as Christians to shoulder your share of the responsibility. Did you ever think that for 1,500 years no Jew was allowed to own real estate, not allowed to own or cultivate land; no Jew was permitted to enter the civil service of any people in Christendom; no Jew allowed to be an officer in any army or in any navy?

The only thing we have let the Jews do has been to trade, and they have been obliged to trade in such commodities as they could hide or carry away—jewels and valuable things that they could conceal; and the attitude of the kings and rulers throughout Christendom has been that of treating the Jews as their prop-

erty, their victims. We have not let the Jews do anything but be small traders, or large traders, in portable things; and they would have been mighty poor scholars, indeed, if, after 1,500 years of Christian drill in this exercise, they had not learned anything. As a matter of fact, they have learned to be the most expert traders in the world, and we have made them so by our persecution.

The Jews were originally an agricultural people in one of the best cultivated lands in the world, but we have taken away these things from them and turned around and kicked and cuffed them because they have been good scholars in the school to which we have sent them. If there are any mean characteristics in the Jewish people before you abuse them, subtract from the sum so many of them as Christianity has planted and trained in that way.

Now what are we going to do about it? It is said that the Government of the United States ought to issue an indignant protest to the Government of the Czar. I wish we could. But would not the Czar have a right to retort, "Physician, heal thyself?" Is not our house made of glass rather too brittle to encourage us to engage in throwing stones? Let the Government of the United States and the governments of the separate States, send protests first to the barbarism that exists here in America.

At a great public meeting the other night Dr. Lorimer suggested that we appoint a great committee of notable citizens and send them to Russia to lay the case before the Czar. I have no objections to any procedure of that sort, but I would like first to send a committee of notable citizens down to Louisiana to protest against the mobbing and murdering of Italians; out to California to protest against the mobbing and murdering of Chinamen; to Georgia to protest against the mobbing and murdering of negroes; to Kentucky and many another Southern State to protest against the condition of things that turns a whole family into murderers while they fight out, generation after generation, a feud until the last man of the line is extinguished.

I would like to have this delegation go to Illinois and Indiana. In Indiana a negro is seen talking with a young girl 13 or 14 years of age. Somebody, without knowing anything about it, suggests that he is insulting her. A crowd gathers, of these purifiers of society, and the negro is shot, and the young woman has not been hurt at all, and, so far as anybody knows, no crime has been committed. Until we in this country can cleanse our skirts a little, our lips should be closed so far as protest against any other country is concerned. This is flag day, and I should have loved to take it for my theme—the day on which we are to cultivate honor and reverence for the Stars and Stripes. I love the flag; I am ready to bow in its presence as being the symbol of liberty, of brotherhood, of humanity, of law. Oh, this is what it ought to be, but is it? Is it, so long as these things I have been hinting at are true? Let us cleanse our own flag, make it pure and white and sweet; then start, if we will, a crusade round the world for the suppression of inhumanity and barbarism. But meantime I am sorry to say we need to be a little humble about protesting to other nations. We must work for education here in this country; educate the people of both races, of all nationalities; we must work for the love of God and the love of man; create noble and true and fine ideals. And then, I am afraid that we must be patient, and wait, wait, wait, until civilization grows and men outgrow the wolf and the fox and the tiger and the snake, and climb up into the human.

But meantime, friends, let us, so far as this country is concerned, insist on justice, insist on equal laws for all people of every nation and every clime; fight for equal opportunities; let us fight for that civilization which takes the legal, though slower course, instead of joining in the madness of the mob that clutches at justice but really grasps anarchy and disgrace.

Dear Father, let Thy love be in our hearts and the ideals of justice and truth animate our minds and direct our conduct; let us be ashamed to be other than humane and just and tender, and true in our relations with any people anywhere around the world.

Sympathy, fellow-feeling and humanity can create the strongest of bonds; therefore the despised Russian Jew is now on everybody's lips.

The season of floods, cyclones and downpouring of rain which we have been recently enjoying, will appropriately wind up with the Annual Rabbinical Pic-nic at Detroit.

Our esteemed co-religionist Hon. Jefferson M. Levy, had the honor of entertaining President and Mrs. Roosevelt at dinner on Tuesday, the 16th inst., at Monticello, Va.

The Convention of Zionists looked for J. Leonard Levy when they were in Pittsburgh, but he had fled, leaving his promissory note behind him unpaid.

Attention is called to the speech of President Roosevelt delivered to the committee of the I. O. B. B. The address appears under B'nai B'rith notes on page 3.

Count Cassini is now trying to recant. Diplomacy, if not truth, should have shown him the dangers of uttering an aspersion and vile slander on the character of the Jew.

We cannot permit the slanderous statement that there are only about 927 Jews of quality in America. The American Hebrew has issued a circular to hotel keepers that it reaches only Jews of quality. Verbum sap.

Nathan Straus will shortly begin his summer work of philanthropy. Sweet indeed are the uses of adversity! For as a memorial of his own child's premature death, Mr. Straus has erected the life-saving booths which, by providing sterilized milk, have contributed to the lessening of mortality among the children of the poor.

Experience Makes Wise.

וכר ימות עולם בינו שנות דר ודר

"And they said unto Joshua, truly the Lord hath given into our hands all the land, and also the inhabitants have become faint-hearted before us."—Joshua i. 24.

We notice that the report of the spies sent out by Joshua is so different from the report of the spies Moses had sent out previously. Here they speak as if the land was already in their hands, as if the inhabitants stood already terrified before Israel, while the spies of Moses, twelve in number, reported the land very good and fruitful, but considered it so well fortified, its people such giants that Israel could never hope to take possession of it. Two of these spies thought differently. Joshua could not be compared in wisdom and ability to Moses, he was not the teacher and manipulator of men that Moses was yet his plan of sending but two men proved so much more satisfactory. Had Joshua sent out men for the first time as Moses did, he might have fallen into the same error, for Moses, after all, was fallible, even as the greatest of mortals are. But experience taught Joshua a valuable lesson. He understood that two men can more easily come to an agreement than twelve; besides, they are apt to do their duty more fully than the many of the larger body, where each one depends on the others. We all, the wisest of us, build the future upon past experiences. The greatest of generals study the tactics of the armies of the past and improve upon the errors as well as upon all movements of armies in ages gone by, and derive decided advantages from such study Joshua did the same.

Another point that comes to our notice. Moses had sent out picked men, doubtless the best he could find, the best in point of knowledge, the most faithful in religious observance. While Joshua, we are told, sent out two men, not regarding such qualifications at all, simply two men that were best fitted for that office. A spy must be a different man from any other functionary in an army. A good general would not necessarily make a good spy, or vice versa. A good soldier of the ranks would not yet make a good spy. They had to be מרגלים חרש דמבט, dumb spies, as we would render it, even as Rashi and the Midrash have it, that Joshua is supposed to have told them

עשו עצמכם חרשים ואחם עומרים אל איהם

"Make yourselves deaf that ye might better learn their sentiments (חרש means voluntarily deaf). That they were practical men we learn from their method and manner of procedure. They went into the house of a woman to stay over night. Now some overly-garrulous people would find serious objections to that course, and under ordinary circumstances it would be reprehensible. But, still, they went there, and were protected until they could leave Jericho to join their own ranks.

The Midrash supposes that the two spies were Pinchas and Caleb. If that is correct, they certainly were two tried and experienced, two staunch and faithful men, both of whom had become wiser by past experiences, and were fittest men for the work entrusted to them. We see the able report that they brought back, which encouraged the people and imbued them with

desire to move onward and occupy the promised land.

All in all, we learn the valuable lesson, that to serve a cause and benefit the people we have to profit by past experiences and adopt methods which are improvements upon those of former men, and in matters of importance, pick the fittest men to do the work as well as least number. Put scholars and working men in their respective places and never reverse this order, for, if you do, success cannot be attained. This holds good in every branch of life, communal or congregational. In lodge or society, in business or even family affairs, let our feet ever be guided by the lamp of experience, it will make us wise.

Jewish Students.

The graduates who went forth from the College of the City of New York were, in the large majority, members of the Jewish race. This manifestation of a desire for higher education by the Jewish youth is most creditable. Let us hope that armed with intellectual weapons and imbued with noble ambitions, this talent will tend to remove whatever anti-Semitic spirit is thoughtlessly engendered in this great land of ours. We feel that these students will lend their lives to the fulfillment of the best desires that the body of our people bespeak for them. It is a creditable exhibition which this large number of Jewish students presents. Godspeed to them.

The Modern Joshua.

Dr. Kohler in his farewell sermon said: "The East sees the immigration and the Ghetto, and there is a retrogression. The hope of Israel is in the West. There I will be the teacher of teachers of Reformed Judaism."

The fiat is thus given. Progressive Judaism will be smothered by the Russian "mashkeelim" of the New York Ghetto. Shades of Einhorn, Adler and Gottheil! Alas! Kohler has left us, hence retrogression. Poor, effete East, New York is thy modern Gib'on, where, at the command of the second Joshua, the sun of Reformed Judaism will stand still, but will shine in the West—the newly-elected teacher of teachers of Reformed Judaism will be there (a sort of Melech malchay ha'mlochim, "Supreme king of kings." HATSOFEH.

Self assertiveness may be a repellant quality at times. In some instances it is needed to repel an invasion of rights. The Jew has therefore to be extremely guarded in selecting the proper time and occasion for an exercise of the privilege of self-assertion, so that when he does allow himself to be heard, his demands may appeal to the humanity and justice of the world's best-thinking citizens.

We are taught better by calamity than by any other means. We look for the light more anxiously when darkness surrounds us than ever we did before when there was nothing but light around us.

Why do Reformers, as Kohler did in his farewell sermon, always look back to the splendid days when the Friday night was observed, and yet conscientiously preach the discarding of all tradition and form?

The Coming Convention of the Union of Orthodox Congregations.

Beginning with next Sunday morning there will be held three sessions of this body which has mapped out for itself a line of useful and creditable work during the past few years. The Union proposes to carry out its programme of uniting the ranks of orthodox and conservative congregations for the single purpose of maintaining a closely welded organization which shall demand recognition by the community of the observant Jew and his needs.

If the most prominent public influence is latent in the Reform camp, it is dormant so far as securing the Jew his rights, and Jewish children their privilege to remain strictly observant of matters pertaining to their religion.

It is left to the Union to battle against the prevailing custom of disregarding the Jewish holy days by the Board of Education, and against municipal disregard of the Jewish Sabbath in more ways than one. Quiet persistence and unostentatious protest may succeed in effecting that which Reform influence has utterly ignored and never sought to remedy.

The Jew of New York constitutes a strong minority, and if he be self-respecting, he dare not miss the opportunity of asserting his claims as one striving to be orderly and law-abiding. It is unquestionably his duty to stand by his orthodox brother, no matter what his private beliefs or convictions may be. May there be wisdom exercised in the deliberations making for the peaceful attainment of the ends desired, the solution of important local and national questions to be suggested.

In Search of a Pulpit.

XX

The Press.

I always was a firm believer in the value of printer's ink.

What the young Rabbis of America would have done without the assistance of the press I cannot say. Their deeds would have been unheralded, their praises remained unsung, their great learning undiscovered and their windy reputations buried in oblivion amid the rubbish of the past.

A Rabbi in this great and glorious country can get along without the knowledge of Jewish literature. The Talmud and its commentaries may be a terra incognita to him. He may even be unable to read Hebrew without the aid of vowel points, but with a healthy pair of lungs, a large stock of rhetorical phrases, a graceful manner and youthful appearance, some natural bornchutzpah and the press at his back, he can command the best pulpit in the land.

It is indeed a fine art which few understand, "how to work the press to the king's taste." It requires one to be a thorough judge of human nature, a refined diplomat, to have natural aplomb and an assumed bonhommerie to be the recipient of favors at the hands of the corps reportorial and at the same time ingenuously lead them to believe that you are conferring a kindness upon them.

One may personally consider that the columns of the Jewish Bladder are filled with social slush, that the American Matzahkleis is as heavy as lead and as dry as dust, and that the Hebrew Stiletto is a vile speci-

men of journalism, yet it is always politic to keep on the right side of the editors, because a Rabbi in their hands is like a lump of clay in the hands of the potter. They can boost him up to the topmost pinnacle of fame, flay him alive with their scalpels of criticism, or kill him beyond hope of resurrection by the shafts of their ridicule.

The press is sometimes rather expensive, but it is a natural adjunct to the cloth and as necessary as well fitting attire, a fashionable tile or a white neck-tie.

It bears the same relation to an American Jewish clergyman as liberal advertising does to a department store.

A Rabbi in this utilitarian age, cannot necessarily be a deep student. To pore over ponderous tomes, and consume midnight oil, is a waste of valuable time.

To study the Torah and "meditate thereon day and night," sounds well in theory, but does not pay in practice.

It was well enough perhaps for the Rabbi of bygone days not to be able to distinguish one matbayah (coin) from another, but the Rabbi of the present age who can bank neither on his piety nor his learning, is forced from the very moment he enters the pulpit, to learn the value of greenbacks and to recognize their influence even in the sacred courts of the Lord.

Then, the community valued his learning, because its profundity and brilliance reflected upon them; they venerated his piety because he was a living exemplar of the beneficent teachings of the faith he professed.

He had no misgivings of the future. He had the assurance that his life would be spent and his days end with the flock who had chosen him as their shepherd; loved, honored, respected and venerated.

The modern Rabbi is differently situated. He recognizes the uncertainty of his tenure. He knows the instability of the average American Jewish Congregation, that when the first glamour of novelty has been dissipated, when the attractiveness of the Rabbi has worn off and he ceases to be a drawing card, "Othello's occupation is gone," and he is at the mercy of every vulgar, scheming Trustee, every purse-proud, upstart Parnass, every ignorant, shoddy member, and every deceitful, intriguing Shammash.

The law of necessity compels him to have a weather-eye to business, and he is forced to the conclusion, that his vocation, which, in his veal days he looked forward to with enthusiastic ideality, is no longer a profession, but a trade.

In the press he finds a ready instrument at his hand—a weapon to attack his enemies, a shield to defend him from his detractors, a trumpet to proclaim his greatness, and a harp to sing his praises.

It is only the younger Rabbis who appreciate the value of the press; the rarified, reform, religious atmosphere in which they live enabling them to fully recognize its potent power and peculiar possibilities.

I cultivated the acquaintance of the "Knights of the Quill" even in my early student days. At every opportunity I was announced as "A New Shining Light in the Theological Horizon"—"An Eloquent Young Orator"—"An Impassioned Modern Isaiah"—"The Jewish Pulpit Afire with burning Eloquence," marked copies of the newspapers were sent to the officers

**In the Jewish World.**

Committees from Worcester synagogues collected \$200 last Sunday for the relief of Kishineff sufferers.

An Austrian financier has asked permission to found a Jewish colony in Portuguese East Africa. The promoters of the enterprise claim to be prepared to send 50,000 families to Mozambique.

Over \$1,000 was collected in the congregation Zichron Ephraim on the first day of Shethnath in aid of the Kishineff sufferers.

The thirtieth anniversary of the Hebrew Ladies' Aid Society of Jersey City was celebrated last Sunday afternoon in the vestry rooms of the Temple Adatto Emuno on Garden street.

The United Jewish Charities of Kansas City last week gave 10,000 loaves of bread through the Commercial Club for the relief of the refugees. One thousand loaves were given each day for ten days.

Rabbi Henry Cohen has just completed his fifteenth year as rabbi of the Temple B'nai Israel of Galveston, Tex. A reception was tendered to him by the Jewish residents in honor of the event.

The will of Adolph Rosenbaum, late of Philadelphia, Pa., admitted to probate last week, devises \$250 each to the Jewish Foster Home, Jewish Hospital Association and Society of the United Hebrew Charities.

Work has commenced on a new and pretty synagogue for the congregation of Agudath-Jacob, of San Antonio, Tex. The building will be handsomely finished, and is located at Seventh and Columbus streets.

The Virginia Social and Pleasure Club was organized last Sunday by Mr. Robert Flagler of Berkeley and Mr. Louis Ellis of Norfolk. The club starts with many members, but it is the desire of the organizers that all young Hebrew men of Norfolk, Portsmouth and Berkeley should become members.

At the last regular meeting of the Independent Hebrew Benevolent Society of Worcester, Mass., it was voted to contribute to the National Jewish Home for Consumptives, and each member pledged himself to give 50 cents. The new members were admitted and two applications received.

A building contract between Albert Gleek and the congregation B'nai Israel of Paterson, N. J., was filed in the County Clerk's office on the 5th inst. The contract calls for the completion of the mason work on an addition to be built to the synagogue by Aug. 1, for the sum of \$2,645.

Complaints have been made to the police with regard to the work of some boys on the corner-stone of the new Jewish synagogue on Roberts street, Pittsburg. Soon after it had been placed in position some of the youth of the district marred the stone by chipping it with bricks. The edges were so marred that it will have to be redressed and replaced in position.

It is said that a large number of the Hebrews of Hudson County are greatly displeased with the mass meeting held recently in Jersey City to protest against the massacre at Kishineff and to increase the relief fund for the surviving sufferers. The complaint is that the meeting bore too conspicuously the earmarks of politics.

The Plainfield, N. J., Hebrew Juvenile Auxiliary gave an entertainment and social last week. Those present gave as many pennies as they were years old, and in this way a gratifying sum was realized. During the summer other entertainments and outings will be arranged by the auxiliary.

No mercy is shown Jewbaiters by Recorder Lazarus, of Jersey City, who last Thursday morning sent Edward Black, aged 23, to Snake Hill for ninety days for assaulting Julius Edelstein, of 29 East Twenty-first street, an old, gray-haired, inoffensive Hebrew. The latter testified that he was sitting on the stoop of his home when Black assaulted him and pulled his whiskers. Black said that he

accidentally stumbled over the old man and denied the assault. In sending Black to jail the Court severely rebuked him.

The two-story synagogue of the congregation Agudath Jeshorim at 113 and 115 East Eighty-sixth street is to be remodeled and beautified during the summer at a cost of \$20,000. A new decorated ornamental facade, surrounded with two cupolas, is to be built and a new balcony and staircases are to be constructed. The plans have been filed with the Building Bureau by Sass & Smalheiser as architects.

The residents and property owners of Glendale and of Ridgewood, L. I., have engaged counsel to fight the proposed location of a new Jewish cemetery that is being established on Cooper avenue, adjoining Cypress Hills Cemetery in Glendale. The residents have decided to carry the fight into the highest courts before they will allow another cemetery to be located there. Options on nearly 100 acres of land adjoining Cypress Hills, Salem Fields, Macphelah and Mount Nebo cemeteries have been obtained and the work of laying out plots has been begun. The residents claim that another cemetery here will decrease the values of property and increase taxes. The taxpayers have been defeated before the Newtown local board, the Board of Aldermen and Mayor Low in attempting to prevent this cemetery from being located here.

The Hartford Hebrew Institute, 18 Pleasant street, is being made use of Tuesday and Wednesday evenings as an evening school for classes under the instruction of a number of the teachers of the city schools who have volunteered their services to educate in the elementary branches the young men connected with the institute whose employment during the day makes it impossible to secure instruction in any other way. For some time the classes met at the North Street Settlement, and the enterprise was conducted quite successfully. Recently the location was changed to the institute, which is more easily accessible and satisfactory for teachers and pupils. The students represent many branches of labor, but all are alike in their thirst for knowledge. Several have been attendants at the public evening night schools, but not content with the opportunities thus obtained, they have sought this new chance eagerly and are manifesting much sincere appreciation for the interest and attention accorded them by their kindly disposed benefactors.

Israel's Mission and Missionaries.  
Editor Hebrew Standard:


The promoters and supporters of institutions for learning and charity founded in Jerusalem have long felt the want of an institute there, to offset and counteract the influence of the missionaries who make a strenuous effort to Christianize Jewish children in the Holy City. The enormous fund expended and the impoverished condition of the Jewish population as a bait, make the field fertile for this purpose. The fault, I believe, judging from my traveling experience in Palestine, lies in the division of the various factions or groups—each working in its individual sphere without united strength. The Sephardim, the Ashkenazim, the ultra-religious and the liberals, or, rather, non-religious. For this reason we find such a deplorable state of affairs—either Torah without Derech Eretz or vice versa; either a Talmudical college without secular knowledge or an institute of a purely French or English character without religious teaching. The rabbis, as a rule, lack the confidence in and of the leaders of the educational schools, who fail to imbue in the hearts of the children the essentials of Judaism. A combination of the above qualities in one institute would, in my opinion, check if not remove the cause of the missionaries' influence over the Jewish youth.

Such an institution, I understand, is now proposed by Rev. M. I. Friedman, who arrived here from Jerusalem with the proper credentials and approbations of the leaders representing the various groups in Jerusalem. An institution that can satisfy the requirements and wishes of the signers of the recommendations would, indeed, be the most effective opposition to the missionaries' tactics, and ultimately lead to the fulfillment of the real Jewish mission for higher education combined with true Judaism coming forth from Zion. 

The matter was brought to my attention. Of course I had no power to prevent those meetings. After a good deal of thought I detailed a Jewish sergeant and forty Jewish policemen to protect the agitator while he held his meetings; so he made his speeches denouncing the Jews, protected exclusively by Jews, which I always thought was probably the very most effective answer that could possibly be made to him, and probably the best object lesson we could give of the spirit in which we Americans manage such matters.

Now let me give you another little example of dealing with a Russian Jew, an experience that I had while handling the Police Department, and that could have occurred, I think, nowhere else than in the United States.

There was a certain man I appointed under the following conditions: I was attracted to him by being told, on a visit to the Bowery Branch of the Young Men's Christian Association, that they had a young fellow there, a Jew, who had performed a feat of great note in saving people from a burning building, and that they thought he was just the type for a policeman. I had him called up and told him to take the examination and see if he could get there. He did and he passed. He has not only been an excellent policeman, but he at once, out of his salary, proceeded to educate his younger brothers and sisters, and he got either two or three of his old kinsfolk over from Russia through the money he saved, and provided homes for them.

I have given you examples of men who have served under me in my administration of the Police Department in New York and in my regiment. In addition thereto some of my nearest social friends, some of those with whom I have been closest in political life, have been men of Jewish faith and extraction.

Therefore, inevitably I have felt a degree of personal sympathy and personal horror of this dreadful tragedy, as great as can exist in the minds of any of you gentlemen yourselves. Exactly as I should claim the same sympathy from any one of you for any tragedy that happened to any Christian people, so I should hold myself unworthy of my present position if I failed to feel just as deep sympathy and just as deep sorrow and just as deep horror over an outrage like this done to the Jewish people in any part of the earth. I am confident that much good has already been done

by the manifestations throughout this country, without any regard to creed whatsoever, of horror and sympathy over what has occurred.

It is gratifying to know, what we would, of course, assume, that the Government of Russia shares the feelings of horror and indignation with which the American people look upon the outrages at Kishineff, and is moving vigorously not only to prevent their continuance, but to punish the perpetrators. That Government takes the same view of those outrages that our own Government takes of the riots and lynchings which sometimes occur in our country, but do not characterize either our Government or our people.

I have been visited by the Russian Ambassador on his own initiative, and, in addition to what has been said to Secretary Hay, the Russian Ambassador has notified me personally, without any inquiry upon my part, that the Governor of Kishineff has been removed; that between three and four hundred of the participants in the outrages have been arrested; and he voluntarily stated that those men would be punished to the utmost that the law would permit.

I will consider most carefully the suggestions that you have submitted to me, and whether the now existing conditions are such that any further official expression would be of advantage to the unfortunate survivors, with whom we sympathize so deeply. Nothing that has occurred recently has had any more constant thought, and nothing will have any more constant thought than this subject.

In any proper way by which beneficial action may be taken, it will be taken to show the sincerity of the historic American position of treating each man on his merits without the least preference to his creed, his race, or his birthplace. [Applause.]


