In the Jewish World.

A free school for Russian Jews will shortly be established in Harrisburg, Pa.

A society for the aid of needy emigrants has been organized in Rochester, N. Y.

Rev. Herman Kamenske has taken charge of the Jewish community at Corning, N. Y.

Ground has been broken for a new synagogue at the corner of Charles and Weeks streets, New Iberia, La.

Rabbi Dr. Ungerlinder, of Berlin, recently completed, his seventieth year. He prolonged his vacation to prevent public celebrations.

For the first time the service for adult deaf mutes was held in Berlin, on the New Year. About two hundred persons were present, of whom 160 were males.

At a general meeting of the Sydney, N. S. W., Great Synagogue, Mr. Neville D. Cohen was re-elected President of the congregation.

The New South Wales Zionist League has discussed the desirability of making representations to the new Pope, asking him to use his vast influence to check outrages on the Jews and to refute the false and cruel charges of Jewish ritual murder. No decision was, however, arrived at.

Herr Michael Heim has been appointed President of the District High Court, at Mitrovitz (Croatia).

Professor S. Ehrmann, of Vienna, and Sanitarsath R. Gluck, of Sarajewo, were elected Honorary Presidents of the Congress on Dermatology, held in Vienna.

A Central News telegram states that the well-known banker, Dr. Rudolf Goldschmidt, of the old-established banking house of Morris Goldschmidt, Berlin, has committed suicide in a fit of depression by shooting himself.

In view of the increasing number of Jewish visitors to Ostend, during the season, it is contemplated to build a suitable synagogue to take the place of the present premises, which are used for Jewish public worship. The services on

the high festivals were conducted by Mr. Berkowitz, of Manchester.

Letters received in Berlin from Jerusalem, announce a German project for the construction of a railway from Haifa to the Sea of Gennesareth, passing through Nazareth and other towns in Galilee. The railway is intended to form a section of the system from the Mediterranean to Damascus and Mecca.

At the first meeting of the Woman's Club for the season, held in Tuckerman Hall, Worcester, Mass., last week, at 3 o'clock, a lecture was given by Rabbi Charles Fleischer, of Boston, on "Fact and Fiction About the Jew."

Rabbi Solomon Foster, of Newark, was a speaker at the fifty-third annual convention of the East New Jersey Baptist

The Staatsburger Zeitung announces that M. Plehve, Russian Minister of the Interior, does not sympathize with the growth of Jewish tolerance in Russian circles. He has accordingly appointed a commission to report to him as to the best means of encouraging the emigration of the hated Semite. Plehve himself, says the paper, favors the creation of a fund of several million dollars to give aid to Jews who wish to get out of Russia.

For some time past special committees of the Young Women's Union and the Philadelphia Section of the Council of Jewish Women have been directing their energies toward combating the evil influences to which Jewish girls and boys

The legal profession of Melbourne has lost one of its ablest and best-known members, in the person of Mr. David Braham. Born in London, sixty-five years ago, and educated there, the deceased came to Melbourne in 1860, and soon became intimately associated with commercial and insolvency law, and many a big case passed through the hands of Braham & Pirani, under which designation the firm, of which the deceased was the head, in course of time became known. He never took part in public matters nor in the affairs of the Jewish community, but for many years he was the legal adviser of, and rendered valuable services without fee or charge to the East Melbourne Congregation.

The Morning Leader Vienna correspondent states that the Galician Bukovina Jews are greatly perturbed in consequence of the agitation and fear that the contagion of the epidemic of Jewish massacres in Russia may spread to Austria. He mentions a "terrible panic" as having occurred on the eve of Atonement in the synagogue of the Strzeliska, in Galicia. Fire broke out in an adjoining house, and the glare of the flames was seen by Jewish women in the gallery, who were present in hundreds. Shrieking and wringing their hands, they rushed to the narrow doorway, which was soon blocked by an immovable human wedge. Three women were crushed to death, four were taken in a dying condition to the hospital, while a great many others were more or less seriously injured.

The newly elected officers of the Young Men's Hebrew Association, of Boston, have decided to take quarters at 694 Massachusetts avenue, and will renovate the place to suit the purposes of the organization. For many years the Young Men's Hebrew Association was the leading Jewish body in Boston, with a membership of more than 500. Owing to the noise of the operation of the L road it was necessary to leave its large quarters at Springfield and Washington streets, and since then interest in the society had waned. Now, however, enough money has been pledged to carry on an extensive programme. About all the members of the past will again take hold and assist the management. The new officers and directors are men well known in business and professional circles, and with their influence there is little doubt that success will be assured. Immediate steps will be taken to renovate the building, and the formal opening will be held soon.

Kirschbaum, of Philadelphia, to provide an industrial home for girls, to be conducted by the council. The home is to be furnished completely by the children of Mrs. Kirschbaum, and is to be known as the Kirschbaum Industrial Home for Girls. The Council of Jewish Women will hold a meeting next week to consider the offer.

Steps are being taken to establish a Jewish Statistical Bureau in London. A preliminary meeting dealing with the matter was held on Sunday last.

The certificate of incorporation of the Gideon I. O. O. F. Temple Association, of Rochester, has been received from the Secretary of State. The Gideon I. O. O. F. Temple Association is a corporation organized under the corporation laws of

Republic relative to the reorganization of Jewish Consistories in Algeria. The decree provides for the formation of new Consistories d'Arrondissement, and for the proportions in which taxes raised by the Jewish communities, such as the Meat Tax, are to be applied to maintenance of communities and to philanthropic objects.

Colonel A. E. W. Goldsmid, probably the most widely known Jewish officer in the British army, has been retired, due to the age limit, he having celebrated his 57th birthday on Tuesday. During his recent three days' stay at Balmoral, Colonel Goldsmid was appointed by his Majesty a member of the Victorian Order (M. V. O.). The colonel also received other signal marks of royal favor. Colonel Goldsmid's interesting military career, as told by himself, is as follows: "I passed second out of Sandhurst in 1866, gaining the first prize in mathematics; I was gazetted in the same year in the 104th Fusiliers. I became adjutant of the regiment in 1871. I was a member of the Staff College in the years 1876-7, and of the Intelligence Department in 1878. I became brigade-major in Belfast and Dublin in 1879, assistant quartermaster general at headquarters in 1884, and assistant adjutant general at headquarters in 1889. In 1894 I was appointed to the command of the 41st Regimental District. Later appointments have been, assistant adjutant general and chief staff officer, Thames District (1897); deputy adjutant general and chief staff officer, Aldershot (1899); assistant adjutant general 6th Division South African Field Force (1899-1900); assistant adjutant general, Transport, Nauport, Commandant Orange River, Herbert and Hay Districts and assistant inspector General Lines of Communication, South Africa (1900-1901)."

In 1892-3, Colonel Goldsmid acted as director general of the Hirsch Colonies in the Argentine. He is commandant of the Jewish Lads' Brigade, president of the Maccabaeans, and a member of the Council of the Anglo-Jewish Association.

The Jews in Germany.

The present social conditions of the Jews in Germany are interestingly revealed in Conrad's Jahrbuch fur National-oeonomie und Statistik. Of the 7,500,000 Hebrews in the world, Germany shelters 570,000. They are not gaining on the Christians, as is commonly supposed, but actually constituted in 1900 only 11.4 per thousand, as against 13.3 per thousand in 1880, of the total population. The percentage of births has suffered a startling diminution; in the period 1820-1866 the number of births to every thousand Jews was 37.70; in 1878-1882 it still was 30.32; whereas in 1893-1897 it fell to 22.5, as against 38.15 among the Christians in this last period. The Frankfurter-Zeitung is inclined to attribute this to the Malthusian tendencies of growing prosperity. Jewish families of twelve or fifteen, such as were numerous half a century ago, have practically disappeared; the average number of children per Jewish marriage, in the period 1895-1899, was only 2.98, as against 4.21 among the Christians in the same period. There is also an increasing tendency to mixed marriages, in which the Jewish element is usually absorbed by the Christian. In 1895 only 24.47 per cent. of the children of mixed marriages were Jewish, and nearly all the children of such mixed couples marry Christians. In the matter of divorces there is no increase because of mixed marriages, and the doctrine that such marriages normally result in smaller families and a less robust progeny is not borne out by the figures. As regards employment, 54.56 of the German Jews follow commercial pursuits, as against only 0.04 per cent. in agriculture. Of the women and girls, 21.97 earned their own living in 1895, as against 15.94 per cent. in 1882. The vast majority of all Jews live in cities. Berlin has 92,206, as against only 18,859 in 1861. Frankfurt, Posen, Mannheim and Breslau exceed Berlin in the proportion of Hebrews in the population. Of Jewish children, 41.34 per cent. take high-school courses, while in Prussian universities they constitute 9.32 per cent. of the students. Criminologically considered, murder is committed by Jews with remarkable infrequency; most of the crimes committed by them grow out of commercial conditions.

When the Committee of Seventy was formed which preceded Mayor Strong's election, more than fifty per cent. of its members became applicants for office. That is non-partisan politics.

Montreal.

The oppression of the Jews of Russia was discussed at a meeting of Christians in Empire Hall on Sunday afternoon. The chair was occupied by Mr. Bardorf, and the principal speaker was Mr. Roswell Fisher, one of Montreal's most prominent citizens. Mr. Fisher uttered a scathing denunciation of Russian methods, and paid an eloquent tribute to the virtues of the Jewish people. Messrs. Richard Kerrigan and Helfond also addressed the meeting.

A resolution was read after the speeches protesting against the "barbarous and damnable" system in vogue in Russia, and stating that the citizens of Montreal realized that the atrocities perpetuated were due to the governing classes. It concluded by calling on all lovers of liberty to assist in overthrowing the cause.

It was read by Mr. Walshe, and received with much applause, after which the meeting broke up.

The annual meeting of the Baron de Hirsch Institute was held on Sunday morning, Mr. D. A. Ansell in the chair. The various reports showed the vast amount of good work done during the past year.

Mr. L. Holstein, chairman of the Relief Committee, referred to the work done and the difficulties encountered during the past Winter in supplying the poor with coal.

Mr. M. Markus advocated the appoint-

ment of a special officer to look after cases of relief.

Mr. Clarence DeSola thought that, although the number of members in the institution had increased largely, yet there should be many more than there are, considering the Jewish population of Montreal. Every person in the Hebrew community ought to subscribe to the institute.

Mr. Levy suggested that collections be taken among the Hebrew workmen in factories and workshops.

Votes of thanks were passed to Messrs. Maxwell Goldstein and S. W. Jacobs for their efforts in obtaining legislation upon the matter of the education of Jewish children in the province of Quebec; to Messrs. Holstein, Goldstein and Markus, members of the Relief Committee, and to the societies which had worked in co-operation with the Hebrew society in its philanthropic endeavors.

Votes of thanks were also passed to the honorary officers.

During the meeting the president, on behalf of the members, presented Mr. I. Rubenstein with an illuminated address "as a mark of their appreciation of his zeal and devotion to the interests of the society in connection with the building of the new Baron de Hirsch Institute."

Mr. Rubenstein made an appropriate address and thanked the members for their kindness.

The following gentlemen were elected to fill the vacancies on the Board of Governors for three years: Messrs. J. Hirsch, M. Hirsch, Clarence DeSola, Lyon Cohen, S. W. Jacobs, J. Goldstein and Louis Margolese, and Mr. Horace Joseph for two years.

Annual Meeting of the United Hebrew Charities.

The annual meeting of the United Hebrew Charities was held last Sunday at 21st street and Second avenue. It was announced that a hospital for convalescents in connection with Lebanon Hospital, would soon be started by the Charities, which had appropriated \$5,000 for the purpose.

The meeting was presided over by Nathan Bijur. The following board of directors was elected: Nathan Bijur, Sidney Borg, Joseph A. Buttenweiser Mrs. William Einstein, Louis A. Heinscheimer, Philip S. Henry, Adolph Lewishon, Fred W. Marks, Morris Mayer, L. F. Rothschild, William Salomon, Henry Salomon, Benjamin Stern, Cyrus L. Sulzbürger, Louis B. Tim, Dr. F. L. Wachenheimer and Mrs. S. Weinhandler.

The total receipts were \$196,896.13. To this sum the Baron de Hirsch Fund contributed \$14,400, the Hebrew Orphan Asylum \$25,000 and memberships \$61,629.17. The total disbursements were \$206,148.74.

A plan for the reorganization of the United Hebrew Charities to produce greater results in its work on the East Side and to obtain the co-operation of the various organizations in that section of the city was submitted. It will be acted on by the new board of directors at its meeting next week. The plan provides for a division of Manhattan, south of either Seventh or Houston streets and east of Broadway, into four districts or ten districts, according to density of population. Each district is to be in charge of a board of directors of thirty members, each to be a member of the United Hebrew Charities. There are to be relief and membership committees in each district. Twenty-seven members of the board are to be elected by members of the United Hebrew Charities living in the district and there are to be appointed by the President of the United Hebrew Charities from the board of directors of that society.

Individual membership in the Hebrew Charities is to be classed in various grades, from the passive member, paying \$5 a year, to the founders, paying from \$1,000 a year upward. Societies may join the United Hebrew Charities by the payment of one cent a week for each member of the organization. There is to be a central committee, composed of six delegates from each of the districts, with the addition of six more members appointed by the President of the United Hebrew Charities. This committee of thirty shall look after the common interests of the entire section.

There is to be a central office of relief in each district. The United Hebrew Charities shall engage a paid agent to carry on the work of the districts. All moneys received by the district organization are to be paid into the treasury of the United Hebrew Charities. The funds for the use of the district committee shall be furnished by the United Hebrew Charities on the basis of an amount equal to the average disbursements made by the Charities in the district for the last five years and in addition the United Hebrew Charities shall return two-thirds of the money received from each district.

Society does not encourage complete independence. And the verdict of mankind counts for something in the present make-up of the social body.

God's Name in Israel.

ושמו את שמי על בני ישראל

"Fear not thou worm Jacob, ye men of Israel, I will help thee, saith the Lord and thy Redeemer, the Holy One of Israel."

Isalah xlix, 14.

To be called by such an unseemly name as worm is by no means pleasant; but it depends upon the person using the term. If an enemy would apply that epithet to Israel, or even one who cares not about his welfare or downfall, it would be offensive; but when God, our Father, our Redeemer, our All in All calls us worm, and especially with the assuring remark "Fear not," we ascribe it to a tenderness which only a loving father would express; for has not the same God called us "Rose of Jacob," "Vineyard of Jacob," and "My first born son?" Nay, more, did not He bid the priests in the words, "ושמו את שמי עלי" to put His name upon Israel and He would bless them? When, then, He calls them here worm, it is by no means intended as a reproach, but rather as a reference to actual historical standing.

For ages and centuries Israel was debased and degraded to the lowest degree of human position, laid in the dust and trodden upon as even is a creeping worm. And like a worm that gives no sound, so had Israel to endure without murmur and without protest. He was considered a worm, crawling and creeping to reach its end, as cringing and twisting, its way on and on; but this worm which God had called so—this worm had the stamp of immortality upon it, it had the name of God as the preservative spirit to keep it alive. Since God had called Jacob a worm, it is a name of honor. Far more formidable is it to be a worm and survive the persecution of men than to be a lion and perish.

Often is Israel pictured in Scriptures as a rose, a rose of Sharon, lily of the valley, etc.; names sweet and delightful to bear, but what would have become of Israel had they been comparatively as roses, even the most redolent and fragrant? The scorching heat of the sun would have despoiled the calix of its life-giving element long ago, or the frost of the frigid times would have bitten off its leaves and robbed it of its delicate hues—the storms of fate would have destroyed and shattered every little remnant of the beautiful rose long ago; but as a worm—a worm called so by God, endowed by divine vitality, Israel was doomed by peoples and nations to crawl and creep along—to live in humility and degradation—with the feet of many treading upon it, but unable to press the life out of it. Many a sword had struck it and parted it section by section, but each part had divine life in it and every portion part had a vivifying essence in it. Though separated from the whole it revived and lived, the very dust it wallowed in gave it life, and where others could not exist, this worm lived and grew, till at last the civilized world awoke to the enormity of their cruel injustice and relaxed the vigilance of their evil purpose, then the rose began to bloom, the lily to assume its snowy whiteness again, and the worm lifting itself from the dust became the lion of Judah. All because the name of God rested upon the honorable name of Israel. Every priest, every servant of God, every one ministering to the spiritual wants of Israel truly and sincerely has put the name

of God upon their constituents and God has blessed them.

Ah, there are yet, oh, so many Israelites who are still the worm, creeping and crawling in dust, trodden upon! but כל כלי יוצר עליך לא יצלח said the prophet: "Every weapon directed against thee, will ultimately not prosper!"

But it is for the priests—and is not every Jew a priest? We are a kingdom of priests—to keep putting the name of God upon Israel, in order that the Lord might bless us. Alas! how many fathers neglect to put the name of God upon their sons and daughters! How many mothers have no God at all in their household! How many teachers in Israel have but their own interests at heart and put the name of God on the people but in words and often not even in that.

Oh, let us consider this deeply, now that we are the worm no longer, but the proud lion, and put upon our charges, upon the people, the name of God in truth that He may bless us.

Mr. Haffen and the Hebrews

The residents of the Bronx who have been observant of the progress of that important Borough, and of the vast public improvements which have attended its progress must give unstinted meed of praise to Mr. Louis F. Haffen, the indefatigable President of the Borough. During the time that he has occupied that important post he has been unceasingly battling for the rights of his Borough, and those who have watched the meetings of the Board of Estimate, which is the arbiter as to what public improvements shall be made and moneys which shall be expended in the City, must acknowledge that against strong odds, the persistent demands for improvement in the Bronx Borough, backed up by a manly and vigorous fight, have been recognized and granted, and that part of the city has been well taken care of because of the devotion of President Haffen to its interests.

Mr. Haffen has been a good public officer, his career has been marked by his faithful devotion to duty. As a man, his sterling qualities are everywhere recognized, and as a cosmopolitan citizen he stands pre-eminent.

His unhesitating participation in the movement in behalf of the sufferers of the recent massacre in Kishineff, and the support given by him to the movement, and his personal presence at the meeting called for that purpose, evidences clearly that neither race nor creed will find him wanting, and that religious bias is unknown to him.

It is, therefore, sincerely to be deprecated that some persons, who believe that all is fair in war and politics, without a color of right and under the guise of a so-called independent movement, have endorsed the Fusion candidate for the presidency of the Borough of the Bronx and the more so is this action to be condemned because of the method adopted in getting names subscribed to the nominating petition upon the statement and assertion that President Haffen was unfriendly to the Jewish people.

It is a disgrace to American manhood and citizenship to inject religion into politics. And it is the more so to be condemned when the man who is the object of the attack is one whose manly and unbiased course commends him to the whole community.

The Issue.

A few days more and the issue will be decided by a jury composed of the citizens of Greater New York whether the great metropolis shall be a Democratic or a Republican city, whether an Aristocracy shall rule, or a Democracy; whether the people shall determine the policy underlying the government of the Commonwealth, or an aristocracy which believes itself superior to the mass of the citizens. It is still the old contest between Jefferson and Hamilton. On the one side, rule by the will of the people, on the other side rule by a few, who believe themselves above the people.

We do not deny that Mayor Low means well, has good intentions, but no one can say anything against Mr. McClellan. It is not a question whether one man or the other shall be at the head of the government, but whether Democratic principles shall prevail or Republican principles; whether the people shall be masters of the city, or whether the masters from the upper tondom shall pull the strings; whether the people may eat and drink on Sundays what they please, or whether Puritanism shall hand them over to the police whenever they transgress any of the laws laid down for them and not by them; whether New York shall be governed as a cosmopolitan city should be, or like a provincial New England town, where the pastor rules and not the citizen.

A city populated by inhabitants who come here from all parts of the globe should enjoy the largest freedom possible, and should not be placed in the straightjackets of a code of laws concocted at Albany by a regency which refuses to listen to representatives of the community, be they Germans or Irishmen, when they present their needs and wishes to the Governor; laws enacted at the bidding of the boss of the Republican party, and who never had any heart for the wishes of the people but for his own interests, political and financial.

We are firmly convinced that the interests of the people of the City of New York are best safeguarded by placing the power of the government into the hands of the Democratic party, and there is only one organization which represents the Democratic party, and that is Tammany Hall. The man selected as candidate for Mayor has filled a number of public offices with honor to himself and with credit to the interests he was charged to guard. The men selected for the offices of Comptroller and President of the Board of Aldermen of the City have filled their positions to the satisfaction of the people, which even their opponents cannot deny.

A year hence we shall vote for a President of the United States, we shall vote for the principle which shall prevail in the National administration. Shall we continue to pursue the policy of aggrandizement, to sacrifice the lives of our citizens and the treasure of the country in extending our rule over territories that are thousands of miles away from us, for the benefit of whom? Certainly not for the benefit of the people whose land we have annexed but for the benefit of a number of office holders who are to be rewarded for services to the Republican party.

Shall we continue a policy of protection which enriches the monopolists, enables the millionaires to place additional burdens upon the luckless

taxpayers, upholds Trusts, which exploits the people, a policy which seems to have finally run its course and is breaking down fast, or shall we try to replace the policy of exploitation by one which protects the people, instead of the plutocrats?

These questions wait for decision, and the country looks upon New York to see whether it will make an earnest move for dethroning the party of centralization and usher in a policy which will make the country more prosperous than it ever was.

This is the great issue, and upon the people's vote depends the fate of the country at large. Be careful what you, be careful how you vote! Vote so that you will not be sorry afterwards. Vote for the ticket of the Democratic party.

With George B. McClellan as Mayor, the city would have a truly democratic administration. His election will go far to bring about that personal liberty which is not now obtaining: The privilege of every citizen to partake of a glass of beer on Sunday, as well as on week day, openly and not clandestinely.

In Search of a Pulpit.

When a Rabbi is Busy.—I.

I had no occasion to be dissatisfied with myself. My prominence throughout Jewish circles in the land was phenomenal. I had but to express a wish to have something done and my congregation forthwith encouraged me in carrying out the latest project that entered my head. I multiplied my ventures in the field of philanthropy and enlisted the sympathy and active co-operation of the city's leading men. I interested even the charitably inclined of other cities to contribute to the cause that then engaged my mind, and it was thus I realized how our people worship success. They are flattered when a man of importance approaches them and are more than willing; almost anxious to open their purses to him. They compete for the honor of entertaining him and showing him extravagant attention. They are prepared to go out of their way and spend thousands on the mere endorsement of the man of prestige. But the humble, obscure and insignificant rabbi has no chance, lacking the encouragement, to fulfill any of his desires. Therefore he is charged with having no ambition and no energy to carry into execution any plan that he may have originated.

I found it as easy to collect thousands upon thousands of dollars for my numerous enterprises as the head of a get-rich-quick concern. It was child's play for me. My lectures were weekly printed in pamphlet form and distributed far and wide. Being so well known, I was the rage from a social and religious standpoint. Therefore I experienced no difficulty in getting people of means to serve on the directorate of various institutions which owned their existence to me and my active brain. They disgorged of their plenty for me. On my recommendation, the last will and testament of many a person was altered so as to include as beneficiaries one or more of my schemes.

My life-plaut for the poor therefore flourished; my Palace of Delight for the workingmen and their progeny was assured of a prominent place

among the institutions of the city; my Agricultural School step by step became the cherished and favored protegee of a large clientele selected from among a host of my friends all over the country. Nor did these exhaust my resources. I had time and funds behind me to establish a Library in my Temple, a Jewish quarterly magazine, a weekly journal, a Lyceum for the young men and women, who prepared themselves for an active business career by joining my classes in stenography, type-writing and book-keeping, the school being open to the general public on payment by the individual of a nominal fee. I called mine the "Open Temple," and boasted of its manifold usefulness. For it contained a Gymnasium with all its equipments, intended to develop muscular Judaism. The Reading-room was open all day and every day in the week, for those who wished to glance over the books of reference and periodicals and magazines of all kinds. The most famous lecturers on popular subjects, the best concert bands that produced good music, glee clubs and entertainers with the accompaniment of stereopticon views held forth in the auditorium of my Temple, the admission fee for the season for the entire course of amusement being small and within reach of the popular purse.

Thus in course of time I grew to be regarded as quite an important factor in the government municipality. I once had occasion to oppose a certain candidate for the mayoralty by an address delivered in such a forcible manner and with such emphatic terms that his subsequent defeat was traced to my public antagonism. On still another occasion after that, I was consulted by the party managers who were anxious to secure my support among the first of the parsonages of the city, and I ventured to suggest the addition to the slated ticket of a friend of mine, a staunch admirer and a Jew. Having thus placated me the party met with success, and attributed their victory, in large measure, to my sage counsel and practical advice. Politically even I cut quite a figure, and was one of the notables of the community.

REB PELONI.

The Mirror.

Two Rabbis were talking of a colleague who had been obliged to resign his position on account of meagre attendance.

"I wonder at his lack of success," remarked one of them; "he preached so well. His voice filled the temple."

"Yes," remarked the other, "but it didn't fill the pews."

A pupil of a Sunday School connected with a well-known up-town congregation reports that he learned from his teacher why ten Jews constituted a *minyán*. The reason given to him was that the numerical value of the three letters forming the word "congregation" when applied to the ten spies who brought in discouraging reports of the land of Canaan, is ten. The teacher probably spelled it ארדה, instead of ערה. A very brilliant Hebrew instructor. My congratulations to the school that employs him.

We have a Hebrew Sabbath School Union. We know what this institution should stand for and mean, but it sails under false colors. Why is it a Sabbath School Union? Does it urge to have schools connected with our temples (as this institution is not the offspring of synagogues) open on Sabbaths (Saturdays) and teach God's word and Judaism on that day? *Osser*, sagt Schiller. We know well that on Saturdays the mothers, God bless them and inspire them with more Jewish tendencies, send their children to dancing schools, or to take music lessons, elocution lessons and other lessons that have nothing in common with religion. In the afternoon they attend matinees, which they cannot do on week-days on account of attending school, hence it is left for Sunday to learn religion. The schools may be, and some are, very good, imparting good wholesome religious instruction, but they are not Sabbath Schools. The day is not our Sabbath. Is it called Sabbath School to be different from the Sunday School, as the churches have it? Then the idea is good, but the name is still improper. Why not have a Hebrew Union of Schools of Religious Instruction? or any other name to convey this idea, but Sabbath School, unless it is a real school where instruction is given on Saturday, is a misnomer.

The president of this H. S. S. Union is the same minister who a few years ago spent a summer in Baltimore, where he lived but a short distance from two temples but attended none all the time he was in the city. The same reverend doctor who, in 1894, strained every effort to have Sunday services at his temple in Cincinnati, forgetting that he served a congregation to which a Lillienthal ministered for many years, and which promptly decided that no Sunday lectures were wanted by them. This rabbi to out-Herod Herod, contrived a plan that the board should act without the congregation, and accordingly, had them hold a meeting at which a majority complied with the will of the Doctor and voted for Sunday services—majority ruled. Yes, but no sooner had the congregation heard of the action taken than a special meeting was called and the action of the board was promptly nullified. But the genial gentleman of the cloth is not a man to be humiliated, and he bore it manfully.

The youngsters with an indescribable gusto grasp at the unusual opportunity to be soothed into a respectful sleep, and to be healed of all their spiritual ailments. With a wisdom unrivalled by their elders, they have already pierced the veil of the future and see in the coming publication a balm for childish ills, a panacea for spiritual croup, whooping-cough and measles.

New Public Bath for Brownsville.

A free bathing place for thousands of the residents of Brownsville; the handsome and modern new interior public bath, on Pitkin avenue, near Watkins street, was formally dedicated and thrown open to the public use last Saturday afternoon.

Thousands attended the ceremonies of dedication. Mayor Low and Borough President J. Edward Swanstrom spoke. There was music by a brass band, and the crowd was vociferous in its enthusiastic greeting of the Mayor and the borough officials. The bath was inspected by Mayor Low and some two hundred citizens. Admission was by invitation Saturday, it being impossible to accommodate the thousands who wished to make a tour of the new building. Borough President Swanstrom escorted Mayor Low through the bath, the latter expressing his pleasure that so fine a bath had been provided for Brownsville people.

Besides addresses by Mayor Low and Borough President Swanstrom, Public Works Commissioner William C. Redfield, the Rev. Dr. Leon Nelson, rabbi of Temple Israel; Dr. Simon Baruch, President Rothschild, of the Hebrew Educational Society, and Mrs. Tunis G. Bergen, also spoke briefly. Mrs. Bergen was largely instrumental in securing a public bath for Brownsville.

The new interior public bath is two and a half stories in height. It occupies a plot 50x100 feet, and was erected at a cost of something more than \$79,000. Four thousand men, women and children can secure baths in the establishment in one day, it is estimated. The other interior public bath in Brooklyn is located on Hicks street. That was finished a month ago.

IN THE THEATRES.

The New Amsterdam.

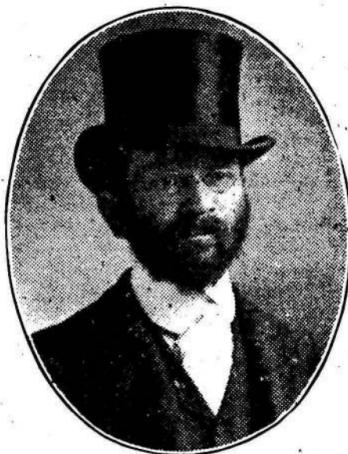

Mayor Low promised a liberal enforcement of the excise law in his previous canvass. Now he is executing the non-carrying out of his promises. Two legislatures met since he has been Mayor. What step has he taken toward urging the liberalization of the Sunday law?

If the Government of the United States is to be administered by a member of a political party, and the States of the Union are to be administered by Governors who are members of political organizations, why should the City of New York be excluded from the same privilege. Non-partisanship is the strongest kind of partisanship. The boss of a non-partisan party is a political boss, none the less.

For the moment that we Jews gave the Christians their God, who, as they claim, brought them civilization, happiness and everything good . . . Whatever the cause may be, we regret our bargain, and we Jews appeal to you, Christians: for God's sake, give us back our God and stop the incessant slaughters. We are already very much exhausted from our long suffering.

Federation of American Zionists.

A meeting of the Executive Council of the Federation of American Zionists was held on Sunday, Oct. 18, at the Leisure Hour Club, East 121st street, New York city. There were present Prof. Richard Gotthel, in the chair; the Rev. Dr. H. P. Mendes, Rev. Dr. A. M. Radin, Rev. H. Masliansky, Dr. B. L. Singer, Messrs. Abel, A. H. Fromenson, L. Lipsky, E. W. Lewin-Epstein, G. H. Mayer, William Morris, M. Neaman, A. L. Schiller, A. Radin, H. I. Barnett and the secretary. The chairman, who welcomed the members at the first meeting at which he has been able to preside, dwelt on the affairs connected with the formation of a Mizrahi in New York city and the collection of the dividend coupons of the Jewish Colonial Trust to cover the deficit of the El Arish expedition.

Question proposed and carried unanimously. The offer of Mr. E. W. Lewin-Epstein to cash coupons, free of commission, was accepted. The secretary submitted a report, which showed an increase of fifty-one organizations since the annual convention (28 chartered), as follows:

Pennsylvania—Allegheny, Beaver Falls, Bradford, Easton, Lancaster, Philadelphia, five in Pittsburg; Reading, Shenandoah, two in Scranton and McKeesport; New York State—Brooklyn, Elmira, Yonkers, Poughkeepsie, two in Rochester, six in New York city; Massachusetts—Boston, Holyoke, Salem and Springfield; Connecticut—Colchester and South Norwalk; New Hampshire—two in Manchester and one in Nashua; New Jersey—Newark, Perth Amboy and Trenton; Georgia—Atlanta; South Carolina—Charleston; Delaware—Wilmington; Mississippi—Rolling Fork; Maryland—two in Baltimore.

The report referred especially to the progress made in the States of Pennsylvania and New York, and to the desirability of carrying on circular agitation in the State of New Jersey, which it resolved to do.

Correspondence and a minute taken at the Basic Congress, with reference to the recognition of the United Zionists as an independent body, were read; and it was resolved to hold a special convention in accordance with that minute in Philadelphia on the 29th inst.

On the report of the death of the late Dr. Marcus Jastrow, one of the honorary vice-presidents, the following minute was adopted by a standing vote:

That the Executive Council of the Federation of American Zionists learn with profound regret of the demise of their colleague and honorary vice-president, Dr. Marcus Jastrow, who, even until a few weeks before his death, championed the cause of Israel and of Zion with ardor and enthusiasm. The council extends to the family of the departed and to all their co-workers in Zion who will sorely miss his kindness and thoughtful counsel, heartfelt consolation trusting that He may comfort those who mourn as He sendeth comfort to those who mourn for Zion and Jerusalem.

Resolved, That a copy of the foregoing minute be forwarded to the family of the deceased.

Further negotiations for the creation of a Mizrahi were referred to the Committee on Organization, with the power to co-operate with the chairman of the Propaganda Committee, and report.

The secretary reported that the sale of National Fund stamps amounted, to \$1,300, as against \$1,813 for the fiscal year 1902-3; and the Golden Book entries amounted to \$1,100 in the four months, as against \$580 for the previous year.

Mr. L. Lipsky, chairman of the Organization Committee, reported on the formation of district councils in Pittsburg, North Eastern Pennsylvania, in the New England States and in the city of New York, and the plans formed for recognizing councils in Baltimore, Cleveland and Rochester.

Mr. H. I. Barnett, chairman of the Shekel Committee, submitted that Sunday, Dec. 20, the seventh day of Chanukah should be celebrated as Shekel Day. This was unanimously agreed to.

Mr. E. W. Lewin-Epstein, chairman of the Jewish Colonial Trust Share Club Committee, reported plans for enlarging the number of these clubs.

Mr. S. Abel, chairman of the Yiddish Publication Committee, reported on the plans for raising \$2,000 for the issue of a Yiddish monthly.

Mr. A. H. Fromenson, chairman of the Education Committee, reported on the formation of a Jewish Lads' Brigade. (Special copies of this report can be had from the secretary.)

RALPH TRAUTMANN, Fusion Candidate for Sheriff.

RALPH TRAUTMANN, the Fusion candidate for Sheriff, has never been a candidate for political office before. Mr. Trautmann is not a politician, and has never engaged actively in politics, except in the interest of clean government. He is a business man pure and simple, and he promises to run the Sheriff's office on a business basis.

Mr. Trautmann, if he is elected, intends to see that the Sheriff's office gets a good, business-like administration, with graft an unknown quantity. Ex-Sheriff Grell, who is running independently because Tammany refused to put him on its ticket, is in the field, he says, because he thinks that the Germans are entitled to representation. Mr. Trautmann is a German. He is a member of numerous German societies, and has always been energetic in promoting the welfare of his fellow citizens.

With the late Abram S. Hewitt and Col. E. A. Stevens, President Roosevelt, then Governor, appointed Mr. Trautmann, in 1900, a member of the Palisades Interstate Park Commission. Gov. Odell reappointed Mr. Trautmann.

President Roosevelt, a short time ago, when he decided to have an investigation made of the conditions on Ellis Island, selected, as a committee of five, to do the work, Mr. Ralph Trautmann, Dr. Lee Frankel, Eugene H. Philbin, Thomas W. Hynes and Arthur Von Briesen.

Mr. Trautmann has always taken an active interest in the welfare of the immigrants on their arrival in this country, irrespective of their race, religion or nationality.

Mr. Trautmann has an attractive personality, and has made many new friends since his nomination. While not used to public speaking, he impresses those who hear him by concisely stating in a business-like manner how he will manage the af-

fairs of the Sheriff's office if he is elected. Mr. Trautmann is sixty-one years old, but he carries his years lightly. He was born near Coblenz, Germany, and when he was seven years old his parents emigrated to this country. His boyhood days were spent in St. Louis, where he studied in the public and private schools. Then he worked for a short time there and saved some money, with which he came to this city.

He was attracted by the stories of the rapid development of the West, and the outbreak of the Civil War found him in Kansas. He was at Fort Leavenworth when Captain Tough's Buckskin Scouts were organized, and he enlisted. Tough's Scouts had many fights with Quantrell's Guerrillas, in which Mr. Trautmann took an active part, but it is hard to get him to tell of them.

He was in the glass business with William A. Demuth in William street, and the next year joined the firm of A. & C. Kaufman, importers and manufacturers of lithographs. He is now a member of the firm of Trautmann, Bailey & Blampney, lithographers.

For a number of years Mr. Trautmann has been a trustee of the German Society, which renders assistance to German immigrants. He is a member of the German Hospital, and is interested in the Isabella Heimath, founded by Mrs. Oswald Otten-dorfer, and the German Polyclinic and other charitable institutions.

He is vice-president of the Liederkranz Society and a member of the Arion Society. For forty-three years he has been a member of the New York Turn Verein, and he is also a member of the Gesellig Wissenschaftlicher Verein. For many years he has been a member of the Arkwright Club and the Patria Club, and is a charter member of the Standard Council of the Royal Arcanum.
