### The Maggid and the Beautiful Jewess.

The Central Committee in Paris of the Alliance Israelite Universelle has sent 2,500 francs for the relief of the Jews who suffered losses during the recent disturbances at Lompalanka, Bulgaria.

Dr. Arnold Netter has been elected by a very large majority a member of the Academy of Medicine. Dr. Netter is chief of Hygienic works at the Faculty of Medicine, physician to the Paris hospitals and a member of the Central Committee of the Alliance Israelite.

Madame Arsene Darmesteter exhibits in the Paris Salon (Societe Nationale) a full-length portrait of Madame Monoto, the wife of the Japanese Minister in Japanese costume. The picture was shown earlier in the year at the Exhibition of the "Femmes Peintres," at the opening of which Madame Darmesteter was complimented by the President of the Republic on her work.

who came from the Philippines. The action of the Government is based on the ground that the policy of the monks is incompatible with the tendencies of modern society. It evidently doesn't pay for the monks to monkey with a liberal government.

In addition to General Popper, whose promotion was reported last week, another Jew, Brigadier Eduard Ritter Von Schweitzer, has been gazetted Major-General. He is the first Jewish general in the active army, which he entered as a private. He received his baptism of fire in the war of 1866 with Prussia. As commanding officer of the Twenty-sixth Infantry Regiment he twice had the honor of conveying the good-wishes of the regiment to its colonel-in-chief, the Grand Duke Michael of Russia, and on both occasions high Russian orders were conferred upon him. A few days ago he was appointed commandant of the Fifth-third Infantry Brigade. Major-General Schweitzer has remained true to his religion and has had his children taught the tenets of their faith.

A Hagan telegram from Cape Town says: Nine hundred and sixty-two undesirable were excluded from the Colony during 1903, under the provisions of the Alien Immigration Act. The number would have been greater but for the recognition of Yiddish as a European language. The number of alien immigrants amounted to fully half that of British immigrants.

Hon. Louis Sutzbacher, who was Associate Justice of the Supreme Court of Porto Rico, has just been appointed by President Roosevelt, to be judge of the United States Court, Western District Indian Territory. The appointment is in the nature of a transfer, as Judge Sutzbacher was very anxious to secure a position nearer home than Porto Rico.

Miss Edith Ayrton, who married Israel Zangwill, is a writer of ability, and the daughter of gifted parents, her father being a well-known scientist, and her mother also having attained distinction in the same field. Her stepmother was a friend of George Eliot, and is supposed to have been the model for Mirah Lapidoth, in "Daniel Deronda."

The Mount Zion Hospital, of San Francisco, California, has received \$1,000 from Mrs. Nettie Schwartz, to endow a bed in memory of her deceased husband. The Pacific Hebrew Orphan Asylum acknowledges the receipt of \$1,250 from Mrs. Schwartz, and a bequest of \$950 from the late Louis Wormser, of New York, and the Kureka Benevolent Association has received \$500 from Mrs. Schwartz, and \$950 as a bequest from Mr. Wormser.

Mr. Morris Kleiman, a native of Russia, but an American citizen, resident in Wisconsin, who was arrested May 14 at Cheljabinsk, has been released through the intercession of the United States Ambassador, Mr. Robert S. McCormick. It transpires that his arrest was partially due to representations made by the agent of a firm competing with the one represented by Kleiman.

Kleiman was charged with violation of Article 225 of the Penal Code, which provides that a Russian subject, who swears allegiance to a foreign State, without the government's permission, is liable to banishment or transportation to Siberia.

A committee has been formed to establish a Liberal Jewish Community in Paris. It is proposed to have a Sunday service, not to exceed one hour, besides one on Sabbath. There will be a sermon, while most of the prayers will be read in French. Everything not corresponding with modern ideas will be eliminated from the liturgy.

The Philadelphia Y. M. H. A. has 654 members and was conducted last year at a cost of \$4,564.88. The following are the officers: President, Adolph Elcholz; vice-president, Ephraim Lederer; treasurer, Clinton O. Mayer; corresponding secretary, Isaac Hassler; recording secretary, Leo G. Reinheimer; directors, Oscar B. Teller, Elkan Heny, Benjamin Loeb and William A. Stern.

of Aldermen brought the matter up before the City Council a second time, and upon the Burgomaster's plea who said that such a refusal would be interpreted as dictated by anti-Jewish feelings, the sum was granted by a vote of 32 to 24. Interesting was the reason given by one of the opponents. He said that the Jewish congregation supported foreign Jews, and thus created competition to the local trade.

Jewish young people not only carried off all of the oratorical prizes at the three high schools in Cincinnati, but that of the university as well. The winner of the latter was Frederick E. Braun, of the Junior class of the Hebrew Union College.

The congregation of Angermunde had lost a lawsuit against the city when the latter prohibited the Shechitah in the city abattoir, whereupon it requested the city to grant the establishment of a special abattoir for Kosher killing, but the city refused even this request, and the congregation will go to law again.

Last Passover the reform of a female choir was introduced in Casale Monferrato. The orthodox opposed it, especially, because the girls stand around the Hazan at the reader's desk, but they submitted to the fait accompli.

To perpetuate the memory of Walter Joseph Austrian, a victim of the Iroquois Theatre fire, a scholarship in his name has been established at Yale University. The donors were his father, Joseph Austrian of Chicago, and his brother-in-law, Henry Block of New York city.

They presented Yale with \$6,000 at the spring meeting of the corporation. The provision of the scholarship, founded with the sum is that the annual income shall be given to a student of strong, manly character and influence, with marked ability and promise of distinction.

Roger Benton Hull of Greenfield, Mass., who was young Austrian's roommate in Pierson Hall, was named as the first recipient of the scholarship.

Austrian was in the class of 1907 at Yale. He lost his life during the fire in the Iroquois Theatre, Chicago, in December while trying to save several women and children from the crush and flames. He was at home on his Christmas vacation at the time.

The Emperor has conferred the Order of the Red Eagle on Dr. Adler, director of the Philanthropin, the famous Jewish School in Frankfurt, which, as mentioned in our last issue, celebrated its centenary on the 14th ult.

The Minister of Finance recently gave a breakfast in Berlin in honor of Mr. Jacob H. Schiff, of New York.

The population of Poland is given as 11,759,642 in 1903, and the following note is added:

"A large proportion of the population are Jews and Germans, who contribute out of all proportion to their number to the development of trade. According to the latest statistics over 1,320,000 are Jews and 500,000 Germans."

Sunday has recently been made a compulsory day of rest for Odessa trades people, and no shops are allowed to be opened on that day. There are over 30,000 Jewish clerks and shop assistants

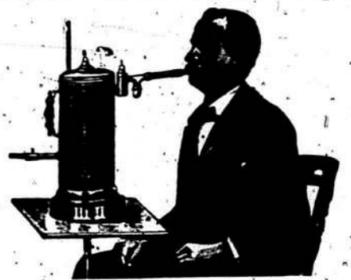

**An Anti-Semitic Rout.**  
 The municipal elections which have just taken place in France have resulted admirably for the cause of racial tolerance. The compact Nationalist and anti-Semitic majority of the Paris City Council has been driven from power, and the Republicans are now the dominant municipal element. Outside the capital, too, the Republicans have done exceedingly well, though it has to be remembered that Nationalism is mainly a thing of the Parisian boulevards. Among the fallen anti-Semites is a member of the staff of the Libre Parole. This newspaper has been unfortunate in late years, for in the parliamentary elections of two years ago, all its editors, with Drumont at their head, suffered ignominious defeat. The Libre Parole has never been backward in acknowledging defeat, and we observe that now, as in 1902, it admits that it has been beaten. In France, as a whole, we are glad to hear that the supposed Jewish question was avoided in the majority of the cases. Even in Paris itself only a few hardy spirits plucked up courage enough to paste the discredited old protests against the "Jewish Masonic Sect" on the walls. On the other hand, a number of Jews have secured election not only as municipal councillors, but as Mayors. In Algeria, where four out of the six members elected to the Chamber two years ago were friends of liberty, and where an anti-Jewish revival was feared, the results are almost equally satisfactory. Max Regis, who in 1892 formally renounced the anti-Jewish movement on the ground that "our struggles, our efforts, our sufferings have remained sterile," stood for municipal honors, but "failed miserably." Owing to apathy, an anti-Semite crept in at Oran, but elsewhere the Republicans gained the day, while former anti-Semites were driven to the humiliating expedient of soliciting Jewish votes. The recovery of the great French nation from the hideous Nationalist and anti-Semitic nightmare—a recovery illustrated by a pending vindication of Dreyfus—is a source of satisfaction to all lovers of France and freedom. Anti-Semitism, as

M. Camille Pelletan has recently said, was always the "favorite mask of reaction." The mask has now fallen, and Frenchmen can see what was behind it. The growing friendship with England will help on still further this return of a great and liberal nation to the light.

**The French Minister of Marine on Anti-Semitism.**  
 M. Pelletan, the Minister of Marine, was entertained to a cake and wine banquet during his recent visit to Constantine. Dr. Aubry, Member for the city in the Chamber of Deputies, in proposing the health of the distinguished guest, recalled the time not long ago when the streets were overrun by a fanatical mob, who insulted inoffensive citizens and threatened their lives and property to the cry of "Down with the Jews!" M. Pelletan, in his reply, denounced the mania for proscription, the unworthy and imbecile racial war of the anti-Semites, and continued: Anti-Semitism, this favorite mask of reaction, has always astonished me, for, after all, the twelve Apostles were Jews, and I ask myself, how would they be received if they should think of revisiting the earth? And was not Jesus Christ himself a Jew, at least through his mother? Picture to yourselves St. Joseph, suddenly resuscitated, attempting to enter a church in order to see the image of his putative son? What would be his astonishment if the faithful told him that he was of the accursed race and that he no longer had the right to appear on earth? (Laughter and cheers.)  
 Rabbi S. N. Deinard has resigned his position as editor of the Jewish Progress, of Minneapolis, Minn.

**"Summer Board."**  
 Now is the time when the Summer hotels and boarding houses are getting ready to receive the multitude which flock to the country during the hot months. The number of hotels and boarding houses are beyond computation. They are good, bad and indifferent in degree.  
 A good many people labor under the delusion that good board and good housing can be obtained at the country resorts at cheap rates. Good board commands adequate payment. Cheap rates buys cheap board.  
 Farm houses which offer five and six dollar rates will give five and six dollar board. The farmer and boarding house keeper are not in business for hygienic purposes. They are looking for a profit.  
 The meats and groceries must come from New York or the large cities, and the fixed rates must be paid. To offer the normal good bill of fare it costs the country boarding house and hotel keeper more than the city hotel and boarding house keeper, and to subsist properly a fair price must be charged to guests.  
 Living on advertised "plenty of milk and eggs" is largely a fiction, which those who attempt to get it soon find out. Nevertheless, there are thousands upon thousands who go to "farm houses," so-called, they pass half the day "kicking" about the meals, but each year they return to the same place.  
 So even at the better paid resorts criticism of the meal and conveniences is

part of the day's programme, and the vow annually repeated that they will never go back to the same place finds the vow annually broken, and they are back again each Summer.  
 The hotel keeper's life in the country is not altogether a bed of roses. To satisfy the guests altogether is an impossibility, so they do the best they can, and every returning Summer renews and ends his ordeal with more or less profit.  
**L'AIGLON.**  
**"Historical and Biographical Narratives."**  
 Under this title appears a book published by the American Book Company and written by Isabel R. Wallach. The book fills a long felt want, and now that we have read it we wonder how we ever got along without it. It is, as the author says in her preface, "a stepping-stone to history," and we heartily recommend it both to teachers and pupils. The sketches, which include the great men of Oriental nations, Greece, Rome and Europe, are written in a particularly clear and graceful style. The ethical lessons, of which there are many, are worked into the sketch in such a manner as to make it very interesting. This is unusual, especially in sketches to be read by children. We wish that some of the school readers would be prepared on a plan more like this; we feel sure they would prove more interesting and beneficial than they now are. We congratulate the author on the success of this book.  
 The Emperor has conferred the Order of the Crown on Herr Julius Katz, chief editor of the Karlsruher Zeitung.

**Montreal.**  
 The Austro-Hungarian congregation, "Shaarai Tefillah," consecrated its new synagogue last week. The building is a beautiful structure and the dedicatory exercises were witnessed by an assemblage that crowded the edifice to the very doors. After the preliminary exercises the prayer of dedication was offered by the Rev. A. M. Ashinsky, of Pittsburg. The Sepharim were carried by the President and other prominent members of the congregation, and the usual circuits were made. After the prayer for the King and Royal Family had been offered by the Rev. Meldola De Sola, the Rev. Dr. Sprintz delivered a Yiddish address. Rev. Meldola De Sola then addressed the congregation in English, as did Rev. Herman Abramowitz, and a second address was given by Rev. A. M. Ashinsky, who had been specially invited to come from Pittsburg for the ceremony. The choral portions of the service were rendered by the Rev. M. Blumenfeld and the congregational choir.

The disbursements in the various departments for relief were \$17,185.14.

**OBITUARY.**

**Meyer S. Isaacs.**

Meyer S. Isaacs, for years president of the Baron de Hirsch Fund, and an active worker and leader in Jewish charitable, educational and commercial institutions, died in the Equitable Building, 120 Broadway, on Tuesday afternoon from heart disease, to which he had long been subject.

Judge Isaacs left his office at 52 William street soon after 3 o'clock, and was taken ill in Broadway. He entered the Cafe Savarin and sank into a chair, quickly becoming unconscious and silently passed away.

Meyer Samuel Isaacs was born in this city May 8, 1841, being the eldest son of the late Rev. Samuel M. Isaacs, minister of the Shaarey Tefillah Congregation, of which the deceased was secretary for a number of years. He was graduated from the University of the City of New York in 1859, and from the law school of that institution in 1862, being admitted to the bar on his twenty-first birthday. He assisted his father in founding The Jewish Messenger in 1857, and was long associated with him in its conduct. He was elected vice-president of the Real Estate Exchange in 1867.

Gov. Cornell appointed Mr. Isaacs Justice of the Marine Court in 1880, and when Baron de Hirsch decided in 1889 to establish a fund for refugees he called upon Judge Isaacs to organize a committee to supervise its expenditure, and since then he had devoted nearly as much time to this work as to his own profession. He was long president of the Board of Delegates of American Israelites and of the Hebrew Free School Association.

He received nominations for the Superior Court in 1891 and for the Supreme Court in 1895; was a trustee and director in the Columbia Bank and the American Savings Bank; a member of the Bar Association of New York City, the New York State and American Bar Association, the American Academy of Political Science, the Civil Service Reform Association, and of the Republican and City clubs.

Judge Isaacs was a life-long Republican. He was in 1884 one of the Committee of Fifty-three which promoted the Roosevelt legislation, and was one of the committee of lawyers that secured changes of legislation in the County Clerk's and Register's offices, and was on the Committee of Thirty which reorganized the Republican party in New York in 1893. He was a contributor to nearly all the Jewish institutions and orders of this city, and a member of True Craftsmen's Lodge No. 651, of F. and A. M.

Judge Isaacs married Marie Solomon, daughter of B. M. Solomon, of this city, on Feb. 4, 1869, who died sixteen years ago, leaving six children, all of whom are living.

**Jewish Publication Society.**

The annual meeting of the Jewish Publication Society was held on Sunday afternoon, May 22, in the Assembly Hall of Keneseth Israel Temple, Philadelphia. Edwin Wolf, the president, read his annual report, in which he referred to the society's output of the year, among the principal features of which was the publication of the first instalment of the new Bible translation. This was the Book of Psalms, a product of the highest scholarship, as regarded both literalness of translation and style. It was a volume symbolic of the culture of the twentieth century Jew of America. Other publications had been "The Voice of America on Kischeneff," edited by Dr. Cyrus Adler; a special edition of Michael Davitt's volume, "Within the Pale," the "Jewish Year Book," and a Juvenile story, "In Assyrian Tents." A New York branch of the society had been organized. Reference was made to the death of Rev. Dr. M. Jastrow and Simon A. Stern, who had been members of the Publication Committee, and of Herman S. Friedman, the society's second vice-president, and the election of Dr. Solomon Schechter, president of the Jewish Theological Seminary of New York, as a member of the Publication Committee, to succeed Dr. Jastrow.

At the conclusion of Mr. Wolf's report Dr. Jacob W. Hollander, of Baltimore, was elected temporary chairman, and Dr. Charles S. Bernheimer, secretary.

The report of the Board of Trustees showed a membership of 5,340, scattered throughout the States and Territories and in Europe, Asia and South Africa. The report of the treasurer, Henry Fernberger, showed receipts of \$26,217.67; disbursements, \$22,510.59; balance, \$2,446.97; balance in permanent fund, \$17,345.50.

These officers were elected: President, Edwin Wolf, of this city; first vice-president, Dr. H. M. Leipziger, of New York; second vice-president, Solomon Blumenthal, of Philadelphia; honorary vice-presidents, Jacob Haas, of Atlanta, Ga.; Rev. H. Heller, of New Orleans; Miss Ella Jacobs, of this city; Simon Rosendale, of Albany, N. Y.; Rev. Dr. Joseph Stolz, of Chicago; trustees, Edwin A. Fleisher, of Philadelphia; Daniel Gugenheim, of New York; Ephraim Lederer, of Philadelphia; Simon Miller, of this city; Harris Weinstein, of Sacramento, and Cyrus L. Sulzberger, of New York.

The banquet given at Mercantile Hall in the evening was attended by about 200 prominent Jewish men and women from Philadelphia, New York, Baltimore and other cities. A feature of the evening was the presentation to Morris Newburger, who had been president of the society from the time of its organization until two years ago, of a handsomely bound and inscribed set of the books published by the society. There were forty-two volumes. The presentation was made by Judge Mayer Sulzberger, who acted as toastmaster.

Mr. Newburger responded, and then toasts were given by the following: Dr. S. Schechter, Rev. Isador Rosenthal, of Lancaster; Cyrus L. Sulzberger, of New York; Prof. J. Hollander, of Baltimore; Dr. Cyrus Adler, of Washington, and J. de Haas, of New York.

Edgar J. Nathan invited the society to hold its banquet in New York. Felix N. Gerson read a poem dedicated to the society.

He will make some slight alterations in the text of the play and will increase the ballet in the third act, making it one of the most beautiful pictures of Oriental gayety, and will add a new feature to the scene where David kills Goliath. Besides this he will novelize "The Shepherd King" for publication by Harper & Bros., go to Denver for a week's starring engagement, and thence to Switzerland, where he will spend a month, returning to New York the first week in September to conduct the rehearsals of his company.

Evidently Mr. Lorimer believes in work.

**Famine and Disease in Russia's Army.**

The correspondent of the Times in Russia says that the mother of one of the Jewish surgeons who were sent from Warsaw to the war recently received from her son a letter which throws a characteristic light on the results of the Russian conscription.

The letter, which is written in the usual official Russian style and bears the stamp of the censor, states that the writer is in good health, that admirable order prevails among the troops, who are certain of victory and amply supplied with all necessities, and that there is so little illness that the army surgeons have hardly anything to do.

It concludes with a request that his mother send some Hebrew books, of which he gives the titles:

These read: "Famine and Destitution," "Consequent Fearful Epidemics," "Scarcely Any Sanitary Appliances," "Demoralization of the Army Constantly Increasing," "End of Discipline," "Wish I Were Taken Prisoner."

Evidently the censor did not know Hebrew.

"For several years we have passed many pleasant and profitable hours together. It is with deep regret that we disband. But we have promised to remain together a little while longer before we enter upon the battle of life.

"Meanwhile we will seize every opportunity to acquire all the knowledge we can.

"This knowledge, the grandest gift, which shapes men's lives and souls uplifts

To the Heavenly land above,  
Where awaits us Peace and Love."

"Thus armed with knowledge, we will go out into the world to take our places in the ranks of the workers, striving at all times to find grace and good regard in the sight of God and man."

The confirmands, all of whom acquitted themselves creditably, were then formally admitted as members of the Jewish faith and words of earnest advice again addressed to them by the rabbi as their diplomas were handed to them.

The gold medal, awarded to the scholar of highest standing, was this year more closely contested than in any previous year during the past ten years. Miss Minnie Monash and Master Irvin Israel will both receive first honor medals. The work of both of these young people is reported as being quite out of the ordinary.

The Synagogue was beautifully decorated by the "Happy Workers," who undertake this sacred duty from year to year.

Next Monday is Decoration Day.

The memory of those who gave up their lives to save their country should never be forgotten.

The dead are never sick—consequently all diseases may be classified as diseases of the liver.

As Nature cannot make us altogether wretched, she resorts to the trick of contrast by making us sometimes almost happy.

As we go to press the National Conference of Jewish Charities has held its opening session which was well attended. We will publish an account of the proceedings in our next issue.

Will some modern Rabbi who has oft deeply deplored the fact that the "economical question" prevents an observance of the Jewish Sabbath, kindly step to the front and point to a single individual whom he has asked to close his business on Saturday?

The oft repeated question, "How many of the children upon whom by the grace of the pastors of the Church of the Holy Convenience the "rite of Confirmation was administered" last Friday, visited the Temple on the Sabbath day immediately following, still remains unanswered.

Every season has its practical charity and with the coming hot weather the Hebrew Sanitarium for poor children will be actively engaged in its commendable humanitarian work.

The Sanitarium has no membership upon which to draw for funds, and their beneficent work is commensurate with the donations received from voluntary contributions. Now is the time to assist them in their preparation for the season.

Rabbi Benjamii, of Temple Beth Elohim, of Brooklyn, is at it again. While recently "administering the rite of Confirmation," the ridiculous and sacrilegious ceremony "Salute the Flag," accompanied with the singing of the National Anthem, was performed by the children while unfurling it to the "breeze" of the sacred edifice. It is not sufficient that the handsome Doctor should be a regular reader of the HEBREW STANDARD but he should also make note of its criticisms, and follow the advice given "not to sacrifice self-respect and principle to the passing applause of the day."

The Threefold Benediction

ברכה ד'

"May the Lord bless thee and keep thee; may the Lord shine His countenance unto thee and be gracious unto thee; may the Lord lift His countenance unto thee and give thee peace!"

Numbers vii, 24, 25, 26.

"It is important that a nation and a people should have, in order to be able to exist, producers, teachers and protectors," says one of our European scholars in defining the priestly benediction, "and therefore a threefold blessing." Under the producers, it may have been understood to be the farmer, the agriculturist, who devotes his life and energy to the tilling of the ground and the harvesting of the fields; who with the sweat of his brow eats his bread as he plows and hoes the soil and prepares the bread to all classes and masses, to the king as well as to the subject, to the rich as to the poor, to the Jew as to the Gentile, to all, who without him could not live even had they millions of income. They are entitled to the first benediction—the first blessing from the priest ברכה ד' ושמך "May the Lord bless thee and keep thee! Bless thee, that thy handiwork prosper, and keep thee from the evil elements that may invade thy territory."

But it must not be forgotten that the sweetest prosperity and abundance is only a small part of happiness man can enjoy, if culture and enlightenment, if knowledge and religion are not present, therefore the second benediction belongs to the teachers—the teachers of knowledge and learning, the teachers of religion and moral virtues. They make the country. They give the power and strength to the people and the government, for ignorant people and an ignorant government make a sorry government—intolerant, superstitious, barbarous, oppressive and unjust. The best government is made by the schoolmaster. "Knowledge is power," and where the most knowledge is, there is the best religion, the sweetest relation between man and man, between neighbor and neighbor; accordingly to them belongs the second benediction,

אר ה' פניו אליך ויחן

"May the Lord shine His countenance unto thee, and be gracious unto thee." His shining countenance guide thee in the right path, to teach thee right knowledge, but be gracious to thee still, if unwittingly thou hast erred.

Then last, but not least, belongs a benediction to our protectors. When we follow our avocations and calling; when we are engaged in our exercises of commerce and industry; or, any personal work and labor that we perform, the strong hand of the law keeps order and cares that we are not disturbed. When steam and electricity prepare the pathway through vast deserts, and their whistle and buzz announce the smiling industries that they create, our protectors and guardians watch vigilantly that none be disturbed, wronged and defrauded. We go even further yet, if a foe should arise and assail our government or seek to invade our land, then our protectors, our soldier boys, who go to the front, risking their lives for their country and government; are they not in need of, are they not entitled to the priestly benediction פניו אליך ויחן "May the Lord lift His countenance unto thee!" Let His benignance and love guide your arms, give courage to your efforts, and hold your breasts firm,

and at last establish for you that peace—that tranquil peace that you so richly merit.

Now, that we are all 'producers, teachers or protectors to some extent, we all do some thing that produces—some thing which others need—all honest, industrious, energetic people. We all have to teach somebody, our children, or some one else who look up to us for example and teaching. We are all protectors of some home, some circle, some body. Let us then devote our energy, our efforts to produce the best we can; to teach in the best manner possible; to protect ably and willingly all an everything that comes under our care, that God may bless keep us! That God may shine His countenance over us graciously! That God's countenance may be lifted to us, vouchsafing us sweet peace.

Myer S. Isaacs.

As we go to press we learn with great sorrow of the death of Myer S. Isaacs. The very suddenness of the same came as a shock to his many friends.

Judge Isaacs has been a familiar figure in this community for nearly forty years. The son of a deservedly respected Rabbi, and himself gifted with most excellent qualities, he identified himself very early in life with the various charities and communal organizations, in which he was at all times an important factor. In later years he gave much of his time to the Baron De Hirsch Fund, of which he was the president.

He was an earnest Jew, and maintained by his life's example the sanctity of the Sabbath. It was of him that the late Charles P. Daily said: "I admire him because he keeps his Sabbath."

The life of Myer S. Isaacs interwoven for decades with the history of the Jews of New York in nearly all its various phases has been an exemplary one, and his death at so early an age is one which will be sadly mourned by the whole Jewish community.

The graduation exercises of the Mount Sinai Training School for Nurses will be held next Tuesday evening. It has always been a matter of surprise to us that this excellent institution has not many more Jewish girls upon its list. Why young Jewish women would prefer to be "sales-ladies" and receive six dollars per week, rather than trained nurses earning \$20 a week and upwards, we are unable to understand. They seem to turn up their pretty noses at the idea of doing menial service, forgetting that every one who occupies an official or professional position has to render services to the public for the salary he earns. It is simply a mere question of false pride.

There is this difference between the two blessings—health and money; money is the most envied, but the least enjoyed; health is the most enjoyed but the least envied; and this superiority of the latter is still more obvious, when we reflect that the poorest man would not part with health for money, but that the richest would gladly part with all his money for health.

Child Thieves and Their Ways.

III.

Face to Face with the Enemy.

BY THE SENTINEL.

It has been shown how the home life of the children of the Ghetto destroys in them the child-like reverence and obedience which in the old country were as natural and real as life itself. The anomaly is presented to the child that it must show reverence to a faith and observance to customs, which it is not slow to discover are no longer considered binding upon its parents. The unwholesomeness of such an atmosphere of religious insolvency, does not require any argument. Add to this the influence of the purely secular education which the child obtains in the Public Schools, and it can readily be seen that such a child soon learns to play the hypocrite, while in the presence of its parents. The gulf which grows between the father and his children is not so noticeable while they are young, through the limited time that his employment permits him to spend under the roof that he calls home. In the case of the mother it is different. The children, the younger ones at all events, are always under her care. But the pressure of the new life forces her, too, to undertake many new and unaccustomed duties. And in any case, the playground of the children is the street.

All at once a new influence is found to have entered into the lives of the children.

This new influence over the younger children is here "Halted" and investigated.

Some sweet faced lady meets little Joseph, or little Becky, in the street, and with great solicitude inquires to know his or her name and where the child lives? Or else some playfellow that the child has met in the democratic way of children, in the gutter playground, suggests to the child that he should come and visit the kind lady who gives them milk and crackers and teaches them to sing such lovely songs. Somehow or other, the child finds itself inside one of the many Settlements, Kindergartens or Creches (nurseries) which during the last few years have sprung into existence in the Ghetto.

Now it must be distinctly understood, that so far as the humanitarian work is concerned, these institutions are good—unquestionably good. A light cheerful room, cleanliness and some wholesome food are far better than the street, filth and hunger, but if the kind ministrant were pressed to answer the question, as to the foundation upon which was built this superstructure of charity, the answer, if truthfully given, would in most cases be, "Wist ye not that I must be about my Father's business?"

"Whosoever shall give to drink unto one of these little ones, a cup of cold water only . . . verily I say unto you he shall in no wise lose his reward."

It is therefore with the underlying spirit that actuates the deed and not the deed itself, that we find fault.

Many of these institutions claim to be "unsectarian." This claim extends no further, in fact, than that they are not specifically Episcopalian or Baptist or Methodist, or indeed, of any par-

ticular sect of Christianity. But they are all Christian, and the aim of all of them is to bring a knowledge of Christian Charity to the Jews! The "workers" know full well the importance of their insidious methods upon the impressionable minds of children. It is not to be gainsaid, that it augurs badly for the future Jewishness of children who encounter harsh strident voices in their homes, rough uncouth manners in their synagogues, ill favored and sloven teachers in their Chederim, and meet the reverse of all these in the Christian mission places.

So we find our child thieves, wolves in sheeps' clothing, "wise as serpents and gentle as doves."

The Man in the Observatory.

XXVI.

Those whose memory runs back for thirty or more years will remember a little brick-house on the south-west corner of Centre and Leonard streets in this city; a staircase ran along the Centre Street front of the building on the outside from the sidewalk to the first floor. Above the windows of this floor was a sign which read "William F. Howe's Law Office." At that early period Mr. Howe was already a noted criminal lawyer.

It was more than forty years ago when Abe Hummel came to Mr. Howe's office as a boy. The story of this alliance has often been told and need not be repeated here. In physical make up, no two men were ever greater extremes; Howe, was always a man of great girth and much avoirdupois; Abe Hummel at that time was diminutive in size and very light in weight. Their association, however, became close, and I might say, affectionate. Mr. Howe entertained the warmest friendship for his protege, and this became more and more accentuated throughout their busy career and partnership.

"Abe," as he was generally called, was a bright fellow, quick and ready. Mr. Howe soon realized his worth and was wise enough to make Abe a partner. And a busy partnership it proved to be. Mr. Howe who, as already noted, was prominent as a criminal lawyer, and the firm of Howe & Hummel became known throughout the entire country. Some of the most noted cases in the criminal history of the State passed through the office of Howe & Hummel and they won many victories in the conduct of their profession. As Mr. Howe grew older and time began to tell upon him, Abe Hummel assumed the burden of affairs, and his career has been an eminently successful one.

Some years ago, one of the then noted members of the detective force told the writer that he was asked to write up his experience in the Central Office, and mighty interesting reading said he it would make, but he has as yet not done so. If Abe Hummel were to write up the history of his professional career, and the incidents and accidents of his intercourse with those whom he and his late partner came in contact with, it would be a great contribution to the writings on criminal history.

Of late years, indeed, for many years, Mr. Hummel has largely withdrawn himself from the practice in the Criminal Courts and has devoted himself to the Civil side of the law, in which he has met with eminent success. In matters of copyright af-

fecting the stage and the drama, on contracts affecting the theatrical profession, Mr. Hummel is an unquestioned authority. So also on the laws governing divorce. While in civil practice in other departments of the law, he is an adversary to be reckoned with.

Abe Hummel is also noted as a society man. He is around and about, and is famous as a "first nighter" at the theatres. Many years ago he was an active member of Manhattan Lodge of the Order of B'nai Berith.

As the years went on, like many others, new fields claimed Abe, though none of the fair sex has ever been able to conquer him and bring him within the folds of matrimony.

Abe is a bachelor still. He was a good son, and is a brother par excellence, and enjoys the confidence and esteem of both Bench and Bar.

The Mirror.

A Rabbi (whose name I am not permitted to disclose,) in a pungent letter addressed to my Chief, takes me seriously to task, for "his (my) incessant aggressive attacks against the Jewish clergy, and his (my) vile aspersions against the sainted Dr. Isaac M. Wise in the last "Mirror."

He continues by saying "That these unseemly onslaughts against men engaged in a pure holy calling, not only tend to bring Judaism into disrepute and its teachers into disrespect, but mar the pages of an otherwise excellent and interesting Jewish journal (of course, all this is taffy,) and will naturally, ultimately result in a great loss of subscribers to the HEBREW STANDARD."

To the first count of the indictment I plead "justification." To the second count I plead "not guilty," and respectfully ask the Court of Public Jewish Opinion to strike out the word "sainted" as surplusage and irrelevant; "canonization," being entirely foreign to Judaism and unknown in Jewish ecclesiastical polity.

It is said of the publisher of a paper in this city, that once seeing a Jewish funeral pass his printing office, he made immediate inquiries to ascertain the name of the deceased, apprehensive that he had lost a subscriber. Now, if my Chief were publishing that paper, the insinuation that a continuation of my Mirror reflections "will naturally ultimately result in a great loss of subscribers," might cause him to quake with fear; but the readers of the HEBREW STANDARD who have watched his course for years know that he is not built on those lines.

Just as every secular newspaper advocates a certain political principle, so I believe a Jewish journal should have a fixed religious platform upon which it should stand at all times and at all seasons.

It should neither toady to the rich for the financial assistance that can be secured, nor curry favor with high-salaried Rabbis for the purpose of securing their approving nod, nor print their dry sermons for that reason to the exclusion of more readable matter.

A Jewish journal should have a pronounced raison d'etre. It should not be all things to all men. It should not "halt between two opinions." It should stand for something, and the

passing away of the Jewish Messenger after a long but useless existence, and the decadence and dry rot of another, are practical illustrations of

פחו כמים אל הוורר "Unstable as water thou shalt not prevail."

I am free to admit, that like my Chief, I am a good hater; and if there is any one thing which my contempt becomes dizzy looking down upon, it is a Mugwump, and if there is one thing lower in my detestation than a political mugwump, it is a religious hermaphrodite. Men in public life who are afraid of their shadows, who bend to every passing breeze seldom succeed, but after strutting a brief existence upon their narrow stage, creep out of a loathsome existence covered with the deserved contempt of their betters.

The HEBREW STANDARD has always been the foe of humbug and fraud in Judaism, and its well-directed efforts have been mainly concentrated upon that malign, insidious, dangerous, life sapping disease, "IGNORANCE AND INCOMPETENCE IN THE JEWISH PULPIT."

To awaken the Jewish public to a sense of the enormity of this crime against Judaism, to depict in plain, unvarnished colors the outrage perpetrated against the rising Jewish generation, and to expose in all its hideous nakedness this deplorable infamy has been the mission of the HEBREW STANDARD.

It is an oft-repeated story and one that should cause the blush of shame to mantle the cheek of every sincere Israelite—but unfortunately true—that a large majority of our Jewish pulpit incumbents, are open violators of God's laws, a great number of them agnostics and some atheists, and three-fourths of the Rabbinical graduates of the Cincinnati College are unable to read Hebrew without vowel points. And yet these men are Rabbis!

I am not aggressive, but Truth is. I am not "incessantly attacking the Jewish clergy," for, thank God, there are yet many honest and sincere Rabbis who have not bent the knee to Baal, many of them who are learned scholars, and their daily consistent lives make them exemplars of the faith they profess and teach. These are the men whom all worthy Israelites honor and respect, and my pen has never written a single line in derogation of their high character.

But with the smirking hypocrites—the insincere Rabbis for Revenue—the pert peddlers of pretty phrases—the garrulous gyrators of glittering generalities—the second-hand swipers of stolen sermons—the pretty, pert, pet pastors whose gigantic intellects revolve around the ponderous problems of organizing Browning Circles, and Culture Classes, and Cadet Corps—the ham and lobster fressers—the open despisers of the Jewish Sabbath—the wilful transgressors of Divine command—the mockers of every time-honored Jewish custom and observance,—I have no sympathy, and will continue to hammer them upon the anvils of common sense and common decency, until they mend their ways, but as the prophet says,

חמסין אהפין מות רשע "Have I at all any pleasure in the death of the wicked?" הלא בשונו מרדכי והיה "and not rather that he return from his evil ways and live."

Referring to my alleged aspersions of the late Dr. I. M. Wise, I would say that while I never regarded him as a profound Talmudist, a pious Rabbi, or an erudite scholar, I always gave him credit for being the most charitable, the hardest worker, the most skilled diplomatist and the best organizer of all the Reform Rabbis in America, in his age and generation.

I am frank enough also to say, that in my opinion, while he was the architect, the builder and the mainstay of American Reform, none other has played such havoc in Judaism than he, and that though honest in his opinion, he builded neither wisely nor well, as the existing disintegration in Judaism, the results of his labors, amply demonstrates

As a fighter I always admired him, and he fairly terrorized all the learned leaders of Reform. Their hatred of him was deep and strong, and now it amuses me and oftentimes fills me with disgust, to see the men who would have knifed him if they could, play the אהרן מוח קרושים act, hypocritically turning up the whites of their eyes and calling him the sainted Dr. Wise. Out upon such drivel and rot!

Not one of them possessed his outspoken manliness, not one of the present time-servers who hated and derided his pretensions to scholarship and leadership, is able to fill his shoes. Give the departed credit for the work he did in his field of action, and let the Rabbis whom he trained, instead of endeavoring to place a saintly aureole around him, manifest their gratitude to their creator by putting their hands in their pockets (not keeping them there) and while soliciting donations from others, contribute liberally themselves to the Wise Memorial Fund. His memory well deserves all honor at their hands.

I think that the Talmudic injunction כל-המרבה דברים מביא חסא could for the benefit of some of our long-winded sermonizers be properly rendered, "He who talks too much (in the pulpit) causes sin."

The German poet, Hebel, has a beautiful little story of a Jew, who accepted a wager of some one who claimed to be such an expert marksman, that he could shoot a coin which the Jew would hold between his fingers. If he missed, the Jew would win. The man shot and hit the Jew's finger instead of the coin, and the Jew exclaimed, "Au waih! ech hob gewonnen."

The Jewish Gazette of last week has the following, which is worthy of reproduction: "Last week a young man who lives on Rivington street was married. His bride, a young miss of seventeen, was, previous to her engagement, engaged in peddling candles from house to house. "Er hot gesucht a meidl mit licht," and his efforts were crowned with success."

Referring to a certain college (nameless here for evermore,) which was said to be a learned place, some one accounted for it by saying, that most persons took some learning there, and few brought any away with them, so it accumulated.

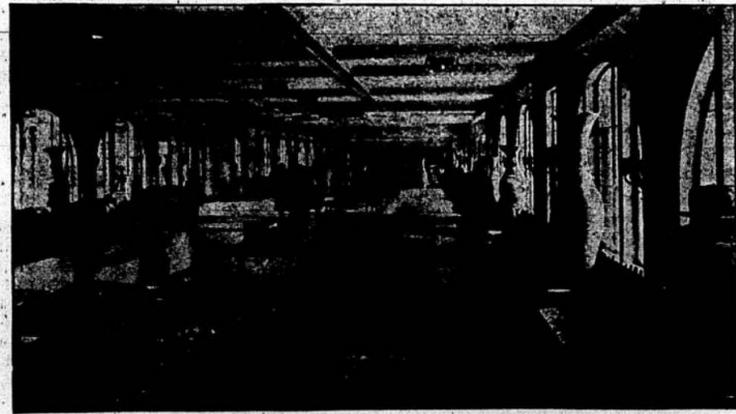

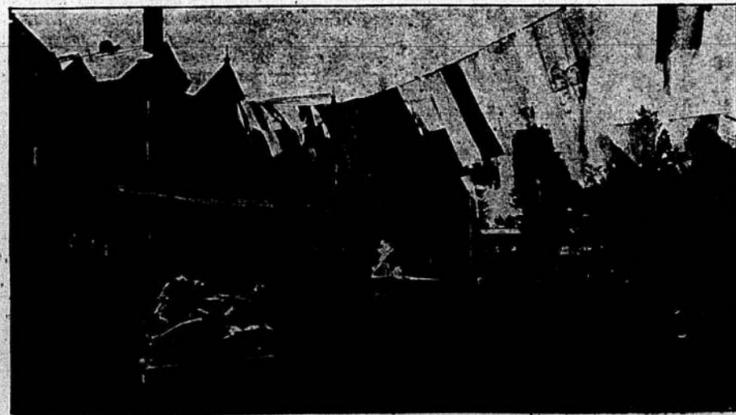

 mulated fire rules for the householder,  
 telling what to do in case of fire and  
 how to prevent fires. The rules of  
 Chief Baxter follow:

In case of fire first of all sound the  
 alarm.  
 Close the door and open the windows.  
 A closed door is a wonderful protection  
 against flame, and an open window lets  
 out the heat and the smoke.

Do not fear thick smoke too much.  
 A stairway that is a mass of smoke is  
 not necessarily impassable. Go down  
 on your hands and knees; you will find  
 no smoke near the floor. Try to de-  
 scend the stairway in this way, and in  
 nine cases out of ten you will descend  
 in safety. Many have been burned to  
 death because they thought a smoke  
 filled stairway meant an impassable  
 one and because they did not know  
 that there is always plenty of pure air  
 to breathe down near the floor.

If there is a skylight, break it open.  
 The smoke then will disappear through  
 the opening rapidly.  
 Should the fire have gained such  
 headway that all exits are blocked,  
 shut yourself in a front room and lean  
 far out of the window so that the fire-  
 men may see you. Once they see you,  
 it is reasonably certain that they will  
 rescue you.

Above all things keep cool. The ma-  
 jority of deaths from fire would have  
 been averted if the victims had not  
 lost their heads.

Inspector Hill gives these rules to  
 prevent fire: Do not put ashes in  
 wooden boxes or barrels. These wood-  
 en receptacles are a frequent cause of  
 fire. In every kitchen and cellar there  
 should be an ash box of iron or tin.  
 Keep the cellar clear of heaps of  
 refuse—of old newspapers, rags and  
 broken wood.

Cobwebs on cellar beams and walls  
 should be carefully guarded against,  
 and every cellar should receive at least  
 once a year a complete coat of white-  
 wash or of fireproof paint.

Line all flues with terra cotta.  
 Keep wood away from the chimneys.  
 Where chimney lathing is necessary,  
 use a lathing of metal.

Never hang lace curtains near gas  
 jets. Let your windows be bare of  
 lace or else move your gas jets to an-  
 other part of the room. In private  
 houses there are few causes of fire  
 more frequent than lace curtains.

**How to Clean Oilcloths.**

To freshen the oilcloth, wring a soft  
 cloth out of clear, warm water, dip one  
 corner of it in kerosene, rub first with  
 wet cloth, then with the oiled corner.  
 Use no soap. For binding the edge  
 of oilcloth there is no more serviceable  
 material than silesia or the heavier  
 drilling. Cut strips about an inch and  
 a half in width, turn under one edge,  
 slide the remaining edge under the oil-  
 cloth, leaving the width of half an  
 inch or less with the folded edge, which  
 turn over on oilcloth and tack in place.

**How to Remove Dust From the Eyes.**

Any foreign substance in the eye is  
 very painful, but to remove it is, after  
 all, an easy matter. If the dust lodges  
 on the lower lid press the finger gently  
 but firmly against the eyelid, pulling it  
 down and telling the victim to look up.  
 This exposes the inner lid, and the  
 dust can be removed upon a toothpick  
 or hairpin, about the end of which a  
 bit of cotton has been wound to avoid  
 a scratch or bruise. If the upper lid is  
 affected take the eyelashes firmly be-  
 tween the forefinger and the thumb,  
 ask the patient to look down and with  
 a quick movement turn the eyelid up  
 over the point of a pencil, which  
 should be pressed against the eyelid  
 just above the stiff part. This causes  
 no pain, and the dust can be wiped off  
 as from the lower lid. A bit of steel is  
 more difficult to remove. If a magnet  
 is at hand it is sometimes easily drawn  
 out by the magnet's attraction.

**How to Clean Gas Stoves.**

Instead of polishing the gas stove  
 every day crumple a newspaper and  
 dampen slightly if there are any spots  
 on the stove; then polish off with dry  
 paper, and unless there is a great deal

of cooking this will prove an excellent  
 way to keep the gas stove clean. Kitch-  
 en ranges may be kept bright in the  
 same way.

**How to Make Beef Essence.**

Beef essence for invalids made as  
 follows will prove a most excellent  
 restorative: Take a pound of gravy  
 beef, free from fat and skin, chop it  
 very finely, add a little salt and put it  
 into a stoneware cooking jar with a lid.  
 Cover the edges with a thick flour and  
 water paste. Stand the jar in a pan  
 of water in a steady oven. Fill up  
 with more water as it dries away and  
 bake in a steady oven for three or four  
 hours. A dessertspoonful of this will  
 prove very nourishing to a sick person.

**How to Bank the Fire.**

Newspaper, soaked in cold water,  
 squeezed and rolled tightly into balls,  
 can be used to bank up the back of a  
 fire that is wanted to burn a long time.  
 Put a good layer of small coal on top.

**How to Prevent Perspiration.**

To prevent perspiration under the  
 arms a beauty specialist advises first  
 washing the skin thoroughly with soap  
 and warm water and then drying and  
 sponging with a preparation made by  
 mixing half an ounce of rosewater, two  
 scruples of tannic acid and two and a  
 half ounces of rectified spirits of wine  
 with three ounces of water.

**How to Remove Paint From Silks.**

Patient rubbing with chloroform is  
 most effective and will not hurt the  
 most delicate colors or fabric. Con-  
 stantly change the surface of the flannel  
 and use more chloroform.

**POINTS ON BOWLING.**

**How to Become an Expert Player at This Game.**

To bowl correctly, swing the ball and  
 roll it, not throw it. This distinction  
 is the cardinal point on which depends  
 the success of the game, says the Chi-  
 cago Tribune.

In starting, bend the elbow slightly,  
 if any, and swing the arm as if pivoted  
 from the shoulder.

Use a ball that you can roll swiftly  
 and guide properly before its start.  
 Too big a ball defeats its own object,  
 for a firm grip is necessary to accu-  
 racy.

Invariably keep the thumb forward  
 as the ball is delivered, leaving the  
 wrist muscles free to guide the ball  
 and the middle finger, sunk in the other  
 finger hole, to start it swiftly down  
 the alley. Spread out the three idle  
 fingers to help control the ball.

Bend over far enough just to touch  
 the boards when the arm hangs down  
 straight and set the ball in motion  
 without dropping it on the floor with a  
 bang.

With the left foot forward and the  
 body swung around, so that the right  
 is well back of the other, there is am-  
 ple room to swing the ball before it is  
 delivered.

For a fast delivery with a small ball  
 lift it up before you and aim for the  
 head pin, standing two steps back from  
 the end of the alley.

Take a quick step forward and swing  
 the ball down and back, bending over  
 well and bringing the left foot up to  
 the line just as the ball swings for-  
 ward, and the impetus of the body and  
 arm will give additional speed.

With a heavy ball stand close to the  
 line and make a long swing back, the  
 arm hanging straight, and thrust the  
 body forward just as the ball is deliv-  
 ered.

When the ball is lifted for the pre-  
 liminary step that is used for greater  
 speed, the left hand is used to balance  
 the ball and guide it in the swing, and  
 then helps to preserve the balance of  
 the body as you bend for the delivery.

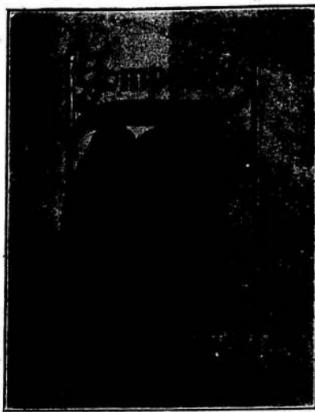
With a large ball played with only  
 one hand, rest the idle hand on the  
 left knee until it is needed to preserve  
 your balance for the swing of the ball,  
 but never on the hip.

These are triplets of mammoth value  
 from an expert bowler.

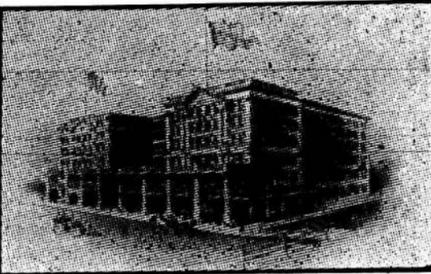
**How to Relieve Hoarseness.**

 and a pound of sugar; let it come to a

LOUIS LEISERSON—There was no second day Rosh Chodesh in the year 1882.

CASPER BOEHM—Two days after the Fast of Tebeth in the year 1871 fell on Thursday, January 5.

M. KURTZMAN—The word "Mizrach" refers relatively to the sun's course and means, therefore, rising east.

L. S. ISAACS—We cannot answer any questions referring to New Testament authorities.

WILLIAM S. FLEISCH—Yahrzeit for your mother, 14th day of Iyar, falls on Saturday, May 13; for your father, 14th day of Tammuz, Monday, June 27.

LOUIS A. MEYER—The "bosses" are not our American masters as you think, but the thickest and strongest parts, the projecting points of shields, Job, 15:26.

W. N. ASHER—It is customary to decorate the synagogue with flowers on Shabuot, it being considered as a Spring festival.

M. M. ISAACS—"Ishi" (my husband) Hos. 2:16, is the name which repentant and faithful Israel was encouraged to apply to Jehovah, in exclusion of Baali (my Lord), which was suggested to former Baal-worship, Ver. 17.

M. ROSENFELD—The word "Tabach" originally signified a "cook," and as butchering fell on the lot of the cook in Eastern countries, it gained the secondary sense "executions," and is applied to the body guard of the Kings of Egypt (Gen., xxxvii., 36.)

ROSE M.—The business of making clothes devolved upon women in a family (Prov. iii., 22). Little art was required in what we may term the tailoring department; the garments came forth for the most part ready made for the loom, so that the weavers supplanted the tailor. The references to sewing are therefore few. The term "Tafar" (Gen., iii., 7; Job, xvi., 15; Eccl., iii., 7; Ez. xiii., 18) was applied by the later Jews to mending rather than making clothes.

S. M. SAMUELS—The word "Deborah" signifies a bee. The first mention of the name occurs in Gen. 4:59, as the nurse of Rebecca whom she accompanied from Aram into Canaan. The name occurs again, when as a prophetess and wife of Lapidoth she judged the Israelites; and dwelt under a noted and perhaps solitary palm tree between Ramah and Bethel. Judges 4:4, 5.

RALPH A. MANNASS—The Hebrew word usually rendered "butter" denotes properly, sour, curdled milk, Gen. 18:8. Judg. 5:25; Job 20:17, a favorite beverage in the East of the present day.

Even in Prov. 30:33 we may render, "the pressing of milk bringeth forth cheese;" elsewhere the rendering "curd" or the "curdled milk" would be appropriate, and in Job 29:6; Psa. 55:21; Isa. 7:15, 22, "cream."

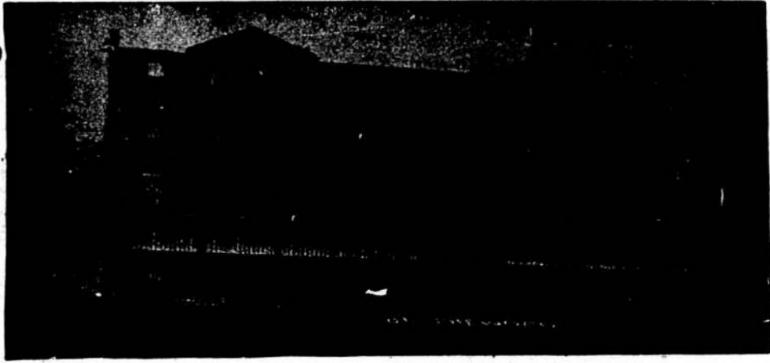

## An Intricacy Solved.

The Talmudical injunction (Pessahim 106, a), reflecting upon the Kiddush, or the sanctification of the Sabbath, by a glass of wine, with dignified toast and appropriate graces performed at night and repeated in the morning, in the case of which the sonorous adjective of Rabba or "enormous" has been significantly attributed to the daily process as to place it on a higher level, above its predecessor, the evening function. This exceptional course (taken by the sages of yore, to ignore the night Kiddush, that has a double mission in the synagogue and at home (ibid. 101, a), and to excel the morning sanctification, which act is a singular family affair, a private concern, and limited only to the boundaries of the individuals, this peculiarity has always embarrassed and puzzled me, and reluctantly I exclaimed the Talmudic Sp'kha mysajabra or its Latin equivalent of vice versa.

The end that our orthodox brethren are coming to will justify the sagacious meanings, strewn throughout the Rabbinic literature. The night sanctification is abandoned; the ceremony abolished and the service dispensed with in both synagogue and home.

Talmudically, the synagogal sanctification was caused by the presence of strangers, while the one at home has been fathered by the appetizing desire for the following feast for Sabbath's sake. Owing, however, to recent philanthropy, current humanity, modern psychology and novel sociology, an alien can't trespass the Temple ground; and the etiquette of late would not tolerate any after-Maaribh—supper, the gastronomic fish and the epicurean tsmes notwithstanding.

As for the morning Kiddush I cull from a Yiddish daily, where a provincial correspondent solicits the reading public to join the newly erected sanctuary, pointing as he does, among other progressive benefits, the Kiddush, that each worshipper can indulge in during Pentateuchal recital, a promise that will, most undoubtedly, be realized on the ground of the succeeding prophesy (Zephaniah iii, 13), "The remnant of Israel shall not do iniquity, nor speak lies; neither shall a deceitful tongue be found in their mouth." 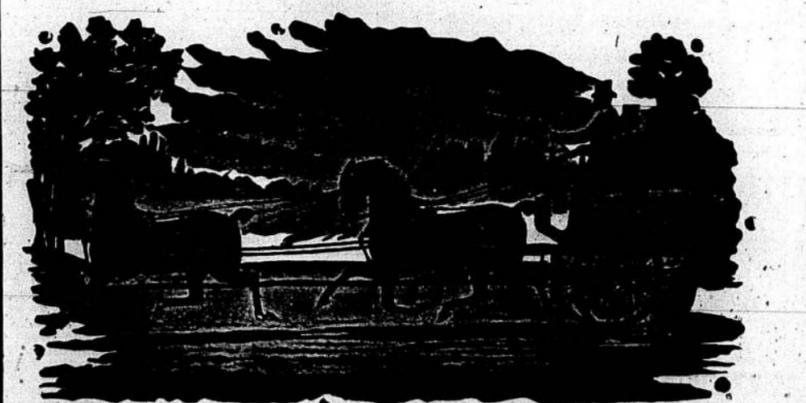
