The Influence of Jews in Recent English Literature.

By J. M. Bulloch (London).

A number of recent events widely different in character have by their cumulative effect served to remind us of the increasingly powerful position of the Jew in English life. The present year is the centenary of Lord Beaconsfield's birth, and three new biographies, together with the promised arrangement of his papers (which the death of Lord Rowton made more possible), take us back to one of the origins of modern Jewish influence. Again, the operations of the Alien Immigrant Commission, and the consequent legislation, even if it will not be so exclusive as some Englishmen would like, give an indication of the pressure which is being felt by the industrial classes from the constant invasion of the poor Jew, whom Russian ruthlessness scatters over the face of the globe. Nothing, however, has made the Englishman so conscious of the power of Israel as the Dreyfus agitation, which comes home all the more poignantly to us, viewed from the vantage ground of the Anglo-French agreement. Englishmen whole-heartedly and in the name of what they considered justice angrily impeached France for her treatment

of Dreyfus. His appearance at his trial helped to sober us; to-day he rouses no more emotion than a South Sea islander. Once again, the presence of the Jew as a factor in politics has been very evident during the whole South African affair, most notably in relation to the introduction of Chinese labor into the Transvaal. Last of all, the appearance of the elaborate *Jewish Encyclopedia* has helped to place in more or less

exegetic learning English Jews have made insignificant contributions. But there are signs that the young Jew belonging to Mr. Zangwill's generation is waking up. Perhaps this activity might be treated coincidentally with the year 1890, for it was only then that all restrictions against the Jew for every position in the British Empire, except that of the monarch, were removed. It has been pointed out that one of the causes which contributed to the deterioration of the Sephardic branch was due to the fact that they became prominent in the national art of boxing. both as actors and managers, may be taken as the continuation of the old Sephardic impulse. The fact is curiously interesting, because the modern Jew has taken practically no part in the athletic craze of to-day. Isaac Disraeli belonged to the Sephardic Jews. His more famous son, therefore, had fewer of those characteristics which mark the German Jew and which have made anti-Semitism so great a factor in mid-European politics. But the two Disraelis serve to illustrate the more notable contributions of the Jew to modern English literature, namely, research and romance, in some ways the twin of that strange mixture of materialism and idealism inherent in the race.

Disraeli the elder was at best only a sloppy kind of scholar. His learning was like a literary bric-a-brac shop; but he is interesting as the first of a new tradition in English Jewry. Far more weighty was the work of Francis Palgrave (father of the better known compiler of the "Golden Treasury of English Song") who helped to lay the foundations of minute research into our public records. Palgrave, who was old Disraeli's junior by twenty-two years, only assumed that fine old name. He was born a Cohen; and it is typical of the older spirit that both he and Disraeli ultimately turned from Israel.

The laboriousness involved in all scholarship seems peculiarly suited for the patient nature of the Jew, even if the financial result is not at all commensurate. But it is probably his Jewish origin which has made Mr. Sidney Lee so great a success in scholarly work, for the Kudos accruing to him from two such hackneyed subjects as a life of Shakespeare, and a biography of Queen Victoria, is quite remarkable, to say nothing of his splendid achievement, first as coadjutor, and finally as sole editor, of the magnificent *Dictionary of National Biography*. For many years, quite a little army of industrious scholars have been working in Shakespearian criticism, and piecing together the fragmentary details of Shakespeare's life, but scarcely one of these has been known except to scholars. Mr. Lee, by skillfully coordinating the results of their labor produced a book that became immediately popular. Similarly, in the case of his life of the late Queen, he managed to produce a book of unique interest, even without recourse to the enormous mass of MSS. which the future historian will have at his disposal. concrete form the aspirations and the outlook of the Hebrew.

I have no intention of traversing Semiticism as a practical force, for we have practically no anti-Semitic feeling in England; but the place of the Jew in the literature of to-day has some interesting sides. It is rather a curious fact, which the *Jewish Encyclopedia* itself admits, that the favorable condition of English Jews has not hitherto resulted in any remarkable display of Jewish talent in any of the arts or in literature. Even to a Rabbinic scholarship and

of to-day (and it was only in 1870 that a Jew could become a scholar or a fellow of an English university) has no desire to hide his origin. He is proud of his race in the fuller liberty accorded to it, and there is even at times the veriest suspicion of truculence.

The beginnings of the Jew as a producer of literature in England may be conveniently traced to Lord Beaconsfield's father, Isaac Disraeli. The point is all the more interesting as illustrating the German influence in Jewry as opposed to the old

tributed almost entirely to the arts in England, for, with the sole exception of Mr. Pinero, who has Portuguese blood in his veins, I can recall no Jew from the Peninsula who has made his mark in literature. On your side you have Mr. Belasco, a name which was once famous in the English prize ring, for Abraham Belasco and his brother Israel, were well-known pugilists in the early years of last century. Sport and the drama to this day are associated in the English mind, and the existence of so many Jews in the theatrical world,

lines, Mr. Israel Gollancz, who is Mr. Lee's junior by some five years, has attracted the attention of a wide public to his editions of the English classics. It was he who gave us the Temple Shakespeare, and edited the beginnings of the extensive library of classics which the Dents have built up round them. He is now building up for Mr. Moring a more select series of tasteful classics which have the attributes both of scholarship and of popularity. Few purely English scholars have created such a big market as Mr. Lee and Mr. Gollancz have done for wares that were once considered of but little marketable value.

Scholarship, however, knows little of the impulses of race and creed; that must be left either for controversial or imaginative literature. The modern Jew has deliberately chosen fiction, and, although his contribution is so far a mere drop in the bucket, it is so powerfully biased (and I am not using the word in any depreciating sense) as to stand by itself. The modern Jewish novelist has a point of view not to be found in the brilliant novels of Disraeli, which were Jewish by the mere accident of the author's birth. The Jewish novelists are now giving pictures of their own people. This has fascinated the Gentile writers. We all know how Daniel Deronda absorbed George Eliot; but it is not too much to say that no Christian, however sympathetic, can understand the com-

plex workings of the Jewish mind. One of the most striking examples in point was the publication in 1889 of "Reuben Sachs" by Miss Amy Levy. It was an extraordinarily intimate study of the pushful Jew, and gave great offence in certain quarters of Jewry. Miss Levy will always be remembered among our modern writers of short stories if only for the fact that the author almost immediately afterward committed suicide at the early age of eight-and-twenty.

No Jew, however, has created so much interest as Mr. Zangwill, whose novels are redolent of the race. Mr. Zangwill's early work might have been written by any humorist; but all his later books, beginning with "The Children of the Ghetto," in 1892, have dealt with different aspects of the Jew. Mr. Zangwill has closely identified himself with Zionism, and holds very distinct views with regard to the millions left by Hirsch. His brother, while displaying the literary instinct, has not identified himself so closely with Judaism. Their father settled in England in 1848, but the two sons are exclusively English by birth and education. Mr. Zangwill's greatest rival is Mr. Samuel Gordon, who is his junior by seven years. Mr. Gordon is the son of a Jewish Minister of Russian origin in the East End of London. He himself was born at Buk, in Germany, and came to England at the age of thirteen. He was educated at Cambridge, where his brother, Mr. Henry Gordon, made his mark in the Engineering Tripos, and where he himself took classical honors. Living among their own people, the Gordons take the keenest interest in all questions affecting Jewry, and Mr. Samuel Gordon's novels are instinct with high hopes for his race, even amidst the maze of many contrary circumstances. Mr. Gordon made his first appearance as a novelist with a small book called "A Handful of Exotics" in 1897; and he has gone on steadily increasing his repertoire ever since.

Several other Jews are busily engaged writing short stories, but none of them have made such a mark as to be included in any list of genuine literary men. One of the earlier Jewish novelists, Mr. Farjeon, was immensely industrious, but he never took a high place, and it was only by the accident of birth—he was in any sense Jewish. Similarly Frank Danby (Mrs. Frankau) has only played with fiction. The characteristically "Jewy" instinct for art came out more prominently in her elaborate work on eighteenth century prints, and her more recent book "John Raphael Smith," which is selling at over thirty guineas, although issued only the other year. Mrs. Frankau is the sister of Mrs. Aria, the well-known writer on ladies' fashions, and their brother is Mr. James Davis (Owen Hall) who has made quite a little fortune by writing the "books" of musical comedies, the best, perhaps, being "A Gaiety Girl" and "The Girl from Kay's."

The note which strikes one in these Jewish novels is one of real sadness, and I think it is more emphasized in the poetry, small in amount, which has been produced by the school. It certainly was the dominating feature of Miss Amy Levy's plaintive book of verse "A London Plane Tree," and, if possible,

it was much more marked in the verses of the late Mathilde Blinde, whose real name was Cohen.

The greatest energy of the Jew, in literature, however, is being expended in journalism—if the Fourth Estate can possibly be dignified as literature. We have several Jewish proprietors, notably Lord Burnham, the owner of the "Daily Telegraph," and Mrs. Beer, who for many years not only owned, but edited, two Sunday papers. The mere inventory of names of Jewish contributors to papers is far too long for me to put down here. Their influence, however, I think it has not been so obvious since it created England's very indiscreet pro-Dreyfus enthusiasm. Among the better known journalists are Mr. Lucian Wolf, of the "Daily Graphic," who has taken up a strong position on Zionism, and Mr. M. H. Spielmann, the editor of "The Magazine of Art."

So far the net result of these Jewish writers has been small, but in view of the short time they have been at work, their influence is remarkable.—*The Lamp.*

Ignorant Criticism.

Next to destructive criticism, that which is almost equally to be deplored is ignorant criticism.

The motives of the ignorant critic may entirely commendable, but not infrequently his defense of the truth is more harmful than the most virulent attacks of the enemy. Some of the greatest embarrassments that believers in divine revelation have met have come from the necessity of apologizing for the untenable positions taken by its ignorant, self appointed defenders. Retreat from such positions looks like surrender and is so proclaimed by the enemy, when, in reality, the positions abandoned should never have been occupied at all.

Zeal without knowledge has, from time to time, proclaimed its own unwarranted assumptions as essential to the truth of divine revelation, and when the very absurdity of these has necessitated their abandonment, the enemies of the Bible have claimed a victory.

Intelligent faith heeds the well known admonition to prove all things and hold fast to that which is good; presumptuous ignorance accepts all things, and is, consequently, subject to disastrous and ignominious retreat from untenable positions.

The Quarrel Between Disraeli and O'Connell.

The story of the quarrel O'Connell had with Benjamin Disraeli, which for vitriolic abuse can scarcely be surpassed in great English electioneering may be of interest to our readers. When Disraeli, the great English Jewish statesman, famed as Lord Beaconsfield, and as Premier of England, was contesting Taunton in 1835 he described O'Connell as an incendiary and a traitor, and denounced the Whigs for "having grasped his bloody hand." This was a reference to the fatal duel O'Connell fought with D'Esterre, and the fact that he had assisted the government in passing the Reform Bill. Disraeli's was a bitter attack, and it drew from O'Connell a savage and vituperative reply.

O'Connell, speaking at a meeting of the Dublin Franchise Association at the Corn Exchange, on Saturday, May 2d, having described his former relations with Disraeli, thus proceeded:

"At Taunton this miscreant had the audacity to style me an incendiary! Why, I was a greater incendiary in 1831 than I am at present, if I ever were one; and if I am, he is doubly so for having employed me. Then he calls me a traitor. My answer to that is, he is a liar. He is a liar in action and in words. His life is a living lie. He is a disgrace to his species. What taste of society must that be that could tolerate such a creature, having the audacity to come forward with one set of principles at one time, and obtain political assistance by reason of those principles, and at another to profess diametrically the reverse? His life, I say, again, is a living lie. He is the most degraded of his species and

kind, and England is degraded in tolerating, or having upon the face of her society a miscreant of his abominable, foul, and atrocious nature. My language is harsh, and I owe an apology for it; but I will tell you why. I owe that apology; it is for this reason, that if there be harsher terms in the British language I should use them because it is the harshest of all terms that would be descriptive of a wretch of his species.

"He possesses the qualities of an impenitent thief who died upon the cross, whose name, I verily believe, must have been Disraeli. For aught I know, the present Disraeli is descended from him, and with the impression that he is, I now forgive the heir-at-law of the blasphemous thief who died upon the cross."

Disraeli, in his reply, made allusion to the fact that subscriptions towards "the O'Connell tribute," which amounted to several thousand pounds, had been collected at Roman Catholic churches. The reply took the form of an open letter:

"Mr. O'Connell," it begins, "although you long have placed yourself out of the pale of civilization, still I am one who will not be insulted even by a yahoo without chastising it." The letter thus concludes:

"I admire your scurrilous allusion to my origin. It is clear that the 'hereditary bondsman' has already forgotten the clank of his fet-

ters. I know the tactics of your church—it clamors for toleration, and it labors for supremacy. * * * My pecuniary resources were limited. I am not one of those public beggars that we see swarming with their obtrusive boxes in the chapels of your creed; nor am I in possession of a princely revenue arising from a starving race of fanatical slaves. Nevertheless I have a deep conviction that the hour is at hand when I shall be more successful, and take my place in that proud assembly of which Mr. O'Connell avows his wish to be no longer a member. I expect to be a representative of the people before the Union. We shall meet at Philippi; and rest assured that, confident in a good cause, and in some energies which have not been altogether unimproved, I will seize the first opportunity of inflicting upon you a castigation which will make you at the same time remember and repent the insults you have lavished upon

BENJAMIN DISRAELI."

Max Nordau.

Among the prominent Jews mentioned as possible successors to Dr. Herzl, is Max Nordau. Dr. Nordau is one of the ablest scholars and writers included in the class of Jews advocating the Zionist movement. He is best known to the world at large by his decidedly original ideas in psycho-

physiological science, which he published under the title "Degeneration." The book provoked much criticism at the time it appeared, for the author presented in it a vast amount of evidence going to show that all modern tendencies in art, letters and life are proofs of physical, mental and moral degeneracy.

Since then Dr. Nordau has been closely identified with the plan of securing Jerusalem for the Jews. Like Dr. Herzl, he wants to realize the old dream of a national restoration. Like Herzl, he is a practical man of affairs, as well as a dreamer. Both men were born in Buda-Pesth, and both suffered oppression from race prejudice. Their enthusiasm in behalf of "the regeneration of Israel" is doubtless due to the prejudice to which they have been subjected.

In Europe the Zionist organization has a following of more than a quarter of a million Hebrews, a large part of whom are found in Russia, and those countries most hostile to the Jew. In America the following is small—the idea being that here the race has every privilege it could rightly ask, and in the free competition of trade it has a decided advantage over anything it could have in a country which is outside the main line of traffic, as Palestine is at the present time. Still the old sentiment lingers in many Jewish hearts, for the Jew is decidedly conservative in spite of his modernity. These idealists seek the

Zion to which Moses led their fathers. Even if only a remnant can be prevailed upon to settle again in the promised land they are eager to secure the right and establish a colony.

Nordau has the zeal required to put the plan into execution, and he has the confidence of the people. Whether he or any of his race will have diplomacy and strength enough to overcome the political obstacles that surround the taking of Jerusalem at present looks very uncertain.—Chicago Chronicle.

BOROUGH OF MANHATTAN.

Federation of American Zionists.

It is a mistake to think that the strength of the Zionist movement can be measured by the number of members formally joining the organization. The Federation of American Zionists holds an annual Shekel Day, and those who believe in the movement and yet cannot see their way to joining an organization, signify by their enrollment as shekel payers, their interest in the cause.

From year to year the Shekel Day has come, and the reports always show an increase. This year a Shekel Day will be held on Sunday, Oct. 16, and already the societies are preparing for their work. The main office will send out Shekel books, in which will be recorded the names and addresses of all those who pay the shekel tax. A careful system of accounting for these books has been installed, and the societies will be required to be very accurate in accounting for the books. The Orthodox Congregations will be approached this year, and a systematic effort will be made to secure the enrollment of all those Orthodox Jews who are averse to joining mixed organizations. Applications for the shekel books should be made to the secretary of the Federation of American Zionists, 326 Broadway, New York.

To Honor Hebrew Veterans.

One of the most interesting ceremonies of the coming Labor Day will be the laying of the cornerstone of a monument to be erected by the Hebrew Union Veteran Association of this city, in memory of their comrades, who fell during the Civil War of 1861-65. In obtaining the funds for this monument, the association is assisted by a citizens' auxiliary committee, of which Nathan Straus is chairman, and School Commissioner Jacob W. Mack, secretary. Samuel M. Schafer is the treasurer of this committee.

The monument will be erected at Salem Fields Cemetery, Cypress Hills, on a plot of ground donated by the congregation of Temple Emanu-El, Fifth avenue and Forty-third street, Manhattan, of which James Seligman is president.

General Daniel E. Sickles, General Horatio C. King and other speakers will be present at the laying of the cornerstone.

The Hebrew Union Veteran Association was organized on March 15, 1896, the late Civil Justice Joseph H. Stinet being elected colonel. After Colonel Stiner's death Isaac Eckstein was elected colonel and now fills that office. Since its organization 210 veterans of the Hebrew faith have been enrolled on its books, and it has lost forty-three comrades by death.

On every Friday evening preceding Decoration Day, the association has held memorial services at the Temple Emanu-El and among the more prominent speakers on such occasions have been President Roosevelt, General N. M. Curtis, General Daniel Butterfield, General James O'Brien, Simon Wolf, General Stewart L. Woodford, General John Palmer, General Thomas L. James, Edward Lauterbach, Joseph A. Goulden and many others.

The monument to be erected will be 52 feet in height, and of handsome design. On top of the shaft there will be placed a handsome bronze spread eagle, measuring over six feet from tip to tip. The sides of the shaft will bear suitable inscriptions.

Mr. Henry Bloomfield, who died at Denver, Col., was buried on Monday, Aug. 22, 1904, at the B'hal Jeshurum Cemetery. Rev. F. Light officiated.

Mrs. Anna Reif, at the age of seventy, died at her residence, 566 West 171st street, and was interred in Washington Cemetery, Monday, Aug. 29. Rabbi Nathan Wolf, of Hoboken, officiated. The funeral was largely attended. Five sons and two daughters mourn her loss.

Joseph Wolf, attorney at law, after a lingering illness, died at the early age of twenty-five years. A widowed mother, brothers and sisters deeply lament their irreparable loss. His funeral, which took place from his mother's residence, 121 West 148th street, on Tuesday, Aug. 28, at 10 a. m., was very largely attended by many dear relatives and innumerable friends. The interment was made in Machpelah Cemetery. The Rev. Bernard East officiated in the house and at the grave.

Lectures for Jewish Young Men.

The new Era Club, a social and educational organization for Jewish young men on the East Side, is giving lectures on Jewish topics every Friday evening.

A Temple Dedication.

The congregation worshipping in the well-known Eighty-sixth Street Synagogue has been making strenuous efforts to improve. Success has crowned the work of the earnest workers in that direction. On Monday, September 5, at 3 p. m. the beautiful new building will be dedicated with elaborate and appropriate ceremonies. Dr. D. Davidson has enlisted the co-operation of Dr. S. Schechter, who will grace the occasion with his presence. Many other distinguished visitors and guests are expected to be present.

Dedication.

On Sunday, Aug. 28, 1904, the Deborah Benevolent Association had their new grounds at Mt. Zion Cemetery dedicated. Rev. F. Light officiated.

Cemetery Gate Dedicated.

The dedication of the gate and rail surrounding the burial plot of the United States Grand Lodge, Order of B'rith Abraham, in New Union Fields Cemetery, Evergreens, L. I., yesterday afternoon, was attended by several thousand persons from Manhattan and Brooklyn, including a number of rabbis. Services were conducted under the auspices of the lodge. Congressman Goldfogle, of Manhattan, made an address and turned the key of the gate over to Samuel Dorf, the Grand Master of the order.

Memorial Services.

According to the annual custom of Cremieux Benevolent Society, services were held at the three cemeteries where the lodge holds grounds, Cypress Hill, New Union Fields and Mr. Neboh. Rabbi Samuel Greenfield delivered the orations at each of these places Sunday, Aug. 28.

North American Relief Society.

An appeal for funds in support of its work has been sent out by the North American Relief Society for the Indigent Jews of Jerusalem, Palestine. This organization has been in existence sixty years. Contributions and donations are to be sent to the president, H. Kohn, No. 3 West Thirty-ninth street, or to the honorary secretary, Sigmund T. Meyer, at No. 149 Broadway.

New Departures Announced for the Coming Year.

The Register for 1904-1905, issued by the Jewish Theological Seminary of America, shows how many-sided the activities of the seminary have become. There is a four-year course of study for the rabbinical degree; lectures, one series for the public, and a special series for the members of the senior class, on the management of the Jewish philanthropic and educational institutions of this city, and a library, with 15,000 printed volumes and 750 MSS., for loan to outsiders, as well as for use in the building, No. 531 West Twenty-third street.

A course leading to the degree of doctor of divinity is a new feature for the coming year. Another new departure is a preparatory department; a three-years' course to enable students, who are attending a college or university in New York City to prepare themselves for entrance to the seminary.

Rabbi Charles I. Hoffman.

Extensive alterations are under way at the Educational Alliance, East Broadway and Jefferson street. The stage in the auditorium is being made larger, and dramatic classes are being organized. One of the plays to be presented during the coming winter is "The Tempest."

Rabbi Charles I. Hoffman, editor of the Jewish Exponent, of Philadelphia, has accepted a call from the recently organized United Hebrew Congregation of Indianapolis, Ind., and will enter upon his ministry this month. Mr. Hoffman is a graduate of the University of Pennsylvania, and was for a number of years a member of the Philadelphia bar. About four years ago he gave up the law, and devoted himself to rabbinical studies, going to Cambridge, Eng., where he studied under Professor Schechter, and subsequently accompanying him to this country.

To Enlarge New Beth Israel Hospital.

Plans have been filed with Building Superintendent Hopper for the enlargement of the new Beth Israel Hospital, at Jefferson and Cherry streets, by the remodeling of a six story tenement house at the southwest corner of Jefferson and Monroe streets. It will be connected by bridges with the hospital building and will be utilized as living quarters for the nurses.

Mutual Benefit and Burial Society.

This is one of the oldest Jewish benevolent societies in the City of New York, and for the annual dues of \$7 its members receive a weekly sick benefit of \$7. In case of distress additional relief to the amount of \$200 furnishes burial and funeral expenses, and pays a death benefit to the family of the deceased of \$250. It has \$16,000 in invested funds and will receive members under thirty-five years of age without an initiation fee. In the Jewish World.

The son of Rabbi Isaac M. Wise, Jonah B., has been elected to the vacant pulpit in Chattanooga, Tenn.

Rabbi Jacob Mielzner has been called to occupy the position of rabbi in Congregation Ahavas Chesed, Cincinnati, Ohio, which body is constructing a new temple building.

A late dispatch brings the news that Rabbi Lippman Mayer, rabbi emeritus of the Pittsburgh congregation, died suddenly this week at the age of sixty-two.

The new synagogue of the Congregation of the Sons of Israel, at Camden, Pa., was dedicated yesterday afternoon. Among the speakers were Rabbis Levinthal, Elchler and Grossman, of Philadelphia, and Mayor Nowrey, of Camden.

Congregation Oheb Shalom, of York, Pa., dedicated their synagogue recently with elaborate ceremonies. Rev. B. C. Ehrenreich, of Philadelphia, delivered the dedicatory oration.

Fort Worth, Texas, has bestirred itself and the Jewish community extended a call to Rabbi Joseph Jasin, a graduate of this year's class at the Hebrew Union College.

A number of orthodox congregations in Philadelphia agreed to present Rabbi Bernhard Levinthal with a summer home at Woodbine. The transfer of the gift was made in a manner suitable to the occasion.

Temple Oheb Shalom, of Newark, N. J., has acquired the services of the well-known cantor, Max Heltere, formerly of New York and Brooklyn.

Rabbi S. Margolis, formerly of Brooklyn, N. Y., has been elected rabbi of Anshe Emes in Cleveland, Ohio.

The Cologne Gazette learns that on Aug. 12 the Russian Ministers and heads of departments discussed the repeal of a number of erroneous interpretations of the laws affecting the Jews. The erroneous verdicts of the courts had received the force of law by decrees of the Senate or the Council of the Empire.

The finding of the Ministerial conference was submitted to the Czar, who, it is understood, assented to the resolution. The reconstituted statutes, which will be promulgated soon, deal chiefly with those Jews already in a so-called privileged position. The large mass of the Jewish working classes, who most of all are the subjects of oppression, receive no alleviation of their lot.

It is said that in well informed quarters in St. Petersburg the new ordinances are commented upon in a skeptical spirit upon the ground that a number of inaccuracies have been allowed to creep in, which will afford an opportunity for capricious and discretionary interpretations of the revised statutes at the hands of the provincial authorities.

At a recent meeting of those seeking to organize a Jewish congregation in the southern section of Philadelphia, Pa., plans were formulated for the holding of services at an early date. The meeting was held at the residence of William Weintraub, 304 South street, Rev. Dr. Krauskopf presided.

Rev. George Zepin, National Director of the synagogue extension movement, explained what had thus far been done, and after some discussion a permanent organization was effected, with the following temporary officers: William Weintraub, temporary chairman; Joseph Klein, temporary secretary.

It was decided that the name of the new congregation be "The Southern Reformed Congregation," that the object be the upbuilding of a congregation, Hebrew school and Sabbath school, where the ceremonies and instruction be along the lines of Jewish reform.

The society was also addressed by a gentleman from New York who spoke on "the importance of the use of good English."

The boys' Natural History Club is also progressing nicely. The children of the sewing and embroidery classes, kindergarten, etc., were recently engaged in preparing an exhibit for the World's Fair at St. Louis. THE ESTABLISHMENT OF A HEBREW CENTRE.

It does not require a penetrating eye, nor the mind of a sagacious observer to mark the striking difference between the immigrant of to-day and that of twenty-five or thirty years ago.

What was true of the people of all other nationalities was also true of our Jewish immigrants. No wonder, therefore, that Judaism in this country was in such a degrading condition, and stands even now on a lower plane than in any other country. You find here horse-shoers from the old country officiating in our synagogues, blacksmiths teaching our young, and cobblers performing our matrimonial ceremonies. Our brethren across the Atlantic laugh at us, they ridicule our chaotic Judaism, and condemn our spiritual leaders.

But this condition of Jewish affairs is not going to last long.

Like a winding stream which flows smoothly on level sand, whose water becomes purer and purer as it wanders through a greater distance, so the

Nissim Behar and His Critics.

Editor Hebrew Standard:

Sir—If your correspondent, "Moshe ben Avigdor," really knew the man whom he calls "Saul Among the Prophets," he would save himself the heartburn, which gave rise to his uncalled-for letter.

His apprehensions about Nissim Behar's "playing with strange fire, and about a tremendous catastrophe" is so baseless as to amuse those who know better. It is a pity, however, that "Moshe ben Avigdor" is not the only one in this country that is (perhaps unconsciously) seeking to reward Nissim Behar evil for good.

This attitude of Behar's critics is, of course, not at all surprising, in view of the following from the Wall Street Financier: "It is a striking trait of a race, perhaps the oldest ethnologically of which we have fair modern knowledge, and certainly the one slowest to lose its strong individuality, that in spite of extraordinarily high average of intelligence, it has usually failed in the one element of co-operation."

Any student of Jewish history knows well that for the want of this one element of co-operation of peace—Jerusalem fell, and for the want of this same element, the Jews' deep aspiration after the national possession of the Holy Land can never be realized.

This is a sad statement indeed, but our history to the present day proves it uncontrovertible.

The only remedy thinkable is, that our people, especially the leaders, must have more of true fear of God.

If "Moshe ben Avigdor" and all those who like him view Mr. Behar as a foreigner with no right to work for the Jewish cause in this land of the free, if they were not so full of themselves and would allow just a spark of godly fear to penetrate through their breasts, they would at once see, that their attitude towards Nissim Behar has been stimulated by the green-eyed monster, envy. They would see that Nissim Behar, unlike themselves, is not doing all this for the sake of "carving out a great name (on paper) for himself in American Israel," but that Nissim Behar's ulterior aim is nothing lower than to serve God and humanity.

They would furthermore see that the Jewish problem is a world problem, and that the Jewish problem could never be solved unless all Jews the world over will co-operate with a view of serving the public good regardless of petty, personal likes or dislikes.

Immeasurably happier and wiser would these critics of Behar be if they only had just a spark of true fear of God.

stream of immigration is clearing and purifying itself as time advances. A new class of people have recently begun to land on our shores,—an intelligent, a patriotic class of people who are loyal to their faith, and faithful to their nation. It is the flower of the Russian Jewish youth—the young Hebrew Maskilim. The public libraries, the institutions of learning, the literary societies and the debating clubs are full of them. A few years only pass on their coming here and they become the real genuine American Hebrews, full of love and enthusiasm for their nation and its ancient traditions, and at the same time respect and honor their newly adopted country. That class is increasing daily. A few more years, and its influence will be greater, its characteristics will become more distinct and visible and its impressions on American Jewry will be more recognizable.

It is the cause of that class of young men that I am now pleading. You Jews in this city in whose hearts a glowing spot of true Judaism is still left, you whose thirst for the study of the ancient and modern Hebrew literature is not yet quenched, you who are always ready to support and maintain any institution for Jewish learning, help in establishing a great Hebrew centre in the very heart of the East Side.

I have read recently in the Anglo-Jewish papers that the society, "M'phitzay Sphath Eber,"—whose object is to promote the knowledge of the Hebrew language and literature among our young—has undertaken to establish a Hebrew library and reading-room on the East Side. Such an institution is of the greatest importance on the East Side. It would not be merely a plain library for reading books, but it will be a great Hebrew centre, dedicated exclusively to Hebrew and for those who are imbued with the Hebrew spirit. It will be a place, which will keep together those young men whose thoughts and ideas exclude them from many societies on the East Side. It is therefore the duty of the Jews in this city to encourage the above society in its work, and to give it their moral and financial support, in order that it shall be able to carry out its plan admirably and speedily.

Transmitted Responsibility

ולא אחכם לברכם כי אם אשר שנו פה

"And not with you alone do I make this covenant and this curse But even with him who is standing with us to-day before the Lord our God, and with him who is not here with us to-day."—Deuteronomy xlix, 18, 14.

The entire people of Israel was being addressed. All stood before God to receive the divine message leading to conduct pure and just. No discrimination was made between those who were fully matured and those of feeble mind, between the strong and the weak, between the nobleman and him of lowly descent. All were classed together in a mass of persons who were chosen to accept the responsibility of the Law.

As a corollary to this proposition of the universal reception of the light and truth of God comes the remarkable statement above quoted. "Not only with you do I make this covenant but even with him who is not here with us to-day."

How important this statement is only he can realize who sees the law of heredity at work on every hand around him. In the physical world, traits and characteristics are passed over from one generation to the next. We often feel inclined to rebel against the inexorable operations which cannot be checked by us if we would. Little as we fancy having ourselves modified by conditions of which we have not the making, even so are we tempted to complain against others being burdened by our sins of omission or commission. But it is a law in force and affects our lives as a threat against the doer of evil. It is calculated to make the latter pause and reflect before he yields to temptation. If I do wrong, I will surely hurt myself in some way, and just as inevitably will the punishment also be visited upon others who may be perfectly innocent, but who will yet suffer because of my connection with them. Perhaps for their sake I may often be strengthened to resist the allurements of sin.

In the moral and spiritual world it would seem as if the same process of continuity connects individuals. We are accustomed to see the development of this thought in the world about us and we become accustomed to the play of forces that must occasionally daunt the worker of unrighteousness. But one is hardly prepared even in the full knowledge of this to come across the verdict rendered in our text concerning the passing of responsibilities from the living to the unborn, from the generation that exists to that which is to be. And yet so it is. The Jew can bear witness to the truth of this. How he is born to duties and responsibilities, how the blessing and the curse have been transmitted to him from generation to generation, only the historian of the Jew has been able to trace accurately and definitely.

As Jews, then, we must accept both the obligation and the penalty, whether we would or no. Ours is the blessing if we obey, just as the curse is also ours if we are disobedient. Our fathers received the law for their benefit and our own. The descendants of the generation of Moses are as much in duty bound to keep the word of God as they who stood before the illuminated mount and heard the the awful reverberations of the spoken commandments between the clefts of Sinai.

And how painfully has the history of the Jew borne this out throughout the centuries past! Every succeeding heir to the fortunes of his father had fall to his lot the career of a pariah, of an outcast, as the victim of persecution and the object of fanatic hatred. Every child of Jewish parentage has been forcibly made to feel his bonds that linked him with the trials and ill-fortunes of those that preceded him. So the truth was manifest. We are children of responsibility even to this day. To our certain knowledge this will continue for many generations to come. May we then accept our burdens with a sense that our lives are rendered fuller and more illuminated with the word of God that passes on from father to son unsullied and inviolate.

Maurice B. Blumenthal as Sheriff's Counsel.

We are pleased to announce the appointment of Maurice B. Blumenthal as counsel to the Sheriff of New York County. The office is a comparatively new one and has heretofore been occupied by W. Bourke Cockran, General Benjamin F. Tracy, ex-Congressman John Adams and James W. Gerard, the last of whom Mr. Blumenthal now succeeds.

Mr. Blumenthal is a familiar figure in our city, and despite his youth occupies a leading position at the bar of this State. He is prominently connected with many Jewish benevolent institutions, among which are the Independent Order Free Sons of Israel, Progress Club, Montefiore Home, Hebrew Infants Asylum, Temple Rodeph Sholom, Hebrew Orphan Asylum, Young Men's Hebrew Association, Lebanon Hospital, Young Folks' League of the Cares Sewing Circle and the Jewish Publication Society.

Although only thirty-three years of age, Mr. Blumenthal has occupied the positions of Assistant District Attorney of this County and Deputy Attorney General of the State of New York, which positions he filled with credit and ability. He retired from the latter position early last winter, as the duties thereof conflicted with his private law practice. He is now practicing law at No. 35 Nassau Street, in association with his brother Daniel W. Blumenthal.

Mr. Blumenthal is the son of Benjamin Blumenthal, President of the Congregation Rodeph Sholom of this city, and the grandson of the late Rev. Simon Blumenthal, the first minister of the congregation. Mr. Blumenthal is a life long Democrat, and a personal friend of Charles F. Murphy, the leader of Tammany Hall, and about ten years ago organized the Tammany Hall Speakers' Bureau upon a system which has since been in vogue, and as Chairman of the Tammany Hall Speakers' Committee earned the plaudits of his party.

The duties of his new office will not interfere with Mr. Blumenthal's private practice, which consists chiefly of mercantile and real estate matters, and in which he has been engaged since 1891.

It is a miracle almost for a rich man not to be overrun with vice, having such strong inclinations to it from within, and such inducements and opportunities to it from without. To be rich in money and rich in good works, too, rarely occur.

BY THE SENTINEL.

Extending the Intrenchment.

Now comes the question as to the use to which our Settlement is to be put during the evenings. We are strongly impressed with the necessity of enlivening the dull routine of the lives of our young people. We know that in a great many settlements, many useful arts, and in some of them, some branches of "higher education" are also taught, but we do not see the necessity for this. Stenography and typewriting, dressmaking and all other such-like means by which our young people can better their material condition, are already subjects that can be learned in institutions specially established for that purpose. It may be true that the course of study would, in some instances, have to be paid for, but we do not see any reason for increasing the numerous roads to "higher education" that are already at the disposal of everyone who chooses to seek them.

A settlement to be a success as a settlement, should devote itself to social matters, and a Jewish settlement should devote itself to such social matters for Jews, as are not already taken care of in the public schools, or in the institutions that are established for the purpose of teaching the various arts.

Our Settlement must be a well, from which every Jew may draw the clear water of happiness that springs from Faith, and Faith that springs from happiness.

We would indulge every aspirant who feels that his life has been touched with the fire of eloquence, and would make it one of our chief attractions to produce small plays, or to get up debates, etc., etc.

So far as classes for instruction are concerned, we do not see that there is any reason why we should not duplicate that which has proved to be so powerful an attraction in the settlements of "The Enemy." If it is possible to gather Jewish children in Christian settlements on Sunday, in order that they may sing Christian hymns and learn the history of the Child Christ, we do not see why it should be impossible to gather these same children into a Jewish settlement and teach them to sing Jewish hymns and to learn about the infant Moses or the child Samuel. The chief difficulty that we foresee, will be for us to be able to induce a sufficient number of Jewish ladies to give up their time to this work, so that they may become the friends of the children. In the Christian settlements this is done to a remarkable extent. Educated, refined ladies bring their sweetest smiles and most endearing manners to the children of the Ghetto, and between fondling them in their arms, making much of them, treating them to all sorts of goodies, and gaining their confidence in every way, they induce them to believe that it is through the religion of these ladies, that they are so different to the women of their own faith, with whom they usually come in contact.

Everyone conversant with the "Trail of the Serpent," will confirm our opin-

ion, that it is in the volunteer worker who devotes herself to this work, that the greatest "success," that is to say, our greatest "danger" lies. There have been many attempts to establish quasi-Jewish settlements, and most of them have been failures, because either the ladies were so patronizing in their manner, or the "Guides" were such mere machines in their work, that the interest that was evoked at the outset, very soon wore itself out, or else the whole of the plan partook so much of a charity air that it palled upon those that it sought to influence.

Add to our suggestions therefore: g) A resort for Jewish ladies.

There is probably no member of the New York Bar whose career has been of so busy a character as that of Alexander Blumenstiel. "I Am a Reformer."

It is amusing, if it is not shocking, to observe how easily questions of the most vital import are dismissed with a simple sentence patterned after the notable utterance of David B. Hill as to his political affiliations.

"I am a Reformer" covers a multitude of sins. When one gives utterance to it, prepare for a complete denial of the binding force of all that many very serious and sincere souls regard as most sacred. Prudence and logical caution are thrown to the winds. These few words spell anarchy in religious thought for many. It guarantees immunity against punishment for committed acts of violence against the traditional observance of Jews.

"I am a Reformer," means playing fast and loose with tradition. It permits freedom and even license in passing upon the value of religious speculation and forms. At least, so it is thought by those who use this cry to shield them from the responsibility of leading a life of restraint such as our forefathers were wont to conduct in private as well as in public.

"I am a Reformer," is responsible for much abuse and still more misunderstanding. It forms an excuse for every neglect, and condones for every breach in religion. It contains a hidden pardon for all kinds of blunders and mistakes made against the dictates of conscience and in opposition to the loyalty demanded by faith to the religion of one's fathers.

"I am a Reformer," stands for everything that makes for inexcusable errors in thought and conduct, and eventually leads to positive misleading of many simple souls from the path that leads to happiness.

Gambling as a Habit.

The speculating tendencies of the average American are very pronounced. The desire to make a wager on anything and everything is so marked that it may be pronounced a distinctive feature of our life. It originated probably in the reckless character of the earlier inhabitants who were wont to indulge in pastimes provocative of gambling as the only recreation open to men who were accustomed to risk life and everything on the accidents of fortune.

Among the so-called higher classes of our civilized society the same instinct prevails, though for a somewhat different reason. In the overmastering desire to experience excitement what could be found more nerve-racking for the leisure classes than gambling of every description.

So for one reason or another the fever of speculation in some form or other is fostered to such an extent that it merits comment as a peculiar phenomenon almost universal in our life.

In its most vicious form it is degrading and highly demoralizing. To it has been traced the early ruin of many a young man with bright prospects. On account of it have so many crimes been committed that, at its worst, we are ashamed to confess it as our habit.

Yet it is almost a habit with us, growing and expanding in every circle until we can discover it among the supposedly staid fathers of families, among the respectable matrons of

households, and even in the ranks of conservative business men.

Nor may we Jews boast of being free from the tainted view of the world which this habit inculcates. Our own physical requirements are such as to call for some force bringing the nerves into play, and we are by no means niggardly in satisfying the craving for excitement demanded by our nervous constitution.

In addition to this, we are apt pupils of the people by whom we are surrounded. We soon acquire the same taste for luxuries and contract the same habits as our neighbors. And this is well proven in the record that our co-religionists have made in the various sports and indulgence in games of chance readily learned from those around them.

As a habit, it need hardly be said, the pastimes provided for the gamster and sport are of a nature calculated to lower the standard of morality and to shake the foundations upon which the structure of family life has been reared, to say nothing of the utter disregard of one's own interests in staking oftentimes more than one can afford.

We must, therefore, deprecate the situation. We occasionally must feel alarmed at the steady progress this habit has made and the terrible inroads upon the former ideal family life which are chargeable to it. We hope that this very dubious mark of advancement in the forward direction may soon disappear from our midst and leave the Jewish household as pure as once it was according to our boast.

How the Mussel Travels.

Of all the absurd forms of locomotion practiced by the creatures of the deep the most preposterous is that of the mussel. Squids will startle you by darting backward, crabs hustle off sideways at a lively gait, but nothing save the dull brain of "some kind of clam critter," pondering over the transportation problem in those remote epochs when time was no object, could have evolved so slow and cumbersome a method.

You may often see mussels climb up the pile of a wharf toward the high water mark. Notice the black threads attached to the clam. They do the business. The mussel shoots out a spray of gelatinous stuff in the direction he wants to go and this hardens into those black threads. He lets go the old ones and climbs up by the new. You can trace his progress up the pile by the bunches of old threads, which he leaves behind at intervals. It has never been figured out whether he could go a mile in less than a year, but it would be safe to back the mussel in the animals' "slow race."—Country Life in America.

JAPANESE JOTTINGS.

The ingenuity of the farming in Japan may be inferred from the fact that the 45,000,000 inhabitants live almost entirely on the productions of a cultivated area about one-third the size of Illinois.

The family of a dead Japanese soldier gets, roughly speaking, one-third the pay of his rank. This would give the widow of a private \$1.25 a month; of a first lieutenant, \$6.25; of a captain, \$8.33, and to the widow of a colonel, \$29 a month.

The Japanese Red Cross society is able to supply through its various branches 3,000 female nurses and 2,000 male nurses. Female nurses are not sent to the front, but undertake duty in Japan in the military and Red Cross hospitals in various parts of the country.

Correspondence Continued.

Where There is a Will There is a Way.

There is a special supplication inserted in the liturgy to be used on Saturdays preceding the day or days of the new moon.

As the prayer books with English translations do not contain any vernacular rendition of the subject under consideration, it behooves me to supply this deficiency.

May it please you, O Lord! our God and our father's God, to renew the approaching month for us for good and for blessing, and may you grant us long life, life of peace, life of goodness, life of blessing, life of maintenance, life of sustenance, life that flourishes on fear of heaven and dread of sin, life that lacks contempt and scorn, life of wealth and esteem, life inspiring the love of the law and fear of heaven, life that will bring about a fulfillment of our good will, for the sake of the Rabbi's petition. Amen, Selah!

The last clause of the quoted entreaty, pertaining to the rabbi, refers to the latter as the originator thereof.

As a matter of fact, the Talmud (Berachath 16, b.), in the list of numerous petitioners and among a multitude of prayers, contains the one in question, attributed to a servant named Rav as the genuine author. The "life" mentioned eleven times intimates eleven beginnings of months on the forerunning Saturdays when this entreaty is uttered.

The month of Tishre making an exception of the general rule, on account of its absorption by the New Year.

Now, the first of the series of "life" is qualified by "long," adjectively, differentiating from the ten subsequent ones, so as to establish the identity of Rav, known as Abba the Long (Hulin 137, b).

The latter, however, extended hospitality to his collaborer in intellectual pursuits by inserting in the second paragraph "life of peace," the Hebrew of the last word being "Shalom," similar to "Samuel."

The third, "life of goodness," reflects upon Adam, whom God beheld and declared to have been very good (Genesis 1, 31).

The fourth, "life of blessing," alludes to Noah, whom God blessed with fruitfulness and replenishment of the earth (Ibid. ix, 1).

The fifth, "life of maintenance," suggests Abraham, who was abundantly provided during the famine (Ibid. xii, 16).

The sixth, "life of sustenance," introduces Isaac, upon whom favors were bestowed during general destitution (Ibid. xxvi, 3).

The seventh, "life that flourishes on fear of heaven and dread of sin," refers to Jacob, who dreaded heaven (Ibid. xxviii, 17), and feared sin (Sanhedrin 98, b).

By a comparison of texts the observer will find the phrase "fear of heaven" a liturgical interpretation, failing to have its double inserted in the Talmudical source.

I, nevertheless, maintain the correctness of this addition, inasmuch as it computes the exact amount of the Patriarchal qualities.

As for the nature of this sentence, differing in its construction from the previous portions, it appears to have been a deduction from the following injunction:

All things are swayed by God upon His throne,
The fear of heav'n depends on man alone.

(Dr. Myers, Gems from the Talmud).

The eighth, "life that lacks contempt and scorn," applies to Joseph, who was scorned as a slave and looked upon contemptuously while a convict in prison.

The ninth, "life of wealth and esteem," involves Moses, who possessed these as well as many another distinction (Sabbath 92, a).

The tenth, "life inspiring the love of the law and fear of heaven," implicates David, who delighted in saying (Psalms cxix, 62-63) "At midnight I do rise to learn of you and of thy righteous judgments. I am a companion of all that fear thee."

Although the importance of the heavenly fear as a constant guide for one's ventures has been prayed for in a former section, the repetition thereof may be urged in connection with the practical study of the law. History repeats itself. Like in olden times, when Rabbi Simon and his associates, absorbed in studies, disregarded divine services, nowadays students of the law,

both secular and theological, abandon the fear of heaven.

The eleventh, "life that will bring about a fulfillment of our good will," points toward Solomon, who disposed of a determined will power of forbearance, meditating as he did (Proverbs xxx, 8), "give me neither poverty nor riches; feed me with convenient food." This applies coherently to "Where there's a will there's a way," which adage is, apparently, an inference from a Talmudic Agada:

"To be unclean who'er desires
Finds open wide the door;
And to be pure who'er aspires
Is aided even more."

(Dr. Myers, Gems from the Talmud). Another remark before quitting the arena:

The finishing touch of the treated chapter, namely, "the Rabbi," is a sort of a stumbling block to many a minister and to a multitude of Hazans, who change it into "Rabbin," which alteration may be sustained as an induction for their scholarly selves by the consequent propensity: "The present Rabbis are Ame Haareth" (Exodus v., 5).

In the Jewish World.

Rev. J. H. Landau, noted for his successful work as a rabbi in Australia and an instructor in England, will conduct the services at the Temple Ohabel Shalom, Boston, Mass., during the holidays, and may become the rabbi of the temple, to succeed Rabbi Hirschberg, who recently resigned.

Dr. Landau came to this country from Sydney, Australia.

On his leaving there he was presented with an engrossed address, signed by Cardinal Moran, of the Roman Catholic Church; the heads of all the other Christian churches, the Lord Mayor of Sydney, the Prime Minister of the Commonwealth, the Moderator of the Presbyterian Assembly, and the Premier of the State of New South Wales.

Rev. Dr. Leopold Hiemari, the new rabbi of Beth El Synagogue, of Norfolk, Va., held his initial service with his new congregation last week.

Rev. David L. Liknaitz, who for the past year has been rabbi of Temple Beth-El, Utica, N. Y., has accepted a position at the head of Temple Benai Jeshurun at Leavenworth, Kan., the oldest Jewish congregation in Kansas, and the largest in Leavenworth.

For the first time in the history of Chicago, the Jewish musical societies will be brought together on the Jewish New Year, Sept. 10, and organized into one organization, to be called the Halevy Singing Society, under the direction of Julian Shapo, who is well known among the Jewish population of Chicago. It is expected that at least 1,000 persons will join what will probably prove one of the finest musical organizations in Chicago.

A most interesting discovery has been made of Jewish gravestones in the foundations of the Hofburg, the Emperor's Vienna residence. Certain alterations are being made in the great Imperial kitchens, which are below the chapel, and the gravestones had been utilized in building the walls. They are twenty-one in number, and, as far as it has been possible to judge from the Hebrew inscriptions they bear, must be at least 800 years old. Some refer to women; for instance, Zipora, the wife of the Rabbi David. Obviously part of the Hofburg must rest on an ancient Jewish cemetery. The stones will be set up in the Imperial library.

A railway official named Vlasic, nephew of an ex-minister of public instruction, was making an excursion yesterday near the village of Bredno, in Northern Hungary, when the peasants mistook him for a Jew whom they accused of arson. They therefore rang the church bell by way of raising an alarm, seized the unfortunate young man, dragged him into the village, and killed him brutally with sticks, stones and scythes, crying "Serve the Jew right." A local peasant has since been murdered under similar circumstances.

Rev. Eli Mayer, the recently elected assistant rabbi of the Broad street Temple, Philadelphia, Pa., will be inducted into office on Sunday morning, Sept. 3, when special services will be held.

The Jewish residents of the South Side are soon to have a synagogue. A congregation has been organized, officers elected and a committee will be appointed to obtain a site and arrange for its purchase and the subsequent erection of a building. There are now about eighty members of the congregation. Herman Frank is president, J. D. Schein vice-president, and J. Lieberman secretary. At the meeting on Sept. 3 trustees and the various committees will be named.

The new Temple of the Congregation Tifereth Zion was dedicated recently. The edifice cost \$40,000 and is one of the largest temples in the West. Rabbi S. H. Bauer delivered the dedication oration.

FOR THE TRAVELER.

How Various Ills May Be Relieved With Simple Remedies.

Some of the following remedies may prove beneficial for car sickness, says the Ladies' Home Journal. It must be remembered, however, that what one person may have found invaluable may not always have the same good effect on another.

Foremost is the old time remedy, lemon juice. If this is taken freely, undiluted, it will usually prove a preventive. Another remedy is clam juice. Cool the juice with ice and drink as much as desired. Tablets of black licorice and pieces of cinnamon bark are also recommended. If thin smoked beef is put in the oven until crisp and a piece taken at intervals during the journey it may prevent sickness. Lying down in a berth in a sleeper may cause sickness, whereas one may not be affected if only slightly reclining.

For seasickness nibbling cloves is warmly advocated; also inhaling vinegar. An old remedy is to place a sheet of writing paper against the stomach.

In case of a sick headache on board either boat or train an ice bag often will bring relief. A little silk or mohair bag, lined with rubber cloth and having a drawing string, may be tucked in one corner of your bag for this emergency.

A sick headache is often caused when traveling by inability to get meals at the usual time. Not many people know that a few raisins carried in a tiny box and eaten from time to time often will avert a headache. Raisins contain a great deal of nourishment. The practice of eating sweet milk chocolate when meals are delayed is becoming almost universal.

To allay thirst when there is no water, or, at least, no good water, to be obtained, a cube of sugar soaked in lemon juice is excellent. Lemons are valuable traveling companions. Sweetened lemon juice added to water is much better for drinking than plain water on boats or trains.

For toothache, rubbing the gum with quinine in powdered form is recommended. The powder should be held in the mouth as long as possible.

To remove a cinder from the eye the insertion of a flaxseed almost always will prove efficacious.

Candles and a box of safety matches are often friends in need, and it is a good plan to include them in one's baggage, especially when traveling abroad.

How to Make Tomato Catchup.

Boil a peck of sliced but unpeeled tomatoes with six white onions and cook until so soft they can be rubbed through a colander. Strain through a sieve and return to the fire with three bay leaves, a tablespoonful each of powdered mace, pepper, cloves, sugar, salt, a half teaspoonful of paprika and a tablespoonful of celery seed tied in a little cheesecloth bag. Boil for nearly six hours, stirring frequently. Remove the bag of celery seed and pour in a pint of vinegar. Bring again to the boil and remove from the fire. When cold, bottle and seal.

How to Revive a Tree.

It has been our ambition to have a beautiful home, says a writer in Good Housekeeping, and when we moved to our present one we found a row of maple trees, all perfect except one, and that, a former tenant told us, had been dead for a year. We disliked the thought of having to cut one out and decided to try what a little nursing would do. We loosened the dirt about the roots, put wood ashes around them to kill any destroying insects, filled in the dirt well up around the trunk and awaited results. In the spring the leaves came. Very few at first—perhaps all summer it was not half full, but enough to encourage us. We continued our petting, with the result that the second summer gave us a tree equalling the rest in its abundant foliage.

Bacon and Coke.

The domestic life of both Bacon and Coke, his great rival, was most unhappy. Each married the wrong woman, and both lived to regret the fact.

Japanese postage stamps are rated as the most artistic in the world. The first stamps were issued in 1871. There are few rare ones, the highest price ever known to have been paid for one being \$50.

First Telephone Circular.

The first circular ever issued referring to commercial use of the telephone was that of Gardiner G. Hubbard in Cambridge, Mass., in 1877.

How to Make Chocolate.

An excellent summer beverage and one which is healthful is chocolate. When well made a cup of chocolate is most nutritious. Here is an excellent formula for making it: Take two squares of bitter chocolate and break them; add two tablespoons of hot milk or hot water and a scant saltspoon of salt, and into these ingredients stir gradually a scantily measured three pints of milk.

How to Make Burnt Almond Ice Cream

Shell and blanch four ounces of almonds and put into a porcelain kettle with three tablespoonfuls of sugar; heat until the almonds are quite brown, stirring constantly. Pound fine in a mortar and sift through a fine strainer. Add this as a flavoring to each quart of plain ice cream. A standard cream which may be used as a foundation for all sorts of varieties is made by adding a cup of sugar to a quart of cream and thickening over hot water with four or five eggs, according as one likes it more or less rich. Allow a little more sugar if more eggs are used, as it freezes out. To this add any fruits, nuts, macaroons, etc.

How to Soften the Hands.

An admirable whitener and softener of the hands is mutton suet, the favorite cosmetic of our grandmothers. Cut suet from mutton kidneys into small pieces, put into a glass jar or bowl and set in a pan of water on the stove. When the suet is melted pour off, add a few drops of carbolic acid and beat with a silver fork until it is cool.

How to Make Mucilage.

To five cents' worth of gum tragacanth dissolved over night in a quart of rain water add ten cents' worth of alcohol, and then add water until the right consistency is reached. Stir well and bottle. This will keep a year.

NOTICE TO TAXPAYERS.

Department of Finance, Bureau for the Collection of Taxes, New York, September 1, 1904. TAXPAYERS WHO DESIRE TO OBTAIN their bills promptly should make immediate written requisition (blanks may be procured in the borough offices), stating their property by Section or Ward, Block and Lot or Map number, making copy of same from their bills of last year.

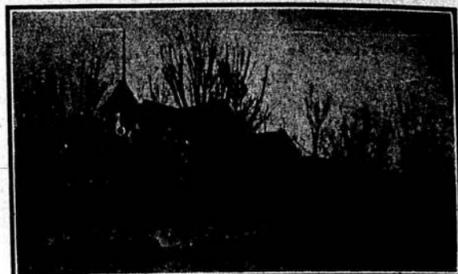

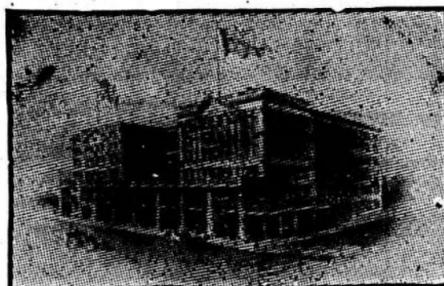

The Hebrew Union Veteran Association.

This organization was started on March 15, 1896, the late Judge Joseph H. Stiner being elected colonel, and serving as such up to the time of his death on Sept. 20, 1902.

Since its organization, 210 veterans of the Jewish faith have been enrolled on its books. It has lost by death 43 comrades.

The late Rev. Dr. Gustav Gotthel was elected hon. chaplain at the inception of the organization, and he served up to the time of his demise, being succeeded by Rev. Dr. Jos. Silverman, who still continues in that office.

The objects of the association are: First. To preserve and strengthen those kind and fraternal feelings which bind together the Hebrew soldiers, sailors and marines who united with their Christian brethren to suppress the late rebellion and to perpetuate the memory and history of those who died that the nation might live.

Second. To maintain true allegiance to the United States of America, based upon a paramount respect for, and fidelity to the National Constitution and laws, and to encourage the spread of universal liberty, equal rights and justice to all men.

Third. To hold memorial services at a Jewish Temple or Synagogue in the manner prescribed by the Jewish faith on the Friday evening preceding Decoration Day.

Fourth. To assist such of our comrades as need help and protection, and to extend needful aid to the widows and orphans of our deceased comrades.

Since its organization it has held memorial services every year at the Temple Emanu-El, the following having been among those who participated:

President Theodore Roosevelt, Gen. N. M. Curtis, the hero of Fort Fisher; Gen. Daniel Butterfield, Gen. Jas. J. O'Beirne, Hon. Simon Wolf, Gen. Geo. B. Loud, Hon. H. M. Goldfogle, Gen. H. C. King, Rev. Clarke Wright, Gen. Stewart L. Woodford, Gen. Jno. Palmer, Hon. Edward Lauterbach, Hon. Jos. A. Goulden, Hon. Amos J. Cummings, Hon. Abe Gruber, Gen. Thos. L. James, Hon. Abe Levy, Gen. E. J. Atkinson, Hon. Jacob W. Mack, Gen. Allan V. Bakewell and Gen. Thomas J. Stewart.

In about every cemetery of other religious faiths in this country a monument has been erected to the memory of those who died that the nation might live, and none ever having been erected and dedicated to the memory of the Jewish soldier, a committee was appointed by the association to take action in the matter, and as a result of its labors, a meeting was held in the vestry room of the Temple Emanu-El, Forty-third street and Fifth avenue, on Dec. 17, 1900, at which it was decided to erect a monument to cost \$15,000.

The monument will be 52 feet in height, and will be of a handsome design. The cornerstone will be laid, on Sept. 5 (Labor Day), with impressive ceremonies. It is expected to have the monument ready for dedication about Nov. 1.

To the Editor of the Hebrew Standard:

The remarks made by Ben Avigdor against that most useful of Jews—Mr. Behar—were unkind and uncalled for. They seem to be inspired by personal motives. All who have watched the progress and development of the fight of our Jewish citizens for equality in Russia, will know that much is due to the untiring energy and unselfish devotion of Mr. Behar.

Let me just recount some of the things he did:

1st. He organized two large mass-meetings in Philadelphia about two and a half years ago for this purpose; at one Judge Sulzberger presided, at the other Hon. Jacob Sulzer.

2d. He founded and organized the "Israelite Alliance of America" (a society composed of delegates from 130 societies). We all know what its objects were.

3d. He suggested and supplied the material for the printing of that useful pamphlet which was sent to every Congressman, Senator, Rabbi and clergymen in the country. I refer to the "Badge of Citizenship."

4th. He sent out men, at his own cost, to Providence, Boston, Worcester, Philadelphia, Pittsburg and other cities to organize mass-meetings favoring the Goldfogle resolution.

5th. He organized three more mass-

meetings in New York City, one at Temple Rodef Sholom and two at the Educational Alliance. (Father Ducey and Rev. Thos. R. Slicer spoke at these meetings).

6th. He personally interviewed the following editors: Dr. Talcott Williams, of the Philadelphia Press; Mr. Adolph S. Ochs, of the Philadelphia Ledger; Mr. Arthur Brisbane, of the New York Journal; Mr. Villard, of the New York Post; Mr. Taylor, of the Boston Herald; Mr. Clement, of the Boston Transcript. (Each of the above named, after the interview, wrote strong editorials favoring Judge Goldfogle's resolution in Congress.)

7th. He personally called on President Elliot, of Harvard University, and G. Stanley Hall, of Clark University, and invited them to address mass meetings. Both accepted and did much good.

8th. Mr. Behar continually kept calling on and reminding our influential coreligionists to insert the clauses (which are now inserted), in the platforms of the two parties.

9th. Mr. Behar is now publishing a monthly, "The Israelite Alliance Review," which has for its object to interest our brethren in their persecuted coreligionists in Russia and the Orient.

Much space, however, is given to the passport question.

The above few statements will no doubt interest Mr. Avigdor and will make him a little more careful the next time he attacks any one.

How to Destroy Weeds.

To destroy weeds of all sorts take of sulphur one pound and the same quantity of lime and dissolve in two gallons of water. Pour this liquid on the weeds and it will destroy them.

How to Make Toilet Waters.

Toilet waters can easily be made at home. For violet water put a quarter of a pound of fresh picked sweet violets, together with their weight of pure alcohol, into a large bottle. Cork and shake the bottle every day for one week. Then add a quarter of a pound of water, filter and bottle for use. Lavender water is made by slowly steeping for one hour in a covered farina boiler one pound of fresh lavender with one pint of water. On its removal from the fire add two quarts of alcohol, filter and bottle for use. One of the most delightful home made toilet waters is cherry laurel water. Bruise one ounce of bay leaves and add to them a half pint of water. Steep slowly for one hour in a farina boiler. Take it from the fire and add one quart of lavender water. Filter and bottle for use.

How to Keep Butter Firm.

Place your butter in a basin and cover it with water to within an inch or two of the top; add a piece of salt the size of a hazel nut; cut off portions daily. Butter treated in this way will keep firm and fresh for days.

How to Test Ventilation.

A very simple way to tell whether your room is properly ventilated is to place a wide necked bottle of water into which you have put half an ounce of limewater somewhere in the room, letting it remain there uncovered overnight. If in the morning the limewater is milky the ventilation is very bad indeed. If the limewater becomes milky on your covering the bottle mouth with your hand and shaking the vessel the ventilation is not sufficiently good. If the limewater remains clear the air of that room is pure.

How to Protect Valuable Lace.

Remember that valuable lace should always be kept in blue paper. White paper is very often bleached with chloride of lime and injures any delicate fabric that lies for any length of time against it.

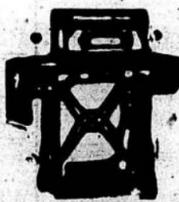

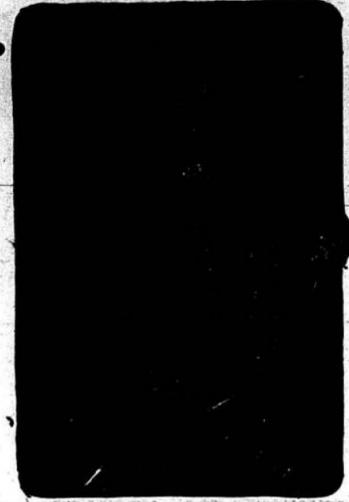
