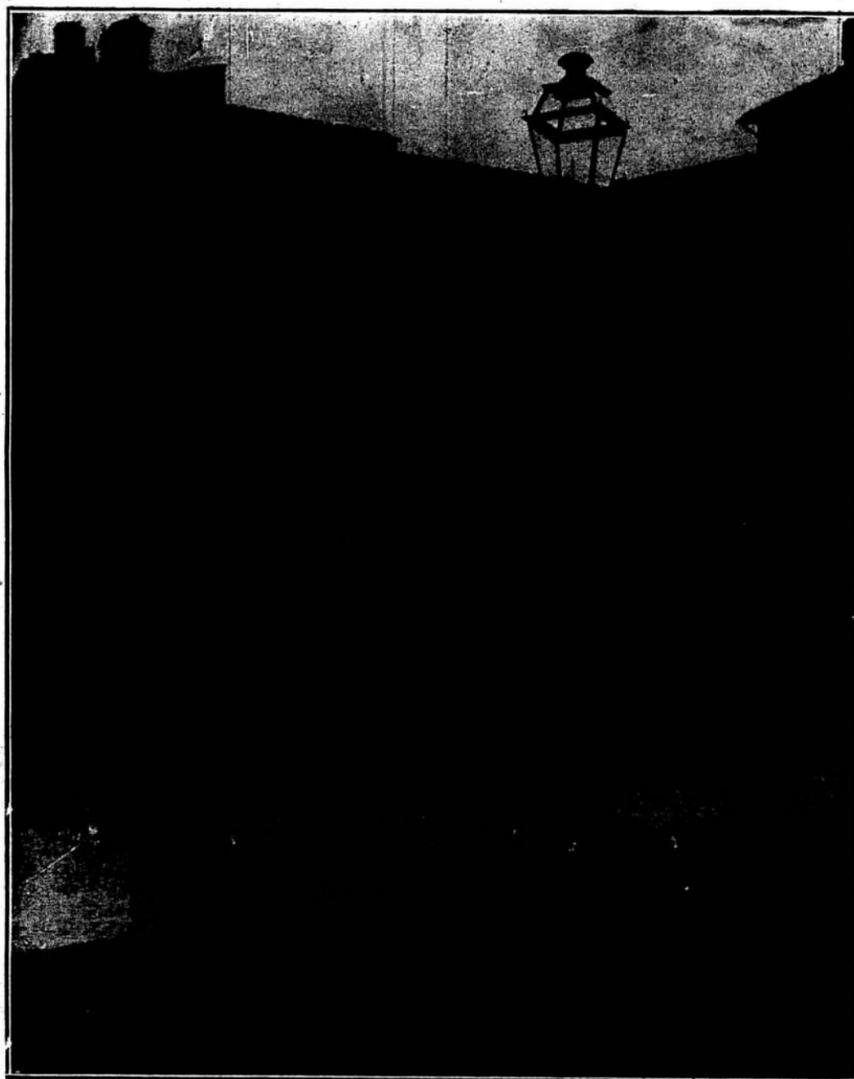

THE GHETTO OF ROME.

EUROPEAN cities are dotted with Ghettoes, and one of the most interesting was the one at Rome. It was established by Pope Paul IV., and was entered on July 26, 1556. Its site was between the Via del Pianto and the Ponte del Quattro Capi. It consisted of a few narrow, dirty, unhealthy streets, which soon became painfully overcrowded. Its first name was "Vicus Iudaeorum," and later it came to be called the "ghetto." It was annually flooded by the Tiber. Each year the Jews had to go through the humiliating ceremony of formally imploring permission to continue living there during the ensuing year for which they paid a yearly tax. This ceremony was observed as late as 1850. The restrictions and regulations which were issued from time to time in regard to life in the Ghetto, and which were alternately abolished and re-imposed by succeeding popes, were repeated in the cruel legislation of Pius IV. in 1775. In 1814, Pius VII permitted a few Jews to live outside the Ghetto; in 1847, Pius IX finally decided to do away with the Ghetto gates and walls and to give the Jews the right of residence in any part of Rome; but the reactionary movement of 1848 re-established the restrictions. In 1870, the Jews of Rome presented to Pope Pius IX a petition for the abolition of the ghetto. But it was reserved for King Victor Emmanuel, who entered Rome in that year, to fulfil their desire by definitely and finally abolishing the ghetto. Its walls remained until 1885, a memorial of mediæval tyranny.

The Five Synagogues, Rome.

With the exception of a few buildings nothing remains of this ancient Ghetto. One of the houses was formally a Matzoh factory and is still used for that purpose. From this house a door leads into an ancient ritual bath. On a portion of this ghetto from which the old houses have been cleared the five synagogues are situated. Even at the time when the ghetto was still in existence all the Jews could not possibly live there and they overflowed their cramped quarters into the adjoining streets. The houses and streets which surround the old ghetto still remain and they form the centre of the present day ghetto.

No attempt has been made to beautify the district or the houses and they present in this century of progress a very dreary picture.

The old synagogues are exceedingly interesting and contain much of particular value to the student of ancient Jewish life.

Judge Frank H. Bellin.

AS an instance of what the Russian Jewish immigrant can do in the United States and to what heights he can rise is the career of Judge Frank H. Bellin, of Providence, R. I.

Judge Bellin was born in Elizabethgrad, Cherson, Russia, 27 years ago, where he resided until he was ten. To escape the hardships incident to residence there, his father concluded to come to America, and with a family of ten children came to New York.

Judge Bellin attended the public schools in New York, New Haven and Central Falls, spent the best part of a year at Central Falls High School, from which time, however, he never had the good fortune to see the inside of a school again. He found it impossible from then to allow his father to labor alone, and he aided him for six years in the operation and management of a mercantile business in Cen-

the Republican ticket, and was elected without any opposition. In 1903, he again had no opponent. In 1904, the combined Democratic and Republican machines ran a candidate against him and he ran on Good Government Nomination Papers and very easily defeated his opponent. In February, 1904, he resigned as Councilman and was elected as Probate Judge with very little opposition. In February, 1905, he was re-elected to the same office without opposition.

He is a member of most of the local fraternal Orders, both Jewish and non-sectarian.

Death of Baron Alphonse de Rothschild.

PARIS, May 26.—Baron Alphonse de Rothschild, head of the Paris branch of the great Rothschild banking concern and Governor of the Bank of France died in that city on Friday morning, last week, in his seventy-ninth year.

Baron Lambert de Rothschild, head of the Brussels branch, will now become the head of the Rothschilds' Paris house. Baron Lambert married the daughter of Baron Alphonse's next younger brother, Baron Gustav.

Baron Alphonse fell ill of bronchitis two weeks ago, and his ailment was aggravated by gout. After several rallies, he began to sink slowly, lapsed into unconsciousness Thursday night, and passed away peacefully at 4.30 o'clock Friday morning, surrounded by his family.

President Loubet, Premier Rouvier and many other officials, financiers and diplomats called at the Rothschild residence during the day to express condolence.

The news of the Baron's death caused a deep impression among financiers. It was said that his death would probably momentarily influence the extensive interests in which the house is concerned, but that it would not have a lasting effect on the markets.

The burial will be severely simple, according to the strict rule of the Rothschild family. The coffin will be plain and there will be no mourning tributes.

Baron Alphonse de Rothschild, born

February 1, 1827, was the second son of James de Rothschild and succeeded his brother, the late Baron Edmond James de Rothschild as head of the Paris banking house. He was not only an eminent financier, but a member of the Academy of Fine Arts, a member of the French Institute and a Commander of the Legion of Honor.

He was the leading spirit of the Rothschilds in their financial relations with practically all of the governments of Europe. It was he who performed the colossal task of financing the indemnity which France paid to Germany after the war of 1870-71. The house of Rothschilds also cares for the finances of the government of Italy and of the Vatican at Rome, and has large interests in Spain and Austria as well as holding a considerable part of the old Russian loan issues.

The Rothschilds have always figured largely in American securities; doing business through J. P. Morgan, the Belmonts and John W. Gates. They have been large holders of Louisville & Nashville and Atlantic Coast Line stock and have also been interested in California mines.

The Rothschild family originated in Germany, were made nobles in 1815 and created barons in 1822 by the Emperor of Austria. Mayer Anselm Rothschild, who founded the great banking house, was born at Frankfort-on-the-Main in 1743, and died in 1812. He had five sons and five daughters to whom he bequeathed the business. The manager of the house was Anselm, and through his energy the business was extended to all the great European capitals.

In the Jewish World.

At Home.

The directors of the Jewish Free Loan Society of Denver, Colo., held their annual meeting at the home of Dr. John Elsner.

I. H. Mendelssohn, the financial secretary, presented a report which showed that the society had received up to May 1 in dues and donations \$1,964.25, and had made loans to about 271 applicants. The entire expense amounted to about \$83.61 and the society had a balance of \$212.64.

After the meeting a reception was held in honor of Mrs. M. C. Benjamin, the president of the society, who leaves shortly for the East. Rabbi C. H. Kaurar, in behalf of the directors, presented Mrs. Benjamin with a beautiful fountain pen and an author's outfit. At the reception Dr. Elsner acted as toastmaster. D. B. Kobey, the vice-president of the society, spoke on "The Burdens of the President;" Mr. Herman Strauss, "The Society's Future Outlook;" G. B. Kobey, "The Problem of the Free Loan Society;" Mr. I. H. Mendelssohn, "Financial Possibilities," and A. L. Fribourg, "The Board of Directors."

The following officers were elected at the eighteenth annual meeting of the Jewish Woman's club in Temple Beth El, Detroit, Mich. President, Mrs. H. A. Kroll; first vice-president, Mrs. W. T. Rosenfield; second vice-president, Miss Bella Goldman; treasurer, Mrs. David Brown; corresponding secretary, Mrs. Max Cohen; financial secretary, Mrs. Frank R. Hamburger; recording secretary, Mrs. Morris H. Sloman.

Managers of the Jewish Maternity Hospital, No. 534 Spruce street, Philadelphia, Pa., contemplate a nursery annex to their institution. Mrs. H. H. Ginsberg has contributed \$100 as a memorial fund for this purpose, and efforts will be made to increase the sum at once.

The matter was discussed at a recent meeting, when addresses were made by Mrs. Esther Amram, who was the first president of the association; President Jacob Gimbel, of the Federation of Jewish Charities; and Rabbi Max Raisin.

Officers for the coming year were elected as follows: Mrs. S. Belle Cohn, president; Mrs. H. H. Ginsberg, vice-president; Mrs. Julius H. Greenstone, secretary; Mrs. Isaac Herzberg, treasurer; and M. S. Mayerhoff, Isaac Leopold, and David T. Berlitzheimer, directors.

Three prominent St. Louis, Mo., organizations—T'pheris Zion Talmud Torah Association, T'pheris Israel Congregation and the Jewish Immigration Aid Society—held a joint meeting at the Temple, Ninth and Wash streets, for the purpose of formulating a plan by which to aid the cause of Jewish immigrants.

The officers of the first of the organizations are: Jacob Fishman, president; Sam Swartz, vice-president; S. Weisman, secretary, and S. Feinstein, treasurer. The officers of the Aid Society are: S. Feinstein, president; M. Goldman, vice-president; D. Goldman, secretary, and H. Albert, treasurer. The Congregation officers are: S. Feinstein, president; A. Stern, vice-president; Joseph Ler, second vice-president; John Ellman, treasurer, and M. Rich, secretary.

Orthodox Jews of Pueblo, (Colo.), are very soon to begin the construction of a synagogue of which they have so long been sadly in need. A lot has been purchased on South Union avenue, above the new brick terrace and below Royal Park, the price paid being \$1,000. The building will be twenty-five by seventy-five feet in size, and will be located on the right hand of the avenue, going south. Its cost, besides the lot and furnishing will be in the neighborhood of \$3,500. Up to the present time the Orthodox congregation has been without a place of meeting of their own; the meetings have been held in various halls.

A new Jewish religious organization has been incorporated in Rochester, N. Y. The incorporators, who are also the trustees of the new society, are as follows:—Frank Sherman, Samuel Lapides, Barnet Eber, Samuel Berman, Hymen M. Meltzer, Lesser Lapides, Solomon Cohen, Wolf Jackson and Benjamin Lapides. The officers of the order, which is to be known as the Ahavas Achim Anshea Radshkowitz, are as follows: President, Frank Sherman; vice-president, Samuel Lapides; treasurer, Barnet Eber; recording secretary, Samuel Berman; financial secretary, Hymen M. Meltzer; trustees, Lesser Lapides, Solomon Cohen, W. Jackson and B. Lapides. The society has purchased the Hollander Church, on the west side of Chatham street, just south of the Central tracks, and it will take possession of the Hollander Church July 15. There are now eighty-one members and many new ones are expected to join when the society moves into its new quarters.

The directors of the Sanitarium for Hebrew Children announce that the institution at Rockaway Park, Long Island, will open for the season with the first train excursion, on Thursday, June 15, after which date two a week will be given, on Monday and Thursday, until September.

LEBANON HOSPITAL

Annual Meeting.

The annual meeting of the Lebanon Hospital at Westchester and Cauldwell avenues, Bronx, took place on Sunday last. There was present a large number of members and friends over which Mr. Jonas Weil, the president, presided.

In the course of his report the president stated that the institution had been in existence for 12 years and that during that period every effort had been made to accommodate the steadily increasing number of applicants and to effect such improvements as were necessary. From May 1, 1904, to May 1, 1905, there have been admitted 2,721 patients, an increase of 401 over last year. In the dispensary 15,000 cases, 3,271 more than the preceding year, had been treated and the ambulance had responded to 1,491 calls, an increase of 74. After acknowledging the services of the superintendent, the matron, the medical and surgical staffs, the report referred to the assistance rendered on the occasion of the Stocum disaster on June 15, 1904, and to the victims of the railroad collision on Feb. 9, 1905. The report then dilated upon the necessity of a separate building for a

training school for nurses, for which purpose \$30,000 had been donated out of the \$50,000 required. The training school when completed will accommodate seventy students.

The receipts during the last fiscal year amounted to \$77,815.61 and the disbursements, \$64,129.36. The hospital received from the Saturday and Sunday associations \$3,622.65. This is evidence of the fact that now the institution is in the front rank of those hospitals which treat a large number of free patients.

The report closed with thanks to the various auxiliary societies, to kindred institutions, to the press, and with a tribute to the memory of departed friends.

The auxiliary hopes to build and endow a hospital in the name of our late venerable Rabbi, and as its work so far has been very successful, especially the Jacob Joseph Talmud Torah School on Henry street showing good results, it expects to accomplish its aims at an early date.

The Yonkers Home.

About two hundred ladies and gentlemen made the annual trip on Decoration Day to the Home for the Aged at Yonkers. At the home they were received by the Board of Governors and escorted around the building. An elaborate entertainment and concert was provided, in which Mrs. Amelia Morgenroth, Mrs. Nathaniel Ansbacher and Miss Charlotte Leslay, of the "Sho-Gun" company, and Messrs. Adolph Wald, Max Liebling and Sidney S. Meyers participated. The entertainment concluded with an operette, "The Rose of Savoy," which was beautifully rendered by about twenty girls from the Hebrew Sheltering Guardian Society. Mr. Henry Meyers presided, and Mr. Meyer Thalmeisinger, in a brief address, tendered the annual subscription of Washington Lodge to the home.

Short addresses were also delivered by Mr. Charles Hartman, president of District No. 1, and Mr. M. S. Hyman, president of the Board of Governors. At the conclusion of the entertainment the entire party had luncheon, returning to the city about 8 o'clock.

The Young Ladies' League of District No. 1 joined Washington Lodge, making its first visit to the beautiful institution at Yonkers.

Presentation to Rabbi Lowenstein.

On Wednesday morning at a meeting of the staff of the United Hebrew Charities, presided over by Dr. Lee K. Frankel, manager, a presentation was made to Rabbi Lowenstein on vacating his position as assistant manager, which position he has held for more than a year and a half, prior to taking up his duties as superintendent of the Hebrew Orphan Asylum. The gift, which was subscribed for by every member of the staff, consisted of an ornate writing set. The presentation speech was made by Dr. Frankel and responded to by Mr. Lowenstein.

Conference of Hebrew Societies.

The Mephalzal 'Phath Eber of New York has arranged for a meeting of all the Hebrew literary societies of America, to be held at the convention of the Federation of American Zionists, which will take place on June 16-20 in Philadelphia. All the Hebrew literary societies are invited to send their delegates. The following points will be discussed:

1. To bring about union of all the existing Hebrew societies in America.
2. To devise ways and means of increasing the number of Hebrew speaking societies.
3. To consider the advisability of a Hebrew periodical.
4. To discuss the possibilities of establishing schools where all the instruction should be given in the Hebrew language.
5. To arrange for lectures on Hebrew literature for the benefit of the public.

All interested in the diffusion of the Hebrew language are welcome.

Hebrew Orphan Asylum.

The annual entertainment and distribution of prizes of the Hebrew Benevolent and Orphan Asylum, of which Louis Stern is the president, was held in the home Friday morning. The feature of the programme was a dumbbell drill by eight boys of the gymnasium class. Among the important prizes awarded were the Korn one-hundred-dollar prize to Samuel Bernstein; the Betty Bruhl prize of \$50 each to Samuel Greenblatt and Annie Dublin, and the twenty-five dollar prize from the Sellman Solomon Society of the ex-inmates of the institution, to I Lang.

President Stern, who made the final address, awarded to each of the sixty boys of the first company of the battalion a silver medal for winning a silk flag against all the competitors in the

Twelfth Regiment contest for the best-drilled company of cadets from asylums.

Jews and Memorial Day.

The annual Memorial Day celebration of the Young Folks' League, a Jewish charitable society of the upper West Side, was held at Terrace Garden Sunday afternoon. Maurice R. Blumenthal, counsel to the sheriff, delivered the oration on "Memorial Day." He said in part:

"Today the cable brings us glad tidings that Memorial Day of 1905 will witness the inauguration of a most worthy reform in Russia—the recognition of the American passport when presented by a Jew.

"But while we are successful in securing the intervention of our government in international affairs affecting our religious rights we must not lose sight of evils here in our own community and particularly the disgraceful discrimination against Jews in public resorts—especially summer resort hotels. It is not the practical result, but the principal involved of which I complain. The passport guaranteeing admission into any hotel or other public place in free America should be nothing more than the applicant's respectability, ability to pay and orderly deportment. Religion or nationality should have nothing to do with it. Those who do not take this view are a menace to the establishment of the brotherhood of man, the chief aim of all good Jews—of all good men.

"And the day will yet come when the constantly increasing greatness and power of the Jew in this land will bring that despicable class of bigots to their knees to the end that even their comparatively insignificant hindrance may be removed from the pathway of an ever advancing higher, better and more liberal civilization."

Becoming Practical.

Our brethren in the Holy Land are becoming more practical it seems. Heretofore it was the custom to send emissaries (meshulochim) throughout the world to collect contributions for the various yeshibas and other institutions in Jerusalem. The expense involved was very great, and results very meagre. The wardens of the Grand College Torath Chayim have abandoned this unsatisfactory method, and, instead have appointed resident representatives throughout the world. For America they have appointed Mr. B. Rosenfeld. That gentleman informs us that he has volunteered his services, making no charge whatever. This guarantees that every dollar collected by him will be devoted exclusively to the needs of the institution, and for no other purpose whatsoever. We know Mr. Rosenfeld to be a gentleman of integrity, and we hope that his efforts on behalf of the institution whose cause he has sponsored will meet with great success.

Mr. Rosenfeld is also well recommended by Dr. H. P. Mendes, B. Drachman, and Dr. Ph. Klein.

Interesting Item.

On June 14, at West Point, Colonel S. H. Milenberg will deliver an oration on the 100th anniversary of the birth of Gen. Robert Anderson. Mrs. General Lawton, the daughter of Gen. Anderson, will be present, also the Secretary of War, Mr. William H. Taft, and the entire Military Academy.

Congregation Shaari Zedek.

On Saturday evening, May 21, at the Arion Hall, the Young Folks' League of the above congregation gave a "shirt-waist" dance. The committee in charge of the affair, of which Myer Yondorf was the chairman, together with President Henry Saul, worked indefatigably for the success of the evening.

The League is now in existence about two years. From a membership of only twenty-two young ladies and gentlemen it has steadily and gradually grown until to-day it can boast of a membership of nearly one hundred and fifty members prominent in the Jewish circles of Brooklyn. It has aided the congregation whose name it bears in the matter of finances at different periods, and has in other ways shown how helpful a younger body can be to a congregation.

The Educational Society Library

In consequence of the recent taking over by the city of the library of the Hebrew Educational Society, at Pitkin and Watkins avenues, in Brownsville, and making it a branch of the Brooklyn Public Library, the library authorities have encountered the problem of what shall be done about keeping the branch open on the Jewish holidays. The question came up at the last meeting of the library trustees and developed into a puzzle of good-sized importance. There was a general debate on what should be done in regard to three holidays next month, and this was finally disposed of by referring the matter to a special committee. So far as settling the question for all time went there was not even an attempt to treat it with such a view.

A Defense of the Emigrant.

To understand the emigrants one must work among them. They have many friends, and among them may be counted Rabbi H. Veld, chaplain of Kings County Penitentiary and Jail, and probation

officer of the Children's Court, of Brooklyn, who delivered a very interesting address at the B'nai Israel Synagogue, Fifty-second street, last Friday night. His text was the last verse of the Third Book of Moses, and his subject was "Obey the Law." Dr. Veld said in part:

"We have been hearing that we Jews are a law-abiding people. Perhaps that is true to some extent, but when we find our children are being taken to the juvenile courts it must not be said that the parents are entirely to blame, or that they are not law-abiding citizens.

"It must be remembered that those children are the offspring of those who have known persecution and who have lived in a land where their very lives were not their own. And when they come to this country, where the inhabitants are all equal, it takes some time before they can throw off the suspicion of the past.

"We cannot do better than encourage them in the love of the law and freedom and independence that they will acquire more and more in a generation or two."

THE SITUATION IN RUSSIA.

The following cable dispatches need no comment. They tell their own story: LODZ, May 28.—In disturbances to-day in the neighborhood of a synagogue soldiers fired on the crowd, killing two Jews.

BERLIN, May 27.—The Jewish Relief Committee of Berlin has just received reports which, it declares, are reliable, regarding the recent anti-Jewish disorders in Russia.

According to these reports, in 17 cities and 480 villages 250 Jews were killed, 3,000 wounded, 350 houses were demolished, and 5,000 shops were plundered.

KISHINEFF, May 25.—In an official investigation of one of the numerous cases of assault on Jews and students in the streets it has been decided that the assailants, including two members of the nobility and five burghers, "exceeded their rights" by stopping and beating passers-by.

All of them were sentenced to short terms of imprisonment, while the victim of the assault, who defended himself with a revolver, was fined \$12.50.

ST. PETERSBURG, May 25.—The Voskhod, a Jewish paper, reviewing to-day the recent riots at Zhitomir, Province of Volhynia, denies that the Jews during target practice on the bank of the river fired at a portrait of the Emperor. The paper says the Jews were armed in self-defense, and when they were first attacked replied with shots in the air.

The Voskhod further complains that the authorities and the Christian population generally were indifferent to the massacre of the Jews, the soldiers not being called to the rescue promptly, and that when they did appear they were slow to act. A Russian student, it is further asserted, was killed because he tried to protect the Jews.

The Roll of Dead and Wounded Grows.

The following dispatch comes from St. Petersburg, dated May 17 (Thursday), 3.30 a. m.

Sixteen persons were killed and more than one hundred wounded, most of them Jews, during the anti-Jewish riots in Zhitomir, Southwest Russia, according to letters received.

Alarming reports continue to come from there, but private telegrams sent to that city, which is eighty miles southwest of Kieff, remain unanswered.

Martial law was proclaimed at Zhitomir yesterday. The place is filled with troops and general order has been restored, though individual cases of violence are still occurring and a renewal of rioting is feared Saturday evening and Sunday.

Private advices bring news of a further anti-Semitic outbreak in Gostynin, Warsaw Province, in which many Jews were wounded and numerous houses were pillaged.

Jews here fear more rioting not only in Zhitomir and Gostynin, but elsewhere along the Polish frontier.

How the Trouble Began.

The Zhitomir troubles were started by roughs stoning some Jews who were boating. The Jews defended themselves with revolvers, wounding several of the attacking party, but not seriously.

Reports of this aroused the Christian populace to frenzy. The Jews banded together for mutual protection, and though a general encounter was prevented by the troops, several minor riots occurred, in one of which a Jewish boy was killed and several persons were wounded.

The disorder culminated Sunday in a pitched battle in the public square in the centre of the town, and conflicts in several of the suburbs. The principal bloodshed occurred this day and the rioting became organized.

Finally three regiments of Cossacks dispersed the mobs. Numerous arrests were made, including forty Christians.

There was no renewal of fighting on Monday. Instead, the rabble, dividing into small parties, plundered stores and houses where they could evade the military, and committed several murders.

Tuesday and Wednesday looting and outrages continued.

The regular garrison of three infantry regiments has been reinforced by a battery of artillery and a detachment of dragoons.

Cossacks Turn Robbers.

Two Jews were attacked and robbed yesterday in the outskirts of Lodz by a band of men, among whom evidently were Cossacks, one of the victims managing to tear off a portion of a Cossack uniform.

Cossack brutality is provoking intense anger all over.

The leaders of the Russians had planned the massacre on the lines of the Kishineff slaughter. Several arrests were made simultaneously. They closed in on the hapless Jews from all sides, drove them into the public square and there cut down all who had escaped the first assault.

The mob raised the cry of: "Kill! Kill! Let none escape!"

The Jews turned and fought dearly for their lives. Their resistance astonished the mob.

The leaders of two of the attacking forces are reported to have been shot down and the men they led were routed.

The Jews, however, were outnumbered and were attacked by mobs coming from opposite directions. They swarmed in on the fighting Jews, and shouting the cry of "Kill! Kill!" cut down their victims on every side. There was no quarter and there were many dead left on both sides.

To-day the Christians swear to take the lives of two Jews for every Christian who fell in the previous encounter.

Friends of the Jews telegraphed to St. Petersburg and it is said that an answer has been received that troops have been sent to Zhitomis as well as to Kishineff.

The following letter has been received by Narcisse Leven, president Alliance Israelite Universelle, Paris, to M. Nissim Behar:—

"Paris, April 24, 1905.

"The Czar has decided to establish a National Assembly which will very likely formulate a plan for the institution of a representative body. What this will lead to no one can tell. At any rate it is a turning point in the history of Russia.

"The Liberals aim at giving the named Assembly the power to make laws. The Czar seems determined to keep this power for himself. What concerns us most is that our brethren should not be excluded from such an Assembly, and that their representation in it shall be in proportion to their number.

"It is discouraging to find that our Russian brethren are excluded from the three organizations, namely, the corporations, municipal councils and zemstvos, which will elect delegates to the projected Assembly. Although some vague promises have been made to better the condition of Russian Jews, the assurances came not from the government; they were only suggestions from one or two ministers.

"While the demands for equal rights in Russia come from all quarters, including Jewish, there is not a sign that the government intends to recognize the Jews as entitled to any representation. It appears that Russia views even her Mussulman subjects as entitled to representation in the Commission.

"Some Russian papers, also, claim equal rights for all Jews, but their voice is ignored by the authorities. The Russian government, however, does heed the foreign press, especially does it pay attention to the public opinion of the United States.

"The point at issue is this:—Will five or six millions of Russian Jews be represented or not in the projected Commission? The American press need not treat this matter as a Jewish question. It can plead for the equality of all Russians, and, at the same time, point to the Jews, who, being the most ill-treated, cannot humanely be ignored by the Russian government.

"The American press has done much in advocating the free admission of American Jews in Russia; but this cause, which concerns the welfare of more than half of our persecuted co-religionists, deserves much more the attention and kind consideration of the American influential press."

Hodge, of New York City, will give a lecture on "The Manners and Customs of Ancient Israel." On July 20 Dr. Hodge will lecture on "Manual Methods of Sunday School Teaching." These lectures will be followed by a teachers' round table conference. On July 21 there will be held an educational symposium, the discussion to be led by a rabbi, a teacher and parent, thus presenting the different phases of the religious school problem. Israel Gollancz, the eminent Shakespearean scholar of London, England, and the editor of "The Temple Shakespeare," will be the speaker at an authors' conference, to be held on Sunday morning, July 16. Such well known authors as Abraham Cahan, of New York, and Rev. Dr. David Philipson, of Cincinnati, will also participate in the conference.

Shevuoth--Feast of Weeks.

MY DEAR CHILDREN:

On Friday and Saturday of next week we have *Shevuoth* or the Feast of Weeks. You will remember that on the fiftieth day of the *Omer*, that is seven weeks and one day from the second day of *Passover* we Jews celebrate this beautiful festival. The date is the sixth and seventh of Sivan.

Shevuoth, in the first place, is "the feast of harvest," *Hak Hakotzir*, as it is written in *Exod. xxiii, 16*. "And the feast of the harvest, of the first fruits of thy labors which thou hast sown in thy field, especially of the wheat and the day of the first fruit offering" *Yom Habikurim* as we are told in *Numbers XXVIII, 26*. "And on the day of the first fruits, when ye bring a new wheat offering unto the Lord after your weeks are out, shall ye have a holy convocation: no service work shall ye do." The first sacrifice of the new corn was offered in the temple: "the bread of the first fruit" which was to serve as an expression of our gratitude for the blessing of the harvest. Since the destruction of the temple in Jerusalem we have no longer any sacrifices. We decorate our synagogues and houses with flowers and plants in order that the sight of those beautiful objects might awaken and strengthen our feeling of gratitude toward the Almighty for his loving kindness. Each one of the plants and flowers show God's wisdom, power and goodness.

There is another significance to the Feast of Weeks, the observance of which we are commanded in *Deuteronomy XVII, 10*, "And thou shalt keep the feast of weeks unto the Lord thy God with a tribute of a free will offering of thy hand, which thou shalt give: according as the Lord thy God shall have blessed thee." It also commemorates the giving of the *Torah* by God on Mount Sinai. It is therefore called "the season of the giving of our Law," *Zeman Mattan Toroseu*. The Children of Israel were in the wilderness and when they came before Mount Sinai God decided to give them His law, and so Moses went up Mount Sinai and received from the Almighty the eternal precepts known as the Ten Commandments.

Three days before this great event the Children of Israel had to prepare themselves for it. As we are told in *Exod. xix*. These days are called "the three days of bordering," *shloshes yemey hagbolah*.

As *Passover* has been practically called the day of Israel's betrothal to

God, the Feast of Weeks corresponds to the wedding-day, and the counting of the *Omer*, therefore, not only connects the two harvest feasts, but also pictures the longing of a bride for the day on which she is to be completely happy, which means the Children of Israel were eager to receive the word of God which would complete the work of their freedom from slavery. You will thus see that liberty without faith and belief in God, freedom without observance of the highest law is impossible. The Children of Israel had been freed, but they were still without the *Torah*, and were therefore, incomplete. The Festival of *Shevuoth* completed everything, and henceforth, the Jews because of the *Torah* which was given them, were to be for all ages, the teachers of truth, righteousness and morality.

JEWISH WORLD.

Continued from page 2.

The fine new edifice of the McKeesport, Pa., Austro-Hungarian Hebrew congregation, Gemulas Chesed, erected at the corner of Market street and Third avenue, McKeesport, at a cost of \$85,000, was dedicated Sunday, May 28. It is one of the finest synagogues in this section of the country. The congregation was formed in McKeesport October 11, 1886, by a number of young men. It was originally a charity society for the protection of the many young Hebrews of the Tube City. Two years later Samuel Firestone, Henry Reiter, I. Firestone, Joseph Feldman, L. Kotz, Solomon Black, Joseph Kaufman, B. Reiter, Joseph Roth, B. Hoerr, A. Iskowitz, Samuel Farkas, I. Kronowitz, L. Kronowitz, Herman Sherman and B. Firestone applied for a charter, and for \$6,000 purchased a site for a synagogue at the corner of Market street and Third avenue, where a frame building was remodeled and used as a place of worship until last July, when the new synagogue was planned.

The congregation now has a membership of 275. To pay for the synagogue the members have agreed to contribute \$1.50 each week. The congregation also owns its own cemetery at Ellrod. Rev. E. Freed is the minister of the congregation and the officers are:—President, Saumel Firestone; vice-president, D. Greenwald; recording secretary, A. Bernstein; financial secretary, Samuel Farkas; treasurer, Fishel Brother. The committee in charge of the erection of the new synagogue was Samuel Firestone, Joseph Roth, David Rosenberg, M. Weiss, A. Freedman, A. Bernstein, Joseph Henlich, D. Greenwald and Joseph Goldberg.

The annual meeting of the J. M. Guskay Orphanage and Home, Pittsburg, Pa., was held on May 21 in the Home, with but a limited number of members in attendance. The reports of the president, secretary and treasurer were presented and showed that the condition of the institution is excellent.

The feature of the meeting was the resignation of the matron, Mrs. Goodman, to take effect as soon as a successor is appointed.

The election of officers concluded the business of the meeting. The old officers were re-elected unanimously:—President, Judge Cohen; vice-president, Charles Zugsmith, Jr.; secretary, A. M. Hast, and treasurer, I. E. Isaacs. There were five members to be elected on the board, and for the first time in many years a friendly contest took place. The following were elected:—Enoch Rauh, Morris Einstein, Louis Goldsmith, Jacques Well and Herman Hirsch.

Judge McDonough, of the Second District Court, Fall River, Mass., announced from the bench, the other day, that Hebrews who live in this city must not be persecuted, and in pursuit of his determination to put a stop to such practices he imposed heavy sentences upon those brought before him.

Judge McDonough said: "A peddler has as much right to go about the streets of our city as any other citizen. I have been trying for several years to inculcate this lesson into Fall River people. I am going to stop the persecution of this much persecuted race if I can. These boys are fined \$25 each."

At a meeting of the congregation of Anshe Polen of Warsaw, of Boston, Mass., in its synagogue on Harrison avenue, a committee was appointed to arrange plans for a new synagogue. Reports showed the finances of the congregation to be in good condition and prospects bright for the future.

Remarkable progress has been made by the Mt. Sinai Hospital, of Philadelphia, Pa., since its new building at Fifth and Wilder streets was dedicated early in March, and the physicians in the institution are kept busy every day with hundreds of patients. During the month of March 2,549 patients were treated in the different wards of the hospital. Last month there were more than 3,300. In the surgical ward 1,100 patients were treated, 702 in the eye ward, 395 in the medical, 278 in the children's, 260 in the gynecological, 139 in the accident, 112 in the nervous, 85 in the skin, 50 in the dental and 185 in the eye, ear and nose ward. Dr. J. L. Werner and Dr. S. I. Eber are the resident physicians at the new hospital.

Three thousand Jews have been wounded in the recent anti-Jewish riots in Russia. Three thousand Russian sailors have found their death in the terrible sea-fight between Togo and Rojstvensky. The swift punishment befits the crime.

It is very patriotic for Jewish merchants to close their business establishments on Decoration Day, but it would also be eminently proper for them to abstain from their ordinary pursuits on Jewish holidays as well. We have no patience with those patriotic Israelites who work on Yom Kippur but celebrate Labor Day.

Union of Forces.

והנו בני ישראל איש על פנתו ואיש על דגולו לצבאחם
"And the Children of Israel shall pitch their tents, every man by his own camp, and every man by his own standard, throughout their hosts—Numbers, 1. 53.

"UNION does everything when it is perfect. It satisfies desires, simplifies needs, forsoes the wishes, and becomes a constant fortune," is a dictum which amplifies our selected verse from this week's Sedrah. While the Children of Israel were divided into tribes, each of which had a special reservation, still all of them were united for the welfare of the people as a whole. One would not cross the boundaries nor infringe upon the rights and privileges of the other, but when the occasion demanded or the need arose there was presented to the outsider a solid front.

Israel to day is divided. In the east, and west, north and south, America and Russia, Germany and Australia, England and South Africa, and yet when danger threatens these different members of the house of Israel, all hands are joined ready to assist each other. In this city, on a smaller scale, it is a case of "every man by his own camp, and every man by his own standard," but "all for one and one for all." One section is interested in the educational progress of the community, another in dispensations of its bountiful charities, a third in the work among the young, and a fourth in the religious work of the synagogue and temple.

Each section labors along its own particular lines but if the work in which they are engaged is to be of permanent value, all must bear in mind the common good of the community. The synagogue, the school, the hospital, and the charity must labor for the promotion of the best interests of the people, and must not be a hindrance to each other. The work of the one must supplement that of the other. "The multitude which does not reduce itself to unity, is confusion," and it were well if this truth were borne in mind by those who preach an "up-town" and a "down-town," an "East Side" and a "West Side," who would divide this great community into two sections. Whenever Israel was united prosperity smiled upon the nation, but dissension and strife gave the enemy the desired opening, and Israel suffered. "Useless discord," say the sages, wrought the destruction of the Temple.

The Jews as a people have no country of their own to-day; and while they belong to themselves they belong equally to all countries and to all nations.

Union and harmony bring in their train peace and prosperity, and there can be no greater unity than that which binds man together for the glory of God and the welfare of His children.

David Lubin, an American Jew, has once more given evidence that our people are in the forefront of every great movement. In inducing the King of Italy to convene the International Conference on Agriculture, now in session in Rome, he has done a distinct service to mankind. The encomiums lavished upon Mr. Lubin by Minister Rava were fully deserved. Jews have reason to be proud of their co-religionist.

A Home for the Free Sons.

THE movement for the erection of headquarters for the Independent Order of Free Sons of Israel, is fast assuming shape and should commend itself to all the members of the district. In the metropolis alone the Order has a membership of 8,000, and its beneficent work could be better accomplished and with less loss of time if there existed a "local habitation" which sheltered it.

An Order, like the Free Sons, is primarily established for the interests of its own members and its success mainly depends upon the unity existing between them. Such "headquarters" as it is proposed to erect would foster the fraternal spirit and further the bonds of good fellowship among the Free Sons. Besides, the out-of-town members would know where they could meet their fellow-members and thus in every way would the Order be benefited by a central home.

There is, however, another aspect of this question, of which the membership should not lose sight. While the Order is a mutual benefit organization, it has been demonstrated by the endowment of a ward in the Mount Sinai Hospital, that it could take a more prominent part in the general communal activities by making their headquarters the centre from which all good work initiated under their auspices could emanate.

The Free Sons of Israel is growing by leaps and bounds. Its membership is recruited from among the best people in the community, and its future will be all the more brighter if the members are given a place where they can meet for social intercourse, for the exchange of ideas, and where they can unite in labors for the welfare of the whole House of Israel.

The Talmud Torah Association of Baltimore.

THAT the Torah is still studied "lishmah," "that is l'il'mod u'l'lamed lishmo v'la'asoth" to learn in order to teach, and to observe and practice its precepts, yea, even in America, is well illustrated by the work carried on by the Talmud Torah Association of Baltimore. Here a handful of devoted and observant Israelites are trying to foster the spirit of true Judaism.

The Talmud Torah Association meets under the auspices and in the rooms of the Shearith Israel Congregation of Baltimore, a congregation which undoubtedly holds a unique place among the others in this country. It is truly a "Shearith Israel," a remnant of Israel, a congregation composed of faithful Jews of all classes, who, recognizing the awful status of Judaism prevailing, have banded themselves together to counteract the materialistic and agnostic tendencies of the age, to scatter the clouds of ignorance veiling the heads of their brethren by shedding upon them the light of the Torah, and showing the world what true Judaism is by that best of lessons—example.

The object of the Talmud Torah Association is to foster the study of everything Jewish, and more particularly the Sacred Literature and Talmud, not as an art, not as an accomplishment, not as an expression of a would-be "patriotism," well styled "hurrah Judaism," which sayeth much but knoweth little and doeth still less, but in order to become better Jews in the sense of the Torah, in

order to serve God the better and the more.

With such an aim the sphere of its activity is by no means narrow as some might suppose; for indeed, how could it be? To the faithful Jew, Judaism is synonymous with life, and, therefore, in promoting the study of the Torah he draws upon all his experiences and every department of knowledge.

The president of the Association is Mr. Philip Gundesheimer, a well-known merchant of Baltimore, whose big department store is promptly closed by sunset on every Sabbath and Holy day eve and not opened until the stars are out on the day after. The members of the Association are men from all classes and walks of life—business people, students, working men, and all those who choose to come in. Prospective members are cordially invited.

The head and propelling force of the organization is the Rabbi of the Shearith Israel Congregation, Dr. S. Schaffer, an accomplished Biblical and Talmudic scholar, a pupil of the late Dr. Hildesheimer, of blessed memory and a graduate of the Berlin Rabbiner Seminar, a master of arts and doctor of philosophy of the University of Leipsic, and withal, a deep thinker, a good man, and a pious Jew who means what he says, and practises more than he preaches.

Dr. Schaffer lectures on the Mishnah and Gemarah, and conducts a special class in Mishna for the young men and the "uninitiated."

A new and very useful line of work has been instituted by Mr. David I. Macht, a graduate of the Johns Hopkins University, and at present a graduate student of medicine at the same institution. Mr. Macht also tries to live up to the title Jew in more than name, and with all his secular and professional studies, finds time for studying a "shiur" of Mishnayoth and Gemara and other Jewish subjects. He conducts a class in the Schulchan Aruch, with the object of practising its contents; he also lectures on the Tenach. Last year and the greater part of this he spent in the interpretation of the Book of Proverbs. Two years is by no means a long time for the task which he has undertaken to accomplish. In his interpretation of the Book he draws on almost every Jewish commentary and source of information within his reach, and strengthens his teaching by drawing on his store of philosophical and scientific knowledge. To him, there is no conflict between Torah and Science. To him, Torah is Truth, Science is Search for Truth; both support and strengthen each other. To him, all knowledge is "Da'as Kedo'shim," is knowledge of holy, divine things, because all things were created by God; and withal that he remembers that "the beginning of Wisdom is fear of God."

In order to reach the general public a course of popular lectures has been given from time to time. Last year these were on various subjects—religious, biographical, and literary—all tending to inculcate the proper knowledge of Judaism.

This year Mr. Macht has given a popular course of lectures on that subject which is so close to the heart of every Jew and Jewess—the prayer book. Mr. Macht treats the subject in a rather broad way, from various points of view—historical, philological, religious, philosophical, literary and even aesthetic—the object here again being not so much to load his hearers with a store of useless, dry, uninteresting information, but to give them a general view of the prayer-book, to call their attention to its beauty, to point out the vast num-

ber of deep thoughts and truths it contains, and in this way to try to make them feel its spirit, hence to make them better Jews by it.

Mr. David Blondheim, also a Johns Hopkins student, conducts another class, namely one in Hebrew Grammar, Jewish history, and modern Hebrew.

It may be remarked that neither Mr. Macht nor Mr. Blondheim, are much indebted to any would-be "antisemitic" professor of Semitics for their knowledge, but have either gotten it by their own efforts or from Jewish teachers.

Mr. E. Strauss, also gives "drush" from time to time to time.

The work of the Talmud Torah Association is not great but it points in the proper direction. It is needless to say, they need many more spirited workers who would also preach and teach what they believe and practice. Where can these be found? May the Lord give strength unto His people; may He bless them with peace!

LAST night Congregation Ahawath Cheed-Shaar Hashomayim celebrated the completion of twenty-five years' excellent service of the Rev. Theodore Guinsberg as Cantor of the Congregation.

Cantor Guinsberg is a familiar figure in the congregational life in New York City. A man of fine presence with a voice as clear as a bell, an enunciation so plain that every syllable receives a distinct expression, it is scarcely to be wondered that his congregation hold him in high esteem and have taken occasion to give expression of this sentiment in the manner above indicated.

Rev. Guinsberg was born on October 29, 1847, in Karlwarya, Poland. He received his education during his early years in Russia and later in Berlin. When he came to this country he was engaged for a time as Cantor in Hartford, Conn., and subsequently at Congregation Derech Emuno of this city. Twenty-five years ago he was elected Cantor of the Congregation with which he is now connected and where he is so well beloved that he bids well to remain for many years more.

Rev. Guinsberg is a man possessed of excellent social qualities and makes an agreeable companion. He has always taken a lively interest in affairs connected with the Cantors' Association, of which he was for a long time an active member.

THE MIRROR.

The happiest man on the East Side is Judge Goldfogle. I saw him the other day and his face was so suffused with happiness that I involuntarily congratulated him upon his approaching marriage.

He sternly denied the soft impeachment and told me that the reason for the smiles that wreathed his countenance was the fact, that his efforts for the last year and a half, demanding for American Jewish citizens equal rights for American citizens regardless of creed had attained their ripe fruition.

Never for a moment since he introduced a special bill in Congress urging that the State machinery be put in motion to prevent further interference with American Jews who desire to visit the Russian Empire, did Judge Goldfogle lag in his efforts.

Direct diplomatic relations were conducted by Secretary Hay, and in his work the Secretary of State had the sympathy of President Roosevelt.

I extend my congratulations to the learned Judge and hope to add to them, whenever he attains sufficient wisdom to select from his many fair admirers one who will increase his happiness by emigrating with him to the blessed State of Matrimony.

The Israelite some time since firmly resolved to adhere to a policy of unvarying courtesy toward its contemporaries, but the editor deliberately suspends this rule long enough to express the sincere hope that his co-religionists in New York City will find some way to pillory, hold up to public reprobation and otherwise adequately rebuke the anonymous editor who in a three-line paragraph of last week's Hebrew Standard couples the names of Nan Patterson and Rose Harriet Pastor.—Chicago Israelite.

I am at a loss to discover whether the susceptibilities of the sensitive editor of the *American Israelite* were wounded because my Chief compared Nan with Rose, or Pastor with Patterson.

They both became public nuisances in their insane desire for notoriety and were stench in the nostrils of respectable citizens.

If Rose Pastor had resolved to abandon her faith; her female friends whom she had so frequently and so solemnly warned against the folly and evils of mixed marriages and to link her fate with Mr. Stokes, it was her own business and the affair was only of such importance as to cause a passing ripple upon the placid surface of events.

When Rose went to Cleveland a flash-light scene of her sitting at the bench making cigars was taken, and her giddy talk heralded through the

length and breadth of journalistic yellowdom.

Had some poor Christian clerk or humble mechanic sought the hand of Rose Pastor, would she have surrendered herself and her religion with the same avidity for him as she did for Mr. Stokes, and would their beliefs have fused so easily and rapidly together without Mr. Stoke's millions in view?

I think the paragraph coupling their names together was true, trite and timely. I have pasted the *Israelite's* rebuke in my comic scrap-book for future reference.

My attention has been directed to the foregoing concluding paragraph of the Doxology as sung at the last annual Communication of the Grand Lodge of Masons recently held in this city.

"You lost money," said the third, the youngest one, turning to the first. "Your loss is certainly not of the smallest one: nowadays, money plays a very great part in life; with money everything is bought. Zionism the Only Remedy.

Editor, HEBREW STANDARD:

The situation in Russia as far as the Jews are concerned is, to put it mildly, very conflicting. One press despatch informs us "on the best authority" that our sorely-trying co-religionists are to be emancipated, while the very same cable brings the news of another terrible massacre, evidently instigated by the powers that be. Jewish soldiers are fighting their country's battles in the Far East and nevertheless they are treated as Pariahs and outcasts.

Within the last few weeks two hundred and fifty Jews have been killed and three thousand injured—and still we are told that there yet remains hope for the Russian Jew. I beg to differ. It is my belief that even if freedom would come to the whole of the Russian people tomorrow the Jew would still have to suffer from the antagonism of the non-Jewish population. It is asserted that the moujik in reality has no feeling of enmity against the Jew, but the small trader is absolutely inimically inclined toward the Jew. "Give a dog a bad name and you might as well hang him." For decades past it has been dinned in the ears of the populace that the Jew is an exploiter, that he hates his fatherland. Jewish blood lavishly shed in the Crimea, in the war with Turkey, and in the present conflict counts for nothing. Is it to be expected then that there can prevail any different opinion of the Jew?

I am very much afraid that the Jewish question can never be solved in Russia itself. The situation is too bad to admit of any permanent amelioration. There is but one solution, one remedy, and that is Zionism. Had our leaders, or those who posed as such until this great People's

Movement which was created in August 1897 deposed them, been less obstinate and paid more regard to the welfare of their own co-religionists twenty years ago, so much Jewish blood would not be wantonly shed today.

It is time that the Jewish people awakened and rallied round the White and Blue flag which proclaims liberty and freedom to the Jew all the world over.

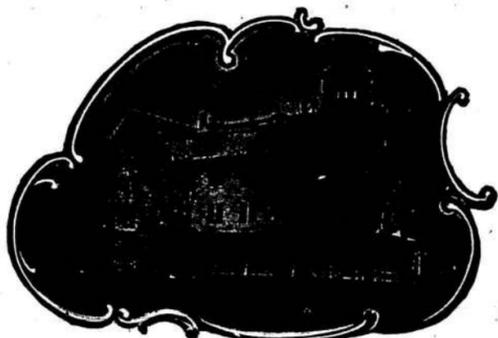

NEW JERSEY.

Jersey City.

The announcement that the Sons of Israel, a Jewish congregation without a present place of worship, has purchased a plot of land at 19 Cottage street, Hudson City, and proposes to erect thereon a synagogue, has caused more than a ripple of protest from the Christian residents of that quiet neighborhood.

Cottage street runs from Summit avenue right below the junction of Hoboken and Newark avenues, to the Hudson Boulevard. The Summit Avenue Baptist Church, which since the addition of a wing is L-shaped, extends to Cottage street. Between the Cottage street branch of the L and the plot said to have been purchased by the Jews there are two cottage-like houses. Between the proposed synagogue site and the Boulevard a great part of the property on the south side of the street is owned by Cylvanus Jud, an old resident of this city. There are about seven houses and three vacant lots and Mr. Jud's strip of land.

Mr. Jud rather reluctantly admitted today that his reason for objecting to the erection of the proposed place of worship was because of the fact that the congregation behind the scheme was composed of people of Jewish faith. He said, however, that he didn't think it was necessary for him to air his religious views.

"Yes, the Christians living on the street," he said, "oppose the erection of a synagogue. I don't suppose any of them would go into details and state for publication just what their reasons are. In a community so strongly Christian such an explanation might be considered unnecessary."

"Will any action be taken to forestall the erection of a synagogue?" was asked. Mr. Jud said something about being willing to purchase the property. According to his statement, it would be a rather difficult matter to tell how much he would be willing to spend to prevent the Jews from invading Cottage street.

It was learned from an authentic source to-day that the Jews who are interested in the Cottage street plot have become aware of Mr. Jud's anxiety and are perfectly willing to use it for the financial advancement of their building fund.

"We can build elsewhere in the neighborhood," said one of the sons of Israel, "but we have a grip on the Cottage street property and are going to shock the Christians with a nice Jewish synagogue, Saturday services, Yom Kippur, Rosh Hashonah and other things that will break the monotony of an old-fashioned byway. Cottage street is like Sleepy Hollow. We will awaken it with our religious zeal."

Louis Falk of 599 Summit avenue is president of the Sons of Israel. He said: "I am sorry for the Christians who object to us. But we've got the property and we're going to hold it."

Mr. Jud says nothing will be done at present to forestall the erection of a synagogue.

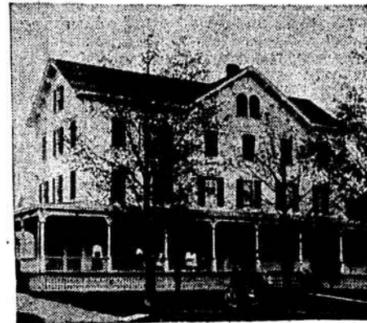

The Agricultural Conference.

ROME, May 28.—In the historic hall of the Capitol to-day King Victor Emmanuel and Queen Helena inaugurated the International Conference on Agriculture in the presence of the diplomatic corps and 150 delegates. David Lubin of California, who originated the idea, was a central figure of the gathering, and was especially complimented by Minister of Agriculture Rava in his address of greeting.

Signor Rava in the course of his speech declared that his Majesty had listened to a voice from distant America, the country of will and energy, addressed to him by a citizen who worshiped the idea that had made the conference possible; that of David Lubin, who felt the spiritual breath of Franklin and Washington.

The idea of the conference is to establish an office for the collection of statistics, and the dissemination of technical information, advice, etc., and to raise the institute to the dignity of an international parliament of agriculture, with effective legislative powers derived from all countries.

Mr. Lubin was visited by signatories, including Minister of Agriculture Rava and the British delegates, Lords Minto and Jersey.

The Jews in Bosnia.

Mr. Harry de Windt, in an article, "Through Bosnia," in the London Westminster Gazette, after referring to the Mohammedan and Christian population, says:—

The remainder are Jews—a Spanish branch of the race—whose ancestors fled here in the sixteenth century from the terrors of the Inquisition, and who still speak a kind of Spanish patois amongst themselves. Of late years thousands of German and Polish Israelites have invaded the towns of this province—so much so that the authorities contemplate restrictive measures—but from these the Spanish Jews keep strictly aloof—both commercially and socially—maintaining that they come of an infinitely superior stock. Moreover, while the new arrivals from Western Europe are universally detested, the Spaniards live in perfect harmony with the Christian and Mussulman population.

IN THE THEATRES.

American Passports Recognized.

A dispatch from St. Petersburg to the State Department says that the council of the empire has approved the recommendations of the passport commission. These include universal recognition of foreign passports, thus meeting the representations of the United States on the subject of discrimination against American Jews.

The Russian Government concedes to the United States that under the treaty of 1834, American Jews bearing passports issued by this government shall have unimpeded entrance and privilege to travel in Russia. It is believed that the journey of Mr. Hay to Europe had much to do with the early decision of the question.

From the Four Corners of the Earth.

The annual meeting of the Board of Trustees of the Hebrew Orphans' Home, of Atlanta, Ga., was held on May 14, the occasion also marking the sixteenth anniversary of the founding of the home. An entertainment was given by the children inmates of the home, followed by a banquet to the visiting members of the board by the local trustees.

The trustees were highly pleased with the efficient manner in which the home had been conducted during the past year and were loud in their praise of the superintendent and his assistants.

That the home was in splendid financial shape was shown by the treasurer's report, \$14,000 having been subscribed for its maintenance during the year. This home cares for the Hebrew orphans from five States—Georgia, North Carolina, South Carolina, Virginia and the District of Columbia.

The entertainment given by the children was held in the auditorium of the orphanage, which was literally packed with spectators.

Following the entertainment a delightful banquet was served. Hon Simon Wolf, of Washington, president of the Board of Trustees, acted as toastmaster.

The corner stone of the first Jewish Temple to be erected in the southwestern portion of St. Louis, Mo., was laid Thursday afternoon of last week under the auspices of the Masonic Grand Lodge of Missouri. The new house of worship at Flad and Spring avenues will be the home of the B'nai-El (the children of God), the only congregation of the Hebrew Church in South St. Louis, whose synagogue for the past thirty years has stood at the corner of Eleventh street and Chouteau avenue. A large crowd including the presidents and managers of the boards of directors of every congregation in the city and representatives from the Y. M. H. A. attended the exercises, which were conducted by Grand Master Judge Leroy B. Valliant. Other members of the grand lodge present were Louis Moller, acting Deputy Grand Master; William A. Hall, acting grand senior warden; Howard Watson, grand junior warden; Rev. George W. James, grand chaplain; Dr. Adam Fuhrmann, acting grand treasurer, and John R. Parson, grand

secretary. The Rev. Dr. Samuel Sale, rabbi of Shaare-Emeth, and Rev. Dr. Henry J. Messing, rabbi of the United Hebrew Congregation, were also present.

At the conclusion of the Masonic ceremonies Dr. Moritz Spitz, rabbi of the B'nai-El Congregation, made a brief address. He called attention to the fact that just half a century ago, in April, 1855, the corner stone of the congregation's first temple had been laid by John Hogan. "Let me remind you, friends," he continued, "ere we leave this sacred spot to-day, that the great, the chief purpose of this house which we are to erect here is to recall to our minds and to the minds of our children the fact that even as in the past our fathers had cause to say, 'Behold, the Guardian of Israel neither sleeps nor slumbers,' even so have we in the present, their descendants, every reason to believe that his guiding hand does not leave us unprotected, nor will he in his mercy forsake our children in the future. That is the corner stone of life, which, in all its dimensions, denotes faith, courage and hope; upon this corner stone is our souls eye riveted, for this is to be to us a 'house of God,' and this is to be to us 'a gate to heaven.' As you behold this corner stone, let me ask you to give it the sure foundation of your faith and trust, of your life's best and noblest part and of your soul's holiest aspiration. Remember the past, regard well the present and establish firmly your hopes for the future."

Nathan Stampfer, president of the B'nai-El Congregation, presented the silver trowel to Grand Master Valliant, and Sigmund Stampfer, chairman of the Committee on Arrangements, deposited a box in the corner stone containing a roster of the members of the present congregation, with a list of the church officers, societies and committees, and the names of the architect and contractor, a printed by-law of 1871, containing the names of most of the members composing the original congregation; a copy of all the current daily and weekly papers published in St. Louis, and the different coins of the realm.

One of the most interested spectators at the ceremonies yesterday was Isaac Baer, the oldest living member, and

former president of the B'nai-El Congregation. Mr. Baer became a member the year it was founded, in 1853. The first temple stood at Sixth and Cerre streets for about twenty years, when a second synagogue was erected at Eleventh street and Chouteau avenue. This was sold about a year ago, since which time the meetings have been held in one of the Protestant churches. The new temple at Flad and Spring avenues will cost about \$60,000 and Architect J. L. Wees hopes to have it completed by September 15.

The present officers of the congregation are Sigmund Stamper, president; S. Steiner, vice-president; H. Kohner, secretary; Sol Bondi, treasurer; Max Weil, chairman of the school board; J. Walstein, temple warden; B. Loebner, cemetery warden, and Sol Stamper, sexton.

The eminent author and Hebrew scholar, Herr Salomon Buber, of Lemberg, Austria-Hungary, has been honored with the title of Imperial Councillor. Though known chiefly for his literary work, Herr Buber takes a very prominent part in the administration of important commercial and financial corporations and of the Jewish communal and philanthropic organizations.

M. Dubief, French Minister of Commerce, replying at Lille recently to an address presented to him by the Grand Rabbis on behalf of the Jewish community, gave the assurance that the Jews might count on the goodwill and sense of justice of the Government.

The Academie Francaise has awarded a prize of 500 francs from the Saintour Trust to M. Jacob Trelat for his essays, "The Old Testament and the French Language of the Middle Ages," and "The Biblical Element in the Poetical Work of Agrippa of Aubigne."

King Edward, of England, has conferred the Royal Victorian Order, 5th Class, on M. Gustave Daltruff, Assistant Commissary of Police in Paris.

Heer M. A. Groenewoudt, Chief Constable of Amsterdam, completed recently twenty-five years of service in the police.

A committee of Italian scholars has been formed to celebrate next year the seventieth birthday of the distinguished Professor of Criminal Anthropology, Cesare Lombroso.

Carpenter's Strokes to Drive a Nail. How many hammer strokes does a carpenter use in driving a nail? Perhaps not one carpenter in a thousand or one layman in ten times that number can tell or ever think of it. The truth of the matter is this: The carpenter takes seven strokes in driving a nail into ordinary wood and twelve regular strokes and two finishing taps in driving nails into hard wood.

These figures are furnished by a man who works at night and sleeps—or tries to sleep—by day and whose bedroom window opens out upon a flat building in course of erection. He figured the average number of hammer strokes for nine mornings and, having learned them, moved to a hotel until the new building is completed.

He discovered that the carpenter drives an average of three nails a minute in soft wood and a fraction under three in hard wood. At this rate he would drive 1,440 nails a day in soft wood if he keeps up the gait steadily and 1,282 in hard wood. He would give 10,080 hammer strokes in soft wood and 20,160 in hard wood.—Chicago Tribune.

Popular Names Abroad.

Numerous as are the members of the Smith family, they do not occupy as prominent a place in European directories as they do in those of England or at home, though they take up much room in the Berlin directory, 5,000 Schmidts being registered. They have to give room, however, to the Schultzes and Mullers. In Brussels the Janssen family is the most numerously represented, while the greater space in the Paris directory is given over to the Martinets.

Morelli and Vitelli are the names most numerous in Naples, and here the Smiths sink into significance; but, like the word "hello," the name of Smith is heard around the world and is represented in practically every directory published, more than may be said of any other surname, whatever its nationality.

England's Round Tree.

The heart of England is a sturdy member that throbs responsive to every call of duty. That, indeed, is not common to England, but is a heritage of every land where the love of country is deep in the breast of man. But the real heart of England—its exact geographical center—is altogether another proposition. So far from being occupied by patriotic sentiment, a tree exactly fills the space. It is called Round Tree and is both a picturesque and distinguished growth. Cold stone might mark the spot, but this living monument which greens as the snow melts is much more fitting. This ancient oak typifies the national strength, and the associations attached to it thickly as leaves in midsummer make it a thing of affection and veneration.

False Dice.

The following passage explains the various methods of cheating at dice in the Elizabethan era so well that I transcribe it in full for the benefit of commentators on old plays, etc., says a correspondent of London Notes and Queries. "What false dice use they? as dice stopped up with quicksilver and heares, dice of vantage, flattes, gourdes to chop and chaunge when they lyste, to lette the trowe dice fall under the table, and so take up the false, and if they be true dice, what shyfte will they make to set ye one of them with slyding, with cogging, with foysting, with coytage, as they call it."—Ascham's "Toxophilus," 1545.

Didn't Have to Pay Rent.

This is said to be how William Waldorf Astor gave the order for the fine offices built for the Pall Mall-Gazette: Mr. Astor was signing checks one morning and was informed that one of them was for office rent. He laid down his pen and remarked: "Well, I must pay taxes and other expenses, but I need not pay rent. If it pays another man to erect a building and rent it to me, then it will pay me. Now," turning to his right hand man, "make arrangements for new offices. I don't want to hear anything more about it for a year." And so the offices were built.

What the Zionists are Doing.

The Greater Actions Committee of the Zionist Movement met in Vienna during the week of May 21. There were present representatives from all countries and the proceedings lasted until Thursday, May 25. From advices received in this country it appears that it was decided that the Zionists all undertake active colonization in Palestine. After studying the report of the committee sent to East Africa, only a resolution was adopted to the effect that it is impossible to recommend carrying out the Uganda colonization plan, and invites the Zionist congress to express deep thanks for Great Britain's offer to help the Jews.

As to the leadership, the committee decided that it be left for the movement to appoint a triumvirate and Dr. Max Nordau, of Paris, Herr David Wolfsohn, of Cologne, President of the Jewish Colonial Trust, and Prof. O. Warburg, of Berlin, will be recommended to congress.

The Anglo-Palestine Company, Ltd.—This Company (a branch of the Zionist movement), with a subscribed capital of £39,195 in fully paid £1 shares, has issued its balance-sheet for 1904. The profits in 1904 were £331, which went to meet the balance at debit of £315 for the preceding year. Most of the Company's capital (£21,892) is invested in shares of the Jewish Colonial Trust. Land purchases were made in Palestine to the amount of £2,163. The cost of the El Arish Expedition was £3,888.

At the annual meeting of the Philadelphia Zion Society, on May 21, at 1325 Columbia avenue, the following officers were elected: President, Dr. Benjamin L. Singer; vice-president, Dr. Albert Bernheim; secretary, Joseph Sternberger; treasurer, Henrich Rosenbaum; representative to the International Zionist Congress at Basle, Switzerland, William Morris; delegates to the convention of the American Federation of Zionists, to be held in this city June 18, 19 and 20, 1905, the Rev. Julius H. Greenstone, Dr. Albert Bernheim, Dr. Herman Bray and William Morris; alternates, H. Rosenbaum, M. Schlesinger, J. Wernberger and A. A. Dembitz.

A meeting of the Oakland, Cal., Carmel Zionist Society was held in the Synagogue on Harrison street, that city, on Sunday, May 14. Mr. M. Jonas the president, welcomed a delegation of San Francisco Zionists, consisting of Rev. M. S. Levy, Mr. Fisher, Mr. Magnus, S. Goldstein and B. Kahn. Mr. Jonas read a paper in which he showed that Zionism was a movement which he believed would cure all the ills of existing society both political and economical. Rabbi M. S. Levy delivered an address in which he stated that, although he did not think that Zionism would do all that Mr. Jonas claimed, still he considered that it would do a great deal for the oppressed of our people, and although its medium would arouse a spirit of patriotism, not only to the Jewish faith, but also to the race, and would be the means of preventing inter-marriage. Dr. Levy closed his address with an appeal to the Jews of Oakland to join in the movement, and amidst applause he announced that the Oakland society during the evening doubled its membership.

Recently the Rev. Dr. J. L. Magnes, of Temple Israel, Brooklyn, secretary of the Federation of American Zionists, delivered an address on Zionism at the Brooklyn Institute Art Gallery. Referring to the movement to resettle the Jew in Palestine, the Brooklyn Union says: "There is no doubt that should this magnificent dream ever be realized a great, prosperous and progressive nation, with its roots extending into far antiquity, and its branches reaching into futurity, would be seen. But the influence of the Jews in developing commerce and useful arts would be missed in more than one land should the exodus to the new promised land be general."

A Zionist society has been organized at Harvard University; the aims of this society are to promote the study of Jewish history and literature and to encourage friendly intercourse among the Jewish students of Harvard University.

A meeting of the Executive Committee of the Federation of American Zionists was held Sunday evening, May 28, at 354 Grand street, New York. There were present Mr. C. L. Sulsberger, in the chair; Messrs. Abel, Blaustein, Fromenson, Luria, Lipsky, Lieberman, Livingston, Lewin-Epstein, Dr. Radin, de Haas Morgenstern, of Cleveland; by invitation, and the secretary. Regrets were read from Dr. H. Friedenwald, and Messrs. Neaman and Kahanowitz.

A communication from Mr. Neaman was read, in which he suggested that, inasmuch as New York is the headquarters of the Federation, the members of the Executive Committee be elected from among those who are able to attend meetings and not according to districts.

The secretary reported that the main activity of the office, at present, was the work relating to the convention. To date fifty-four delegates' credentials had been received; also requests for twenty-one proxies. Possible delegates to congress were about twenty-four.

New societies were reported to have been formed and to have applied for affiliation in Terrell, Tex.; Lynchburg, Va.; B'nai Zion, Newark, N. J., and Shoshanas Zion, Hartford, Conn. The following old societies have applied for sub-charters:—Friends of Zion, Steelton, Pa.; Atereth and Achioth Atereth Zion, New York, and Young American Zionists of New York.

The following societies have been granted sub-charters since April 2:—Ansonia, Conn., Herzl Tiphereth Zion; Baltimore, Agudath B'nai Zion Ass'n; Boston, Mass., Honorable Knights of Zion and American Zion Band; Bellaire, O., Dr. Herzl Zion Society; Columbus, O., Daughters of Zion; Camden, N. J., Camden Zion Society; New York; Zionist Society of Columbia University, Students' Zionist League, B'nai Zion Association and Ahawath Zion.

Mr. Lewin-Epstein reported for the committee on the establishment of a branch of the Jewish Colonial Trust in this city.

Motion was made and carried that the Executive Committee announce that no action will be taken in the matter of the United Zionist installment moneys until the books of the United Zionists be turned over to the Federation, all attempts to secure these books in the past having proved unavailing.

Mr. Lewin-Epstein reported on the action of the Order B'rith Abraham at its recent convention in Baltimore. It was decided at this convention that a portion of ten cents per capita, devoted by the Order B'rith Abraham to benevolent purposes, be given to the Jewish National Fund.

Mr. S. Abel was appointed acting treasurer until the convention, in the absence of Mr. Lewin-Epstein in Europe.

"Dr. Herzl Zion Club No. 2" has been organized in Brooklyn. The Herzl clubs are composed of boys of twelve to sixteen years of age, and the meetings are conducted in Hebrew.

Mr. Barasch Pinchasson, who has done extensive propaganda for Zionism in Roumania and recently at Montreal, Canada, will speak in Yiddish on Friday evening, at the club-rooms of the B'nai and B'nai Zion Kadimah, 318 Broome street. The public is cordially invited.

A literary meeting will be held by the Atereth Zion on Saturday evening, June 3, at the B'nai and B'nai Zion Kadimah club-rooms, 318 Broome street. Members, as well as others, are requested to attend.

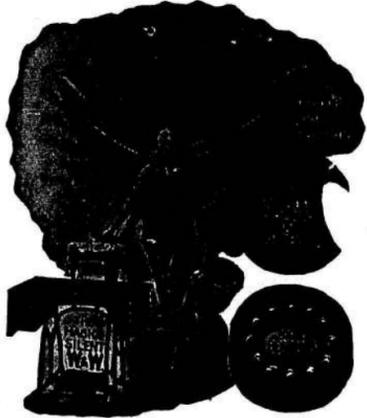
