THE POOR JEW.

A TERRIBLE fall wind raged in the stubble fields, tearing the blossoms shrubs and shaking the the ash-trees on the uneven road. The night veil descended on the cold earth and the sunball disappeared bashfully behind the dim clouds. Few red rays broke through the broad fog lighting the big windows of the white palace, majestically dominating the flat land, interrupted here and there only by few hills. In respectful distance stood the other buildings of the old counts' estate.

An old man fighting against the terrible wind walks towards the palace. With a heavy bundle on his shoulders and his long grey beard fluttering in the blast he makes very slow progress. With laborious breath he painfully peers anxiously into the twilight. Suddenly a light sparkles in one of the windows and a contented sigh escapes him.

"At last, at last!" mutter his frozen lips "at last in the neighborhood of human beings."

"I can not walk any farther and the wind is so wild to-day. It seems to be a large property? Perhaps there will be a little room for an old Jew.

With renewed energy he walks on.

Soon he stands at the entrance of the palace. Busy servants hurry with full pails to feed the cows, which impatiently tear at their chains, and the horses whinny and scrape the stone floors in their stables.

In the middle of the lawn stands the young count, in his hand a cane, giving orders in a powerful voice.

Trembling in every limb the old Jew enters through the gate; he does not see the scornful inscription on the gate; "Beggars and Jews not admitted."

With dragging steps he approaches the inspector, who is busy superintending the feeding of the cattle. The young count suddenly sees the tired,

vacillating appearance of the stranger. His face becomes red with anger.

"What brings this Jew on my farm. Did he not read the inscription on the gate. Inspector, "what means this?" Furiously he runs towards the Jew, his cane in hand.

The inspector hurries to lead the trembling old man out the gate.

In vain are the laments of the Jew. Kindly the inspector says: "I cannot help you, old man. The count is an anti-semitic, and if I were to harbor you here against his will, it would

cost me my position, which would help neither of us. "Go walk straight ahead," he continued in the darkness, there you will find people. In two hours you will easily reach the next village, where you can find a lodging. Here is something to pay for the

night's lodging, and he held out a coin. The old man did not take the money. A look of silent grief was in his face. "I don't beg," he murmured and walked away.

Darkness fell. Irresolute stood the old man near a lime tree.

"—In two hours I can reach people, here, here are none. In two hours."

Toilsomly he followed the wagon's tracks in the soft sand. "Only a moment I will rest here. The storm tires me so much."

Groaning he falls on the cold earth. Shivering he wraps himself in his thin clothing. Tired, sinks his head on his trembling knees, and the bundle slips from his shoulders. As the moon breaks through the gloomy clouds it reveals the strange figure cowering on the road.

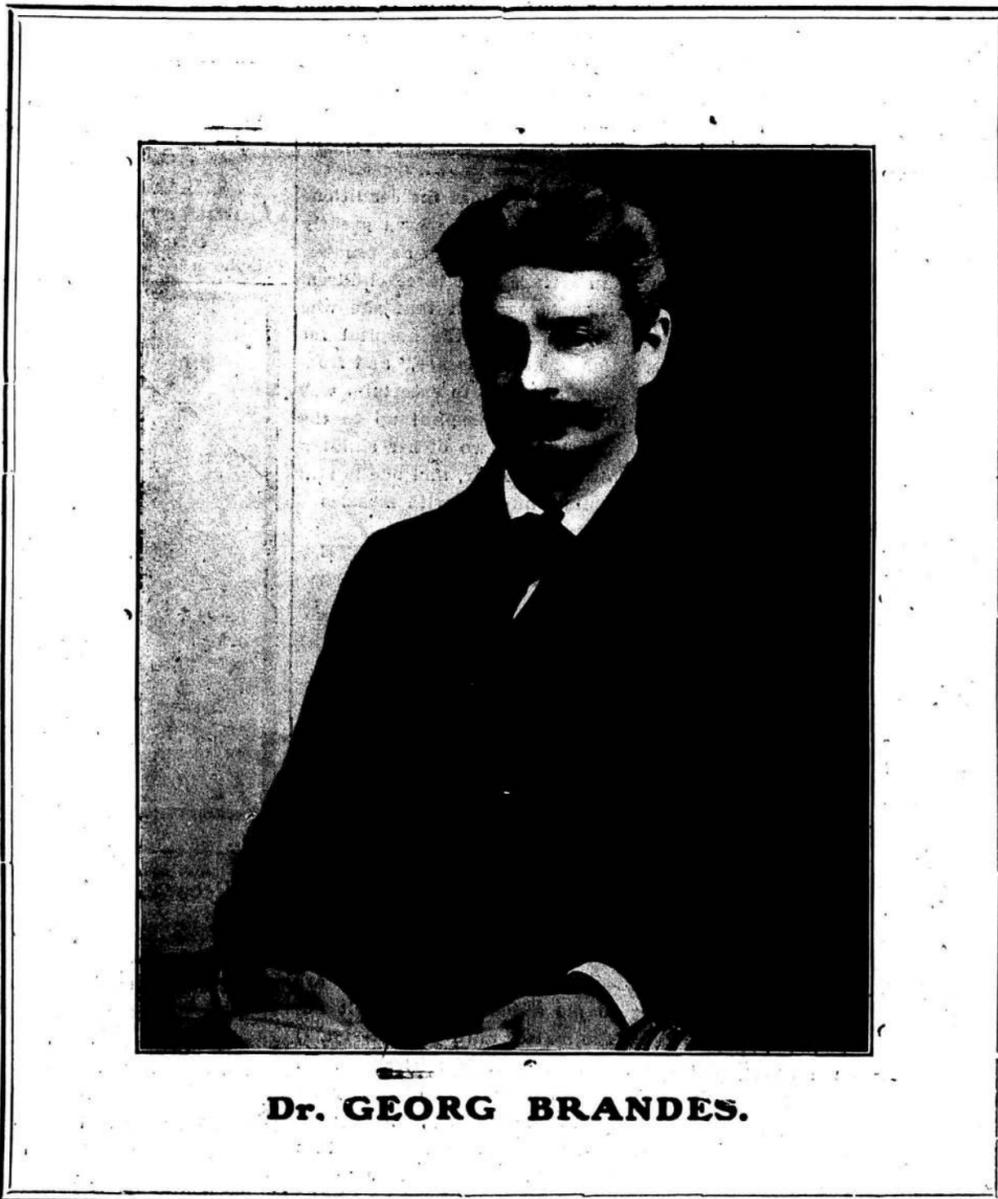
Two lights sparkle in the night; they are lanterns of a small hunting coach drawn by two brown horses, one of which snorting with fear and trembling stops, forcing the other horse to do likewise. The coachman cursing, grasps the bridle, but the horses refuse to go forward. He jumps from his seat to learn the cause. "Here lies a man," he calls to the indignant count "It is the Jew."

"He is drunk!" cries the count, getting nervous from the delay. "Put him on the edge of the ditch and drive ahead. We will surely be too late for the train."

The coachman does not answer. He is bending over the crouched figure. "He is dead," he says with emotion, after a pause.

"Dead?" asks the count, who feels uneasy. "It is irrational for an old man to travel in such cold weather, and especially by night. But we have nothing to do here now. To-morrow morning early you will come here to remove him, and now go ahead."

The coachman silently takes his seat and grasps his whip, and the horses drive away. Only the coach-dog remains near the dead body, whining and sniffing around. A shrill whistle from the coach far ahead, and the dog runs in haste to join his master.



Dr. GEORG BRANDES.

Dr. Georg Morris Cohen Brandes, to give him his full name, is the great Danish author and critic. He was born in Copenhagen, Denmark, on February 4, 1842. His reputation as a writer is worldwide, and he is rightly regarded as one of the greatest thinkers of the day. Brandes has written much, but his principal work is "Main Currents in Nineteenth Century Literature," which aroused an enormous opposition from the orthodox and reactionary, but gave him a large following, especially of younger and academic citizens, who understood of turning their thoughts into the universal currents. The numerous congratulations received by him on the occasion of his sixtieth birthday, in 1902, were ample testimony to the high regard in which he is held. In the same year he was created a professor by "royal patent conferring rank."

Immigration Troubles.

Complaint having been made to Hon. Simon Wolf, Chairman of the Board of Delegates on Civil Rights of the Union of American Hebrew Congregations, as to improper treatment of Jewish immigrants in New York, Mr. Wolf addressed himself to the Bureau of Immigration, as well as to the Department of Commerce and Labor, and received from the department copies of the correspondence had by the department with the Immigration Bureau, reading as follows:

DEPARTMENT OF COMMERCE AND LABOR, IMMIGRATION SERVICE.

Hon. F. P. Sargent, Commissioner-General of Immigration, Washington, D. C.
Sir: I have the honor to return herewith communication signed by E. H—, addressed to Hon. Simon Wolf, Washington, D. C., and forwarded under Bureau reference No. 49148 of August 23, 1905, in which I am instructed to submit a reply as to the allegations of the writer, Mr. H—. The record in this case was forwarded to the Bureau on August 5, 1905, our No. 32501. The Bureau's decision was made on August 7th, No. 49148. The facts as disclosed by the minutes are that this woman arrived here per S. S. "Finland" August 1st; destined to friends; possessed of something like the equivalent of \$12 United States money; accompanied by two small children, aged respectively 5 and 6; and in a pregnant condition. It is true that she stated that she had left her husband in Austria, and that his purpose in remaining behind was that he wished to harvest his crops before coming. It will be noticed that her father—M— W—, who appeared as a witness in her behalf, said, in giving a reason why she came without her husband, "One of my sons is to be married and I would like this daughter to be present at the wedding." This seems to have been given as an additional reason, but appellant herself apparently knew nothing of said additional reason. The case was heard on its merits, and the "Board of Special Inquiry" concluded that she and her children were persons who were likely to fall a charge on the public, and accordingly voted, two for her exclusion and one for her admission. The case was then made subject to appeal. I gave appellants a most patient hearing, and during the time they were in my office I observed that the children's faces were shockingly bleached by masses of running sores which caused me to send the children to the doctor's office, feeling as I did that the trouble had probably developed and made itself manifest subsequent to the original examination given them. Dr. Stoner personally came to me and said that, while the sores were undoubtedly contagious, they were due to a temporary ill-condition of the blood, but he did not regard the cause as being organic and thought that it would yield to treatment in due course of time. In view of this statement by the Surgeon-in-Charge, I made no reference to their physical appearance, but allowed the case to stand solely on the record made before the "Board of Special Inquiry." I then

thought that they should be deported. I have not since had any reason whatever to regard that as a mistaken view. I note that "mass meetings are likely to be held" with a view to calling attention to the mal-administration of this station, and the necessity for such a course is alleged to exist because of a case which is typical of a great many such cases occurring here, the same being the subject of a newspaper clipping attached to the communication in question. On reading this communication I sent for the representative of the United Hebrew Charities, who is daily present at Ellis Island, who has a corps of assistants, who is given access to all records and to all the detention rooms, and is given every facility and opportunity to communicate with the relatives and friends of aliens detained here, and I asked him what his view was of such a letter. He replied: "I do not identify myself with a single sentiment expressed therein, and as regards the newspaper clipping, I wish to state that at the time it appeared first I sent a copy of it to the president of the United Hebrew Charities, and shortly afterward—fearing that the society might misunderstand the matter—I wrote a letter to the president of the society, copy of which I should be glad to give you." (Copy attached.) I think the testimony of this official is entitled to far more credence by the Bureau than the remarkable and unworthy statements of E— H—. In view of the tendency of certain parties—residents of New York City—to cast aspersions on the official management of this station, I deem it necessary in this connection to refer to one or two similar cases. The same newspaper from which the enclosed clipping was taken, published an equally sensational article on Wednesday last, setting forth that a very pretty little woman and her two children were being arbitrarily deported because she was short of stature; that her husband had spent several hundred dollars in preparing a home for them, and had furnished it very neatly and comfortably—thus planning a great surprise for the wife and children; but that he was not permitted to enjoy the pleasures he had anticipated, the immigration authorities having ordered it otherwise. This particular case (that of C— S—) was also the subject of appeal, and the appeal was dismissed by the Department on August 19, letter No. 49248—eminently a proper decision in my opinion. The day following the publication of this article a responsible representative of the New York World was sent here by the management of that paper to ascertain whether there was any truth in these stories or whether that journal was being imposed upon. He was accompanied by two other reporters. I showed them the entire record from beginning to end, and took them personally to the detention quarters and gave them an ocular demonstration of this woman. They left this station, stating that the action taken by the immigration authorities was strictly in accordance with law and was certainly wholly warranted. The record in that particular case shows that not only did the husband and father not have any home provided for them, but that he had neither money nor habitation, for them. The Bureau is probably also aware that when a certain alien—Mrs. R—, was ordered on Bureau Warrant No. 49082 deported, that at the time this particular alien was placed on board ship the same newspaper published a sensational story that she was being torn from her husband and arbitrarily deported, but that a United States Judge

had prevented this miscarriage of justice by issuing a writ of habeas corpus, It will interest the Bureau no doubt to learn that the parties who were responsible for the issuance of that writ guaranteed to the Court and to all concerned that if this deportation were prevented that the charge for maintenance of said alien should in no sense become a public one; and thereupon she was placed in a private hospital, and philanthropic friends were appealed to to raise funds to keep her there. All of which went well for two weeks. These private funds have now failed and the very parties who took legal possession of this woman have now voluntarily returned her to this station, claiming that they can no longer be responsible for her. This case is the subject of an official communication sent to the Bureau to-day under another cover. I have digressed from the original and specific case sufficiently to indicate to the Bureau the tendency of things at Ellis Island. I characterize the letter of E— H—as untrue—absolutely and wholly. There is neither high-handedness nor irregularity practiced at this station, but a few people—including himself—seem to be sorely aggrieved because in the performance of my official duties I refuse to permit the practice of high-handedness and irregularity against the Government.

Fearing, however, that in sending this clipping, without a letter of comment, that my action might be construed as approving said article, which was far from my intention, and from my knowledge of the case, I am convinced that the conditions surrounding the case have been greatly exaggerated. The record is as follows: The woman arrived with three children, her condition being such that she was immediately placed in the hospital for "observation of heart disease," and from what I have been able to ascertain, was unable to leave the hospital up to the time of her death. Two of her children were admitted to father, and one is still in the hospital suffering with measles.

Sir: In referring to the letter of August 18th written by Mr. E— H— to Hon. orable Simon Wolf in reference to the alien F— K— and her children, I note that Mr. H— states that he had this woman in court upon habeas corpus proceedings before Judge Holt and that, on his statement there her relatives are willing to file a bond, Judge Holt adjourned the matter until August 31st. I think this statement is misleading. I was present in Court and distinctly remember that some attorney, whether Mr. H— or not I do not know, appeared for these aliens and stated that the attorney of record was out of town, that he desired to traverse the return, and for that reason asked that the hearing be adjourned; and for these reasons Judge Holt granted the adjournment. The adjournment was not taken because of the willingness of this woman's relatives to file a bond.

Reconverted to Judaism.

A correspondent of the Oesterreichische Wochenschrift (of Vienna) writes from St. Petersburg: Ever larger becomes the number of former Jews who avail themselves of the tolerant edict of the Czar in order repentantly to return to Judaism which they had abandoned. Among them is the well-known lawyer, Herr Kupernik, of Kieff, whose reputation extends far beyond the borders of Russia. The Jewish people may well be proud of this penitent son. During his forty years' connection with Christianity he always energetically exerted himself to serve the Jews, and in many trials affecting the Jews as a body, notably the trials arising out of the excesses at Homei, to defend the interests of the Jewish people. Another lawyer, Herr Bernstein, of Elisabethgrad, member of

the Odessa Chamber of Lawyers, who some years ago embraced the Protestant religion, has informed the Crown Rabbi that he has again become a Jew. In his letter he says: "I have never practised the prescribed ceremonies of the Protestant Church. On the other hand, I have not for a moment ceased to feel a Jew at heart and to share the spiritual life of my sorely-tried people." It is likewise interesting to notice that hundreds of Seventh Day Sabbath keepers, as well as other Judaized sects, are making use of the Czar's edict of April 30, 1905, officially to adopt the Jewish faith. Entire villages of such Judaized sects are to be found in the Government of Astrachan. The peasants in these villages are embracing Judaism in large numbers, and many are proceeding to Palestine, where they hope to obtain employment as day laborers in the Jewish colonies.

EUROPEAN STEAMSHIP AGENCY

From the Four Corners of the Earth.

A bill in equity has been filed at Mead, Pa., at the instance of Henry Menke and others, property owners of East Lansdowne, a new suburban town just outside of Philadelphia, against Wood, Harmon & Co., owners and agents of the tract, to have the court prevent them from selling or conveying any lots to negroes, Italians or Polish Jews.

This is a most extraordinary attempt to discriminate against the races, and there is likely to be some interesting testimony when the matter comes before the court for a hearing.

It is intimated that the larger lot-holders fear that the lots, being sold at low figures as they are, will bring an undesirable class of persons into the community.

A certificate of incorporation of the Hebrew Brothers' Association of Binghamton, N. Y., has been filed in the County Clerk's office.

The object of the association is to promote fraternal feeling and friendship, and the social, intellectual and religious welfare of the members and the Hebrew people residing in Broome County, to render voluntary aid and assistance to the relatives and family of deceased members and to render aid to any worthy and deserving member financially and otherwise. The directors are: Jacob Shulman, Max Shapiro, Benjamin Le Vene, Isaac Kilousky, Isaac Silverstein, Morris Citlen and Abram Feinblom.

Worcester, Mass., Jews must close their stores Sundays. The edict has gone forth from Police Headquarters.

Beginning on last Sunday the proprietor of every shop illegally kept open, will be summoned into court. The police say the Jews have had ample warning. Policeman John W. Reardon of Station 1, who patrols streets in which are many Hebrew shopkeepers has warned the dealers what to expect if they keep open to-morrow.

Indignation is expressed on every hand among the Jewish community. They claim that they keep their stores closed Saturday, which is their Sabbath. They figure that they will have only five days a week in which to do business if they

who, in the absence of Alderman Bromberg, acted as chairman.

The president, A. Tittebaum, then followed with a brief history of the society, which, starting three and one-half years ago with a capital of \$300, succeeded in purchasing the \$10,000 estate whereon the home stands, and this without having recourse to loans or mortgages.

The Hon. E. B. Callender said that it did not surprise him to be invited by a ladies' society, as he was always known to have been an advocate of woman suffrage.

Rabbi M. S. Margolies of the Baldwin Place Synagogue, Boston, Mass., and Rabbi S. H. Shohet, who donated the first dollar towards the fund and who travelled from New York for the direct purpose of being present at the dedication, spoke next.

The orator of the day was Dr. David Blaustein, superintendent of the Educational Alliance of New York.

"Two hundred and fifty years ago," he said, in the course of his remarks, "the Jews were permitted to settle in this country on condition that they take care of their own poor, and though this condition is not any longer contingent upon them, they faithfully kept their promise until now.

"Ninety per cent. of the Jews in America have come from small towns and villages, and there is no danger of their overcrowding our large cities, for no sooner do they become Americanized than they are found establishing communities all over this great and glorious country.

"But they must first live in large cities in order to learn the civic duties of citizenship, of which they have been deprived for many centuries.

"The spirit of the Boston Jews needs no other illustration than this building, erected by men and women who twelve or fifteen years ago were new arrivals to this country.

"They have learned the value of or-

ganized effort and the spirit of American institutions, and men whose mothers, wives and sisters are able to achieve such results as this home for aged Hebrews are sure to become good citizens of this glorious land."

Among those who spoke were also Leo J. Lyons, the editor of the Jewish Advocate; Rabbi S. J. Friederman and others.

The singing of Cantor M. M. Thilman and choir added to the solemnity of the occasion.

The officers of the Hebrew Ladies' Home for Aged Association are: Albert Tittebaum, president; Mrs. I. Shore, vice-president; Mrs. M. Markelson, treasurer; Miss Cella I. Blume, honorary secretary; Harris Koretz, financial secretary, and I. B. Reinherz, treasurer of the building fund.

Mrs. H. Gordon presides over the board of directors, and Alderman E. J. Bromberg is the chairman of the dedication committee.

The Jewish Consumptives' Relief Society.

After working for many weary months to raise funds for a suitable building, the Jewish Consumptives' Relief Sanatorium Association had its efforts crowned with success. On Sunday last the cornerstone of the new building was laid with all the impressive ceremonies usually attendant upon such an event. For the friends and supporters of the institution it was an event of the greatest importance.

At the present time the sanatorium is little more than a tent city. It is situated three-quarters of a mile west of the end of the Larimer car line on the Golden road. There are now in use some twenty-three Tucker tents, occupied by thirty-two patients, a tent library, a dining room and kitchen in one large tent and a large henry and stables. The present tent city will not be done away with after the main building is erected. It is the intention of the society to house most of the patients in tents, as it is believed that sleeping in semi-open air is more beneficial to consumptives than being shut in a house.

The new building will cost in the neighborhood of \$25,000 when completed. It will be built on the latest approved line of hospital architecture, with especial reference to the sanitation and ventilation of the building. The plans were prepared by George L. Bettcher, the architect.

WITTE GIVES ASSURANCE.

RUSSIAN ENVOY SAYS CONDITION OF RUSSIAN JEWS WILL BE AMELIORATED.—RECEIVES MESSRS. STRAUS, SELIGMAN AND KRAUS.—MASSACRES AT KERTSCH.—JEWISH BANKERS AND LOAN.

WITTE'S MESSAGE

(Dictated at the St. Regis Hotel by Minister Witte for the Evening World and translated by Samuel Feldman.)

I do not know what to say about the American people. I cannot say too much as to my admiration for them. I have been greatly impressed with everything I have seen during the short time I have been here.

There is one thing I want to say, and I want you to bear this message:

Tell the Russian Jews through your paper that I am greatly delighted at their behavior in this country. I am very much pleased at the way they are building themselves up. Tell them that, with the help of God, if there should happen to be any more disturbances and misunderstandings in Russia, they will soon pass away. Tell them that is my greeting, on the eve of my departure, to the Russian Jews of this country.

SERGE WITTE.

ANOTHER WITTE STATEMENT.

Sergius Witte, in a statement to the American, made on the steamer before he sailed, gave this message to the American people:

When I came to this country one of the things which interested me, secondarily only to the immediate matters in hand, was the condition of the Jews in the United States, and especially the Russian Jews. I could not leave my duties in Portsmouth, but my desire was so strong to discuss certain questions with representative Jewish gentlemen of the United States that I invited several of them to meet me in a conference at Portsmouth. They courteously acceded to my request.

That conference was enlightening and profitable to me, but the field of discussion was large and time pressing, and I requested that another meeting be arranged before my departure for Russia, and without regard to the outcome of the peace negotiations at Portsmouth.

In accordance with that arrangement I again met some of the Jewish gentlemen this morning. I should rather that they, who have a command of the English language and a better understanding of conditions, should speak with reference to what passed between us. We seemed to be in accord in many matters.

I cannot speak authoritatively, I can only express my wishes and hopes. If they are of interest to the American people, including the Jewish citizens, I shall say to them as a farewell message: I hope that my visit to America shall not be fruitless of results with regard to what I have learned about the Jews here, and the information I have obtained, which I shall make known to others.

I hope for a new era for the Jews in Russia, and to see them politically emancipated and participating in the Government. It takes time to change sentiment, and work political reforms in government, and regrettable things cannot always be foreseen or prevented.

But true reform does not suffer from such acts, and will finally triumph.

I hope for that speedy triumph and believe all others may join me in that hope.

MR. SELIGMAN'S STATEMENT.

Before sailing on Wednesday afternoon M. Witte, the Czar's peace plenipotentiary, gave unofficial but authoritative assurance that the condition of the Jews in Russia would be speedily ameliorated.

This information came through Mr. Isaac N. Seligman, who, with Oscar S. Straus and Adolf Kraus, of Chicago, held a conference with the Russian envoy at the St. Regis Hotel Wednesday morning.

Mr. Seligman, in speaking of the conference, expressed himself as in every way satisfied with the result. "M. Witte," said he, "allowed us to foresee the emancipation of the Jews in Russia, and their participation in the government of the empire in the same degree and proportion that other Russian subjects are allowed to participate.

"M. Witte made no official pledges engaging his government; he spoke for himself as an individual, but it is well known that while at present he is not in power, he soon will be. With him at the helm the Jews in Russia will again enjoy civic and national recognition. We have M. Witte's word for it that as far as he himself may be able everything will be done to give to the Jews of Russia their full constitutional rights. Discrimination prejudicial to them, the injustice of which he admits freely, will be ended, and they will be placed on an equal footing with the rest of the Czar's subjects." Mr. Seligman was asked if the subject of a loan to Russia, to be made by a syndicate of Jewish financiers, had been broached, but replied in the negative.

"The matter of a loan," he said in reply, "was not even suggested. M. Witte, at the time of our first conference with him at Portsmouth, had expressed a desire to confer with us further on the question of the persecution of Jews in Russia, and the visit Messrs. Straus, Kraus, and I paid him was in compliance with this expressed wish of his.

We continued the discussion of economical conditions in Russia where we had left off, citing inequalities in the laws and restrictions particularly affecting the Jews, and suggested their abolition and repeal. I may say that we left M. Witte impressed with the belief that the reforms urged by us will be put in effect and that at no very distant day the Jews of Russia will enjoy equal rights with all other Russian subjects."

TERRIBLE ATROCITY AT KERTSCH

A St. Petersburg dispatch says the atrocities of Kishineff were duplicated in Kertsch, a Crimean town, in fearful fashion.

Mobs plundered and destroyed property and burned houses in all directions. They beat, all Jews, men, women and children, until they fell insensible and bleeding in the streets.

One mob seized the 2-year-old son of a Jewish tradesman named Hirschmann and threw him into a bonfire they had made of Hirschmann's furniture. The helpless child was burned alive in sight of his parents. Many similar outrages are reported.

After three hours of terror sixty young Jews armed themselves with revolvers and made a stand to defend the Ghetto.

discuss plans for a large parade, and to adopt resolutions protesting against the massacres in Russia.

Abraham Cahan, who will act as chairman, said that he expected fully 50,000 persons to march in the parade.

In speaking of the massacres, Mr. Cahan added that, although peace had been declared between Russia and Japan, there was no peace in Russia itself. Mr. Cahan said he hoped that M. Witte, the Czar's chief peace envoy, would remain in the city to see the parade.

On Sunday a mass meeting will be held in Carnegie Hall, at which many prominent men will speak.

A PROTEST IN THE RUSSIAN CHURCH.

On Sunday morning, during the service at the Russian Church in East Ninety-seventh street, Miss Madge Doree, the Jewish authoress, walked the full length of the aisle and deposited at the foot of the sacred image on the altar and beside the astounded priest, copies of one of her works—an appeal for her persecuted race in Russia. The books were inscribed, in large handwriting, "To the Czar."

The congregation was amazed. There was a buzz of excited whispers. As she took her seat Miss Doree was questioned by an usher.

"They are good books that I placed there," she replied; "they won't hurt anybody. They will interest your master, the Czar."

Nicholas de Ladygenski, Russian Consul General in New York, said a few words to Miss Doree, reproving her and asking if she did not know it was a peace service.

"Peace?" she exclaimed, with spirit "There is no peace in Russia while the Jews are being slaughtered daily and the people are being oppressed."

THE B'NAI B'RITH.

WORK OF DISTRICT NO. 1.—AIDING IMMIGRANTS—THE WORK OF THE ADVANCEMENT COMMITTEE—THE SABBATH QUESTION—A NEW DEPARTURE—MASS MEETINGS—YOUNG LADIES' LEAGUE.

At its last session the Executive Committee of the B'nai B'rith officially took cognizance of the very important problem of aiding the United States officials at Ellis Island in determining which immigrants should be permitted to land and which come within the spirit of the inhibition of the immigration laws, and must for that reason be deported. A number of cases reported in the past six months have attracted a good deal of attention, for one reason or another, and the order has done well to interest itself in this work. It is hoped that the number of complaints will be smaller by reason of its efforts.

Our friend, Bro. Simon Wolf, in Washington has volunteered to look after all deserving cases when they reach him, and is ready to take them up with the Immigration Department directly. All information concerning these cases should be forwarded to the Executive Committee in this city.

The Hebrew Immigrant Aid Society, which has been doing excellent work on Ellis Island, is to be reorganized at its September meeting and an effort made to pool its interests with the B'nai B'rith on the subject of immigration. The idea cannot but be commended, as a union of effort is bound to result in greater good

27, and Horeb Lodge, No. 25, be advised to celebrate their golden jubilees in some appropriate manner, these celebrations to be made events in which the whole district is to assist in order that those still unacquainted with our work be awakened, interested, assimilated and brought into our ranks. These four celebrations in different parts of District No. 1, if properly and enthusiastically supported, ought to result in the re-awakening and rehabilitation of the Order in Buffalo and Boston—two of the weakest spots in our District, while Maccabee and Horeb Lodges ought to double their membership on these momentous occasions.

The Sabbath Observance League has long been on the lookout for the pernicious activities of those persons or bodies who have been leading Jewish youth away from Judaism. Brother Isidore Hershfield, a prominent member of the committee, has been gathering data on the subject and will at the next meeting present a plan for a mass meeting not only to protest against these activities but if possible to reach the fountain head of the evil and convince the men who finance these undertakings that their efforts are not only not appreciated but that the time has come when this kind of work among Jews in this city must cease.

Brother Jacob de Haas, a new member of the committee, is bending his energies on establishing a B'nai B'rith Congress or Circle which is to meet once a week at B'nai B'rith Headquarters, and to which members of the Order, regardless of lodge, are to be invited for the purpose of discussing Jewish problems in general as they arise from time to time. Some one or other is to lead in these discussions—which shall be open to all for participation. His final plan of this novel B'nai B'rith activity will be submitted to the General Committee for approval at its next meeting.

In order that sufficient time and care be given to the rounding out of the work of the year it is proposed to hold three or four great mass meetings in representative localities where B'nai B'rith orators and leaders are to expound the platform and principles of B'nai B'rith to that great section of New York Jewry which has hitherto kept aloof from our work and from the institutions we maintain. Every stratum of our population is to be looked after and cultivated at these meetings.

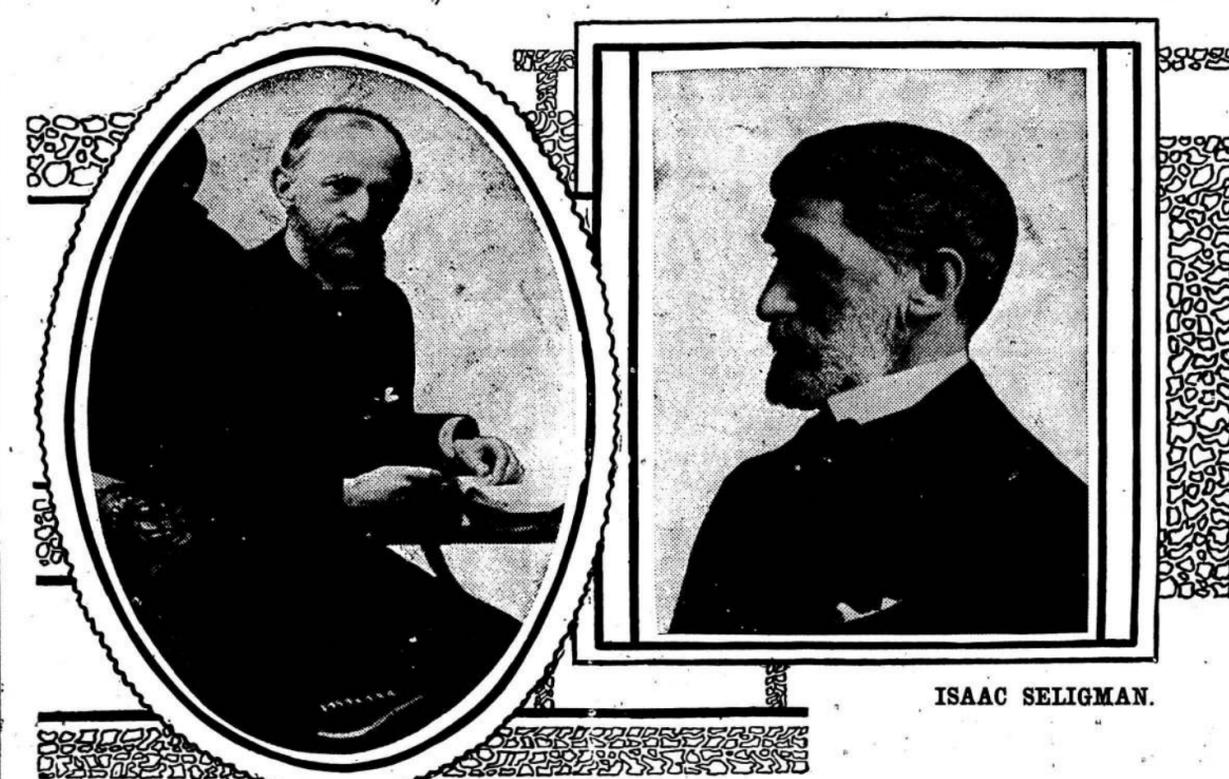

On September 19, at Clinton Hall, the members of Justice, Roumania and Harmonie Lodges are to join the new downtown lodge named after our great and lamented leader, Leo N. Levi. It is hoped that with the very able men in this new combined and united body the great dream of Leo N. Levi to create a great citadel of the Order on the East Side will be fulfilled.

Some members of Roosevelt Lodge will at the first meeting of that lodge try to commit its membership to the creation of a Jewish hospital in the new part of Brooklyn known as Brownsville. With its population of fifty thousand Jewish souls the idea is not only much to be commended, but ought to be made a reality. Here is to success to Roosevelt Lodge in this its first venture.

JEWISH BANKERS AND A RUSSIAN LOAN.

According to the Schlesische Zeitung, that the Jewish bankers of this country have promised to loan Russia \$200,000,000 had been made upon the express stipulation that the Russian Government would accord to the Hebrew subjects of the Czar the same civil and religious rights as those given to other Russian subjects, including the right of residing in any part of the Empire, whereas now they can live only in certain zones.

In reference to such a loan the Evening Post in its issue of Sept. 9 says:

Although tempting offers have been made to American bankers to bring out a Russian loan, the opposition of powerful Jewish firms has made it very difficult for any underwriting managers to secure the requisite support. A very powerful Hebrew banker said this week that the prejudice of the Jews against bringing out a Russian loan in this country was so great as to seriously injure the prestige of any Hebrew house that joined in such an undertaking. The objection, he added, was more than sentimental, and in spite of M. Witte's diplomatic moves in the direction of securing American support for the forthcoming offering by conciliating the interests in this country opposed to Russia, the Jews would not only have nothing to do with bringing out a loan here, but would see to it that no Jewish support of any sort was accorded.

Fall and Winter Programme.

The work of the association during the Summer months was confined largely to its vacation camp, though the building was constantly in use and a number of subordinate literary and athletic clubs held regular meetings. Most of these clubs also held outings, trolley rides and athletic field sports.

The vacation camp at Centreport, L. I., was an exceedingly busy centre. During the ten weeks of its duration over 400 young men were its guests. A great majority of them were members of the Y. M. H. A., but the privileges of the camp had been extended on equal terms to boys from the Educational Alliance, New Era Club and the Hebrew Technical Institute, and nearly one hundred availed themselves of this opportunity of spending their vacation amid Jewish surroundings. The camp is ideally situated, being directly on the waters of Huntington Bay, and have for a background the beautiful woods and meadowland of Northern Long Island. All healthful sports, such as bathing, boating, fishing, tennis, baseball, athletic games, rambles, etc., were freely indulged in, while the dining accommodations were equally satisfactory. On Friday evening religious services were held, as well as on Sabbath mornings, and though attendance was not made compulsory, a great majority of the boys took pride in attending the services. Jewish boys of every shade of belief and in every walk of life freely mingled together, and the excellent good feeling which prevailed was one of the most pleasing features of camp life.

With the onset of cooler weather the Fall and Winter plans of the association are fast maturing. The free educational classes will open on Monday, Sept. 18. From present indications the enrollment will exceed that of former years. The course of studies comprises bookkeeping and commercial arithmetic, stenography and typewriting, Spanish, French, German, Hebrew, Bible and Jewish literature, elocution, mechanical drawing, first aid, writing, correspondence and spelling. Some of the studies are so arranged as to enable students to pass the Regent's examinations. In all the classes special prizes are to be awarded at the end of the term for scholarship. The classes are free to all young men, irrespective of creed or membership in the association. An able corps of instructors has charge of this important branch of Y. M. H. A. work.

The religious work planned for the coming season includes Holy Day services for people unaffiliated with a synagogue and are maintained mainly for the benefit of young men. Free seats are provided for all members who apply, while a limited number are sold to the general public to help defray expenses. The services are conservative, and are conducted by a competent cantor, assisted by a choir of male voices. Rabbi Rudolph I. Coffee, former superintendent of the Hebrew Orphan Asylum, will preach the sermons. Mr. Coffee has been appointed to take entire charge of the religious work of the association. This comprises the Bible and Hebrew classes, Friday evening religious exercises and the Saturday afternoon services for children. He brings to the work a vast fund of enthusiasm, and his appointment will be pleasing to a large constituency.

The social work of the association will consist of entertainments, lectures and a number of plays to be performed by members of the Dramatic Society under the direction of a competent coach. The various literary societies will hold joint debates and a series of debates with other Young Men's Hebrew associations is to be projected. The regular semi-weekly lectures under the auspices of the Board of Education will likewise be held in the auditorium. Dr. Leipeizer is arranging an excellent course.

The gymnasium has been thoroughly overhauled and new applicants are registering daily. There are two divisions in the schoolboy afternoon class, junior boys ranging in age from 8 to 12 meeting on Monday and Wednesday afternoons, and senior boys over 12 on Tuesday and Thursday afternoons at 3.30 o'clock. The men's division meets on Monday and Thursday evenings, senior associates on Tuesday and Saturday evenings, and junior associates Wednesday evening and Sunday morning. A fencing club was in operation during the past few months and will be strengthened now

that the Winter months are approaching. A new camera club is being organized and amateur photographers are invited to join. The association has an excellent dark room thoroughly equipped. The library, which now contains over 9,000 volumes, will soon be enlarged by the addition of a new section of shelves capable of holding 5,000 additional volumes. The reading room is open daily from 9 a. m. to 10 p. m., except Saturdays, and is entirely free to the public. Visitors to the building are always welcome.

The present membership of the association reaches a total of 3,500, and new members are constantly enrolling. Young men are especially invited to join.

Young Women's Hebrew Association.

The speed class which has been in session during the summer months is about drawing to a close and the girls are all ready to accept positions.

Registration is now going on for classes in dressmaking, both shirtwaist making and drafting, stenography and typewriting, kosher cooking, Bible, Hebrew, English literature, piano, elocution, English, first aid to the injured, and physical culture.

The employment bureau has on file many applications of girls who desire positions as stenographers, bookkeepers, cashiers, salesladies, office assistants, nurses, and dressmakers. Any one wishing to employ them can secure the names and addresses at the association, 1534 Lexington avenue, or over the telephone, 2952-79.

The Emanu-El Brotherhood.

The Emanu-El Brotherhood consists of two organizations—the one the congregation, the other the auxiliary. Their work is progressing immensely, and will in the near future effect something in the practical sense of the word. After the last divine services at Volks Lyceum, 216-220 East Second street, an informal meeting was held, and Dr. Lipkind, the minister of the Brotherhood, spoke to the effect that the young men and young ladies of the East Side, especially those who attend the divine services every Friday evening, should band themselves together and demonstrate their spirit in the best way to the knowledge of the uptown people of Temple Emanu-El, who wish to erect a building in the settlement style with the co-operation of the East Side young folks.

Some members signified their intention of giving in their names. The Senior Auxiliary had a dance September 11, and will have a theatrical performance and ball at Murray Hill Lyceum on December 10.

Congregation Mickveh Israel of Harlem.

This congregation formed early last Spring and which has already held numerous services on Sabbath and festivals, is preparing specially solemn worship for the approaching holy days. For this purpose the commodious and attractive hall at 35-43 West 125th street has been obtained for the new year, the Penitential Sabbath and the Day of Atonement. The pulpit will be occupied as hitherto by the Rev. Henry S. Morais and the Rev. Philip H. Diamondstein, for many years cantor of the 114th street synagogue, will be the chazan. The services will be marked by decorum and melody, contributing to impress all, and, in particular, the rising generation. The preaching will be entirely in the English language. The congregation intends to continue services and to open a religious school.

The Albert Lucas Club Outing.

The Albert Lucas Club, a society of boys who are attendants of the Albert Lucas religious classes, and are under the direction of Mr. Walter H. V. Epstein, had an outing last Sunday at the Bronx Park. The day was a very beautiful one, and the boys enjoyed it immensely, particularly the rowing and the baseball game, in which they beat the Young Friendly Circle by a score of 5 to 3.

An Outspoken Attack.

The following letter was addressed to the Editor of the London Times by Mr. Lucien Wolf, the eminent Anglo-Jewish journalist and writer:

"THE BANKERS AND THE PEACE NEGOTIATIONS.

"Sir—The arrival of certain Jewish and other bankers on the scene of the peace negotiations at Portsmouth has not surprised me, for I knew as far back as two months ago that the financial aspects of the proposed treaty of peace were under discussion between the Russian Government and one of the Jewish houses mentioned in to-day's telegrams. From the moment, however, that I was made aware—imperfectly, it is true—of what was going on. I set my face against the negotiations, for I was, and am still, convinced that the plan favored by M. Witte will not prove acceptable to the Jewish people in Russia, that it will, on the contrary, seriously injure their cause and the larger cause of Russian Liberalism, and also that its effect will be to betray the investing public in Europe and America into a very dangerous speculation.

"The idea of M. Witte seems to be to assure the success of an indemnity loan by making certain concessions on the Jewish question, which will conciliate the Jewish bankers of the West. The bankers themselves are, no doubt, quite honest in thinking that an arrangement of the kind proposed will prove beneficial to their coreligionists, and they have, as I happen to know, been confirmed in this belief by certain of their financial colleagues in St. Petersburg and Moscow, who are, however, more anxious to serve the Russian Government than their own people, with the bulk of whom they are not in very close touch.

"But what are the facts? I have lately had occasion to confer with some of the leading men, both Jew and Christian, on the side of the Reformers, and I can say positively that they look upon the contemplated transaction with alarm. The Jewish question at the present moment cannot be separated from the general political question, and any attempt to separate it must prove disastrous for the whole cause of reform. It is true that it will produce in Russia the impression that the Liberals have been betrayed by the Jews, and thus a bitter discord will be introduced into the relations of the two parties. This trick is a very ingenious one and characteristically Russian. Its results would be that Russia would, for the moment, solve her financial difficulty and paralyze the reformers, while, so far from the Jews benefiting, the concessions made to them would be without any guarantees of permanence, and would, moreover, be completely neutralized by the increased anti-Semitism to which the separate treatment of the Jewish question would inevitably give rise. The Jews of Russia—those of the Pale of Settlement, at least—do not desire concessions of this kind. They are resolved to sink or swim with their Russian fellow citizens, with whom they have, during recent years, fought shoulder to shoulder in the general struggle for freedom.

"The transaction is also likely to be a bad one from the point of view of the investing public. One of the great difficulties in the way of a Russian loan at the present moment is that it is very widely felt that without a far-reaching reform of the Russian administration there can be no security for the solvency of the Russian Empire. Peace alone will not place Russian finances on a stable footing. Long before the war the financial administration was absolutely rotten, and if the system is to be pursued when the war is over, and when a very much larger debt will have to be

Russian Notes.

A Central News telegram from Odessa yesterday week states:

The Governor-General has forbidden the sale in this city of the Odesski Dnyl, a small weekly paper which made its appearance on the morrow of the late fatal disturbances here. The inhibited journal appeals directly to the worst fanatic passions of the people against the Jews. By specious and plausible arguments and allegations it professes to prove that the late emeute and massacre were directly attributable to the Jews. With more indisputable facts and figures it, shows that four-fifths of the whole trade of the southern capital are monopolized by the Jews to the detriment of the Russian population, and it is unfortunately difficult to dispute the charges leveled against the nefarious practices of a considerable portion of the Jews in trade and commerce. There is nothing, however, in the whole impeachment to warrant the Odesski Dnyl in exhorting the orthodox Russians to loot and burn Jewish property and expel the Jews by brute force. This inflammatory anti-Jewish organ is printed in Moscow with the imprimatur of the Moscow censor and policeman.

A Reuter telegram from St. Petersburg on Saturday states:

It is reported from Romny (Poltava) that the Hebrew population, resenting the performance of "The Merchant of Venice," boycotted the local theatre at which the piece was produced. The manager has now undertaken not to provide plays in which Hebrews are presented in what is considered as an unfavorable light.

Considerable alarm has been created among the Jews of St. Petersburg by the rumor that the rights of Jews, especially Jewish artisans, to live in St. Petersburg would be examined.

The Minister of Public Instruction has given directions to the University Authorities, in considering applications for admission from Jewish students, to give the preference to those whose previous applications could not be acceded to.

A Central News telegram from Odessa on the subject of the official friction between the Commander in Chief of the Southern Military Province and the Interim Governor-General says:

These official contretemps would be of little interest did they not occasionally lead to grave consequences to other persons. For example, two young Jews, named Halperin and Lappe, each aged twenty-five, and a Jewess, named Flalka, aged eighteen, were recently arraigned before the ordinary military tribunal, which is under the supreme jurisdiction of the Commander-in-Chief, for the manufacture of bombs. Halperin and Lappe were each sentenced to twenty years' hard labor, and the girl, Flalka, to thirteen years' hard labor. At the instance of the Governor-General, the military Crown Attorney has now intervened, demanding that the sentences be quashed and capital sentences be pronounced.

provided for, it is certain that national repudiation will only be a question of a few years. Hence if, by a transaction with the Jewish bankers, a great loan is now floated, not only will the cause of Russian freedom be shamefully betrayed, but the Western investing public will be deceived to their serious pecuniary hurt. I cannot believe that men like Mr. Oscar Straus and Mr. Jacob Schiff, whose unselfish devotion to the highest interests of humanity is so well known, will on reflection allow themselves to be inveigled into a transaction which must have such disastrous consequences.

"I trust it will not be imagined that I have any desire to put a spoke in the wheel of the peace negotiations. No one desires peace more earnestly than I do, but it would be far too dearly purchased at the cost of the freedom of the Russian people and of an eventful financial crash which would spread desolation throughout Europe.

THE long expected Jewish protector, is about to become a reality as our news columns this week bear witness. Land has already been bought, and ground will be broken very shortly.

It is high time that the community took care of its own delinquent children. The spectacle of Jewish

Meanwhile, he might write upon some other topics than Jewish. We would not take him seriously, but "eine Katze kann auch Schaden machen," and the irrepressible Dr. Singer is certainly becoming dangerous. He seems to delight in arousing the editorial wrath of the Sun, and whereas, he formerly worked single-handed, he now has Dr. I. K. Funk as a coadjutor. Between them they can do more mischief than half-a-dozen rabid Anti Semites.

We would like to point out to this "Trinity" that it is not a question of "race distinction," when protesting against anti-Jewish sentiment or against actions which smack of anti-Semitism. The American Jew can be just as good a citizen by remaining faithful to his religion as if he sought a Singerian combination of the Church and the Synagogue.

Further, the Jew votes as an American citizen and not as a Jew, for if he did, the Irish candidates on the East Side would be hopelessly snowed under.

We shall not discuss this matter any further, except to say that it is to be devoutly hoped that some one will speedily extinguish Dr. Singer, that Dr. Funk will return to the company of his "mediums", and that the editor of the Sun will recognize that however much his paper may gain by his attitude on Jewish affairs among a certain section of the population, all right-minded Americans will condemn him for his efforts to arouse a "Jewish Question."

FOR the first time in his political career a contestant for the leadership of the District has arisen against Julius Harburger. That he is doomed to an overwhelming defeat goes without saying. NEW SYNAGOGUES,

Jews from Boston, Malden, Chelsea and other surrounding points, to the number of about 3,500, attended the dedication of the new synagogue of the Congregation of Beth Israel on Faulkner street, Malden, Mass., on Aug. 27. Before the new edifice was opened a procession was formed, under the leadership of Max Quint, for a march to the old synagogue on Lombard street, from which the sacred scrolls were taken out to be carried to their new quarters, some of those in the procession bidding high for the privilege of carrying the precious parchments. When the new synagogue was reached the right to open the door was determined by auction. M. Lebedoff of this city securing the privilege by a bid of \$50. Inside the new building exercises were held, consisting of an address by Rabbi Bouchoff and short speeches by some of the prominent men of the city. The new synagogue was purchased from the Faulkner Methodist Society, which held its Sunday service in Mystic Hall.

One of the largest public ceremonies ever held in McKeesport, Pa., will take place Sunday, September 17, when the new synagogue of the Gemulas Chesed congregation, Third avenue and Market street, will be dedicated. Mayor Falkenstein, Select Councilman David Rosenberg and Superintendent J. B. Richey of the public schools are to deliver addresses. There will be visitors from Youngstown, O.; Pittsburg, Allegheny and surrounding towns. Rev. P. Friedman of Youngstown and Rabbi Michael Fried and Edward Steur of Pittsburg will also speak. The opening prayer will be delivered by Rabbi M. S. Sivitz of Pittsburg. The Ten Commandments will be placed in the ark by M. J. Janovitz of McKeesport. Miss Lucy Rosenberg will "light the holy fire."

Many other unusual features have been arranged by the committee in charge. The latter is headed by Joseph Heimlich, Chairman, and A. Burnstein, Secretary. The new church is one of the finest in the city and has cost about \$100,000. The rabbi is Rev. E. Fried, who has been in charge of the congregation for several years.

When the new Temple Israel of the Congregation Sherith Israel is consecrated on September 17 San Francisco, Cal. will have one of the handsomest edifices of worship in the United States. The new temple has a seating capacity of about 1,300, but it is safe to say that a great many more than this number will crowd into the synagogue on the eventful day of the consecration.

The new temple is located on the corner of California and Webster streets. It is built after the Roman style of architecture. The material is California sandstone. The vestibule and main staircase are built of Vermont white marble, while the interior finish is of mahogany. The decorations are Byzantine in style, being emblematic of the Jewish religion. Texts from the Old Testament also decorate the sides of the walls.

The cost of the new temple is about \$300,000. During the approaching holidays the atonement and Jewish new year, the faithful will worship in the new synagogue. Seats are to be allotted to members of the congregation on the coming Sunday.

The Jews of Hampton, Va., have leased rooms over the Hudgins block on Queen street and have had them tastefully fitted up for a synagogue. It is expected that a rabbi will be called here in the near future. Officers have been elected by the Hebrew Sunday school as follows: President, Mr. H. Tuckscherer; vice-president, Mr. B. Horwitz; secretary, Mr. S. Saunders; treasurer, Mr. J. Gold.

The contract for the erection of the new church for the Jewish congregation of Beth Israel, Stevens Point, Wis., has been let to W. H. Allen, who began the work of construction this week. The new building will be a one story structure of frame construction set on a stone foundation without basement. The main dimensions will be 30x50 feet. The roof will be surmounted by a dome. The plans were drawn by John Bukolt. The cost will run upwards of \$1,600. The building will be located on a lot on Water street, a little north of Owen Clark's residence, which was recently purchased of Mr. Clark.

Ahavas Achim Anske Radichowitz congregation, Rochester, N. Y., organized six months ago, dedicated its synagogue on Aug. 26. The building was formerly the True German Reformed Church. The rabbi is Herman Paley and the officers are as follows: President, Frank Sherman; vice-president, Samuel Peters; secretary, Bernard Eber; treasurer, Herman Meltzer; trustees, Lester Peters and Bela Peters.

The official opening of the new Hebrew synagogue on McCaul street, Toronto, Ont., the former New Richmond Methodist Church, will take place on Sunday, Sept. 24. The services will probably begin at 4 o'clock in the afternoon, continuing until midnight or later. Rev. Solomon Jacobs, Holy Blossom Synagogue, assisted by a rabbi from Boston, Mass., will conduct the opening services. The church is being thoroughly overhauled and renovated. The interior is being painted, electric lights installed and the roof repaired.

Underneath a large American flag and with imposing ceremonies, 2,000 members of the First Hungarian Jewish congregation, Agudah Achim, witnessed the laying of the cornerstone in their new temple at Marshfield avenue and West Polk street, Chicago, Ill., on Sept. 5.

The ceremony was preceded by a number of addresses and a musical programme by a juvenile band of twenty pieces from the Jewish Orphan Asylum. Among the speakers were Rabbi M. Fischer, who will be in charge of the new temple after its completion; Rabbi Julius Newman, Adolph Frisch and Rabbi Brodie. Mayor Dunne, Judge Mack and Samuel Alschuler, who were also scheduled to make short addresses, were unable to attend.

One feature of the ceremony was the plan in which the person who set the cornerstone was selected. Each member of the congregation was given a slip of paper upon which he wrote his name and the amount of the subscription he intended giving toward the new building.

When these slips were examined it was found Samuel Pitezlo had donated the largest sum of money. The other slips were left in the tin box which was set in the stone. A new hammer and trowel were then handed Mr. Pitezlo and, surrounded by the congregation, he placed the stone in position and filled in the crevices with mortar, while Rabbi Fischer offered up prayer.

The addresses were in German and in his opening address Dr. Fischer urged upon his hearers to support their church and reminding them that the Jew was the first one to teach the word of God.

It is expected the new building will be completed by Jan. 1. It will seat 1,500 persons and cost \$60,000.

NORTHAMPTON, Aug. 19.—The new Jewish synagogue in Bridge street, Northampton, Mass., was dedicated on August 22. The dedicatory service was entirely in English for the benefit of the outsiders who contributed to the fund for the remodeling of the building and who had been invited to attend.

The congregation of B'nai Israel has every reason to feel proud of its new home. The building, formerly the St. John's Episcopal church, but of late years used for a storehouse, has been remodeled throughout and presents a fine appearance. The old storehouse was for years an eyesore to that section of the otherwise beautiful Bridge street; the appearance of the new synagogue is a credit to any part of the city. The tall spire which for years was a landmark has been replaced by a yellow dome, characteristic of a synagogue. The interior of the remodeled building is beautiful. The walls are immaculately white and the ground glass windows with stained glass at the top give a pleasing and easy color to the light. The interior is finished in chestnut, the color blending finely with the general effect. The front entrance, up stone steps, is lighted with an arc lamp, shaded. Inside the double swing doors is a vestibule, roomy and well lighted, with open stairways leading to the gallery. From this, through the large entrance, one passes into the main auditorium. In front is a large open space, leading to the raised platform in the center, from which the rabbi reads the scrolls.

The gallery runs around about half of the main auditorium. Ordinarily it is

used exclusively for the women, although this custom is not always adhered to. On the west side of the gallery is the toilet room for women, while underneath on the main floor is the men's toilet. In the rear of the main auditorium, reached either through it or by a side entrance, is a room for social purposes, and in this the children's classes in Hebrew will be taught. Ranged along the sides of the main auditorium are two rows of pews, each seating about eight persons, this with the gallery giving the synagogue a capacity of about 400 seats.

The Northampton Jewish congregation has been in existence for several years and comprises about 40 families. For a long time meetings were held in a Pleasant street hall and in other places, but about a year ago some of the most active of the workers began to plan for a synagogue. The purchase of the building in Bridge street shortly followed, together with the raising of the money for its remodeling. The total cost of the lot and the rebuilding is in the neighborhood of \$10,000. The work was done by W. E. Stetson & Son, of this city.

The principal numbers on the programme of dedication were the report of the chairman of the building committee, A. W. Stone; the address of dedication, in English, by Rabbi Dr. Solomon Schindler of the Jewish Reformed Temple, Boston; prayers of the evening and the bringing in of the scrolls; addresses by Mayor T. M. Connor, Rev. J. C. Breaker of the Baptist Church, President G. W. Cable of the Home Culture Club, and Prof. Irving Wood of Smith College. The building committee, which has worked so indefatigably for the success of the affair, is: A. W. Stone, chairman; Meyer Michelman, E. Alberts, Max Michelman, B. August, A. Barger, S. Carlson, Isaac Michelman, and Louis Michelman. The chairman, Mr. Stone, is one of the pioneer Jewish settlers in Northampton. When he came here 18 years ago there were but three Hebrew families in this city, those of Simon Cohen, A. Sherwin and Peter Sobotsky.

A "Jewish" Anti-Semitic Leader.

Writing in the Washington Post, the Marquise de Fortenoy says:

A new leader has started up in Paris, with the avowed object of conducting a crusade against the Jews? This time it is not a converted Hebrew, like Drumont, or like Arthur Meyer, the disreputable editor and chief of the Paris newspaper, Gaulois, but a man of excellent family, the Vicomte de Bruc, who is the moving spirit of the agitation, which is of a purely social character, and which has in view a social boycott of the Jew. In an address which he delivered the other day to an audience composed of the cream of the Parisian aristocracy, he urged that every member of the Jewish race should be blackmailed by all the first-class clubs; that invitations to balls and dinner parties given by the Hebrew element should be sedulously consigned to the waste paper basket, and the Hebrew shops, Hebrew couturiers, and Hebrew modistes should be avoided by the fair sex.

The remarks of the noble viscount were greeted with much applause, and even enthusiasm, by the distinguished audience, prominent among which was Mme. de Martel, better known by her pen name of "Gyp," whose husband has just been fighting a duel on her account. But in spite of the good will and sympathy which those present manifested for the views proposed by M. de Bruc, I do not believe that there is the least probability of their being carried into effect. At least three of the leading couturiers, that is to say, men whose reputations in matters of feminine raiment are international, are Hebrews. The principal tradespeople of Paris, such as, for instance, the leading jewelers, the bric-a-brac dealers, etc., likewise belong to that race, while if one were to begin to boycott those members of French, and especially of Parisian, society who have Jewish affiliations or Hebrew blood in their veins, one would be compelled to ostracize more than two-thirds of the French aristocracy.

Without endeavoring to go into any elaborate statistics, and mentioning merely the first names that occur to me, there are the Dukes of Gramont, Richelieu, Brissat, Rivoli, de Broglie, Wagram, Polignac, Fitzjames, Elchingen, Talleyrand, de Castrices, and Decazes, as well as the Princes of Ligne, of Lusinge, and of Moskowa, besides hundreds of others who would all have to be barred by society on account of their Jewish family affiliations. In fact, were the proposals of Vicomte de Bruc to be carried into effect there would be virtually no society left, since the only portion of the French aristocracy that has maintained its lineage free from Hebrew matrimonial alliances is that of Brittany, which has always held aloof from Paris.

I would recommend to the Vicomte de Bruc a little anecdote which has a bearing upon his scheme. King Joseph of Portugal at one moment of his reign took it into his head to decree that all Jews should be expelled from his kingdom, and that all those who were of Jewish origin of descent, no matter how remote, should be forced to wear white hats. His prime minister, the famous Marquis de Pombal, a member of the illustrious Portuguese house of Carvalho, saw that it was useless to argue with the monarch when the latter commanded him to have the decrees prepared for his signature. But on the following day, when visiting the King, he brought with him a couple of white hats and put them on the table before him. The King at once asked what they were for. "They are for myself and also for your majesty," replied the marquis, thus recalling to the mind of his sovereign that the latter had always prided himself—just as the Kaiser and King Edward do to-day—on being descended from the same royal Jewish line as the Founder of Christianity, and on kingsmanship with the Messiah. That was the end of the anti-Hebrew decrees in Portugal.

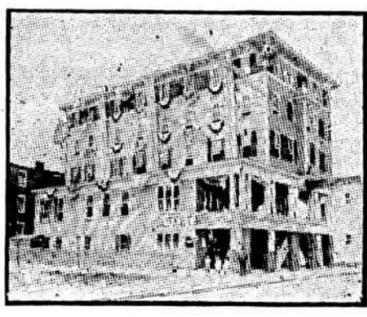

Resolved (if the assembly concur), that section one of article six of the constitution be amended by adding thereto the following provision: The legislature may from time to time increase the number of justices in any judicial district except that the number of justices in the first and second district or in any of the districts into which the second district may be divided, shall not be increased to exceed one justice for each eighty thousand, or fraction over forty thousand of the population thereof, as shown by the last state or federal census or enumeration, and except that the number of justices in any other district shall not be increased to exceed one justice for each sixty thousand or fraction over thirty-five thousand of the population thereof as shown by the last state or federal census or enumeration. The legislature may erect out of the second judicial district as now constituted, another judicial district and apportion the justices in office between the districts, and provide for the election of additional justices in the new district not exceeding the limit herein provided. § 2. Resolved (if the assembly concur), that the foregoing amendment be submitted to the people for approval at the general election to be held in the year nineteen hundred and five in accordance with the provisions of the Constitution of the State of New York.

Whereas, At the last session of the legislature, the following amendment was proposed in the senate and assembly, namely: Resolved (if the assembly concur), That the following amendment to the constitution be agreed to and referred to the legislature to be chosen at the next general election of senators: Section one, article twelve of the constitution is hereby amended to read as follows: It shall be the duty of the legislature to provide for the organization of cities and incorporated villages, and to restrict their power of taxation, assessment, borrowing money, contracting debts, and loaning their credit, so as to prevent abuses in assessments and in contracting debt by such municipal corporations; and the legislature may regulate and fix the wages or salaries, the hours of work or labor, and make provision for the protection, welfare and safety of persons employed by the state or by any county, city, town, village or other civil division of the state, or by any contractor or subcontractor performing work, labor or services for the state, or for any county, city, town, village or other civil division thereof. And Whereas, The said proposed amendment was agreed to by a majority of the members elected to each of the two houses of the said legislature, entered in the journals, with the yeas and nays taken thereon, and referred to the legislature to be chosen at the then next general election of senators. And Whereas, Such election has taken place and said proposed amendment was duly published for three months previous to the time of making such choice, in pursuance of the provisions of article fourteen, section one of the constitution; therefore, Resolved (if the assembly concur), That the foregoing amendment be submitted to the people for approval at the general election to be held in the year nineteen hundred and five, in accordance with the provisions of the election law.

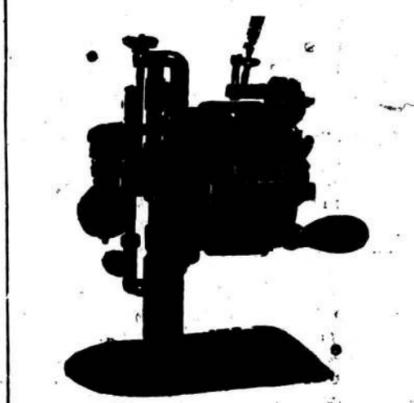

Home Hints.

"I Always Do."

If you want to have a luxuriant head of hair at seventy don't part it in the same place from the time you leave school. If you do you will have a "fly walk" that would accommodate black beetles. No woman in the world has such beautiful hair as the woman who keeps well in sight of the prevailing fashion. It means that she frequently changes her mode of dressing, and a change in dressing is as good for the hair as intelligent irregularity is for the human mechanism. Those harmless little words, "I always do," have been the stumbling block in many and many a human life.

"Why do you always double on a win which so seldom comes off?" was asked a card player, who immediately replied, with a look of mingled pity and scorn, "Why, it is my system." It was a very bad system, but there was nothing more to be said.

So, with your hair as with many of your habits, try swinging off once in awhile into new grooves and don't cramp yourself by a foolish regularity. Remember the axiom, "Wise men change their minds," and, it is to be hoped, sometimes their habits.

Troubles of a "Faculty Wife."

The wife of a young instructor who has \$800 to \$1,000 a year must do her own housework and can hardly offer her friends even tea and thin bread and butter. She is probably gently bred, often college trained, almost always plucky and independent. When You Wake in the Morning.

When you first wake up in the morning take a good, long stretch. Stretch the hands as far out sideways as possible. Then stretch them over the head as far as you can reach, and at the same time stretch the feet downward as far as you can. Raise the feet and stretch upward just as high as you can and then lower the feet and legs very slowly. When you get out of bed raise your arms over your head and, standing on tiptoe, see how near you can reach the ceiling. Then walk about the room while in this position. Stand on the right foot and stretch the right arm forward and upward as high as you can, while at the same time the left foot is raised from the floor and stretched outward and the left hand is stretched backward and downward. This is a fine exercise for the whole body and is especially good for the waist and hips, making them firm and strong.

The Sunday Dress.

There is one section of the dress reform which pleases many, and that is the new fashion of dressing plainly for church. The Sunday dress has really gone out of fashion. It is no longer considered proper to wear one's best clothes to church. The best clothes must be laid away for worldly pleasures—for the theater or circus—and the plainest gown, or, in fact, the everyday outfit, is to be worn on Sundays. Women of the east have leaned gradually toward this, and for some time it has been noticed by strangers they look exceedingly plain when attending church.—Chicago News.

Dress For the Office Girl.

Spend more money on your office outfit than on your Sunday frock or your party gowns. You wear the office dress six days to the Sunday dress one, and there is a wonderful moral support in working in a well fitting waist and a well hung skirt. A smartly made and fitted shirt waist suit with plenty of fresh neckwear is the ideal

office attire and commands more respect from employers and fellow workers than retired Sunday gowns refurbished and overtrimmed. Dress does not make the man, but it often holds a desirable position for a woman.—Woman's Home Companion.

Hairbrushes.

After washing hairbrushes they can be quickly and thoroughly dried without injuring the bristles by brushing them briskly with a whisk broom, and there is no better way to dry the hair after it has been washed than to hold up a few strands at a time and with a small whisk broom fan it, letting the broom act at the same time as a comb gently drawn through it. This method is a good substitute for sunlight, which can neither be had to order nor relied upon with certainty.

Children's Falls.

If a child is injured or stunned by a fall or a blow take him at once to the open air. Lay him flat on his back, the head slightly higher than the body. Put cold water or ice about the head and prepare a hot mustard bath for the feet. If the child remains in a stupor it may be necessary to apply warm water to the body. The same treatment should be given to an adult, though it can be more heroic.

The Hands.

The hands need moisture, and the skin must be fed. The hands also need exercise, not exercise with certain fingers nor with certain muscles, but regular exercise for the whole hand. Let the hands be soaked daily in warm, rich, soapy water, and let them be treated to a paste nightly, and they will retain their beauty, even through the roughest work.

Dangerous Door Knobs.

A dirty door handle is an obvious offense against sanitary principles. Constant contact with the hand means contamination sooner or later. It is conceivable that a dirty door handle would convey disease, and there is thus ample reason why door handles should be kept as clean as possible.—London Lancet.

Ribbons.

Ribbons may be freshened, if not too much soiled, by sponging with weak ammonia water and hanging for a few minutes in the fresh air. They should then be put between pieces of white tissue paper and ironed with irons as hot as can be used without scorching.

Glass Dishes.

Once in awhile put the glass saucers and the tumblers into a warm suds and with a new nailbrush give them a scrubbing. This takes the dull and grayish look off them, and after they are rinsed in hot water and dried they sparkle almost like cut glass.

Poison in the House.

It is an excellent plan to keep poisons in fluted bottles so as to be able to recognize even in the dark by the touch the nature of their contents. But whatever you do, refrain from plain bottles containing poison among those containing tonics and medicines.

To clean cork carpet wash all over twice a week with skim milk or polish with beeswax and turpentine as you would a stained floor. The latter method darkens the cork and gives it a rich appearance.

Dean Swift's Dinner.

A characteristic story is told of Dean Swift, who after a series of expensive entertainments in London invited six of his hosts to dinner. They arrived, expecting the usual costly surfeit of good things. They found the table laid with a piece of bread, a bottle of wine, a plate at each cover and a waiter behind each chair. They took their places. "Mr. Dean," said the lord chancellor, "we fail to see the joke."

Swift lifted his plate. Underneath were the bill of fare of a neighboring cafe and a half crown. He turned to the waiter at his side and gave him the money. "Here," he said, "bring me the worth of that in goose and potatoes."

The guests each sent the money under his plate for whatever dish he chose, and the dinner was eaten and enjoyed.

Swift then laid upon the table £100 and, deducting the three crowns which had been spent, said: "The remainder—the crumbs and fragments—is to go to the poor. We all have had enough money to satisfy hunger. You shall advise me how the rest is to be spent."

The Rope of Ocnus.

"The Rope of Ocnus" is the name of a famous picture painted by Polygnotus, a Greek artist, who died about 426 B. C. He was the first who gave life, character and expression to pictures. According to Pliny, he opened the mouth and showed the teeth of his figures and was the first to paint women with transparent draperies and rich addresses. The picture represents Ocnus as a poor man, weaving a rope of straw, while behind him stands an ass consuming the other end of the rope. The silent lesson thus conveyed is said to have had a wholesome effect upon the wife of Ocnus, whose extravagance had been his ruin, so that she became frugal and thrifty and helped him to rise from penury to great prosperity. The phrase "like the rope of Ocnus" signifies profitless labor.

Sweet Potato Coffee.

If coffee is suspected of being harmful to the nerves it is the part of wisdom not to drink it. Most substitutes are unspeakable concoctions. During the war sweet potato coffee was brought to a rare perfection and is said to be a very palatable beverage. Good Housekeeping furnishes an old war recipe: Pare the potatoes, cut them in small dice and let dry for a day or two. Parch like coffee, grind and put away in a cool, dark place. Mixed with one-third real coffee, the potato coffee was much liked, and even when used alone it was said to be very good. The weak nerved might try this substitute with the certainty that they are getting a drink that is at least unobjectionable.

A Trick of Sex.

A man seated closes his knees to catch an object thrown on his lap. A woman in similar circumstances opens hers. This is a fact that Mark Twain used in "Huckleberry Finn." Huck is disguised as a girl, and a woman throws an object into his lap. Though he wears a skirt, he hasn't sense enough to spread his knees apart so as to catch the object better—he claps them together, as a trousered man would do. An English novelist in a book called "The White Rose" uses the same idea. Pierre de Coldirodi, the Italian romancer, uses it in his well known "Maidens and Love." The Frenchman Henri Paul uses it in his "Widows' Tears."

Making It Pleasant.

"That's what I call a good dinner," remarked Bobby as he leaned back in his chair with an air of repletion.

"Bobby," said his mother, "I'm ashamed of your saying such a thing."

The visitor who was dining with the family laughed heartily. "Bobby appreciates the good things of life," he said, "like all the rest of us."

"Don't you think it was a good dinner?" Bobby asked the visitor.

"Yes, indeed," the latter replied, with a smile. "I enjoyed it thoroughly."

"Mother said she thought you would, because she didn't suppose you got very much at home."

Starfish.

Starfishes commit suicide. When one is caught in a net it dissolves its incorporation into a dozen or so of frag-

ments, and the pieces escape through the meshes. In time each becomes a perfect animal. To preserve the starfish whole it must be plunged into a bucket of fresh water before it has time to take the alarm. Fresh water is instant death to it, and thus only can some varieties of the starfish be preserved.

Swallowed Table Knives For Fun.

The glass eaters, iron chewers and all other classes of "human ostriches" are well known to the frequenters of dime museums and side shows, but it is seldom that we see, read or hear of a man who swallows indigestibles of extraordinary size just for the novelty of the thing. Such a man, however, was John Cummings, whose history is given in extended notices in the medical and surgical annals of Boston. He watched a French sword swallower one day and immediately after attempted a similar feat with a common table knife. The knife accidentally slipped down his throat, and a few days later, it having given him no inconvenience, he repeated the experiment. Both of these exploits took place at Havre de Grace, France. On his return to Boston he boasted of the feat and upon being bantered repeated the dose again and again. During the following ten years he swallowed in all thirty-five knives and forks, finally dying in terrible agony. He died in 1809.

Grim Story of Napoleon.

A grim story of Napoleon is told by Christian Waas in a Frankfort review under the title of "Napoleon at Yafa." A great number of the soldiers were down with the plague, and one day Bonaparte sent for his chief surgeon, Larrey. "If I were you," he said to him, "I should put our plague patients out of their misery. It would save them from having recourse to opium to soothe them." "But my duty is to make them live," replied Larrey. Bonaparte then revealed the grim truth. He and his staff were reduced to traveling on foot because the horses were all being used for the transportation of the sick. He must therefore either abandon the plague stricken to the cruelty of the enemy or get rid of them. Mr. Waas maintains that the order was carried out accordingly. There is an end, observes the Journal des Debats, to the illusion of the famous picture in the Louvre of "Bonaparte Visiting the Plague Stricken Soldiers at Yafa."

A Dramatic Scene.

The most dramatic scene ever witnessed in Westminster hall was that trial in Henry VIII's reign when 480 men and 11 women appeared before the king and some of his great nobles with ropes around their necks on a charge of being concerned in the rising of the prentices on the previous May day. Fortunately they had good friends in three queens—Katherine, Mary of France and Margaret of Scotland—who begged for their pardon on their knees, and when Henry at last yielded to such supplications the prisoners, it is said, "gave a mighty shout for joy, throwing their halters toward the top of the hall." The stage has never produced anything to rival that dramatic moment.—London Graphic.

Two Stories.

Several years ago, soon after "Treasure Island" had appeared and attracted public attention to Mr. Stevenson, two gentlemen were traveling up to London from Norfolk. One of them was reading "Treasure Island." Presently, having finished the book, he dropped it into his traveling bag, remarking, "Well, I think I could myself write a better child's story than that." The other, who, by the way, was his brother, urged him to try. Six weeks afterward the former handed to the latter a complete tale in manuscript. It was "King Solomon's Mines," the first novel that made a reputation for Rider Haggard.—London Queen.

We Usually Find Our Level.

Do not hypnotize yourself with the idea that you are being kept down. Do not talk such nonsense. Nobody of any sense would believe it. People will only laugh at you. Only one thing is keeping you down, and that is yourself. There is probably some trouble somewhere with you. Of course there are employers who are unjust to their help, there are instances in which employees are kept back when they should be advanced; but, as a rule, this is only temporary, and they usually find their level somewhere.

Cross Eyed Angels.

Near the village of Monterey, Mass., in the heart of the Berkshires, on a knoll peculiarly well fashioned by nature for its uses, is a burying ground of the Revolutionary period which possesses more than ordinary interest by reason of its well preserved headstones. These headstones were cut from a native stone which has endured the elements so well for more than a hundred years that the inscriptions are now almost as easily read as they were when the stones were set in position. A striking peculiarity is found in the carvings on the headstones, apparently all the work of one sculptor, who had a speciality in the creation of cross eyed angels. Almost every one of the old headstones is ornamented at the top with the head of an angel, and each angel face is unmistakably and painfully cross eyed. This characteristic has led some guests near the burying ground to call it the "cemetery of cross eyed angels."—New York Tribune.

Cooking Fish In Clay.

"The natives of the north woods have more appetizing ways to cook fish than any other class of cooks in the world, I believe," said a Tomah man.

"The universal favorite, however, seems to be the clay method. The fish is wrapped in the clay without having so much as a scale ruffled by the cleaning knife. He is not dressed, and the only seasoning is a pinch of salt placed in the mouth. When the fish is done up in the clay the package is placed in the embers of the campfire to bake. When it is done the clay is cracked open, and the scales of the fish are found to be sticking in the clay, and the head is then broken off. The delicate flavor of a fish cooked in this way cannot be described. Some of the cooks have a habit of cutting a long gash along each side of the dorsal fin and inserting a slice of fat bacon. This adds greatly to the flavor of the fish."—Milwaukee Sentinel.

A Strange Thunderstorm.

It was a strange thunderstorm that struck Suffolk, England, Aug. 4, 1577. According to Hollinshed, the tempest of lightning came through the wall of Bilborough church and went a yard into the ground, knocking over twenty people and killing two. Then it came up again, mounted the steeple by way of the vestry door, broke the bells and darted off to Bungay, six miles distant. There, according to another chronicler, it became a fiery black dog, which dashed between two people kneeling in church and broke their necks and clawed another man on the back so that he was "presently drawn together and shrunk up, as it were, a piece of leather scorched in a hot fire." Claw marks remained on the door to prove the reality of the black dog.

Old Time Advice to Travelers.

Edward Leigh's "Hints For Travelers" was published at the end of the sixteenth century. Only those who speak Latin should travel, he says, and every one should be well grounded "in the true religion" lest he be perverted abroad. Travelers should know their own country before being allowed to leave it. Before his voyage the traveler "should make his peace with God, receive the Lord's supper, satisfy his creditors if he be in debt, pray earnestly to God to prosper him on his voyage and to keep him from danger, and he should make his last will and wisely order all his affairs, since many that go abroad return not home."

The Word "London."

What is the derivation of the word "London?" The usually accepted one is the Celtic "Llyn-Din," or lake city, referring to the historical fact that the city was built on a river that overflowed at full tide and half surrounded it. Other philologists have derived it from "llawn" (full) and "dyn" (man), others again from "lon" (a plain) and "dun" (a hill). But the derivation London, or "grove city," seems more probable than most of these. The name occurs in wooded parts of Scandinavia to this day.
