### Death of Hon. A. Moses.

HON. ALTAMONT MOSES, a member of the South Carolina House of Representatives, and one of the most highly respected citizens of that State, died at his home in Sumter, S. C., on Friday, December 8th, and was buried on the following Sunday with Masonic honors.

Col. Moses was about 59 years of age, and was the son of the late Judge Montgomery Moses, and a nephew of the late Chief Justice Moses of that State. His mother was a Miss Phillips, of Philadelphia, Pa., sister of Congressman Henry M. Phillips, a prominent lawyer of that city.

Mr. Moses had served a number of terms as a member of the South Carolina Legislature, part of the time as State Senator and part of the time as Representative, to which office he was, on several occasions, elected unanimously by the people of Sumter County. He was known and designated as the "Nestor of the Legislature," serving on many of the most important committees and his advice and counsel being constantly sought by his fellow members. He was prominent in social, as well as in Masonic circles, and in many other fraternal organizations, having held high honors in the Knights of Pythias, Knights of Honor, United Workmen and other benevolent societies.

Col. Moses was a delegate to every National Democratic Convention since 1888, and was high in the councils of his party in his native State. He served in the Confederate army during the Civil War, and, at the time of his death, was a member of the staff of the Governor of South Carolina, ranking as Colonel. His funeral was attended by an immense concourse of people, who were present to pay the last tribute of respect to the remains of their deceased fellow-citizen.

Mr. Moses is survived by a widow, who was Miss Octavia Cohen (daughter of the late Marx E. Cohen of Charleston, S. C.), and six children, one of his sons being Lieut. Emile P. Moses, of the Marine Corps; another,

Herbert A. Moses, who is the city editor of the Sumter (S. C.) *Evening News*, and Vivian M. Moses, being engaged in journalistic and literary work in New York City.

### In the School of Liars.

I am fifty years of age, and I am not ashamed to acknowledge that I cannot comprehend the grandeur of that book. There is a philosophy which is deeper than the sea; a lyric which thrills through all our bones and nerves. To illustrate and demonstrate it, I take up the line which graces my article:

There are criminals and criminals, there are thieves who bring families on the verge of starvation. There are murderers who are murdering people and turn homes into ruins. Yet, all of these criminals are righted in the eyes of the Lord, except the liar.

Why is the liar so punished? He does not harm, only tells a lie. Years of experience have taught me that the liar is the greatest criminal. The thief steals, either it is the struggle for life, or he is a kleptomaniac. The thief wants to fill his soul, as King Solomon says. The murderer has some reason for his crime. Sometimes it is poverty, and sometimes it is plainly an act of revenge, but what motive has the liar? Like a chain of pearls, if one is lost, the rest follow; so if a person tells lies, other crimes are bound to follow. Lying is the incubator where in crimes are bred.

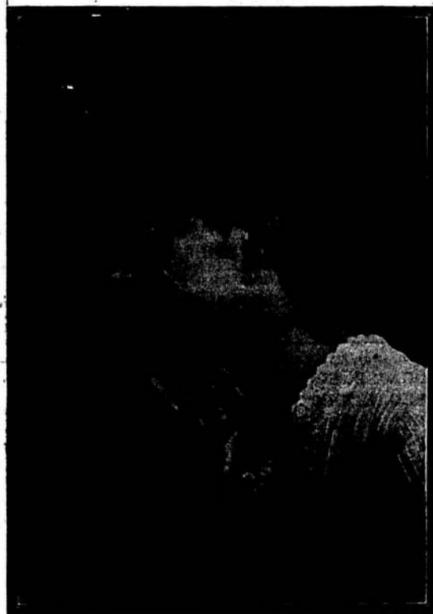
We often read in the newspapers that some butler has looted the home of his mistress, the servant girl run away with the jewelry of her lady, or some clerk looted the safe from some institution or banking house. Who made them criminals? Of course, principals, for our institutions and homes of the wealthy are "Training Schools for Liars," and the lie is the A B C of crimes.

**Jewish Life in Small Communities.**

**New Brunswick, N. J.**

The good Jewish people of this place, irrespective of their religious inclinations, the Orthodox, Conservative and Reformed, jointly received the writer of this with something akin to enthusiasm.

Inasmuch as Monday, the 4th of December, the time chosen for mourning, affliction and fasting by both, Reform and Orthodox, Dr. Stolz of the C. C. of American Rabbis and Rabbi Israelite of the Agudath Rabbonim, Temple Emanu-El of Fifth Avenue, and Beth Hamidrash Hagadol of Norfolk Street, that memorable day was approaching, your correspondent, in his address on the preceding Saturday to considerably numerous audiences, emphasized the importance, weight and significance of the coming Monday. Although there are two great luminaries shining brightly upon the glorious horizon of the local Jewry, viz.: Gustav N. Hausmann, the scholarly, eloquent and efficient Rabbi of the Temple of the Congregation Anshai Emeth, and Simson Ratner, the erudite, musical and learned minister of the synagogue of the Orthodox Ahawath Achim, there was, nevertheless, an opportunity for your humble servant to make himself useful to some extent,

tent, introduce some sort of a novel service and mourn the martyrs at the appointed hour.

Dr. Hausman of the Reform Temple is taking a post-graduate course in the Columbia College, New York, making his presence in a rural district during the week literally impractical.

On the other hand, Rev. Ratner found himself between the Reform Seylla and the, Orthodox Charybdis. Pursuant to the modern celebrities, the Union Prayer Book with some Hebrew augmentations was recommended, whereas the Rabbis of the old type suggested the *Selichoth* for the 20th of *Sivan*, commemorating the *Chmelnitzky* atrocities, as suitable appropriations.

As the Orthodox of the Simon-pure tendencies would suffer neither Union Prayer Book, nor any English prayers, and as there is not a *Siddur* in the whole of New Brunswick containing the sanctioned *Selichoth*, the minister and the communal leaders experienced a state of depondence and passed in a condition of despair.

Your correspondent, therefore, offered for the special occasion his lately published books of Daniel and Ezra with their Hebrew translations, pointing out the chapters ix and xii from Daniel and ix from Ezra as timely recitals for the occasion.

Rev. Ratner, accordingly, chanted the *Minchah*, service read from the scrolls of both, the Pentateuch and the Prophets, portions generally assigned for the *fasting days*, declaimed the verses from Daniel and Ezra and recited אֲחִינוּ מִלִּבְנֵי אַהַוָּת. The Synagogue of Ahawath Achim was filled to its capacity with men and boys, young and old, conservative and radical, while the galleries were overtaxed with women, all of whom shared in the silent services and participated in the responsive supplications.

At this juncture the old adage of אֲחִינוּ is the best אֲחִינוּ, may be revived, corrected and applied to the case at issue. Food, as such, can neither be the best, nor the worst entertainment.

אֲחִינוּ is the best אֲחִינוּ, reflecting upon a liturgical portion of the *machsor* for terrible days, which begins with that peculiar diction. While at most of the prayers, the congregation, following its minister, cries itself to a stage of hoarseness and exhausts its articulative power, at this particular petition, it stands calmly, neither utters a sound, nor moves a lip, but listens attentively instead.

At our unfortunate celebration, Rev. Simson Ratner, availed himself of the chance and recited the אֲחִינוּ which is the beginning of Dr. H. P. Mendes' Zion Hymn, rendered into Hebrew by the translator of Daniel and Ezra and included in that book under the title of שִׁיר צִיּוֹן as an inspiration for the multitude to become

Zionists in which instance he partly succeeded.

A society of Zionists was formed right there then, with an enormous number of members, under the presidency of Rev. Simon Ratner and vice-presidency of Mr. Max Lewin, the son of Mr. Wolf Lewin, the latter being the president of the synagogue.

The services, including the writer's address, at which fusive tears were shed, lasted fully four hours, from 4 to 8 P. M.

Notwithstanding the fact, that a goodly number of the present worshippers abstained from food and from drink all the day, the sum of money as ramson of those who were not able to fast, reached to \$34 00, owing to the personal solicitations of the Mr. Lewin, which amount was sent to the Relief Fund in New York.

There is a society entitled *Shomre Hadath*, the pious disposition of its members varying somewhat from the others, which, however, was fairly represented at the mourning procedure. The name of its president is Mordecai M. Fellor.

There is another society having for its purpose the "Sheltering of Strangers" under the guidance of Mr. Max Jolin and the leadership of Mr. Moses Ratner.

As a result, the latter's very son, the local minister, and his charming and charitable wife, generously and hospitably shelter and house all the strangers at the city portals.

### LITERARY NOTES.

*Woodhull's Elementary Physical Science.* For Grammar Schools. By John F. Woodhull, Ph. D., Professor of Physical Science, Teachers College, Columbia University. American Book Company, New York, Cincinnati, and Chicago.

This course has been prepared owing to the wide spread demand that elementary physical science should be introduced into the grammar schools. The book, which is designed to be used by the pupil, aims first, to give him accurate verbal concepts of ideas that have already entered his consciousness through his senses; second, to broaden the pupil's knowledge by calling his attention to practical applications of the principles that he has seen illustrated in the laboratory. From a study of this book many useful, common facts, relating to mechanics, fluids and heat, are made clear to the pupil. He learns why earthenware, in order to hold water, must be glazed; why the brown-stone fronts of buildings disintegrate; and why edged tools must be tempered. City water and gas receive particular attention. The application of heat to thermometers and to propelling steamboats and railway trains, and the heating of buildings by the fireplace, stoves, hot water heating and steam heating, together with the ventilation of buildings, are taken up in an interesting and instructive manner.

This is the latest addition to the popular and widely-used series by this well known traveller and writer. Carpenter's African Reader is largely based upon exploration, and also upon the author's travels and personal observations in all parts of the continent. He has, in fact, presented the best and latest information about Africa from the standpoint of educational interest, and that in a way that cannot fail to interest the children.

The book is a personally conducted tour, in which the children, accompanied by the author, travel through Africa studying the geographical, commercial, and industrial features of the continent as they go. They explore the great mountains; they ride in caravans across the Sahara; and see for themselves the wonders of the Nile, the Niger, the Kongo, and the Zambesi while sailing upon them. They study the strange peoples of the various countries, and learn about the birds and wild animals by seeing them in their haunts.

The Reader shows the great development that is going on in Africa. The children go over the new rail roads; they go and see the gold and diamond mines and other great industries of South Africa, and learn the part that each country has in the world of commerce and trade. Indeed, the book is filled with just the

everyone should know, presented in such a simple manner and interesting way that the children can not help but understand it. Mr. Carpenter has had exceptional advantages in securing authentic information, illustrations, and other literary material. The book is profusely illustrated from photographs by the author, and is supplied with numerous and helpful maps.

*The Rose Primer*, by Edna Henry Lee Turpin. Cloth, square 8vo, 128 pages, with illustrations in colors and in black and white. American Book Company, New York, Cincinnati and Chicago.

The primer is distinguished by the small vocabulary of common words, the frequent reviews, the short sentences, the simple language and phonetic exercises, and the carefully graded and well-selected subject matter. There are never more than two new words on a page, and only one hundred and ninety-eight in the book. These words are carefully repeated, most of them being used ten or more times. Every new word is given both in script and print, and there are frequent script exercises for tracing and copying. The sentences are short and simple, and the construction is varied as much as possible to avoid the formation of singsong and monotonous reading habits. The child, confronted by the least possible labor in word getting, can easily master these pages. On completing them he has acquired a small but serviceable vocabulary of common words, and can begin any

facts about the Africa of today that well graded first reader with ease and intelligence. The subjects in this primer are those which appeal to the intelligent interest of children. Here are described and discussed familiar objects, plants, and animals, the common amusement of boys and girls, and the everyday round of home and school life. The illustrations are attractive and helpful to the child.

NO CHANGE IN THE SITUATION.

Renewed Massacres—Eye Witnesses on Arrival in This Country Corroborate Cable Reports of Atrocities—The Relief Fund Grows—Another Resolution in Congress.

The latest reports from Russia are to the effect that the situation has undergone no change for the better. New tales of massacres continue to come to hand, and there is every apprehension that the lives of our coreligionists throughout the pale of settlement are in danger. The relief funds are growing by leaps and bounds, and in response to the appeal of the National Relief Committee \$1,151,903.13 has been contributed up to date. No second appeal will be issued, but the fund will be kept open.

Mr. Jacob H. Schiff, the treasurer of the Relief Committee, has agreed to receive and provide for five hundred Jewish children orphaned as a result of the massacres.

In Monday's session of the House of Representatives Congressman Sulzer, of New York, introduced a strongly worded resolution denouncing the massacres of the Russian Jews.

Elizabethgrad Massacres.

VIENNA, Dec. 12.—A dispatch to the Neue Freie Presse from Bucharest says:

"Reports received here through refugees are to the effect that since Sunday the town of Elizabethgrad, Russia, has been burning and that a mob has been killing and plundering in the Jewish quarter.

"A regiment is proceeding to Elizabethgrad from Kishineff to restore order."

Fifteen Hundred Killed in Kiev.

BERLIN, Dec. 7.—A newspaper here reports a terrible massacre of Jewish students and reformers at Kiev on December 4 and 5.

More than 1,500 were killed and a large number were wounded.

Lueger at the Game.

VIENNA, Dec. 7.—In a speech to-day Burgomaster Lueger, who is a notorious Jew baiter, accused the Hebrews of supplying to the Socialists money with which to buy red flags. He said:

"I solemnly warn the Jews of the possibility of the re-enactment here of the Russian atrocities. We Viennese are anti-Semites, although we are not disposed to murder and bloodshed, but if the Jews endanger the Fatherland we will have no mercy on them."

Emanu-El Brotherhood.

After two years of patient and energetic work the leaders of the Emanu-El Brotherhood have achieved the results so much desired by them.

On Sunday last, in the presence of a large number of members and friends, the Brotherhood dedicated their new house at 316 East Fifth street. For the past two years the Brotherhood has been meeting in various East Side halls for religious worship and social work, under the guidance of the minister in charge, Rev. G. Lipkind. The founder of the Brotherhood was the Rev. Dr. J. Silverman, of Temple Emanu-El.

The philanthropic work, which was begun in earnest on Sunday, is in the nature of Jewish settlement work. As was stated at the meeting, a hall holding 1,500 could easily be filled, but the means for renting so large a place are lacking.

Although the money has come from a number of sources, Adolph Lewisohn, by a donation of \$5,000, and G. A. Kessler, by a gift of \$10,000, have given the work additional impetus. The movement contemplates the quickening of the Jewish consciousness, useful instruction and opportunities for social enjoyment intended to keep the young from the streets.

The building dedicated is equipped and furnished to meet these needs. The principal religious services will still be held in Volk's Lyceum, but there is room in the new building for smaller religious meetings. There are rooms set apart also for daily kindergarten instruction, a model kitchen, a gymnasium and a cozy club-room for boys and young men. Already twenty clubs have been formed in the neighborhood to meet in the building. No less than twenty-six young men and women have offered their services as instructors of the various classes which are to pursue various lines of study.

At the meeting yesterday Dr. Silverman emphasized the real purpose of education, which, he said, meant "developing the intelligence, the feelings and the will. With these three possibilities developed to their utmost," Dr. Silverman went on to say, "one individual increases his potentiality threefold. A man or woman becomes really three persons in one."

Several others made speeches of encouragement, among them being Adolph Lewisohn, Max H. Winkler, the Rev. George A. Kohut, and the Rev. G. Lipkind. Letters were read from District Attorney Jerome, Jacob H. Schiff and others.

persons as an outrage and a direct incentive to hoodlums to attack the Jews.

How Jewish Students Fought.

With the scars and bruises of the conflict still unhealed, Peter Smolensky has just reached this city from Odessa, bringing a thrilling story of the massacres and of the desperate bravery of the students who formed the Jewish Defense Organization.

The students, he said, changed their position from one street to another, taking their stand wherever the danger was greatest. They fought with all their might, even after they were fatally wounded; but at last were overwhelmed and fell one by one.

"It was terror and destruction, cries for help, fire and blood everywhere," said he. "Some of us were half mad with desperation and despair. Some of the students were overcome with the desire for revenge. Some of the self-defense carried bombs, and one was thrown at a church, which goaded the hoodlums to greater slaughter."

Smolensky fled from Odessa to Warsaw, thence to New York. While in Tils he was condemned to Siberia, but escaped. His sister, Esther, a student at the Georgen-Gymnasium in St. Petersburg, was hanged with a girl companion some weeks ago for alleged complicity in a plot to blow up Gen. Trepoff.

The Union of American Hebrew Congregations.

The receipts for the Isaac M. Wise Memorial Fund to November 30, 1905, amount to \$296,693.60.

The Board of Managers of Synagogue and School Extension organized last month by the election of Mr. Louis Krohn as chairman and Mr. Lipman Levy as secretary. The following additional members of the board were elected: Messrs. Julius Rosenwald and Israel Cowen, of Chicago, Ill., and Messrs. Samuel Strauss and Lipman Levy, of Cincinnati, Ohio. Rabbi George Zepin and Rabbi Alfred T. Godshaw were elected respectively as director and assistant director for another year.

The secretary reported that since the transfer by the Hebrew Sabbath School Union of America of its assets to the Board of Managers of Synagogue and School Extension, he had sold and distributed up to October 31, 1905, 31,753 Sabbath School leaflets, the greater portion of which went to congregations which are members of the Union of American Hebrew Congregations and to schools organized for charity and "settlement" work. The others have been sold at the rate of fifty cents per hundred. The secretary was authorized to continue the sale and distribution of these leaflets in like manner.

Director Zepin, being present, presented a brief report preparatory to his annual one to be furnished shortly, wherein he called attention to the fact that it would be advisable to organize Sabbath Schools in the congested Jewish districts of Chicago. He was authorized to undertake the work, and \$200 was placed at the disposal of the chairman to defray the expenses connected with the work.

The board by unanimous vote expressed its opinion in favor of organizing and instituting religious work among the Jewish students in the various universities and colleges throughout the land. Very flattering reports were received from both the director and assistant director as to the progress they are making in the work assigned to them, that of organizing congregations and Sabbath Schools, and incidentally mention was made that through their efforts congregations had resolved to become members of the Union of American Hebrew Congregations.

The annual meeting of the Executive Board of the Union of American Hebrew Congregations will be held in Cincinnati on Sunday, December 17, 1905. A large attendance of the members of the board is expected, as important business is likely to come before the meeting.

Musical and Dramatic Comment.

There were two interesting "events" at the Irving Place last week—the performance of "Heimath" with Frau Gertrude Arnold, and the debut of Fri Palmay. For the sake of convenience I bracket these two names, for they represent spheres of art as far apart as the poles. If we accept her conception of the character of Magda as correct, then Frau Arnold's embodiment of it must be regarded as remarkably skillful and satisfying. She makes the woman hardened by her struggles with poverty, and even when she greets her sister the note of tenderness is only lightly touched. After that first scene, the impersonation increases in interest from one episode to another. In the lighter moods the actress' use of conversational dialogue is very natural, and her scorn when dismissing Keller is finely expressed. After seeing her in two sharply contrasting roles, I am convinced that Frau Arnold is, far and away, the best heroine whom Mr. Conried has had in a long time.

Ilka Palmay's success in "Heisses Blut" was largely a matter of patriotism. The lady is a Hungarian, and our Hungarian co-religionists are ardent patriots. They packed the theatre last Thursday night, and their applause and cries of Eljen gave a hearty if rather vociferous welcome to a performer whom Budapest has delighted in for years. If you've not been a "looker on in Vienna," you will hardly be able to understand such fervor. Fri. Palmay, to be sure, sings in French, English, German and Hungarian, dances the *csardas*, and is mistress of all the other *soubrettenlaenste*. But her voice is frequently shrill, and while there is plenty of vivacity in all that she does, the quality of charm is seldom apparent. "Heisses Blut" remains the bill all this week. It is very well given, and Von Seyffertitz as the theatrical wig-maker was never more amusing. A capital comedian—this man with the long name and the longer legs.

Contrary to his usual custom Mr. Walter Damrosch will give two different programmes at his fourth pair of symphony concerts—Carnegie Hall, Sunday afternoon and Tuesday evening next. On Sunday D'Indy's "Symphony for Orchestra and Piano, in the song of a French Mountaineer" will be produced, with Raoul Pugno at the piano. At the evening concert Mr. Pugno will play Caesar Frank's "Symphonic Variations" and the symphony will be Tchaikowsky's Pathetique. At both concerts, Miss Bessie Abbott will sing.

Benjamin W. Huebsch, who was once engaged in the honorable occupation of writing musical criticisms for the Sun has become a publisher. To him the writer is indebted for two unique little volumes: "Beethoven, the Man and the Artist as Revealed in his own words" and "Mozart," with a similar sub title. These volumes were compiled and annotated by Frederick Kerat, and are edited and translated by Henry E. Krebbiel. After a careful perusal I am convinced that they will appeal strongly to every music-lover. The Beethoven

book consists of his own words culled from letters, reports of conversations, diaries and some sources unavailable prior to the compiler's research and relating to many of the problems which arose during the great composer's life. His opinion of men and things, his views on the questions which assail every thinking man as on those problems belonging specifically to his own art, are classified under appropriate chapter headings. That relating to Mozart is thus aptly characterized: "The unique personality of Mozart is revealed more effectively in these quotations from his own pen than would be possible in the most painstaking study by another of the light-hearted genius. His filial devotion, joyous love-making, high spirited protest against the degradation of his profession and profound loyalty to the faith in which he was reared, are all set forth with an ingeniousness and impetuosity that recreate for us this absolutely charming musical conjurer."

The holiday afternoon cycle of "Der Ring des Nibelungen" at the Metropolitan Opera House begins on Monday, the 25th, with "Das Rheingold," to be followed on Wednesday by the "Die Walkuere." "Siegfried" is to be given on Thursday, and the series concludes on Friday with "Gottterdammerung." Mr. Hertz will conduct, and the performances are being carefully rehearsed by Mr. Conried. This evening La Sonnambula is to be revived with Caruso and Sembrich. To-morrow afternoon the "Queen of Sheba" may be heard, while in the evening "La Gioconda" will be sung.

Beethoven's Solemn Mass was sung by the Oratorio Society on Saturday evening. Twenty-three years have elapsed since it was last given, and the same number of years will probably go by before it is again heard. Mr. Frank Damrosch and the Society certainly took infinite pains in trying to overcome difficulties which are insurmountable, and at times they succeeded well. The chorus sang with great precision and a fine quality of tone. Even in passages that are almost unsingable the impression of undue strain was hardly apparent, and in the climaxes, the "Gloria" in particular, splendid effects were obtained. The soloists, except in the case of the soprano, accomplished their not very grateful task creditably. The annual performances of "The Messiah" take place on the afternoon of Wednesday evening the 27th and Thursday evening the 28th. Mrs. Corinne Rider Kelsey, Mme. Kirkby Lunn, Mr. George Hamlin and Mr. David Bipham are the soloists.

Madame Gadsby will give one song recital this season, at Carnegie Hall, on Tuesday afternoon the 26th. It is to be hoped that not many days will elapse before the announcement is made of her engagement at the Opera, where she is very much needed. J. M.

Worthy of Emulation

THE Emanu-El Brotherhood, an organization founded by the Rev. Dr. J. Silverman of Temple Emanu El and which has been doing excellent work on the East Side for the past two years, opened a settlement House in Fifth Street on Sunday last. It is the first Jewish settlement on the East Side and will no doubt do a great deal to nullify the Christianizing influences of the non-Jewish settlements and Christian missions in that district.

Temple Emanu El, Dr. Silverman, the directors of the Brotherhood are to be congratulated upon the results of their labors and Messrs. A. Lewinohn and G. A. Kessler deserve the fullest gratitude of the community for their munificence which made the opening of the Settlement House on Fifth Street a possibility.

In the beginning, with a view to the dissemination of the principals of the Reform, the Emanu-El Brotherhood was hotly assailed because it was understood that it was to be conducted as a reform institution, but our orthodox friends were soundly asleep while the reform wing was working and plodding energetically.

The Emanu-El Brotherhood House will be the bright spot in a neighborhood sadly in need of some Jewish sunshine. More than one Jewish settlement is needed and those who always deprecate Reform Judaism might for once bastir themselves and put their teaching into practice. We know Mr. Albert Lucas is desirous of establishing a number of Jewish centres and we shall watch with interest the amount of material support he will receive, now that the practical example has been afforded, from the constituents of the Union of Orthodox Jewish Congregations, from the Union of Orthodox Rabbis and from private individuals who in season and out of season are loud and persistent in proclaiming their adherence to traditional Judaism, and recognize, so they say, the urgent necessity of the establishment of Jewish settlements as the best means of protecting the Jewish children of the East Side.

The Immigration Conference.

THE much advertised National Conference of Immigration has come and dispersed, but it has not been a case of *veni, vidi, vici*. There has been a great deal of talk and it was to be expected that Mr. Samuel Gompers, the spokesman of organized labor, which to a certain extent is as bad as an organized trust of capital, should be a fervent friend of restriction. But he failed to make out a clear case.

The only resolutions of importance were those calling for an International Immigration Conference, and the establishment of a bureau of information so as to enable the new settlers to see the advantages of taking up their abode in less congested places.

The whole trouble appears to us to be one of distribution. This country has room enough for millions more of immigrants. To this, however, the rabid restrictionist replies "Preserve the undeveloped territory for the coming generation of native born Americans."

Mr. Gompers, an immigrant himself, preached the doctrine of self protection and to this President Elliot of Harvard rightly replied:

"I question the doctrine of self protection. It is over-worked. To a great extent it is a good thing, but if it is to be followed, at the expense of our fellow-men it is a dangerous thing. It is not the nobler, more generous attitude to assume, and it will never commend itself to our people in regards to immigration."

These are the words of a true American.

A Futile Attempt.

LORD Rothschild, Sir Samuel Montagu, David L. Alexander, K. C., President of the London Board of Deputies, Claude G. Montefiore and other "leaders" of English Jews have spoken. They are opposed, so the cable tells, us to colonization either in Palestine or in East Africa, but they pin their faith to emigration either to the United States, Canada or Argentina; meanwhile these self-same leaders were very careful to tell the English public that none of the money collected in the British Empire for the relief of the Russo-Jewish Sufferers would be utilized for assisting immigration of Jews into England. This is another beautiful example of Anglo-Jewish Statesmanship. It rivals the repatriation policy of the London Jewish Board of Guardians. We wonder how many of the unfortunate Jews sent back to Russia, by the London community are among the murdered and the wounded. It is the old, old Jewish curse: make shifts, make shifts. We wait until a massacre occurs and then collect money; go back to sleep until another instance of bloodshed, and again money. But for the permanent solution of the Jewish question there is no money.

The fact is that the gentlemen who signed this statement against Zionism and Territorialism are Englishmen of the Jewish persuasion. Some years ago Lord Rothschild was the recipient of a petition signed by about ten thousand London Jews asking him to aid the resettlement of Palestine by the Jewish people. He carefully perused the document, which, by the way, had appended to it the name of Samuel Montagu, before he was appointed a baronet by Gladstone for giving money to the Liberal Party and the Christian Churches, and before the noble Lord did anything he struck out the title of Prince of Israel, which the enthusiastic Rabbi Singer conferred upon him.

A thousand lords, and baronets and presidents of Anglo-Jewish Associations, and Boards of Deputies cannot stay the progress of the Jewish National Movement. The conscience of the Jewish people has been awakened and the time will surely come when Israel will return to his own country.

The irony of it, these great financiers, lawyers, men of business, dictate to the Jewish people what should be done and they contribute the least in proportion to their wealth to the relief funds, both here and in Europe. Most help, as has always been the case, is coming from the masses, from the small tradesman, from the tailor, the shirtwaist maker, from the factory hand and the peddler.

We have no quarrel with the lords, the baronets and the bankers and the lawyers. If it please them they can assimilate, but there will be the great difference between the Jewish Nationalists and the assimilators. The former will constitute the Jewish people, the latter will be simply followers of the Jewish religion and in time their descendants will be altogether unknown to the Jewish people and the faith of the Jews. History is merely repeating itself.

It is futile for these erstwhile leaders of the Jewish people to stem the tide of Zionism. It is like Mrs. Partington endeavoring to mop up the waves. The waters of the ocean will sweep them and their theories into oblivion.

THE MIRROR.

To my surprise, Reb Yossef Loel has not sprung anything sensational upon the Jewish community, since his return from Japan.

It is rumored, however, that he has been engaged in a literary production written in pure classic Hebrew, entitled

ממקארא הקטון עד רוסיה הגדולה Memikado hakoton ad Russia hagodol "From the little Mikado to the great Russian," or "How I made peace between Russia and Japan."

It is, I understand to be an edition de luxe, and on the title page will be inscribed in gold letters M D C C L. I thought at first it was intended for the date of 1750, until my chief enlightened me, explaining that, in his opinion, the letters were evidently a sort of Pittsburgian *Roshay Tayvos*, and intended for "Magen David," "Cross," "Crescent," "Levy," which Utopian idea he announced a few years ago.

Needless to say, I await with great anxiety this marvellous production, and as the centre of population has been shifted from Columbus, Indiana, so the centre of Jewish learning has been shifted from Cincinnati to Chicago thence to the Smoky City, and soon we will be able to exclaim משהו חורג הצא חוצה לרוב, "For out of Pittsburg shall go forth the Law."

I take off my hat, or to use the Johnsonian classic phrase "I doff my dicer," to Rabbi Joseph Silverman of Temple Emanu El, for within the past few weeks he has raised himself at least 85 per cent. in my personal estimation and the estimation of the Jewish people of this metropolis by his manly, outspoken attitude upon the Russian Defense agitation.

We are so accustomed to dry, colorless Reform sermons—topical in everything except Jewish—that I was entirely unprepared for the fervid flow of true eloquence which characterized his public addresses

upon the recent Russian outrages, which largely aroused his audiences to a high pitch of enthusiasm and earned for him the well merited applause which greeted his able efforts.

Now, that Dr. Silverman has discovered the true path which leads to popularity among his brethren; now that it has dawned upon his mind that a Jewish tongue, with a Jewish message to deliver to Jewish hearts is the surest way of carving out a great name for himself in the Jewish community and gaining their sincere admiration, he should apply the same methods in his own pulpit and there preach Judaism to Jewish hearers.

Dr. Silverman or in the Hibernian vernacular, "more power to your elbow."

A verdant countryman purchased a breast pin with Masonic emblems, and upon being interrogated as to the significance of the letter G replied: "That ere letter G stands for Jerusalem, the place where we uns come from."

Now all the young Rabbis, whether "half-baked" from the Cincinnati bakery, or having received no classical Jewish education at all elsewhere, seem to have adopted the letter G as the emblem of their tribe; for with them it fully represents their stock in trade—Geysers, Gauze, Gayishkeit, Gas and Gall.

Some of them imagine because they can spout like a geyser in melodramatic style and Episcopal monotone, that they are qualified to fill any pulpit in America. Some are under the impression that gauzy sermons with alliterative titles and read or delivered without elocutionary training, a sort of *vox et preterea nihil*, will captivate the hearts of their hearers, and may believe that a chemical mixture of Gas and Gall will enable them to push their way to the best pulpits in the land.

Reform audiences however wanting in their knowledge of Hebrew or

their familiarity with the principles of Judaism may be, are not apt to be hypnotized by Gas which is not even illuminating gas.

Sincerity and not "gall"; Jewish learning and not "gas"; sound knowledge, the product of deep study and ripe experience and not flimsy "gauze"; a Jewish mind speaking through a true Jewish heart, and not the frothy ebullition of a spasmodic "geyser," a consistent Jewish attitude, and not mere aping imitation of Episcopalianism, are the rounds in the ladder which reach to fame in the Jewish pulpit. Stand from under!

The marriage of Miss Ora Slaughter, of Eminence, and Mr. Leon Kaufman Frankel, of this city, took place Wednesday, Nov. 22, at high noon, in the Christian Church. The ceremony was performed by Dr. H. G. Enelow and was followed by the breakfast to the immediate families and the bridal party at the home of the bride's parents, Mr. and Mrs. J. Slaughter.—Chicago Israelite.

Are there no halls, synagogues or temples in Louisville that marriages of Jewish people must be performed in the Christian church? Or, perhaps, Dr. H. G. Enelow is seeking notoriety.

Death of Chief Rabbi Zadoc Kahn.

It is with the utmost regret that we record the death of Mons. Zadoc Kahn, Chief Rabbi of France, which occurred in Paris on Saturday last. The deceased rabbi, who was the personification of gentleness and kindness, had been sick for some time, but his death was unexpected.

Mons. Zadoc Kahn was born at Mommenheim, Alsace, February 18, 1839. He was educated at the rabbinical school at Metz, and at the Seminaire Israelite of Paris, of which he subsequently became rector. In 1868 he became chief rabbi of Paris, and in 1889, after the death of Grand Rabbi Isidore of France, Zadoc Kahn succeeded to his place. He was widely active in philanthropic undertakings, and 1870 his services were recognized by the French Government, which appointed him Chevalier of the Legion of Honor. In 1901 he was made an officer of that order. He was also an officer of public instruction.

Rabbi Zadoc Kahn was a brilliant orator and a scholarly writer. Some of his works are: "Sermons et Allocutions Adresses a la Jeunesse Israelite," "Biographie de M. Isidore Loeb," and "Religion et Paix."

Prof. Adolph Cohn of Columbia University is a nephew of the deceased Chief Rabbi.

ONE of Philadelphia's most respected citizens who is properly regarded as the leader of the Jewish community, and a man who is held in the highest esteem by both Jew and Gentile is Mayer Sulzberger.

Judge Sulzberger has been a prominent figure in the community in which he dwells for very many years, and his reputation extends far beyond the territorial limits of his native city. In his early days he was much sought after and his services brought into repeated and active requisition as a lecturer and his frequent appearance gained for him the well-deserved reputation of an earnest, thoughtful speaker upon the platform in many of the largest cities of the Union. He has always identified himself with Jewish congregational and communal affairs, and has been an ardent supporter of every measure which tended the elevation and glory of our people.

As a lawyer, he reached the height of his profession. He was held in such high esteem by his clients, that many insisted upon making him executor or trustee under their will.

He was elected by the people of Philadelphia as a Judge of the Court of Common Pleas of the First District of Pennsylvania, of which Court he is now the presiding judge. He accepted the position of Judge of the Court at a time when he enjoyed one of the most lucrative practices of any lawyer in Philadelphia. As a Judge he has won the highest esteem of his fellow-citizens and the personal esteem of every member of the bar, and he displays such eminent fitness for the position by reason of his extraordinary abilities that he has been re-elected to the office which he now holds and has creditably filled for many years.

Judge Sulzberger is a man of exceptional literary attainments, a scholar, both in Hebrew and English, of the highest order. He has for many years had the largest private library of any citizen of Philadelphia, amounting to over forty thousand volumes, containing many rare and valuable Hebrew works and manuscripts, which, with a munificence and self-sacrifice, he presented to the library of Jewish Theological Seminary, of which he is an active Director.

In his early days he was a valued contributor to the *Occident*, and after the demise of the late Isaac Leiser, continued the publication of that journal.

He is a leading spirit in all the Jewish eleemosynary institutions of Philadelphia, executor of the will of Moses A. Dropsie, and trustee of the college bearing that name.

Judge Sulzberger delivered the ora-

tion at the 250th anniversary of the Jews celebrated at Carnegie Hall on Thanksgiving Day.

The Judge was born in the Grand Duchy of Baden, and received his education in Philadelphia, where he has always resided.

Altogether, Judge Sulzberger has been an active citizen, beloved and respected by all who know him. He is, to the deep regret of the Jewish ladies of Philadelphia, a bachelor.

**CORRESPONDENCE.**

Christmas in Our Public Schools.

EDITOR HEBREW STANDARD:

I have several times called attention to the misuse of power by some of the public school principals and teachers, who introduce into the public schools of this city a religious celebration at this season of the year. The explanation is given that the exercises do not convey any religious significance, but are merely expressive of the "Love and goodwill" prevalent at this particular season.

I dispute the accuracy of this statement, both in fact and in theory. Some two years ago Superintendent Maxwell issued an order prohibiting the teaching of hymns that had any sectarian tendency, etc. In spite of this, some instances have already come to my knowledge of preparations that are being made to celebrate Christmas in some downtown public schools. Some of the children of my classes report that they have been chosen to take part in "Santa Claus" plays, etc. In some cases the children say that they have been told to ask their parents whether they have any objection to their taking part in the celebration. The mere fact that this question arises at all shows that the teachers know that what they propose to do is open to objection.

By the light of our experience in similar matters, we can easily understand that nothing less honest could be urged as an excuse for doing something that should not be done at all.

We do not forget the exhibition, in a West Side Church, of some Jewish children as converts to Christianity "with the consent of their parents and Rabbi." As a matter of fact, the parents knew nothing about it, and there was no Rabbi who even could have been consulted.

I call upon Jewish parents to inquire into the details of what their children are being asked to do in their schools during the next couple of weeks and to see to it that their children do not take part in any celebration that partakes in any way of being a Christmas Festival.

Our brethren in Russia are suffering enough in defense of the "Honor of the Name," and it should be an inspiration to some of our weak kneed brethren here. The out-and-out missionaries find the task made much easier when the minds of our children are impregnated with a sympathy with Christianity through the celebration of Christmas in any way in the public schools. It is about time that it was put a stop to.

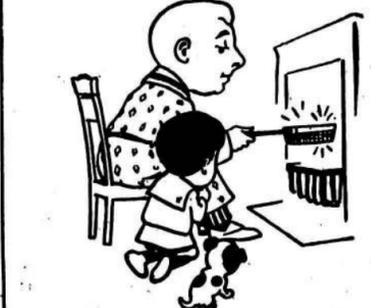

Home Hints.

THE GIRLS' COLLEGE.

A Sharp Criticism of This Now Popular Institution.

If an instinct lies dormant too long there is danger of atrophy. The four years that a girl spends in college are the last of her best learning years, and during that time, except in some colleges which are experimentally inclined, the domestic half of her mind is left to shift for itself. For men there are special courses in agriculture, engineering, law and medicine, but the greater woman's colleges content themselves with expanding the student's brain merely. Until the woman's college can prepare a girl for her specialty as well as a man's college prepares him for his it must remain, after all, a rather ornamental thing, not in every way comparing well even with the "finishing school."

In the aim to make the college education of a girl equal to that of the boy similarity has been mistaken for equality. The girl in the man's college, with her masculine environment, is a reversal of the story of Achilles among the maidens. Give her, along with her higher mathematics, Greek, biology and what not, the modern equivalent of a distaff, and she will seize upon it as eagerly as poor Achilles did upon the sword, and until she does receive the modern equivalent of the distaff the college provided for her will be a thing borrowed from the other sex, not a growth from woman's needs.—Collier's Weekly.

BEING WELL DRESSED.

It Is More a Matter of Detail Than It Is of Money.

We all like good clothes and the feeling of being well dressed. It is not entirely a question of money. It is also a matter of detail and of giving a small portion of our time to keeping our belongings in order. No matter how expensive or well fitting one's dress is, the appearance is spoiled by a soiled stock or piece of lace or a crushed and frayed skirt.

Just stop and think what a saving of time and money the short skirt is to a woman, especially the busy woman. No skirt braids need renewal, no frayed edges give her an untidy appearance.

Take a look at your everyday skirt, think what an improvement a good pressing would be to it. This can be done very easily at home and should be done every week or two. Place your skirt on a covered ironing board and have handy two hot irons rather heavy in weight. Now cover the portions to be pressed with a thoroughly wet piece of unbleached muslin folded double and when pressing don't move the iron too quickly over it, but press until the material stops steaming, says Woman's Life.

Should there remain dull or glazed spots sponge lightly and press again. This repressing when damp will form steam that will remove such spots.

THE HOME DOCTOR.

Warm friction with a rough towel will generally give quick relief to cramps in the legs.

The fire can be drawn from a burn by applying cloths wet in strong alum water. It will also assist in relieving the pain.

If you have charge of a relative suffering from diabetes keep in mind that beet root may not enter into the dietary. This because it is rich in sugar.

Lemon sirup made by baking a lemon twenty minutes and then squeezing the juice upon half a cupful of sugar is excellent for hoarseness and will break up a cold.

When your feet are very tired bathe them in hot water; dry, go over them with olive oil, wipe and apply powdered starch freely. They will feel a source of joy instead of pain.

How to Make Pickled Cabbage.

When pickling cabbage shave or cut fine good, firm cabbage to measure four quarts, chop fine one large onion and two red and two green peppers and mix all well together. In a stone jar place alternate layers of the mixture and a level tablespoonful of salt; let it stand in a cool place for twenty-four hours, then drain, pressing out all the liquid. Mix together one-half cupful of white mustard seed, one

quarter cupful of whole cloves, as much allspice and one tablespoonful of whole peppercorns. Pack the cleaned jar with alternate layers of the cabbage and spices. Pour in slowly sufficient cider vinegar to cover and set aside in a cool place. This will keep for some time if kept cool.

The Reigning Princess.

Every girl who has married and moved to another town learns in course of time how it feels to be a monarch who is deprived of his kingdom. She is a princess before marriage and has the front room upstairs. She marries, moves away, her sister next in years becomes the reigning monarch, and when the married woman returns home on a visit some years later she finds herself relegated to a back bedroom, with her sister, the princess, on a throne in the front room.

How to Make Damson Pickle.

To pickle damson plums put one pound damsons in a stone jar. Boil together one-half gallon vinegar, one pound sugar, one teaspoonful whole cloves, one tablespoonful each whole allspice, mace and broken cinnamon. While the vinegar is hot pour it over the fruit. Repeat this for five days. On the sixth day boil the fruit for thirty minutes and put in sealed jars.

How to Remove Scars With Olive Oil.

A daily application of hot olive oil, well rubbed in with the tips of the fingers, it is said, will very much lessen the unsightly appearance of scars.

How to Save by Judicious and Economical Buying.

Careful purchasing of household necessities is one half the secret of economy, while careful use of the article bought is the other half. Economy in buying consists in the perfect adaptation of the purchase to the purse and needs of the family.

First.—The article should be worth the amount asked for it—that is, its intrinsic value should be such that, as prices average, you are getting the full worth of your money. If it is an article for the table it should be in good condition to use and of good weight and measure. Nothing is worth buying at all that is half spoiled or that will not wear well in proportion to its cost. If for personal or housekeeping purposes, its quality should be the best to be obtained for the price.

Second.—The article should supply a genuine need. The need may not be immediate, but it should be both possible and probable. Many things can be purchased by watching the sales between seasons, when rather than keep them over the shopkeepers are willing to sell even below cost. But only standard goods should be bought in this way. Many persons have a mania for buying everything they see that is cheap, and then perhaps they never use it. Food, clothing and household articles are often accumulated without regard to quantity, and then changing fashion makes them worthless, this being especially so with ornamental things. Buy of such only what you actually need.

In purchasing for the table a list should be made out the day before and looked over the next morning. In buying groceries a list is indispensable if one would buy cheaply—have just enough and do not forget at the critical moment just how much is really required.

And when one does not go to market every day, and few do, a few minutes spent in seeing how much is on hand that can be used and a short menu of the meals of the next two or three days made is time well spent, for in this way a lot of perishable stuff would not be ordered, but, say, a roast, with possibilities of cold meat and rissoles or stew, or some other piece of meat that can be utilized in several ways, and vegetables which will keep at least three days. One can easily learn to market for three and four days at a time, and thus one saves time and money. In buying a roast of beef insist that the bones cut off from your meat be given you, and get a couple of knee joints of beef and one of veal at the same time. These make the finest stock, and from that hundreds of different things, all good and wholesome, can be made, and if you go to buy them alone you have to pay much more than if you purchased a large joint besides. Often a butcher will throw in one or two knuckles where a leg of lamb or some other rather expensive piece has been taken. It is in quality, good judgment and

In buying only what is needed, and that after reflection at home, that the good housekeeper is known and in which true economy consists.

How to Remove Grease From Hands. A preparation that will remove grease and stains from the hands is this, which should not be used if there are cuts, as it will burn intensely. Cut into small bits an ounce of any nice laundry soap and dissolve it in an ounce of fresh lemon juice. It may be necessary to warm the juice to do this, in which case put the liquids in a small bowl and set into a saucepan of boiling water until the soap is dissolved. Remove from the heat and add one-half ounce of oil of bitter almonds, one-half ounce of glycerin and a quarter ounce of carbonate of potassium. Use as you would soap, rubbing it first well into the hands before applying water.

How to Preserve Green or Wax Beans. A good way for preserving green or wax beans is to soak the beans for a few hours in cold water or parboil them slightly, says Good Housekeeping. Cut them in long, thin slices and pack in large jars with generous layers of salt between the layers. When the jar is full cover with a cloth and put on a weighted plate to keep the beans in the brine. They should keep perfectly until spring.

CARE OF WOMEN'S FEET. How to Keep Them Pretty as Well as Comfortable.

One's general health depends largely upon the comfort of one's footwear and the judgment used in the selection. If young women are sensible about choosing out of door shoes I think some leniency must be permitted them in house shoes, says a writer in McCall's Magazine. Have some pretty slippers if you can afford them. Have one pair if no more. The young woman who is employed all day will take much pleasure in pretty slippers with which to replace her shoes when she comes home in the evening. It is well to make a shoe bag for one's room and have the slippers where they are easily at hand. Even if you are tired you will find the change of footwear to be infinitely restful. It is well to have more than one pair of walking shoes too. By alternating these one throws into play different muscles which aid in resting the feet.

Do not wear shabby shoes in rainy weather. Even if they are covered by "rubbers" these must be removed during office hours, and nothing is a surer indication of one's neatness than the shoes. If they are worn, see that they are blackened. Wear the best shoe you can afford. They will last longer and hold their shape.

To go back to house slippers—a much daintier subject—be sure to discard them when they show a tendency to become worn. It is a temptation to wear old slippers when they have grown comfortable. Have them comfortable in the beginning and avoid the untidiness of down at the heel footwear. A woman's heel is almost always attractive when daintily dressed and never more so than at home.

The feet should always be bathed at night, and by removing any weariness this treatment is an excellent sleep producer. The water should be salted, allowing two tablespoonfuls of salt to a quart of water, and let it be hot or cold, according to individual constitution.

The feet should be scrubbed all over with a nailbrush, which will often prevent a formation of corns, and hard spots on the soles may be reduced by using a fine piece of emery paper or a fine file before the feet are placed in the water.

The brine may be made by dissolving a pint of sea salt in two quarts of water, pouring it into a covered jar or bottle and allowing it to stand for twenty-four hours. As the brine is used, the bottle may be filled with clear water, repeating the process until all the salt is gone.

A powder used in the German army for sifting into the shoes and stockings of foot soldiers is called "fusstreupulver," and consists of three parts of salicylic acid, ten parts of starch and eighty-seven parts of pulverized soapstone. It prevents chafing.

Shipping Wild Animals. Of all the creatures to be seen at zoological gardens snakes are probably the most easy to ship from one country to another. Lions are not very troublesome considering their size and

strength, the boxes in which they travel look out of all proportions, but there is method in placing these animals in small cages or boxes, because it deprives them of the chance to get a good spring. Snakes take very little room and throughout a long voyage give not the least trouble. They do not require to be fed, nor do they require looking after in any other way. Pythons starting on a long voyage are put into a large cloth bag and tied up. The bag is slipped into a box just big enough to hold it, and a piece of cloth is nailed over the hole cut in the top of the box. Nobody pays any further attention to the reptile until it reaches its destination.

How Benjamin Franklin Worked. Benjamin Franklin when he set to work to discover his faults and to correct them adopted a very rational plan. Upon a piece of paper he set on one side five or six faults to be got rid of. The other side of the paper was divided into seven columns, each labeled with the day of the week. 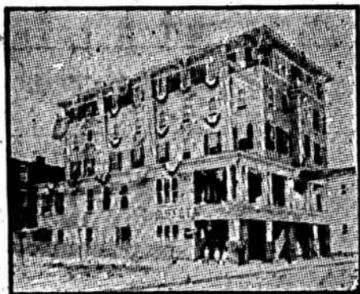
