A Unique Jewish Colony—A Word to the Baron De Hirsch Fund.

AM sojourning for the second time in a unique Jewish Colony, the like of which I have not found in the history of Jewish farming in the Diaspora. The Colony I mean, is named "Garten Road," it is situated between two Jewish colonies, Rosenhayn and Carmel, N.J.

The population of "Garten Road" is between fifteen and eighteen Jewish families, whose sole occupation is "farming" in the full sense of the word. The Colony is not under the protectorate of the "Baron De Hirsch Fund;" may be some individuals have some business transactions with the office of 45 Broadway, but the Colony as a body is free and independent.

Two years ago I had my vacation there, and now, I enjoy my second sojourn, which has enlightened me upon the problem of Jewish farming. I found a beautiful institution *a la* "Educational Alliance" with a fine circulating library. The places of worship one an orthodox, and the other is going to be built on the basis of Moderate Reform, to the latter the "Ladies Benevolent Society" has donated an expensive Scroll of the Law. They have a Hebrew school, and a Public one, and in each home you will find some Jewish newspaper subscribed for.

Two years ago I found all farmers sitting side by side with young ones, whom I took for their grandchildren, listening attentively in the night-school to a teacher.

I was a year in Woodbine, a colony created by the "Baron De Hirsch Fund," with a population of more than two hundred Jewish families, and three manufactories, and endowed with "home rule," and yet I found there friction, strife, and each one of

them was either a Job, who cursed the day of his landing there, or he was a Jeremiah, with a lamentation of his ill fate and disappointments.

Carmel was once a flourishing colony with corporation shops, and subsidized by the "Fund." But the flourishing was like that of the flourishers,

of short duration. The workers in the shops have been scattered to all the corners of the land by the ill wind "Kismet," which blows *co* good.

The few farmers who, from the start, devoted themselves to farming are still on the laps of mother earth.

Rosenhayn, with a few Jewish cloth-

ing shops, where, in time of strikes, the scabs find their shelter, is the poorest of all the Jewish colonies founded by the "Fund."

The success of that gnomonic colony of "Garten Road," has forced me to switch up my train of thoughts from philosophy and poetry upon the rails


of "political economy." "Garten Road" has no superintendent, for every farmer is superintended by the weather Bureau, and accordingly he regulates his farming, while in the other Jewish colonies, which are supervised by a representative from the "Fund," who often does not know the A, B, C, of agriculture, orders the farmer to do his farming according to his command, and the poor farmer must obey for he is the boss.

Manufactories on a large scale is a blessing in a village, but not in a colony, especially in a Jewish colony, for it is the breeding place of envy and jealousy, for if one gets a few dollars more wages, the others are envious, and consider it as favoritism by the manager, and this becomes the root of strikes and sufferings.

I remember the last strike in Woodbine, when most of the ablest young men left the colony with curses behind them; a farmer cannot succeed in farming where there are shops, for they divert his mind from the study of "farming." "Garten Road" has no boss, and no manufacturers, and they say as the dove of Noah said, "it is sweeter to me the bitter olive leaves from the hand of God than the sweet fruit from the hand of man."

If the "Fund" will bring up Jewish farmers, let it remove from its colonies, the bosses, and the sweat-shops and factories, and let them study the grammar of agriculture, pure and simple, as all other farmers do. Let the motto of the "Fund" be the saying of our Hillel the Great. "Let the children of Israel alone, for they know what they are doing."

Those who find revenge sweet to the taste usually suffer later from moral indigestion.

As announced in last week's issue of the Hebrew Standard, the Rev. Martin E. Meyer, rabbi of Temple Beth Emeth, Albany, N. Y., has been selected to succeed the Rev. Dr. J. L. Magnes as spiritual guide of Temple Israel, Brooklyn.

ed in glowing lines. He composed "Samson and the Philistines," a drama of the Biblical epoch. (A fragment of this drama has been published in his work of Rhetoric "Lshon Limudim.")

This early work outlined already the future author. Very beautiful are the monologs of Samson, and most forcible is his monolog before his tragic death. Luzzatto's dramas "The strong tower," (Migdol Oz) and "Glory to the Virtuous" (Layshorim Thilo) are full of beauty and vigor, grace and elegance, and in them color and euphony prevail together. He had a poetic, delicately strung-soul which responded to every breath with harmonious vibrations.

His drama in four acts, "The Strong Tower," is beautiful in versification, melodious in eloquence, but shallow in thought. The then young poet had not yet seen life in its fullness, nor given attentive study to its struggles and metamorphoses.

He had an idea of idyllic family life, but virtue and vice, love and egotism, which he describes in his drama, were not very familiar to him. His allegoric drama "The Strong Tower" originated at that time, in which the influence of such Italian examples of drama, as Guarini's "Pastor Fido," has flourished. The foundation of this drama is a moral one: the victory of justice over wickedness. A great many parts of this drama exhibit the influence which the Scripture exercised over Luzzatto particularly the "Book of Job." (Viz. Act iv. Sc. iii.)

His drama "Glory to the Virtuous" differs materially from his earlier works. The tendency of same is a philosophic moral one. It possesses an indescribable charm, not alone in its subject matter, but also in its artistic form, which proves how flexible the Hebrew language is. The characters of the drama are not mere puppets; the author has depended largely, not on his imagination alone, but on his varied experiences.

Luzzatto's masterpiece is not a drama in the broad meaning of the term. The characters represented are not of the concrete kind, but mere abstractions: Reason and Folly, Merit and Deceit are put on the stage. The dramatic action is trifling. The drama is merely a pretty garland, a wonderful combination of very high lyric monologues and thoughtful didactic dialogues. (Viz. act 1. Sc. iii; act 2. Sc. 2.)

The first act takes up the injustice of mankind, who esteem deceit above merit, and closes with the admiration of solitude and confidence of the pious virtuous. The second act describes the hopes of the virtuous and his fate. The third contains the praise of truth and justice.

I shall conclude with Delitzsch's view about this drama in his work "Geschichte der Juedischen Poesie," p. 92: "All fragrant flowers of the Biblical poetry appear here, as if upon a prairie closely grouped together; the language is not a mosaic of Biblical phrases, but an enamel of the most rare and beautiful Biblical elegancies."

A number of mistakes appeared in my first two articles, as space does not permit the correction of all, I will correct but the most important four errors.


- 1). In art. 2., line 6, should read *our* instead of *one*;

The Development of Modern Hebrew Literature.

III.—MOSES CHAIM LUZZATTO.

"There is no more successful method of awakening an interest in Hebrew studies, than to direct attention to the lives and works of men who wrote Hebrew with the facility of a mother-tongue."—Isaacs.

Moses Chaim Luzzatto (b. 1707, d. 1747). After Immanuel, the Hebrew Muse became silent for a long time and it required a fresh powerful stimulus to awaken it from lethargy to new activity. Verses were, of course, written before and after his days, and rhymes were polished, but they were as remote from real poetry as a popular air is from a soul-stirring melody, and it is giving too much honor to term such writings poetry. Some of these verses show a fair command of language on part of the authors, but they lack both potency of expression and elegance. Others again, are but of such degree as to expose its authors as mere versatile postasters, whose language is often rough, and whose allusions point out a decisive lack of taste; they sink into puerilities where they should rise to lofty thoughts. It is of such

books that Ingersoll speaks, as successful prescriptions for insomnia.

In the first half of the seventeenth century there were added to the Hebrew literature, among other literary productions, two Hebrew dramas: "Foundation of the World" (*Yesod Olam*) by Moses Zacut, and the "Captivity of Hope" (*Asirei Hatikvah*) by Joseph Felix Penso. Both dramas possess little poetical merit, but they are important evidences of the desire of the Jews to use Hebrew for all forms of literary art, inasmuch, as even the greatest Hebrew poets, Gebirol and Jehuda Halevi, produced only lyric and didactic poetry, not directing the least attention to the drama.

Though the before mentioned two dramas preceded those of Luzzatto's, he, in truth, may be called the real pioneer of Hebrew dramas. He wrote under the influence of the Italian poet Guarini. His metres, his long soliloquies, his lyrics, his dovetailing of rural and urban scenery—all are directly traceable to Guarini. Luzzatto was, nevertheless, an original poet. His mastery of Hebrew was complete, and his rich fancy was expressed

It was evident that the 170 boys and girls intrusted to Mr. Goldstein's care were most attentive and receptive. It would be well for some congregations of adults to follow the laudable example of the rising generation whose attention was rivetted on their teacher's words. M. A. LEVI. A plain evidence that Moses was influenced by no worldly or ambitious views; or rather he was not the constructor or author of the law which he gave to Israel, but received it from God; for had he framed it, it is natural to suppose, he would have made some better provisions than he did for his sons and for the grandeur of his house, and not have advanced his brother's above his own own.

B. NIEMANN. As in ancient times the ordinary meals were not so many in a day, so neither were they costly; and, therefore were they called *ארוחת* *aruchoth*, which probably signifies such fare as travelers use on their journey; whereas the extraordinary and more liberal kind of entertainment was called *משתה* *mishteh* "feast."

S. H. FOX. The words which we translate "Man became a living soul" (*Gen. ii, 7*), are rendered in the Targum (*Chaldee Paraphrase*), "The breath, breathed into him by God, became in man a speaking soul."

A. R. DOBLIN. Originally the accusation of using blood for ritual purposes on Passover was made by the Heathenish Romans against the early Christians who were then known as Jews. Later on, the Christians brought the self-same accusation against the Jewish people. In the dark ages of Christian history the story was circulated by a monk and as a result hundreds of thousands of Jews were killed. To show that this was not the case, the Jews would open their doors on the eve of Passover for the purpose of permitting the Christians to enter and see for themselves that there was no sacrifice, but the story would not down, and in some benighted countries in Europe, notably in Russia and Austria, it lives to day.

JOSEPH NATHANS. There are no specified days upon which Reform Rabbis refuse to perform a marriage ceremony. All functions of this nature are regulated by Jewish law, which have no legal or binding force upon them.

Will Justice Prevail?

WHAT has become of the Dreyfus case?

Two years ago it seemed certain that the French Court of Cassation would take up the request for a revision of the court-martial at Rennes. Then Dreyfus' counsel fell ill and the case was again shelved. Of the prominent friends of Dreyfus who secured the re-opening of the question and his return to France after five years' imprisonment on Devil's Island, Scherer-Kestner, Zola, Bernard Lazare and Traireux are dead. Clemencieux is alive and Minister of the Interior.

Found guilty of treason and publicly degraded in 1895, Dreyfus' second trial was an even worse travesty upon justice than the first, because it was enacted in public and the absence of incriminating evidence could not be concealed. The army demanded a victim. Even so, the judges were divided, five on one side and two on the other. Dreyfus was sentenced to 10 years' confinement in a military prison in France, but his judges spoke of "extenuating circumstances" They prayed that he might not be degraded. The Rennes court-martial in effect had morally cleared him while sacrificing his person, fortune and future in its unreasoning prejudices. A pardon was granted the convicted officer and freedom, but against his name stands the record of a crime not proved but of military record.

Of his accusers and his persecutors the record remains blackened for all time—Esterhazy, confessed forger, blackleg and refugee from justice; Henry, forger, traitor and suicide; Lemercier-Picard, forger, blackmailer and suicide. Paty du Clam and Mercier came off little better. The documents they manipulated, manufactured, suppressed and destroyed all really tended to confirm the innocence of Dreyfus and the existence of a clumsy and malicious plot to ruin him.

He was vindicated five years ago, but will no efforts be made to rectify the records of the war office? Must he remain for the rest of his life in enforced obscurity and virtual disgrace because no Zola lives to force France to do justice.—N. Y. World.

A Model Institution.

TAKEN unawares by a critical visitor, the officials at the Hebrew Sheltering Guardian Society's Orphan Asylum, Washington Heights, are not in the least disconcerted. They are placid and reposeful amidst the orderly and peaceful surroundings. Everything looks spick and span. The time of the visit is a few minutes before the public service in the Asylum Synagogue where some 170 boys and girls, neatly dressed and well behaved are assembled, awaiting the signal from the Rev. Jacob Goldstein. The bell rings and the impressive liturgy is launched by the excellent singing of a girls' choir, led by a thorough musician—Mr. Weinstein. There are 24 girls in the choir, one of whom is the leading soprano. The singing is excellent throughout the service. But whilst the chant is an important feature it is scarcely overshadowed by the onerous duties performed by the Rev. Jacob Goldstein, who recites prayers in Hebrew and English, reads the Torah, translates the portion of the day direct from the Scrolls of the Law, and closes the service with an instructive sermon.

It is the first day of *Shabuoth* and the text chosen by the earnest lecturer was the story of the giving of the Law at the foot of Mount Sinai, including the Ten Commandments. Good conduct in life of the Jewish man or woman was the lesson which the preacher strove to inculcate, and

TO RESTRICT IMMIGRATION.

A Mighty Protest Monster Meeting at Cooper Union—Plan to Send Immigrants South—Fight in Congress.

THE PROTEST MEETING.

That the Dillingham bill and the Gardner amendment now before the House of Representatives will not be permitted to pass into law without a mighty protest being made against the injustice of the proposed enactments is evidenced by the monster protest meeting held on Monday evening last in the large auditorium of Cooper Union under the auspices of the Jewish Federation of New York, and similar gatherings in other parts of the country.

Readers of the Hebrew Standard will gather the purport of the bills from our editorial on page 8.

Over three thousand persons filled the spacious hall and many more had to be refused admittance, owing to the lack of room.

Eloquent addresses were delivered by the Hon. Edward Lauterbach, who acted as chairman, Congressman Bennett and Goldfogle, the Revs. Thomas R. Slicer, Madison C. Peters, H. Masliansky and J. Seft, Arthur Brisbane, Michael F. Conroy and Joseph Barondess.

Resolutions protesting against the restriction of immigration and asking that Congress pass a law permitting the appointment of a commission to study the question of a proper distribution of the immigrants, and that a delegation appointed by the chairman of the meeting be sent to Washington to present these resolutions to President Roosevelt and to Speaker Cannon were passed unanimously.

Edward Lauterbach, chairman of the meeting, asserted that the main reason for strongly protesting is because this proposed measure is known to be only a precursor of more stringent immigration laws in future. He said the administration yearly accumulates a surplus of millions under the present law of taxing immigrants two dollars per capita, which certainly proves that this country does not need the money.

The Government, therefore, instead of trying to raise the head tax to five dollars, would do much better in devoting these surplus millions for proper distribution of immigrants.

Congressman Bennett, who, with Congressman Goldfogle, had come on from Washington to address the meeting, was the next speaker. Mr. Bennett, who is leading the fight against the measure in the House, won great applause when he declared that every Congressman from Manhattan Island would vote against the measure. In barring out the immigrants, he said, we do America an injustice, but we have hopes of defeating at least the worst provisions of the bill.

Representative Goldfogle spoke and assured that he will certainly do his duty when the question comes up in Congress. In introducing Michael F. Conroy, who, as an Irishman, spoke against the bill, the chairman paid a tribute to Michael Davitt for his great services to the Jews after the Kishineff massacres, and at his request the whole house rose in tribute to his memory. The Rev. Madison C. Peters, in his address, pictured the sad conditions of the many poor in the con-

gested districts. He said this country needs all immigrants who are willing to work and become Americanized, and as there are millions of acres awaiting the coming of new arrivals, therefore a proper distribution of these immigrants would solve the problem.

Dr. Thomas R. Slicer spoke against the restriction of desirable immigrants, and particularly against the educational qualification. He said: "The Jews number eleven millions, all told. They could all find room in the State of Texas, and yet leave much room for more comers. That the Jew is not faultless we have our Christian civilization to blame. It is the comedy of history that the Christian nations have taken the Bible and spurn its source—the Jews. The only way to atone for this iniquity is for us to gladly welcome every Jew willing to come and settle in this great country."

Congressman Goldfogle, in the course of his speech, stated that many of those who in Congress were in favor of restriction had absolutely no knowledge of the whole question.

Rev. H. Masliansky, in an impassioned address, said that the restriction of immigration was contrary to the spirit of the Constitution and of those who established this Republic.

Mr. Joseph Barondess ridiculed the statement that immigrants lowered the rate of wages.

A protest petition addressed to President Roosevelt and to Congress with space for 25 names and addresses on each was handed to everyone in the meeting. These petitions, when signed, will be taken to Washington by the delegation named in the resolutions. The Hebrew Orphan Infant Asylum Band provided music, which was liberally applauded by the audience.

IMPORTANT AMENDMENTS.

We are in a position to state that every opposition will be offered to the clause of the Dillingham bill, giving the examining surgeons at the ports of entry the arbitrary power to decide whether an immigrant is mentally and physically fit to earn his livelihood, and, secondly, an amendment will be moved to the effect that all refugees from religious and political persecutions shall under all circumstances be admitted into the country.

NATURALIZATION BILL PASSES.

On Tuesday the House of Representatives passed the bill establishing a Bureau of Immigration and Naturalization and providing for a uniform rule for the naturalization of aliens throughout the United States.

The bill as passed provides for a Bureau of Naturalization at Washington. It requires an applicant to file a petition for naturalization ninety days before it is acted upon by a court. It prohibits any naturalization thirty days before any general elections. It adds the additional qualifications that applicants must be able to speak English before receiving final papers, and they must swear that they intend to reside permanently in the United States.

Congregation Beth-El.

The first Jewish temple in the Martense section is now being erected by the members of Congregation Beth-El of Borough Park, at the northwest corner of 41st street and 12th avenue.

According to the plans filed with the Building Department by J. C. Walsh, the architect, the building is to be of Moorish design, half brick and half frame, and if present arrangements are carried out, will be completed in August next, in time to celebrate the fourth anniversary of the founding of the congregation.

The congregation was organized in August, 1902, when there were but very few Jewish families in the neighborhood, but so many have since then taken up their residence in the section that the temporary house of worship which the congregation occupied, at the corner of 40th street and 13th avenue, became much too small and the necessity of a much larger building apparent. They decided to build on a plot of ground 50x100 inches, which they owned at the corner of 13th avenue and 41st street, and on Sunday next, June 10, at 3 o'clock in the afternoon, Michael Furst will lay the cornerstone with appropriate ceremonies.

All the borough officials have been invited to take part in the exercises, and many have signified their intention to be present, among whom are County Clerk Chas. T. Hartsheim and his deputy, Bela Tokajl.

The Building Committee, of which Henry Lyons is chairman, is composed of the most active members, and includes the following: M. Napelbaum, S. Gurian, Sr., J. Holman, H. Wilner, S. Elgard, D. Bussan, J. Becker, E. Rapoport, A. Flaxman and M. Kadin, who are working very hard to bring their efforts to a successful conclusion.

The Ladies' Auxiliary have been doing excellent work during the past winter, and succeeded in raising quite a nice sum of money, which they have turned into the Building Fund.

The officers of the congregation are: M. Napelbaum, president; E. Rapoport, vice-president; H. Sartzlich, second vice-president; P. Gurian, Sr., treasurer; Wm. Wasserstrom, recording secretary; and Henry Lyons, financial secretary. Office, 1260 40th street.

Temple Israel's New Building.

Tuesday afternoon in the presence of over five hundred members and friends of Temple Israel, of Harlem, the corner stone of the new temple at 120th street and Lenox avenue was laid with appropriate ceremonies.

Attorney General Julius M. Mayer was the principal speaker.

"I look forward to the time," he said, "when our children may be referred to simply as American citizens. We should strive to make them, not Hebrew-Americans or Jewish-Americans, but American citizens of the Jewish faith. Americanism, loyalty to the institutions and the ideals of the country in which we live and work, should be first and foremost in all our training of the young."

Daniel P. Hays, president of Temple Israel, the master of ceremonies, urged the need of a broad religious outlook and co-operation. He referred to the fact that until the new temple is finished the congregation has been invited to worship in the Calvary Methodist Church, at 129th street and Seventh avenue. "Brotherhood and not isolation in worship," declared Mr. Hays, "should become one of the ideals of this temple."

The Rev. Dr. M. H. Harris, rabbi of the temple, told the history of the congregation, remarking that though it had been in existence twenty-five years this will be the first temple it has built.

Samuel Weil, former president of the congregation, performed the ceremony of laying the stone. He used a silver trowel given to him by the trustees.

Beneath the stone was placed a copper box containing newspapers, both American and Jewish, date, lists of the officers and of the members of the congregation, and the programmes of recent entertainments and services in the temple.

On the surface of the stone were cut the two dates 1896-1906.

The Rev. H. Newman read a Psalm, and the Rev. Dr. F. De Sola Mendes made the closing prayer. The band of the Hebrew Orphan Asylum furnished the music.

Temple Israel, of Harlem, recently sold its building at the corner of 125th street and Fifth avenue, which the congregation had occupied for eighteen years. The new temple will be ready for use about the end of this year. It will be a simple, substantial building of white stone designed on Colonial lines. On the main floor will be an auditorium seating 1,800 persons. A high basement will be divided into Sunday school and class rooms, the latter being a special feature.

Rev. Dr. H. Pereira Mendes, New York. To the Editor of Al-Moghreb Al-Aesa.

Dear Sir: You have already in your valuable paper drawn the attention of the public to the sheer distress of the Jews of this city and to the efforts made to alleviate their awful sufferings. I am very pleased to be able to report the receipt of substantial aid from England. We learned sometime ago that Mr. A. Lennox had written to Mr. S. L. Bensusan (some of us had written to London before without result), the well known journalist to enlist his influential pen on behalf of his starving co-religionists, we asked him to forward a petition and a statement of the number of the poor and the efforts of the local committee. Mr. Lennox confirmed our statement from his personal experience, and on receipt of these papers Mr. Bensusan sent them to Dr. Gaster, the Chief Rabbi of the Sephardic Jews, and also wrote powerful letters to the principal Jewish and other papers, with the desired result that a fund has been opened, and we hear that it has reached the sum of £300 on the 30th ult. This money is being carefully distributed by the energetic and able members of the local committee, and thus thousands are enabled to keep themselves alive. Many respectable families have kept life in by the proceeds of their few belongings, but now that these are all sold their only hope of existence is in the meagre allowances afforded them from these subscriptions. There are some 2,000 families on the committee's books, so that there is not much for each.

We have had good rains, but nevertheless the great distress will continue for the next two months.

Another Generous Gift.

Simon Guggenheim has donated another \$10,000 to the Colorado School of Mines, Denver, Col., making his total subscriptions thus far \$80,000. The money will be used to equip the Simon Guggenheim Hall.

February 14, 1905, Simon Guggenheim gave \$50,000 to the Colorado School of Mines. The board of directors immediately arranged to erect a building to be known as the Simon Guggenheim Hall. When plans were drawn for the edifice it was found that the work would cost \$70,000. Appreciating the requirements of the school and not wanting to see the original plans changed, Mr. Guggenheim added another \$20,000 to the gift. A few days ago he learned that there was no money at hand to equip the building and he gave another \$10,000 for that purpose.

Will Dedicate Cemetery.

Services will be held at Mount Zion Cemetery, Maspeth, Long Island, Sunday, when members of the Hebrew Veterans of the War with Spain Association will dedicate a gateway and fence, erect a flagpole and place a monument at the grave of the only member of the association buried there. Many societies are expected to take part. The Rev. Judah L. Magnes, of Temple Emanu-El, will speak.

The gateway is of granite. At the top of one column is inscribed the federal coat of arms and opposite the emblem of the order. Over the centre of the arch is a large granite ball crowned with a wreath of laurel surmounted by an eagle in bronze. There are a number of inscriptions on the column.

A plot for the burial of members of the association is surrounded by eighteen granite columns linked together with chains. The flagpole in the centre will be presented by the ladies' auxiliary of the association, of which Miss Anna Simmons is the head.

Morris Feltman, who served in the navy during the war, is the only member buried in the lot and over his grave the monument will be placed.

Isidore Weill is colonel of the association.

Moses Tried, and not Found Wanting.

FROM THIS WEEK'S SEDRAH.

Numbers.—viii.—xiii.

It was in the first month of the second year after the departure from Egypt, that the Israelites celebrated this first anniversary of their deliverance, and solemnly observed the Passover. One would have thought that the memories, thus religiously awakened, of the past unhappy bondage and the glorious redemption, would have sufficed to keep them good and grateful, at any rate for a time. But, unhappily, the easily roused nature "which took full easily all impressions from below, and half despised the height to which it would not, or it could not, climb," too soon forgot the enduring lessons of trust and content which such mercies should have taught and began grumbling and wearying Moses anew with complaints.

It would be almost laughable, if it were not so sad, to see the greedy form this discontent took. "We remember the fish," say these rescued slaves, for whom miracles had been wrought, "we remember the cucumbers, and the melons, the leeks, the onions and garlic which we did eat freely of in Egypt," and the complaints grew louder and fiercer.

Fancy the greediness, the utter want of self-restraint or self-respect which could set them longing for delicacies which, after all, must have had a bitter taste of bondage in the eating; fancy the utter ingratitude which loathed the God-sent manna; and we shall not wonder that "the anger of the Lord was kindled greatly and that Moses also was displeased."

Very sorrowfully the good, patient leader turns in his trouble to God, asking why he should be so afflicted; why he should have all a parent's trouble and anxiety without the personal love to make the responsibility pleasant, and with this vast multitude which so enormously increased the difficulty. "How," he exclaims almost in despair, "can I find flesh to feed them; for they weep unto me saying, Give us flesh that we may eat."

So the Lord answers His poor tried servant in the gentlest way, desiring him to gather the elders of the congregation together, that they may help him to bear the burden and anxiety, and adds, the sure help, "I will come down and talk with thee there."

Further, the gracious God promises that the mighty multitude shall be fed, and with flesh; and when Moses, wondering both at the mercy and the power implied in such a promise, speaks of the numbers so greedy to be fed, the Lord only answers, "Is the Lord's hand waxed short?"

The people soon learnt, as we all have to learn some time, by sad expe-

rien-e, the sorrow of granted wishes. We grieve often over unfulfilled desires, unsatisfied longings, ungranted prayers, and now and again, like our murmuring ancestors of old, have to find the real sorrow comes only when the gift is given, in angered answer to our blind impatient craving. "He gave them their own desire," says the Psalmist speaking of this incident; and the little sentence bears a wide meaning and wide moral. A desire so granted, in reply to selfish longings rather than patient strivings, proves often a curse rather than a blessing.

It was so in this instance; in the words of the Bible, "a wind went forth from the Lord and brought quails from the sea." "And the people stored up all that day and all that night and all the next day gathering the quails." Just as the manna had laid all round and about the camp, so now lay these quails, and the people were able now to "eat flesh" to their full.

While the coveted taste was yet fresh in their mouths, God smote them with a very great plague; so that numbers died in the very moment that their desire was granted, perhaps in consequence of it; for the food so greedily longed for, and which might have been both good and pleasant for them in the days of hard work in Egypt, they had never in their ignorant greediness stayed to consider, might affect them quite differently under their changed mode of living in the wilderness.

God gave them their desire; but you see they would have been much better and happier if they had been content with their manna, and had had faith enough to believe, that God gave, what He in His wisdom knew was best suited for their needs.

That trouble was scarcely over, and the pestilence stayed, when Moses had a fresh annoyance, and this time from his own family. Miriam and Aaron grew jealous of his influence, and spoke to each other in low discontented tones concerning him; flattering themselves by saying, "Hath the Lord spoken only by Moses? Hath He not spoken also by us?" and the Lord, whose right was thus questioned, in the Bible words, "heard it," and Himself defended His faithful servant. "Wherefore were ye not afraid to speak against him?" God asks, and His anger was kindled, and their unworthy jealousy was punished.

As the Cloud departed from the Tabernacle, the culprits looked at each other, and Aaron saw that his sister was stricken with that most awful disease of leprosy. We do not read that Aaron also suffered; so probably, as in most sorts of ill-natured gossip, the blame was unequally divided; and Aaron's share was sufficiently punished by the severe rebuke which God administered, which, as Aaron was the High Priest, must have been specially hard to bear.

When Moses saw Miriam suffer, his first thought was one of sorrow for her pain, and his second a prayer that she might be healed. The same grand nobility of character, which could feel neither jealousy nor revenge, showed itself now as it had done before, when, you remember, he had been appealed to in haste, because the spirit of God seemed to be showing itself in others in the camp, and they too were prophesying.

Things concerning the Clock.

The clock is so sensitive that it constantly keeps its hands before its face. This is due to the fact, that through no fault of its own it has been doing time for many years in the most public manner. What the Zionists are Doing.

The Young Men's and Ladies' Zion Gate of St. Louis, held a very interesting meeting on Tuesday of last week. The attendance was unusually large, owing to the presence of many non-Zionists who are interested in the movement. At present, this organization boasts of the largest membership among the Jewish societies of St. Louis, counting among its members most sincere and earnest workers. They have arranged a series of lectures on Zionism and various Jewish topics by members of the organization and persons well-known locally. Arrangements have just been completed for the annual summer reunion of the local Zionists to be held on July 1 at Ramona Park, as a souvenir of which a daintily gotten up programme containing many interesting articles on Zionism has been published. It is expected that this affair will be the most successful of the kind ever held under Zionist auspices. The entire proceeds to be derived from various sources in connection with the undertaking will be donated to the Jewish National Fund.

The B'nai Zion of Holyoke, Mass., have succeeded in establishing a most complete chain of educational institutions which does credit to the organization and should be a source of pride to the community. They have opened a B'nai Zion Hall, where lectures on Jewish topics have been delivered at regular intervals, attracting goodly attendance. A Talmud Thora for children has been established where the boys and girls are taught not only the subjects embodied in the ordinary curriculum of such institution, but also the use of Hebrew as an everyday language. As a complement to this school, a kindergarten will be opened. In addition to the free lecture given at the B'nai Zion Hall, those who are interested in Jewish matters are also enabled to follow up the subjects in books which are given for home use from the circulating library conducted by the B'nai Zion Association. This marks a promising revival in the Jewish communal life of Holyoke and tends to strengthen materially the Zionist organization. Most of the lectures were delivered by Rev. Dr. Wernikowsky, who was called to Holyoke from New York on the recommendation of Prof. Solomon Schechter. Dr. Wernikowsky also supervises the work done at the Talmud Thora and kindergarten.

Under the auspices of the Patriots of Zion, an enthusiastic mass meeting took place on May 27, at Providence, R. I. Rabbi A. Gorowitz, of Woonsocket, R. I., delivered an interesting address in Yiddish. He was followed by Mr. J. Rose, who was enthusiastically greeted by the local Zionists, having just returned from Russia after a stay there of two years. On his departure from Providence, the Patriots of Zion honored Mr. Rose by inscribing his name in the Golden Book of the National Fund in recognition of his activity in the organization.

The Ahawath Zion Society, of Ft. Worth, Texas, have elected the following officers at a recent meeting: Israel N. Hehl, president; S. Gilbert, vice-president; A. Salsberg, secretary; M. Sheinblum, treasurer; N. Ginsburg, L. Cohen and H. Brotke, trustees.

Rev. Mr. H. Masliansky, of New York, delivered addresses on Zionism in Yiddish under the auspices of the Zion Society of Syracuse, N. Y., on May 20 and 21. On both occasions Mr. Masliansky re-awakened the old enthusiasm of the Zionists and won over to the movement new adherents.

The recently elected officers of the Zion Society are: S. D. Solomon, president; Rev. H. J. Braude, vice-president; M. Jacobson, treasurer; H. Weinstein, secretary; Rabbi J. N. Rosenberg, press chairman; Messrs. Hanson, Levy, Sauber and Ehrlich, directors.

The arrangements that are being made by the Zionist Council of Greater New York for the picnic to take place on June 17, at Ridgewood Park, Long Island, promise to make this year's summer outing reunion one replete with interest and entertainment for the Zionists and their friends. Present indications are that the encouraging success of last year's picnic will be greatly eclipsed by the present undertaking. One feature which should attract a large number of persons will be the continuation of the bazaar instituted at the Ohanukah Feast for the purpose of holding the raffle of the various objects then offered. Tickets are to be obtained from New York societies, and at the office of the Federation of American Zionists, 165 East Broadway.

From the Four Corners of the Earth

A batch of about three hundred Russian emigrants passed through Paris recently en route for Havre, where they embarked for the Argentine.

Seventeen Jews have been returned to the new Hungarian Parliament. Twelve of these sat in the late Chamber of Deputies, which had twenty-one Jewish members.

The municipal elections in the fourth electoral district of Vienna have given a severe blow to the Anti-Semites. The Social Democrats captured four seats, including one in Dr. Lueger's own constituency.

M. Dreyfus and M. Gerschel, Central Commissaries at Dijon and Limoges, France, respectively, have received gold medals from the Minister of the Interior for having distinguished themselves in the preservation of order during the recent period of excitement.

An important sale of musical autographs took place recently in Berlin, when the collection of the banker, the late Herr Meyer Cohn, was dispersed. The collection included letters from Bach, Beethoven, Chopin, Gluck and Schubert.

Prince Ludwig, the heir to the throne of Bavaria, will visit Furth next week, on the occasion of the centenary festival of that city. He is to be the guest of a Jew, Herr Sahlmann, a fact which has caused much annoyance to anti-Semites.

The Hilfsverein der Deutschen Juden has addressed letters of thanks to Prince von Bulow, the German Chancellor, and Herr von Radowitz, the Duke of Almodovar, and Mr. Henry White, respectively representatives of Germany, Spain and the United States at the Algierais Conference, for their interest in the condition of the Jews in Morocco.

The new Prime Minister of Austria, Prince Conrad von Hohenloe, was, until summoned to this high office by the Emperor, Governor of Trieste. Only recently we mentioned the sympathetic manner in which he addressed the Chief Rabbi of that city, when handing to that functionary, at his own residence, the insignia of the Order bestowed on him by the Emperor. As Governor of the Bukovina, he also showed the utmost friendliness to the Jews.

In the course of an address recently delivered at Budapest, Count Stefan Karoly said: "I am a religious Catholic; but I respect every religion. On this account, I deem it most tactless and unpatriotic to foster religious dissensions in our midst, and to carry on an agitation which must lead to religious strife. Those persons who preach Anti-Semitism must be held in contempt by society, and must be punished for their proceedings. To those people belong certain Anti-Semitic agitators, whose names I will not condescend to utter."

The death is announced in Vienna of Imperial Councillor Moritz Hirsch, President of the Austro-Hungarian Export Association. He was a partner in the late firm of Karpeles and Hirsch, which has been amalgamated with the well-known house of Schenker and Co. His interest in Jewish affairs was shown by the fact that he was one of the Vice-Presidents of the Jewish Community of Vienna. Herr Hirsch devoted a large portion of his wealth to philanthropic works.

A movement is on foot for the establishment of a permanent Jewish museum in Prague. Many interesting Jewish memorials have been lost owing to the demolition of a section of the Jewish quarter for town improvements. The project has, therefore, been warmly welcomed. The Jewish Community has provisionally placed some rooms in the Council House at the disposal of the Museum Committee.

Herr Theodor Marcus, head of the important Berlin banking house of Marcus and Volkmar, died last week, after a long illness. For more than a quarter of a century he was on the executive of the Federation of German-Jewish Congregations. He also rendered valuable service on the Town Council of Charlottenburg (to which he was re-elected over and over again, notwithstanding the hostility of anti-Semites), especially in respect of the municipal budget. He was Chairman of the Liberal section of the Council, and was an Elder of the Merchants' Corporation of Berlin.

Borough of Richmond.

With the purchase of the lots on one of the most beautiful avenues of Port Richmond the speedy erection of the splendid structure of the new Temple Emanu-El of Staten Island, is now assured. Meetings are held frequently and means and ways are being devised to raise the funds. No doubt the generosity which always characterized Staten Islanders will also in this instance manifest itself. Only let all hands work in harmony and let all attempt to wrangle be stamped out. No drones for us. Work is what we want. Chairman Julius Schwartz and the charter members, every one of which is a prominent citizen of Staten Island are working earnestly and zealously to build up this sacred edifice which will be an ornament to the island and an honor to Judaism. The charter members so far are: Julius Schwartz, H. L. Bodine, Max Solomon, Gustave Strauss, Wm. Konowitz, Leo Sander, David P. Schwartz, Charles Weiss, David M. Hamburg, H. J. Weisburg, Morris Mord, Abraham Trohn, Phillip Schwartz, Sigmund Weiss, Jacob Bodine, Charles Greenwald, Joseph Goldstone, Samuel D. Wisan, John Rosner. There will be two more charter members elected and in the next week we will be able to report the final organization of the congregation.

The Hebrew Benevolent Society will hold its annual meeting at the home of Mrs. A. Mord on Thursday, June 14, 8 p. m. At the last meeting President Julius Schwartz handed over to M. Klauber, President of the Congregation B'nai Jeshurun in Tompkinsville, the sum of \$305.80, as part of the profits of the last entertainment. The money we hope will come in handy to our sister congregation in whose behalf M. Klauber and S. Mendlowitz are working with praiseworthy zeal.

Leo Sander is a busy man nowadays. What with his flourishing business, his interests in one of our banks, and his share in the new Happyland, he has his hands full. Certainly Brother Sander is a successful man and a loyal and earnest worker for Temple Emanu-El. Gustave Strauss, another of our good citizens is chairman on site and location and full of enthusiasm for the good cause, as is Brother Greenwald, who, in spite of the inclement weather, came to the meeting to testify to his loyalty for the cause.

We regret to state that Jesse D. Schwartz, son of Mr. and Mrs. D. P. Schwartz, has been indisposed. His physician, Dr. George Mord, assures us, however, that the fine fellow will be his own self again shortly.

Charles Weiss, another of Emanuel's charter members, has entirely recovered from his recent illness, and is up and doing. Keep it up, Charley.

Julius Schwartz and H. L. Bodine canvassed Elm Bank, Mariners' Harbor and Long Neck Sunday and Monday for the new temple. They wear a smile that is broad and it won't come off, either. They met with great encouragement by all whom they saw and all hands joined in the new synagogue.

THE knowledge of Judaism of some confirmants reminds us of a beautifully gold embroidered mantel covering a ספר תורה Posul Sepher Torah.

THE confirmation exercises concluding a מותן חורתינו in the Temple are an exhibition of how little the confirmants know of the תורה, despite the diploma duly sealed and be-ribboned which they receive.

IN the course of his splendid speech Monday evening the Rev. H. Masliansky called upon the shades of Washington and Jefferson to come and witness the decay of the national legislature In vain—the pigmies in Congress would order their exclusion from the country. They had more brains than money.

The Wrong Attitude.

WHILE we were uncompromisingly opposed to the plan of organization as proposed at the abortive conference held the other day in this city, we are not in agreement with those who aver that no central organization at all is needed. The present state of chaos is simply disastrous. If ever there was a time in the history of American Jewry when a central representative body is more needed, it is the present time.

The Jewish population of this country is growing by leaps and bounds; the problems are many, and the doctors far too numerous, and many of their remedies empirical.

Organization is needed for the preservation of the fair name of the American Jews. We regret sincerely that the Committee did not present a plan that could have been accepted. The Marshall plan was undemocratic and altogether one-sided. But there must come an organization, and the sooner it will be called into being the better it will be.

As to Immigration.

THE campaign in favor of the restriction of immigration to this country is very near being brought to a successful issue, unless a mighty voice of protest will make itself heard.

There are now before the House of Representatives in Congress the Dillingham Bill, and the Gardner Amendment, both of which are arbitrary unjust, and will, if permitted to become law, be almost brutal in their results.

The Dillingham Bill which has already passed the Senate proposes, (1) that the Head Tax be raised from \$2 to \$5, (2) that illiterates shall be barred and (3) that the examining surgeon at the port of entry shall decide whether the immigrant is mentally and physically capable of earning his livelihood. The Gardner Amendment desires to increase the amount of money an immigrant should have with him at the time of landing, viz., every male immigrant \$25; every female immigrant, \$15, and \$50 for a whole family.

The clause in the Dillingham Bill providing for an educational test has been prompted by President Roosevelt, who in his message to Congress expressed the opinion that the immigrants should show "some intelligence," whatever that vague statement may mean. During the administration of President Cleveland a bill debarring the landing of illiterates was passed, but the President promptly vetoed it.

Those favoring a more rigorous immigration law include the chauvinists who are always raising the cry of "America for the Americans," as well as the Trade Union Workmen, the majority of whom were immigrants themselves not so very long ago.

The provisions of the Dillingham Bill are not only ridiculous but they are manifestly unjust. The increase of the head tax will mainly benefit the steamship companies, who will exact a higher rate from those desiring to find a home in this country.

The most pernicious clause of the bill is the one giving the examining surgeon the arbitrary power to decide after, what must be only a cursory examination, whether the immigrant is mentally fit to gain his own livelihood. The rigors of the voyage and the confinement in close quarters temporarily weakens the physique of the immigrants. Many of them, moreover, contract diseases during the journey.

As to the illiteracy clause, care must be taken that Hebrew and Yiddish shall be recognized. We are in a position to state that every endeavor will be made to have an amendment passed admitting refugees from religious and political persecution under all circumstances.

Nothing can be said in favor of the Gardner Amendment. Should it be accepted, the criminal possessing twenty-five dollars and who can manage to hide his identity will be admitted, but the honest man who will

become a good citizen and a credit to his adopted country, will be shut out.

It is in keeping with the spirit of the times to measure everybody and everything from a monetary standpoint. Brains, brawn, energy, honesty and industry appear to count for nothing.

This country has been built up not by the men with money, but by those who have worked and labored in various fields.

Meanwhile we can do only one thing, and that is to enter our emphatic protest against the injustice of the bills now before Congress. We urge upon all of our readers to write to the Congressmen of their respective districts and call upon them to vote against the measure.

The further restriction of immigration is contrary to the spirit of those who founded the Republic, for it is mainly to immigration and the admixture of races that the country owes its prosperity and the virility of its citizens.

There is room enough, and plenty to spare, for millions of newcomers, and it is only a question of intelligent and careful distribution. This country has every need of the immigrant.

For Reform and Orthodox Rabbis.

THE revelations of the Chicago meat inquiry showing how unhealthy food has been criminally sold to the public for healthy food is a criminal offence against public morality besides being a criminal offence against public health.

The attention of the Jewish public was a few weeks ago called to an offence against high moral standards which all classes of that public must condemn.

We refer to the custom of selling or labelling food as Kosher when it is not Kosher.

Just as the vegetarian who eats no meat will justly condemn the Chicago frauds for their sin against public morals, so the Reform and non-observant Jew will condemn the man who deceives conscientious observant Jews by proclaiming food to be Kosher when it is not Kosher.

Restaurants and delicatessen stores that pretend to be Kosher and are not so, justly merit the condemnation of all true men.

Indeed, Dr. Emil G. Hirsch was correct when he insisted that Jewish Institutions should observe the dietary laws out of consideration for Jewish inmates who conscientiously desired such food.

But a halt should be called when a Reform Rabbi, needless to say, not Dr. Hirsch, issues a permit or recommendation to "all Jewish homes" to use certain food without assuring the observant Jews that their religious scruples have been respected.

Two months ago, a hechsher for Matzoth, and to which we referred at the time, was issued by a Reform Rabbi in this city.

Reform Rabbis may decide what is right and wrong according to Reform Judaism. But for Reform Rabbis to interpret Jewish religious law for orthodox Jews is as absurd as it would be for Protestants to decide Christian duties or doctrines for Catholics, or vice versa.

We will assume that the Matzoth were properly prepared.

But the following interesting questions are raised in consequence of a Reform Rabbi issuing officially what is tantamount to a "religious permit," which gravely affects "all Jewish homes" and therefore orthodox Jewish households, and which involves religious considerations and requirements which Reform Rabbis do not endorse, regard or obey. We have never heard of any Rabbi in American Reform Judaism insisting upon the precautions which orthodox Jews desire in the preparation of the unleavened bread.

1. Since no Rabbi can guarantee Matzoth, etc., as being prepared in accord with "Jewish Law and Custom," unless he has controlling and constant supervision of the whole process of manufacture from the first to the last stage, what explanation can be advanced for that Rabbi's action in declaring that the Matzoth are Kosher on the basis of the synagogal affiliation of the manufacturer?

2. How can synagogal affiliation with a Reform Temple whose customs are certainly not in accord with "Jewish law and practice," as recognized by "all Jewish homes," be advanced as evidence of the loyalty of the individual concerned to these same Jewish laws and practices? Is not this affiliation rather an evidence of distinct departure from, and disregard for, the aforesaid laws and customs, unless extra and additional precautions are observed in that factory under strict orthodox supervision, which however, the Rabbi's permit does not state.

3. Does not the position acquire singular gravity when the Rabbi, as in this case, is an active and pronounced supporter of reform principles and an avowed opponent of what is "Jewish law and custom," to the majority of the Jews?

We are thus face to face with the following conditions:

1. Where the Rabbi claims to decide and to judge for all Jews, while he personally denies the authority of the law and custom which is recognized by the great majority of Jews. This surely, in matters religious, savors of the improper.

2. Where the Rabbi declares a certain individual is to be regarded as trustworthy, i. e., that he will act in accordance with "Jewish law and custom" to the satisfaction of "all Jewish homes," because forsooth, that individual belongs to his congregation! And it is a congregation which disavows unqualified allegiance to Jewish laws and customs respected in so many of the "all Jewish homes!"

3. Where the Rabbi substitutes a certificate which concerns itself with character and not with competency, for the constant and responsible supervision and control which "Jewish law and custom" imperatively demand.

This surely in matters which for "all" observant "Jewish homes" is of the highest and profoundest importance. Such certificate is criminally careless.

This must appeal to the whole Rabbinate, irrespective of Reform or Orthodox proclivities, as an issue in which the fundamental principles of honor are concerned, and as an occasion for concerted action by the whole body.

אדם קרוב לעצמו Adam karob l'atzmo, "Man is nearest to himself." He then filled his wife's plate with the same, exclaiming ארבעה עשר אהבתי ohavte eth ishti, "I love my wife," and while scooping out the thick into the plates of his children בני ע'ת הבאי and "my children." And when there was nothing left in the tureen but clear water, he ladled it into the soup-plate of the bachur.

The young man who was equal to the emergency, emptied his plate upon the heads of the astonished family remarking:

זורקתי עליכם מים טהורים vezarakti alechem mayim thorim, "I will sprinkle clear water upon you."

A ba'l hagolah (wagon driver) had bought a seat in the מזרח mizrach (east) side of the synagogue, that locality being deemed the place of honor, the seats being generally occupied by the wealthy members of the synagogue. He was asked, how it came that he a "wagon driver," should occupy such a prominent seat. He replied, "As the mizrach is filled mit pferd (with horses) a ba'l hagolah becomes a matter of necessity."

Paraphrasing the Talmudic saying, אל תסתכל בקנקן אלה במה שיש בו Al tistakayl b'cancan ellah b'mah sh'yesh bo. "Don't examine the pitcher, but what there is in it." I might say, "Don't look at the pretty labels on the Chicago canned chicken, but rather on the formaldehyde, salicilis, bob veal contents of the can."

Old Synagogue Member: "Mr. B—, why did you omit saying וקש מיניו קשים—Renew our days as of old?"

B—: "My dear friend, it will never do for a wholesale diamond merchant to wish himself again an orange peddler. I hate Olev Hasholem times."

By the Way.

THE name of Senator Eleberg has of late frequently been mentioned by the press as one of the candidates for a place on the Supreme Court bench. The first contribution from the East for the victims of the San Francisco disaster was telegraphed to Oakland last Wednesday night by M. Guggenheim's Sons, the great copper merchants. Here in Baltimore their charities are unbounded, and they give service and sympathy, as well as money. Fourth on the list of local contributors in the Herald of yesterday was a firm of wealthy Jewish merchants. Ninth on the list was another firm of Jews. Eleventh and twelfth were still other Jews.

Let everyone else—Jew and Christian—be as generous.

WE excerpt from the report of one of the examiners of a New York "meat factory" as published in the daily press the following item, which is of interest to many of our readers:

One of the members of the union, who has been employed for five years in an establishment which makes a specialty of "kosher" or orthodox Jewish sausage shrugged his shoulders when asked if he would subscribe to a sworn statement of his recital of conditions in the place in which he worked.

"No," he exclaimed. "I have a wife and eight children. I am paid \$12 a week. I make sausage for the Jews, and I know it is not kosher, although I am not a Jew myself. I do not say the meat is unclean or diseased, because I do not see it killed, but the sausage is made from parts of the animal which the rabbi prohibits. We cheat the Jews and they don't know it."

Both gentlemen are bright specimens of energetic American Jews, and the elder Mr. Moserohm, together with his father, the Rev. Dr. N. M. Moserohm, as editor, made the Jewish Tribune a

splendid publication. Its breeziness, connected with true Jewish scholarship and excellent typographical appearance reflect the characteristics of the editors and manager.



LITERARY.
פְּחוּמֵי בְּסֵפֶר. *Written down in a Book:* is the name of a brochure composed and published by H. Mahachovsky, who has moved from Philadelphia to 190 East 101st Street, this city.

This brochure proves that its author is not only a master of the Hebrew language, but also a profound scholar, a poet of fertile imagination. Its short stories, which are written in pure biblical Hebrew, are highly amusing and interesting, sparkling with wit and taken from real life. They are calculated as a rebuke to many of our Russian brethren who are residing in this city and elsewhere in the Union.

The first story describes very minutely the stir and excitement among our Russian brethren in the month of Ellul. How over night innumerable congregations are born, and bills are being posted in every corner announcing that in the house of so and so, a great Cantor will officiate on Rosh Hashanah etc, etc. One of those bills which depicted R. Feital of Slonim as the greatest man and sweetest chazan arrested the author's attention. And to his great surprise he discovered that R. Feital was, in his native town, an ignorant shoemaker, whose real name was R. Jochanan the shoemaker.

In another story the author pictures a unique character, Lemech the Batlon, the indolent, who in his native town was known as a man who in his younger days spent many years in a (Jeshiva) (rabbinical college) but he learned nothing but the names of different books and of their authors. He immigrated to this city and in a short time he was dubbed "Rev. Doctor," etc., Hebrew scholars will undoubtedly derive great pleasure from perusing this little work, and will get ample value for the small price which they may pay for it.

The Harlem Federation.
It will no doubt be interesting news to many that the Harlem Federation for Jewish Communal Work has grown so rapidly within the last year since its inception and the starting of the Federation House at No. 227 East One Hundredth street, the subsequent which is at Nos. 311-213 East One Hundred and Sixteenth street, that it has been necessary to purchase Nos. 238 and 240 East One Hundred and Fifth street, two 3 story and basement private houses on a lot size 33 feet 4 inches by 100 feet 11 inches. There are sixteen clubs now at One Hundredth street with a constant pressure for more room and more club leaders. The Federation reaches some of the poorest boys and girls between the ages of 10 and 14 years in Harlem, and it fills a crying need to the best of its ability, but it is hampered by lack of funds for the Building Fund and the equipment, as well as for the running expense, which is quite heavy. Under the able guidance of Dr. Maurice N. Harris the Federation has managed to get along fairly well, but the Executive Board feels that the efforts of the Membership Committees and the Building Fund ought to be heartily supported by the general public, particularly by those who live in Harlem and who are morally responsible for the uplifting of their brethren. More than 700 children are on the rolls of the Federation in its various activities. The clubs, literary and social, sewing circles and music classes, nature study and art, physiology as well as religious classes are lead by earnest young workers, but more volunteers are needed.

Chinese Outrages on Transvaal Jews.
In an official return of the outrages committed by Chinese coolies in the Transvaal during the period June 1, 1905 - February 28, 1906, as many as eight cases occur of attacks upon Jews. Thus, on June 25, about 300 coolies armed with weapons, broke into a Jew's store at the Angelo Gold mine, smashed the furni-

ture, threatened the inmates, and stole goods to the value of £30. On July 4, a coolie broke into a Jew's store at Boksburg in the night-time and stole goods valued at £10. On July 29 a party of Chinamen, broke into a Jew's store at Boksburg in the night-time, and stole goods to the value of £40. On the 3d of August, a gang of coolies assaulted two Jews at Benoni by beating them with sticks and jumpers about the body, and robbed them of £1 in cash and a quantity of sugar. On August 8, a gang of coolies broke into a Jew's store at Benoni in the night-time and stole goods to the value of £15. On August 21, some coolies broke into the store of a Jew at Benoni in the night-time, and stole watches and clothing to the value of £50. On September 3, some coolies broke into a Jew's store at the Angelo Mine in the night-time and stole goods valued at £17 18s. 6d. On September 15, a party of coolies broke the windows and shutters of a Jew's store at the Angelo Mine.

The Expulsion of Jews from Berlin.
The Berlin correspondent of the London Morning Leader, dealing with the expulsion of Russian Jews from Berlin states that the Prussian Minister for the Interior informed a deputation recently that 5,500 Russian Jews had collected in Berlin since 1904, and that the expulsion orders concerned only such persons. Seven hundred have been expelled, or were to be expelled, immediately, because they were entirely without means or engaged in political agitation. The minister stated that the Jewish relief committees were always informed of the projected expulsionist, so that the necessary measures could be taken to get the people out of the country, without harshness being employed. The correspondent adds that the Conservative papers say that the Russian Jews are notoriously seriously implicated in the worst kind of revolutionary agitation in Russia, that such people being from the outset politically suspicious, are undesirable as residents in Berlin, and that it is the duty of the Government to get rid of them as soon as possible.

Brevities.
Henrietta Blumenstock, by her will, has bequeathed \$5,000 each to the Hebrew Sheltering Guardian Society, the Montefiore Home for Chronic Invalids and the Montefiore Home for Consumptives. Mrs. Blumenstock divided the rest of her estate, said to amount to about \$50,000, among her relatives.

The Congregation B'nai Israel, of Elizabeth, has decided not to move the house of worship on East Jersey street, as was at first proposed, but to remodel the structure and to enlarge it by erecting in the rear an extension. The work will cost \$3,000 and it is now in progress.
