

The practice of drinking directly from the bottles is a habit that must also be borne in mind as a possible means of contamination with tubercle and Klebs-Löffler and bacilli.

GEORGE BRANDES AND THE JEWS OF FINLAND.

ST. PETERSBURG, May 17.—The Fraind publishes a letter from its correspondent in Finland, I. Shure, which tells of the recent visit to Helsinki of George Brandes, the great Danish critic, and the futile effort that was made by the Jewish delegation to have a celebrated writer say something in behalf of his oppressed brethren in Finland, who now find themselves in especially bad plight.

The incident has brought painful realization that this man, though of us, is not with us. Herr Brandes came here by steamer from Stockholm on Wednesday evening, May 13, and his arrival was the signal for the appearance of many articles in the newspapers in praise of his writings. He came here to deliver three lectures. One paper even raised the question as to whether as a Jew Herr Brandes had the right to remain here beyond the prescribed limits of three days. It will be remembered that Brandes played an important role in defending the people of Finland during their struggle for freedom several years ago. The noted visitor was met by the Danish Consul. Next day he received the representatives of the various newspapers; he received them all cordially, and freely answered all questions they asked. On Thursday evening he delivered his first lecture in the auditorium of the university, and on Friday he lectured for the second time. On Saturday morning a deputation of the Central Committee for the Attainment of Equal Rights for the Jews of Finland called on him. A member of the deputation gave the correspondent his impression of the visit in the following words: "We called upon Herr Brandes at 11 o'clock in the morning. We informed him through his attendant that we had come in behalf of the Central Committee. His attendant brought us the reply that George Brandes could not receive us that day for the reason that he is very busy."

"When is he going away?" we asked. "To-day," answered the attendant. "We sent in to ask whether Herr Brandes would be able to see us later in the day, and the reply was brought to us that for the time being he was occupied, but if we did not object to speak in the presence of other persons we could come in. We had already made up our minds to give up this mission, but we reconsidered the matter and decided that it was at any rate of importance to us to know whether Brandes is still alive for his brethren or not. One member of our deputation entered and stated that the matter was of great concern to us and that we could not speak of it in the presence of outside persons. The Danish critic was then entertaining Dr. Hirn, who had spoken very highly of Brandes in one of his addresses. Herr Brandes was visibly at a loss as to what to do, as to whom first to give his attention, whether the Swedish physician or the Jewish deputies, but Dr. Hirn relieved him from the embarrassment by offering to withdraw out of deference to the committee, which he thought had come on an important mission. "How many of you are here?" asked Herr Brandes of the deputy, which had entered his room. "Three," was the answer. "Then tell them to come inside," said Herr Brandes.

"We entered, and it seemed as if a cold wind blew in our face when Brandes turned to us coldly and asked. "What is it you want of me?" "We replied that the Central Committee has instructed us to explain to him the terrible condition in which the Jews in Finland now find themselves, and stated that it was the firm conviction of the committee that any utterance which Herr Brandes would publish in the press in behalf of the Jews would be of great value to our movement, since the intelligent classes are prone to be greatly influenced by statements in the European press. At the same time we went into a full exposition of the present conditions of the Jews here. Herr Brandes listened rather indifferently to our story of Jewish woes, and from time to time interrupted us with questions which gave us a clear indication that he did not intend to do anything for us. "Yes," he said at the close of our recitation, "but how can I help you. The experiences of my life have brought me to the conclusion that words are of little consequence so long as we have not the power wherewith to enforce them." "Thereupon we reminded him that at the critical period in the history of Finland he did not hesitate nor ask any questions, but spoke freely in behalf of that country, and that his words exercised a strong influence. "Yes," he returned, "it is true, but how can I point out the faults and shortcomings of the intelligent classes of Finland after they had given me such a warm and friendly reception?" "Just because they have given you

this fine reception is the reason why you should not permit yourself to be blinded to real conditions and you should point out their narrowness and prejudice," remarked one of our deputations.

"But tell me, really," asked Herr Brandes, "who here is for the Jews and who is against them?" "The only party here," we replied, "that really strives for equal human rights is the Social Democratic party. As far as the Young Finnish party is concerned, we know that this organization which is regarded on the Continent as a progressive radical body, has in its publications always made it a point to ignore the Jewish question. Since recently when the question came to be more agitated than heretofore the press of the Young Finnish party always publishes the arguments of those who are opposed to us and not of those who defend us, and so we have come to know this party in its true colors. "And the Government?" asked Herr Brandes.

"The Senate," we replied, "always tries to defer any discussion of the question that may be in our interest. And whenever it is necessary to bring a sacrifice for the higher powers that be, it is the Jewish question that is sacrificed to make up for this. The Swedish Constitutional party does a lot of talking in favor of the Jews. "Well," said Brandes rising from his chair, "I can promise that when I will come to write concerning Finland, I will surely touch the Jewish question, if you find that of use to you."

"Thus there ended the visit of the Jewish deputation to George Brandes."

In regard to Mr. Uriaschohn, Mr. Salaman in his anxiety to reduce the costs to a minimum seems to have overlooked that the first hearing Mr. Uriaschohn traveled from Crodno to London, carrying the proxies of several thousand Russian shareholders, and was detained a fortnight in London by the postponement of the hearing. Although, therefore, I agree that the claim for his expenses is justified, I trust they will be calculated as moderately as possible.

As for my personal costs, I adhere to my determination not to diminish the Zionist funds by a single farthing, for, though, as you know, the whole case which has been three times before the court, has been a great drain upon my time and energy during many months, I am content to have safeguarded the future of Zionism.

A meeting of the Emigration Regulation Department of the ITO was held at New Court on Monday, the 25th inst. There were present: Messrs. O. E. d'Avigdor-Goldsmid, Hermann M. Kisch, Carl Stettauer, Alfred J. Waley, Lucien Wolf, Israel Zangwill, Leopold de Rothschild (Honorable Treasurer), and Clement I. Salaman (Honorable Secretary). Mr. Salaman presented a detailed report dealing with the work of the department up to date, and Mr. Leopold de Rothschild a balance sheet.

Bernard Adelberg, a jeweler, of Boston, Mass., has brought suit against the New England Telephone and Telegraph Company for \$2,000 damages because of a line which appears in the telephone directory issued by the defendant company. He alleges that in January, 1908, in the directory published by the defendant company were the words: "Adelberg, Bernard, Jewer, 1113 Washington street."

The newly-established Wilna Jewish Society, the Kneseth Israel, has evidently not found favor with the Real Russians, who have decided to interpellate the government on the advisability of closing it. The chief aim of the society is to foster religious education among the Jewish youth. The society will meet on June 3 in conference.

A Report of Progress.

We are glad to make known to our readers the following details relative to the activities of the new Society of Jewish Art. A perusal of its report will serve to convince all that this body is preparing a most attractive programme for its work in the winter of 1908-1909:

The Art Committee, of which Dr. Joseph Jacobs, chairman, proposes an exhibition of Jewish art to be held in the fall. This committee had intended to provide an exhibit of Jewish ceremonial art in April, but owing to the lack of responses on the part of persons possessing such objects, and of time at its disposal, the exhibit had to be abandoned. The exhibition promised for the fall will not be limited to objects of ceremonial art, but will be more general in its scope. Its success will, naturally, depend a great deal upon the membership, which is urged to co-operate with the Art Committee in order to secure a collection that shall be both valuable and instructive.

A great deal of interest has been shown in recent years in the field of Jewish folk-music, of which several specimens were given at our February meeting. The Music Committee, of which Mr. Lewis M. Isaacs is chairman, intends to arrange an evening to be devoted to a series of Jewish folk-songs. The committee will have the assistance of a number of our members, who are specialists in that branch of Jewish music, and who may be relied on to give the music of the society a programme that shall disclose the beauty as well as the historical value of this music, the composition of which is traceable to the lowliest of our people.

The Committee on Drama and Literature, of which Mr. Leon Moisseiff, chairman, has under advisement an evening with Jewish drama. Three or four specimens of drama, based upon Jewish life, will be presented during the winter by competent performers. The programme will serve, we hope, to acquaint our members with the latest developments in the field of art, which, by its very nature, has an important bearing upon contemporary Jewish life.

The literature section of the same committee, while not yet prepared to report definitely, has intended to give an evening devoted to the illustration of Jewish social life as it is depicted in Jewish literature. The annual meeting of the society, which the council aims to make an event in our activities, will be held in December and will serve to provide social intercourse by means of which the society hopes to vitalize its work; a conversation will be part of the annual meeting.

We note, too, with pleasure the election of Dr. Jacob Teschueras the president of the society. He is a promising worker.

A writer in the Van Norden Magazine for April makes these sensible observations anent the value of the Russian Jew in America:

The Russian Jew, hampered on every side, restricted in dwelling place and occupation, denied the pursuit of happiness in almost every way, has had developed the idealistic side of his nature. He it is who furnishes a large proportion of the "intellectuals" of his country. He furnishes the teachers, the journalists, the speakers, the martyrs, as well as the terrorists, who are willing to sacrifice their lives if in so doing they can strike a blow for liberty. The Jew is hated in Russia, not by the poor people who are his citizens—as in Germany—but by the bureaucracy, for his mental and moral qualities. The massacres that take place from time to time are not spontaneous outbursts of the Judenhetze, but carefully fostered attacks of the Black Hundred, the roughs of Russia, who would attack and murder them with impunity and with the moral support of the Government.

The Russian Jew becomes an intellectual because all other modes of self-expression are denied him. Where the young Englishman indulges in sports, the Russian Jew reads. Where the American goes into all manner of business ventures, the Russian Jew reads. Where the German travels, the Russian Jew reads. Books furnish the Russian Jew not only with his recreation, but with what is greater of all, his hope. His twenty-year-old boy would feel as ashamed if he did not know Spencer and Huxley and Darwin and Spinoza, and all the other "heavy" writers as an American boy would feel if he did not know who won the baseball game at West Point and who held the football championship. The thinkers, who are only names to the majority of youths of a happier land, are the dissipation of the young Jews of Russia.

Even here in America their old habits cling to them. Theoretically, they approve of our more healthful and natural way of spending our leisure time. Practically they cannot become used to seeing grown men chase a little ball across acres of sward, or batting another back and forth across a net. With Russia to liberate, and the rest of the world to convert to Socialism, they have no time for such a pastime. Their bookishness does not slough off even under the blue sky and in the pure air of the Bowery. The librarians of any library within reach of the East Side will tell you that the solidest books are taken out and studied by the Russian Jews. For them the "best sellers" have no attractions. Go to the Rand School of Social Science and listen to the intelligence of the questions asked by this proletariat of working men and girls—questions often showing wide reading and deep thinking. To propound one such question in a roomful of young Americans would cause a stampede.

Recently the King of Italy, who attended in state, formally opened the new building of the International Institute of Agriculture in Rome. The Institute, it will be remembered, owes its existence in the first place to the initiative of Mr. David Lubin, an American Jew.

American Jewish Colony in Palestine.

The association tendered a farewell dinner on Monday evening, June 15, 1908, to two of its shareholders, Mr. E. W. Levin-Epstein and Rev. H. Masliansky, on their departure for Europe. Mr. Harry Fischel acted as toastmaster and speeches were made by Dr. David Blaustein, L. Kamalky, Isaac Allen, Albert Kruger, D. H. Lieberman, L. D. Livingstone and the principal addresses were delivered by the two guests of honor, namely, E. W. Levin-Epstein and Rev. H. Masliansky.

A Jewish merchant has been cruelly murdered at Ellsabetgrad.

Orthodox Hebrews of Hartford, Conn., are planning the erection of a new synagogue.

The Kieff police have forbidden the writer "Shalom Asch" to give public readings in Yiddish.

The chairman of the Zemstvo at Uman has prohibited the public chemist from selling drugs to Jews.

The Sanitarium for Hebrew Children inaugurated its season last Monday with an excursion for 450 people.

The Cherson Real Russians have decided to request the government to prohibit Jews becoming chemists.

Jewish residents of Middleton, Conn., recently purchased a building and last week filed plans to alter it into a synagogue.

Ground was broken last Wednesday for a new synagogue to be located at Fifth and Taylor streets, Fort Worth, Texas.

Lieutenant Marx, son of the former Chazan at Roubaux, has been promoted to the rank of captain of frigate in the French navy.

Memorial services were held last Sunday at the Leopold Morse Home in Mattapan, Mass., in commemoration of the founder.

The Russkoe Znamya suggests that all the Jewish soldiers should be sent to the military workshops instead of serving in the regiments.

The governor general of Charkoff has forbidden the Jews to spend their summer holidays in the health resorts of the Charkoff district.

The Jewish sculptor, Herr Bernstamm, has received an order from the Tsar for a statue of Peter the Great rescuing shipwrecked people.

A committee was formed at Kieff in aid of the Jewish sufferers from the floods. At Slobodka alone the latter number three hundred families.

The new buildings of the Jewish Sheltering Home for the Homeless, 315 South Third street, Philadelphia, were dedicated last Sunday afternoon.

More than 3,000 pupils participated in the seventieth anniversary services of the Hebrew Sunday School Society of Philadelphia, Pa., last week.

Making the Jewish History in Galicia.

The Jews of Galicia have recently celebrated the anniversary for the last election for Parliament. It was well to celebrate this anniversary, says a correspondent who is writing from Cracow. We all feel very deeply the great progress which the Jewry of Galicia has made in the last few years, an advance which at other times it required several hundred years to make. What is one year in Jewish history? Did we not remain in almost the same position in Poland for a period of 500 years? Only one year has passed and it is barely possible to recognize the Jews of Galicia.

Of the events that transpired within this one year, in Austria the historian of the future will have much to relate. All of a sudden, almost, there arose here a Jewish people and in the divided and torn Austrian empire wherein eighth nationalities wage war with each other, a place has to be made for a ninth nationality. Gradually the Gentiles became accustomed to the idea that the Jews represent a people of their own. Before this they would laugh at such an idea, and then people began to argue about it. The matter became more serious and actual fights took place at mass-meetings and at the universities. Perhaps the fighting would have still been going on, were it not that the Zionists of Galicia took a decisive step and put up their own candidates for Parliament. Real Jewish representatives in Parliament!

The Jewish people of Galicia caught up the idea and they elected twelve Jewish Nationalists as Deputies to the Reichsrath. Eight of these men were robbed of their seats through political trickery and only four were left. But these four men, though they were not the most important of those elected, have done more for the Jewish people than, for instance, the twenty-two Jewish Deputies in Hungary. There cannot be even any comparison between the two countries. With the entrance of the "Jewish Club" in the Austrian Parliament new life was infused not alone into the Jewry of Galicia but of the whole of Europe.

They speak altogether differently of Jews these days. Thus have now the Jewish students of Vienna received the right from the faculties to register as members of the Jewish nationality. This is a great victory for the national idea. The government will no longer be able to continue to deny our rights as it has done heretofore. Only last week the most pronounced assimulator of the Jewish Deputies, Counselor Kuranda, addressed an interpolation to the Minister of Justice inquiring why he permits anti-Semites to circulate false rumors concerning ritual murders. Counselor Kuranda spoke in the tone of a nationalist and the Jewish Socialist Deputy,

Rabbi Leon Harrison delivered the address at the forty-seventh commencement exercises of Washington University of St. Louis, Mo., on the 18th inst.

The contractors have agreed to finish the new Benal Israel synagogue at the corner of Duval and Jefferson streets, Wheeling, W. Va., by August 1 next.

In view of the decision of the Nicola-Jeff Town Council to raise the tax on Jewish meat, the butchers have struck work and the population is without kosher meat.

On the 10th inst. Prof. Solomon Schechter of the Jewish Theological Seminary took out citizen papers and formally renounced allegiance to the King of England.

The Knoxville, Tenn., Sentinel in its issue of June 9, states "Ben Allen, who is 'one of the finest' of the city police force, is the only Jew police officer in the South."

The new synagogue of the Congregation Ahawath Chesed, Mobile, Ala., was impressively dedicated last week. Mayor Patrick J. Lyons of Mobile delivered an address.

Rabbi Eli Mayer, formerly of Paterson, N. J., has been installed as assistant rabbi of Temple Rodeph Shalom, Philadelphia, Pa., and preached his inaugural sermon on Sabbath last.

A feature of the annual meeting of the Young People's Society of Temple Beth Emeth, of Albany, last Monday was the presentation by members of the comedy "The Maneuvers of Jane."

Through the courtesy of the management of the Empire Theatre, Albany, N. Y., the entire receipts last Friday evening were donated to the fund of the Hebrew Educational Building.

Before the opening session of the summer term of the New York School of Philanthropy, on Monday last, Dr. Lee K. Frankel and M. W. Waldman of the United Hebrew Charities delivered addresses.

William Jennings Bryan has recommended to the Democratic National Committee the appointment of Rabbi Nathan Krass of Muncie, Ind., as chaplain of the Democratic National Convention at Denver next month.

The Schammass of the Great Synagogue of Priluki was murdered at the synagogue by Hooligans. His face was cut in several places, and his ears were torn off. A Jewish woman was also cruelly assassinated at Minsk.

Dr. Lieberman, spoke in regard to the question of the Jews in the army in the same spirit.

The thing is becoming popular. Not the least of the signs of the national awakening in Austria is the union of all the congregations. The Jews from many cities assembled in Cracow within the past week to review the events of the year and to consider some plans for the future. Many resolutions were adopted and every one of the following order and character: (1) To the Jewish Club: "We have the utmost confidence in you and we ask you to continue the work along the same lines." (2) To the President of the Ministry: "We demand our national rights and ask to be free from compulsory rest on Sunday." (3) To the Landtag: "We demand our national rights and universal and equal suffrage in the election of the Parliament."

The Situation in Russia.

The Fraind of St. Petersburg continues to publish the replies to the questions, addressed by the Yiddish organ to the Jewish leaders in Russia, with reference to the Jewish problem. N. Niselovitz stated, in his answer, that he wished himself to be considered primarily as a Jew and then as a Constitutional Democrat. His projected bill on the Jewish question provides for the full emancipation of our coreligionists, but in view of the fact that the Duma is only likely to remove some of the restrictions against the Jews he prefers to await the decision of the entire Jewish people, before entering on his difficult mission. Mr. Freeman expressed himself against any attempt to introduce the Jewish question at the present time. They could, at the moment, only obtain a partial relaxation of the restrictions. He is willing, however, to co-operate with N. Niselovitz, if his brethren found the time opportune for the discussion of the question. M. Lillienblum was in favor of obtaining those rights, which might soon be granted, and of then continuing the fight for emancipation with renewed vigor. He has advised the deputies to base their arguments on the Tsar's manifesto of 1904, which foreshadowed the removal of certain restrictions against the Jews. The deputy of the first Duma, M. Ostrogorsky, speaking in the name of the Volks Group, was strongly opposed to the introduction of the question.

Harlem Casino.

"Die Lustige Wittwe" will probably be given in the spacious and cool theatre for the rest of the summer. Repeated hearings do not dull the irresistible charm of Lehár's music. The performance is very enjoyable.

A mammoth fair and festival to be given in the new Coliseum in December under the auspices of the Jewish Charitable and Educational Union of St. Louis, Mo., for the purpose of raising \$100,000 is contemplated.

Rabbi Krauskopf of Philadelphia, Pa., will lay the cornerstone of a new synagogue being built for the Bnal Israel Congregation at Allentown, Pa. The rabbi has been allowed to select his own date for the ceremony.

The Odessa governor-general has adopted stringent measures to secure absolutely kosher meat for the Jewish population. With that purpose in view he has also introduced a special examination for the Jewish butchers.

The Jewish Educational Alliance of St. Louis on the 6th inst. appointed a committee to visit Crawford County and select a site for a Jewish colony there. The plan is to relieve the congestion in the Ghetto by sending several hundred families to the country.

The Turkish government performed a kindly act last week by placing gratis at the disposal of the Hilfsverein der Deutschen Juden a steamboat to convey the pupils of its three schools in Constantinople on a trip to the Sweet Waters.

Rabbi Rudolf I. Coffee of the Ez Chaim Synagogue, Pittsburgh, Pa., received the degree of doctor of philosophy at the annual commencement exercises of the Western University of Pennsylvania on June 7th. Rabbi Coffee submitted a thesis on "Hebrew Cosmology." Rabbi G. H. Lowenstein, of Augusta, Ga., has resigned his position.

Colonel Simon Vogel was recently to be promoted to the rank of general in the Austrian army in recognition of his brilliant services, but as he is a Jew the condition was imposed that he should be baptized prior to promotion. The colonel preferred retirement to apostasy, but he was nevertheless gazetted as a general in the reserve, however.

Nathan Straus, the well-known philanthropist, has accomplished what has for forty years been regarded as a political and religious impossibility. Through his efforts recently the Protestant lord lieutenant of Ireland, Lord Aberdeen, has been officially received at the Mansion House by the Roman Catholic Lord Mayor of Dublin and the representative of the British crown has presided at a public meeting in the official seat of the chief officer of the most Irish city on the Emerald Isle.

Jews in Cuba.

Jews have been suffered to dwell in Cuba only since 1881, and only with the Cuban independence has the profession of Judaism publicly been permitted. Several Jews in the American army of liberation settled permanently in the island. To-day there are about fifty Jewish families in Havana, and on August 5, 1906, the United Hebrew Congregation of Cuba was organized. This body owns at Guanabacoa a burial ground, and its existence was confirmed by the American provisional government in October, 1906. One of the leaders is Senor Don Luis Marx, the wealthy tobacco planter. The congregation now proposes to secure its own rabbi.

Rabbi A. Simon of the Washington Hebrew Congregation was recently tendered a farewell banquet prior to his departure for Europe and presented with a purse sufficient to defray the expenses of the trip.

LITERARY.

THE ART OF LIFE SERIES. EDWARD HOWARD GRIGGS, Editor. B. W. HUEBSCH, 1907.

"Of all problems those of human living are most absorbingly interesting. . . . If we wait till we know how to live before we begin, we never begin. . . . This element of experiment in all human living means that life can never be reduced to exact science, but will always belong in the field of art. . . . The aim of this series of brief books is to illuminate this never-to-be finished art of living."

This, in brief, is the editor's explanation of the object and name of the series.

The first volume by the editor, is termed "The Use of the Margin;" the second by Thomas Wentworth Higginson, is called "Things Worth While;" another by Earl Barnes, is "Where Knowledge Fails." Mr. Griggs' little book tells us about the proper use of our leisure time. Education is life-long, and our two school-masters are Love and Work. Living is a vocation. A slight study of mathematics will show that even a large factor multiplied into Zero will give Zero. Such are the daring and novel sentiments of Mr. Griggs, spun into a fine, yet strong thread of moralizing for about 65 duodecimo pages.

Thomas Wentworth Higginson's little work on "Things Worth While" is in much the same strain of quiet, gentle, didactic philosophy. "The first chapter seeks to indicate what those things are which make human life on the whole, worth living," says the writer; and the six other brief chapters, each scarcely longer than a paragraph, follow out the theme in simple, easy elaboration. Written in excellent limpid English, the stream of thought runs in clear, lazy, shallow carat-like placid summer brooks among leafy trees. They are probably planned by publisher and writers to give summer vacationists something more worthy, though scarcely more exacting, than the usual run of novels at this season, as literary vademecums to be read to the accompaniment of the drowsy hum of bees and to blend with the sounds and sights of the far country-side in the preparation for those post-prandial slumbers full of deep dreams and quiet breathings, which are the chief charm of ruralising.

"Where Knowledge Fails," by Earl Barnes, is much more worthy than either of the other two volumes, and is a work curiously attractive and of remarkable finish for so short an essay. Far better than the other writers of the series does he grasp the demands of the "Art of Life," and his exposition is proportionately the more satisfying. His little work can be read again and again with profit and pleasure.

B. W. Heusch, the publisher, seems to have hit on a happy idea and to have secured worthy executants. The little series can be profitably and worthily extended, and there must be many thousands of Americans who would consider an expenditure of 50c. in money and an hour or two of time far more worthily employed in the purchase and perusal of one of these excellent little volumes than in a visit to a theatre. The series deserves a wide-spread public recognition.

THE LAST EGYPTIAN. EDWARD STERN & Co., INC., Philadelphia, 1908.

"This book is inscribed to Mr. Edward Stern, a fellow-traveller in the Wilds of Egypt, by the Author." Such is the inscription which tells us all that is vouchsafed to us of information about the writer. With that—and guesses—we have to be content. "The Last Egyptian" is a pure-blood Copt, who proudly announces that he is "no dog of an Arab." Born in the lowly village Al-Kusiye, we are introduced to him one hot Egyptian afternoon. Bare-legged, dirty, ill-clad, there is yet something about him that arrests the attention of the Englishman, Winston, who has just kicked him into wakefulness. He is a lineal descendant—always on the distaff side—from Ahtka-Ra, the "most wonderful ruler Egypt has ever known," who was high Priest of Amen and was the real power behind the throne in the days of Rameses, misnamed the Great, who was really a foolish and vain creature, and a mere puppet in the hands of Ahtka-Ra, who should have been the real king because of his descent "from the famous Queen Hatshepsut."

The reader, however, is mistaken if he imagines that Kara, "the last Egyptian" and the English kicker are to drink hashesh and so be transported back 5,000 years to learn the details of some Scandalum magnatum of old days. Why Prince Kara came to be; what was the nature of the vendetta to which his life was devoted; how he partially succeeded and why he partially failed can only be imagined by a fellow traveller in the Wilds of Egypt-of-to-day, and a discerning reader of Dumas' Count of Monte-Cristo. The story is well and interestingly told.

But the present reviewer has imagined a much prettier story about the personalities of the writer and of Edward Stern—possibly he is Edward Stern, Inc., himself—the "fellow-traveler." The present writer is much ashamed and out-of-countenance at the thought of his impudence, but he does hope that some not too-distant day after that journey in the "Wilds of Egypt" the wedding-bells pealed a merry carol in the Wilds of Philadelphia, Pa.

FOUNDATIONS OF MODERN EUROPE. BY EMIL REICH. THE MACMILLAN CO., N. Y., 1908.

Dr. Emil Reich, the Hungarian litterateur and historian, whose critical writings have already made him favorably known to the American public, delivered a very dashing series of lectures, in 1903, at the invitation of the authorities of the University of London, on the "main facts and tendencies of European history" for the last century and half. The present volume, while making no pretensions to be more than an outline of the topic, is an elaborated reprint of these lectures.

Dr. Reich takes very original stand-points and maintains his somewhat peculiar views very ably and strikingly—if not altogether convincingly. He has thoroughly studied his sources and if there is more of the journalist than of the cautious dry-as-dust historian in his mental outfit, that fact by no means makes his book less interesting reading. The serious student of history can scarcely question his facts, however much he may differ from the conclusions. To the general reader there is a dash and brilliancy about Dr. Reich's aperçus which make the work pleasant and attractive reading.

The twelve lectures included begin with the War of American Independence and end with the Franco-Prus-

sian—by a characteristic peculiarity termed here the "Franco-German" war. Perhaps the most interesting of the lectures are the six dealing with the French Revolution and the Great Napoleon; though none of the lectures is in the least negligible. The important part played by Beaumarchais, writer of *Le Mariage de Figaro*, in aiding the American colonists in their struggle for independence is, for the first time in a popular work, pointed out. If we are to trust Dr. Reich we shall need to take all our Lafayette statues off their pedestals and replace them with those of Beaumarchais! Generally speaking, the author is a great and unyielding iconoclast, and Chatham, Bourke, Washington as well as Wellington and Metternich, will have to be relegated to the background.

Dr. Reich's regard for Napoleon amounts to the rankest hero-worship. But none can question his grasp of the facts or his lucidity in marshaling them. The Hungarian mysticism of the lecturer appears most amusingly on pages 99-100 (Third Lecture), where we are told how strange is the coincidence whereby the West Indies on the one hand brought good luck to France in the persons of "two of the most charming and most important royal spouses," Madame de Maintenon and Josephine de Beauharnais; while on the other hand, Austria twice brought "bad luck" to that country by the ill-fated marriages with Marie Antoinette and Marie Louise. These disastrous espousals of Hapsburg princesses give rise to Dr. Reich's suspicion that Metternich of *malice aforethought and with the fullest prevision of the misfortunes that must ensue*, urged the negotiations for the marriage of Napoleon and Marie Louise. "For," says Dr. Reich, "as now everybody knows, the House of Austria is, of all the reigning houses in the world, the one that has been visited, in our own times, with the greatest number of most shocking disasters, just as in the Eighteenth Century the Hapsburgs brought nothing but ill luck to either the Bourbons or Napoleon." Despite the prophetic foresight thus attributed to Metternich, he is easily outwitted by Talleyrand in the Congress at Vienna, in 1814.

There is a suspicion that we need not perhaps be too ready to re-cast our estimate of the warriors and diplomatists mentioned at the bidding of Dr. Reich. On the other hand, most of us will heartily agree with him in his estimate of Napoleon and Bismarck, especially the latter, to whom the fullest justice is done.

Dr. Reich's perceptions of the relative value of events and tendencies must be pronounced to be strikingly just and brilliant. The work is most acceptable and valuable, taken as a whole. J. G.

The illustrations are mainly from photographs, and have been carefully chosen to impress upon the student the results of the action, both past and present, of those forces which have moulded the surface of the earth, and which have determined the development and distribution of the varied forms of plant and animal life. A large number of maps and diagrams show geographically the points treated in the text. The adoption of the smaller size of page will add much to the comfort and convenience of the reader.

Fun at Home. DON'T be afraid of a little fun at home, good people. Don't shut up your house lest the sun should fade your carpets, and your heart lest a hearty laugh shake down some of the musty old cobwebs there. Editor, HEBREW STANDARD:

Dear Sir—We the undersigned, and in behalf of the committee and members of this society, beg to solicit the favor of your kind assistance towards an urgent and much needed synagogue and charitable institution for Shanghai.

We have succeeded during the past four years in maintaining a synagogue, and Philanthropic Society. The latter, we are glad to say, has proved very instrumental in relieving the many destitute Jews that are constantly coming here, many of whom we have sent to distant countries, providing monthly grants to local indigents, and otherwise alleviating the sufferings of our poor unfortunate brethren in distress.

Our local donations and subscriptions have so far enabled us to meet all such calls, and to keep up a few rooms for daily services, but the time has now arrived when the ever-growing community of Shanghai should also be blessed with a synagogue of their own, and to realize this cherished hope we must depend upon the generous support and contributions from our co-religionists abroad, who will, we sincerely hope, through your kind offices, help us to accomplish our good purpose.

It is our desire to establish a refuge

in conjunction with the synagogue, for the old and infirm whose daily sustenance we can provide, our subscriptions being sufficient for that and to meet all expenses for the upkeep of a synagogue, the rent for which now absorbs the greater part of our income, and which we can save and utilize for more relief work if we had our own building.

It is estimated that a suitable building to meet all our requirements can be secured for about £3,500 out of which £1,000 has already been promised locally, and to realize the greater part of this sum we have sent subscription lists to various cities in the States and Europe, all of which we hope will bear good and patriotic testimony of the charitable and brotherly feeling which exists among Jews all over the world, and we shall feel very grateful if you will kindly distribute the accompanying lists among the rabbis of your town, with an urgent appeal from us for them to circulate the same among the members of their congregations, among whom we hope will be found many benevolent sympathizers who are in a position to bestow substantial assistance.

All contributions so collected will be gratefully received and acknowledged through the medium of your valuable paper, on receipt of same by the committee of Synagogue O'hell Moische, care of S. Zimmerman, Esquire, Shanghai, through the International Banking Corporation, payable to Synagogue "O'hell Moische and Philanthropic Society, Shanghai."

We most sincerely hope that this will appeal to all our co-religionists, and meet the support it deserves. Thanking you in anticipation for impressing upon the minds of your numerous readers, through the columns of your valuable paper, the very urgent need and necessity for this our duty towards the poor and homeless Jews in far away China.

The trial has taken place of the three Russian Jews who were arrested in Egypt on a charge of conspiring to blow up Russian ships at Alexandria. It will be remembered that they were encouraged in their plot by Russian secret agents, who ultimately handed them over to the police. In spite of the questions raised in the House of Commons, it was found impossible to resist the demand for extradition made by Russia in accordance with the Egyptian law. The men have been sentenced to exile in Siberia.

THOSE OF OUR READERS who have read "Halitvack's" charming stories of Russian Jewish life will no doubt be pleased with his contribution to this week's issue which deals with life in New York's Ghetto.

ALL MEN will ultimately come to a proper knowledge of the truths of Judaism in the words of the Haftorah of tomorrow לא ברזל ולא בכח כי אם ברוחי אלהים "Not by power nor by strength but by my spirit saith the Lord".

WHEN THE NEWCOMER barely begins to make a living, his hand is always open to his needy brethren, and his small down-town store is closed on the Sabbath. But when blessed by prosperity he moves up-town, his business place is open on the Sabbath, while his heart is closed to humanity.

IN OUR LAST ISSUE we made allusion to a discourse on "What is Liberal Judaism", inferring that it had been borrowed in part from an essay under the same title written by Claude G. Montefiore. We have since learned that our informant was mistaken in his conclusions and we embrace this opportunity of making the amende honorable.

WE NOTE with satisfaction the action of the state prohibition convention of Seattle, Washington, the other day. The preamble of the platform contained these words: "We accept Jesus Christ as our leader," On motion they were expunged. Ministers of the gospel voted in its favor declaring they had no desire to give offence to observant Jews.

לא יהיה מקרב הארץ. "The poor shall never cease from the midst of the land" and each charity has its own particular season. The heated term brings into prominence the activities of the "Sanitarium for poor Hebrew Children," and with it, the necessity of that liberal support at the hands of the Jewish public, which, this excellent society deservedly merits.

THE REV. TOBIAS SCHANFARBER, of Chicago, who was one of the chaplains to the Republican National Convention held there this week, is to be congratulated upon the honor thus conferred upon him. But at the same time we may be permitted to deplore the institution of chaplaincies at political gatherings where so many business and other deals of doubtful religious significance are arranged. This is only another instance of the prevailing hypocrisy in American politics.

THE DEGREE of Doctor of Literature has just been conferred by the Heidelberg University of Ohio, upon Rabbi Gustav N. Hausmann, Rabbi of Cong. Anshe Chesed. Naturally his flourishing congregation thoroughly appreciate and feel justly proud of the honor conferred upon their Rabbi. The abilities of Dr. Hausmann are too well known to need comment at our hands and we bespeak for him a successful career in the Jewish ministry. There are very few occupants of the Jewish pulpit in our city who possess such a comprehensive knowledge of Scripture and Talmud or a more intimate acquaintance with Jewish Literature. We congratulate both the Rabbi and the congregation.

THE JEWISH PUBLICATION SOCIETY is to issue speedily its translation of the Bible.

"This version of the Bible in English," says the report of the board, "issued under Jewish auspices, will be free from all non-Jewish interpretations. When completed the Bible will be made accessible to all English-speaking Jews, inasmuch as it is planned to issue an edition at practically a nominal price, so as to enable every Jewish household to possess a copy."

A consummation devoutly to be wished, provided the work is placed in the hands of competent scholars, whose minds are filled with a knowledge of Hebrew, and whose hearts are filled with the spirit of God.

Women Voters.

WE are glad London Jewry is not behind New York in the matter of votes for women seat-holders in synagogues. At the election to which we referred recently the franchise was extended to ladies—if the United Synagogue, which is the supervisory and managing organization, will fall in with the view of its constituent, the Brondesbury Synagogue. At this writing none knows what the United Synagogue authorities will do: it cannot hurt to adopt the Brondesbury suggestion. Perhaps in view of the importance which the franchise would lend them, it might induce a better attendance of the Mothers in Israel at the services, or lead them to a more active participation in Jewish affairs. That is entirely their affair; ours only is to point out that here women vote at some of our Reformed Temple meetings, and at the gatherings of the Free Synagogue. But for London that is, as Kipling would say, another story!

Local Judaisms.

THE Verband of Galician and Bukowinian Jews has come in for some criticism upon the ground that its existence emphasizes the origin and Jewish ideals of but a small section of Jewry in general. This is regarded by some as a mistake because in America, forsooth, all our citizens must be Americans of the simon-pure variety, and nothing else.

We cannot sympathize with these views. Jews have the same right to join together in order to keep alive the ideals and customs of the lands of their birth as have Americans of German or Austrian or Italian birth or descent.

Added to this is the fact that the Verband in question was formed to aid and succor its members in sickness and distress, and to provide work for them. Surely a Galician Jew or a Bukowinian Jew, especially one but newly-arrived on these shores, is better off, in every sense of these words, with an employer who is a "Landsmann" than with a "Stock-Amerikaner". The practical value of such an organization as this Verband should by no means be lost sight of.

Too Open Charity.

IN the current issue of "Charties and the Commons" Miss Lillian D. Wald, the head worker of the Nurses' Settlement in Henry Street, and who is an authority on methods in scientific charity, discusses the necessity of providing some of the East Side with proper meals. She declares that their reported suffering is not general, and that the recent indiscriminate aid of the children is unwarranted.

Summing up, Miss Wald says: "Nothing in the circumstances of the school child within the last couple of weeks has warranted hasty action. The general condition has existed in this city for many years, though with increased hardships during this season. Experiments of former years and of this winter have proved the futility and mistake of meeting the needs of the underfed—or improperly fed—school child by free lunch rooms or kitchens on the basis of charity."

"The need of the school luncheon has been again recognized; it is not a revolutionary measure—in reality not a departure from the principle of the obligation assumed by educational authorities toward the child, but rather an evolution of the measures adopted for child nurture to the end of securing the highest efficiency of the responsible adult citizen."

"Estimated by the most material measurement, it is a comparatively small investment of public thought and public money for a large result. It has been tried and accepted in some schools and for the specially favored. It would be democratic and of wide social value if the successful experiment for the few were made general and for the many."

The board of education evidently has not a high opinion of the work Miss Julia Richman has set out to do in behalf of the starving school-children of the East Side. At a recent meeting one of the commissioners proposed that a committee of the board inform Miss Richman that she was employed to do school, and not settlement, work down-town.

This is correct: And just because Miss Richman has always insisted on mingling settlement work with her school work, and because her self-imposed guardianship of the East side Jews has been so pronouncedly un-Jewish mainly because of her ignorance of the customs and ideals of Jewish Jews she has drawn upon herself the criticism and the displeasure of the entire Jewish community of this city.

The Responsibility of Leaders.

WE have do desire, certainly it is no business of ours, to judge the merits of the remarks of Sir Philip Magnus, of London, referred to in another column. We do not live in England but in free America, and would not therefore presume to tell foreign Jews how to set their communal house in order.

At the same time Sir Philip Magnus' speech may serve us as a hook upon which to hang a number of our thoughts with respect to our own community.

New York Jewry has often been compared with London Jewry, and in ninety-nine cases out of a hundred, to the disadvantage of the former. We are told we lack unity and community of interest and purpose, and that we have no leaders or at least none who are universally respected.

If by leaders are meant the persons to whom like Sir Philip Magnus everybody salaams, of whom like Sir Philip Magnus in the instance referred to everybody is the retainer, then we have none. Thank God for it! Here all may speak as they please. True, occasionally prudence oversteps its bounds—but enthusiasm is far better than cowardly hedging to authority.

And, in spite of our much desired license of speech and deed, we venture to say that in politics—ridden America,—now in this presidential year the very air is full of the germ,—at a Jewish educational gathering—say like that at the Jewish Theological Seminary of America two Sundays ago—no man, no matter how high and important his position and influence may be, when called upon to make an address would make a political harangue.

Our Jewish Anglomaniacs who look upon all that is English with rapture and on all that comes out of Germany or America with averted faces, please note!

THE JEWS OF IOWA who are trying to help Governor Cummings to realize his ambition of obtaining a United States Senatorship are adopting mistaken methods. They have taken to organizing "Hebrew Business Men's A. B. Cummings Clubs."

Light and Utility.

יהי אור.

"Speak unto Aaron and say unto him, when thou lightest the lamps, against the candlestick itself, shall give light the seven lamps."—Numbers viii., 2.

LIGHT is the emblem of Judaism, adopted on account of its mature brightening and illuminating everything around wherever its rays can reach. When God created the world; before yet anything was brought forth, Scripture informs us that God gave utterance to the words יהי אור "let there be light!" and that opened creation with light; indicating that God intended this world for a bright, light world, for both the eyes and life—for the eyes—not to grope blindly about our ways, but to see, search, investigate, probe and accept things understandingly; for life, not to wail and moan about the enjoyment that others indulge in; but to live at all times in joyful mood, enjoying every pleasure that is proper and legitimate.

Now, that the tabernacle had been built, this bright emblem of Judaism is given unto the hands of the priest, the teacher of righteousness, to exhibit it in proper manner before the Children of Israel. That the light would naturally illumine the tabernacle is a matter of course, but that it should have thrown its light against the body of the candlestick that held it, needed perhaps some elucidation.

Following this direction to the priest, a description is given of how masterfully this candlestick was made by skilled artificers who deserved the respect of the people. In former readings a detailed account is given of the donations that came from the various sources. Everybody had contributed liberally towards the building and the perfecting of the central sanctuary, the holy resort of Israel. Mechanics and laborers had given their skill and talent—even the women contributed their handiwork; but it must be remarked that Aaron, as all the Levites, gave nothing. It was not required they should give; so he felt ashamed, says the Midrash, and he soliloquized sadly: "All are recorded as donors, but I and my tribe gave nothing;" and the voice of God softly called: "Aaron, be not dismayed, thou bringest the best of all that is good—thou lightest the lamps in the sanctuary."

What were the lights in the tabernacle most needed for? Prayer books there were none to read. Women did not come in with magnificent imported bonnets, or Merry Widow hats; they were not garbed in Worth's latest style or Directoire gowns; they were not mere walking fashion plates with glistening jewels to be viewed and admired, rewarded perhaps by their own notice. The light was not there for the display of vanity, but mostly for its emblematic and symbolic representation. It was there to show the beautiful art of the candlestick itself, signifying that skill and talent were to be highly esteemed among Hebrews. No carved image, no costly painting, no works of plastic art, no engravings that should in any way represent an image or figure of any kind was permitted there; nor ever thereafter in a Jewish house of worship; but every art, every skill, every talent, every science was encouraged and commended. That is what light mostly stood for.

Light, furthermore, stood for understanding, as Solomon had said, כי נר מצוה ותורה אור "Commandment is a lamp and the law (of God) is a light." not to idly fold the hands and lie dormant, but to open the mind to admit its rays; as that we do not follow a blind faith, an irrational belief, but a reasonable knowledge of God and His will.

This is made clearer when we understand the beha l'pthecha literally does not mean to light up, be-he-ircha would mean that; beha-al'pthecha means, "when thou causet to ascend, expressing the duty of the priest. It is his to cause the light so to ascend as to bring out the beauties of Judaism. Our priests, the teachers, the preachers, have to teach Judaism so, as not to keep the flock in blindness, but to elevate them with the luminous knowledge that should make them proud of the religion that gave the civilized world the knowledge of God and His truths. Many have still not grasped the real idea of Israel's light. "Let there be light," is still incomprehensible to them, as they are led by selfish dogmas, by sectarian doctrines of salvation, wanting others to believe as they believe or else read them out from "kingdom come." It is ours to stand steadfast and firm as our fathers did, carrying our light to brighten up the world—to light up the human mind; so that we form, so to say, the candlestick, and the light thrown out shall cast its rays against us. In other words, we should be seen recognized as the light-bearing, light-giving people, whom God had chosen to be a kingdom of priests, whose duty it shall ever be, like of Aaron of old to keep God's light ever burning.

IN HIS NEW VOLUME, "The Religion of a Democrat", Prof. Charles Zueblin, of the University of Chicago, declares that the church is only an agent co-operating with the state in synthesizing and democratizing all human wants. The church, he asserts, is inadequate for the expression of democratic religion because it depends upon dead formulae, fears to trust the instincts of the people, and is aloof from industry and politics. How different from this is Judaism. It is a democratic faith, for a democratic state, for democratic people and is the web and woof of our lives and thoughts and beings.

THE MIRROR.

No one would have imagined for a moment that the wonderful voice of the world-renowned Caruso is mentioned in the Bible. Nevertheless it is a fact, for we find in Daniel, Chapter third, fourth verse *וְכָרְחוּ דָרָא כְּחֵלִי* which is aptly rendered, "And Caruso called with a powerful voice."

It has been suggested that Dr. Kaufman Kohler, President of the Hebrew Union College should go through the ceremony of *שְׁנוּי הַשֵּׁם* *shinuy hashem* "change of name," and call himself "Joseph;" for like him *הוּא הַשְּׁלִיט* *hu ha-shalit* על *הָאָרֶץ* *hu ha-aretz* הוא המושל על הארץ He is the ruler of Reform Judaism in America, and the *am ha'aretz* graduates are sold when they are led to be that they are "Rabbis."

Referring to the verse *וְלֹא יָדַע אִישׁ אֶת קְבֻרָתוֹ* *And no man knoweth his (Moses) grave* (Deut xxxix:6.) the *Sohar* 1.27 b says *קְבֻרַת מֹשֶׁה מְשֻׁנָּה* "the grave of Moses is the Mishnah."

Was the writer a Karaite, a prototype of the present Reform iconoclasts or a mere modern American journalistic "rabbi hater?" Will some Talmudic savant, kindly rise and explain?

Nowadays, when we want any information upon Jewish matters, there is no necessity for turning over the pages of the Jewish Encyclopedia; all that is required is to carefully scan the columns of the secular press, where the average reporter disporteth himself like the huge Leviathan in theological waters.

The *Minneapolis Tribune*, for example, sagely tells us, that on the first day of "Schevios," as he calls it, "the orthodox Jews live on meat exclusively, while on the second day the domestic dietary laws are reversed, and milk food, such as cheese and butter makes up the diet."

The sapient reporter further says: "Each of the 49 days between the Passover and the giving of the Law is devoted by Jews to cleansing themselves from one of the 49 temptations by which they may be beset."

It is a recognized fact, that frequently the most important inventions are sometimes brought to light by mere accident, from casual observation of some trifling matter, and the space writer's lucid presentation of an observance probably only known to the *Minneapolis Tribune*, adds additional point to the old adage *מִכָּל מַלְמְדֵי הַשֵּׁכֶלֶת* "from all my instructor's will I gain knowledge." It should not be *הַשֵּׁכֶלֶת* "I will gain knowledge," but *הַשֵּׁכֶלֶת* "I will learn nonsense."

At the annual picnic of the Reform Rabbis, which will be held during the coming month at Frankfort, Mich., when the Ecclesiastical Knights of the Round Table are assembled in solemn conclave, and the whole Jewish scholarly world without awaits with bated breath, the results of their learned deliberations, I would

suggest that the question "What are the 49 temptations by which the Jews may be beset during the intervening days between Passover and "Schevios," be taken up for serious discussion.

When each rabbi unburdens himself of the particular temptation which has beset his career,—whether it be eating *chazzer*, or smoking on Shabbas, or trying to learn Hebrew, or playing tennis on the day of rest, or flirting *בְּשִׂעֵצוֹת הַיָּמִים* with the "water nymphs," or cribbing sermons, or backbiting his colleagues—it will be a very interesting function, and might form the basis of a new Reform edition of "Moses' Miscellaneous Messuggas."

Referring to the story told in the last *Mirror* "that the Rabbi was a vegetarian because there was no meat in his sermon," reminds me of the Trustee of one of our Conservative Congregations, who told the Rabbi that while he liked meat in his sermons, he was opposed to *Chazzer* that is to say he objected to sliced "Bacon" served up as an original dish.

The Sunday Jews of Temple Beth-El are now enjoying a vacation. Rabbi Joseph Silverman, no longer brings the glad tidings of salvation to the un-Jewish Jews, who on Sunday morning religiously sit at the feet of Gotham's Gamaliel, but saddest of all *וְעַל אֱלֹהֵי אֲנִי בֹכֵיָה* and "for this do I weep," that great stronghold of Judaism—the Free Synagogue—closes its doors through the summer, just when thousands of free seat grafters, are perishing for the priceless waters of effervescent gush.

The Jewish Women's Council of Huron, Ohio, recently petitioned Congress for the establishment of playgrounds in the District of Columbia.

"Let the Light of Thy Countenance be Shed upon the Hand of the Giver."

The other day I read in one of the daily papers, that a couple were married by a minister in one of the cities in Kansas. After the ceremony, the bridegroom pushed into the fingers of the clergyman a bank note, which the latter, in the usual way, crushed in his hand and only looked at it after he had led his guests to the buggy, which drove off rapidly; when lo, and behold, he found it to be a counterfeit ten dollar note.

I never could understand, and do not now, why there should be so much legerdemain about the transfer of a fee for services rendered as is practiced between the clergy and laymen. Every laborer is worthy of his hire, whether on the big pipes or in the vineyard of the Lord; and a man

has no more right to expect a minister of the Gospel to do a service for him without remuneration, than he has to consult a lawyer without paying a fee for the advice.

Every man selects a profession in order to derive a livelihood therefrom. The ministry is supposed, it is true, to occupy a less sordid position than the other professions; but I believe, with Mr. Bryce, who says in his excellent work on the "American Commonwealth," that "Even in the Christian Church there are other than spiritual motives to lead pastors to spiritual work; nor do all poets write because they seek to express the passions of their souls," to all of which every sensible person will say Amen. And this applies to every other church beside that of the Christian denomination.

Some over-pious individual, whose gaze is always directed heavenward, and the whites of whose eyes are oft only visible, would have one believe that money and religion are deadly foes. Not at all. Even a great number of saintly-inclined ministers preach against the precious minted article, and it is possible that because of this theoretic-religious way of treating the lucre that a fee is never received openly in the face of the Lord, but covertly by the giver getting into contiguous juxtaposition to the divine cloth and by an artistic juggle transferring "what makes the mare go" into the palm of the hand which opens up to receive it, and then closes like a vise to hold it.

It requires money to spread the Gospel, and there would be a fearful state of irreligion and irreverence and chaos if the wherewithal to preach it were not forthcoming. Our Temples, Synagogues and churches must be built and paid for; our Rabbis and dominies must be educated and compensated, and the running of a Synagogue or Church, if I may use the common vulgar worldly term, is as much a business as the trustees of many a Synagogue and Church can testify to, and often requires as much tact and skill as any secular enterprise or undertaking.

Don't let us apotheosize Mammon and worship at its shrine to the utter disregard of what is righteous; at the same time we must not despise the value of money, and the money itself, and its purchasable power, its instrumentality for good, and its appliance to purposes of which the Almighty will approve. Neither the Synagogue, the Church, the State nor the individual can well afford to do without it; this is a truth so apodeictical that no further time need be lost in demonstrating it more fully.

No lawyer would think of permitting a client to push a fee into his hand without examining it in his presence, and if it is insufficient he will tell him so. A clergyman may say "but this is your business; fees are extra, in addition to our salary." To this might be answered, "No minister, no clergyman contracts with his church to attend marriage ceremonies, funerals and other occasions—mournful as well as merry—as included in his stipend." If this is so, it is a service, which is "business" as much so as is the lawyer's, or doctor's, and being so, the pay should be handed over open and above board. It is honorably earned and should be properly tendered and accepted. L'AIGLON.

"Reform Temple of the Jewish Persuasion."

Editor HEBREW STANDARD:

In your issue of May 29, your editorial in regard to Moses Maimonides Memorial Temple of Brooklyn, or "Reform Temple of the Jewish Persuasion," seems fraught with a sympathy mixed with condemnation over the organization which has its announcement for the benefit of the Jews, who believe that even in religion there can be certain forms laid aside if the substance is preserved. The world moves and no obsolete dress or form, are so sacred as to demand the respect, love and veneration of those who belong in the ranks of progress. *The stage coach of a century past* had its comforts for our ancestry; laced cuffs and frilled and puffed shirts bedecked and made manly and admirable the beau of the past; *plated and chained armor protected the warrior from the missiles and weapons of the enemy*; the obsequiousness of the Courtier was admirable in past ages. But these are things of memory not to be observed in this *practical age of the 20th Century*, but to be smiled at and condoned because the beings who were subjected to them had made all the progress that it was intended that they should make. Our children and grandchildren will have progressed beyond us to the extent as we have progressed beyond the age of our ancestors, and that progress it is *devoutly hoped will be in spiritual matters* the same as in material matters. They may observe the substance, but forms will undergo a mighty change.

The Jew of the present is not the Jew of the past. He is not circumscribed in his acts of humanity by tribal relations; his treatment to others differing with him in religious views is broad and humane, and his charity is distributed with a broad and liberal hand towards those in distress, whether they be Jew or Gentile. As time goes on, he will broaden and grow as material things have grown in the past, and will grow in the future, and by that growth he not only will win the love and respect of those of his own blood, but he will excite and command the admiration of all who believe in a just God and a proper and humane mode of life.

A Synopsis of Different Religious Ideas.*

By SIDNEY ROGOW.
(age 13).

THE theories respecting God and his methods, are so numerous and so divergent, that an impartial onlooker would be sceptical as to the correctness of any. A truly religious man, however, need have no inward misgivings on the subject. Religion is simply *faith*. No one has been able to prove beyond controversy that a God exists, that we are endowed with souls, or that our souls are immortal. Nor has anyone been able to demonstrate successfully, the opposite. It is essentially the force of our own convictions, which sustain our theories. Nevertheless, it is very interesting to examine the conflicting ideas.

The most widely accepted religions of the world, generally agree on one point,—monotheism—the existence of one and only one God. The most powerful exponents of this doctrine are Judaism, Christianity, Mohammedanism and Brahminism—which must not be confused with Buddhism.

In the Jewish religion, the most important factor, besides the recognition of but one omnipotent God, is the advocacy of Immortality—the eternal life of the soul. Granted that religion is a belief; yet beliefs are not fabricated on the instant, they spring from the deductions of long generations of experience. Hence: there are reasons which we consider, are sufficient to justify our faith, in Immortality. These are:

- I. It has always been naturally embraced by men, and was prevalent even among the earliest savages.
- II. Science teaches us that matter is indestructible; how much more probable then than the soul, of a higher and finer substance; should be imperishable.
- III. It seems necessary that some recompense be afforded to those unfortunate individuals who have been handicapped at birth.
- IV. One short earthly life does not seem sufficient to enable us to achieve our ambitions.

Therefore! we may conclude that our beliefs have reasonably firm foundations.

Next, we come to Christianity. Perhaps the most abhorrent doctrine of this otherwise lofty religion, is the confusion of a trinity about a monotheistic ideal. If we accept this idea literally, which is the only possible manner, we arrive at rather awkward conclusions. It does seem rather contradictory, that a perfect spiritual God should descend to beget a son, a son who is one and the same as God, and that this son, who is one with God in order to please the God who is the one with the son; should offer himself to God, in order that his sacrifice to his father, who is the same as himself, should enable this omnipotent father to have evil banished from the earth; something which, by the way, was never accomplished. Satire at its best, is undignified in a religious discussion, yet when ideas are so constructed as to be fallacious, ridicule is the best shaft with which to explode them.

Mohammedanism, next to be considered, is almost wholly like the religion of Israel. Like Judaism, it has an expounder, Mohammed, and a Divine Being, Allah, who is merely different in name from our own God. They are really sister religions. There is but one fundamental difference. That is; that Mohammedanism permits polygamy, and prohibits the use of wine, while Judaism's restrictions are vice-versa. The demoralized condition of the Arab, as contrasted with the moral serenity of Israel's household; is a mute witness, attesting Judah's superiority. One fault of Mohammedanism must be censured, and that is their overwhelming zeal, to establish their teachings by fire and sword.

The last religion to be discussed is Brahminism. This is not an idolatrous sect. Probably one of its most peculiar creeds is that their God, being just as much an ideal conception as any other, is feminine; while, although no special gender is assigned to ours, God is generally regarded as masculine. Their reason for that is, that a mother is naturally more tenderly related to the infant, than a father.

But their most curious doctrine is that of reincarnation—the indefinite embodiment of the soul through generations until it has attained perfection on earth. Their reasons for this is that:

- I. Witnessing the inequalities of this existence, they conclude that as the soul is perfect before it descends here that there must have been another underlying cause, in a past incarnation; which is being punished here. And,—
- II. Seeing, also, that many crimes go unpunished on this earth, they infer that they will be expiated in a future incarnation.

When we compare this, with our own idea of immortality, we perceive immediately, how much more ours coincides with God's attributes of "Mercy". Can we conceive that a forgiving God should force us to endure the miseries of an indefinite number of sojourns on this earth? No! Crime at worst is developed by either hereditary disorders, or by circumstantial necessities. Neither of which man can foresee or prevent. Hence: Can we believe it possible that our precious Father could be so exceedingly exacting as to punish us for deeds, for which we are not directly responsible? No!

How much more human is our idea of a peaceful state of rest and pardon for the wearied soul!

But, above all, our entreaties, break the narrow-minded limits of one sect's welfare and are offered for universal blessing of peace and happiness.
