The Jew in Politics.

THE painful silence was almost physical. Finally the girl's fingers unstiffened and her set teeth went apart, her head slowly uplifting.

"I am determined, father," she said calmly, and leveling eyes concentrated with final purpose, "if I can't marry him with your consent, I'll marry without it."

Her parent's eyes met hers sorrowfully. "So all my teachings are for naught," he breathed heavily, his head going heartbrokenly; "the traditions of our people are not to be taken into consideration. You, yourself a woman of fine and deep sentiment, say Judaism means nothing. Does the Christian say that of Christianity? And such Christianity as exists to-day! Our faith,—it is nothing to you; although thousands have suffered and died for it. And yet to-day, with all the persecutions of our people, we are alive, while other races have come, lingered, died, and then disappeared forever. *The faith of our fathers still lives!*"

"What is the faith of my fathers to me?" flashed the girl, standing forth bravely. "In this advanced age, what difference is there, or should there be, between Jew and Christian? Why should I not marry a Christian if I love him, and he loves me? Love, true love, real love is the greatest thing to a woman. Every sacrifice a woman has ever made has been for love; either mother love, or love for the man of her heart."

"But the love of our faith is greater, far greater, than anything earthly," returned her father with solemn impressiveness. "Perhaps not to you,—but to me. And though I am not an over-pious Jew, still I do not want my child to marry outside my faith. *The Jew must stand by the Jew!* It is our only salvation, the only hope of keeping together our scattered forces; to keep Judaism alive! What will become of us if we intermarry? Our people will disappear, our children will become Christians, or even worse, and then, farewell—Judea. But it will not be so. God has ordained otherwise. The fact that we are here so long, proves that we are a race of people unperishable, to last until time is no more;—not to be wiped off the face of the earth." He paused for a moment's breath. "My daughter, before you take any rash step, consider again what you are about to do. Think of the alliance you are about to make. See, I am not angry. Only my heart breaks to think that among all the youths of our own people there is not one you would select as a husband. It is indeed sad that you must go outside Jewry. There may come a time, perhaps, when you will look back at the step you are about taking, and look back with reddened eyes and a weeping heart."

"Father," responded the girl, choking back her emotion, "I have determined to become the wife of the man I love;—even though he be a Christian. I am ready to suffer the consequences, let them be what they may."

EVEN in Anti-Semitic Germany we find that the Jew in politics takes front ranks.

Ferdinand Lasalle, the founder of the German Social Democracy, the darling of the German working classes, jurist, economist, orator, philosopher and poet, made Socialism a force in European politics; and when he died in a duel in 1863, at the age of 38, Bismarck and he were considered the two foremost men of the Fatherland. Edward Lasker was another idol of the German working people who became known as statesman by his work on the constitutional history of Prussia, as a member of the Prussian chamber, and subsequently of the North German and German imperial parliament. He was one of the founders of the National Liberal party, although on more than one occasion he voted with the Progressive party. He was a member of his political party just as long as it upheld justice. He was a promoter of the union of the southern and northern states of Germany. He was for years the acknowledged leader in the Reichstag. He was for a long time a powerful supporter of Bismarck, until the latter's administration introduced a bill which aimed to limit the freedom of speech in parliament. Thenceforth Lasker became Bismarck's decided antagonist.

In 1848 Herr J. Mannheimer was elected to the presidency of the Austrian diet. The famous Gabriel Riesser, the same year, was elected minister of state to the prince protector of Germany, John of Austria.


Ludwig Bamberger, for many years a member of the Reichstag, and author of a number of works on history and political economy, was one of the makers of modern Germany. He was, at one time, one of the leaders of the National Liberal party and an adversary of the late Prince Bismarck. In the revolution of 1848, he became one of the leaders of the popular movement, and took an active part in the insurrection of 1849, the object of which was the establishment of a constitutional government for Rhenish Bavaria.

In the Reichstag, Herr Bamberger became one of the chiefs of the National Liberal party and assumed an important place as a financial orator. Later he distinguished himself in the ranks of the Progressive party as one of the adversaries of Bismarck.

Dr. Wilhelm Cahn, privy counselor of legation and one of the legal advisers of the ministry for foreign affairs, was the only Jew in the imperial chancellery and was publicly commended by Bismarck for having refused to abjure his religion in order to gain advancement. At the time of the outbreak of the Franco-German war, Dr. Cahn was in Paris as counselor of the Bavarian legation; he remained there throughout the war, under the protection of the Swiss legation, and he did not leave his post even in the terrible days of the Commune.

DAWN OF FREEDOM IN ITALY.

It is not much more than seventy-five years since the Jews were permitted any liberties in Italy. Yet under the most adverse circumstances, Isaac Pesaro Maurogonato be-

came "an athlete in parliamentary debate." He was born in Venice, November 15, 1817. After having achieved success as a lawyer he turned his attention to politics. In 1848 he became postmaster-general of Venice, and in 1849, minister of finance and commerce.

Only since the establishment of the kingdom under Victor Emmanuel II. have Italian-born Jews enjoyed equal civil and political rights with their fellow countrymen. Yet the people who were considered the lowest have by their talents and character reached with astounding rapidity the highest round in the ladder of political fame.

One of the most illustrious careers in Italian politics came to a close at Rome a few years ago by the death of Senator Artom. In 1855 he received an appointment at the ministry for foreign affairs. The famous statesman, Count Cavour, recognized his profound genius; and, in 1858, he appointed Artom to his private cabinet. Signor Giacomo Malvano held the responsible post of general secretary of foreign affairs. The present mayor of Rome is a Jew.

France was the first of all European countries to grant to the Jews civil and political rights at the time of the great revolution in 1793. The Jewish religion is one of the three religions recognized in France and supported by the state, being on the same footing with Catholicism and Protestantism. Since 1793, Jews in France are both electors and eligibles, and no office whatever has been closed to them.

Bordeaux, Avignon and Nimes have had Jewish communities for centuries; and many of the Jews of France are better French stock than some of the great families, which have played a prominent part in history, like the De Broglies, who came from Piedmont; the MacMahons, who were Irish; like the people of Alsace-Lorraine, who belonged to France only since 1648, and like Bonaparte, or Bournaparte, the name of the family which has given to modern France its imperial dynasty, who were Italians.

In politics the Jews in France have been powerful out of all proportion to their numbers. There are only 80,000 Jews in France today, and it is simply astonishing how many ministers their race has furnished to France.

The great ultra-liberal Gambetta (1838-82) was of Genoese-Jewish descent. David Reynal, of Bordeaux, became senator, and, under Ferry and Casimir-Perier, minister of public works and minister of interior—the real ruler of the French republic, ninety years after

the emancipation of the Jews; E. B. Millaud, senator and minister of public works under Goblet; Jules Simon, minister of education and religion under Thiers; Camille See, the successful champion of female education; Lockroy, heir and relative of Victor Hugo, secretary of the navy during a recent ministry; M. Naquet, friend and adviser of Boulanger, are a few of the Jews, who have distinguished themselves in French politics.

GREATER LIBERTY IN ENGLAND.

The first gleam of hope for civil and religious liberty in England was the repeal of the test and corporation acts in 1828. This first decisive move in the right direction was received with exultation by Roman Catholics, Christian dissenters and British Jews. But the clause "On the true faith of a Christian," appended to the Oath of Abjuration, was a clause intended as a protection against any mental reservation on the part of the Roman Catholics to jurisdiction in England, although not intended to affect Jews. Jew-baiters used this unintentional clause in the new declaration as a bar to a Jews' admission to the parliament, to officers under the crown, and all municipal and corporation affairs.

Many attempts were made to relieve the Jews from the political and civil disabilities from which they were then suffering. In 1835 David Salomons was elected sheriff of London and Middlesex; and to enable him to serve the office without subscribing to the declaration "On the true faith of a Christian," a bill was passed, entitled "The Sheriff's Declaration Act." In the same year Mr. Salomons was elected alderman of the Ward of Aldgate; but being unable to take the abjuration oath he could not accept the office, which was declared vacant and a Christian elected.

Various emancipation bills were placed before parliament, but failed to remove the disabilities which then effected the Jews in England, so that the efforts of the friends of equal rights were directed toward removing the disabilities gradually by successive efforts. In 1837 Moses Montefiore was elected sheriff of London and Middlesex, and received the honor of knighthood from Queen Victoria.

In the same year David Salomons was defeated in the Borough of Shoreham, this being the first attempt of any Jew to enter parliament. In 1844, David Salomons was for the second time elected an alderman for the City of London, but was again prevented from accepting the office, because he could not subscribe to the oath which he was bound to take.

In this same year British Jews were relieved from the obligation to subscribe to the oath "On the faith of a Christian," upon being elected to municipal offices. In 1836 Sir Moses Montefiore and Baron Anthony de Rothschild were made baronets of the United Kingdom of Great Britain and Ireland. In 1847 Baron Lionel de Rothschild was sent to parliament by the Liberal electors of London, but, unable to take the oath "On the faith of a true Christian," he was not permitted to take his seat.

The contrast between parliament and the people was proved by Baron Rothschild's re-election for the City of London in the years 1848, 1852 and 1857. In 1851 Alderman Salomons was returned to parliament as a member for Greenwich. He insisted on taking the oath upon the Old Testament, and omitting the declaration "On the faith of a true Christian," concluding with "So help me, God." He took his seat, voted and spoke three times on the very question of his right to remain in the house, but he was compelled to withdraw. An action was taken against him to recover from him three penalties of five hundred pounds for sitting and speaking three times and voting in three divisions in the house of commons without taking the oath. The affair led to long legal proceedings before the court of exchequer. In 1855 Mr. Salomons was elected lord Mayor of London, becoming not only the first Jewish Lord Mayor, but the first Jewish member of the privy council. In 1857 Baron Lionel de Rothschild, having resigned his seat in the house of commons, was again re-elected. The Liberal electors of London were determined never to cease electing a Jew to parliament until their efforts were crowned with having him seated.

Through all these years, bills removing the disabilities of the Jews passed the house of commons, and were as regularly rejected by the house of lords. In 1858 a new oath bill, applying only to Jews, was carried in the house of commons and referred to the house of lords, and was passed with certain amendments, which were not approved by the house of commons. A conference of both houses was consequently appointed, and Baron Lionel de Rothschild was named to serve on the committee. To the surprise of his brother lords, the Earl of Lucan gave notice that he would introduce a bill authorizing the house of parliament to admit Jews by resolution without the obligation to subscribe to the words "On the true faith of a Christian."

This bill afterward passed the house of lords on the 16th of July, 1858, and the house of commons on the 21st of the same month, and on the 23d it received royal assent; and Baron de Rothschild took his seat in the house of commons on the 26th of July. The year following, Mr. Alderman Salomons was for the second time returned to parliament and given his seat. Since then, many distinguished Jews have served in parliament.

DISRAELI'S METEORIC CAREER.

The remarkable rise of the British Jew in politics reached its high-point in Benjamin Disraeli (1805-81), Earl of Beaconsfield, premier of Great Britain, who without help or friends, pushed his way up through the middle classes, through the upper classes until he swayed the scepter of England for twenty-five years and became one of the controlling powers in European affairs. Scoffed, ridiculed, rebuffed, hissed from the house of commons, he simply said, "The time will come when you will hear me." After three defeats in parliamentary elections, he was not

the least daunted, for he knew his day would come. Lord Melbourne, the great prime minister, when the young man was introduced to him, asked him what he wanted to be "Prime minister of England," was his audacious reply. When an aristocrat, opposing him for parliament, loftily declared that he "stood on his family name and broad acres," Disraeli replied, "I stand on my head." Imagine England's surprise, with her contempt for self-made men, to see this man, sprung from a hated and persecuted race, virtually her ruler.

The late Lord Herschell, who died at Washington, D. C., March 1, 1899, was of Jewish descent. He was chairman of the Anglo-American joint high commission from Great Britain, twice lord high chancellor of the London university. A few days before his death he was complimented with a seat on the supreme court of the United States, a compliment which had been extended once previous, in the instance of the then lord chief justice of England. George Faudel-Phillips, the fourth of his faith who became lord mayor of London; Sir Joseph Wolff Drummond, the English minister to Turkey; Sir Otto Jaffe, former lord mayor of Belfast; and Mr. Louis S. Cohen, lord mayor of Liverpool, are only a few among scores of distinguished Jews in the municipal and national politics of England in our day.

CORRESPONDENCE.

AN OPEN LETTER TO THE ORGANIZERS OF THE PROPOSED JEWISH ORGANIZATION.

Editor HEBREW STANDARD:

IT is not out of lack of appreciation of the lofty motives, zeal for Jewish interests and moral courage which prompted you to attempt what has hitherto been deemed unachievable, namely, the welding together of all factions and all sections of the local Jewry into one *Kehilla*, but on the contrary just because of my sincere admiration for the undertaking, and the great hopes which I cherished for the same, that I presume to take exception to the work which you have done since the closing of the Clinton Hall Conference.

1. It was widely reported by the press, and as you have not contradicted the same I take it to be a correct statement, that you have come to an understanding with the Committee by which the proposed new organization placed itself voluntarily under the protectorate or patronage of the latter. In fact the press report which ran to the effect that "the Jewish Committee has assumed the task of calling the new organization to life," and which went unchallenged by you, amounts to nothing else than that the organization which first saw the light at Clinton Hall has entirely given up its ghost to be borne again "on the knees" of the Jewish Committee. It was further stated that after being so created, the new organization shall constitute the New York section of the

Jewish Committee. This also went unchallenged by you; in fact the report had an official ring in it.

If all this is true, the temporary committee which has made such transactions is guilty of high treason to the Clinton Hall Conference, by whom it has been created. Like the legions of Rome, in the well-known Talmudic legend of Onkelos, the committee went out to conquer and was itself conquered. The suggestion at the Conference was to propose to the Jewish Committee that it place its New York section under the jurisdiction of the new organization; the committee ended by agreeing to constitute itself the New York branch of the Jewish Committee, and thus place itself under the jurisdiction of the latter. And this, considering that the Jewish Committee has at no time been recognized by the national or local Jewry as a representative body of the same, as in truth it is not. (This of course is not intended to cast aspersion upon the individuals composing the Jewish Committee or upon the noble work they have already done for Jewish and cosmopolitan interests).

2. It was stated in the HEBREW STANDARD of Dec. 52th, that "the temporary committee will probably call a conference of delegates to elect an executive committee which shall have the power to transact all business of the organization for a year." Now if they do issue such a call, chances are that a number of organizations will, through lack of insight, send delegates who will agree to such a method of representation, and then New York will be blessed with a *Ze'er Anpin* or, to use a more popular expression, an abridged edition of the Jewish Committee, which will parade before a non-Jewish world as representative of the entire Jewish population of New York, but which in reality will represent only the twenty-five persons composing it.

As a delegate to the Clinton Hall conference, and especially as a member of the New York Jewish community, who has the interests of the same close at heart, I emphatically protest against such a mode of representation, and I hope that every right-thinking man will agree with me, that if New York is to have a *Kehilla* at all it must be a truly democratic body in harmony with the American spirit; an assembly in which every organization shall be represented by its own delegates, who, without mediators of any kind, shall themselves transact the business of the community at regular and special sessions in accordance with parliamentary usage. I would go a step further yet and propose that the great mass of Jews who are not at present affiliated with any Jewish organizations shall also be allowed a chance to be represented in the *Kehilla* by joining the new organization directly and paying to the

same a small monthly dues (just to signify affiliation) which will entitle them to send a proportionate number of delegates to the *Kehilla* in accordance with the laws of representation governing regular organizations.

In conclusion I wish to emphasize, first, that it is positively undesirable, and wholly subversive of the original idea, for the Jewish community of New York to place itself under the tutelage of any organization, least of all of a body which is admittedly unrepresentative in character.

Secondly, that if a new organization is to be created at all it must be truly representative. The greatest Jewish community of the world would not, and by right should not, delegate its power to twenty-five men, be they even Solomons, every one of them. That an executive, even of twenty-five wise and earnest persons, is not infallible, was in fact already illustrated practically by the transactions of the very committee created at Clinton Hall.

The Senate has again considered a number of Real Russian complaints against M. Stolypin's circular on Jewish residence outside the Pale. They were all rejected by a large majority. It is significant that the Premier, in defense of his action, stated that his circular was not intended to stop the exile of the Jews from Central Russia, but to regulate their expulsion.

According to a telegram dispatched from Adia Abeha, Abyssinia, Dr. Faitlovitch (who has been sent on a mission by the Pro-Falashas Committee, of which Chief Rabbi Margulies of Florence is President), has again been received in audience by the Emperor Menelek. His Majesty gave Dr. Faitlovitch the assurance that he would take measures for the improvement of the condition of the Falashas.

The Daily Telegraph, of London, recently printed an article from a correspondent dealing with the entente with Russia. The writer makes a strong appeal for liberty, and urges that the Tsar shall once more call Count Witte to his counsels, and bid him make a reality of the Constitution, which he helped to frame, so bringing peace and tranquillity to Russia, prosperity to her commerce and industry, and personal safety to the autocrat Sovereign who rules her destinies.

With the death of the late Minister of Justice Muravieff (recently Russian Ambassador at Rome) the anti-Semites have lost a strong supporter of their views in the bureaucratic world. The deceased was well known among the Jews for his strong persecution of the Jewish lawyers, against whom he introduced a series of restrictions. During the famous trial of Blondes for ritual murder at Wilna, the late Minister also displayed great animosity towards the Jews. Although he outwardly sided with our coreligionists, he did all in his power to hinder the triumph of justice.

A deputation of Odessa Jews, headed by Rabbi Dr. Arinovitzy, was received by the Tsar's Commission sent to investigate the recent shooting affray. The delegates expressed their loyalty to the Tsar, and protested against the accusation that the Jews were revolutionaries. General Pantelejeff, in his reply, thanked the deputation and the Jewish community for their kind wishes, and made inquiries concerning the numbers of the fresh Jewish recruits. He also announced that there was no truth in the statement that the policeman who killed the officers was a Jew. In connection with the inquiry, the Russkoe Znamya has published a special message to all its followers informing them that the Real Russians have succeeded in persuading the Government to allow General Tolmatcheff to remain at his former post.

The Sabbath Lights.

The kindling of the Sabbath Lights has always been deemed of vital importance to all true adherents of the Jewish religion.

It ushers in the Jewish Sabbath, transplants in poetic idealism the true believer from the domain of toil and earthly labor to a higher plane of spirituality.

It emphasizes the passing from the mundane to the celestial, from the week of toil and trouble to the day of rest, and develops within the heart the earnest prayer for "that day which will be all Sabbath and rest through eternal life."

On account of the significant lessons which this simple lesson teaches, the sages of Israel, more than twenty centuries ago, discussed in their own quaint, discursive manner the question: "With what material may the Sabbath Lights be made?"

This interesting, polemical discussion is to be found in the Midrash, treatise Sabbath, Ch. ii, and is known to the Jewish world from its initial introduction as "Bammayh Madlikin," as follows: "With what material may the Sabbath lamp be lighted and with what may it not be lighted?"

The knowledge to be derived from a study of even mere perusal of this treatise is deemed of such importance that it has been incorporated in and forms an integral part of the Synagogue Ritual for the Friday night services.

It particularly emphasizes the fact that nothing of an impure nature should be permitted to enter into the composition of the light, and that no petty niggardliness should be employed upon the score of economy.

The "pros and cons" of the matter are plainly and lucidly set forth, and that the use of the Sabbath Lights and the preparatory purity of their composition is not a questionable matter among Israelites is demonstrated from the fact that the sages of Israel deemed it important enough to incorporate their opinions in the Mishnah, for the guidance of future generations.

The use of the pure paraffine wax candle has been strongly recommended, by reason of the purity of the component ingredients by scientific and intelligent investigators who have given the matter close study and are convinced with the necessary religious requirements.

The mere fact that paraffine wax is absolutely pure is sufficient in itself to commend it to the consideration of those who religiously regard all lights used for ceremonial or ritual purposes to be the symbols of purity.

There are other important reasons why the pure paraffine wax candle should only be used for Sabbath lights.

Aaron Elsemann will address the Young Folks' League Wednesday evening, the 20th inst., at the vestry rooms of the Synagogue, 323 East Eighty-second street. Hebrew Sheltering House Association. The annual meeting of the Hebrew Sheltering House Association was held at the Sheltering Home, No. 339 East Broadway, on Sunday evening last. The annual report was read by the president, Justice Leon Sanders, and showed that 2,517 immigrants have been temporarily taken care of in the last year, and aid was given to many to begin life in this country. The receipts were \$14,207.71 and the disbursements \$14,753.57. It was brought out in the report that Mr. Jacob H. Schiff had taken a \$40,000 mortgage against the building for a period of ten years without interest. Besides transacting other business, the society adopted resolutions praising the work of Robert H. Watchorn as Immigration Commissioner and asking President Roosevelt to reappoint him. The Jewish Sabbath Association. A committee of the Jewish Sabbath Association, consisting of Rev. Dr. Bernhard Drachman (president), Messrs. M. Jarmulowsky, Harry Fischel and J. H. Luria, was received by Police Commissioner Bingham on Tuesday, the 7th inst. The object of the conference was to come to an understanding in regard to the acting of the Police Commissioner's new ruling in regard to the Sunday law as applied to the seventh day Sabbath-keepers. The matter was carefully considered from every point of view, and the Commissioner finally informed the committee that he had decided to order the police to strictly enforce the Sunday law, but not to apply it to the merchants who had observed the previous day as Sabbath. He stated that he would accept the certificates issued by the Sabbath Association as evidence that the holder was a Sabbath-keeper, and would instruct the police to ascertain on Saturday how many merchants besides the holders of these certificates had their places of business closed. As an example of the good work which this association is continually doing in behalf of the Sabbath, it may be mentioned that the association during the past month interceded with three large manufacturing firms, employing over one thousand Jewish working people, where efforts had been made to turn the Sabbath into a working day. In every instance the committee were received with the utmost courtesy and their requests were granted, thus preserving all of these Jewish souls from the sin of Sabbath desecration. The names of the firms are omitted, as they do not desire publicity. The Executive Committee of the Hilfsverein der Deutschen Juden met recently. The chairman, Herr James Simon, reported on the measures which had been taken in the interests of the Jews in Roumania in view of the possibility of a conference of the powers which were signatories to the Berlin Treaty. Dr. Paul Nathan reported on the progress of the educational work in the East.

The Death of Dr. Frenkel. The European Jewish press reports the death in Meran, Italy, at the age of fifty-one, of Dr. Isidor Frenkel, the noted physician and Hebrew writer of Warsaw and the author of "Somer Habriath," a book on hygiene. The deceased was widely known among the Jewish population of Warsaw, and especially among the poor, to whom he gave medical attendance without any remuneration. He wrote popular articles on medical subjects for the "Hafrah." These articles attracted so much attention that they were afterwards printed in book form, which ran through a number of editions. Dr. Frenkel was recently planning to start a new Hebrew weekly, and he had already applied to the General Governor for permission to publish such a paper. Dr. Frenkel was born in the little Polish town of Ripin, Government of Plotzk. Young Men's Hebrew Association. The association has inaugurated a series of "Health Talks for Young Men" and the second of the series will be given on Sunday afternoon, January 17, at 3 o'clock by Dr. Herman Jarecky on "The Care of the Eyes and Ears." There will also be a series of lectures in connection with the campaign against the Great White Plague, and on Tuesday evening, January 19, Dr. S. A. Knopf will lecture on "The Young Men's Duty in the Fight Against Tuberculosis." A dramatic recital of Shakespeare's "Midsummer Night's Dream," with incidental music by Felix Mendelssohn Bartholdy, will be given in the auditorium of the Young Men's Hebrew Association on Sunday evening, January 17, at 8 o'clock. A nominal charge of 15 cents for non-members will be made. At the Friday evening religious exercises the attendance is very satisfactory and the services well adapted to hold the attention of the young people for whom they were instituted. This week the lecture is to be given by Rev. Dr. I. S. Moses, and the presiding officer will be Dr. Louis S. Rosenstiel. Mrs. Rebekkah Kohut spoke last Friday evening before a very large and interested congregation. At the Children's Sabbath afternoon services the speaker this week will be Mr. Armand Weyl. On Saturday evening, January 16, Hon. Herman A. Metz will deliver an address in the auditorium. Subject: "Finances of the City of New York." United Hebrew Charities. 
JEWISH WORLD HAPPENINGS.

These items are collected from the four corners of the Jewish earth, and are presented in tabloid form without comment. A society of Jewish youth has been started at Mayence. A large public Jewish library is soon to be opened at Cologne. A new Jewish school of commerce has been opened at Lodz. Dr. Philipp Schonberger, for many years rabbi in Nordhausen, is dead. Temple Emanu-El, San Francisco, Cal., was visited by thieves a week ago. Temple Emanuel, Union Hill, N. J., was dedicated on Sunday afternoon. The Jewish Young Men's Association has been organized in Albany, N. Y. One hundred members are now enrolled in the Harvard Menorah Society. The Hebrew Relief Association, of Cleveland, O., expended \$16,412 last year. David A. Ellis has been appointed head of the Boston, Mass., School Board. In Reggio, the city which was recently stricken, the first Hebrew book was printed. The Odessa Court has acquitted forty-five organizers of the pogrom at Bolshol Byalick. The Chicago Hebrew Institute has inaugurated Children's Sabbath Afternoon Mincha Services. The Hebrew Friendly Inn of Baltimore, Md., served meals and lodging in 1908 to 12,000 people. Rabbi Wm. Rosenau, of Baltimore, Md., has announced his intention of remaining in that city. M. Pergament, the Deputy for Odessa, will be tried for actively assisting the liberation movement in 1905. A wing of the girls' school, now under construction at Jaffa for the Odessa committee, recently collapsed. A memorial service for the late Eduard Glaser, the great explorer and traveler, was recently held in Munich. The Jewish Athletic Union of Strassburg celebrated Chanukah by a public gymnastic exhibition and ball. Mr. Zangwill's play, "The Melting Pot," will soon appear in book form, dedicated to "President Roosevelt." Dr. Henry H. Piper addressed the members of the Boston Council of Jewish Women on the 4th inst. on "Mohammedanism." The Women's Hebrew Benevolent Society of Buffalo, N. Y., has decided to maintain its fresh air camp again next summer. The members of the Star of Israel and Daughters of Israel, Hoboken, N. J., have united towards the building of a new synagogue. The Farmers' Loan and Trust Company has assumed a mortgage of \$125,000 on the Hebrew Sheltering Guardian Society's building. The Y. M. H. A. of Syracuse will hold a debate with the Rochester Jewish Young Men's Association in Rochester on February 14. A committee for Jewish students in distress has been formed at the Moscow University, where a Jewish Students' Literary Society has been founded. The Young Men's Hebrew Association, of Memphis, Tenn., has taken steps toward consolidating with the Rex Club, a Jewish social organization of that city. The Hebrew Sheltering Home and Day Nursery, 310 North Fourth street, Philadelphia, Pa., is confronted by a deficit of \$4,000 at the end of the year's work. The Maimonides Koshet Hospital Association has begun active work towards the raising of funds for a new \$75,000 hospital for Orthodox Jews in Chicago, Ill. The fourth anniversary of the Congregation Adath Israel of Louisville, Ky., was observed on the 5th inst. by a banquet, which was attended by over two hundred and fifty. Rabbi Samuel Sale, of St. Louis, occupied the pulpit of the First Unitarian Church, New Orleans, La., on Sunday, January 3, preaching to an exceedingly large congregation. Mr. Ezekiel Leavitt, the well known author and educator has been elected and installed as superintendent of the Hebrew School of Washington, D. C., Fifth and I streets, N. W. Jacob Mayer, one of Portland's (Oregon) pioneer Jewish citizens, was laid to rest last week. Mr. Mayer was the last of those who formed the Cong. Beth Israel over fifty years ago. Baron Edmond de Rothschild donated \$10,000 for distribution among the poor of Paris on January 12, to celebrate the marriage of his son, Baron Maurice de Rothschild, to Mlle. Neemie Halphen, the daughter of M. Jules Halphen. Texas Zionists concluded their annual session on the 4th inst., at Waco, and selected San Antonio for the next meeting place. Bertha Kalich will presently appear in a new play written for her by Prof. Thomas Dickinson, of the University of Wisconsin. Its title is "The Broken Road," and Mr. Fiske will produce it. Edward Lazansky has been appointed by Mayor McClellan a member of the New York City Board of Education to fill the vacancy occasioned by the resignation of Nathan S. Jonas. Dr. Robert Graf, Rabbi of Temple Beth Israel, Austin, Tex., was the recipient last week of a solid gold watch fob set with diamonds as a token of esteem from his congregation. Anniversary day at the Jewish Widows and Orphans' Home, New Orleans, La., was observed on the 10th inst., and the new superintendent, Mr. Chester J. Teller, formally welcomed. St. Peter's German Evangelical Church school and parsonage, of St. Louis, Mo., have been sold to the Beth Abraham Congregation, which will occupy it after making extensive improvements. Twenty-two hundred dollars was realized from the bazaar held last month by the Daughters of Beth Israel, Philadelphia, Pa. The society celebrated its fifteenth anniversary on the 4th inst. The Tsar has, through his secretary, informed M. Dubrovin of the pardon of ten pogrom organizers from Bielostok. Five ringleaders of the Vepisky (near Gadlatch) massacre were also released. Several Jewish organizations interested in the question of immigration have asked President Roosevelt to reconsider his recent withdrawal of the nomination of Robert Watchorn for re-appointment as Commissioner of Immigration. A Zionist bazaar and ball, the largest of its kind ever held in this city, will take place at Grand Central Palace on Sunday, March 14. A feature of the bazaar will be an exhibit of Palestinian products. Immediately after the closing of the Institute for Foresters at St. Petersburg the Jewish students were ordered to leave the capital within twenty-four hours. Our co-religionists appealed to M. Stolypin against this harsh order. Recently in Vienna a committee of students organized a performance of three Yiddish plays in German in aid of the building fund of a Jewish Students' Home. The pieces given were Coranik's "Red Snow," Perez's "Sisters" and Pinski's "The Eternal Jew." M. Max Getting, one of the heads of the important financial house of Fould (which has rendered such important services to France) has been appointed Chevalier of the Legion of Honor. Two other Jews have been similarly honored in connection with the Bordeaux Exhibition. The feud that has long existed between the Rev. Leopold Cohen and Philippe Spievacque, who conduct rival Christian missions to the Jews of Brooklyn, has broken out afresh, with the result that Spievacque has been hauled up before the courts as a judgment debtor in supplementary proceedings. Judge Jacob Moses, of the Baltimore, Md., Juvenile Court, has received an invitation from President Roosevelt to attend a conference in Washington next month to consider what action should be taken with reference to neglected and destitute children, against whom no charges have been made. The strife in the Homel Town Council for and against opening the Jewish shops for a short time on Sunday is still raging. The anti-Semites threaten to organize a pogrom, and to complain to the Central Authorities against the action of the Governor, who declined to enforce the regulations of the Council. Ferdinand Hecht, a leading Berlin Jewish merchant and well known in business circles in this country, died on the 8th inst., aged fifty-six. Five years ago the Kaiser conferred upon him the title of Prussian Royal Councillor of Commerce as a token of his services in behalf of Germany's overseas trade. The Russian Assistant Minister Krizanovsky has informed a press representative that the government never intended to grant the Jews equal rights. All they proposed to do was to abolish the Pale, on the strict understanding that Jews should not become eligible for government appointments of any kind. Simon Oppenheim, upon being elected for the twentieth consecutive term president of the Adas Israel Hebrew Congregation of Washington, D. C., was presented with a loving cup last Sunday evening as a mark of appreciation from the members of the congregation. A feature of the event was the fact that the presentation speech was made by Mr. Julius Baumgarten, who at the same meeting was elected secretary for the thirtieth consecutive term.

The German Emperor, several ministers and persons prominent in science and industry have rendered signal honors to Councillor Rathenau, director general of the General Electricity Company, who introduced electricity, especially as an illuminant, into Germany, on the occasion of his 70th birthday. The company which he founded is now regarded, next to the Krupp works, as the most important industrial undertaking in Germany. The Tsar has cordially received the Chairman of the Real Russian Conference at Odessa, Count Konovnitzin. The latter informed his Majesty of the resolutions and petitions of the Black Hundreds, who insisted on the necessity of introducing new legislation restricting the trade and social rights of the Jews. Rev. Israel Cooper, for twenty-four years the famous cantor of the Kalvarierer Synagogue, Pike street, this city, died on the 4th inst. The funeral was one of the largest ever held on the East Side. Rabbi Cooper leaves two sons, Harry and Bert, well known on the vaudeville stage as members of the Empire City Quartette. The following coreligionists have been appointed members of the Superior Statistical Council for a term of three years: Senators Edouard Millaud, who has been designated vice-president, and Paul Strauss; M. Michel Levy, member of the Academy of Sciences; M. Neymarck, a former president of the Statistical Society of Paris; M. Rene Worms, general secretary of the Sociological Society, and M. The next lecture in the course of popular lectures will be on Thursday evening, January 21, at 8.30 o'clock, at the Seminary building. Dr. Cyrus Adler will be the lecturer, and his subject will be "History of Hebrew Studies in the United States." The popular lectures are open to the people.

Jewish Maternity Hospital Completed.

The announcement of the completion and the proposed dedication of the Jewish Maternity Hospital serves to make known the successful accomplishment of an undertaking which reflects credit to the Jewish community. It also brings into notice the laborious efforts of the determined and undaunted few who, awake to the crying need for such an institution, pledged themselves to unceasing effort until such a hospital should be established which would not only satisfy that need and be true to Jewish traditions, but should be an example of its kind, in the efficient dispensation of its particular service.

It is difficult to believe, yet nevertheless true, that magnificent as are the equipments of our Jewish general hospitals, no provision existed for the care of the poor Jewish woman in the delicate state of motherhood. Unable to obtain admission, these women were compelled, in their dire necessity, to enter hospitals where the Mosaic dietary code is not observed, the rites of circumcision not performed, their language not understood and their secular beliefs ignored. These conditions deterred the large majority of the needy from applying for aid at such institutions and compelled them to remain in their poverty stricken homes to be cared for under the most unhygienic and unsanitary conditions by ignorant and unskilled midwives.

The pride of the Jewish community was at last stirred by such a state of affairs and it was not long before such men as Harris Aronson, Rev. Phil. Jaches, Rabbi M. S. Margolis, Harris Uris, Pincus Ronginsky and others organized the Jewish Maternity Hospital Association and during the winter of 1906 applied to the State Board of Charities for a charter to build a hospital. In April of that year, after but one hearing before the Charities Board, the charter was immediately granted and an appeal was then made to the community for support. These workers knew the warmth and generosity of the Jewish heart and its solicitude for those in distress and they were not disappointed in the response which followed their appeal. So generous was it that it enabled the new organized board of directors to purchase the two houses at 270 and 272 East Broadway with the purpose of remodeling them into a hospital.

Innumerable difficulties had to be overcome but by dint of persistent effort, steadfast devotion and enthusiasm and the invaluable assistance of the Ladies' Auxiliary, a society of 400 earnest workers, the task has been completed and the hospital is now finished. It is a four-story building thoroughly equipped with every essential detail of a modern hospital and will accommodate seventy-five patients. It consists of two large and two small wards, four semi-private rooms, operating room, training school for nurses, administration rooms, etc. A unique and valuable feature of the hospital's work will be a nursery, where under the care of a matron, the little children of the family temporarily deprived of the services of the mother will be tenderly cared for.

The completed hospital represents an outlay of \$90,000, and this has been obtained from contributions varying from 50 cents to \$500, through the tireless work of such men as Hyman Karp, Julius Dukas, Frank Hillman, who have contributed liberally. The Ladies' Auxiliary Society contributed \$2,000 during the past year. The officers of this society are: President, Mrs. E. Paller; vice-president, Mrs. S. Lieberman; second vice-president, Mrs. L. Munvis; treasurer, Mrs. A. Hymanson; secretaries, Mrs. L. Hilkowich and Miss N. Wetter.

Not alone by the solicitation of contributions but by personal service in the various affairs organized for the obtaining of funds the members of this society, prominent among whom are Mrs. Fast, Korngold, Bernstein, Lefkowitz, Loeb, Rothkowitz, have rendered valuable aid, and with the assistance of the Board of Directors have already obtained four endowed beds.

As soon as the dedication ceremonies, which take place during the last week of this month are over, the attention of all interested in the hospital will be

turned to the Charity Ball which will be held at the Grand Central Palace on Feb. 27, 1909, through which it is hoped to realize about \$10,000.

The Board of Directors, through its president, Rev. P. Jaches, express their thanks to the numerous friends of the hospital for the sympathy and support they have so generously given. Encouraged by the successful accomplishments, the Jewish community is further appealed to for assistance, in the endeavor to make this institution a monument to Jewish philanthropy.

THE marriage of Dr. James H. Hamilton, head worker of the University Settlement at Eldridge and Rivington Sts. to Miss Etta Brodsky, a young Jewess, twenty years of age, which ceremony was "ethically" performed last Saturday afternoon by Dr. John Elliott, associate of Dr. Felix Adler of the Society for Ethical Culture, is one upon which we do not wish to waste many words.

ANOTHER "NON-SECTARIAN" MESALLIANCE.

Day after day, and year after year, until the volume is piled mountains high, evidence is forthcoming of the absolute falseness of the position claimed for those settlements which dub themselves "Non-sectarian."

We do not wish to bring upon the the pillory of public opinion Dr. Hamilton, neither as a man, nor in his official capacity, but it is the institution of which he is the executive "head worker" and others like it, of which the HEBREW STANDARD has in the past and continues to complain.

Without any reservation we again assert that the phrase "Non-sectarian" is a lie. Dr. Hamilton is a proof that there is no such thing as an absolutely neutral position, possible in matters religious. Following the notorious Stokes-Pastor episode, and the Walling-Strunsky affaire, we now have the Hamilton-Brodsky denouement. The public has no right to inquire into the private life of Dr. Hamilton. He can marry whom he likes, when he likes and how he likes. But he is posing on the lower East Side as "an example." He is "living the ethical life." Oh, the pity of it! Oh, the sorrow of it! He is nothing but a weak mortal, like the rest of us, after all. The charms inherent in the womanhood have caused him to fall, as have fallen greater men than he. Our contention is again supported by irrefutable proof that it not right for the Jewish community supinely to allow the hordes of impressionable young persons to come into daily and hourly association with either men or women, who are not staunch and true, whose religious convictions are not beyond question, whose loyalty for their faith has not been tried in the furnace of time.

IN Philadelphia last month there were no Christmas celebrations in any of the public schools. This was accomplished largely because a Jewish member of the local board of education was not afraid to stand forth on behalf of his race and to demand, because of the facts which are very well-known and which we in this journal have reiterated many times, and oft, that these celebrations shall cease. Our government is not irreligious: but it is emphatically non-religious.

The Pennsylvania people recognize the justice of these, our demands, and their representatives have not as in New York last year, moved heaven and earth to defeat the ends attained.

The Philadelphia Baptist Ministers in meeting assembled adopted a strange but emphatically correct resolution which, however, we can understand under the circumstances. They declared:

"We, therefore, earnestly and emphatically demand either that no Christmas celebration whatever be allowed in any of the public schools or that the name of Jesus Christ be saved from such public affront as the order of the Board of Education, if carried out, would inevitably inflict; or that this order be at once rescinded."

IT IS, TO OUR MIND, wrong for prison authorities to permit a converted Jew to lecture to the convicts. In the Ohio State penitentiary at Columbus on New Year's Day the significance of the day was explained to the prisoners by a converted Jew "who drew apt comparisons with Hebrew law and custom." This must make a peculiar impression on the convicts.

IN the German *Israelitisches Familienblatt* of Hamburg, Dr. Max Wittenberg proposes that the government of the German Empire set apart one day of rest in every seven. He sets forth in no uncertain terms the Christological character of Sunday rest, and shows how cruelly this operates on the German Jews.

THE DAY OF REST.

The proposal that the state set apart one day in every seven as the day of rest is interesting to us in the United States too. The citizen should of right rest on one day in each week, but the state ought not to say on which day this rest is to be taken.

Hence the proposal of Dr. Wittenberg deserves wide dissemination. Here in America the Puritanical fervor about Sunday is apparent in even greater measure than in Germany. And we hope the day is not far distant when in the United States the citizen may rest on the day of the week which suits him best, and not have the religious ideas of others crammed down his throat.

A GREAT discovery has been made! The villain in the melodrama, if a Gentile, smokes innocuous and insipid cigarettes; if he is a Jew, he is never without a big, black, deadly, poisonous cigar in his mouth.

The *Pharmaceutical Journal* of Montreal, Canada, which may claim the credit for this truly wonderful discovery, adds gratuitously that the Jewish villain has a pointed nose while his "Christian fellow only has a pointed moustache." Now, why are the Jewish villains cigar smokers? Because those of their race are strong smokers by habit, and are probably made so by temperament, and have high-strung nerves.

"Tell me, Mr. Levi, did you celebrate Christmas this year?" "Oh, no! My wife and I are too old for that, and my children are baptized."

IN THE ELIZABETH SCHOOL, of Frankfort-on-Main, where half the pupils are of Jewish faith, the authorities recently compelled all students to attend a lesson on the evidences of Christianity. This is absolutely indefensible: and if it would occur in New York, there are some Jews who would justify it.

A SOCIETY has been recently organized in Cleveland, O. under the title "To Live as Jesus Did." If the membership would sincerely endeavor to live up to the Jewish principles contained in the "Sermon on the Mount" humanity would be benefitted. We would suggest that a missionary of the society be sent to Russia with the herculean task of initiating the Czar into the tenets of this new-born society.

THE DEATH OF REV. ISRAEL COOPER, the celebrated Chazan of the Kalwarier Cong., Pike Street, is deeply deplored by the many admirers of his rare *Chazonath* abilities and by the community at large. He had faithfully filled his position as the Kalwarier Chazan for nearly 25 years to the great satisfaction of his constituents and was highly esteemed for his purity of character and the true religious spirit which entered into his ministrations.

SO, A PROPOSAL has been made to incorporate an association for the promotion and protection of the gospel among the Hebrews throughout the world. Why this step is necessary one hardly knows: the promoters say it is on account of the persecution of the Jewish Christians by the Jewish people. We for our own part doubt the correctness of this statement: persecution of *Meshummodim* by their former brethren there never was

"And there went a man from the house of Levi and took a daughter of Levi."—Exodus ii, 1.

THAT we are so strenuous in our opposition to intermarriage is not only on account of religious difference but for the practical illustration of one of life's most serious problems. Experience is the best teacher. Moses, from a theory conceived in his mind, placed obstacles in the way of intermarriage, but time and experience of subsequent history gave our rabbis and teachers clearer

insight of the matter and they deemed it advisable to change the Mosaic obstacles into a strict prohibitive law. Experience had shown that intermarriages had resulted either in strife and domestic unhappiness, or that they had destroyed the religion that either one or the other, or both, had been reared in.

Between husband and wife there should exist the least possible antagonism, because religious difference is the most vital that could ever exist between them. If the great Solomon—the wisest of men in his age—was swerved from the right path and his heart turned from the faith of God by intermarriage, what then does it not do to ordinary characters? How does it change their conduct?

Solomon wrote in his proverbs ראה חיים עם אשה אשר אהבת "Enjoy life with the wife thou lovest." When a Jew marries a woman of another faith or vice versa, the love is surely evanescent. Of that love can be said:

Love is a changeable fashion, my friend,
Intense at the time it is spoken;
Intense for a little, it fades, I contend,
And dies with the vow it has broken."

It is the love for the woman's charm or the man's appearance, and when the woman has become the wife, with some religious spark, however feeble, burning up in the bosom, which has not as free a sway as if the parties were in perfect accord in that direction, then love begins to fade and gradually vanishes.

As the Midrash remarks: "Between men and wife there is the indwelling of God, as the words imply. איש (ish) is man, the word consisting of, א aleph, י yod, ש sheen; אשה (ishah) is woman, the word consisting of, א aleph, ש sheen, ה hai; the י yod in איש (ish) and the ה hai in אשה (ishah), form the abbreviated name of Jehovah, which is יה (Jah). When husband and wife are not in harmonious accord, particularly in the matter of religious belief, so that strife and dissensions ensue, the י yod, falls out of the איש (ish) and the ה hai from the אשה (ishah), leaving the א aleph and the ש sheen, which is the word אש (esh) "fire." This is that we are doing all we can, all we should, attempt to prevent, for fire to take the place of conjugal felicity.

We read in Scriptures on this Sabbath that a man from the house of Levi took a daughter of Levi. If the record should have been intended to play an important part of history, there would doubtless have appeared the names of this man of Levi and the daughter of Levi, but as they form no part of the scriptural record it indicates that the action, not the persons, was the noteworthy part. The action evidences that a man was taking a wife unto him such an one that would come nearest to his ideas, with whom he would most agree and best consort, and from this union was born the child Moses, who had grown to be the leader and teacher of Israel.

It simply conveys the idea that in seeking a wife or a husband, sentiment and romance must dwindle into significance; the one important, all important question must occupy the thought and mind, "will we live happily, will we be able to live altogether with and each for the other?" If there should arise some doubt in their minds upon this, then it is far wiser to bring a sacrifice, to discard that sentiment, that romance that creates the momentary rapture and does not enter into the inseparable bond of marriage, involving the future happiness of the wedded pair as well as the religious sentiment which leads to domestic conflict.

Practical reasons are potent obstacles to intermarriage. Religion is an important factor in the question of marriage and we would be false to ourselves if we in any way favored steps that would be detrimental or injurious to our religion, as intermarriage surely is. Still, religion, as it is naturally understood seeks the peace and happiness of all men. We thus earnestly urge and advise our marriageable men and women to do as that man of Levi did, who took to him a daughter of Levi. Levi consisted then of many families, so that this man did not necessarily overstep the boundary lines of consanguinity, but in choosing his helpmate selected one most suitable to his station, one most in harmony with his views and ideas. Such an affinity must needs bring about the sweetest bliss and the happiest family relations. In that domestic sphere man enjoys the life with the wife he loveth—with the wife not with the sweetheart, not with the bride, but with the woman who has grown around the tendrils of his heart to be the wife, the source and creator of every happiness in the household, who promotes peace and harmony and fans into living flames the fire of love and contentment which dwells in their heart. Between that husband and wife there is the indwelling of God.

THE AMERICAN JEWISH COMMITTEE II.

WHEN their pronunciamento was first issued, the entire Jewish press—with the exception of a few sycophantic journals—rose up in arms against their invasion of the personal rights of the Jewish people. But it is remarkable to note, how when personal pressure was evidently brought to bear upon them, that they immediately turned turtle, kowtowed to the financial potentates and arrayed themselves upon the side of the *Hoffjuden*; stifling their resentment, stultifying themselves by depicting in glowing colors the benefits to be accrued to the Jewish public by the American Jewish Committee, &c.

That the readers of the MIRROR may have an idea of the peculiar manner by which some of their New York representatives(?) were, without their own knowledge, made constituent members of the secret organization, I cite the instance of the appointment of a prominent East Sider whose was brought about by a letter written to one of his employees, requesting him to designate some one whom he deemed influential on the East Side. The gentleman, of course, named his employer, and without any further consultation his name appeared upon the list of New York representatives.

I have no personal objection to the gentleman. He figures prominently in East Side Jewish affairs and bears an excellent reputation in the community. But what Moshey Slappak would like to know, is, why should that individual have been designated as the person to select a member of the committee and what kind of a committee could it be, when this is the mode of their selection.

It is a well understood fact, that the *Hoffjuden* by their liberality, control the affairs of the Jewish Theological Seminary. It is also well understood that they are the stockholders of the *Court Journal*. They appointed as their clerk—the only salaried officer—the editor

of the *Court Journal*, who is at the same time the Registrar of the Jewish Theological Seminary. This triune "Poo Bah" combination elicited the derision of the Jewish public and served to call its attention to the existence of the un-Jewish octopus whose tentacles are stretched out in every direction, and, as has been suggested, with the further view of entering into the political field.

Sensible of the error they committed in this direction, the clerk was assigned to temporary oblivion. Subsequently when THE HEBREW STANDARD called their attention to the fact that the Rabbis on their committee were all of the Reformed persuasion, they took the hint and designated Dr. Mendes, evidently as a sop to the Orthodox portion of the community.

My Chief pointed out to them the unreasonableness of not associating themselves with men who represented in their own persons the necessary true Jewish and not the milk and water spirit dominating the committee. Judge Greenbaum and a few others were subsequently designated; but the judge had the good sense to decline to serve upon a committee so unconstitutional and misrepresentative in its very inception.

That a man like Judge Goldfogle, whose memorable speech in the House of Representatives upon the "Russian Question" elicited the warm admiration, not only of his own people, but of the communities of American citizens all over the country—should not have been designated as a member, showed that there was something rotten in Denmark, but when it was currently rumored that he had been requested by some prominent Israelite not to press the subject in Congress for fear of the evil results which would follow; and had declined to accept the advice I can readily perceive that they understood he could not be misled by their motives, and was therefore *non persona grata*.

The figures (of speech) crowd upon my surface so thickly, at the memory of these outrageous acts of insolent defiance of decency and breeding that I must pause awhile. But wait! A little breathing spell and then—next week.

THE term "beautiful" applied to women is often expressed just as it is in reference to other matters and things. "Isn't she beautiful?" is a very frequent expression, given birth to upon the appearance of a woman decked out in fine dress, with herself made up by means of the appliances of the latest scientific fashionable development.

Fine feathers make fine birds, but while this may be so as to the ornithological species, fine costumes, while they set off women to great advantage and pleasing view, do not make beautiful women; for, after all, the number of really beautiful women is comparatively small.

Of course I am speaking of the standard of beauty which has the sanction of "common assent." With many people this adjective is constantly pressed into service at the slightest provocation. Everything is "beautiful" whether it really is so or not.

People who would hesitate to tell a wilful falsehood, and who possess a strong religious bias, will say a thing is "beautiful" while they know it is not. Take women, for instance, when asked how they like another woman's new dress, reply to its owner, "beautiful," "beautiful," and in almost a continuing breath will turn and utter a contrary opinion to another.

Of course many women may ask one to judge their dresses and give an expression of opinion as to them, generally look only for a favorable comment, and will feel far from pleased to hear one in an opposite direction.

In society every thing is "beautiful," and in society people don't like to tell the exact truth, because, as a rule, people do not want to hear the minute truth. Once a well-known French courtier had the rashness to tell a fashionable dame that he thought that he had discovered a suggestion of an incipient wrinkle upon her beautiful brow. It was the truth, but her answer completely annihilated him. A woman will accept a compliment that she is "beautiful" though she knows that it is untrue, without a shade of resentment.

Who has not seen people petting ugly looking members of the canine breed and caressing them with the remark, "my beauty." In matters of this kind it is as the French say, "Chacun a son gout."

\$100,000 More for Beth Israel Hospital. At a meeting called for the purpose of organizing a General Building Committee of the New Beth Israel Hospital, at the Hotel Savoy last Monday night, which was attended by over 150 representative men, close to \$100,000 was added in subscriptions to the present building fund of \$60,000.

Hon. N. Taylor Phillips was elected president of the General Committee, Morton Stein, vice-president, and Edward Epstein, secretary. Mr. M. Aslanof called the meeting to order, Dr. L. J. Ladinski acted as temporary chairman, and Mr. Adolph Lewisohn was the permanent chairman.

Mr. Lewisohn, on taking the chair as permanent chairman of the meeting, received a tremendous ovation, and said, among other things:

"The work of the Beth Israel Hospital is now appreciated, not only in Jewish circles, but by the entire community, and though I personally am liberally inclined, I heartily endorse the principle that the religious feelings and scruples of the inmates of institutions are to receive every consideration, and that every hospital should be conducted according to the religious beliefs of the majority of the patients. It is the duty of a hospital to do as much good to as large a number as possible, and I am heartily in favor of erecting the new institution where it will do the most good, but I am absolutely opposed to any hospital with an idea of ornamentation and ostentation."

Other speakers were Rabbi Rudolph Grossman, Dr. D. C. Potter and J. E. Reinthaler, M. D.

Mr. Uriah Herrmann, treasurer of the hospital, presented his report of the building fund, and announced the following amounts which had been subscribed some time ago:

MUSICAL AND DRAMATIC COMMENT.

If patriotism could create art, England would be the most artistic country in the world.

A few weeks ago glowing accounts of a new symphony by Sir Edward Elgar was being printed all over Britain, and its praises were sounded from John of Groat's to Land's End.

And now we benighted Americans have had vouchsafed us an opportunity to listen to the much-heralded opus, and we find it difficult to account for the Englishman's enthusiasm.

The new work has to recommend it two, or possibly three, beautiful themes, material sufficient for a symphony that should, at the utmost, not have taken more than half an hour to perform. But Sir Edward, with characteristic prolixity, takes an hour, less five minutes. His instrumentation suggests Brahms's, but as he does not possess the master's skill in construction of in contrasting a variety of tints of the orchestral palette, the effect becomes monotonous.

I derived these impressions at the recent concert of the New York Symphony Society, where the Elgar symphony was very well performed under the careful and sympathetic guidance of Mr. Walter Damrosch.

Two of Henry Bernstein's plays have been performed here in English versions more or less faithful. And now German translations, which usually adhere very closely to the original, at any rate not attempting to improve them, will be seen at the local German theatres. One of these, "The Talon" was announced for last Wednesday night at the Madison avenue playhouse, with that remarkably able character actor, Emil Lind, and Hedwig Reicher, in the leading roles. The other, "Baccarat," will serve to introduce Marietta Olly, a German actress of considerable repute, whose first appearance will soon take place at the Irving Place Theatre.

Two very interesting programmes have been arranged for the matinees to be given by the Kneisel Quartet on January 19 and February 23.

The first comprises the Beethoven Quartet in C minor, op. 18, No. 4; Corelli Sonata for violoncello, played by Mr. Willeke; Scherzo from Eugen d'Albert's Quartet in E flat major, op. 11, and a novelty in the form of two unfinished movements from the Quartet in F major (Posth.), by Ed. Grieg, completed by Julius Roentgen, Sr., the musical executor of the Norwegian composer. These two movements are in manuscript and will be played in New York for the first time.

They will be awaited with especial interest in view of the general enthusiasm aroused by the performance of the first two movements by the Quartet on December 15.

The programme for the second matinee is as follows: Beethoven Quartet in A minor, op. 132; Bach concerto in D minor, for two violins, with accompaniment of string orchestra, and the Brahms Sextet, for strings, in B flat major, op. 18.

Gustave Mahler's production of "Le Nozze di Figaro" will be given at the Metropolitan to-morrow afternoon. In the evening "Il Trovatore," with Mmes. Kaschowska and Homer and Messrs. Martin and Amato, will be sung. This evening's double bill brings "Le VIII" and "Pagliacci." At the Manhattan "Peleas and Melisande" is announced for to-night, the Saturday operas being "Traviata," with Tetrazzini in the afternoon, and "Otello," with Labia, in the evening.

The programme performed by Mr. Gabrilowitsch at his recital on Sunday afternoon consisted entirely of familiar numbers, except his own "melodie" in E minor, op. 8, given for the first time. This was a charming little piece, in which a most attractive theme is treated with deft skill. My idea of it is perhaps best expressed by saying that if the name of Schumann or Chopin had been attached to it, it would have been quite worthy of such a designation. As usual, Mr. Gabrilowitsch's playing was lovely in tone color, impeccable in technique and full of subtle nuance.

A new quartet, by Robert Kahn, of Berlin, will be performed at the Klein "Poc" concert next Sunday afternoon at the Deutsche Theatre. One of the soloists will be Miss Kitty Cheatham.

Mt. Vernon, N. Y. The general interest shown by members of the Sinal Temple of Mt. Vernon and their friends in the first open meeting of the newly-formed Temple Club was more than justified when a crowded hall greeted Prof. Richard Gotthell on Tuesday evening, January 5, in the vestry rooms of the temple. Prof. Gotthell gave the club the benefit of his views on "The Turkish Constitution and the Future of Palestine."

The Temple Club takes the success of its first open meeting as a good omen for the future of the society, and has decided to give its members each month the benefit of hearing some well known authority on a current topic. Announcement of these meetings, which are open to the public, will be made in advance.

An elliptical iron stairway gives access to the two upper floors, which are given over to the various departments of the bank. The scheme of decoration includes Formosa and Alps green marble for the banking room, as well as Pavenazzo and white Italian for the entrances. Large Ionic columns of Scagliola marble support the ceiling. Large and secure safe deposit vaults are in the basement.

The bank's original capital was \$100,000 and was increased to \$1,000,000 on January 2, 1907, by a cash dividend of 900 per cent. out of the earnings of the bank. The capital is now \$1,000,000, with a surplus of \$745,000, all of which has been earned.

The officers of the bank are: President, Oscar L. Richard, in which capacity he has served the bank since its organization. He is also head of the firm of C. B. Richard & Co., bankers and steamship agents, 31-33 Broadway.

Vice-President Arnold. Kohn, who, without doubt, is better and more favorably known on the East Side than any other person doing business there, having spent most of his life among the people of that section. He has been connected with the bank almost from its inception, first as director, then as director and vice-president.

Second Vice-President Walter L. Burckett, who became associated with the bank three years ago, having previously spent many years in the service of the Fourth National Bank of this city. He is well equipped for the handling, in all its details, the affairs of a large institution.

Cashier Albert I. Voorhis, in which office he has served the bank well and faithfully for a number of years, having risen from a clerkship in the bank, which he entered more than fifteen years ago.

Assistant Cashier John Kneisel, to which office he was promoted after many years of painstaking and conscientious service.

In addition to the first four officers the following named men well known in the business world make up the directorate of the bank: Lucius N. Littauer, of Littauer Brothers, gloves, 715 Broadway; Jacob C. Simon, of Charles Simon's Sons, hosiery, 15 Union Square; Edwin H. Richard, of C. B. Richard & Co., bankers, 31-33 Broadway; Harry W. Vogel, of William Vogel & Son, clothing, 611-621 Broadway, and Walter T. Kohn, lawyer, 309 Broadway.
