AMERICAN PASSPORTS AND THE TREATY WITH RUSSIA.

We present to our readers herewith two addresses delivered at the House of Representatives in the closing days of the 60th Congress when the House joint resolution directing the President to enter into negotiations with the Czar of Russia, was passed. As is well known, Russia has not lived up to her treaty obligations with this country in respect to the recognition of American passports in the hands of American citizens of Jewish faith traveling in the Russian Empire. For many years, in fact ever since he has represented the 9th New York District on the floor of the House, Representative Goldfogle has made the consideration of American passports in the hands of Jewish citizens particularly his own. It is hoped that the joint resolution passed by Congress will be effective in its work and that Russia will be brought to a realization of the inconsistency of its position and its un-Christian actions. Of the various speeches delivered at the time the resolutions was up for consideration in the House those of Messrs. Goldfogle and Hitchcock are peculiarly striking and we reproduce the same for the benefit of our readers.

SPEECH BY
HON. HENRY M. GOLDFOGLE
OF NEW YORK,

MR. SPEAKER: This resolution deeply concerns the honor and dignity of American citizenship and the respect due the American passport. The subject involved has been several times, in various forms, brought before the attention of Congress. It has been pressed on the attention of the State Department. It has been presented to the President of the United States. Yet the evil complained of has not been remedied. Russia still violates her treaty obligations, and has persistently refused to honor the American passport held by our citizens of Jewish faith.

It is a deplorable fact that when a citizen of that faith presents for visa our passport to the Russian authorities it is discredited and dishonored. In the eyes of the Russian Monarch it is a valueless document. It is to the Russian official a mere worthless paper. Though the conditions have existed ever since our first treaty with Russia, our protests have gone unheeded, and America

has suffered the humiliation which Russia has seen fit to place upon us when she refuses recognition to the passport of our citizen who bears it.

based on the fact that he is a Jew. That fact alone, however reputable he may be, makes him odious in the eyes of the Russian and forthwith the passport bearing our seal

solently to disregard our passports. She must be given to understand that America will not suffer her citizens to be discriminated against by any foreign government merely on the ground of creed or religious faith.

While, in common with many of my colleagues here, I would have welcomed a more drastic form of resolution, yet I feel that this expression of the Congress of the country, speaking for over 85,000,000 people, will be productive of decided action by the incoming administration and convince Russia that the American people, true to the principles of our liberal and enlightened institutions, will not much longer suffer Russia to arrogantly dishonor the highest certificate that issues to our citizens to accredit them abroad and bestow on them when traveling in foreign lands the fullest protection of the American flag. [Applause.]

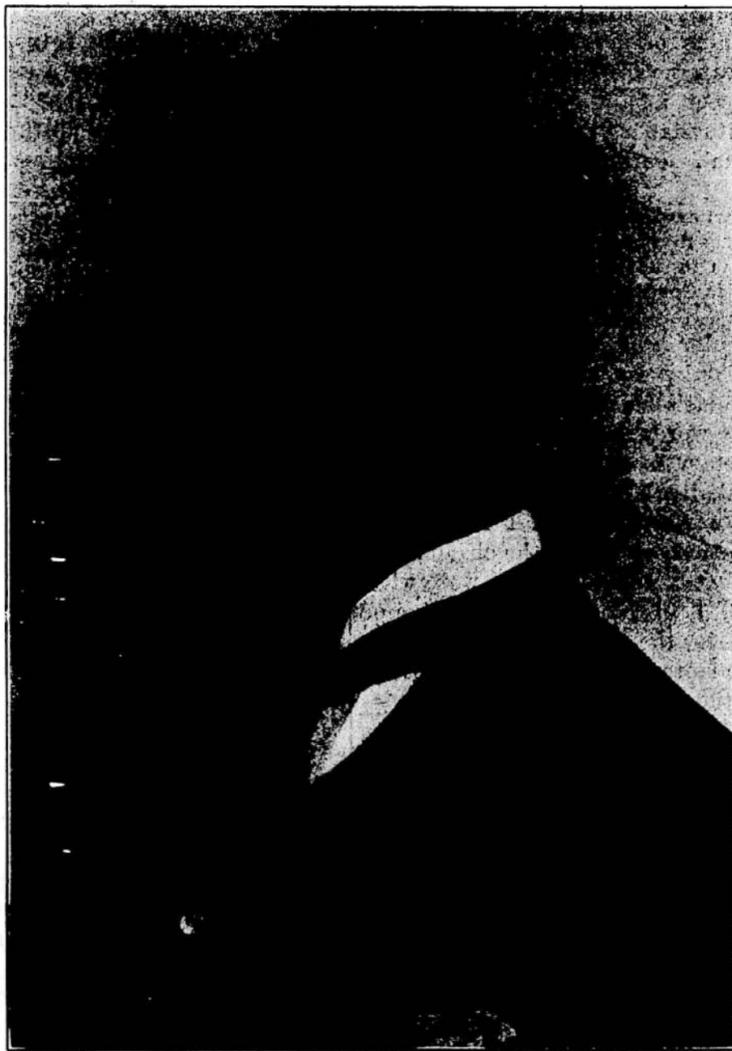
In 1902 I introduced a resolution of inquiry which brought this subject clearly before the American Congress. I took occasion to point out numerous instances of Russia's refusal to honor our passports, and pointed out her evasion of the obligation she owed our citizens under the treaty of 1832. I called attention to her outrageous treatment of the Jews within her borders, her barbaric treatment of them, her proscriptive policy, and her tolerant conduct toward these people within her dominion. With that phase of the matter we were, and we are, unable to deal.

We can not, of course, interfere with Russia in her own domestic affairs. But in dealing with the question this resolution directly affects, we simply assert the integrity of our citizenship and the principle that Russia can not discriminate between our citizens, on religious grounds, when our passports are presented at her gate.

To assert less, Mr. Speaker, is to deny to our citizens, whether native or naturalized, that equality which is the boast and one of the very bulwarks of our American institutions.

Well, Mr. Speaker, the resolution of 1902 passed the House, and yet the State Department remained inactive and did absolutely nothing in the matter up to 1904.

In 1904 I secured the passage of the reso-

lution which led to the correspondence between our Government and Russia, to which I shall presently allude. The resolution provided:

That the President be requested to renew negotiations with the governments of countries where discrimination is made between American citizens on the ground of religious faith or belief to secure by treaty or otherwise uniformity of treatment and protection to American citizens holding passports duly issued by the authorities of the United States, in order that all American citizens shall have equal freedom of travel and sojourn in those countries without regard to race, creed or religious faith.

Agreeably to that resolution, Secretary Hay, in July, 1904, communicated with Ambassador McCormick at St. Petersburg and took occasion in his letter to say:

I have therefore to instruct you to inform Count Lamsdorff that the text of the foregoing resolution has been sent to you for your information and for your guidance in interpreting this expression of the feeling of the people of this country, through their direct representatives, as to the treatment of the citizens in question.

You will make known to his excellency the views of this Government as to the expediency of putting an end to such discriminations between different classes of American citizens on account of their religious faith when seeking to avail themselves of the common privilege of civilized peoples to visit other friendly countries for business or travel.

In carrying out his instructions, our American ambassador in August, 1904, laid before Count Lamsdorff, the imperial minister of foreign affairs in Russia, the text of the resolution. Before that time a copy of that resolution had been conveyed to Count Cassini, the Russian ambassador here at that time. I want to call especial attention to some of the sentences found in that excellent and well prepared letter of our ambassador to the Russian Government. He says:

The resolution voices not only the feelings of the people, but also a principle which lies at the foundation of our Government. It is for this reason that the question has been, is, and always will be a live question with us and liable to become acute and be brought forward at some time in such a way as to seriously disturb the friendly relations which have always existed between Russia and the United States.

Aside from the belief that the treatment accorded by Russia to many of our most reputable and honored citizens is needlessly repressive, public opinion, as your excellency knows, plays a large part in the foreign relations as well as domestic affairs with us; and when underneath this public opinion there lies an important principle, as is the case in the United States, it can not be left out of account by those who have maintained the close relations which it is desired by my Government to see maintained with this great Empire and her august ruler.

For these strong and manly—nay, more for these courageous words of our ambassador, those affected by the resolution owe much. It would have been well if these noble sentiments had been followed by an earnest and active negotiation and an insistence that Russia shall cause proscription of our citizens and her "repressive" treatment of those who came to her with our passports.

But sir, our administration, just as before, relaxed its efforts. Our State Department once more again gave evidence of its indifference by failing to follow up the subject. It once again, so far as we know, lapsed into silence. Russia, cunning, crafty, quick in diplomacy to perceive, took advantage of the situation. She continued her policy. She discarded our passports; she let go unheeded the veiled threats of Ambassador McCormick.

That it may be seen that our American Department of State left itself open to criticism that its acts of recent date gave Russia encouragement to continue her course of insolently dishonoring our passports, let me call attention to the circular letter issued by our American Secretary of State on May 28, 1907. It was an un-American document. It was unwarranted by the Constitution and the laws and opposed to the very spirit of our Republic. It first contained the usual caution to former Russian subjects contemplating returning to their native land, though citizens of our country; then tells them they can not, if they return to their country, expect immunity from the operation of the Russian law; and then contained this unusual, extraordinary remarkable clause:

This department will not issue passports to former Russian subjects, or to Jews who intend going to Russian territory, unless it has assurance that the Russian Government will consent to their admission.

This circular was signed by Elihu Root and kept alive by its issuance to hundreds of American citizens for eight long months. Its offensive words were finally withdrawn by the Secretary of State and a new circular issued eliminating the offensive and objectionable words to which I have called special attention. Neither the circular nor the letter that accompanied it were withdrawn until I introduced a resolution on this subject in the early part of this Congress, and vigorously protested against the issuance of the circular.

With such a document emanating from the American Department of State, will anyone wonder that Russia felt we lacked sincerity in what Ambassador McCormick wrote, and that after all we were not so insistent in having the restrictions removed as one might suppose we were from the diplomatic correspondence to which I have called your attention.

It is time that this Government spoke out on this subject to Russia emphatically and distinctly. The insult tendered in her refusal to honor American passports is not an insult to the citizen that bears that passport alone; it is an affront to the American Government.

Happily and fortunately in this land all our citizens are equal before the law. Under our enlightened policy we accord equality to all who owe allegiance to the American flag. This country is too great to permit any longer any government to refuse to pay due

respect to our passports, for our passport should be the safeguard of every American traveling, in times of peace, in every country and in every clime. [Applause.]

Upon this subject I desire to quote from a leading editorial in the Philadelphia *Inquirer* of January 21, 1909, these words:

The question which is so clamorously calling for settlement is by no means confined to those whom it most immediately affects. It is not whether persons of the Hebrew race shall be allowed, when provided with an American passport, freely to traverse Russian territory; it is not whether such persons shall enjoy the equal protection of the Russian law. It goes far beyond that. The question is whether the passport issued by the Department of State shall be recognized and accepted, no matter in whose hands it may be found, as an authoritative certificate of American citizenship, or whether any foreign official who chooses may refuse to accord such passport the credit which is due to it and may take upon himself to repudiate and ignore the rights and immunities to which as the appanages of American citizenship it certifies in its possessor, without eliciting from the Government of the United States any more effective action than a mildly academic remonstrance.

Now, Mr. Speaker, I trust that the resolution will pass without a dissenting vote. I indulge in the hope that the incoming administration will take up the subject in real earnest and push it vigorously and earnestly to secure results. But the subject will have the strongest endorsement when it comes backed by the action and approval of the American Congress. [Applause.]

The passage of this resolution by both the House and Senate will wield a strong moral effect, for it will not alone strengthen and encourage the Executive, but it will speak out loudly to Russia that public opinion on this question is aroused and that the American Government demands the cessation of her insulting treatment.

I ask the adoption of the report of the committee and the passage of the resolution.

SPEECH OF
HON. GILBERT M. HITCHCOCK,
OF NEBRASKA,

MR. SPEAKER: I am glad of the opportunity to say a few words in support of this resolution introduced by my friend, Judge Goldfogle, of New York. The only regret I have is that the Committee on Foreign Affairs has not seen fit to report the resolution in stronger, clearer and more emphatic terms. In its present form the resolution requests the President of the United States to renew negotiations with the Government of Russia to secure, by treaty or otherwise, uniformity of treatment and protection of American citizens holding passports issued by our authorities, so that Jewish-American citizens may receive the same protection and immunity in Russia which other Americans receive when carrying a passport and visiting that country.

Five years ago this House passed a similar resolution, requesting the President to renew negotiations with such governments

as discriminate against Jewish Americans, and as that request and those negotiations have been of no effect so far in the case of Russia, it seems to me that the time is approaching when the House of Representatives and other departments of the Government might very properly adopt more effective measures and speak more emphatically. This is not a new question in America. For many years the matter has been agitated. Year after year and session after session Judge Goldfogle, of New York, and others have demanded that Russia should accord to Jewish-American citizens the same privileges of travel in Russia that Russia accords to other American citizens and to other citizens of other countries. These privileges are no more than America accords to all the citizens of all countries. They are no more than all nations of the world except Russia accord to Jewish Americans. No argument is made, on the floor or elsewhere, so far as I know, which presents any substantial reason why Jewish-American citizens should not have the right to travel in Russia the same as other American citizens have. No argument is presented here or elsewhere, as far as I know, which indicates that there would be any possible danger which could come to the people of Russia or to the Government of Russia by reason of permitting Jewish-American citizens to travel there and to enjoy the protection of American passports.

Why, then, is this discrimination against the American Jew? It is a discrimination based wholly upon prejudice, a prejudice which either has its foundation in race hatred or religious intolerance. In either case the American people have the right to resent it. An American passport ought to be good in all countries of the world when in the possession of a law-abiding American citizen. This country cannot afford to allow its dignity to be affronted by further indifference to this arbitrary stand taken by the Russian Government without reason and without apology.

Mr. Speaker, I commend my friend Judge Goldfogle for the persistence and ability with which he has pressed this issue upon the floor of the House of Representatives. I only wish that I might also extend my congratulations to our Department of State. It seems to me remarkable that while the United States of America, affording to the citizens of Russia all the privileges and immunities, all the friendship and the consideration which are due to a people of a friendly nation—I say it seems to me strange that in extending these privileges to Russia this country has been willing to tolerate this unjust discrimination against a large number of our American citizens. It was an American who secured freedom of the press for the newspapers of Russia. America has furnished the example to inspire all the reform elements of Russia to attain self-gov-

The FIRST Month [ד' ניסן]

THE month of Nisan is ushered in with much formality, with a flourish of trumpets as it were. It is annually introduced with that divine proclamation issued in its favor on the Eve of the Exodus. It is received by Israel with Cheer and Joy. No sorrow, however poignant, is permitted to cloud its brow nor mar its stay. The living are jubilant; even the dead. We are told to enjoy it; so much so that to die during Nisan is considered a privilege!

To this one, however, acquainted with the resplendent record of this month in the past, forgetting even for the moment its promise for the future (vouched for by Jewish and Gentile tradition alike) to him, the ovation accorded to this month seems but natural. He knows that "Nisan", apart even from its great historic festival, is the month of Marvels—a month that monopolized almost all the brilliant achievements, all the singular triumphs of our marvellous past from the early dawn of our history down to the time of Ezra. Its record is not quite complete even now, since it is expected that its past will have a fitting complement in the future—to have a good deal more to claim to its credit. Dealing, however, for the present with its record of the Past, we shall begin with the starting point in our history:

- (A) The unique covenant God had made with Abraham, by which our Father was promised a numerous progeny with the land of Palestine as an inheritance, to ratify which God's special representative passed through the pieces a phenomenon unrivalled in the history of the world—this unique covenant, known in Hebrew terminology as "ברית בין הבתרים," was entered into in the month of Nisan. (Trad.)
- (B) Abraham's return from Egypt to Palestine, with honor and wealth—as foreshadowing what will happen to his children, occurred in the month of Nisan. (Trad.)
- (C) Isaac, the first born Jew, came into the world in Nisan. (Trad.)
- (D) The first message Moses delivered to Pharaoh, was in Nisan. (Trad.)
- (E) The Exodus Twelve months later took place in Nisan. (B. His.)
- (F) The miraculous passage of the Red Sea occurred in Nisan. (B. His.)
- (G) The descending of the Divine Presence, in the sight of all the people, to take possession of the Tabernacle, occurred in Nisan. (B. His.)
- (H) The miraculous passage of the Jordan transpired in Nisan. (B. His.)
- (I) The equally miraculous fall of the Walls of Jericho likewise, occurred in Nisan. (B. His.)
- (J) The annihilation of the Vast Midianite, host under Judge Gideon had occurred in Nisan. (Trad.)
- (K) Sennacherib's huge army round the walls of Jerusalem,

in King Hezekiah's time, was struck down dead in the month of Nisan. (B. His.)

- (L) The fall of Babylon, which spelled the "Restoration," took place in the month of Nisan. (P. B. His.)
- (M) The return from Babylonian Captivity or to "Second Redemption, began in the month of Nisan. (His.)
- (N) The miraculous deliverance of Daniel (in the lion's den) who influenced the "Restoration," had occurred in Nisan. (Trad.)
- (O) And Haman was hanged, and his plot burst, in the month of Nisan. (B. His.)

When a month can boast of such an unparalleled brilliant record, is it any wonder that Jewry hail it with delight? During this recurring month Israel has seen itself freed twice; delivered time and again from tight and perilous positions; seen their bitter and unscrupulous foes entrapped in their own snare now and again. Is it to be wondered that its advent cheers the heart of the Jew?

In ages gone by the 1st of Nisan was our political New Year, and all our state papers and documents, all our historical records were dated accordingly. Nisan is the month which saw our political birth, our beginning life as a distinct nation was placed at the head of this month; and at the head it still remains! It is still the first, the beginning of our political year; for we have not finished our political career yet. Our political year is but suspended for the present, but not dead.

We have proved ourselves indestructible, undying; and since we cannot die we are bound to live. We have surprised the world with our first rise, we shall astound it by our second—and the Gentile is not unaware of it!

The month of Nisan, as the month of marvels, may yet play once more its marvelous role in our future as in our past history. Jewish tradition has proclaimed it all along; and now Gentile theologians say the same. Our great past was, we are taught to regard, as but a kind of "sample," to form thereby an opinion as to what our future may be like—but as a "sample!" the goods of which will be delivered when we are one and all ready to receive the same.

The Church talks enthusiastically of the "second Advent" of the Nazarene. But is the Church not making some kind of a mistake? Is it not confusing the individual with the Nation? Methinks it is. The Church should rather begin to talk of the second Advent—into possession and position—of the Nation which gave the Nazarene birth! For the "Second Advent" of that individual Jew is but a myth—the realization of which they will never see; but the "Second Advent" of his nation i. e. the second rise of Israel—this is not a myth, this is getting nearer

realization year by year; and this they certainly will see! Even this very marvellous Nisan they may see break its own record; make additional claims to be called first. It was the first (political) month of the first (chosen) people, redeemed first, through the agency of the first prophet; and it will remain the first of the nation—the sufferers the first for the sake of the Unity of the First, when they will return to their position—the first, to be regarded as the first among the nations who now claim to be the first.

MUSICAL AND DRAMATIC COMMENT.

Last Tuesday the Kneisel Quartet gave us one of those evenings of melodious music, "pure and undenied," which are particularly refreshing at a time when clashing dissonance and crashing climaxes fill the air. Only a block away from Broadway, at Mendelssohn Hall, my soul was soothed with strains that blotted out the present and made me breathe the serene musical atmosphere of a hundred years ago. The concert began with that octet of Mendelssohn's composed when he was only sixteen years old. It illustrated a passage in the Walpurgis Night scene from Goethe's "Faust." The composer's sister Fanny wrote of it: "I see everything in the poem which was before his mind. The whole piece is played staccato and pianissimo, the tremolo passages standing alone. The flashing light thrills, all is new, strange and yet so attractive, so familiar. One feels so near to the spirit world, and so lifted up to the clouds, that one is almost tempted to seize a broomstick in one's hand and follow the merry troupe. At the end the first violin fades away into the lightest sound and all is vanished."

A cello sonata by Corelli followed. Mr. Willeke's beautiful tone and excellent technique recreated, so to speak, the delightful rococo music. A most vital, finished and temperamentally inspiring performance of Schubert's C major string quintet brought the evening to a close.

A correspondent to settle a wager writes to me asking which opera house—the Metropolitan or the Manhattan—gives the best performance. To which I answer in Hibernian fashion: "Both of them." This reminds me of Goethe's famous reply, when he was asked whom he considered the greater poet—Goethe or Schiller: "Let Germany," he said, "be proud of possessing two such fellows."

Herr Pfeiffer, a Catholic member of the German Parliament, has recently been advocating a new law whereby the social position of stage folk might be bettered. In a public speech he expressed the hope that actors would more frequently go to church. Thereupon a Berlin journalist remarked that this would be quite impossible, for most actors religiously inclined attended the synagogue.

A series of brilliant achievements, briefly but adequately, describes Mr. Hammerstein's season now rapidly drawing to a close.

Of course, there is always the exception proving the rule and "La Princesse d'Auberge," in my humble opinion, mars the otherwise unbroken record of successes.

The story of this so-called Belgian opera is a little more sordidly repulsive than those plots which the librettist took for a model and, with the exception of the highly picturesque ending of the second act and a part of the third, the music never rises above the level of clever eclecticism. It is the sort of thing which any learned chapel master can accomplish with more or less facility, particularly if he care not how quickly the listener recognizes the borrowings from Massenet, Meyerbeer and Wagner.

At the premiere M. M. Gilbert and Dufranne alone distinguished themselves, for Mlle. Labia sang distressingly out of tune, and M. Valles constantly reminded me of Herr Schmedes at his worst! The playing of the orchestra left much to be desired.

M. Block's opera is admirably staged, the carnival scene presenting an attractive picture of revelry. Mr. Coini, who does all things well, has here surpassed his previous efforts.

Next season will mark the twenty-fifth anniversary of Walter Damrosch's debut as an orchestral conductor in New York. He was only twenty-three years of age when his father's sudden death placed him in the very midst of musical activities. Through his arduous and incessant labors, the Symphony Orchestra has now for two years been maintained as a permanent organization. This is

the first local orchestra so established and the society hopes in the future to keep the lead thus gained. The plans already completed for next season include a new departure which the directors are not yet prepared to divulge.

For the two special concerts to be given under Mr. Mahler's direction on the evenings of March 31 and April 6 at Carnegie Hall the Philharmonic Orchestra is to be increased to one hundred players. For the first concert Schumann's "Manfred" overture Beethoven's Seventh Symphony, the "Siegfried Idyll," and the overture to "Tannhauser" are announced. A Beethoven programme, comprising the "Egmont" overture and the Ninth Symphony, will be performed at the second, at which the Bach Choir of Montclair will co-operate.

Elgar's "The Dream of Gerontius" will be sung at Carnegie Hall on Saturday evening by the Oratorio Society, with the assistance of the Symphony Orchestra, a semi-chorus from the Musical Art Society, and these soloists: Miss Janet Spencer, Mr. Gervase Elwes and Mr. Claude Cunningham. . . . The Symphony Society concert next Sunday will bring the Tschuikowsky cycle to a close and will also be the last Sunday afternoon concert of the season. The programme includes the "Nut Cracker" suite and the "Pathetic" symphony. . . . The third and concluding concert of the Volpe Symphony Orchestra is announced for next Thursday evening at Carnegie Hall. The soloist will be Katharine Goodson, the English pianist, who will play a Liszt concerto. . . . Miss Goodson will also be the "assisting artist" at next week's Kneisel Quartette, when Dvorak's quartette in F major, Brahms' quartette for piano and strings and Mozart's quartette in G major. . . . "Die Liebe Wacht," a German version of "Love Watches," is announced for this evening at the Irving Place Theatre. J. M.

Strike at American College in Palestine.

The Hebrew paper Hazevi of Jerusalem tells of a strike which broke out at the American College in Beirut. The strikers were all the Mohammedan and Jewish students who attend this college.

According to the report, the trouble is due to the fact that the students were required to attend the Christian chapel twice daily, before and after the studies.

Ever since the revival of the constitution in Turkey the Moslem students began to object to this, and at one time they held a meeting and the students in body swore by the Holy Koran that they would never again attend the religious services, no matter what happened. Shortly after that the Jewish students joined the Mohammedans, and one day recently all went out on a strike.

The local directors of the college have been at a loss as to what they should

Several of the students have returned, but the majority of the Mohammedans and Jewish young men remained on strike. The students maintain that they will not return to their studies until the compulsory attendance at the religious services is abolished.

It is reported that the faculty of the college has appealed for advice in the matter to the New York directors of the institution.

At the time of the writing of the report in the Hazevi no answer had yet been received from America.

A dispute has arisen in Baltimore, Md., Jewish circles over the plan of Judaic Lodge to hold a "charity" bazaar on May 3. The Federation of Jewish Charities and United Hebrew Charities are opposed to it, and they have inserted advertisements in the daily papers asking the public to withhold patronage.

HAPPENINGS IN THE JEWISH WORLD.

A Hebrew Ladies' Club was recently formed at Portsmouth, N. H.

The old Jewish cemetery at Nuremberg, in Bavaria, has been badly damaged by floods.

Dr. Hugo Marcus has been elected president of the Medical and Surgical Association of Nice.

Five hundred Jewish newsboys of Baltimore, Md., were tendered a Purim dinner last Sunday evening.

According to the latest statistics there are at present 1,800,000 Jews in Poland, 300,000 of whom reside at Warsaw.

Rev. Samuel Bless, of Morgentown, W. Va., has accepted a call from the Beth Jacob Congregation, Duquesne, Pa.

There is very little doubt that the proposed Federation of Brooklyn Jewish Charities will become a reality early in April.

The annual conference of Mississippi Jewish Religious School Teachers was held in Vicksburg from the 12th to the 15th inst.

A Junior Auxiliary of the National Jewish Hospital for Consumptives at Denver was organized in this city last Tuesday.

A Yiddish organ specially devoted to arts will shortly appear at Wilna in memory of the late Professor Antopolksky.

The Independent Southern Congregation Talmud Torah, Philadelphia, Pa., has purchased an edifice at No. 629 Dickenson street.

Reports from various parts of Russia announce the opening of new branches of the recently organized Hebrew-Speaking Association.

The Governor of Kieff has arrested a police official for failing to detain an individual who carried on an agitation in favor of a Jewish massacre.

The Germantown (Mass.) Citizens' Association have entered a protest against the proposition to establish a Jewish cemetery in West Roxbury.

M. Maurice Levy, member of the Institute, has retired from his professorship at the College of France. He has been appointed Honorary Professor.

It is reported that the library of the Berlin Jewish community, which is free and open to the public indiscriminately, has been much frequented lately.

Among the guests at the recent Purim ball of the Ladies' Auxiliary Society, United Hebrew Charities of Baltimore, was Governor Crothers, of Maryland.

Mme. Pauline Donalds has been engaged as leading soprano for the season of grand opera to be given at the Academy of Music, this city, next winter.

Plans have been filed for the erection of a new synagogue in the Bronx by the Tremont Congregation Gates of Mercy. The edifice will cost about \$30,000.

The year book of the Jewish Charitable and Educational Union of St. Louis shows last year's receipts \$121,515.83; disbursements, \$60,745.03; balance on hand, \$66,770.80.

The Congregation Agudath Achim, Columbus, O., which recently erected a handsome synagogue, is badly split up, the older and orthodox members having withdrawn.

Over 25,000 individuals attended the International Tuberculosis Exhibition last Sunday afternoon in Philadelphia, Pa. The day was set apart and known as Yiddish Day.

A movement is on foot in Paterson, N. J., for the establishment of a Paterson Educational Alliance, which will be modeled after the New York City Educational Alliance.

The Emperor of Austria has conferred the Order of the Iron Crown on Mr. Herbert G. Lousada in recognition of services rendered to the Austro-Hungarian Colony in London.

The new Jewish Sanatorium, at Berlin, was dedicated recently. The interesting function was attended by many representatives of the official and communal life of the city.

The notorious Real Russian, Major Petuchov, who led his regiment against the Jews in the Siedlece massacre, has been found guilty of criminal offenses and deprived of his rank and orders.

About sixty Jewish soldiers belonging to the various organizations at present quartered at Fort Leavenworth, Kan., recently held a meeting, were addressed by the local rabbi and organized for social purposes.

The death took place recently at Frankfurt of apoplexy of Mr. Henry Seligman, the well known banker and philanthropist. The deceased, who was a brother of Mr. Isaac Seligman and Mr. Leopold Seligman, of London, and was eighty years of age, combined an intense interest in Jewish affairs with a practical and spontaneous charity.

M. Suvorin, the well-known editor of the anti-semitic Novoe Vremya, will shortly be appointed a member of the Russian upper House on the occasion of his completion of fifty years of journalistic activity.

Dr. Richard Strauss' new opera, "Elektra," the recent production of which aroused almost universal interest, is dedicated to "his dear friends," Commercial Councillor and Mme. Willy Levin, of Berlin.

Dr. Edmund Landau, private secretary at the University of Berlin, has been appointed ordinary professor of mathematics at the University of Gottingen, in place of Professor Minkowski, who died a few weeks ago.

The Russian Senate has declared that Jewish recruits who are absent at the rollcall, even if they present themselves immediately afterward, are still to be regarded as missing and their relatives are liable to a fine of 300 rubles.

The Unity Club, of Brooklyn, is financially and numerically in a more prosperous condition than it has ever been in its history. At present 250 members are enrolled and demands for a new clubhouse are heard on all sides.

The dispersal of the Jewish soldiers among the Russian regiments stationed in the central provinces has been ordered by General Hershmann. The commanders were requested not to enlist too many Jews in each army unit.

Mr. Louis Kronberg, a distinguished American artist, formerly of Boston, Mass., is a new arrival in London, and is now located at the Bolton Studios, Redcliffe road. Mr. Kronberg proposes to exhibit in the spring at the Mendoza gallery, New Bond street.

At the present International Chess Congress, at St. Petersburg, most of the participants are Jews. The government at first wished to deny the Jewish experts the right to reside temporarily at St. Petersburg, but finally was forced to yield.

In convocation recently at Oxford University the honorary degree of Doctor of Civil Law was conferred on the historian, Professor Dr. Felix Lieberman, of Berlin. Recently he was elected a Member of the Academies of Science at Munich and Gottingen.

A new Hebrew-speaking society, under the name Ivriah, has just been founded at Sofia, Bulgaria. The society proposes to establish a Hebrew library and to hold frequent lectures. In Philadelphia Rabbi Dr. Z. Rabiner has founded a society for Jewish History and Literature.

M. Ruchlov, the new reactionary Minister of Ways and Communications, has decided to dispense with the services of all the Jews serving on the Russian railway lines. The new minister has also ordered the authorities of the Amur Railway to give precedence in placing contracts to Real Russian engineers.

The Imperial authorities have declined to indorse the recommendation of the Finnish Senate to prohibit Shechita in the province. Following the advice of the Governor-General, the St. Petersburg Cabinet informed the Senate that in the opinion of the Ministry the Jewish method of killing animals was not inferior to the Christian one.

Great difference of opinion has arisen at Kieff among the Real Russian clergy and the ordinary members of the branch. The latter refuse to regard the Old Testament as a holy book on account of its Jewish origin, whereas the clergy naturally maintain that the New Testament is founded on the law of Moses.

Preliminary arrangements are being made for a party tour of Zionists to Palestine. A number of members of the party have already been secured. Those interested are requested to correspond for further communications with Dr. B. L. Girdon, 1316 South Fifth street, Philadelphia, Pa.

All the Jewish public buildings in Jerusalem, including the Yeshivas and Talmud Torahs, as well as the shops in the city, were temporarily closed early this month owing to their proximity to the scene of the disturbances in the Greek quarter. The streets were occupied by troops owing to the threats of a massacre by the Greeks.

The Cercle des Intimes, a Jewish club at Salonica, has requested the Jewish Colonization Association to assist it in the establishment of a Jewish colony in the neighborhood of that city. The Ica offered to contribute 100,000 francs on condition that the remaining sum required shall be raised by the Salonica Jewish community.

For the first time in Algeria a lady lawyer has pleaded in the law courts. The lady in question is Mile. Azoulay, a Jewess, who, by her able defense, secured the acquittal of an Arab charged with murder. She was congratulated by the president of the court and the leader of the bar, and received an ovation from the general public.

The Federation of American Zionists has been receiving a number of inquiries from prospective colonists to Palestine. Among the most interesting of these is one who writes in the name of a colony of fifteen Jewish farming families who have become successful in Wapella, Canada. These Canadian Jewish farmers are ready, upon the receipt of satisfactory information, to dispose of their possessions and to migrate in a body to Palestine.

A co-religionist at Alexandria, Egypt, M. Henri Nahmann, has been appointed Knight of the Francis Joseph Order by the Emperor of Austria in recognition of services rendered for many years past. He is vice-president of the Austro-Hungarian chamber of Commerce and an active member of the Committee of the Austro-Hungarian Benevolent Society, Judge-assessor of the Mixed Tribunal at Alexandria, and Secretary of the Association for Import Trade. He carries on his numerous duties without any ostentation and enjoys general esteem.

Major Edmund Louis Gray Zalinski.

In the death of Major Edmund Louis Gray Zalinski in New York city on March 10, 1909, at the age of 60 years, the Jews have lost a coreligionist who had achieved world-wide renown. At one time he was considered one of the greatest authorities on high explosives in the world. In the preparation of an historical paper read at the seventeenth annual meeting of the American Jewish Historical Society at Philadelphia in February last the writer has had occasion to examine many reliable sources of information in order to obtain data concerning Major Zalinski. Between 1883 and 1889 Major Zalinski became widely known as an inventor, and was actively engaged in experimental work in the perfecting of various military devices, many of them now in use on the coast defenses. Some of his inventions were a ramrod bayonet, a telescopic sight for artillery and an trenching tool. He was best known for his development and perfection of the pneumatic dynamite torpedo gun. This weapon uses pneumatic power in lieu of gunpowder, and throws a torpedo projectile weighing 1,000 pounds charged with 600 pounds of high explosives. His improvements made the weapon practical. The Vesuvius was armed with three of these guns. In 1890 he made an official trip through Europe, visiting nearly every country and studying methods of warfare. Four years later he visited South America, Japan and China on the same errand. Immediately after the Maine explosion in Havana Harbor on February 15, 1898, the principal newspapers throughout the country published interviews with various experts on matters pertaining to marine machinery and ordnance. Among those whose views were widely quoted in the public press at the time was Major Zalinski. As he had been Professor of Military Science at the Massachusetts Institute of Technology, and was then the foremost living expert upon explosives in warfare, Major Zalinski's theory, based on facts known at the time, that the Maine was blown up as the result of design and not by accident, tended considerably to augment the prevailing war spirit throughout the country, which was only allayed by the fact that a court of inquiry was about to be convened for the purpose of officially investigating into the circumstances of the explosion, and the advisory telegram of Captain Sigsbee, of the Maine to the Secretary of the Navy, that public opinion be suspended, backed up by the authorities at Washington calling on the public to await the final report of the court before formulating definite conclusions as to where the blame lay for the explosion. It is interesting to note in this connection that Major Zalinski's theory that the battleship was blown up by a torpedo or submarine mine was one readily coincided in by Professor Alexander Graham Bell and other noted scientists of the day and the one finally adopted by the court of inquiry and incorporated in the findings and conclusions which were later submitted to Congress and which no doubt hastened the actual conflict with Spain. Major Zalinski was born in Kurnich, Prussian Poland, on December 13, 1849. He came to America with his parents when he was four years of age, and the family settled in Seneca Falls, N. Y. In the Civil War he was appointed an aid on the staff of General Nelson A. Miles. In February, 1865, he was commissioned a lieutenant in the second New York Heavy Artillery, the commission following an act of gallantry on the field of Hatcher's Run, Virginia. When the volunteers were mustered out, Major Zalinski entered the regular army, becoming second lieutenant in the Fifth United States Artillery. He was in turn promoted to first lieutenant in 1867 and to a captaincy in 1867 and was retired from the army, with the rank of major, in April, 1894. He is survived by his mother and sister, who live in Buffalo; his brother, Major Moses G. Zalinski of the quartermaster's department at Washington, and a son Edward Rollins. He was one of the organizers of the American Jewish Historical Society, and a member of several scientific societies.

Ladies' Fuel and Aid Society.

The annual meeting and election of officers of the Ladies' Fuel and Aid Society was held on Thursday, March 11, at the Herrnsstadt, 29 West 115th street, New York city.

The reports of the president, secretary and treasurer were read and received with demonstrations of approval. The president, in an elaborate and well worded report, gave the work of the society in detail. The itemized report submitted by the secretary shows the total receipts for the fiscal year to be \$5,797.88. The disbursements for the same period amounted to \$7,382.84. The treasurer's report shows a balance on hand at the present time of \$6,064.50, which is on deposit in three savings banks and one business bank. At the conclusion of the reading of the reports the election of officers was held, which resulted as follows: Mrs. L. Hershfield, president; Mrs. I. Raphael, Mrs. S. Liebovitz, vice-presidents; Mrs. I. Unterberg, treasurer; Mr. Jacob M. Guedalia, secretary; Mr. I. Unterberg, Mr. M. Asinoff, Mr. J. M. Guedalia, Mr. I. Scheinman, Mr. N. Kaufman, Mr. M. Baron, Mr. J. Luxenberg, Mr. J. Samuelson, Mr. I. Raphael, Mr. S. Liebovitz, Executive Board.

Hebrew Technical Institute.

The Rev. Dr. Rudolph Grossman gave one of his characteristic talks to the boys of the Hebrew Technical Institute on Monday morning of this week. Roosevelt in Palestine.

That is the head line of a news item which appears in the latest issue of the Neue Judische Korrespondenz to reach this country. The Neue Judische Korrespondenz is a news bulletin published in Berlin and which is designed to furnish Jewish publications with information concerning the affairs of the people in the different countries. The item referred to in the latest number of the bulletin is as follows: "Our correspondent from Heifa (Palestine) writes to the New York correspondent as follows: 'According to a report which has been received here, ex-President Roosevelt intends to visit Palestine either in May or June of this year, and it is stated that he has expressed a wish to visit several of the Jewish colonies in this country.'"

This announcement has been received here with great interest in Jewish circles, and it is especially interesting to Zionists who expect that Mr. Roosevelt's inspection of the colonies would serve to attract attention to the plans of settling Jews in the Holy Land.

"Much praise is continually bestowed upon the playwright who knows how to draw tears; but the most miserable onion has that coveted gift, and he must share his laurels with that interesting vegetable."

"Cuba's most prominent feature is his pride. If he should ever see his Maker in heaven, he will compliment him upon having created him."

"Rothschild, too, could build a Walhalla, if the fancy took him—a Pantheon of all princes that went to him a-borrowing."

SAMIR'S THE BEST SPECIMEN.

Perhaps the finest example of Jewish humor is that of Samir, as the following specimens I have translated from the German plainly show:

"What is money? Money is a goodly lump which the Lord God attaches to insignificant people so as not to lose sight of them in his creation, as a good housekeeper puts a big label on a little key.

"What is money? Money is a figure which grows in importance as there is a cipher attached to it.

"What is money? Money is a metal heel under the boots of little people to make them appear as tall as others.

"What is money? Money is an indemnity which God gives to a certain number of persons on condition that they will not make bold to acquire any such goods as intellect or genius.

"What is money? Money is the mysterious essence of a being which defines its ego in the following words: 'If I were not what I have, I should not have what I am.'"

D'ENNERY'S REPLY TO RIVAL.

A story of M. Adolphe D'Ennery, the French dramatist, is excellent.

One of his rivals once remarked, "This D'Ennery is a true Jew; that is why he never produces a play without interest."

"Ah," remarked D'Ennery, "what a good Christian he must be!"

The baron scarcely could believe his eyes; but he foreboded that this was not the end. Sure enough, a month later the borrower appeared, asking for the loan of \$4,000. American Passports and the Russian Treaty.

ernment. America shielded Russia and assisted the broken empire to conclude an honorable peace with Japan, and further aided her after the war. Surely America ought to be able to secure from the Emperor of Russia recognition and honor for American passports in the hands of peaceful law-abiding and reputable American citizens, whether they be Jews or gentiles.

Mr. Speaker, I have said that I regret that the resolutions now before the House are not stronger. I regret that they do not have much of the vigor and vitality which they had as originally drawn by Judge Goldfogle. I regret that the Committee on Foreign Affairs has found it necessary to moderate these resolutions so much and to make them so mild and inoffensive. Nevertheless, as this seems to be the best that we can procure at the present session, I shall take pleasure in voting for the passage of these resolutions requesting the President to renew negotiations with Russia, and I trust the Department of State, under the direction of the President, will insist firmly, even though it be politely, upon the American demand that a passport from the United States shall be honored when presented by a Jew as well as when presented by a Gentile. If these negotiations fail, as other negotiations have heretofore failed, then I hope the House of Representatives will inspire the Department of State to take stronger measures to bring about justice to the Jews of the United States and honor to American passports.

Judaism and Zionism.

All this gave him courage to exist, to be able to stand his persecutions, to overcome all his sorrows, to look bravely at all dangers and not be consumed.

Zionism—this is the mystery of the long endurance of our nation. Zionism—this is the secret of the everlasting existence of the Jew.

The Jew cannot mention the name of his God without remembering the land that God gave his forefathers. The Jew can not remember the land of his forefathers without reminding himself of his God, who reigned there once in so much glory.

Zionism and Judaism are the body and the spirit of our nation. One cannot exist without the other. Judaism without Zionism is simply a dead body. Zionism without Judaism is flesh without bones.

Zionism—this is the tree that spreads its branches towards all parts of Jewish life. If we wish our children to be Jews, if we would save our next generation for us, then we have only one means—to surround them with a Zionist atmosphere.

Zionism must become the watchword of American Jewry. It is the banner that must be raised in our children's hearts. We must tell them of the great part we once played among the nations of the world. Our children must know how we spread rays of sunshine upon all mankind from our ancient land, how much we have contributed to the world's civilization.

New Attack on Jews in Duma.

Reports which have been received in London from St. Petersburg show that a violent attack has again been made upon the Jews by the "Black" Deputies of the Duma. The attack was made in the course of a discussion concerning Azeff, the noted revolutionist, a Jew, who has been found to be a spy of the Russian government. The reactionaries attributed all evils of the country to the Jews, charging that the Jews made profit out of the revolutionary movement and have demoralized the police department through the connection of certain Jews with the secret service.

Herr N. Nisselevitch, the Jewish deputy, who has recently recovered from a severe illness, defended the Jews in the course of an eloquent address. He depicted the degrading conditions under which the Jews in Russia live and which have driven many of them into the ranks of the revolutionists and have caused others to act the part of an Azeff. He said that it was the Jewish youth in despair, finding all doors closed to him, who threw himself into all sorts of the most extreme activities. The way to change present conditions, he said, was to give the Jews equal rights with all other Russian citizens. It is said that his speech made a strong impression.

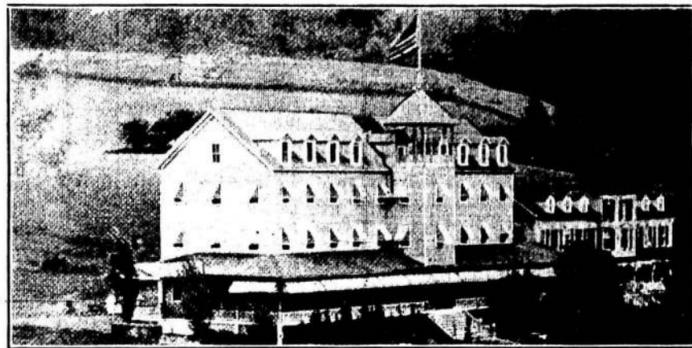
A second report from St. Petersburg states that the Assistant Minister of Foreign Affairs, Krizsonovsky, speaking before a committee of the Senate, expressed himself in favor of abolishing the Pale of Settlement.

A cable to the Jewish Daily News, which had previously reached this city, stated that the Jewish question was recently taken up by the Russian Senate and that the Senate accepted the report of a special commission on the subject recommending that some of the restrictions against Jews should be removed. According to this report, representatives of the Ministry of the Interior spoke against the extension of the right of Jewish residence beyond the Pale. Others again favored the granting of such a right to the Jews. The result was that the Senate could come to no definite conclusion on the matter and that the subject was again postponed.

As evidence of the feeling of fraternization among the various races inhabiting the Ottoman Empire since the proclamation of the constitution, it is interesting to note that the Turkish newspaper, Stamboul, recently published a sympathetic poem by a Greek society lady on the occasion of the election of Rabbi Haim Nahoum as chief rabbi of Turkey.

ROSH CHODESH NISSAN will be duly celebrated on Tuesday next in all orthodox synagogues.

THERE ARE A FEW JEWS of Irish birth in the city and we have no doubt but they celebrated "the day" in due and ancient form.

SOME OF OUR Jewish mushroom insurance fraternities have received a black eye at the hands of the Insurance Superintendent. They may explain and excuse and palliate, but "figures won't lie."

The hegira of un-Jewish Jews to Albany in opposition to the Sunday law permitting Jews who observe the seventh day as their Sabbath, may be confidently expected when the bill is brought up for action.

"ACCOMMODATE YOURSELVES to conditions" is the slogan of Reform. "Be true to your principles at any sacrifice" is the war cry of the Orthodox.

A PRESS OF MATTER has again compelled us to turn the "MIRROR" to the wall, and though "Aspaklarya" mourneth and refuseth to be comforted, his "reflections" will have to lay over until other copy disappears "from the hook."

MATZOS ON PASSOVER are known by the designation of lechem oni "the bread of affliction;" but the real bread of affliction is that earned by the meagre salaries of orthodox chazonim with the accompanying moror of an ignorant, insolent Parnass.

WE ARE PROGRESSING. The un-Jewish Jew does not observe Jahrzeit any more. The sad occasion is remembered in the "In Memoriam" columns of one of the dailies with a few doggerel couplets attached.

AT THIS SEASON of the year the Ladies' Fuel & Aid Society, the Sisterhoods' and the benevolent organizations in which our Jewish women are actively engaged, are making preparations for the relief of the poor during the approaching Passover holidays.

WE NOTE WITH REGRET that ex-Secretary of Commerce and Labor, Oscar S. Straus has reached the conclusion that he must decline to accept the ambassadorship of the United States to Japan, offered to him by President Taft.

THE NEW DEPARTURE of Postmaster Edward M. Morgan, of this city, in permitting the postal clerks who celebrated St. Patrick's Day this year to remain away from their places is to be commended.

WE HAVE RECEIVED the thirty-fifth annual report of the Union of American Hebrew Congregations, and read the same with a great deal of interest. It contains the detailed account of the proceedings at the twenty-first biennial council of the Union, held at Philadelphia in January of this year.

JEWS can everywhere point with pride to the career of Edmund Louis Gray Zalinski. A native of Russian Poland, where he was born in 1849, he retired from the regular army of the United States in 1894 with the rank of major, and died on March 10th at his home in this city, respected by the greatest names in the science of modern warfare as one of the most eminent authorities on and inventors of guns and substitutes for powder as a means of propulsion for missiles.

DEAD.

He was a member of the leading and most exclusive clubs in this city. A loyal Jew, we cannot regard Edmund Louis Gray Zalinski otherwise than as one who conferred lasting honor on American Jewry.

WE are glad that the 60th Congress passed the Joint Resolution introduced in the House by Judge Goldfogle, of New York, calling upon the President of the United States to take suitable action with respect to Russia's persistent violation of her treaty obligations as to passports in the hands of our citizens of the Jewish faith.

THE GOLDFOGLE RESOLUTION AGAIN.

We are certain that Judge Goldfogle will not rest here. We hereby would encourage him to persist in his laudable work to the best and the utmost of our power.

Mr. Goldfogle demanded that the President take up Russia's violation of her treaty obligations. The empire of the Czars has, as everybody knows, deliberately refused to honor the American passport when its holder is a Jew.

The resolution as finally passed states that "it is alleged" that Russia has violated her treaty obligations, when even those who are not congressmen know that. Now, it is a patent fact that an American Jew cannot enter Russia? A few years ago Mr. Isidor Straus, of this city, to name but one notable instance, tried to travel in Russia, but could not, simply because he is an American Jew.

In conclusion we wish more power to Judge Goldfogle's elbow and more "backbone" in our estimable Solons.

AN attempt is being made by the Jews of Massachusetts to regain the privilege of working on Sunday, providing that they observe the Seventh day Sabbath.

The bill which was petitioned by William Abromson and others was presented by Representative Callaghan of Ward nine, Boston on January 25, and reads:

MASSACHUSETTS

SUNDAY LAW.

"An act relative to the observance of the Lord's day.

"Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of same, as follows:

"Whoever on the Lord's day at any time between midnight and midnight keep open his shop, warehouse or workhouse, or does any manner of labor, business or work, shall for each offence be punished by a fine not exceeding fifty dollars: provided however, that the foregoing shall not apply to any person who observes the seventh day of the week as Sabbath, and actually refrains from secular business and labor on that day, and does not disturb any other person on the Lord's day."

A hearing on the bill was given to those interested about two weeks ago by the Committee on Legal Affairs: The speakers on behalf of the bill were Representative Parks of Fall River, Rabbi M. M. Eichler of the Temple Ohabi Sholom, Rabbi Phineas Israeli of the Adath Jeshurun synagogue, W. Abromson, J. M. Levine and others.

The opponents included members of the New England Sabbath league headed by Sec. Kneeland and several Presbyterian ministers.

The Committee has not reported the bill yet and the sponsors of the enactment have hope that when it does report the measure, the report will be favorable.

Representative Parks of Fall River, also had a bill before the house, petitioned by the Hebrew League of Fall River, allowing the Jewish meat dealers to be allowed to sell and deliver Kosher meat on Sunday forenoon. This bill was also urged by Representative Martin M. Lomasney of Boston.

"And the work of the tabernacle was finished, and the children of Israel had made it according to all that the Lord hath commanded Moses."—Exodus xxxix, 32.

OUR attention is particularly directed to one phase that is so often repeated in the section of the Torah of this week. In speaking of the completion of the tabernacle, item after item is particularized and described and each concludes with the words, כאשר צוה' ה' את משה

THE COMMANDS OF GOD.

"according to all that the Lord hath commanded Moses."

It is remarkable that chronic fault-finders raise the objection that religion is too arbitrary. It is too exacting in its demands, they say. They would have a religion with more freedom, more in consonance with "the spirit of the age"—a religion that would let men do as they wish. Just imagine how affairs would run with such freedom, with such a government, where everybody does what he feels like doing.

A few years ago one of the immigrants coming to these shores bought a few dollars' worth of merchandise and went peddling in one of our country places. He was arrested for having no license and was, of course, released, but the poor boy could not understand that in a free country a person could not sell anything he wished without being molested by the police. He could not understand that merchants had to be protected and that officers who watch over our safety and without whom crime and depredation would have no bounds, must be paid, and for this merchants and tradesmen must be taxed.

Not less regularity must there exist in every organization, whether religious or educational, commercial or industrial; every institution must have set laws to govern it.

Particularly for a religious institution that concerns itself about the moral principles and character of every body must there be a set code of laws. Especially is a rigid rule necessary for erecting a building. For were there no such rules how many architects would have locked horns, each knowing better than the other how to design and how to build this and how to form that. Each mechanic would have wanted the house made his way, and the result would have been the same as at the building of the tower of Babel, which had to be abandoned. Therefore, there were no two ways about anything that had to be made at the tabernacle, but all had to be done according to all that the Lord had commanded Moses.

One thing must be said in regard to Israel's tendencies to obey God's commands. It was ever their delight to do what God had willed them to do. In the earliest stage of their independence in the wilderness, where they had risen so often in revolt when their wants and desires were not readily gratified; or even when they had committed that awful sin of dancing around the golden calf, never did they protest against or object to any of the commandments that God had given them by Moses. The daughters of Zelophchad were the only ones that came with a petition to Moses to have a clause inserted in the law entitling them to inherit their father's property, as females therefore could not do, and the Lord told Moses that they were right. So the law was made.

Throughout Israel's history we find the same uniform obedience of the commands of the Lord, and it seemed to hold the people within the bounds of honest integrity. "The commandments are pure, enlightening the eyes." Our prophets were all exponents of the Mosaic code. Malachi laid before the people the injunction וכו' רזורה משה "remember the law of Moses my servant, whom I commanded on Horeb for all Israel, statutes and ordinances," handed down to all generations, who stood, lived and acted by them. So that the כאשר צוה' ה' את משה, "according to all that the Lord hath commanded Moses," has been the cue to a life worth living, and an example to all worlds and peoples.

The tabernacle erected in the wilderness was only for the people to accustom themselves to do God's will in all things and to obey His commands through Moses. Though over three thousand years since these laws, statutes and ordinances were given to Israel, it is wonderfully true that they are as valid to-day as they were when first promulgated. Day by day the civilized world recognizes the sublime truth more and more. Should it then not be our pride and our pleasure to implicitly obey them and teach our children the beautiful lesson that they should in all the activities of life deport themselves as Jews, "according to all that the Lord hath commanded Moses," for "the commands of God are pure, enlightening the eyes"

Some Necessary Education.

SOME time ago, it will be remembered, one of the New York morning papers contained a census of how many "hogs" its reporters met in the railroad cars and ferry boats. This porcine term was applied to men who sat in the seats of cars and boats and permitted women to stand.

A good many men may be excused for committing this offense, as there is nothing in the school books upon the subject. And what the school books and the teachers fail to inculcate, they believe unnecessary to practice.

It wouldn't be a bad idea to add a class in each school which shall have an instructor upon politeness and etiquette. This will suggest itself to many as being as appropriate and probably more useful than a teacher in Latin, or some other ornate branch of the usual curriculum of the school.

There are many things which a professor of politeness and etiquette could teach, and taught in school the youngsters would remember the lessons and also heed them. For instance, he could tell the small boy that, when he makes his debut in a down-town office, it is in order to take his hat off upon entering. He could teach him that in manhood, in ordinary conversation, it would be more proper in directing a subordinate, to say to him: "Show this gentleman into the Mayor's office." instead of saying: "Show this man into the Mayor's office." He could teach the rising man that it is impolite to smoke in the drawing-room in the presence of ladies; and also, that when he becomes a man, grows rich and owns a house, and furnishes it with elegant satin furniture, it is not the proper thing to sit on one of the satin chairs and rest his dirty boots on another—and this in the drawing-room.

He could teach the young girls and boys that it is impolite to talk aloud in public conveyances and excite the attention of fellow passengers, as well as annoy them by this breach of good manners which so frequently is witnessed. He could also teach them that the table in the hotel dining-room is not the place for noisy declamation, to the annoyance of other guests. He could teach the rising merchants that it is not the thing for them to talk over their business affairs in the public cars, and tell one another how many cases of goods they sold and bought during the day, and this in a loud tone and to the disgust and annoyance of the other passengers.

And he could teach young girls, who will be the future mothers of daughters, that it does not necessarily follow that, in each instance when a gentleman visits their daughter, that he has "intentions;" that he may only desire to spend a sociable evening, and that it is not quite the thing to send the next day to the Mercantile Agency for a report of the visitor's "standing."

And he may also teach these mothers of daughters not to be too importunate, and that it is not quite the thing to hurry their daughters off at 18 and 19 years of age, for fear they might get left; and that it is well to remember the old German proverb: "Jedes topfchen findet sein deckelchen in zeit."

But let me come back to the "hogs" figuratively speaking. It wouldn't be out of place for the professor to teach the female of this species that when an old lady bent with age, tottering along the car, and none of the "hogs" rise, it is the proper thing for a strong, hearty woman, young or middle age, to arise and give her a seat. It is rare, very rare, that a gentleman, a "hog" if you please, though he will not get up for a strong woman, will not quickly arise to give an old lady a seat.

By all means, though, let us advocate the appointment of a Professor of Politeness and Etiquette for each school. L'AIGLON.

The Passport Question.

One of the speakers at the first meeting of the Jewish Kehillah in presenting the claims of the American Jewish Committee for consideration and stating what they had done, asked "Was it wrong to consider the passport question and to endeavor to secure the rights of Jewish-American citizens throughout the world?"
I would like to know what has the Jewish Committee done towards adding the adoption by Congress of the Goldfogle resolution? The general impression is that instead of giving it a warm support some of its individual members have rather endeavored to impede the action of Judge Goldfogle upon whose shoulders alone should rest the mantle of glory for what he had done in the passport question, and I suppose the American Jewish Committee will want to claim the credit for it.

AN INQUIRER.

The Three Rivers Cemetery.

Editor HEBREW STANDARD:
Sir—Certain correspondents have been flooding your columns with a history of the Jews of Three Rivers in general and of the Hart family in particular. The details of this history might be of some slight interest to antiquarians, but they are of little value in connection with the determination of the city of Three Rivers to expropriate the Hart Cemetery. I should not have noticed the lucubrations of your historical correspondents if they had not been guilty of misrepresenting the Montreal community.
The cemetery at Three Rivers is the private property of the Hart family. The Montreal congregations have no legal status in the case. Opposition to the expropriation must be formally initiated by at least one of the Hart heirs. As a matter of fact, it was the well-known minister of a Montreal congregation who raised the alarm about the cemetery some four months ago, and he has been repeatedly urging the New York heirs to authorize a Montreal lawyer to file an opposition to the expropriation. He has even intimated that the Montreal community would probably stand behind the heirs if they could not bear the expense of a legal contest. Acting under legal advice, he has repeatedly told the heirs that they must fire the first shot in defense of their property by formally authorizing a lawyer to file an opposition. But what have the heirs done? Absolutely nothing, as far as I know.
If, instead of writing about the entertainment of "the Sailor Prince" and the Duke of Trent, your correspondents would induce the Hart heirs to act, and if, instead of sifting mud at the Montreal community and its ministers, they would come down to facts and business perhaps the desecration of the Three Rivers Cemetery would be prevented. Let us have a little less ancient history and a little less writing, but a little more practical common sense and a little more recognition of the manifest duty of the moment as pointed out to the heirs by the Montreal minister to whom I have referred.

THE BATTLESHIP "MAINE" AND THE JEWS.

By Mark J. Katz.

(Continued from last week.)
(CONCLUSION.)

After the 28th of February, the bodies recovered were sent either to Key West or Arlington for burial on our own soil. Chaplain Chidwick, assisted by a most devoted and kind hearted undertaker, a Spaniard, identified the bodies and saw them properly prepared for the grave. Eiermann's remains are in coffin No. 57, seventh row, and Gross' remains in coffin No. 95, eighth row. The Navy Department records state that neither of these graves are "noted."

Since the war with Spain, Jews have been migrating in considerable numbers to Cuba, and to-day some of the most prominent merchants in Havana are Jews, the city it is said numbering about fifty Jewish families. Perhaps in time these Jewish families will see fit to honor the memories of Eiermann and Gross by fittingly marking the graves of the two gallant sailors of their faith.

It was Mr. Sigmond Rothschild's version of the calamity to the "Maine" that the Board of Inquiry wished particularly to hear, for he was one of the few who saw almost everything that happened. He was a prominent tobaccoist and resident in Detroit, Mich. He had been visiting Cuba frequently for ten years prior to the event and understood the political situation there. His examination in detail before the Board of Inquiry on February 24, 1898, took three-quarters of an hour. He was one of seventeen passengers on the "City of Washington," which lay within 300 feet of the battleship's anchorage and her boats were the first to rush to the side of the sinking vessel, rescuing thirty-three survivors, including Captain Sigsbee.

Mr. Rothschild died two years ago, but his family have preserved a letter written by him on the morning after the catastrophe, which they have kindly placed at the disposal of the writer. In it he gives a graphic account of his experience on the night of February 15th, 1898.

Perhaps the most interesting event in connection with the destruction of the "Maine," is the part played by Lieutenant Commander Adolph Marix, United States Navy, as a member of the Court of Inquiry, which was con-

vened shortly after the catastrophe, for the purpose of inquiring into the circumstances resulting in the loss of the battleship, and to report its findings and conclusions to the Secretary of Navy. A court of inquiry might well be called a court of investigation. It has no power to impose sentence. It makes findings and may suggest whether or not it is advisable that further action be taken.

The report, which no doubt had much to do with the bringing about the Spanish-American war, was framed, signed and presented to President McKinley by Lieut. Commander Marix, Judge Advocate of the Court.

Besides the Judge Advocate the Court had as members, Capt. Wm. T. Sampson, presiding officer, Capt. French E. Chadwick and Lieut. Commander William P. Potter, officers well qualified by rank and practical experience to discharge the onerous duty imposed upon them. Capt. Sampson at the time was in command of the battleship "Iowa," Capt. Chadwick was captain of the flagship "New York" and Lieut. Commander Potter executive officer of the "New York." It was a court which inspired confidence. All the members were scholarly men. Lieut. Commander Marix was recognized as the foremost expert in the United States Navy on all matters relating to navy and maritime laws. He had been appointed to positions requiring tact and ability on numerous occasions and was considered an officer of great force, character and individuality.

In addition Lieut. Commander Marix knew the structure of the "Maine" and her organization in every detail, having been executive officer of the "Maine" for over two years; in fact it was he who, under Commanding Officer Crowinshield (now Rear Admiral, retired), organized the crew of the vessel. As Judge Advocate of the court it was Lieut. Commander Marix's duty to definitely determine the rights of the court to lay down the lines of procedure, and with his broad intelligence of the law there was no doubt among naval officers that the right man had been selected for the post of Judge Advocate. In the proceedings of the court he assumed the role of inquisitor. The sessions of the court covered a period of 23 days, the first session taking place on board the United States Lighthouse Tender "Mangrove," in Havana harbor, on February 21, 1898. Later sessions were held on board the battleship "Iowa," off Key West, Florida, and one at the Military Station at Key West, where the wounded were being cared for.

Seventy-seven witnesses appeared before the court and were examined, not including the sur-

vivors of the "Maine" (officers and men) who were assembled in a body at the army barracks at Key West in the presence of the whole court and there examined in a body. The court completed its report at Key West on March 21st, one month after its first sitting at Havana. The testimony taken, with the findings and conclusions of the court and exhibits, made a bulky volume of 307 pages. The report, which was a formal dispassionate recital of facts and bearing the stamp of that strict officialism which marks naval procedure, was laid before President McKinley by Commander Marix, on Saturday, March 26th, 1898.

From the time, on March 22d, 1898, that Lieut. Commander Marix went ashore at Key West from the battleship "Iowa," in the torpedo boat "Dupont," to obtain Admiral Sicard's approval to the court's findings, until he finally reached Washington, on March 25, 1898, and especially on the momentous day following his arrival, the eyes of the nation were centered on Lieut. Commander Marix's movements.

He left Key West on the afternoon of March 22, 1898, on the "City of Key West," with a guard of two naval officers, both formerly of the "Maine," the party sailing for Miami. In consideration of the vast importance of the court's proceedings and conclusions, extraordinary precautions were taken to prevent any one from touching this carefully sealed document. The court's findings were safely stowed away in Commander Marix's stateroom, with one of the party standing guard on the outside. After reaching Miami he went to Jacksonville, Florida; from there he took a sleeping car on the Southern Railway for Washington. He was the subject of much interest wherever he appeared. Many hundreds of residents of Jacksonville cheered the Commander as the train pulled out for Washington.

He reached the Capital on the night of March 25, but Secretary John D. Long, of the Navy Department, had notified him that the report would not be received until the next day, when it would be read to the Cabinet. Early on the morning after his arrival at Washington he laid it before Secretary Long, who at once accompanied him to President McKinley at the White House, where the members of the Cabinet were awaiting them.

Here for the first time the seals on the white canvas bag, which had been affixed by Commander Marix at Key West, were broken and the document revealed. The President and his Cabinet spent six hours that day considering the "Maine" report, Lieut. Commander

Marix remaining with them to explain the testimony and conclusions and to assist the Cabinet, if necessary, in interpreting the charts and drawings which accompanied the report. In order that Commander Marix might be on hand to elucidate any point in the court's report over which the authorities might puzzle, he was temporarily attached to the office of the Judge Advocate General. It was Saturday when the first of these historical meetings took place and the conference was resumed Sunday morning.

In the meantime Secretary Long and Commander Marix went to the State Department and gave to Assistant Secretary Day a synopsis of the report which was later cab-

Hebrew Ladies' Auxiliary of Bath Beach.

The next affair the society will give will be a pound party at the home of Mrs. Arthur Pinover, Bay Twenty-ninth street, on Thursday afternoon, April 22.

A concert will follow in May in charge of Mrs. M. J. Grossman.

In commemoration of the coming Passover holidays the proteges of the society will receive double their allowance.

The proceeds of this ball will also be distributed among the local cases, which are continually increasing, and the consumptives in Denver.

Harlem Hebrew Institute.

NEW BUILDING OF THE UPTOWN TALMUD TORAH ASSOCIATION DEDICATED.

With much enthusiasm the dedication services of the Herlem Hebrew Institute of the Uptown Talmud Torah Association took place Sunday, March 14. The first school was organized in 1882, and was little more than a Chedar, in Ninety-ninth street, near Third avenue. Later on, 1894, the building, No. 225 East 104th street, was bought, to which has later been added No. 227 East 104th street. The enrollment is now nearly 800 boys and girls. So many were the applicants for admission and so apparent was the need for increased facilities, that in 1905 the lots at 132 to 142 East 111th street, near Lexington avenue, were bought and the new building was begun, the cornerstone having been laid by Samuel Golde on December 1, 1906.

The cost of the entire establishment was in the neighborhood of \$195,000, and of this about \$70,000 had been given by 1,400 individual contributors before the exercises on Sunday. An opportunity was given during the afternoon for other subscriptions to be handed in, and amounts approximating \$10,000 were handed to the chairman, one contribution being for \$5,000 from Mr. Adolph Lewisohn, who acted as chairman. The Young Folks' League, which has a membership of 400, sent \$500, and promised to pay for and provide the entire gymnasium equipment. Five hundred dollars was also sent by the Ladies' Malbush Arumim Society, which clothes the poor children of the school; \$100 was subscribed by the Culture Club, and \$50 more as the gift of the Junior Club, a club of girls ranging in age from 8 to 12 years. There were many other donations, including \$500 from Louis and Morris Golde, \$500 from one of the speakers of the evening, who asked that his name not be mentioned; \$250 from Mrs. Harry Fischel; \$150 from Mr. Joseph Solomon. Mr. Elias Surut became a life member at \$100 per annum, and the contributions came thick and fast, too fast to record, and the chairman was overwhelmed with money and cards in smaller sums from all sides. In all, the chairman announced a little over \$10,000 had been contributed, but that the association still owed \$22,000 which he hoped would soon be raised among the friends of the institution.

Mr. David Cohen, the president, introduced Mr. Adolph Lewisohn, the chairman for the evening, who in turn introduced Mr. M. S. Margolies, of the Congregation Kehillath Jeshurun, of Eighty-fifth street. He delivered an eloquent address on the duty of the older Jews to meet modern conditions as exemplified in this building.

Mr. Edgerton L. Winthrop, Jr., President of the Board of Education of New York city, was then introduced. He congratulated the Jewish people of Harlem on coming into possession of their new building with its equipment of class rooms, auditorium, gymnasium, kindergarten, roof playground and open air playground.

Mr. Jacob H. Schiff, who had sent \$5,000 to the building fund some time ago, which was the first large contribution which it had received, spoke of the urgent need for immediate and adequate instruction in the Hebrew religion. He said that this was not a republic of nationalities, but that in many peoples were to make up one nation. "America is the merging point," said Mr. Schiff, "in which the nations of the earth are blended into one."

Mr. Louis Marshall followed and Dr. Magnes made a plea for the life and development of the Hebrew language.

Dr. Magnes spoke of the movement initiated by the Uptown Talmud Torah to gather together all the various Hebrew schools of the city, including the Russian, German, Austrian, Gallician, Roumanian, Spanish and Polish Talmud Torahs of the Boroughs of Manhattan, Brooklyn and the Bronx. He spoke further of the need of common text books and common grades. He felt that the time was ripe for a reviving and modernizing of the Hebrew teaching profession so that the study of the language would be a dignified one and the profession of teaching it an honored one.

The music was furnished by the band of the Hebrew Sheltering Guardian Orphan Asylum, and was very well rendered and received. At this point fifty girls, pupils of the Talmud Torah, dressed in white, marched down the centre aisle singing "Ma Tobu Oholechu" and 175 boys marched down the two side aisles, meeting in front of the platform and joining in the hymn. A solemn hush came over the audience. Tears sprang to the eyes of most of the people. Those on the platform were seen to brush their hands furtively across their eyes as the high treble of one of the little girls rose throughout the auditorium and the voices of the others sank almost to a whisper. A common wave of nationalistic and racial feeling swept through the room, making all kin orthodox and reform Jew, Russian and German, members and visitors, all were Jews alike as the Hatikvah trembled from the throats of the children.

They marched solemnly out, to be followed by a wild outburst of enthusiastic applause.

Mr. N. Taylor Phillips also spoke, after which the formal presentation of the key to the building was made by Mr. Jacob Katz, chairman of the Building Committee, and was received by Mr. David Cohen, the president, who then thanked Mr. Katz and the rest of the Building Committee, Mr. Charles Friedman, Mr. Harry Fischel, Mr. Barnett Feinberg, Mr. Harris H. Uris and Mr. Elias A. Cohen. He spoke feelingly of the time and effort and money expended by the Building Committee, of the various sacrifices they had made in these

hard times, of the fidelity with which they had discharged their trust, and he also thanked the directors for their support during his administration and the members who had given in large sums and small and to whom was due the successful completion of the new building.

He then turned to Mr. J. H. Schiff, presented to him the key in recognition of the fact that, as the building had proceeded toward the third or fourth story, when the efforts of most of those concerned had nearly reached their limit, Mr. Schiff had sent a check for \$5,000, and that that timely contribution had served to revitalize the flagging energies of the directors, and he therefore felt that it was but fitting that Mr. Schiff be given this key.

A Sefer Torah was then presented by Mrs. Miriam Golde, and then, after the Mincha Service, the Rev. Golubowsky delivered the closing address.

The programme for the dedication services includes Monday night, March 15, which was "Siyum Sefer Torah Night;" Tuesday, March 16, which was "Ladies' Malbush Arumim Night;" Wednesday, March 17, which was "Young Folks' League Night;" and Sunday, March 21, which will be "Harlem Night," being exclusively devoted to residents of Harlem and members of the Harlem synagogues.

At the Young Folks' League Night, on Wednesday, March 17, the principal speaker was Hon. Samuel S. Koenig, Secretary of State. Other speakers were Rev. Dr. D. de Sola Pool and Rev. Dr. Henry S. Morais.

DAVID WASSER. The accompanying portrait is that of David Wasser, proprietor of one of the best-known, and at the same time one of the best kosher restaurants on the East Side, 108 Bowers, near Grand street, and which is designated as "Wasser's." Wasser's restaurant has been established since 1895. The business men of the East Side have always been patrons of this establishment, which was the first up-to-date kosher restaurant opened in that section of the city. Mr. Wasser has just secured a new lease for a long term, and will continue to



personally conduct his restaurant in the efficient manner which has heretofore characterized his management. Special preparations have been made for the holidays, so that all who dine at Wasser's will enjoy home "Yom-tovdik" cooking in its perfection. Mr. Wasser understands the business and is a thorough restaurateur. He is popular as a business man and as a citizen. Besides his restaurant, in which 400 to 500 people dine every day, Mr. Wasser makes a specialty catering in all its branches for weddings, parties, etc.

Extravagance on the East Side. Pesach is house cleaning time and the thoroughness of it is commendable, for it includes everything in the household, from the parlor to the kitchen. Since the introduction of gas as fuel, the use of "hot plates" has become general on the East Side where they are used for cooking. The "hot plates," as they are called, are gas stoves with from one to three burners, that usually require a box or stand of some sort that is not attractive to the eye, and certainly does not improve the appearance of the kitchen. In the absence of anything better or cheaper, they served their purpose, but they have their disadvantages and are now superseded by a more attractive and useful device. The "hot plates" are really extravagant to the owners, among our coreligionists, who in their zeal to conform to the strict letter of the law, are obliged each Pesach to throw them away and purchase new ones, and it falls heavily upon the poor. The cost of these antiquated "hot plates" is from \$1.50 to \$3 per year. This seems extravagant when it is known that the gas companies of the city will rent or loan to any gas consumer for one dollar a year a gas cooker that is ornamental and will roast or bake, which the "hot plate" will not do, having an oven in addition to the burners found on the hot irons. Through their General Fuel Appliance Department, at No. 29 East 21st street, the gas companies announce that they will be pleased to replace the discarded or thrown away "hot plates" by renting a gas cooker or small stove at the price of \$1 per year, and which will be kept in good repair or exchanged at the end of a year if desired without extra charge. It is thus possible for our orthodox brethren to have a gas cooker, upon which they can roast and bake as well as fry, rented to them for three years at the purchase price of a "hot plate" for one year. Besides the saving of money, the convenience and utility no less than the beauty of the gas cooker, should cause their general adoption on the East Side.

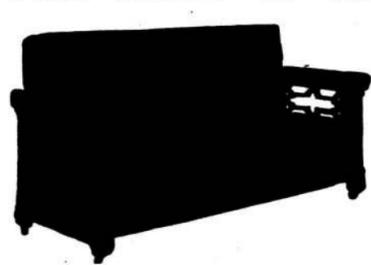
