THE CENTENARY OF LEOPOLD LOEW

On October 13, 1875, Leopold Loew, one of the foremost Jewish rabbis of Continental Europe of the Nineteenth Century and beyond doubt the very foremost leader of Jewish thought of Hungary, died at Szeged, Hungary, where he had been the chief rabbi of the Jewish congregation for a period of over a quarter of a century.

On this anniversary of his death we take occasion to refer to the centennial festival of his birthday held by the Jews of Szeged and Hungary in the month of June of this year.

A similar festival, the centennial of the birthday of a Jewish rabbi, the world probably has never before heard of.

The memory of a Jewish rabbi, celebrated by the Jews of Hungary, the celebration participated in by a Christian community, memorial addresses delivered by leading savants of the Hungarian nation, by a leading Protestant and a well-known Roman Catholic priest, laudatory mention thereof made in the Magyar Parliament, the great journals of the land "writing it up" in editorials and in reviews and notices, learned societies taking notice thereof at their meetings in the form of resolutions of appreciation and acknowledgment and eulogistic speeches, and a Catholic city of 120,000 inhabitants naming one of its principal streets "Leopold Loew Street," is surely a unique, a rare, but at the same time a splendid and flattering evidence of the worth of the man and of the grateful appreciation of those amidst whom he devoted his life to all that is good, noble and elevating.

Leopold Loew was born on May 22, 1811, at Cserxahora, a small hamlet of Moravia. He was a direct descendant of the famous "Hohle Rabbi Loew ben Bezalel" of Prague, famous in Jewish legend, fable and story (Sixteenth Century). His early education—the village he was born in had but one Jewish family—was looked after by his father as far as his alef-beth, his "sziderl,"

his "chumesh," his "t'nach" and his "Rashi" were concerned, while his general education, reading, writing, arithmetic, music, foreign languages, was entrusted to the Roman Catholic priest of the village. Then came the Yeshivas at Leipnik, Eisenstadt and Pozsony, crowned by his

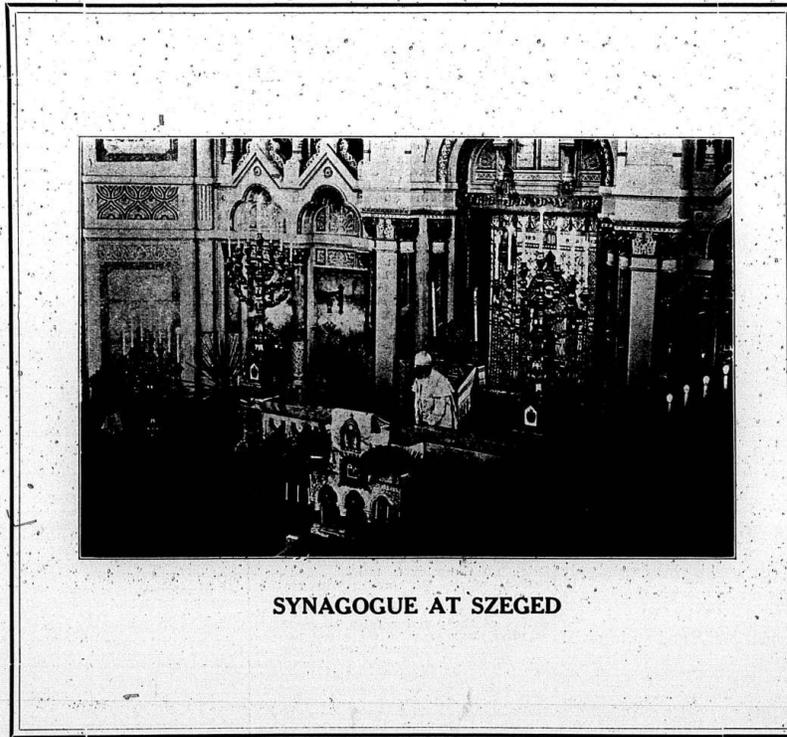
his accepting his rabbinical office until the day of his death he steadfastly labored and sublimely grand were his achievements.

He founded schools, even girls' schools, until then an unheard of thing in Hungary; trade schools and educational societies. He had acquired the Magyar language and did it in such a masterly way that he preached in that language—he became one of the foremost Magyar pulpit orators, named as such in works on Hungarian literature—and over and above everything he began his life's work—i. e., to secure the political emancipation of the Jews of Hungary. This part of his labor, brought him in the early 40's into association with Louis Kossuth and Francis Deak, both of whom held Loew in high esteem. When Loew died Louis Kossuth declared his death to be "a national loss."

Then came the Hungarian revolution Loew joined the revolutionary army as an army chaplain and his addresses to the soldiers were printed by order of the revolutionary government and distributed among the soldiers. The cause of the Hungarians was crushed by the Russian Czar, called in by Austria, and Loew was thrown into prison. Haynau, the notorious military commander of Hungary, gave him his liberty, but demanded and obtained of the Jews of Hungary the sum of 500,000 guildens as a ransom for the liberation of their two famous rabbis, L. Schwab of Pest and Leopold Loew, and as a fine for their participation in the struggle for Magyar freedom.

In 1850 he became chief rabbi of the Congregation of Szeged, Hungary. Hungary then being a conquered province of Austria, Loew's Magyar national patriotic work was stopped, but twice he was summoned before military court-martials for his outspoken liberal views.

Loew's indefatigable labors for the emancipation of the Jews in Hungary were successful—of course, he had a score and more co-laborers, Jews and Christians—and with the

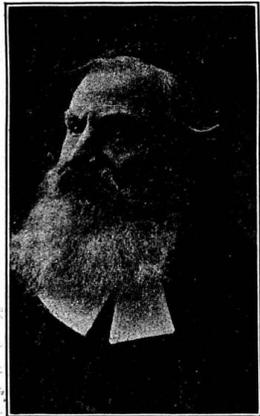
Leopold Loew began his civilization work, and from the first day of

The centennial of Leopold Loew's birthday was celebrated on June 4 of this year. Hungarian and European newspapers were filled with glowing reports of the unique festival at which, apart from the speeches and sermons of Jewish rabbis—Rev. Dr. Immanuel Loew (his son and successor), Rev. Dr. Louis Venezianer, rabbi of Uj-pest; Rev. Dr. Leopold Keeskemethy, rabbi of Nagy-Varad; Rev. Dr. Adolph Lowinger, rabbi of Szegeid,—there were memorial speeches by Professor Mor Karman de Kislaki, who occupies in Hungary a position as pedagogue corresponding to that held here in the United States by Professor Elliott of Harvard, by the Right Hon. Zoltan Beothy, Hungary's greatest author of to-day, one of the presidents of the Magyar Academy, a member of the "House of Lords," by the famous Father Julius Varossy, a Roman Catholic priest, author and Member of Parliament.

It was an interesting, yea an inspiring sight, to see sitting in a row—chairs were placed on the alpenor—sixteen Jewish rabbis, delegates of their respective congregations, with Protestant ministers, Roman Catholic and Greek Catholic priests—all in their respective priestly garbs, listening to the Jewish rabbi's eulogy on a Jewish rabbi, while the body of the synagogue contained the elite of the city, county and nation, assembled to honor the memory of a truly great and good man.

Great as Loew was as a Magyar patriot, he was greater as a Jewish sayant and as a Jewish rabbi. He is the recognized founder of the science of Talmudical archaeology, and his two great works, "Die Lebensalter" and "Graphische Requisiten," are standard works on Jewish archaeology. Other great works of Loew are the "Hamafteach," a history of Jewish literature; "Dogmatische und Dogmengeschichtliche Studien," "Die Tradition," "Eh-rechtliche Studien," "Bibliche Geschichte," "Aaron Chorin," "Die Grosse Synode," and about one hundred or more exhaustive essays on divers Jewish theological subjects found in his "Gesammelte Werke," which form five heavy volumes. He wrote a whole library of Jewish historical works, volumes of sermons, a Hungarian work on "The Jewish Cult," which was read before the Hungarian Academy of Sciences, and one, "The Jewish Oath." These last two were translated into English. Finally, for ten years he edited the "Ben-Chananiah," a weekly journal devoted to Jewish theology, the pages of which teem with the evidences of his masterly mind and genius.

Loew was a leader of "modern reform"—here in the United States he would have been called "an orthodox rabbi," but reform or orthodox, what does it matter? During the forty years of his public life Hungarian Judaism and Judaism of the world knew not a more bold, more brave, more loyal champion of truth and justice, and Jewish theological sciences in all their branches knew not a closer student, a more earnest investigator and a more successful author. His works were chiefly written in German, but he also wrote in

stone, every brick therein was laid under his personal supervision. It is absolutely the most beautiful Jewish temple in Europe, probably of the world.

On June last, at the occasion of the Loew centennial, the city of Ezege named one of the streets leading to the synagogue "Leopold Loew Street," the Right Honorable George Lazar, mayor of the city, a leading Catholic statesman of Hungary, delivering an eulogy on Loew and Loew's family on that occasion.

Leopold Loew has one son living in this city—he is the well-known lawyer and poet, Wm. N. Loew, author-translator of "Magyar Poetry," "Tragedy of Man," etc; an old contributor to our Hebrew Standard. Mrs. Rosalie Loew Whitney, the foremost woman lawyer of New York, is a granddaughter of Leopold Loew.

Jewish Doctors in the Middle Ages.

Outcasts as were the Jews in every European country during the whole period of the Middle Ages, there was always one profession in which they were recognized as equals, and in many cases the superiors, of their persecutors. That was the profession of medicine.

They did not, however, gain this position of equality without a struggle. It is true that the mass of people appear always to have reposed a peculiar confidence in the knowledge and skill of the Jewish doctor; but the practice of calling a physician belonging to the Chosen People was discouraged by the church, which regarded as any rapprochement between Jews and Christians as undesirable, if not actually dangerous. Again and again in the thirteenth and fourteenth centuries the French ecclesiastical councils forbade any Christian, under pain of excommunication, not only to consult a Hebrew practitioner, but even to take medicine prepared by them. The fulminations of very little effect. In the opinion of Dr. the church, however, seem to have had P. Pansier, of Avignon, who published in the July number of Janus an article of "Les Medecins Juifs a Avignon aux XI^{me}, XII^{me}, et XV^{me} Siecles," these fulminations were inspired not by fear of the spiritual dangers arising from contact between Christians and Jews, but by the dread lest the medical profession should degenerate into a happy hunting ground for members of the latter race.

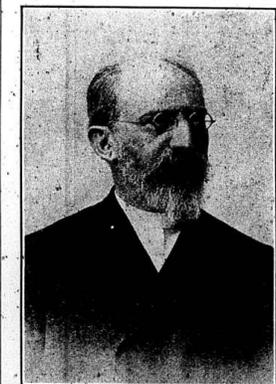
This was by no means a remote contingency, especially in the South of France, where the Jewish element in the profession was particularly strong in mediaeval times. From very early days a Jewish school of medicine had existed at Lunel, near Montpellier, and to use Dr. Pansier's expressive words, it had "flooded the south with its physicians." The Jews of the town of Aragon, the pope, where the faculty in certain cases, granted them a license (magister in medicina de Montepesulano). The extent of the popular faith in the Jews of Avignon may be measured by the fact that, notwithstanding the threat of excommunication, nearly all the great nobles went to them for advice in preference to Christian practitioners, some of them going so far as to appoint Jews as their household physicians. Even Alphonse de Poitiers, the brother of St. Louis of France, when suffering from eye trouble, did not hesitate to consult Hahybrum, a Jew of Aragon. The Jewish physicians became so numerous in the fourteenth century that the church was obliged to mitigate her laws concerning them. In 1341, at a synod held at Avignon, it was decided to raise the interdiction against them in consideration of the fact that "at the time when this prohibition was made there was a great number of Christian physicians; but they were unable to cure the sick, and the sick who wished to obey the laws of the church and refused to be treated by Jewish doctors were unable to obtain any medical aid at all." This declaration marked the commencement of the golden age of the Jews in Avignon, which lasted over a century. During that period even the convents went under the

care of children of the Ghetto; the convent of the Cordeliers, for instance, had as its medical attendant the Jew, Abraham de Carassonna, who received the princely salary of 4 florins a year. This same convent in the course of one century had four different doctors, of whom three were Jews.

Later the Jewish doctor played a prominent part in looking after the plague-stricken patients during the epidemic which raged at Avignon during the latter years of the fifteenth century. Curiously enough, however, those attached to the hospitals at this time were not so well paid as the Christian doctors, the latter sometimes receiving as much as 12 florins a month, while their Jewish colleagues only had 9 or even 6. It is at this period and with regard to a Jew that we have an interesting glimpse of the system of quarantine as it was practiced in the Middle Ages. One Leon Botarel had been engaged by the town authorities to treat sufferers from plague either in hospital or in their own homes; and besides the salary of 17½ crowns a month allotted him, and the fees he was allowed to take from rich patients, he was given free quarters in the Ghetto. It was not until the fifteenth century that the Christian Jew appears as a practicing medicine in Avignon, but even then there were still many countrymen who preserved the faith of their forefathers. The Jewish doctor had departed, however, and the opening of a new century witnessed a notable diminution both of their numbers and their importance, and in 1555 a Bull was issued by Pope Julius III, forbidding any physician in Avignon or in the Comtat Venaissin. Later, whoever wished to receive the degree of Doctor of Medicine was obliged to make a profession of Orthodoxy, and this explains the total disappearance of the Jewish practitioners of the seventeenth century. The reason of the Jewish physician's marked success in his profession is not far to see. In the thirteenth and fourteenth centuries he was far superior in every way to his Christian colleague. At a time when the line was very sharply drawn between physicians and surgeons, when the physician knew surgery, and the surgeon nothing of physics, the Jewish doctor had studied both and practiced both indiscriminately. Moreover, unlike the Christian physician of that period, he did not disdain to take the most smallest and most unpleasant details concerning the workings of the human body; and as a natural result the Jewish portion of the medical profession was of the whole, far the most efficient. Another point to be observed with regard to the Jewish doctors of that time is that they frequently came of medical families. In such a case the son learns his trade from his father; where this was not possible, the Jewish student was apprenticed to some practitioner of his own race.

Dr. Pansier quotes a fifteenth century contract which may serve as an example of the usual sort of agreement, made between master and pupil. It is dated June 25, 1472, and is drawn up between two Jewish surgeons, Messrs. Ferrussol and Jacob Leon de Cavillon, of Avignon, and their fellow countryman Antoine de Bale, by which the latter agrees to spend a year at their school, where he is to go through a course of medical literature, three books being specially mentioned. These are: (1) "The work known by the name of Lanfranc," (2) "Maitre Guy de Chauliac," (3) "The fourth part of Avicenna." The privileges the father of the young apprentice had to pay three golden crowns. One of the most interesting points of Dr. Pansier's article is his exposure of an old fallacy. It has been long believed that the Popes, during their exile at Avignon, had Jewish physicians in their service. This, as Dr. Pansier points out, was clearly impossible, since the Pope's doctor was likewise his chaplain, and nominated by a Papal Bull, which could not be accorded to any one outside the church. The only foundation for this belief appears to rest upon the fact that Pope XII had a Jewish attendant, Joshua Lurki, an Aragoese Jew; but it is apparently forgotten or not known that not only was this long after the Papacy had returned to Rome, but also that Lurki renounced his own faith and became a Catholic under the sonorous name of Hieronymus de Sancta Fide.—The British Medical Journal.

JUDAISM AND PATRIOTISM

The great task has been assigned to us of spreading truth and goodwill among all people. This holy mission brings with it a sense of great duty and responsibility, and we must first be true to ourselves in order to properly fulfill all of life's obligations. Therefore, I consider the main question that should concern all those interested in religious and social work among our people is the problem of arousing greater interest, enthusiasm and loyalty for Jewish ideals in the minds and hearts of the young.

While I believe we should always be optimistic, we must nevertheless recognize the fact that many of our youth are inclined to be indifferent and to treat lightly duties and responsibilities they will soon be called upon to assume. We must impress upon their minds that much of their future happiness and peace of mind depends upon their devotion to faith and that we cannot hope to command the esteem of our neighbors if we do not properly respect and uphold all that is truly Jewish. It was our own great Washington who said "Let us indulge with care the supposition that morality can be maintained without religion."

Let us frankly consider where part of the fault lies and how it might be remedied. My candid opinion is that in our synagogue life and in the religious work of many of our institutions there is a tendency to lay stress upon questions of ritual and ceremony and these often become the main issues instead of fundamental principles. In my limited experience it has always seemed to me as a cause for deep regret that so much energy should be frequently consumed over minor details and have often thought that if the same amount of spirit was directed towards the solution of important problems concerning our common welfare, how much more would be accomplished for the good of all. The great amount of feeling that is often aroused over questions of detail regarding religious observances might be compared to those thoughtless persons who show weakness of character by indulging in petty gossip concerning family affairs. They always seem to be eager to discuss the faults instead of recognizing the good qualities in others. They exaggerate the importance of trivial matters and instead of rising to a sense of their higher duties and the sacrifices that all should be glad to make for those near and dear to them, they frequently cause heartache and family discord by such narrow and selfish conduct. This applies to religion.

Much could be said and written of the great harm and little good that has been accomplished as the result of argument concerning details of religious observance and neglect to emphasize the fact that it is deed and not creed—not what we profess, but what we practice that is the true test of our worth and merit. The stress that is often laid upon questions of minor importance and concerning which we may honestly differ, has often been the means of causing many to drift away from the fold who might otherwise have become valuable and enthusiastic workers for the cause of Judaism. It has, therefore, been truly said "Religious contention is the devil's harvest."

True religion requires that we should be broad-minded and tolerant, and not argue over questions which should in most cases be left to the good sense of the individual. Is it not much better to work together in a brotherly way and be at all times

willing to make the necessary sacrifices in order to attain the higher and nobler aims of our religious life?

When I speak of Judaism and patriotism I express my firm belief that living as we do in this glorious land of promise, enjoying all the blessings of our beloved country as well as opportunities and privileges denied to so many of our people born in foreign lands, we should show our gratitude by striving, in union and harmony, to uphold and maintain the principles of our faith.

This is the largest Jewish center in the world. The number of our people in New York is rapidly approaching a million. We must recognize the fact that whether we are living uptown or downtown, the Bronx or Brooklyn, no matter whether our tendency be towards orthodoxy or reform, we must be united and work hand in hand when it comes to carrying out the ideals and fundamental principles of our religion. These principles may be summarized as charity, and philanthropy; how to best Americanize our brethren, who seek refuge and protection under the stars and stripes from foreign persecution; to help properly distribute them throughout the country and thus avoid the evils of congestion. The Jewish Big Brother Movement which takes care of our delinquent boys should receive our best thought and co-operation. Another important problem is to provide proper and modern religious instruction for the young so that they may grow up an honor to themselves, their country and their race. We must also consider the best method of arranging religious instruction so as to properly train the children of our poor and that our Christian neighbors should not feel called upon to perform the duties which are neglected by us. We frequently become indignant at the work of missionaries. Let us not forget that this is done for the love of humanity, and if we properly train our young people they can no longer regard it as a necessity.

The establishment of centers where our boys and girls may meet under Jewish influence for healthy recreation and thus offset the demoralizing influence of the streets, low grade theatres and dance halls should receive serious thought. How important it is for all of us to labor unselfishly to fulfill the duties that lie before us. Not long ago the annual meeting of the Jewish Protectorate was held. Mr. Mortimer L. Schiff, the president, stated in his report that the directors recognize the necessity of taking steps to care for Jewish delinquent girls in addition to the boys now entrusted to their care, but that the means of the institution would not permit them to undertake this important task at the present time. What greater argument could be advanced for the value of preventive work.

It is interesting to observe what our Christian neighbors are doing in this direction and how they meet similar problems. Many years ago the Y. M. C. A. was organized as a religious institution. They realized that an organization was needed to uphold the fundamental principles of their faith and which would not emphasize the details of religious observances, but spare no effort to

rouse enthusiasm and loyalty for Christianity. This was followed by the Y. W. C. A. which works along similar lines. What has been accomplished in this direction is unnecessary to dwell upon, for the influence for good of these institutions is well known. Not long ago we read in the papers of the large sum of \$400,000 raised in Brooklyn for the Y. W. C. A. The interest and enthusiasm displayed in that undertaking commands our esteem and admiration. That great organization known as the Salvation Army is also doing a tremendous amount of good work among the poor and wayward, so we see that our Christian neighbors are in a practical and united way working for the solution of their ideals, and to meet with similar success we must have harmonious co-operation among all classes of our people.

Not long ago a series of meetings were held under the auspices of church leaders representing various denominations for the purpose of discussing questions in which all are interested. One of the speakers stated that the time has come when all should be glad to emphasize the many questions of common interest rather than those regarding which we differ. How truly this may be applied to our Jewish people. Institutions such as the Y. M. H. A., the Y. W. H. A., the Educational Alliance and the Emanu-El Brotherhood have a great mission to perform, for our hope is centered in the young. Religious services such as we hold here weekly must prove beneficial. Those who have the work at heart must always be imbued with the thought that it is not a question of how orthodox they should be, or how reform, but how truly Jewish in tone and character. Let us profit, week by week, from the inspiration they afford. As we listen to the beautiful prayers sung and recited

Following an annual custom, the Cleveland, O., Stock Exchange, was closed on Yom Kippur.

Rabbi A. J. Messing has received a call to the Moses Montefiore Temple, Bloomington, Ill.

Rabbi Martin Meyer, of San Francisco, Cal., has resigned the editorship of Emanu-El.

Rabbi Louis Hurwich has taken charge of the United Hebrew Congregation of Indianapolis, Ind.

The death is reported of Sigmund Fischel, a well-known communal worker of Montreal, Can.

The capital of the Trust Fund of Gratz College, of Philadelphia, Pa., now amounts to \$203,123.

A symphony orchestra has been formed by the Young Women's Union of Philadelphia, Pa.

Hertz Heller, a prominent member of the New Orleans, La., Cotton Exchange, died last month, aged 84.

An effort is being made to bring about a unification of the several Scheectia Societies in Glasgow, Scotland.

Mr. Henry F. Barnett has been returned unopposed on the Municipal Council of St. Kilda, Melbourne.

The Beth Hamedrash Hagodal Congregation of Glasgow, Scotland, dedicated a new synagogue on the 23rd ult.

Mr. Albert M. Steinert, of Providence, has received the Democratic nomination for State Treasurer of Rhode Island.

The old Hebrew Infant Asylum building on Eagle avenue, this city, will soon be turned into a home for Greek children.

The Associated Young Men's Hebrew Associations of New England will hold a convention at Boston, Mass., on December 24.

Dr. Edward Pisko has been appointed professor of Dermatology at Fordham University, a Catholic institution of this city.

Rev. M. Samfield, of Memphis, Tenn., has been appointed a director of the Hebrew Immigrant and Aid Society, of this city.

A Ladies' Society has been formed in Utica, N. Y., to collect funds for the institution of a modern Hebrew Free School.

Hebrews of Portsmouth, N. H., are formulating plans for the erection of a synagogue on the south side of Newton avenue.

Rev. Dr. J. B. Menkes, formerly of Jacksonville, Fla., is now in charge of the Beth Zion Congregation, at Bradford, Pa.

Theodore Roosevelt announces that he will have an article on "The Passport Question" in a forthcoming number of The Outlook.

The members of the Kesher Israel and Chisuk Ebnuah Congregations of Harrisburg, Pa., are endeavoring to effect an amalgamation.

Martin Beir, of Zerubbabel Lodge, I. O. O. F., of Rochester, N. Y., recently celebrated his fifty-fifth anniversary as a member of the order.

The current number of the Atlantic Monthly has the first installment of a series by Mary Antin describing life in the Pale of Settlement.

A Christian resident of Hull, England, has been fined by the local magistrates for turning a hose on the synagogue during divine worship.

Plans for the erection of a big school building to cost \$75,000 are being made by the Montefiore Jewish School Association of Chicago, Ill.

A moving picture corporation has been organized in this city to present scenes of Jewish interest, and a company of Jewish actors has been specially engaged for the work.

The death announcements in the columns of the last issue of the Jewish Chronicle show a remarkable average longevity. The announcements of thirteen deaths in which the age is given show a total in ages of 945 years, or an average of over 72 years 6 months.

An attempt is being made to establish a Hebrew Free Loan Association in Los Angeles, Cal., in connection with the Hebrew Benevolent Society.

The Congregation Beth Israel of Syracuse, N. Y., has purchased a lot on Grape street, which they will improve with a handsome synagogue.

The members of the Congregation Ohav Shalom, of Brooklyn, at a recent service subscribed the sum of \$1,000 towards the Hebrew Ladies Day Nursery.

Widespread Jewish resentment is being felt in Russia at the assassination of M. Stolypin, memorial services having been held in all the synagogues.

The tenth annual report of the Chicago, Ill., Jewish Charities shows an income last year of \$309,507.52. Of this sum \$32,700 was applied for relief.

A committee of the Philadelphia, Pa., Y. M. H. A. is at work endeavoring to raise \$60,000 with which to erect a new addition to the present building.

"The Jidischer Literaten Club" has been formed in this city for the purpose of raising the tone of Yiddish literature, mutual aid, and sociability.

A theatre, devoted entirely to Yiddish plays, is planned by Louis Friedland, for Minneapolis, Minn. The building will cost \$75,000, and seat 1,000.

M. Margolin has contributed a large sum towards the cost of endowing beds in the Kieff Jewish Hospital in memory of the dead Premier Stolypin.

Benjamin A. Banks, of Norfolk, has been elected a member of the Virginia State Legislature. Mr. Banks is the first Jew to be a member of that body.

To appropriately celebrate her eighty-first birthday, the members of the Jewish Foster Home of Philadelphia, Pa., observed last Sunday as "Esther Baum Day."

The Congregation Agudath Ashkenazim, of Cambridge, Mass., which has been worshipping in a hall for the past six years, has decided to erect a synagogue.

The Minister's Association of Malden, Mass., recently passed a resolution strongly condemning the recent outrages upon Jews while observing the ceremony of Tashlich.

The Cincinnati Club, a Jewish social organization of Cincinnati, O., finds its membership dwindling away, and will most likely have to close its doors in the very near future.

The Pacific Hebrew Orphan Asylum, of San Francisco, Cal., is inadequate to the needs of the institution, and the directors are planning for a new building and a new site.

Rabbi Isidore Meyers, of Los Angeles, Cal., who has held the same office for many years, is contemplating going upon the stage with an act upon the same lines as that of Elbert Hubbard.

A number of Jews have been nominated for the Massachusetts State Legislature, among them being A. M. Burroughs, Isaac Gordon, William Berwin and Edward A. Cohen.

Congregation Beth-El, one of the most prominent congregations on the northwest side of Chicago, Ill., will celebrate its fortieth anniversary Sunday with a banquet next Sunday night.

The Pennsylvania Women's Press Association will hold their next meeting in Philadelphia, Pa., and will devote the afternoon of October 19 to the memory of the late Mary M. Cohen.

Dr. Sigismund Sonnenfeld, of Paris, France, director of the Jewish Colonization Association since its establishment, has just resigned his office, and will henceforth reside in Buda-Pesth.

Dr. Morris Jastrow, Jr., of Philadelphia, Pa., announces the completion of his work "The Religions of Babylon and Assyria," upon which he has been engaged for the past nine years.

A reception was recently tendered to Abraham Meyers, of Helena, Ark., on the occasion of his seventieth birthday. Mr. Meyers was at one time Mayor of Helena and is at present city treasurer.

A number of Jewish citizens of Toronto, Ont., have petitioned the local School Board for the use of rooms in public schools to teach children Yiddish. The petitioners offer to supply competent teachers.

At the suggestion of the trustees of the Barnato, bequest, a kosher kitchen has been arranged at the new cancer wing of the Middlesex Hospital at London. Dr. Michael Adler, visitor at the hospital, has now obtained the consent of the authorities for the use of the kitchen by all Jewish inmates of the general hospital also.

Benjamin Marshall, a prominent business man of Syracuse, N. Y., died on the 4th inst. in his home, in the fifty-third year of his age. Mr. Marshall was a brother of Louis Marshall, the well-known lawyer.

Julius Harburger has been nominated for Sheriff by the Democrats of New York County. The term of office is for two years. This is the richest office in the county and the fees average over \$50,000 per annum.

The unopposed return of Mr. Joe Cohen to the Leeds (England) Board of Guardians is a unique event in the social history of the community, as it is the first time a colorist has been elected to that body.

The Council of the community in Berlin at its meeting last week, voted 5,000 marks from the treasury towards the relief of the sufferers by the recent fire at Balata (Constantinople), which affected 1,000 Jewish families.

Mr. Henry Solomon, president of the State Commission of Prisons, has been appointed by Governor Dix a delegate to represent the State of New York at the National Prison Congress, to be held in Omaha, October 14-19.

A correspondent of a Berlin, Germany, news bureau, telegraphing from Dehabit, in the Tunisian frontier, under date of the 6th inst., says that six Jews were killed and one Jew wounded during the bombardment of Tripoli.

The synagogue at Pirmasens, Germany, had to be closed recently for repairs, and Herr Strobel, the Chief Burgomaster, allowed the congregation the use of the Municipal Council Chamber for the holding of services.

A mass meeting will be held at the Rodeph Shalom Synagogue, Pittsburgh, Pa., on the 30th inst., for the purpose of passing resolutions favoring the treaty of peace and arbitration between England and the United States.

With the appointment of the renowned young mathematician, Leopold Fijer, as ordinary professor of higher mathematics, the number of Jewish ordinary professors at the University of Buda-Pesth has been raised to five.

Plans have been filed with the Department of Buildings of this city for the erection of a new building for Rabbi Jacob Joseph, at No. 167 Henry street. The building will be five stories high, and will occupy a plot 43.6 by 65 feet.

Col. Charles H. Lauchheimer, of the United States Marine Corps, who for several years has been in charge of the Philippine Inspection District, with headquarters at Manila, has been relieved of that duty and ordered to San Francisco.

Messrs. Jacob H. Schiff, Isaac N. Seligman and Abraham I. Elkus are members of a committee appointed by Governor Dix to represent the New York State at the fourth convention of the Atlantic Deeper Waterways convention, to be held in Richmond, Va., October 17-20.

The Tsar has received another Jewish deputation at Tchernigoff, which included Rabbis Cheln and Schneersohn. The usual address of loyalty was presented, it being, of course, a permanent one, and it is to be noted that no mention was made of any matter affecting our co-religionists.

A Russian correspondent of the Jewish Chronicle discusses the situation that has arisen in consequence of the death of M. Stolypin, and expresses the opinion that the policy of the new Prime Minister is not so likely to be a new one as a mitigation of that pursued by his predecessor.

Rabbi M. M. Elchler, of Boston, Mass., is in charge of the Congregation Ohabei Shalom in seeking new quarters, the building which they have occupied on Union Park street for over a quarter of a century was at one time the Second United Hebrew Church, where the late Rev. Edward Everett Hale preached.

Organization to Urge Passport Legislation. Organizers of the National Citizens' Committee met on Tuesday at the Waldorf-Astoria and elected officers and an executive committee in a campaign they propose to bring to influence Russia to cease discriminating against American passports held by Jews.

William G. McAadoo presided and there were speeches from Edward Leach, William S. Bennett, Mr. McAadoo and Congressman Goldfogle.

The executive committee, of which Mr. McAadoo is chairman, is to meet soon to plan a course of action on the executive committee are Edward Leach, James Creelman, Andrew D. White, Allan Robinson, William J. Schiefelin, John Halen, Herman Ridger, Lee Kohus is chairman of the finance committee, on which are also William J. Schiefelin, Cleveland H. Dodge and Lucien C. Warner.

George W. Wilson, Judson B. Harmon and Bolese Pearson, and Speaker Champ Clark, who sent letters of indorsement of the movement, are of the advisory committee.

An arrangement has just been concluded between the New York Jewish Committee of the Deaf and the New York Institution for the Instruction of the Deaf and Dumb at 1634 street and Fort Washington avenue, whereby about half religious instruction will be given to the Jewish pupils who are sufficiently advanced in the study of language to be capable of benefiting by such instruction. There are over 100 pupils in this institution who have hitherto been entirely under Christian influence. Classes will be organized immediately by Dr. Barnett A. Elzas, Minister to the Jewish Deaf who will be assisted by competent teachers. Arrangements have been made with the Congregation B'nai Israel, of Washington Heights, who generously placed their synagogue at the disposal of Dr. Elzas for the work after listening to an address by him during the services last Sunday morning.

Interesting talks on the festival were given in the Succah by Dr. Mordecai M. Kaplan, Rev. H. Maslansky and Mr. Aaron Robinson.

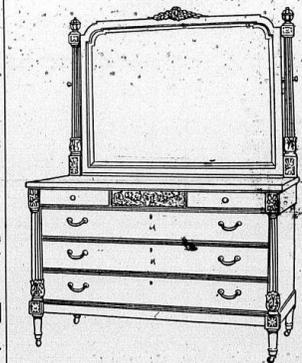

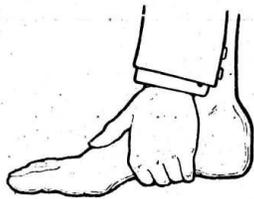

each week, let it inspire us with new hope, faith and courage.

We have unfortunately many thoughtless Jews who tell us that they are proud of their religion; they however claim to be unable to keep the same throughout the year, but always strictly observe the two days of the New Year and the Day of Atonement. What would we think of one who says, "I am proud of being an American citizen and show my patriotism by keeping the national holidays and also sing patriotic airs at their celebration." True patriotism demands of us that we should be patriotic every day in the year by doing everything in our power to help the cause of good government. So it is in religion. Every day we should regard as the beginning of a new year, for the Almighty blesses us each day with new strength, vigor and ambition. Every day likewise should be regarded as an atonement day. If we have done any wrong there is no time like the present to atone for same. This great holy day is also known as the Day of Memorial. Should we not regard every day as a memorial day? Life is uncertain and we have no lease upon it. Emerson said: "No man lives correctly unless he regards every day as the best day in the year and recognizes the fact that each day is doomsday." Some of our people tell us that they do not believe in Judaism and are ethical culturists. Ethical culture is, indeed, a fine thing; it is one of the pillars of our faith. Why, therefore, should we be willing to sacrifice our religion for what is only one of the branches of the tree? Matthew Arnold said: "Religion is ethics heightened and enkindled by emotion." It was a bright mind who said: "Modern literature is ablaze with beauty and with power, and yet millions are still going to-night to one old and thumb-worn text for their final consolation." When plunged in grief through family bereavement which comes to all of us sooner or later, we often find those who have been indifferent to their religious duties seek comfort in the synagogue. Does this not seem like slighting a good friend and coming to that friend only in time of need to get sympathy and consolation? Let us not fail to build 'spiritual dwelling-places' in our hearts, so that we may seek refuge in time of need from these piercing storms of life. We need only turn to one chapter of the Bible for an example of the best ethics and uplifting thought—the Twenty-ninth chapter of the Book of Job, in which we read: "I took righteousness as my garment and it clothed me; as a robe was justice unto me. I delivered the poor and the fatherless, yea,

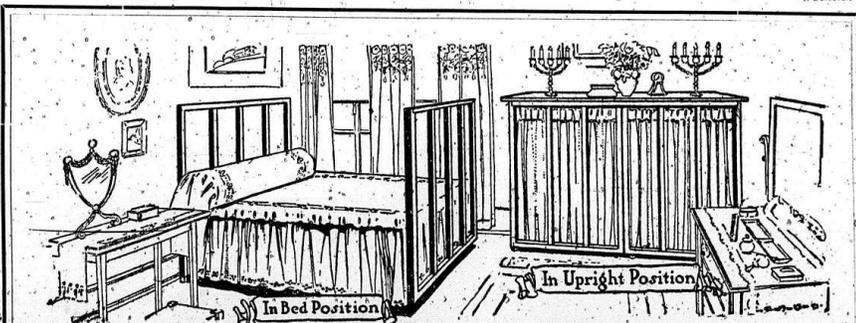

NEWS FROM ENGLAND.

(Exclusive Correspondence to THE HEBREW STANDARD.)

The New Year—Welsh Rabbi on Local Anti-Semitic Outbreak—Interesting Zionist Book—Berlin Jewish Charities—Helping Towards Better Sabbath Observance.

London, September 29, 1911.

The New Year fervor has been as strongly marked this year as ever, and the important days that have recently passed must have represented an epoch in many a life. Everywhere the old saying, "All Israel are brethren," was invested with a deep significance. For real intensity of fervor one had to visit those temporary places of worship where large numbers of the foreign Jewish population celebrated the New Year. To many thousands of their number, victims of oppression and repression in other lands, the New Year celebrations were fraught with an added significance, for the fate of certain of their Russian coreligionists seemed to be trembling in the balance.

In the East End the extraordinarily large number of foreign women who take part in the service is usually a matter of common knowledge. To all appearance their fervor is far deeper than that of some of the male worshippers.

The special services for Jewish children, for which the halls of certain council schools were requisitioned, had a charm peculiarly their own. Games conducted upon lines calculated to appeal to the imagination of the very young.

In the synagogues of the Sephardim Rosh Hashana was ushered in with the same customs, as when the synagogue was established in 1701. This very old synagogue in Bevis Marks has managed to hand down, without a change, the hauntingly beautiful New Year melodies that have been sung ever since the days of the resettlement. Much of the glory of the place of worship has departed. The wealthy Sephardic merchants who lived in and around the city have gone to their rest. Great warehouses have sprung up where once were private residences. But the Portuguese liturgy remains unchanged, and although the congregation represented only a handful of the community, the former days, the New Year services in this fine old synagogue were something to be remembered.

The adjacent great synagogue missed the genial presence of the late Chief Rabbi, while the sweet voice of its cantor, the late Rev. Marcus Hast, has been stilled by death—a double loss for London's cathedral synagogue, white-draped as of yore.

Preaching at Cardiff synagogue on the occasion of the Jewish year, the Rev. H. Jerevitch referred to the recent rioting in South Wales, and said that they were not justified in attributing the outbreak to anti-Semitism. It is estimated in Berlin that there will be a heavy call upon the resources of the wealthier members of the Jewish community in the coming winter. To meet all necessitous cases the leaders of the community have prepared a rather heavy budget, which provides for philanthropic and social purposes, and, in addition, for an expenditure of 912,505 marks for religious purposes.

Of the several schemes that have been promoted from time to time by Orthodox Jews with the avowed object of aiding the Jewish working man in the proper observance of the Sabbath, the most successful is that of the Sabbath Observance Employment Bureau, which was called into existence two years ago. The bureau considering the difficulties that it necessarily encounters, has done a great deal already in the way of facilitating the employment of Sabbath-observing work people by Sabbath-observing employers.

The bureau has established the fact that, in spite of the widespread desertion of the Sabbath, there is still a considerable residuum of Jews and Jewesses anxious to adhere to the ancestral ordinance. It has also discovered that there are a large number of Jewish employers willing to employ them, provided they are not required to work on Saturdays. On the other hand, there are applications from Jewish employers who are ready to grant facilities to work people of different trades.

One rabbi-editor less in this country! Rabbi Martin A. Meyer, of San Francisco, has nothing more to do with *Emanu-El*.

The *Globe*, of this city, states that many of the Jews of England are sufferers from "smoker's heart." This, in addition to internal communal dissensions, South Wales and Bethnal Green!

Bishop Frederick Burgess, of the Episcopal Diocese of Long Island, seems to be a very liberal prelate in his views on the Sunday law. He believes our existing laws on the subject are ample, more than ample in fact, when one remembers that there are so many Jews in the Greater City of New York. If the law be fairly and impartially enforced the question of aviation meets on Sunday would never arise. For, the law is, and should be, the same for Timothy L. Woodruff, erstwhile Lieutenant-Governor of the State of New York, as it is for the poorest Jewish peddler on Hester street.

Die Welt, the international Zionist weekly, begins with its issue of September 29 the publication of what promises to be an important series of "Letters from Russia." In the first of these the writer declares that most Jews of the Occident are literally unable to judge of the abject condition and misery of the Jews under the rule of the Czar, because the entire field of Russian politics is to them *terra incognita*. The picture he draws of Russian political life is indeed distressing; the Jew is the scapegoat of all the various parties and hatred of him has increased in the last few years rather than diminished.

In Bohemia the perpetual quarrels between Teutons and Czechs are about to be ended by means of a protocol, the purpose of which is to define with much circumstance the rights, privileges and immunities of each of the two "nations." Then, like the two universities of Prague, the German and the Bohemian, they will dwell together in peace and contentment, and the era of "justiciableness" will have begun for the country. But, it is a pertinent question, in what camp will the Jews be found? Whose leadership will they follow? Teutons or Czechs? The Jews of Bohemia are on the horns of a dilemma, dire in its portent and consequences for them.

The *Jewish Ledger*, of New Orleans, ought to know better! It speaks of the solemn ceremonial feast on last Maundy Thursday of the Chapter of Rose Croix, of this city, as "one of the most inspiring and important Masonic events in the whole world!" In the first place, the Rose Croix Division of the Ancient Accepted Scottish Rite of Freemasonry is boldly Christological; therefore, not a part of symbolic Masonry, which is non-sectarian. In the second place, the Rose Croix makes it its mission to inculcate in its devotees, "I give ye a new law, That ye love one another." Moreover, it seeks to teach that God is Light and Life and Love, which is obviously Christian in sentiment. While we unreservedly praise Hon. Simon Wolf's address on "Are We Not All Brethren?" at the solemn feast referred to, our Southern contemporary literally overshoots the mark in hailing the Rose Croix celebration as a Masonic festival. Parenthetically, we are glad to observe that Mr. Wolf, as usual, on this occasion was proud of his Jewish affiliations and took advantage of his opportunity to preach true toleration to his non-Jewish brethren.

CHILDREN AND THE HOLYDAYS.

WE have heretofore commended the action of the "great and glorious" Kehillah in establishing provisional synagogues for children, for the proper observance by them of our high holidays. When houses of worship, both permanent and temporary, are at this season crowded to the doors by the brethren of the House of Israel, the question naturally presents itself, What are we doing, what can we do to hold the coming generation, our children, to Judaism? Must we not see to it that they are made to feel themselves part of our community, that for them prayer and praise are as necessary as for their elders?

Here and there, throughout the length and breadth of our land, an earnest attempt is being made to satisfactorily answer this question, to do our full duty by our little ones, the true Hope of Israel. The "great and glorious" Kehillah's action is one instance of this. Another is furnished by the conservative congregation in Pittsburgh, to which Rabbi Rudolph I. Coffee ministers. There, on Yom Kippur, during the long repetition of the *Mussaf*, Rabbi Coffee caused all the children of his congregation to assemble together in a room adjoining the synagogue. He led them in prayer, read the book of the prophet Jonah to them and delivered a brief lecture. The experiment was, as indeed it must be wherever tried, an unqualified success.

We mention Rabbi Coffee's children's service thus in detail, because we believe his experiment can and should be emulated by every other Jewish congregation in this country. If the rabbi's presence at the main service be the *sine qua non*, an active and devoted member of the congregation (even if he be only a volunteer, or the principal of, or a teacher in the religious school), could well be depended upon to conduct such a children's service as this. Its value and importance are patent and the necessity for the service is also perfectly apparent.

The recent growth of interest in our children by the leaders of our congregations is a hopeful sign for the religious future of Judaism in America. We fancy the time not to be far distant when every congregation in this country will have made adequate provision for the holding of children's services, concurrently with or supplementary to its main services, not only on the holidays, but on every Sabbath in the year.

The Hebrew schools in the Holy Land, by which we mean those institutions for elementary education conducted in the language of Sacred Writ, are fostering dramatic performances in Hebrew by their pupils. We welcome this as additional proof that to them Hebrew is indeed a living tongue.

Jacob H. Schiff has added another to his many benefactions to the cause of Jewish education in this country, and his newest is perhaps the best opportunity he has embraced to bring this matter home to every man, woman and child of our community. We have heard so much about the "existence" of a Hebrew-less Judaism (to quote the wise Dr. Benderly) and the necessity that bears on us to deal rightly by our rising generation, that Mr. Schiff's endowment of a correspondence school for religious teachers comes as a fitting climax to the agitation for devoted and scholarly religious teachers among the Jews. By means of a correspondence school the religious teacher in even the smallest *kehillah* in the "wild and woolly" West will have the chance to keep himself in touch with the latest phases of Jewish religious thought and the most approved pedagogical ideas of the newest age. Mr. Schiff's donation to the Chautauqua comes at the psychological moment; let that body make good use of it.

A young man, Raphael P. Goldstein by name, writes from Portland, Oregon, to *The American Israelite* in explanation of his desire to be a reform rabbi. He, the son of an orthodox rabbi, paints a most unfair and distorted picture of orthodox rabbinical conditions and traditions, and then indulges in the following transport of delight over the reform rabbi. The reform rabbi, says Mr. Goldstein, "is a live wire in all church affairs and a living spirit in the entire conduct of his congregation. He teaches the adults the word of God in a manner to win their respect and very often they fairly idolize him. He keeps in touch with the younger element of his congregation and trains the Jewish children to love their religion, their history and their God. If he has any ability at all he often becomes an important factor even outside the walls of his temple (!) and his useful activity is soon felt throughout the entire city, State and country." Characteristically enough, amid all this verbiage of praise, Mr. Goldstein has neglected to say that his reform rabbi is a Jew, an important consideration; surely the most important consideration, after all. For, we fancy we are correct in assuming that where a congregation can secure the ministrations of one who is, as Mr. Goldstein would have him, Edisons lineman, idol, actor and politician all at once, but who is not a Jew, the congregation, if it wishes to retain its standing as a Jewish congregation, will hardly avail itself of his services.

THE REJOICING OF THE LAW.

שש אנכי על-אמרתך כמוצא שלל רב

"I rejoice at thy word as one that findeth great spoil." (Ps. 119:162).

IT is one of the well-worn phrases of sermonizers that Judaism is a religion of joy. Like all catch-phrases, this one, too, presents some aspect of our faith—in a manner, however, which may cause confusion. For, the real sense of the phrase is a religion which considers joy in itself a supreme good: a purely hedonistic religion. Such a religion was—paganism. Judaism, as a matter of fact, does not teach so much the religion of joy as—the joy of religion! Judaism is not the cult of love, but the love of cult. Judaism is not the service of pleasure, but the pleasure of service.

True, the Succoth holiday might give rise to errors as to the place material pleasure holds in the economy of Judaism: Essentially a nature-festival, it might be ranked with similar festivals of joyful thanksgiving celebrated at harvest-tide by the Greeks and other pagan nations. But recently I had occasion to quote in this column a Midrash in which a heathen draws a parallel between pagan festivals and Jewish holidays—Succoth being among the latter. Similarly, modern comparative theologians are inclined to believe that there is no difference between any of these nature or harvest festivals, whether they belong to the life of polytheistic or monotheistic peoples. But we know that in Judaism material blessings, while considered blessings emanating from the rich store-house of God's bounty, are but means toward higher ends. Judaism refines and elevates the gratification of the flesh and brings it under the sovereignty of the spirit.

Be this as it may, if Succoth is apt to inspire erroneous notions regarding the estimate our religion places upon the pleasures of life, it is Succoth again which corrects such notions. For Succoth, the nature-festival, Succoth the festival of joy and gladness, Succoth the festival of the clement sky and the fertile earth, ends in a wonderfully contrived climax—in the rejoicing of the Law! The contrivance is unconscious—a contradiction in terms, to be sure, yet perfectly intelligible when we consider that the national genius of the Jew has always kept working silently at the loom of Jewish life weaving its brightest threads in the depths of the best minds and tenderest hearts. Theologians call this work of secret contrivance—revelation. I call it—*The Consciousness of the Unconscious!* That marvelous religious instinct which is and always was the Jew's chief virtue has produced coincidences and juxtapositions which are certainly not the work of a mind seeking to adapt means to ends in a conscious way, which yet forth such an organic part of a consistent spiritual plan that there is but one conclusion left us: namely, that there is a sort of unconsciously conscious principle at work in the soul of the Jew—a sort of soul-of-soul, a Jewish over-soul, which presides over the life of our race, beautifying and enriching it, without our individual ken, with a subtle art all its own.

This is no digression by any means. The rejoicing of the Law, coming as it does at the fag-end of the Succoth holiday, is a case in point. One might easily ascribe this juxtaposition of Succoth and Simchath Torah to peculiarities of the lunar calendar; but to my mind, we are confronted here with a striking manifestation of the secretly contriving Jewish over-soul. The Succoth holiday (as already said) being given over largely to material joy and the feeling of gratitude springing from this source, and being—on that account—open to hedonistic misinterpretation, gives way to—nay, ends in—a day devoted to a higher kind of joy: joy at the word of God, and to a higher kind of gratitude: gratitude for the spiritual harvest which God has granted us through His sacred Law!

Thus, the Succoth holiday corrects the errors it might give rise to by teaching us the effective lesson that we must rise from mere material gratification to the life spiritual. There may be those who rejoice in the "finding of great spoils," in the accumulation of wealth; but we must be different. Our joys must be spiritual joys. Our spoils must be spiritual spoils. Our spirit must be capable of rising to those heights of unalloyed soul-delight, where a truth found, a truth deeply felt, a truth fashioned in the furnace of one's inmost being, fills the heart with a happiness which cannot be told in human speech, which can but be understood by the saint, the seer, and by—God! On those heights alone can human life be lived as it should. On those heights alone can there be an intimate communion with God in thought, in feeling, in action. On those heights the unuttered and unutterable Word of God speaks to man in clear accents. On those heights prayer is its own answer, worship its own acceptance, and every deed its own reward. On those heights the joy of religion, the love of cult, the pleasure of service, find devotees in men and women who, as when man was first created, walk hand in hand with their Creator under the life-giving trees of Paradise. What he there says is marked by sanity and logical clarity, and when he declares that the time has come when the neglected Jewish neighborhood, in which a Jewish settlement is located, must be protected from the corrupting organized political agencies, we are in substantial agreement with him. A Jewish settlement does not by any means take sides in political contests; if it seeks diligently to prevent the Jewish vote of its district from being exploited for the benefit of interested individuals, who very often are at the head of the local "Hebrew" political club. Work of this nature forms part of the educational curriculum of a Jewish settlement, and therefore needs to be done.

The Banquet to Julius Harburger.

The dinner given by more than five hundred admirers of the Hon. Julius Harburger, in appreciation of his services rendered to the Democratic party, is, as Mr. Thomas F. Smith, secretary of Tammany Hall, said, something unique in the history of New York politics. As Mr. Smith well said, responding to a toast: "I have seen banquets given to men who were elected and inducted into office, and in honor of various occasions, but this is the first time in my experience that I have heard of or attended a banquet given to a district leader retiring from the leadership, and with so many of his predecessors in office present to do him honor." It was truly a unique affair, as Mr. Smith remarks, but Julius Harburger, be it known, is a unique character in politics. Of sterling worth and unimpeachable integrity, he has enjoyed a political career, unsullied and without a stain. This is recognized by all who know him. And all those present at the banquet, comprehending many of our judges, lawyers and prominent

business men, were outspoken in their tributes to the character of "Julius." In a district of such a heterogeneous character as the "Tenth," Mr. Harburger held the leadership for nearly fourteen years, something unprecedented. Mr. Harburger in retiring from the leadership does not retire from active participation in political affairs. His reputation as a political factor is not confined to any one district, but is generally respected throughout the city, and elsewhere. He is probably the best known and most highly respected official in public life by the whole body of our co-religionists, and we feel that there will be higher honors still coming his way.

[Since the above was written Mr. Harburger has been nominated by the Democracy of New York County for the office of Sheriff.]

The rumor that Rabbi Israel Levi, of Paris, is about to be chosen as the successor of the late Dr. Hermann Adler in the English Chief Rabbinate is interesting, if nothing else. As a rumor it is entitled to the barest momentary credence, and to nothing more. It were hardly possible that the Council of the United Synagogue, of London, so soon after the conclusion of the summer vacation, had united upon a *foreign* rabbi as competent to fill the difficult post of rabbi of the United Synagogue, and thus as Chief Rabbi of the United Hebrew Congregations of the British Empire. For, the Council will surely delay selecting the new Chief Rabbi until an opportunity, no matter how insufficient and merely formal, has been given the small eligible "home talent" to display its fitness to represent the Anglo-Jewish community before the British public. That Rabbi Levi is well qualified for Dr. Adler's office goes without saying, and his orthodoxy seems to be beyond all cavil. But it is altogether too premature for rumors of the success of this or that distinguished Jewish minister in the matter of the English Chief Rabbinate to be more than simple rumors, zephyrs of the thinnest gauze.

Rabbi Emil G. Hirsch, of Chicago, has taken the Union of American Hebrew Congregations under his protecting wing, and calls attention to what seems to be an unpardonable omission from the calendar of events in the current American Jewish Year Book. To us the omission seems to have been the result of a pure oversight, although we confess that the failure to chronicle the holding of the twenty-second council of the union here last January is not calculated to enhance the popularity of those responsible for the Year Book with certain portions of the community. After all, Rabbi Hirsch's strictures must be regarded as well taken. In the compilation of an annual summary of events in the Jewish world, bias and partiality should not be permitted to play a part. Allowance must of course be made for the defects in the personal equation, but the current Year Book is open to the criticism passed upon it.

those who had none to help them, and I caused the heart of the widow to sing for joy. Eyes was I to the blind and feet to the lame was I." Let us strive to profit by these thoughts and always remember that it is not the cold letter of the law, but the spirit of it that warms the heart. True religion points to a goal (the higher and better life), and our conscience is the compass. It is not a matter of serious concern the exact route we travel in order to reach that goal. Suffice it to know that it can only be gained by traveling through paths of truth, honor and integrity.

Let me conclude by quoting the beautiful words of great Lessing, the German scholar, which sums up all that I have tried to express: "If the religion in which you have been raised is the religion of your fathers, think always that it is the best religion, and to give the world the proof that it really is the best, act kindly to others, be modest and unassuming in your demeanor, assist the helpless and needy, further the progress of education and enlightenment, advo-

JEWES AND SCIENCE.

By B. HOROWITZ.

Fourth Series—No. 8—Moritz Schiff

Moritz Schiff belongs to the most noted of those physiologists who in the second half of the Nineteenth Century placed physiology as an experimental basis for all work in medicine. For a long time his name was not as well known as it should have been. Through an act of injustice of the German government he quit Germany to live first in Switzerland and then in Italy. As a result most of his researches appeared in either French or Italian. Now as it had been the custom to look upon the Germans as the great leaders in medicine, and to more or less ignore contributions from men of other nationalities, it was a long time before the world at large took note of Schiff.

Another reason for his failure to gain popularity was due to the fact that he attacked problems in physiology along totally new lines. At one time all biological phenomena were explained by the view that there exists a special vital force essentially different in nature from such manifestations of energy as heat, electricity or chemical action. Schiff showed that this view cannot be upheld. Vital phenomena are to be explained only on those mechanical principles which apply to the inorganic world, but, of course, are rendered more complex by the special activities of protoplasm. Schiff indeed belonged to the physico-chemical school of physiology—to the school in which Helmholtz and Bois-Reymond were pioneers, and whose most brilliant exponent in late years has been our coreligionist, Jacques Loeb, now of the Rockefeller Institute of this city. It was only when the studies of biology, physiology and physical chemistry had become more profound, when a truer interpretation of their teachings, as well as the relation existing between them was beginning to be grasped that men began to take note of the sayings and doings of individuals such as Schiff.

Schiff was a most original thinker; he never seems to have followed in anybody's footsteps. And perhaps that is another reason why his work was for some time ignored. He mapped out his own path, an unbeat-en track, along which he experimented, caring naught for the adverse comments of colleagues, absorbed with but one great thought—that of proving or disproving his theory. If proof were forthcoming he would improve the structure by strengthening and adorning it. If not, he would think of other plausible theories and straightaway test their genuineness by casting them into the experimental machine. Such was his method, and from this he never deviated. In after life, when Schiff's great merits had become to be recognized, if one could support his views by saying that it was also Schiff's, that man won the day. Everyone knew that Schiff would not say a thing was so unless he had proved in a thousand and one different ways that the thing was really so.

Such a man was not given to making friends. So grand a spirit very few could understand and appreciate. Most of his colleagues considered him unduly stubborn and attaching too much weight to his own ideas. Many, more wise, recognized a genius, but pervaded with the demon of selfishness attempted to decry everything he did. Only a few, choice spirits were ready to pay homage. Among them Magendie, Louget, Matteucci, Moleschott and

Valentin stand out prominent. With these Schiff's relations were of the pleasantest. They entered into his labors wholeheartedly, and he greatly appreciated their friendly criticism.

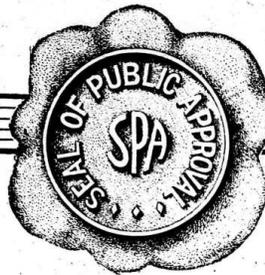
In assiduity, in the close and constant application to his work, in the complete effacement of everything but the physiological problem before him, Schiff surely never had an equal. It is related of Pasteur that on the day of his marriage he was so interested in his tartaric acid crystals and their optical activity that he forgot all about the wedding. A similar story is told of Schiff. The humorous journals, ever ready to picture the absent-minded professor, have certainly some justification for it.

Schiff was born on January 28 1823, in Frankfurt-on-the-Main. I have been told that he came from the same family as our noted philanthropist of this city, Jacob H. Schiff, but how far true this I have not been able to ascertain. His father wanted him to become a merchant, but overcoming the scruples of the parent he embarked upon a course of study in natural philosophy, and then in medicine. From 1840-44 he studied under Tiedemann in Heidelberg, Johannes Miller and Lichtenburg in Berlin, and Rudolf Wagner in Göttingen. In 1844 he received his M. D. on a thesis, entitled: "De vi Motoria Baseos Encephali Inquisitiones Experimentalis." He next practiced medicine for some time in the city of Frankfurt, but his skill was of no avail, for of patients there were few. However, the lack of these gave him an opportunity to prosecute researches, of which he was not slow to take advantage. In fact, what appeared at the time distinctly disheartening was, in reality, a blessing in disguise. Together with one or two other young graduates whose patients were few, whose purses were slender, but whose love for the science was extreme, Schiff studied and experimented in ornithology. With a reputation—a most just one—for a brilliant student, well up-to-date in all the branches of his profession, he was sought after as a tutor. Ere long a sufficient body of physicians had been collected to whom a regular series of lectures on various phases of medicine could be given, and these lectures as delivered by Schiff were highly successful.

A rather amusing story of him in those days has been handed down, gladly welcomed him into their It would seem that a certain well-known hypnotizer, Regazzono of Como, came to town, announcing that he could so put a "medium" of his—a young lady—to sleep that she would lose all sense of feeling. The thing was boomed all over the city, qualities as teacher and investigator, and people came from far and wide. They all wondered how punches, this interested audience was our friend Schiff. He also wondered, stabs and burns seemed to have no effect on the sleeping woman. Among but he did not stop there. He decided to test the matter in his own peculiar way. On the next occasion he brought along a live frog, which he dexterously allowed to glide into the bosom of the fair one. Scarcely did she feel the little animal creeping on her when up she sprang, crying, "Una bestia! Una bestia!" and ran away. Exit Signor Regazzono! In 1885 Schiff first attempted to get into the university by establishing himself in Göttingen. As, however, he had served as physician

in the revolutionary forces at Baden, a position was refused him; "for," said these upright and learned judges, "his teachings to youth are dangerous." Disgusted with such treatment he proceeded to Bern, and here the faculty, having regard only to his midst. In the following year (1856) Schiff was appointed to the chair of comparative anatomy, which he resigned only seven years later when a similar professorship was offered him at Rome.

Epoch-making as his discoveries are only a study of physiology can make them comprehensible. Suffice it to say that of his great work, "Text-book of Physiology," where in not only everything that was then known on the subject was collected, arranged and criticised, but innumerable results of his own experiments were inserted—so much so that on every page of the book new facts and new ideas are still to be found—the celebrated Nothnagel of Vienna has said: "Es ist ein Meisterwerk ersten Ranges heute noch —[this was written in 1893, though the work first appeared as far back as 1858]—und eine wahre Fundgrube wissenschaftlicher Schätze." Schiff's collected works [4 volumes, Lausanne, 1894-98], edited by Elex Herzen, have been published. He died in 1896.

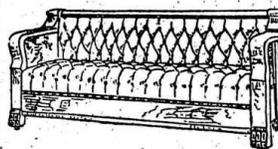

symphonies which includes: four of Beethoven (with the ninth and the Mendelsohn Chorus assisting); two of Haydn, Mozart's "Jupiter," Mendelssohn's "Scottish," two of Brahms, Schumann's No. 1, two of Tschaiikovsky, the No. 5 and the "Pathétique," which is said to be one of Stransky's most impressive interpretations; two of Schubert, including the "Unfinished," two of Dvorak, including the "New World," Berlioz's "Symphony Fantastique," Bruckner's No. 3, the rendition of which has won for Stransky praise in Berlin; Mahler's No. 5, the Caesar Franck D-minor, Goldmark's "Peasant Wedding," Liszt's Dante Symphony, and Weingartner's new No. 3.

The Philharmonic Society will present this winter twenty-four symphonies, representing sixteen noted composers, as compared with last year's list of sixteen symphonies, representing ten composers.

In opening its season with programmes devoted entirely to the music of Franz Liszt, (Friday and Sunday afternoons, October 27 and 29), the Symphony Society of New York, Mr. Walter Damrosch, conductor, will follow the example of a host of orchestral organizations in Europe. One of the principal orchestral works of Liszt, his "Faust Symphony," will be played at the first concert of the Symphony Society, and the score will be presented in its entirety, including the tenor solo and "Chorus Mysticus." At the first public performance at Weimar, on September 5, 1857, a great gathering of noted musicians was present, and the new work won high appreciation. The soloist at both the Liszt concerts will be Mr. Harold Bauer, the pianist. The programmes will be entirely distinct, and the concerts will take place at the Century Theatre, formerly the New Theatre.

And thus Malchiah, Zichronoth and Shoferoth are combined with Teshuva, Tefillah and Tzedaka, and the evil decree is averted.

Finally, we demonstrate to our Heavenly Father that all the world is as naught to us if we possess but His love. We leave our fine dwellings and all the pomp and pride of the luxuries of life and are contented to dwell with Him in a humble little booth which we call Succah, for there we can see the stars of heaven and be reminded of His promise that we will yet be as exalted and innumerable as the heavenly stars.

Resolved (If the Senate concur) That section six of article three of the constitution be amended to read as follows: § 6. Each member of the legislature shall receive for his services an annual salary [of one thousand five hundred dollars.] as follows: The members of the senate the sum of three thousand five hundred dollars and each member of the assembly the sum of three thousand dollars. The members of either house shall also receive the sum of three cents for each mile [one dollar for every day and for each mile] in going to and returning from their place of meeting, once in each week of actual attendance of the session, on the usual route. Senators, when the senate assembly is convened in extraordinary session, in which session no members of the senate are tried on impeachments, and such members of the assembly, not exceeding nine in number, as shall be appointed managers of an impeachment, shall receive an additional allowance of ten dollars a day. § 2. Resolved (If the Senate concur) That the foregoing amendment to section six of article three of the constitution be submitted to the people for approval at the general election to be held in the year nineteen hundred and eleven, in accordance with the provisions of the election law.

AMENDMENT NUMBER TWO.

Concurrent Resolution of the Senate and Assembly, Proposing an amendment to section two of article six of the constitution, in relation to assignment of justices of the supreme court to hold circuit and trial terms.

Section 1. Resolved (If the Assembly concur) That section two of article six of the constitution be amended to read as follows: § 2. The legislature shall divide the state into four judicial departments. The first and second shall consist of counties of New York; the others shall be bounded by county lines, and be compact and equal in population as nearly as may be. Once every ten years the legislature may alter the judicial departments, but without increasing the number thereof. There shall be an appellate division of the supreme court, consisting of seven justices in the first department, and of five justices in each of the other departments. In each department four shall constitute a quorum, and the concurrence of three shall be necessary to a decision. No more than six justices shall sit in any case. From all the justices elected to the supreme court the governor shall designate those who shall constitute the appellate division in each department; and he shall designate the presiding justice thereof, who shall be a resident of the department in which he is to preside. The other justices shall be designated for terms of five years or the unexpired portion of their respective terms of office, if less than five years. From time to time as the terms of such designations expire, or vacancies occur, he shall make new designations. A majority of the

justices so designated to sit in the appellate division, in each department shall be a resident of the department. He may also make temporary designations in case of the absence or inability to act of any justice in the appellate division, or in case of the presiding justice of any appellate division certified to him by the presiding justice of the department. Justices are needed for the speedy disposition of the business before it. Whenever the appellate division in any department shall be unable to dispose of its business within a reasonable time, a majority of the presiding justices of the several departments at the time called by the presiding justice of the department in arrears may transfer any pending appeals from such department to any other department for hearing and determination. No justice of the appellate division shall, within the department to which he may be designated to perform the duties of an appellate justice, exercise any of the powers of a justice of the supreme court, other than those of a justice out of court, and those pertaining to the appellate division, or to the hearing and decision of motions for habeas corpus, or to the duties of a presiding justice, when not actually engaged in performing the duties of such appellate justice, in the department to which he is designated, may hold any term of the supreme court and exercise any of its powers or judicial district in any other department of the state. From and after the last day of December, eighteen hundred and ninety-five, the appellate division shall have the jurisdiction now exercised by the supreme court at its three courts, to wit: the general term of the court of common pleas for the city and county of New York, the superior court of the city of New York, the superior court of Buffalo and the city of Brooklyn, and such additional jurisdiction as may be conferred by law. It shall have power to appoint and remove a reporter. [The justices of the appellate division in each department shall have power to fix the times and places for holding special terms therein, and to assign the justices in the departments to hold such terms; or to make rules therefor, be approved.]

A county judge of any county may hold county courts in any other county when requested by the judge of such
