STUDIES OF RUSSIAN JEWISH LIFE AND CHARACTERS

By HANNAH BERMAN—No. 4—"A Lost Life"

"Everyone is going away to this place and to that. It is an empty village. Only old men and little children and helpless, feeble women remain behind, and they can do nothing for themselves. There is, therefore, neither work nor pleasure in the village any more and all the business has sunken to nothing. For instance, old Isaac, the innkeeper, does nothing but sit on the bench outside his door and wait for chance passers-by to come and gossip with him. In vain he looks up and down the road to see if there is any stranger coming from whom he might earn a little money. No travelers come for Isaac's benefit nor do the villagers want anything from him—any of the fine dishes he was famous for once upon a time. They never think of anything like fine dishes nowadays. They are satisfied if they have sufficient dry bread to keep them alive while they wait for news from this place and from that, whither their men folks have gone to make fortunes.

Yes, so it is. Even old Isaac has nothing to live on. And it is not so very long since he had not a minute's time to talk to his friends, so busy was he. It is my opinion that the train is responsible for all that has befallen us. Had it not come into the village and had the little railway station not been built almost on top of the houses we would not have found ourselves living alone, without the men folks, the village looking like a wilderness. First one thing was made easier and then another, until to-day traveling is so easy that it is almost forced upon everybody. Men found the money somewhere and went. For when once a man has made up his mind he is sure to go away sooner or later, especially if he finds no difficulties in the road, and all the more so if he is convinced that there is less hardship to be encountered in going to America to-day by steam than there used to be in going to the next village by cart. The strange men who suddenly made their appearance in the village, coming from God alone knows where, surely had something to do with the emptying of the village. They stayed in old Isaac's inn for several months, and all the time they did nothing but talk and talk and smoke cigarettes without end. No doubt they talked the men folks of the village into believing the stories they told of the fortunes which waited in England and America for everybody who was

willing to stretch out his hand. They were dressed in beautiful cloaks and wore gold and silver ornaments. They had plenty of money, which they threw right and left, so that even the astute Isaac was led to believe there was a good time coming for the whole village. He was the very first to shout aloud, as one might say, that the trains were a

They left as soon as the wish to go here and there had taken firm root in the hearts of the villagers. I was perfectly right when I told whoever I came across that these strangers were not gentlefolks who had come to visit us out of curiosity. I was not to be deceived, despite their fine clothes and clever talk. I knew at once they were nothing more than


nocent women and children. How could anybody look at the wonderful iron giants, hissing and screaming and sending out volumes of smoke like bewitched creatures, without being led to imagine they were responsible? One has only to compare what was with what is now in the village to be fully convinced that my words are true. Before the trains came who,

dared to walk over to where the earth and sky met in a straight line. It used to be said that the trees which grow in the forest had demons living in them who might at any moment leap down from their heights and lead the wayfarer astray. They resented coming of a man, and therefore took revenge on him, but without letting him know it. They confused him by innumerable echoes, coming now from this side and now from that. The traveler set out in pursuit of the sound, but never reached it, as might be imagined. He went round and round a certain spot in a circle until he fell down with exhaustion and died of hunger on the spot where he had fallen.

Such stories as these put fear into everybody's heart, so that few ever ventured out into the lonely regions, either on foot, or in carts. But as soon as the trains came into the village from behind the sunset, from God knows where, the villagers were led to think that they, too, might venture out into the broad world without any more harm coming to them than had come upon the strangers who came to the village from the other side of the forest. They soon realized that the trains were not only a means of traveling quickly, but were also a strong refuge from the evils of wood demons and other malignant spirits.

And the village is empty now! Nor is there anything left for anyone to make a living out of. I myself have tried, without ceasing to bring prosperity back to the village as well as to make a living for myself; but I have not been successful in the least. Nor does anyone in the whole village seem to have found a way out of the misery.

Once I asked Zelde, the watchmaker's wife, what was to be done to prevent the village from becoming a wilderness, and also if she could advise one how to make a living. She answered me in this fashion, according to her own ideas. "Tsipalle," she said to me, "I will ask you something. You are a clever woman despite the fact that in your ignorance you cannot read as much as the figures on the clock. It wonders me, therefore, that you wait and wait until one must ask you, face to face. Tell me why it is you do not seek to marry off your daughter Beilalle? Who will marry her when she is overaged, I ask you? Sixteen, seventeen, eighteen—it is enough. My advice is that you should hurry up and

find someone to marry her. And then Reb Itzig and yourself will both have rest from toil in your old age."

I drew the edge of my shawl down over my forehead, lower and lower, almost covering my eyebrows, and after a while made answer.

"Zeldalle," I said, "I asked you one thing, wherefore do you answer me something different altogether? You know yourself without asking why I do not marry off my Beilalle. There is no one left in the whole village—no young man at all. She has to wait and wait, for God knows what destiny. But it is not such a great evil if a girl does not get married the moment she is seventeen years old. Good fortune sometimes waits for one as well as bad. Was not I myself much older when I got married than my Beilalle is now? I was not as beautiful as she is, besides which I limped a little then, just as I do now. And yet it cannot be said I got a rude, ignorant or ugly husband. No one can deny that my Itzig, Reb Itzig, I mean, is the greatest Talmudist in the village, next to the Rav himself. And who shall say he is not tall and straight and broad shouldered, with beautiful eyes and a beautiful beard, making him look like a Polish nobleman?"

I went another day to Chanalle, the woman who owns the big red brick grocery shop which stands in the middle of the village, and asked what one ought to do in order to make a living, and she, too, spoke of my Beilalle.

"Tspalle," she began, "We all know you are a clever woman; that you have a man's head, as they say; but where is your good sense in allowing Beilalle to grow old and faded without finding a husband for her? A girl is like a flower. She blooms early and her beauty fades early. And when she is old she is pitiful to look upon. And a girl's reputation is like a towel, so to speak. Everyone who wishes wipes his hands on it, no matter whether they are clean or dirty."

I feel always that one cannot answer Chanalle's questions carelessly. I don't know why there should be a distinction made between her and the other women of the village. But one makes it as if the habit belonged to one's nature. I always pause to think before speaking, as if my words were likely to carry a special meaning to her. And even when I have made up my mind what to say to her I speak slowly and carefully, feeling that I ought by right to count my words.

"Chanalle," I said, replying to her question, "Chanalle, believe me, there is no one in the village to whom one could marry one's daughter. Even the shoemakers and tailors, the youths one would never look at in good times; the youths every Jew despises from his heart if he be a man of learning; even of them there is not one left to whom one could marry one's daughter."

I said no more. My heart was full, so that I could do nothing but sigh. And when I was outside Chanalle's shop, I promised myself that never again would I ask anyone what I ought to do in order to make a living. I saw clearly that it is best to

keep one's soul within one's own body, to do this and that in secret, as if one lived for one's self only and one's kindred. And at the same time I was fully aware that by keeping to one's self one is not prevented in the least from doing one's duty to one's neighbors. I still remember the poor, and go from house to house collecting money and food and old garments for them, as if I myself had no care for the morrow.

Yes, I still collect this and that for the poor. But I never add anything of my own now excepting my poverty to the communal pile. At every step I am reminded afresh of the numbers who left the village of late. The emptiness of the place and the despair of the people are thrust upon me at every step. I am sure to get something for the poor in every household, for who is there that does not know me? Who is there that does not know Tspalle, the woman president of the community, never yet asked for herself nor ever asked on a trivial pretext? Therefore she is not to be refused an alms, despite the fact that every one who gives knows that to-day she is no better off than the people on whose behalf she collects. The village can never forget that she was once the wealthiest woman in it, and that, furthermore, in the height of her prosperity, she pitied the poor. She always gave generously of her work as well as of her money toward supporting and keeping in tolerable comfort those who had nothing at all of their own.

I talk thus with myself as if the Tspalle I refer to and myself were two different persons. And it is because I wish to justify myself in my own eyes that I praise myself, for I feel in my heart that I have no longer any right to ask charity for other people when I myself am suffering so keenly from poverty. I never fail to remind myself of the terrible fact that the hour is drawing near when I myself and my husband, Reb Itzig, the Talmudist, and my daughter Beilalle, who is as beautiful as a rose, will be forced to depend on the same charity which I now ask for the people. Yes, I think I understand now why I cannot find it in my heart to speak to Chanalle as to any other woman of the village. Without my being aware of it I feel prompted to remember that the day is coming on which I shall be compelled to go to her for assistance, because she is now the most important woman in the village. I shall have to say to her:

"Chanalle, I was once rich, but I am now poor—so poor that I have not the wherewithal to buy bread to eat. I have come to entreat you to go and ask the villagers to give you something for me and my husband and daughter. No one will dream of asking you for whom you are collecting, for everybody knows you would not go for a trivial purpose. It will be with you as it was with me in the years of my prosperity. People will give or not give, but they will never spill your blood. I mean that they will never insult you to your face by saying you collect for yourself. Sometimes this happens to collectors of alms who are not respected. But as it never happened to me, so will it never happen to you. Perhaps people will put two and two together and say that there must be some reason why you go to collect instead of me. Perhaps they will guess you are going on my behalf. Well, it cannot be helped. Go for me all the same, for I may no longer consider what people say or think. It grieves me that we must wait on charity, but if one is hungry, Chanalle, one forgets one's own grief as well as other people's cries of shame." I shall say further, on that dreadful day which is coming toward me, "Chanalle, for years I spent many hours each day on behalf of the poor. But now I have neither the strength nor the wish to do it. I am too full of pity for myself to have pity for others. And it becomes no one better than yourself to take up

their burden, to look after the poor. And fate has decreed that I should be the very first for whom you must go and beg from house to house. I will tell you from whom to ask and from whom not to ask. I will disclose to you the secrets of those who are in want, though I swore never to tell. I cannot do otherwise now. You will go for me, Chanalle, will you not? I am hungry and my husband, Reb Itzig, the Talmudist, is hungry and my Beilalle, the delicate flower for whom I can procure no husband, is hungry, too."

I repeat these words over and over again within myself. I dare not utter them aloud, lest my ears hear their full import, which would assuredly frighten me to death. I still keep up my courage. I have not yet lost the wish or the strength to collect alms for the poor of the village. Each day I find more empty houses and more people in sore straits. Instead of one family in a house several families are banded together to comfort each other until the fathers and husbands send them money from abroad. It is the same everywhere. Desolation has come upon the whole village. The doors of many little houses are locked. The little windows with their tiny panes of knobby green glass are covered with dust and cobwebs. The unlucky spiders creep along the walls, making me shudder as I pass them. All these indicate how many families have been torn from the peace and quiet and piety of the village. They have been carried away by the iron trains into the hurry and tumult and godlessness of the cities across the sea. God knows where the wanderers have strayed, how far they are scattered one from the other over the whole world, torn up, root and branch, as a tree is torn out of its native soil by a thunderstorm.

I do not get half as many alms as I used to long ago, despite the fact that I explain fully to each household that the number of poor people has increased beyond counting. In bygone days who would have offered me less than a silver five-copeck piece when I came to their house for an alms? Nobody would have dreamed of putting such an indignity on me. And the result was that I had a good sum of money to distribute. But to-day everything is different. I am glad if I can get so much as a piece of dry bread in a house. Indeed, I feel that I ought to be satisfied in some cases that I myself am not asked for an alms instead of being given it. I dare not ask anybody to give me a little more, as I used to do before the bad times came, sometimes coaxing them to give twice as much. According to strict justice I ought not to ask at all from the people who have sold everything they possessed down to the pillows under their heads, in order to be able to send their men folks to the golden lands beyond the sea. They themselves are half starved while waiting for news day by day. Still I come upon very few who refuse me altogether. They give something out of their very last, perhaps only a crust or a ragged garment. They are full of sorrow because they cannot give more, and they say to me, "Tspalle, little heart, the while take this from us for your poor folks. It is better than nothing at all. Maybe to-morrow or next day we will get money from over the sea.

Then we will surely give you silver five-copeck pieces, as we used to do in the olden times; that is, a few months ago." I take what I can get without saying a word, roll everything into a tight bundle in my apron and go with it into this house and that to distribute it to the hungry.

No one can guess from my words or my actions whether I get from or give to his next door neighbor. I treat everybody exactly alike—those who are only taking like those who are giving, and those who are giving like those who are taking. It is not my fault that those who hold out their hands to me afterward rush away with flaming cheeks, while, on the contrary, those who give detain me for as long as possible, explaining how they cannot give more on this account or on that.

Whenever I go into the house of the rabbi to ask for advice concerning the affairs of the villagers he invariably questions me about the humble folks I come across.

"Tspalle, are they getting poorer, poorer?" he asks, stroking his long gray beard and looking sharply into my face.

"Yes, Rebbe," I answer, "they are getting poorer every day." And when I am done speaking I cast down my eyes as if I had committed a shameless act. This is the feeling which always comes over me whenever I talk to the Rebbe of the poverty of the village. I don't know why it is. I cannot remember ever having done anything which was in the least hurtful to any creature.

"And they are still going away, the men, I mean, here and there, as if a great plague had descended upon the village?"

"Yes, Rebbe, yes; just as if they were all running from a great plague."

"And you think they will all be successful—the young and the old, the simple and the wise alike? What do you think about it, Tspalle?"

I do not know what to say. I can only sigh aloud, remembering all that I witnessed going through the village.

"God alone knows, Rebbe," I make



bold to answer. "Surely He will have pity on the little children who are waiting for bread with wide-open mouths, after the fashion of little birds in their nests, who open wide their beaks for the mother bird to drop in a worm, knowing no better than to wait."

After a while the Rebbe goes on to say: "Tsipalle, I am afraid many of them will lose their lives—the adventurous men, I mean. They will lose their lives as one loses money in a game of cards, within a night, as one might say."

So often have I heard him repeat the same words again and again in connection with the folks who have gone away that I imagine I hear them always. I am falling more deeply into the habit of applying them everywhere, not only to the men who have left the village in search of the fortunes they will never find, but to everyone with whom it is not going well. They are suited to the poor from whom I take alms as well as to the hungry who are waiting for what I bring them. And I myself, I, too, who have a husband and daughter waiting for the food I cannot get for them, I, too, have lost my life as in a game of cards. It is not the less true that I have lost my life if I have stayed in the village instead of having gone on a restless search for my fortune. Not one person has been inside my shop for months past. I have not sold a single thing to anybody since the men first began to go from the village by train. The hungry women and children they have left behind have no use for iron. There is no building and no repairing going on anywhere. Everything is going down into ruin, for there prevails with everybody the feeling that he will surely abandon his home very soon. And there is no more noise of tools in the village than there was in Jerusalem when King Solomon's workmen were building the Temple. Only there is a great difference. It is written that in getting the stones for the Temple a miracle happened. The stones were made the right size and shape by a worm which ate and ate noiselessly, eating out the pattern of the stones with as much exactitude as if the most skillful workmen had cut them with the sharpest chisel. But the village is silent because it is empty—empty as a wilderness. I

have had to close my shop, the shop which had provided the three of us with comforts for so many years. We never dreamed that the day would come when it would not bring us in so much as the price of a crust of bread.

And now we have no way at all of making a living. We have not even the hope left us of getting money from our relatives in England and America like the rest of the village. We cannot quicken ourselves with the thought that some good fortune or another will surely befall our men folks. No one belonging to me has gone away. My husband still goes to the House of Learning day after day. He shows us that he has no wish at all to leave the village. And Beilalle is only a young woman. What could she do in a distant land?

Some of those who are here still can somehow manage to exist on the produce of their gardens. But I possess no garden to depend on for a meal. It is true I have a piece of land, but it was never cultivated. There was no one to do it. I spent all my time attending to the business. Reb Itzig never did anything but read and Beilalle was brought up in luxury as befitted a delicate flower. She never dreamed of digging and planting and weeding, like a poor child.

And so there is nothing for me to do but to run frantically up and down the village, in the dust and rain and sweltering heat, asking this person and that if they want any iron. I would be satisfied if they bought from me so much as the value of a single loaf of bread, but I have not yet come across anybody who wanted anything. The lock of my shop is getting rusty from never being used.

One day in spring, before seed time, I had hopes of selling something. The horses had to be shod anew for field work, the ploughs repaired and set in working order again, and the cartwheels recovered with new iron rims. But there was no ploughing going on. The cattle were led onto the meadows to graze. The gardens were not dug up with heavy spades. The surface was scratched, as one might say, with sharp pieces of wood, and the onions, carrots, radishes and so on were sown at random. The people were too poor to buy new iron tools. They managed with broken ones, or with pieces of wood, as I have said. They cared nothing about the condition of the land; for they were filled with the idea that they were going from the village to-morrow, or another day.

I could not make bread to eat out of the explanations and excuses and apologies I heard when I went to offer my iron for sale. I felt that I must go elsewhere. I must find some way out of our desperate position. I tied the long ends of my big shawl behind me in a knot, and thus protected against the rain and the cold, I set out to walk to the village of Tomsk. One gets there by following the river for several miles, without turning to the right or to the left. I did not care how far it was, I wished only to find someone to buy some of the iron-ware which was rusting in my shop.

I started out early in the morning, thinking that I would surely be home before nightfall. But despite the fact that I never rested once, going or coming back, I was not home until a late hour at night. For the occasion, I borrowed the beadle's heavy polished wood walking stick to lean on when I got tired. I was hungry and soaking when at last I arrived in Tomsk. But I did not pause. I at once set about asking the inhabitants if they wanted any iron-ware. I knocked at the doors, one after the other, exactly as if I were a beggar. But I found no one who wanted anything. It was

ITEMS OF INTEREST IN THE JEWISH WORLD.

A Y. M. H. A. has been established at Bessemer, Ala.

A new B'nai B'rith lodge has been instituted at Bryan, Tex.

Glasgow, Scotland, has a Jewish Literary Society with over 400 members.

The police of Lublin have begun to close local synagogues on various pretexts.

The Hebrew Literary Society was established at Rochester, N. Y., last week.

Articles have been filed incorporating the United Hebrew Charities of Elizabeth, N. J.

Rabbi Montague N. A. Cohen, of Butte, Mont., has accepted a call to San Diego, Cal.

A theatre to be given over exclusively to the Yiddish drama is about to be built in Detroit, Mich.

In Buda Peth, Hungary, the Jews number 203,687, or 23.1 per cent. of the whole population.

Mrs. Mortimer M. Menken has been elected a director of the Society of New York State Women.

The Boston Section Council of Jewish Women is actively engaged in providing a new home for immigrant girls.

William Lissner, a pioneer Jewish educator of San Francisco, Cal., died suddenly last week after an illness of only twenty-four hours.

Major Lewis Barned, L. C. C., has been appointed vice-chairman of the Parks Committee of the London, Eng., County Council.

A permit has been granted for the erection of a nurse's home to be built in connection with the Jewish Hospital at Louisville, Ky.

The Jewish colony at Clarion, Utah, is prospering; 8,000 acres have been purchased from the State and an irrigation canal is being installed.

Dr. Harburger, professor at the University of Munich and Councillor at the Court of Appeal, has been appointed President of the Senate of the Supreme Court.

The Jewish Religious Teachers' Union of Austria has now its press organ. The paper is being issued monthly at Vienna, under the title of Freie Judische Lehrerstimme.

Rabbi Samuel Schwartz, who recently refused to be a candidate for re-election by the Congregation B'nai Jeshurun, Cleveland, O., has accepted a call from Jacksonville, Fla.

The Jewish Colonization Loan Company has been organized at Salt Lake City, Utah, for the purpose of advancing money to settlers with which to improve their farms.

According to the death certificate filed at the city clerk's office, Paces Slosberg, who died at Randolph, Me., on April 2, was 109 years old at the time of his death.

Owing to the floods which make travel in the Mississippi section uncertain, the annual convention of District Grand Lodge, No. 7, I. O. B. B., which was to have been held at Galveston, Tex., on Sunday, the 21st inst., has been indefinitely postponed.

Last month Imperial and Royal Ministerial Councillor Dr. Theodor Pollak, chairman of a department at the Austrian Ministry of Railways, died at his residence in Vienna.

Edward Steindler, who died in New York city on April 10, bequeathed \$2,500 to the Cleveland, Ohio, Jewish Orphan Asylum and \$1,000 to the New York city Hebrew Orphan Asylum.

Plans have been filed for the erection of an addition to the Hebrew Technical Institute of New York city, to be used for offices and a gymnasium. The addition will cost \$30,000.

Old Sinai Temple, long a landmark in what was once an exclusive residence section of Chicago's South Side, is about to be torn down to make room for a manufacturing plant.

The Beth David Hospital has purchased a plot of ground at 113th street and Lexington avenue, New York city, upon which a modern eight-story hospital building will be erected.

Rev. Isaac Cumay, rabbi of the only Jewish congregation in Racine, Wis., died suddenly last Tuesday. He was fifty-six years old and has resided in Racine for the past two years.

After twenty-five years of service, and owing to advancing age, Rabbi I. L. Leucht has tendered his resignation as vice-president of the Jewish Widows and Orphans Relief Association, of New Orleans, La.

Senator Max Silberberg has been re-elected chairman of the Hamilton County Ohio Memorial Committee, consisting of all Grand Army posts and patriotic organizations in Cincinnati and vicinity.

Simon Suss, a well known St. Louis Jew, died last week, aged sixty-one. He was prominent in Masonic circles, and had been for some years district Grand Lecturer of the Grand Lodge of Missouri.

The Bessarabskaya Zhlnz has been fined three hundred roubles for a pro-Jewish article on the centenary of the emancipation of the Prussian Jews. The editor, having declined to pay the fine, was sent to prison.

Last week the German Empress visited the Woman's Exhibition in Berlin, where she congratulated Professor Dr. Lydia Rabinowitsch-Kempner on the scientific work which had gained her the title of professor.

Jews of Quincy, Mass., who were for some time past, subjected to rough treatment at the hands of some local rowdies, hailed the miscreants into court last week, where they were bound over to keep the peace.

Dr. Mark J. Lehman, who for the past fourteen years was editor of the Jewish Ledger, died at New Orleans on the 7th inst. He was a physician of note and an expert and authority on the treatment of yellow fever.

From Nice comes news of the death, in his sixty-third year, of Abraham Effendi Fresco, for many years a contractor to the Turkish War office. When the revolution broke out and the Young Turks eliminated from government affairs everybody who had reaped profits from the old regime, Abraham Effendi Fresco was one of the few contractors who was not interfered with, as his integrity was fully recognized.

After serving in the National Guard for forty-one years, Lieut.-Col. Sol. E. Japha, of the Ninth New York Coast Artillery, has applied for retirement. Col. Japha was made captain in 1875, major in 1889 and Lieut.-Col. in 1900.

The University of Algiers has been authorized to accept the legacy of 200,000 francs bequeathed by the late Madame Azoulay. The annual income is to be applied to the maintenance of laboratories for the Faculty of Science at the university.

Michael Mintz, who for many years was the publisher of the Daily Jewish Herald (now the Wahrheit) of New York city, and who for the past few years has managed the Lipzin Theatre, committed suicide last Sunday. His widow is Mme. K. Lipzin, a well-known actress on the Yiddish stage.

The Jewish Medical Association of Kieff has resolved to take the initiative in a scheme for founding a University in Palestine in the name of Professor Mandelstamm. Many influential admirers of the deceased are also urging the erection of an Ophthalmic Hospital in Palestine in his name.

The National Jewish Hospital for Consumptives, at Denver, Col., is planning a medical research laboratory that will be one of the largest of its kind in the world. Dr. Simon Flexner, of the Rockefeller Institute, is vitally interested in the proposed laboratory, and will go in person to Denver and start the work.

Attempts have been made by some Serbian newspapers to stir up animosity against the Jews in the kingdom, who do not form a half per cent. of the population. The heads of the community at Belgrade have, however, received assurances from the government that it will not permit any attacks on a nationality or religion.

Mr. O. Falk, who for the past two years has served as councilman for Tampa, Fla., was renominated over three opponents at the last primaries. This is equivalent to an election. Mr. Falk carried every ward in the city by a plurality and received most of them by a majority over all. The Jewish population is very small in Tampa.

Gustave Bacharach, who held many political offices in Philadelphia, Pa., died suddenly at his residence last week, aged forty-four. Mr. Bacharach was president of the Civil Service Commission for two years, mercantile appraiser for five years, and at the time of his death was a real estate assessor which position he had filled for the last six years.

Professor Dr. Martin Rade, the Marburg theologian, has written to the Press, suggesting that a Jewish theological faculty should be established at the new University in Frankfurt. He recommends that the subjects to be taught should include Old Testament, Talmud, history of Judaism, religious science and history, and practical theology.

The celebrated scholar, Professor Dr. Wilhelm Bacher, who has hitherto been rector of the Jewish Theological Seminary in Buda-Pesth, has been appointed by the Emperor-King, on the recommendation of the Hungarian Minister of Public Workshop and Instruction, director of the seminary for life. This is the first time that a director of a Jewish seminary has been appointed by a monarch.

Charitable bequests of the late Jacob W. Mack, who died on April 11, are \$10,000 to Mt. Sinai Hospital, New York and \$2,500 each to Jewish Hospital Furth Bavaria; Jewish Orphan Asylum Furth Bavaria; Salem Fields Cemetery of Temple Emanu-El, Hebrew Orphan Asylum. Home for Aged, Montefiore Home, Society for Prevention of Cruelty to Children and Ethical Culture Relief Fund, all of New York city.

Jewish Sabbath Association.
A large and enthusiastic throng gathered Wednesday evening, the 19th inst., in the Educational Alliance auditorium to participate in the celebration of the fifth anniversary of the Jewish Sabbath Association. There was a spirit of rejoicing manifest in the great audience, which showed how warmly it sympathized with the organization and rejoiced in the good work which it has been doing. The opening address and historical account was given by the president of the association, the Rev. Dr. Bernard Drachman, who said in part:

"Five years ago the Jewish Sabbath Association was organized. It succeeded to the Sabbath Co-operative Association, which had been organized two years previous by Rev. Drs. Philip Klein, H. Pereira Mendes and Bernard Drachman and Messrs. J. H. Luria, Hyman Eisenberg, Meyer Goldberg, Y. Samuel D. Aaronson, Henry P. Goldstein and Gabriel Davidson. But the association did not succeed. In 1907 the society was reorganized under the present simple and unmistakable name Jewish Sabbath Association. The step was a wise one, and success, modest but still real and undeniable, began to attend the movement. Sabbath observance was in a wretched state of decadence when the society began its work. Numerous shops hitherto closed on the Sabbath were opening and condemning their employees to Sabbath desecration, young persons seeking employment without necessity of Sabbath desecration had none to aid them in that heart-breaking endeavor, there was no organized expression of Sabbath sentiment and no effort to spread or strengthen that sentiment. The society at once began vigorous work along these lines.

"In 1909 our Employment Bureau was opened as a regular department and at once accomplished splendid results. In this year we had a Sunday exemption bill for Sabbath observance introduced in Albany and a great delegation from all over the State attended it. We also started a movement to close stores in Canal and Grand streets, which was attended with some success.

"In 1910 we organized leagues of young men and young women, which we esteem as some of our best work. Commissioner Bingham in 1910 instructed the police not to arrest storekeepers displaying certificates of membership for doing business on Sunday. During this year we published the Journal for twelve successive numbers and it made a splendid impression. We again introduced a Sunday exemption bill and went to Albany to advocate it. Our Employment Bureau procured places for several hundred applicants.

"Nineteen twelve saw the establishment of a children's synagogue, which is doing splendid work. If we can secure more means we can make our work for the Sabbath great and beneficial, indeed, and we appeal to all Sabbath-loving brethren and sisters to join our ranks.

Dr. Drachman was followed by Rabbi B. Z. Alperstein, who spoke in Yiddish and expressed the deep gratitude of our co-religionists on the East Side for the great help which the association has afforded them in solving the Sabbath problem. Dr. D. de Sola Pool was the next speaker. He welcomed the Jewish Sabbath Association as an indispensably necessary organization doing one of the most difficult and urgently needed kinds of work in our communal life. Taking forth a letter from his pocket, which was a communication from a young lady, desirous of observing the Sabbath and finding great difficulty in obtaining a position, he said that this was but one example of the problems which are constantly arising. The president, Dr. Drachman, took the letter from him and assured him that the case would at once be attended to by the employment bureau. Other speakers were Rabbi J. Segal, Rabbi S. Balsac, Mr. Nissim Behar, Mr. D. B. Cohen for the Young Men's Sabbath League, Miss A. Hartman for the Young Women's Sabbath League, and Mr. J. Horwitz for the Children's Synagogue. Regrets were received from Hon. Otto A. Rosalsky, Hon. D. P. Hays, Hon. Samuel Greenbaum, Hon. M. W. Platzek, Hon. Cyrus Sulzberger, Rabbi M. Z. Margolies and Rev. Dr. J. H. Hertz.

A number of reports of great interest will be presented at this convention, and much interest centres around the presentation of the first annual report of the Bureau of Education, which will be presented by Professor Israel Friedlaender, chairman of the Committee on Education of the Kehillah. Dr. J. L. Magnes, as chairman of the Executive Committee, will report of the general activities of the Kehillah, while Mr. Louis Marshall will present a report of the American Jewish Committee, which has made the remarkable record during the past year in connection with its work for the recognition of the American Passport in Russia. Rabbi S. H. Gluck will present a report of the works and plans of the Vaad Harabbonim, (Board of Rabbis), while Mr. Cyrus L. Sulzberger will report for the Committee on Social and Philanthropic Work. Jewish Apostasy in Berlin.

The ravages which apostasy is making among Jews in Berlin can be seen from the statistics of Jewish baptisms in 1911 which have just been published. The number of Jews baptized in this year is 224, comprising 148 men and 76 women, and does not include children. This forms quite a record in the recent history of Jewish apostasy in Germany, and surpasses the figures in 1889 (162) and in 1893 (184), when anti-Semitism was in its heyday and baptism was regarded as the sovereign remedy of Jewish misfortune. The figure for 1911 also exceeds that of 1907 (149) and 1908 (186). It would be considerably larger if one included the Jewish children, as it has been carefully computed that 10 per cent. of all Jewish children in Berlin take part in Christian instruction and a great percentage of them is formally converted to Christianity in early youth. If the present rate of progress—or rather retrogression—continues it will not be long before Berlin competes with Vienna, which records more than 600 Jewish baptisms each year.

NEWS FROM ENGLAND.

(Exclusive Correspondence to THE HEBREW STANDARD.)

Chief Rabbi of Spanish and Portuguese Congregations Celebrates an Anniversary—His Interesting and Erudite Career—Lull in Chief Rabbinate Controversy—American Officials of B'nai B'rith in England—Liberal Judaism Developing Slowly—Important European Pronouncement on Jewish Liberals.

London, April 14, 1912.

Dr. Moses Gaster, one of the greatest living Jewish scholars, celebrated on March 31 the twenty-fifth anniversary of his occupation of the Chief Rabbinate of the Spanish and Portuguese Congregation in England. To mark the occasion a special service was given on April 1 in the Bevis Marks Synagogue. The Haham delivered an address mentioning the leading incidents in Anglo-Jewish history in the course of the period during which he had held the position. He recalled the fact that he found the congregation vanishing, but he was glad to see that there was still a great future for that ancient community. After service the audience retired to the vestry, where Mr. Mocatta presented a handsome address to Dr. Gaster on behalf of the Sephardic community. As a token of individual esteem a sum of money had been collected from the members of the congregation and this was handed over to Dr. Gaster. Dr. Gaster is one of the most interesting personalities in the community. A profound scholar, an eloquent preacher, a man of great courage, and possessed of intense sincerity he is without a doubt one of the greatest forces in English Jewry at the present time. On many points he does not see eye to eye with the accredited communal leaders, but that is perhaps because he is an idealist and in many important matters ideals cannot go hand in hand with practical politics. But they admire his standpoint none the less, and to a very large section of them he would be indeed, welcome as the Chief Rabbi of English Jewry. They know, however, that in such an important matter as Zionism they are hopelessly at variance with him. Were it not for this one fact, the community would not be as troubled as it is at the present moment on the question of the future of the English Rabbinate.

Dr. Gaster was born in 1856 at Bucharest, Roumania, and was educated at Bucharest University and at Leipzig. He attained his Rabbinical diploma at Breslau in 1881, and was exiled from Roumania four years later. Coming eventually to England, he was appointed to an important lectureship at Oxford University, one of the head centres of British university educational excellence. During the last twenty years he has held high official posts in all kinds of learned societies, Jewish and general. He has been president of the English Folklore Society, vice-president of the Anglo-Jewish Association, member of the Councils of the Royal Asiatic Society, the Society of Biblical Archaeology, and the Society of Apocrypha. He was delegate of the Royal Asiatic Society to the Oriental Congress at Rome in 1899, to the Bi-centenary of the Prussian Academy of Science in 1900 and the Oriental Congress at Hamburg in 1902. These are only a few things showing his wide intellectuality and popularity among learned men. His publications cover an equally wide range beginning with the history of Roumanian popular literature in 1883 and including many contributions to learned journals and reviews. He was president of the English Zionist Federation in 1907 and the vice-president of the second, third, fourth and seventh congresses.

We do not appear to be hearing so much just now in the controversial way about the appointment of a successor to the late Dr. Adler as spiritual chief

of Anglo-Jewry. The conference deputed to deal with the subject has been allowed to pursue its inquiries in peace. Nevertheless, the community, as a whole, has in no sense lost interest in the matter, and awaits anxiously the further meeting which is shortly to take place at which the report of the special committee will be considered. One incident in the whole proceedings has been the attitude of the Federation of Synagogues, a body consisting of numerous small congregations in East London, of which Lord Swaything is the head. The United Synagogue contributes the greater portion of the Chief Rabbi's stipend, and acting strictly in accord with its constitutional powers, invited those congregations who contributed to this fund to send delegates to the conference which is to make the final selection of a successor to Dr. Adler. The federation objected to representation on this body being in proportion to the actual contributions, and urged that representations should be upon numerical rather than a financial basis. To this neither the United Synagogue nor the other contributing bodies would agree, declaring that it would give the federation an undue weight in the councils of the conference. The latter body withdrew from the deliberations. Many people see in this attitude possibilities making for communal disruption.

At the London Hotel Great Central a reception was held on March 31 by the English lads of the Order of B'nai B'rith in honor of the president and officers of the Grand Lodge of the order, who are now on a visit to this country. Dr. Gaster having welcomed the guests, the Hon. Adolph Krauss, president of the order, expressed his pleasure at the welcome given him and his colleagues, and referred to the utility of the order in promoting the welfare of Jews in all countries throughout the world.

Lucien L. Solomons said they were ready to do battle in the cause of Israel, wherever situated and wherever dispersed. They bore the Ark of Israel's redemption enclosing the Divine testimony of the human brotherhood of Israel. He traced the origin of the order in America, which had been largely due to the necessity of alleviating the lot of the raw immigrants into that country. It was an offensive and defensive organization of native-born and foreign-born American Jews which took in all classes, and he was glad to know that their work was extending in different parts of the world. Their brethren in America looked forward with faith to the time when an international movement would succeed in making it impossible for any nation to be regarded as a great power unless its attitude to all its citizens, irrespective of creed, were on the highest plan of civil and religious equality.

Liberal Judaism in England appears to be all the better for the work of the new minister of the Liberal Jewish Synagogue. The history of the movement here is now well known. Claude Montefiore was its first champion and exponent. Associated with him were such earnest men as the late Simeon Singer, the late Nathan Joseph, and many who are still in the forefront of Jewish communal life. It was declared to be an honest attempt to combat religious apathy, to keep within the fold many who were slowly yet surely drifting from it. For a time the community was greatly disturbed, for the movement bade fair to do more than it originally proposed to do; it attracted many from existing places of worship. Then Mr. Montefiore went further, and published a so-called declaration of the Liberal Jew's faith. But that went too far for many. It discarded many cherished forms of ceremonies, and struck vitally at the roots of what was considered more than ceremonial. Many secessions took place, among them some of the most prominent men in the movement. For a space it languished. Dr. Stephen Wise and others associated with Liberal Judaism in America came over from time to time and infused new life into it, but it was felt that if it was to succeed permanently a leader and minister must be appointed. The choice fell

upon Mr. Mattuck and a wise one it has proved.

The following protest against the "Ritual Murder Lie" is published by the Frankfurter Zeitung and copied widely in the English press: On March 12, 1911, a boy named Andrejff Justschinski was murdered at Kieff, and all efforts to discover the murderer failed. Finally, a Jew was arrested on suspicion of being the murderer, and is detained in custody while the case against him is investigated by the judicial authorities. We have no means of deciding whether this Jew is the murderer or not, and it would not be proper to offer any opinion on a matter which is sub judice, and, moreover, in a foreign country. We feel impelled, however, to define our position in respect of one phase of the affair. The agitation of the street has seized greedily on this incident, and maintains that the boy Justschinski was butchered by Jews with the object of obtaining his blood, which they desired to employ in accordance with an alleged law of the Jewish religion for ritual purposes. This erroneous idea, which has been unscrupulously circulated among the people has again and again, from the Middle Ages until the present time, produced the most terrible consequences. It has instigated the uneducated masses of the people to cruel massacres and deluded crowds have, through this erroneous idea, stained their hands with the innocent blood of their fellow men. And yet not even the shadow of a proof has ever been brought forward in justification of this superstition, while most eminent Christian connoisseurs of Jewish literature have proved incontestably that at no time have the Jews been instigated by their religion to murder their fellow creatures. We hold it to be the duty of every person who has at heart the moral progress of mankind to raise his voice against such sad senselessness, and we, therefore, join in the warning cry of the most distinguished Russian savants, writers and artists, in the consciousness that such a warning is not bound by any frontier posts. It must be taken up by the whole civilized world.

The document is signed by a large number of men prominent in German public life. At a mass meeting to protest against the Russian atrocities held on March 29 at the Great Assembly Hall, London a resolution was unanimously passed expressing horror at the atrocities committed by the Russian Government, protesting against the treatment of political prisoners and exiles, and the flogging and torturing of men and women in the prisons of Russia and expressing condemnation of the Anglo-Russian Alliance as opposed to the best traditions of the British nation and a danger to progressive development of humanity. Letters of sympathy were received from Israel Zangwill and others.

As we go to press we have but meagre news of the details of the Titanic disaster, but it seems that among those who met their fate was Isidor Straus. We hope for the best, however.

District Attorney Charles S. Whitman has been mentioned as one of the possible candidates for the office of Governor of this State. Now daylight seems to have entered into the Brandt case.

We hear that the management of the Hebrew Gymnasium at Jaffe have dropped Dr. Mosensohn for his extremely un-Jewish teachings. In these columns some time ago Rev. Dr. Bernard Drachman uttered a strong protest against the methods prevailing at the school, and the resignation of Dr. Mosensohn must indeed be a vindication for his antagonism.

The German governing section of the Alliance Israelite Universelle, while protesting against the determination of the Central Council of the organization to supervise the internal conduct of the affairs of its regional subordinates, agreed recently to bend all their efforts to secure an increase in the German membership of the body. This latter is the proper and only loyal position for a Jewish eleemosynary institution to take.

Justice Marean, of the Supreme Court in Brooklyn, has a poor opinion of the veraciousness of many of the witnesses who appear in his tribunal from day to day. The learned jurist includes in his estimate, to our regret, those of our own co-religionists by and large who have testified before him. While he undoubtedly is entitled to his opinion, we submit that his strictures are somewhat too far reaching and more than cover the particular cases he may have been hearing and determining.

The financial success of the Sirota tour has had its effect and already imitators are touring the country expecting to rake in the shekels. The latest is Chazan Meisels, formerly of New York, who is being billed with the same circus methods which characterized the Sirota tour. In the misleading advertisements Chazan Meisels is described as having come over here from Odessa and was specially called to Chicago to conduct the Passover services. The graft is evidently good and we feel that the worst is yet to come.

The Passover and Easter of 1912 seem to have come and gone in every part of the world without a revival of the infamous "Blood Accusation." This originated in the Middle Ages, when the inflamed non-Jewish populace of Europe translated the command enjoining the use of the blood of the Paschal lamb of Egypt into that of the blood of Christian children. From time to time, even in late years, there has been a recrudescence of this outrageous indictment of an entire people, especially where the non-Jews are steeped in ignorance.

The address of Rabbi Samuel Schulman, as president of the Central Conference of American Rabbis, which was delivered in Baltimore at the opening of the twenty-third annual convention of the organization, last Sunday morning, makes interesting and instructive reading. That the document is able and well phrased is only what one was led to expect from a facile mind like the reverend gentleman's. It is a calm and careful narrative of facts, interesting to rabbis, which the past nine months have revealed. One may well, however, take exception to Rabbi Schulman's glorification of "American" Judaism and to his exploitation of the so-called "triumph" of the reformed principles as by no means borne out by the existing conditions. It should be remembered, however, that this was an address for an audience to whom anything else than the glorification of "American" Judaism and the exploitation of the "triumph" of the reformed principles would have been taboo. No matter how much the Judaism of any land is profoundly influenced by the spirit, the institutions and the political and social conditions which prevail in that land, there is a continuous historical thread running down the Judaism of all the centuries in all the lands of the earth which defies the destructive efforts of the protagonists of "American" Judaism. This is the true significance of the term Catholic Israel.

TURN ABOUT IS FAIR PLAY

WE noticed the other day in one of the daily newspapers of this city an advertisement inviting young men to join the hospital corps of a cavalry troop in the National Guard of this State. The advertiser stated boldly and bluntly that Christians were preferred as applicants, and thereby made an invidious distinction among the eligible youths of our citizenship who may be moved to accept his offer.

It must not be forgotten that the militia, the National Guard of this or any other State of the Union, is supported by the general body of taxpayers, regardless of their religious faiths or adherence to this or that section in the community. If the State in the exercise of its sovereignty as a taxing power were to say that Mohammedans will be sought out as taxpayers so flagrant a defiance of our laws and customs would lead to its own defeat. Similarly it is with our militia regiments, which theoretically are open to every citizen of the proper age and physical development.

Still it should be observed that some justification, however slight it be, exists for the procedure outlined above, and to our regret, be it added, this comes from a Jewish source. Our readers are doubtless familiar with the efforts put forth by that paper organization, the Federation of Jewish Organizations of the State of New York, and its controlling spirit, Nissim Behar, to secure the formation of a Jewish battalion in the State militia. We have from time to time referred to this proposed military organization in deservedly condemnatory terms. We regard it as much un-American and impolitic to create a Jewish regiment as it is to attempt to conserve the so-called Christian character of a similar body. The one is as much to be frowned down upon as the other. There should be no room for either within our National Guard.

But when Jews set out to organize a regiment on wholly sectarian or religious lines who may say that Christians have not the same privilege? No matter even if the Jews leading the movement do so because of this very discrimination, existent or fancied, against them in similar bodies.

The results of Mr. Behar's quite mistaken zeal are apparent in the advertisement we mention. Another proof of the defectiveness of his propaganda.

Theodore Roosevelt's declaration in the Tree of Life Synagogue of Pittsburgh, on the last day of Passover, that the modern efforts to improve the conditions of the working people and their inspiration in the Bible, is only notable because he said it. The thought is neither new nor illuminating, and the fact that comment should be necessary upon it reveals how little the average man of to-day, be he Jew or Gentile, knows of the contents of the Book of Books. The Pentateuch is filled with provisions for the safety and prosperity of those earning their bread by the sweat of their brows. Isaiah spoke at length in his prophecies concerning the "landless and homeless." Yet we would not in aught attempt to minimize the pleasure the congregants of Rabbi Rudolph I. Coffee derived from the remarks of the doughty Colonel. He is, we are free to believe, as true and sincere a friend of the Jews of America as ever drew breath.

It has become an annual custom of late years for the proper communal charitable bodies to distribute *Matzoth* at *Pesach* among the Jewish inmates of correctional institutions. In all large centers of Jewish population there inevitably arises a class among the Jews who come within the terms of the foregoing statement. It is true that the percentage of Jewish criminals is fortunately far, far below the proportional average, the olden virtues of respect for law and order abiding with our people to-day no less than with our fathers in ancient times. Dayton, Ohio, where there is a fairly large percentage of Jews resident, endeavored to keep alive the *Matzoth* distribution this year, as previously, but found there were none in the various institutions who could properly be the recipients of such a bounty. In other words, not a single member of our race is confined in the jail or workhouse of Dayton at this time. We give this fact prominence if only to confound those who loudly proclaim that the immigrant Jew is a steady recruit for our criminal class.

We think Rabbi Stephen S. Wise was well moved in opposing the bill for the incorporation of the "great and glorious" *Kehillah*. We understand that the project of securing the sanction of the Governor and Legislature of New York for the adoption of the name "The Jewish Community" has egregiously failed, a circumstance we would be hypocritical in deploring. Two paragraphs from the memorial of Rabbi Wise in opposition to the bill in the Legislature may be quoted:

The body which seeks to be incorporated through legislative sanction under the title "The Jewish Community," has no right to use that name. Numerically, it represents a very small percentage of the Jewish population of New York, despite the absurdly extravagant claims of some of its overzealous founders. The truth is that a very large majority of the members of the Jewish community of New York are ignorant of, or, if not ignorant of, are indifferent to the project familiarly known as the *Kehillah*. In addition to this great number there is a considerable minority, of which I happen to be one, who are seriously opposed to the methods and to the spirit of the *Kehillah*, believing that it is an institution that is not serviceable to the highest interests of the Jewish community, and that the attempted use of the name, "The Jewish Community," is, to say the least, an unwarranted usurpation by a limited number of people of a title which belongs to nothing less than the whole of the Jewish community.

I know very well that several of the most distinguished Jews in New York have given their support to the project, and I know, too, that the *Kehillah* in a sense represents an attempt to democratize a self-named and self-styled national organization of Jews, but the aforementioned considerations, despite my own deep respect for some of the founders of the *Kehillah*, but not by any means for all of them, as named in the articles of incorporation, constraining me to protest.

THE PIETY OF IGNORANCE

"An ignorant person cannot be pious."—(Pirke Aboth, ii., 6)

ולא עם הארץ חסיד:

HEAVEN save us from the piety of ignorance!

Judaism can well guard itself against the impiety of ignorance, but finds it more difficult to guard itself against the piety of ignorance. Judaism can well survive the attacks, the malice the hatred of impious ignorance, but how can it survive the defense, the good will, the championship of pious ignorance?

When ignorance steps out in the open, wearing no other armor than the armor of ignorance, and using no other weapons than those furnished by ignorance, then Judaism need have no fear. But when ignorance of the crassest kind mantles itself with the characteristic garbs of Judaism, hiding behind the shield of David and wielding the lance of the Macabees, then Judaism may well tremble with fear.

When ignorance is clad in Talith and Tephillin, turning its eyes upward and mumbling formulas of prayer and principle it understands not, beware!

If ever the Biblical metaphor about "a ring of gold in a swine's snout" held true it holds true of the piety of ignorance. A more unseemly adornment—incongruous in the extreme—none can imagine than the crown of piety on the empty pate of a fool.

The piety of ignorance has neither the excuse nor the charm of childlikeness. It is mere blind, gross superstition. It is not really pious, except in name, or rather in pretense. The hollow pretense at its core is it that renders it so repellent and loathsome to all right-thinking men. Just think what perverted sense of proportion it requires for an ignoramus to proclaim himself the *true defender of a faith* that demands not only extensive knowledge, but also deep thought. When shallow wits skim the surface of the unfathomable sea of Judaism, pretending all the while that they and only they have sounded its depths, it is time to consider the advisability of defending Judaism against its defenders. It is time to tell them in the language of Hillel, "An ignorant person cannot be pious."

It would not be far from wrong to assume that this sharp rebuke of pious ignoramus was directed by Hillel against those who arrogated to themselves the role and title of sole champions of the faith. I have no space here to explain very fully why I particularly suspect the existence of such champions in the time of Hillel; but it matters not, for such champions are present in every age. They are, in fact, a universal phenomenon easily explained as a part of a certain type of morbid religious temperament. There were at all times men to whom religion was nothing more nor less than a sort of emotional spasm, the felt vibrations of an unexplainable something racing up and down the nerve fibres. This violent emotional action such men oft mistook for the direct manifestation of divine power. They called it "inner light," or "inner voice," or such like mystical names. Their characteristic trait has always been scorn for the learned and for learning. Such men lived in an atmosphere supersaturated with visions and wonders. Out of such an atmosphere sprang such sects as the Judeo-Christians; the Kabbalists of the Middle Ages and the modern Chassidim. And is it not a striking fact that as the Judeo-Christians of yore condemned the Pharisees, namely; the expounders of the law, so did the Kabbalists oppose the Talmudists and the later Chassidim actually hate the learned *Mithnaggedim*? Is it not curious that rabbinic lore was despised by all these sects?

The fact is that we deal here with a consistent historic phenomenon. Those whose bent is toward *indiscriminate* mysticism, those who babble about the "inner light," are always, by the irresistible logic of their position, opposing those who stress learning, scholarship, reasoning as the surest foundations of religion. This historic opposition may be called the opposition between the piety of ignorance, and the piety of knowledge. And hence I am not very wrong in assuming that the saying of Hillel, which forms the text of the present discussion, is an echo of that early war between rationalists and mysticists whose end is not yet. Hillel insists that the pretended piety of ignorant persons is absolutely worthless. Piety must be founded on learning, on reason. Religion must well up from the depth of reasoned conviction. Religion is not mere emotion, not mere convulsive nerve vibration. Emotion in religion is very valuable, indeed, but it should be aroused by deep knowledge, as deep knowledge will never fail to evoke lasting enthusiasm. The best traditions of Judaism, therefore, always laid emphasis on the dignity and power of learning. Judaism always encouraged the unrestricted use of our reasoning faculty. This implies the grandest conception of religion. Religion is to be the flowering of the best in us, the sum and substance of our mental and spiritual acquisitions; it is not merely a part of our being lodging within us in the neighborhood of other component elements; it is rather the grand passion of our lives to which all other stirrings and aspirations, whether moving in the territory of feeling or of thought, are ancillary and tributary. It would be a mere mockery of true religion if we admitted a religion based only on feeling and opposed to reason. Such a religion would be too crippled and crabbled to serve as a reservoir of *all* our powers.

More could be said about our text, but let the above suffice to show that genuine Jewish piety is the piety of knowledge and not the piety of ignorance. And so, once again, heaven save us from the piety of ignorance!

mobile traffic practically pre-empt the public highway.

All kinds of chauffeurs drive these machines, the smallest possible proportion are careful, the best drive along at a reckless speed, only slowing up when they think they are being watched by a police officer, and always without regard to the rights of those who walk.

Some of these machines are as powerful as locomotives, but not nearly as safe. The locomotive is driven by a trained engineer, and runs upon a track. The auto-locomotive is mostly in the hands of men who have but little training, and makes its own track upon the highways, and runs at the will of the chauffeur in any direction.

The chauffeurs, as a rule, are a callous lot, having small regard for the rights of others, and take an innate enjoyment in just escaping the running over of some one, and it may be added that the occupants of many of these machines take an equal delight in the discomfiture of those whom the chauffeur nearly runs down.

THE SEMINARY AND ITS COURSE.

To the Editor of the Jewish Exponent:—

The old saying that "the sum of disagreements makes up the total of

agreements" is not always rectified to the letter. It is particularly regrettable to the writer of these lines that he must disagree with you, in certain editorial expressions of last week, in reference to the Jewish Theological Seminary of America. You say truly: "The devoted efforts of Doctor Sabato Morais established the original seminary on a foundation of reverence and respect for tradition." You do well in ascribing all this to "the original seminary." That seminary was planted by means of real devotion, self-sacrifice of a rare character and adherence at all hazards to its chosen motto: "To learn and to teach; to observe and to do."

But reviewing somewhat the course of ten years, since the reorganization of the institution, you write: "The promise then held forth for the importing of new vigor to the old institution has been amply fulfilled." This statement of yours, I feel pained to say, admits of far more than ordinary qualification. If by "new vigor to the old institution" is meant the enlisting of more support, financially, to the seminary, there can be no questioning your words. Some men, who never gave to it before, help now substantially; others who were lukewarm, and contributed but a nominal donation, now come forth largely.

If an institution is so to be determined—a theological institution at that with a background of Bible, Tradition, and all that goes to make it, what its founder designed it to be—then, to use your own words, "the seminary is a tower of strength in the preservation of traditional and historical Judaism." But there is no use shutting our eyes to facts. The seminary is not what it was under the direction of its sainted founder, nor what he wanted it to be for all time; it has not, since reorganization, graduated (except in a few instances) men "with the loyalty that is the sign-manual of character"; it has deviated in its actions far from its purpose; it has done this thing, and another thing, and still another, of which I, as a son of its projector, make bold to declare, would never have been approved by Sabato Morais. It has gone far away from what Dr. Solomon Schechter, during the first year of his administration, told me with his own lips, it would stand by; it is not "a tower of strength in the preservation of traditional and historical Judaism," for it has alienated many of those who believe in the Written and in the Oral Law as well, and it derives its chief support from the opposite side of the house. It has put upon its teaching staff certain men with, at least, whilom radical ideas, and it has harbored within its walls, students, who are known to entertain opinions thoroughly comporting with the Cincinnati College, whose avowed purpose none is at a loss to understand.

This "sitting on the fence" policy ill accords with the spirit and the teachings of Bible, and of Rabbinism; it would have been hateful to my father, whose lifelong motto was, "SHOW YOUR COLORS."

Hence I must beg to differ with you. If you want itemized tables of the facts, which "speak louder than words," which, like figures, will not lie, I have them ready. It is only because professions and practices have been all along in the ten years since reorganization, so diametrically at variance, that I, as a son of Sabato Morais, feel prompted, aye, feel it my duty, to come forward and record my deep regret, even more, my intense pain, that an institution, brought into existence by

my father, in his old age, which he really called his Benjamin, and to which he gave his all, has been suffered to drift so far away from the purpose which he held steadily in view, and for which he battled; a purpose which allowed no quarter to would-be destroyers, which tolerated no parleying, which frowned down on all attempts at compromise, or sailing under questionable colors, and which planted firm as a rock, the standard of Biblical, Traditional, unadulterated Judaism.

Anglo-Jewish Singers.

The late W. Clarke Russell came of a family which, in earlier years, took a prominent part in the management of the Western Synagogue. His grandfather, Moses Russell, and his uncle, Israel Russell, took a leading part in its affairs, and his father, Henry Russell, was, in his early days, before he went to the United States, a regular worshipper in St. Alban's Place. Henry Russell has not yet been dead sufficiently long to be forgotten by the present generation. Both as a composer and as a singer he remained for many years prominent in the public eye. He was the composer of no less than eight hundred songs, from which, however, he is said to have derived as little as £400. As a singer, however, he was more successful, and in that capacity amassed a fortune. For his song, "Cheer, Boys, Cheer," he was most famous, but its companion, "To the West, to the West, to the Land of the Free," is believed to have influenced a considerable migration across the Atlantic. When Henry Russell retired from the concert platform he entered into business as a financier also with some success. He left a numerous family by his two wives. Mr. Landon Ronald is a son by the second marriage.

The death of W. Clarke Russell recalled the memory of Henry Russell; the elevation to the peerage of Sir Edward Strachey directs attention to an earlier and even more distinguished Anglo-Jewish singer. John Braham (otherwise Abrahams), the greatest English tenor of the late eighteenth and early nineteenth centuries, was a choir-boy at the Great Synagogue who had been befriended by the famous Chazan and opera singer, Myer Leoni. At the age of thirteen, Braham first appeared at Covent Garden. After Leoni's financial collapse, Abraham Goldsmid came forward as the boy's benefactor. His success was rapid. At the Royal Opera House, at the oratorios, and the Festival of the Three Choirs he was always in demand. In 1797, he went to Italy to study, but his journey was one of triumphal progress from Paris to Florence, Venice, Trieste, Vienna and Hamburg. On his return to England, he was more popular than ever. Then commenced his period of opera-writing. The number of his works is considerable, but the only one that survives is "The Death of Nelson," which occurred in his opera "The Americans," produced in 1811. Another title which he has to fame is that Byron's "Hebrew Melodies" were especially written for the music composed by Braham and his distinguished contemporary, Nathan.

Braham left a son and a daughter. The latter, Frances, Lady Waldegrave, was a leader of English society during a considerable period of last century. Four times she was married. Her first husband was Mr. J. J. Waldegrave, of Navestock, her second was the seventh Earl of Waldegrave. A year after Lord Waldegrave's death, his widow married George Granville Harcourt, eldest son of the then Archbishop of York and an uncle of the late Sir William Harcourt. Her fourth husband was the Rt. Hon. Chichester Fortescue, afterwards Lord Carlingford. John Braham's son, Charles, was the father of Lady Strachie, formerly Lady Strachey. Thus, by the latest addition to the House of Lords, the number of prospective peers of Jewish ancestry has received an accession.

The response made by those present in the synagogue of the Congregation Kehilath Jeshurun to the appeal for the local Talmud Torah on the last day of Passover was both gratifying and encouraging. Rabbis Margolies and Kaplan earnestly advocated the cause of Jewish education and the laymen present heeded their words in a truly Jewish and substantial manner. This is proof positive that the Jews of Yorkville are fully cognizant of what the education of their children along Jewish lines demands of them.

Rabbi Theodore F. Joseph, of Troy, in a local address the other day referred to the race prejudice displayed by those in charge of the Emma Willard School of Troy, in that no Jewish students at the institution are permitted to take up their residence in its dormitories. Rabbi Joseph appears to have made out a good case for his criticism, as certainly a school which bears the honored name of Emma Willard would not be expected to discriminate between the sons or the daughters of men. If our rabbis will, whenever the opportunity presents itself, condemn such a procedure wherever this is revealed as current, perhaps those guilty of the practice will be shamed into abandoning it.

In common with the rest of the civilized world we stand aghast in presence of the appalling calamity which befell the steamer *Titanic*. We deeply sympathize with those of our own household and the community in general who, in default of positive

cheering information, mourn the loss of loved ones. We note with satisfaction the comparatively large number of survivors and trust that further developments will reveal the names of many, many others.

Herman Struck, the distinguished German artist, who is at the same time renowned as a strictly orthodox Jew and a warm Zionist, is coming to America in behalf of the Mizrachi or orthodox Zionist movement. He is expected on Sunday or Monday next. He will be received with great enthusiasm by the orthodox Zionists of America, and there can be no doubt that his visit will be productive of immense good to the Mizrachi movement. A great reception committee is being organized to meet him upon his arrival, and a monster mass meeting—probably at Cooper Union—will take place shortly for the propaganda of the movement.

AUTO-SPEED REGULATION.

There will have to be more stringent regulations for automobiles in this city; the increase of the number of cars and the reckless driving of them through the crowded thoroughfares will demand that drastic measures shall be taken by the city authorities, and that soon.

not until the day was well advanced that I came upon somebody who wanted something from me—not until I came to the smithy of Johann the Prussian.

I sat down on an old anvil. Johann talked to me. He had not much work to do; for, in Tomsk in Argassoff, all the men were going away, more and more daily. But I forgot all about the sorrowful news when he told me he wanted some steel to make a pair of carriage springs for the owner of the village.

We talked for another little while, and then I set out on my journey homeward, rejoicing within myself that I would have a little money soon—the price of the steel for the springs. I forgot everything in my joy. I even forgot that I was wet, and tired, and hungry, having eaten nothing all the day but the piece of rye bread and the bowl of milk Johann gave me.

Next day I set out with the steel in a sack on my shoulder. And although I again had the beadle's stick to lean on, I was far more tired than on the day before, despite the fact that I had not tramped all around the village in search of customers. I forgot how exhausted I was when Johann told me he was glad I had brought the steel at once. From the beginning he had made up his mind that I would keep him about a week, seeing how deep the mud was which covered the roads. He did not know how anxiously I was waiting for the money.

He gave me bread to eat, and a dish of curds to refresh me. And while I was resting on the anvil, he went away to the landowner to show him the steel, and also to recommend him to buy something else from me. He came back soon. His face shown with gladness. The landowner wanted three plough blades, two for a horse plough and one for a hand plough. I thanked Johann with all my heart, and went on my way rejoicing.

When I was completely rested, and when my clothes were dry again, a few days later, I went to the beadle for the third time to borrow his stick from him. He didn't wish to lend it. He said he could not walk across the street without it. I said to him in a loud voice, shaking my head and my hands in anger: "Reb Shapsel, do you know why you can't go across the street without your stick? It is because you have given yourself the habit of leaning on it, just as if you had no bones in your body to support you. You are not alone in doing this. Every Jew in the village must lean on something. Look how shiny the benches in the synagogue and the House of Learning are with your backs! One can see in them as in a looking glass. And because of this habit which brings you no good whatever, you wish to deprive me of a little support for a few days in a lifetime. Shall I be compelled to walk through the mud which covers one almost to the neck, like a mantle, for want of your stick to help me pick my way out of the ruts? Shall I have to walk with my back bent double from the weight I carry, because you have no wish to wean yourself from your bad habit for so much as a day or an hour? I am taking your stick, Reb Shapsel, despite your grumbling. I will take it whether you wish it or not, every time I am in want of it. Remember my words, Reb Shapsel."

Quaint Folks

I took his stick from its corner. And before I left his cottage, I made deep holes in the floor with its iron point, and drove the strips of sweet smelling bulrushes to the right and to the left of me until they flew about in the air like feathers let loose.

I heard him grumble when I was out of sight. He came out to the door to let everyone hear the complaints he had against me.

But even the beadle's stick did not prevent me from getting tired before I was gone two miles. The sack on my shoulders was far heavier than the one I had carried a few days before. It took all my strength to keep it in place, much less carry it. I sank down to rest on the banks of grass which one finds everywhere, no less than a thousand times, so to speak. I thought I would never come to the end of my journey, and certainly never come home again. I crawled along somehow, almost on all fours. I could not stay in the mud, and allow myself to be soaked to the skin with the driving sleet and rain. In the hours when I was on the road to Tomsk, I hardly knew what was becoming of me. I could only murmur: "I have lost my life as in a game of cards." They were the only words I could remember.

Johann, the smith, was glad I had come so soon. He was surprised at me. The roads had become much worse; and they were not easy to walk through without anything to carry, much less with a weight of iron bending one almost double.

"It is good that you have come," he said. "I can set to work at once.

The landowner will have no cause to grumble because I was too long doing it."

"Johann," I said, "I see that your landowner grumbles, too. I thought it was only the lord of Argassoff who did that."

"I think that all landowners are the same. But one can hear their grumbling a little now and again. After all we live on them, and not they on us," he added. A smile spread across the whole of his broad, good-natured face. His red cheeks were puckered up, and his little gray eyes were lost from sight.

He went away with the iron, sack and all, to show it to the landowner, and to explain how he was going to cut the blades. Before he left me he gave me some bread, and curd-cheese and a bowl of milk. As on the other two days, I sat on the anvil and rested while I ate. He came back long before I felt my weariness leaving me. He was carrying my sack on his shoulders. My heart sank at the sight of it. I thought he was bringing the iron back to me because it was unsuitable. But it was not so. It was quite otherwise. Johann was carrying a sackful of seed potatoes which the landowner had given him for me as a reward for my promptness. He, too, had made up his mind that I would not return for weeks.

All this happened many months ago! I have not earned another kopek since then. I am not afraid of working, or of going here and there for a piece of bread. On the contrary, I have tried harder than ever in my life before to bring back a trifle of my old prosperity. I have been in Tomsk many times, and in all the villages within walking dis-

tance; I mean, I have been to all the villages I could reach in half a day. And I have searched them all diligently from end to end without the least success. The money I got for the iron was soon spent, as well as what I got for the seed potatoes. And we have no bread to eat to-day. There is nothing left me to do but weep with tears of gall, or laugh wildly. I have lost my life as in a game of cards. I can do nothing. I can only draw my shawl lower down on my forehead, until it covers my eyebrows.

I have already borrowed from nearly every single individual in the village. I have not the faintest notion of how or when I can pay back. But God is my witness that I did not borrow for any other purpose than to keep myself and Beilalle and Reb Itzig from dying of hunger.

I got this and that from Chanalle. She shakes her head each time I come into her shop. She seems to be asking me when I am going to pay what I owe her already. And I make haste to say to her:

"Chanalle, trust me with a loaf of bread and a little butter for the Sabbath, nothing more. In the olden times I had luxuries for the Sabbath; such as roast goose and baked potatoes, and pudding, and soup, and what not; but now I am satisfied if I can provide a little butter to cover the dry bread of week days."

She never says a word in answer to my pleading. Yet, I grow red with shame, as if I had committed a crime. I rush out of the shop like a thief, carrying the loaf of bread, and the morsel of butter safely hidden under my shawl.

And now the time has come that I feared to think of. We are starving, and there is no help for us. Only yesterday the end began for us. I went to Chanalle again to ask her to trust me with another loaf of bread, until God knows when. I felt that I dared not ask for a little butter as well. I went early in the morning, so that no one in the village might discover my shame—the terrible shame of going to get a loaf of bread on trust—I who was once the wealthiest woman in the village.

Chanalle looked into my face, and said: "Tsipalle, I will tell what I have been thinking of since the first day you asked me, with pale frightened face, to trust you with a loaf of bread and a little butter for the Sabbath. I have been thinking that I myself will soon be as badly off as you are. How long can I go on giving my goods on credit to the villagers? What will happen when I have nothing left, and no money either? What can happen to myself and to you all?"

My heart sank with shame. I trembled in every limb so that I could hardly stand erect. I did not know what to say nor what to do. I drew my shawl down on my fore-



I believe they are both fools and knaves—fools to think that their belief or non-belief will change the powers or providence of the Almighty; knaves because the wish is father to the thought, and their sole thought is to be free from the All-Seeing Eye, to do everything that their evil desires dictate to them without having to give an account and reckoning for same. As our sages of blessed memory have said, "Slaves to their passion's love license."
