THE INTERRUPTED NAP

Moishe ben Aaron had just become a widower and at his age of three score years and twelve he felt the loss of his spouse keenly. But a man must have a home; alone he could not live, so he wended his way to the house of his only child, a married daughter, where he hoped by helping in attending the children and doing the chores for the household, it would in some way compensate for his room and board.

The synagogue was Moishe's home. Even after the inauguration of the Sabbath on Friday night,

sometimes alone and at other times with one or two others, Moishe would remain in the synagogue all night studying by the aid of the Sabbath lights, until the arrival of the

Hashanah began Friday evening. Moishe, as was his wont, arrived early bringing with him his *kittel*; taking his accustomed seat at the end of a bench near the wall, the fourth

then busied himself to see that everything was in order, incidentally examining the "shofar" and placing it within easy reach, although it was not to be used until Sunday as


listen to the evening prayer. One cannot but feel inwardly anxious on such an occasion. A new year it would be to all, whether in joy or sorrow; whether in continued life here or change of life in death.

His body rocking to and fro, he was soon delving deep into its contents, the accustomed eye alone being able to read in the semi-darkness. Thus he continued for some time until his body now and again jerked as his eyelids dropped forcing them open with a start; the swaying and rocking became more slow and less frequent and in spite of himself, one arm stretched across the open book, slowly his head sank thereon and Moishe ben Aaron was in slumberland.

The newspapers had heralded the advent of the Jewish new year and in glowing articles told of the richness in decoration of the synagogues for the occasion. It so happened that a brawny young colored man, who had more to his debit than credit, reading this notice, thought it would be a good opportunity to make his balance sheets more equal without much risk. fully studied the ground at the same time formulating a plan of operation.

THE SEVEN SINS

Probably not many of us could repeat off-hand a list of the deadly sins, nor yet explain how they came to be thus defined, or why they are seven in number. They belong so clearly to the middle ages. They represent so graphically the monastic mind, and are so much involved in the discipline of the Roman Catholic church that the modern intelligence has gradually forgotten their importance, and ceased to give them a conspicuous place in its ethical codes.

Of course, the number seven is a mystical number, and, as such, has appealed to Eastern as well as Western religious and metaphysical thought. There are seven chief virtues, as well as seven deadly sins; seven spiritual works of mercy, seven corporeal gifts of mercy, seven penitential psalms—to say nothing of seven days of the week, in which the world came into being. Man, according to the Chinese sacred books, has seven material souls, while, according to the Buddhist philosophy, a man is the representative of the great seven-stringed world-lyre. There is nothing, therefore, remarkable in the number—which appears, by the way, in Rossetti's "Blessed Damozel," "and the stars in her hair were seven." But the distinction between capital and venial sins is more arbitrary and less explicable—except in the ecclesiastical assumption that the former were those sins which, being of the nature of a betrayal, cut us off from all the avenue of grace. The sins are Pride, Gluttony, Lust, Envy, Anger, Avarice and Sloth, and the remarkable thing is that they are obviously based on common experiences of human frailty, and are by no means especially ecclesiastical. The corresponding chief virtues are Humility, Chastity, Love, Patience, Bountifulness, Temperance and Vigilance, and, if we may imagine that they were enumerated first and the vices framed afterward to correspond to them, it is just possible that they owe something to Greek thought. For Plato had four capital virtues—Prudence, Temperance, Fortitude and Justice.

If we go to literary history we find no lack of references to the mystical "seven." Their most flourishing period was, of course, the time of the religious plays, through the fourteenth and fifteenth centuries. The Chester plays have constant reference to them; so, too, have the Digby mysteries; and one of the best specimens of the old morality plays, "The Castle of Perseverance," reveals the seven deadly sins in the capacity of doughty champions against the hero, who goes by the name of mankind.

Christopher Marlowe, when he was writing his modernized version of an old mystery in "Dr. Faustus," of course made considerable play with the Seven Vices. They appear in act 1, scene 2, introduced by Mephistopheles, and we notice at

once that they are not the formidable shapes of evil which appealed to the conscience of the early age, but a kind of comic relief—things to inspire laughter as part of the comedy of human folly. To take some examples:

"Pride: I am Pride. I disdain to have any parents. I am like to Ovid's flea. I can creep into every corner of a wench; sometimes, like a periwig, I sit upon her brow; next, like a necklace, I hang about her; then, like a fan of feathers, I kiss her."

"Covetousness: I am Covetousness, begotten of an old churl in a leather bag, and might I now obtain my wish, this house, you, and all should turn to gold that I might lock you safe into my chest. Oh, my sweet gold!"

"Envy: I am Envy, begotten of a chimney-sweeper and an oyster wife. I cannot read, and therefore wish all books were burned. I am lean with seeing others eat."

Observe how Marlowe, the scholar, treats as a supreme exhibition of Envy the insensate dislike of the dullard to learning.

"Gluttony: I am Gluttony. My parents are all dead, and the devil a penny they have left me but a small pension, and that buys me thirty meals a day and ten beavers, a small trifle to suffice nature. I come of a royal pedigree. My father was a gammon of bacon and my mother was a hogshead of claret wine."

What is most observable is that to Marlowe the Seven Deadly Sins have lost their awe-inspiring character, and serve as mere opportunities for mirthful raillery. Not so were they regarded in earlier times.

Spencer makes use of the sins in the "Fairie Queen." They are the counselors of the "foul Duessa," who, because of Una is supposed to represent Queen Elizabeth, is generally taken to designate Mary, Queen of Scots. And Shakespeare? For the great Elizabethan dramatist the sins had little or no dramatic value. Nevertheless, he has two passing allusions. The first occurs in "Measure for Measure" (act 3, scene 1), where Claudio is beseeching his sister, Isabella, to give herself up to Angelo, in order that his own worthless life may be spared.

"Sure it is no sin; Or of the deadly seven it is the least," and the second reference is to be found in "Henry VIII." (act 3, scene 2), in the well-known speech of Wolsey:

"Cromwell, I charge thee, fling away ambition; by that sin fell the angels, how can man, then, the image of his Maker, hope to win by it?"

Ambition here stands for Pride,

ITEMS OF INTEREST IN THE JEWISH WORLD.

The East New York Hebrew Benevolent Association, of Brooklyn, has been chartered by the Secretary of State.

There are 10,000 children attending Jewish educational institutions in Philadelphia, Pa., at a cost of \$60,000 per annum.

A number of Jewish societies of Lynn, Mass., have amalgamated under the name of the Associated Jewish Societies of Lynn.

Through the will of the late Joseph Hirsch, sixteen New York institutions receive bequests ranging from \$250 to \$1,000 each.

Three thousand dollars was raised at a benefit performance for the Jewish Consumptive's Relief Society, of Chicago, Ill., last week.

A mass meeting was held in St. Louis, Mo., last Saturday night to consider the plans of the local Y. M. H. A. to erect a \$100,000 building.

A boycott has been instituted by Jewish housewives, of Chicago, Ill., against kosher meat dealers, and 275 shops have been forced to close.

Although the Progress Club of Fort Smith, Ark., numbers only forty-five members, they have just completed a building costing over \$45,000.

At the annual spring exercises held at the National Farm School, Doylestown, Pa., last Sunday, Elbert Hubbard was the principal speaker.

Mr. S. Hoffnung-Goldsmid has been adopted as prospective Unionist candidate for Northeast Bethnal Green at the next general election.

The programme for the next Central Conference of American Rabbis, to be held in Atlantic City, N. J., in July, 1913, is now being made up.

The annual meeting of the Israelite Alliance of Vienna, which has just taken place, shows that the income during 1911 amounted to 182,499 Austrian crowns.

The first class of the Teachers' Institute of the Hebrew Union College at Cincinnati, O., graduated last week. There were six members in the class.

Former Rabbi Isidor Philo now a practicing attorney at Akron, O., has received the Republican nomination for Congress from the Nineteenth Ohio district.

Governor Johnson, of California, has appointed Dr. Jessica B. Peixotto, of Berkeley, to serve as a member of the State Board of Charities and Corrections.

The dates of the International Conference of the Jewish Territorial Organization, to be held at Vienna have been changed to the 27th, 28th and 30th of June.

In the publication of the Russian General Staff (of the army) mention is made of the assassination of M. Stolypin, stating that "he fell at the hands of a Jewish assassin."

The Chicago Association of Jewish Women will maintain an outing home in Western Springs, Ill., this summer. Mothers and children will be given two week outings.

The peasants of the Russian village of Zaslava (Kheron) have unanimously decided to ask the authorities to declare the place a townlet in order to enable Jews to settle here.

The Magdeburger Sachsenschau has publicly recanted the anti-Semitic opinions which it had advocated for many years. An occurrence of this nature is extremely rare in Germany.

The Fanny Falk Memorial has been dedicated in Pittsburgh, Pa. It is an annex to the Rodeph Shalom Synagogue, and was erected by Mr. Falk in memory of his wife at a cost of \$65,000.

The Jewish Publication Society is about to embark on a campaign for a fund sufficient to insure the society to erect a permanent home. There are now over 10,000 members.

The death has occurred at St. Petersburg of M. Griliches, who recently celebrated the thirty-fifth anniversary of service as senior designer of coins and medals at the imperial mint.

Dr. Marc See died in Paris last month. He was a member of the Academy of Medicine, honorary surgeon of the hospitals, professor of the faculty of medicine, and officer of the Legion of Honor.

Rabbi Philip Weisman, formerly of the Congregation Beth Jacob, of Dayton, Ohio, died last month after a short illness. Rabbi Weisman came to Dayton about twenty-five years ago and retired to private life about fifteen years later.

A congregation has been formed in Wakefield, Mass.

Mr. Phil Levy has been confirmed as Police Commissioner for Butte, Mont.

The new building of the Jewish Sisterhood of Newark, N. J., was dedicated on Decoration Day.

A new dispensary, to be called the Dr. Herzl Dispensary, has been opened in Montreal, Quebec.

There are at present 12 Jewish members out of a total of 118 in the London, Eng., County Council.

According to recent statistics the Jews in the British Isles represent 1 in each 200 of population.

The London (England) Home for Jewish Incurables is about to erect a new wing at a cost of \$40,000.

Dr. David Reisman has been appointed professor of clinical medicine at the University of Pennsylvania.

President Taft addressed the members of the Baron de Hirsch Colony at Woodbine, N. J., last month.

Mr. Martin J. Kohn has been elected permanent chairman of the Maryland Congress of Master Printers.

Franklin F. Wolff has been awarded the Harvard Scholarship from Stanford University for the coming year.

The Philadelphia, Pa., Federation of Roumanian Jews has decided to secure a building for educational purposes.

The Jewish hospital at Buda-Pesth, Hungary, last year admitted 3,429 inpatients, of whom 1,146 were Christians.

Contracts have been awarded for a new synagogue to be erected for the Congregation Anshe Roumania of Newark, N. J.

Signor Azebllo Policarpo Bemporad, professor of astronomy, has been appointed director of the Observatory at Naples.

Mr. Julius Rosenwald has been appointed a trustee of the University of Chicago to succeed John D. Rockefeller, Jr., resigned.

Recently published statistics show that one-fourth of the agricultural land in Hungary is in the hands of Jews, either as proprietors or lessees.

Lee Winn, a negro, of St. Louis, Mo., received a workhouse sentence of six months last week despite his defense that he thought it no offense to strike a Jew.

Mrs. Elmer Black, chairman of the American Arbitration League, has purchased for American production Israel Zangwill's latest drama, "The War God."

Mayor Rockwell, of Akron, Ohio, has appointed Rabbi Louis D. Gross a delegate to the National Conference of Charities, which meets at Cleveland, Ohio, on June 12.

Mrs. Hannah Rosenbloom Van Baalen, who was a leader in communal work in Syracuse, N. Y., died on May 17. Her work was not confined to Jewish charities alone.

The success in London of "The Five Frankforters," the play dealing with the early life of the Rothschilds, has been so great as to necessitate extra matinees being given.

Although the B'nai Berith Orphanage at Cleveland, Ohio, was filled to capacity last year, namely 500 boys and girls, there was not a single death among the inmates.

During the four months of the current year, Jan. 1 to April 30, the Hebrew Free Loan Society of New York City made 6,735 loans, amounting to \$196,510 and collected \$187,167.49.

Residents of Richmond, Va., irrespective of creed, are subscribing for a stained glass window to be erected in Temple Beth Ahaba in memory of the late Mr. and Mrs. Isidor Straus.

Governor Dix has appointed Joseph Barondess to represent New York State at the international convention of Factory Inspectors now in session at Washington, D. C.

The Jewish population of Munich rose to 11,083 last year and comprises one-fifth of all the Jews of Bavaria (55,341). In 1840 the Jewish population of Bavaria was larger than it is now (59,008).

An example of Jewish charity is mentioned by several Philadelphia, Pa., papers in the case of Menucha Fox, who left an estate valued at \$120, of which she bequeathed \$70 in sums of \$10 to seven Jewish institutions.

Testimonial Banquet to Hermann Struck.

A testimonial banquet was tendered to Herr Hermann Struck, the distinguished German artist and Mizrahi leader, by the "Mizrahi Hermann Struck Reception Committee of New York," at Vienna Hall last Saturday night. There was present a large gathering of sympathizers with the Mizrahi movement and of personal friends and admirers of Mr. Struck.

At the table eloquent and enthusiastic addresses in which the highest admiration for Mr. Struck, as a splendid representative of the new type of orthodox Jew in which loyalty to the olden traditions high secular culture, and warm nationalistic feelings are combined, were made by a number of gentlemen. Among the speakers were Rev. Dr. Bernard Drachman, who presided over the gathering, and by Rabbi S. D. Posner, of Jersey City, Rev. H. Maslinsky, Mr. G. Bublick, Mr. S. Lamport, Prof. George Selkowitz, Dr. David Blaustein and Dr. J. Bluestone and Rev. Dr. S. Buechler. Mr. Struck replied to the addresses briefly and with evident feeling. After the address of Dr. Buechler a collection was taken up for the benefit of the Tachkemoni School, which netted a handsome sum.

A large number of letters of regret were received from prominent Zionists and communal workers.

Kehilath Jeshurun to Erect Talmud Torah.

On the last day of Passover an initial fund of \$30,000 was raised at the Kehilath Jeshurun Synagogue for the purpose of establishing a Hebrew School in Yorkville. Steps have been taken to charter an organization to be known as the Yorkville Talmud Torah, and buildings, Nos. 123-125 East Eighty-fifth street, have been purchased. A five story fireproof modern school building will be at once erected on this site. The school will contain sixteen class rooms, a library, and a roof garden play ground. During the day the building will be used for a kindergarten. Provisions will be made for the instruction of about 1,000 children after public school hours, and in the evening advanced classes in Hebrew for those who are employed by day will be maintained. The school will be conducted on a very high plane of efficiency.

Cantors' Association of America.

The installation of officers of the Cantors' Association of America took place at the meeting rooms, 123 Second avenue, Monday evening, May 27. The following officers were installed: President, David Cohn; vice-president, A. Frachtenberg; second vice-president, M. Aronoff; treasurer, Edward Kartschmaroff; financial secretary, Isidore Frank; recording secretary, A. Auerbach, and the Board of Directors: A. Minkowsky, H. Ruscotto, A. Grafman, B. Steinberg, I. Schurr, L. Levkowitz, Chas. Kaminsker, P. Rosen and M. Rosenstein. Mr. Leon Kramer was unanimously re-elected as conductor.

The Roman Catholic Bishop, Count Mikes, recently visited a town in his Hungarian diocese and received a deputation, headed by the rabbi of the Jewish congregation. In replying to the address of the rabbi the Bishop expressed his warm sympathy with orthodox Judaism on the ground that it had passed through severe struggles and was called upon to make great sacrifices in the cause of loyalty to the traditional principles of the ancient Jewish faith.

A Famous Cantor Here.

Ober Cantor Rosenblatt, of Hamburg, who arrived in New York on June 4 by the steamer Kron Prinzessin Cecilie has been invited by the Congregation Ohab Zedek, of 18-22 West 116th street, to officiate at services Saturdays, June 8 and 15.

Cantor Rosenblatt is known to be one of the most pious Chazanim in Europe. His singing is awaited with great interest, as there are many in this city who have heard him in Hamburg and speak of him in terms of the highest praise.

Hebrew Free Loan Association.

The report of the Hebrew Free Loan Association shows that for the first five months of the current year it made \$4,888 loans amounting to \$247,600 as against \$2,269 loans amounting to \$230,100 for the same period of last year.

The society appeals to the public for larger support in order to keep up with the increased demands. It made last year 19,949 loans, amounting to \$560,025, and since it started 194,560 loans, amounting to \$4,723,262.

Money is loaned in sums of \$5 to \$200 to applicants irrespective of creed on notes indorsed by responsible people without charge of interest or expense of any kind, the borrower repaying the loan in weekly installments.

Roumanian Federation Convenes.

The fifth annual convention of the Roumanian Jews of America was opened last Saturday evening, June 1, at the Manhattan Lyceum and closed the day following. In his message the president, Dr. P. A. Siegelstein, dwelt especially upon the importance of the Home for the Aged, recently established at Mount Vernon, which promises to be an institution reflecting great credit and honor upon the Roumanian Jews. The Federation is composed of more than twenty societies representing a membership of over 6,000.

Dr. P. A. Siegelstein was re-elected president, and Dr. Emil Koffler as second vice-president. There will be another meeting in the near future for the purpose of electing the other officers and directors.

Y. M. H. A., of the Bronx.

The Union of Hebrew Teachers, of Greater New York and vicinity, at a general meeting last Sunday, resolved to call a congress of Hebrew teachers of the United States and Canada. The time and place of this congress will shortly be announced. A temporary committee of ten has been selected to work out in detail the preliminary preparations for this great undertaking. Young Women's Hebrew Association.

Although most of the class work has closed for the season, the children's Hebrew classes will continue their regular work throughout June and the summer months as well.

We learn with deep regret of the death of our colleague, Sender Jarmulowsky. His many charm and wide usefulness, attracted staunch friends, who rightly valued him for what he was and what he did. The Jewish Immigrant.

The intellectual problems and the advanced thinking of the Hebrew, his fondness for study and his freedom on the whole from wasteful forms of dissipation, sport and mental stagnation, constitute him a more fortunate acquisition for this country than are thousands of the descendants of colonial settlers. In short, we must reconstruct our idea of democracy—of American democracy. This done, we must construct a new picture of citizenship. If we do these things we shall welcome the rugged strength of the peasant or the subtle thought of the man of the Ghetto in our reconsidered American ideals. After all what are these American ideals we boast so much about? Shall we say public schools, the ballot, freedom? The American stock use private schools when they can afford them; they too often leave town on election day; as for freedom, competent observers believe it is disappearing. The conservators and believers in American ideals seem to be our immigrants. To the Russian Jew Abraham Lincoln is a god. If American ideals are such as pay honor to the intellectual and to the spiritual or foster human brotherhood or love culture and promote liberty, then they are safe with our new citizens who are eager for these things.—Rev. Percy S. Grant, Minister of the Church of the Ascension, New York City, in the North American Review, April, 1912.



Sender Jarmulowsky

Sender Jarmulowsky, the well-known banker, died at his residence, No. 16 East Ninety-third street, on Saturday, June 1, at 11.30 a. m. Mr. Jarmulowsky had been ailing for some time past, and his death was not altogether unexpected.

Mr. Jarmulowsky, who was born in the province of Lomza, Russia, seventy-one years ago, was without doubt the best versed lay Hebrew scholar in this city. He had a geshibah training and received "smicha" from some celebrated rabbinical authorities, but never followed the calling of rabbi, although for many years he was wont to expound the weekly portion of the law at the Mincha services either at the Zichron Ephraim, Kehilath Jeshurun or Orach Chaim synagogues, of all of which he was a member.

Mr. Jarmulowsky came to America in 1873 from Hamburg, where he had previously been in the banking business, and established himself in Canal street, this city. His business prospered, and to-day his concern occupies the ground floor of a magnificent fourteen-story building just completed and which is the largest building on the lower East Side.

To enumerate Mr. Jarmulowsky's many charities would be impossible in this limited space. He was the first vice-president of the Lebanon Hospital and besides being a contributor to almost every Jewish charity in this city, distributed alms with a free hand and helped many a poor family and indigent scholar.

Funeral services were held at his late residence on Monday morning, Rabbi M. S. Margolies assisted by Cantor Mitnick officiating. The body was then conveyed to the Kehilath Jeshurun Synagogue, East Eighty-fifth street, where Rabbi Margolies spoke. From thence the body was taken to the Zichron Ephraim Synagogue, East Sixty-seventh street, where there was an immense gathering present. Eulogies were pronounced by Rabbis Margolies, Drachman, Kaplan and Horowitz and Mr. Jonas Weil.

Mr. Jarmulowsky is survived by a widow, four sons, Messrs. Albert, Meyer, Louis and Harry Jarmulowsky, and two daughters, Mrs. Amelia Clark and Mrs. Blume Ettlinger.

The execution of such plans will affect lands situate in the Counties of Greene, Ulster, Delaware and Schoharie, and will also affect the flow of water in streams flowing in or through the Counties of Albany, Columbia, Delaware, Dutchess, Greene, Montgomery, Orange, Putnam, Rensselaer, Rockland, Saratoga, Schoenectady, Schoharie, Ulster and Westchester, the riparian rights on said streams, and also the water rights of said streams.

All persons, water works or municipal corporations and other civil divisions of the State of New York, who have objection to the execution of said plans, in order to be heard thereon, must file such objections thereto in writing in the office of the Conservation Commission in the city of Albany, N. Y., on or before the 10th day of June, 1912. Every objection so filed must particularly specify the grounds thereof.

London at last has its Sirota case.

The Hebrew Free Loan Association of this city submits its annual report for the latest fiscal year to the community with the hope that its work will receive from all sides that support it abundantly merits. We trust this indirect appeal will bear good fruit.

The Jewish Theological Seminary of America has outgrown its own home with respect to its annual commencements. That of last Sunday was held for the first time without the walls of its building in West 123d street. Whether the young men who received their *S'micha* in the Carnegie Lyceum will make as inspiring guides for their congregants as their predecessors remains to be seen.

That was a fine tribute which Nathan Straus paid to the late Isidor and Ida Straus, arriving here from abroad last week. It concerned itself with the broader implications of their deaths, as examples of the heroism of an individual Jew and Jewess, rather than with the narrower grief of a close relative for the loss of loved ones. He, too, like his brother Isidor, is of the stuff of which heroes are made.

The May number of *Jewish Charities* is an excellent issue of this journal, devoting, as is just, especial attention to the Dillingham immigration bill. The careful and deliberate argument of former Congressman William S. Bennett against this measure deserves to be thoroughly digested by every person interested in the subject. This means that all citizens who take thought of the future of their country should read this article.

The seventh biennial meeting of the National Conference of Jewish Charities begins next Sunday evening in Cleveland. That city is a proper place of meeting for so important and influential an organization, for Cleveland is a prosperous and developing city. The programme of the coming meeting augurs well. The charity workers do these things better than, for example, the rabbis. They permit a subject to be presented and discussed at their meetings only by experts.

"Dr. Abrahams, Dr. Hyamson, Dr. Gollancz and Dr. Hertz form upon the British basis the only possible quartet of candidates at present. No one of them, by reputation, possesses all the qualifications that we have been led to look for in a Chief Rabbi judged by the norm at which Dr. Hermann Adler set the office." Thus discourses "Mentor" in *The Jewish Chronicle*. Without specifying we beg leave to dissent from his judgment in the case of at least two of those whom he mentions.

Men like David Ritter von Gutmann, of Vienna, and Sir Albert Sassoon, of London, who died only the other day filled a distinct niche in the economy of their communities. Both were possessed of princely fortunes, and, in the latter case at all events, reckoned their descent from the intellectual leaders among their co-religionists of a more or less remote antiquity. They took a keen interest in the welfare of their brethren and were ever ready with their means and advice when danger was threatening the security of the Jews in any part of the Eastern world.

It speaks volumes for a Jewry of which the following can be said: " . . . But I must not talk of this just now. It will keep 'ntil the Jews of Chicago without consulting the *Luach* will discover when *Rosh Hashonah* is, for you know when in Chicago one asks the other, 'When is *Rosh Hashonah*?' the answer invariably runs as follows, 'It is the week after Doctor Hirsch comes back from Europe.'" (Laughter.) And the pathetic part of this excerpt from an address is that its statements are unqualifiedly true—of those Jews of Chicago whose light rises and sets with the Sinai Congregation.

KOHLER AGAIN

THE Rev. Dr. K. Kohler, president of the Hebrew Union College and honorary president of the Central Conference of American Rabbis, is an estimable gentleman, who seems to have a genius for saying things which are almost always calculated to ruffle instead of sooth a large and important section of his brethren. For, we are certain that Rabbi Kohler will allow that the orthodox Jew, even the Russian or Roumanian or Galician Jew, is just as much of a Jew as the German Jew, the French Jew, or the English Jew, who follows the leadership of the Reformed rabbis.

Here is a case in point. Rabbi Kohler, at the recent meeting of the newly-formed and somewhat nebulous Eastern Council of Reformed Rabbis in this city, was represented on the programme by a paper in the course of which he said: (The purpose of the new council) is "the strengthening of the cause of Reform in the East, and especially in New York, where so many elements have combined to crush or strangle Liberal or Progressive American Judaism and make the spirit of Ghettoism and Orientalism dominant among the millions of Jews living there and millions yet unborn." Instead of welcoming the Eastern Council as an organization of Reformed rabbis, which would do well in endeavoring to combine the diverse elements of our community into a strong force for good, which would in its limits work to upbuild Jewry in these parts rather than to set Jew against Jew, Dr. Kohler waxes enthusiastic over the new foundation because he sees in it another opponent of that terrible and terrifying Orientalized Orthodoxy which has done so much to restore Judaism on the Atlantic seaboard of America to its pristine condition, which has put our faith and its followers here in these parts in touch again with the rest of the world. Incidentally, this Orientalized Orthodoxy has, by insisting on the things that endure, diminished the influence of such evanescent and ephemeral movements as the one with which Dr. Kohler, the "annual picnic," and even the Eastern Council are identified.

No wonder Dr. Kohler seized gladly the opportunity "to take a fall" out of orthodox Judaism. No wonder that he grew "hot under the collar." But ineffective and inapt as usual were his diatribes on this occasion. We of the "Ghettoized, Orientalized" East know what to expect from Dr. Kohler militant.

THE CHIEF RABBINATE

ANGLO-JEWRY seems to be a step nearer the solution of this problem, which has affected for almost one year now every section of that community in the religious life. We refer to the action of the council of the United Synagogue in formally inviting applicants for the vacant post of chief rabbi to register themselves.

This much accomplished, it does not become us to comment on the men and personalities who will figure in the coming election. Withal its transcendent importance, the question is certainly a fair one: Has not the chief rabbinate as an institution somewhat outworn itself in the course of the decades since its establishment? Just as a state church in the British Empire has grown to be less and less part and parcel of the governmental system, so in Anglo-Jewry the ecclesiastical headship does not, cannot mean as much to-day as it signified to our forbears, for example, in the middle of the past century.

And we must confess that this circumstance was a logical result of the religious structure of Jewry at large in the Diaspora. Each congregation is *volens volens* a law unto itself. The splendid headship of the English chief rabbi was not sufficient to make every Jew in the regions directly under his sway acknowledge his suzerainty. Then, too, it is apparent in the present election that the chief rabbi of the United Hebrew Congregations of the British Empire is first and foremost the rabbi of the United Synagogue of London, and that, in the latter organization, he is connected by strong ties with the *shool* in Duke's Place known as the Great Synagogue.

With the great traditions that have grown up around the chief rabbinate in the period of the Adlers, father and son, one will not willingly dispense. These should and can be preserved. The office itself will in a sense live in the future, if those who now must undertake the selection of a spiritual chief approach their task in a broad and thoroughly Jewish spirit. By Jewish we mean widely human, taking account of the traditions of our race and faith since time immemorial. This is the supreme test which our brethren in London must face. May they succeed in their purpose to the glory of God and the exaltation of His holy name among all men!

The splendid victory which Congressman Goldfogle and Sabath won in the Committee on Immigration of the House of Representatives will, we sincerely hope, signify the permanent defeat of the cause dear to the advocates of the literacy test. Never before the present Congress were the friends of restriction so strong or so demonstrative. Never previously, to our recollection of late years, did they carry out their designs to the extent they reached at this session. Congressman Goldfogle has kept up a valiant and unequal fight against these modern Know-Nothings for some time, and we rejoice with him in his present success. With the early adjournment of Congress a probability, let us hope that we have heard the last of this literacy test. While it is too much to expect that such projected measures will never again be heard of in the legislative halls, we trust that the friends of such legislation will be conspicuous by their absence from future national legislatures.

A STRIKING PARALLEL

אכנו דברך ואורשנו ואעשה אהך לגוי גדול ועצום ממנו

"I will smite them with the pestilence and disinherit them, but will make of thee a greater nation and mightier than they." (Num. xiv., 12.)

THE thoughtful reader of this week's portion containing the story of the spies may observe a striking parallel between the latter and the story of the golden calf. That this parallel should exist is not astonishing, since both stories deal with essentially one and the same thing—with a crisis threatening the very life of Israel as a nation. For on each of these two occasions Israel's sin against God was of such a nature that, had adequate punishment been meted out for it, Israel's career as God's messenger would have come to an untimely end. The worship of the calf meant the denial of the very message intrusted to Israel. The lack of faith shown by those who repudiated the Promised Land, meant the refusal to accept the conditions under which alone this message could be effectively delivered; for only as an independent nation living in its own land could Israel hope to become a light unto the nations. Both sins, then, shook the very foundations upon which Israel's historic mission—its excuse for being—rested. Hence the points of similarity between the two narratives.

Let me enumerate these points one by one:

First. When God saw the riot around the calf, He told Moses wrathfully that He would destroy the people and make of Moses a great nation. Similarly after the backsliding of the spies, God—as our text shows—expresses this same desire, in practically the same words, to destroy the people but make of Moses "a great nation."

Second. In the story of the golden calf, Moses' principal plea in behalf of Israel is: "What will the nations say?" His chief argument in the story of the spies is again based upon the same reference to the scorn of Israel's enemies.

Third. The story of the golden calf winds up with that magnificent climax: the proclamation of God's attributes whose keynote is—God's long-suffering mercy. In the story of the spies we hear once more the mention of these attributes; nay, here they are introduced with the words: "As thou hast spoken, saying"—words that can only be interpreted as quotation marks having reference to the story of the golden calf.

These three points justify the assumption that the intent of both stories is the same; that a single set of ideas underlies both; that these ideas are coherent in themselves. Let me now set forth the meaning underlying these three points in their given order:

First. God's saying that He would make of Moses a mightier nation might be interpreted in the sense than in the historic development of mankind the great man is more important than the masses. Let the people perish but let the one prominent personage live and all will be well. This reminds one of both Carlyle and Nietzsche. According to Carlyle, the Hero is the origin of History; according to Nietzsche, the Hero is the goal of History. According to Carlyle, all History proceeds from the exploits of the superior human type; according to Nietzsche, all History tends to produce the superior human type—the Superman. Neither of these teachings is in accord with Judaism. Judaism teaches that the meaning of history is not to be sought in the few but in the many; not in the individual but in the group. The birthpangs of the generations are not to result in the production of a few exceptionally gifted individuals, but in the harmonious and gradual development of all humanity along the lines of ethical perfection. Moses, therefore, deprecates the thought that he, the individual, could be the origin of a mighty nation, and his answer to God is, "Forgive the people or blot me out of thy book which thou hast written." Hence I take it that the dialogue between God and Moses on this subject is a dramatic representation of the democratic ideal of Judaism that "in the book of destiny which God has written" the central figure is not the Hero but Humanity.

Second. Because all development is gradual, the Divine Plan was to lead first one nation—the Jewish Nation—to the height of perfection, so that through it all humanity might be gradually improved. In the light of this thought we can understand Moses' repeated reference to the dreaded scorn of the nations. We are not to suppose that, not unlike some of our contemporaries, Moses was morbidly afraid of "What-will-the-nations-say?" Moses feared the effect God's punishment might have upon the nations by way of alienating them from God forever. If Israel, God's messenger, comes to grief, what shall become of God's message to the world? What shall become of the cause of righteousness and justice?

Third. The idea that God is long-suffering and merciful, when translated into terms of history, means nothing more nor less than that the development of mankind towards righteousness and justice is a matter of gradual unfoldment requiring untold ages for its final consummation. God is patient. God waits. Time does not weigh as heavily upon the infinite God as upon His finite creatures. If God counts time at all, His unit of measurement is larger than ours. "For a thousand years in thy sight are but as yesterday." And while the nations of the earth boast of their enduring glory, "He that sitteth in the heavens laughs," well knowing that their glory is but of a day or two, and that in the end only those nations will endure that will follow Israel on the journey toward the Promised Land of the Future.

To be sure, Israel too oft stumbles; but in the main its face is set toward the golden goal of ultimate perfection. Therefore, all failings despite—Israel shall retain its place in the vanguard of human progress. This is the combined lesson of the story of the calf and the story of the spies.

The late Sender Jarmulowsky, one of the pioneer Jewish bankers of this city, was in the truest sense of the word a great *Lamdan*. In addition, his charity was open-handed and widely-distributed to all who worthily claimed his assistance. He possessed the olden Jewish virtues to the full: God blessed his worldly affairs with success and vast pecuniary rewards, and he utilized that which he received for the highest good of his fellowmen. In calling the late Sender Jarmulowsky the greatest lay Talmudist among the Jews of this city we are extending to him only his due. Oftentimes at the *Mincha* services of the congregations with which he was affiliated, he entered the pulpit and delivered a *D'rosha* which for learning and power could fairly rank with the word-products of professional preachers. New York Jewry is much the poorer for his quitting this life. In mourning his loss we recall with pride that his was a strictly orthodox way of life, that he was ever a tower of strength among his brethren in faith in this city.

Rabbi Emil G. Hirsch may indeed be called the "rabbinical captain of industry." Always in receipt of a princely salary, his congregation was probably fearful that large and wealthy Eastern *kehilloth* would do as much for their spiritual guides, so they recently increased his annual compensation to no less than \$20,000. This figure will stand for a very long time, we are fairly certain, as the acme of rabbinical salaries. Financially, Rabbi Hirsch has more than "made good."

We learn from news dispatches that Rabbi Leon Harrison, of St Louis, Mo., was held for speeding his automobile last Sunday. This couldn't happen to any of our orthodox rabbis. Their congregations see to it that their salaries will not warrant such luxuries as automobiles.

The committee took the bill from the table and struck out all the provisions of it and substituted in their place the Burnett Literacy Test bill. While the Burnett bill, which proscribes only a reading test in any language, including Yiddish, contains a number of exemptions from the test, is not satisfactory and meets with my decided opposition, yet the complete defeat of the Dillingham Immigration bill by the committee is a great victory. Judge Sabath, of Chicago, worked hand in hand with me in opposing these bills, and we are glad to have been able in the committee to successfully oppose the obnoxious feature of the Dillingham Immigration bill.

Federation of Oriental Jews.

The coming together of the Jews of the Levant has somewhat modified the anxiety felt concerning their well-being in our city. It was known that from forty-five hundred to five thousand of them were among us, many of them without occupation or means, and unacquainted with the vernacular. A federation of the Turkish, Arabic and Greek societies was agitated, and during the past month meetings were held at the Settlement House, No. 186 Orchard street, at which meetings fourteen of these societies were represented by delegates, resulting in a federation. A constitution has been adopted, and a number of committees appointed. A hopeful feeling has arisen that much of the misery and embarrassment of the new immigrants and those who may follow them will be materially avoided. Dr. De Sola Pool has been elected an honorary president, and the Sisterhood of the Shearith Israel Congregation, of which he is the assistant rabbi, has opened a class for instruction in English at the Neighborhood House, No. 336 East Fifth street. Young Turkish men, under the tuition of a competent instructor, meet there every evening for English.

It is very gratifying to see the interest which the old Spanish-Portuguese congregation of this city is manifesting in behalf of these Oriental Jews, and we expect the happiest results from it.

A visitor to the meeting of the federation will derive much pleasure. A more orderly assemblage will not be found anywhere. The secretary is a very busy man. After reading the minutes in English, he is requested to put in Spanish, and an Arabic or Greek-speaking member is called upon to do the same for his countrymen in their respective languages.

The officers are: Joseph Guedalicia, president; A. J. Amato, financial secretary; Kol Chamiral, treasurer; M. Zadik, recording secretary.

Isidore Osorio is chairman of the Committee on Religious Matters.

Visit of Israel Abrahams to America

Arrangements are being perfected for the visit to America in the fall of 1912 of Israel Abrahams, M. A., reader in rabbinic literature at Cambridge University, England, and author of "Jewish Life in the Middle Ages." Mr. Abrahams' visit is upon the basis of the lectureship inaugurated by Adolph Lewishohn, Esq.

Mr. Abrahams is to deliver lectures at Yale, Columbia, Harvard, Johns Hopkins, Chicago and Berkeley universities, and before the Hebrew Union College of Cincinnati. In addition, Mr. Abrahams will give addresses before the Free Synagogue of New York and Sinai Congregation of Chicago and at Philadelphia, Newark, Baltimore, Washington, Pittsburgh, Detroit, Indianapolis, Louisville, St. Louis, Denver and San Francisco.

PLEASURE.

What is pleasure? If you ask a hundred people this question you will most likely get nearly as many different definitions. As people are constituted differently, and as all natures run in their own peculiar channels, so, it seems, do what they call their pleasures.

Of course, each strata of society has what it calls its pleasures, and what other people witnessing the supposed enjoyment of them also call pleasures. 



The Hebrews have been accused of a certain form of ancestor worship, although a denial of this in a sense seems well established. The Russian Senate has approved of the policy of the Minsk Governor not to permit the existence of Jewish literary societies on the ground that they might foster hatred toward other nationalities.

The Independent Order Brith Abraham at its last convention reported that forty-five lodges and 13,468 members were added last year, making a total of 654 lodges and 163,677 members of the order.

The University of Athens, Greece, has conferred the honorary degree of doctor of law, honoris causa, on three Jews, namely, Dr. Max Nordau, Dr. Paul Ehrlich and Prof. Alfred Philippson (Bonn).

The Mount Sinai Society, the oldest philanthropic and benefit society in Paris, celebrated its centenary recently by a special service at the synagogue in the Rue des Tournelles and a banquet.





But we must not forget that the Jews are not an imperialistic but a spiritual nation, and to enlist as a soldier in the Jewish army requires not physical strength, not the brutal strength of arm by which one can fight, kill and conquer new territories; but mental vigor—that vigor which preserved the identity of the Jewish nation despite the thousands of years of suffering and persecution; not the strength of body by which one can take a life, but the strength of mind which enables one to give his life, if necessary, for the survival of his nation. And this kind of strength, I believe, is sufficiently developed in the average boy at the age of thirteen.

Ladies and gentlemen, my parents have been kind enough to me to teach me the Hebrew language and Jewish history. For this I shall ever be thankful to them, for it is the knowledge of the past of my people that fills my heart with pride to realize that I am a son of that nation whose privilege it was to spread light and civilization throughout the world. And in the presence of this worthy assemblage I promise you, my dear parents, that while I intend and hope to remain loyal to the country which was the first to open her doors to my perse-

The Law of Life

Dear Children:

Sometimes on a Friday night my little black-eyed boy climbs upon my knee and begs me "Please, papa, tell me about the lions," and of all the stories about the lions that I tell him he likes the story of Daniel in the lions' den the best. When human strength is pitted against brute strength, although man is the conqueror—as in the other stories—it does not seem to appeal so much to his young imagination as does the picture of Daniel, the man greatly beloved, standing in the midst of the fierce lions who crouch about his feet, as submissive as the most faithful dogs to their beloved master.

In his childish intelligence my little boy illustrates, instinctively, the Law of Life that places the human mind above brute force. Strength is superb, the strength that enables a Samson to rend a lion as he would have rent a kid, but the light of Divine intelligence that shines from a Daniel's eyes and makes the lions quail beneath his gaze is far more superb.

I have told you about the illustrious ancestor of Daniel, King David, who, casting aside all royal luxuries, spent his nights in the study of the Torah; how many of you, dear children, know that he, too, had killed a lion? When he was a little shepherd boy, feeding his father's flocks, there came a lion and a bear and bore off a lamb out of the drove; he went after them and killed the lion and the bear and saved the little lamb. There are not so many of you that know this story about King David, but you all know that King David was the Sweet Singer of Israel, that his beautiful songs, the Book of Psalms, refresh the weary, console the sorrowful, sustain the afflicted and give new life to those to whom life would have been an unbearable burden were it not for the sublime spirit of cheerfulness that these songs impart to them.

Thus you see it is the Law of Life that the Torah or the Law of the Higher Life shall rule the world, and not the strength of the mighty, for although David was skilful as a player, a mighty valiant man, and a man of war, and intelligent in speech, and a person of a good form, and the Lord was with him, yet the description of these qualities are thus paraphrased by our Rabbins "skillful as a player" in the Holy Scriptures, "and a mighty valiant man" in the Mishna "and a man of war" skilled in the "warfare of the Torah," "and intelligent in speech" and in good actions, "and a person of a good form" in the Talmud, "and the Lord is with him," the Halacha or the Jewish law is decided according to his opinion.

And do not think, dear children, that because David was the King, the law was decided according to his opinion, as the crown of the Torah is greater than the royal crown. It was just because he prized the crown of the Torah far more highly than his own crown, as you have already seen, and as I hope yet to show you, that he became so learned in the Torah that he was the head of the Synhedrin, who sat in the Sheveth Tachkemoni, or Place of the Wise King David, was superior to all of them in physical beauty, in wisdom and in strength, and to give you an idea of King David's wisdom

I will just mention the fact that the chief of his captains, Adino the Ez-nite, slew 800 of the enemy at one time in a battle, single handed, and immediately thereafter sat in the Sheveth Tachkemoni and studied the Torah. When a man is exhausted in such a terrible battle he is hardly in a fit state to master the intricacies of the Jewish Laws, and yet he was wise enough to accomplish it, and King David was still wiser! This proves how true is the maxim of the great Sage Hillel, who is also a descendant of King David, that "the more systematic study, the more wisdom."


