is sinful, but thou especially."

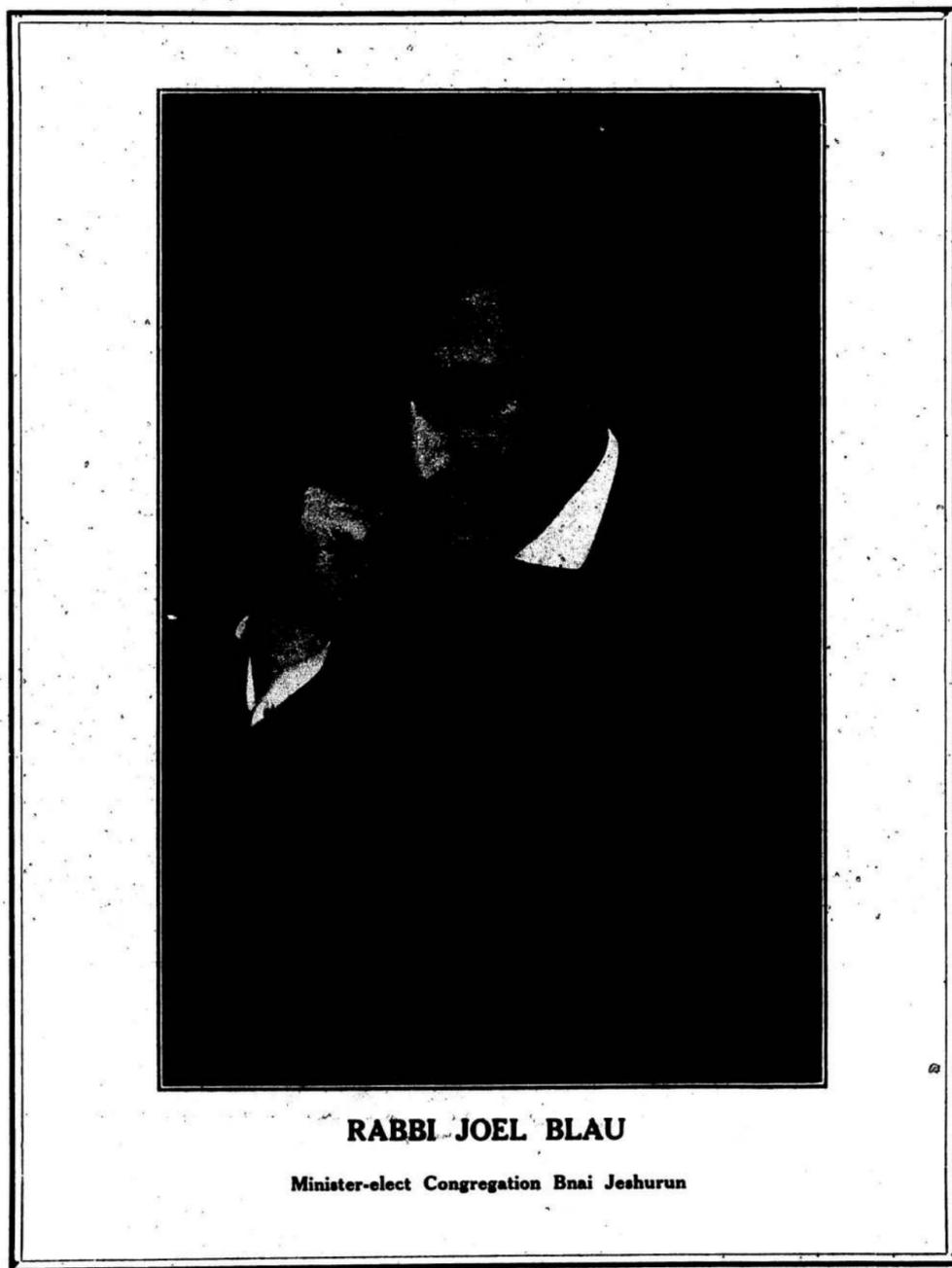
"Especially?"

What Ails the New York Kehillah?

Any comment on the work of the New York Kehillah at this time is apt to be viewed with suspicion by its leaders. The community has been "rattled" by so much criticism of an indifferent sort that it would not be surprising if all criticism were regarded as pernicious.

The writer, however, is a friend of the Kehillah movement. As one of a group who believed it to be an important step in the direction of Jewish union, he contributed something to the organization of the New York Kehillah. He feels, therefore, that the following review of its tendencies is entitled to be considered on its merits, without prejudice.

The leaders of the Kehillah seem to be unaware of what is going on. They do not understand the temper of the community. The petty and scattered criticisms to which it has been subjected, and to which it seems to have disdained a reply, is symptomatic of a serious condition in its affairs. That criticism does not fairly represent the indictment which is slowly gathering for an effective presentment.

The Kehillah was the outcome of a spontaneous impulse to create a central organization to speak and act for the composite interests of the community as a whole. It arose as a protest against the charges of General Bingham. That incident crystallized the latent sentiment, and it was urged from all quarters that there should be a permanent organization to act for the Jews of this city, in their name and with their support.

For years local Jewish affairs had been represented by scattered and unsystematic fragments of endeavor. For years the various elements, of diverse antecedents and ideals and tempers, were distrustful of one another, unwilling or unable to co-operate. The Bingham affair for the time united them all in defense of Jewish interests. It seemed that the time had come for the introduction into Jewish life here of that traditional form of self-government in which we had, in the past, in other lands, united for our common interests.

This genuine democratic impulse has been completely dissipated. The Kehillah, in the three years of its existence, has succeeded in starting a number of important local Jewish enterprises, but it seems to have lost the confidence of every element that had joined in its organization. Radical Jews, keen in their vision of principle and theory, were the first to desert. Orthodox Jews, by tradition and training presumably appreciative of a Kehillah's work, have been loudest in their opposition. Reform Jews, pressed into the organization by the rush of popular enthusiasm, with the decline of popular interest, have been gradually departing. Even the Zionists, admittedly the best friends of the Kehillah, now seem to be looking with anxiety at the trend of affairs and are silent only because they hope there will be a change for the better.

The Kehillah seems to have lost its representative character. It seems to have abandoned the very essence of the composition of a Kehillah. It is now, in effect, operating as a benevolent despotism.

Over everything it now does we may read this motto: The people are not to be trusted. Things are better done in committee, without publicity or discussion, without interference by well-meaning or incompetent, or unruly, "leaders of the people." Do the work first, then, if you think it desirable, get the approval of the people. You cannot have a democratic representation for Jewish affairs. It is impracticable. It is unnecessary. It is even dangerous.

I shall not attempt to justify democracy to American Jews. To Jews born in this country that would involve elementary propositions. Nor is it necessary for Jews who have emigrated to this country. They have come here filled with aspirations for free, democratic conditions of life. Furthermore, may they be presumed to have learned something from our leaders, who have been preaching American ideals for the last thirty years?

The pupils seem to have profited by these lessons, but their teachers have forgotten them. The preachers of de-

mocracy in American life are fearful of the results of democracy in Jewish life. It is the sons of persecution who are behind the demand that the New York Jewish community be organized on a democratic basis. It is because the Kehillah has neglected to listen to their demands, crudely put, often indirectly and offensively urged, that it is now facing a crisis.

It is axiomatic that there can be no Kehillah unless it is democratic. That is implied in the name, and especially an American Kehillah which has no power to coerce support, must keep its finger constantly on the communal pulse. Its form of organization must allow free play for public opinion. To ignore or to affect to ignore it is fatal. Its success, therefore, is to be measured not so much by what it does as by how it does it.

That is to say, the Kehillah may accomplish a great deal of concrete good, but unless it has the direct backing of a broad, democratic constituency, it becomes not an efficient Kehillah, but an efficient bureau of education, or an efficient Waad-ha-Rabbonim, or efficient in the specific work it is doing. As a Kehillah, its unequivocal aim should be not to establish institutions, or to do specific acts of benevolence, but to create and become the government of the local affairs of the Jewish community. What that government shall do must be left to its citizens.

Who will say, measured by this standard, which is the traditional and only possible standard in a country where representative government is in vogue, that the New York Kehillah is such an organization? Or that a majority of its leaders have earnestly and consistently desired or aimed to create such a Kehillah?

Yet, when the Kehillah was organized, that was the ideal of those who aided Dr. Magnes in his efforts. How was this ideal frustrated? How was it transformed into the anomalous thing which it has become?

The first step in the confusion of the Kehillah's ideal and its decline as the official representative of the community, which it aspired to be, was taken when it entered into what seems to have become an indissoluble alliance with the American Jewish Committee.

That committee was born out of a keen desire of a number of influential Jews of the East to form a national organization to act for American Jews. But while appreciating the value of a representative body, in theory, they were, it seems, averse to having the larger affairs of American Jews reviewable by the people at large, in large committees or public conventions. They had no confidence in such methods. They wanted to have the people behind them, but at the same time, seemed not to have the courage or the assurance or the willingness to organize them.

This attitude was consistent with their previous training in Jewish affairs. It agreed with the prevailing Jewish ideal not to assert special Jewish interests. For many years American Jewry had been represented in its national affairs by agents with carte blanche mandates from organizations like the Union of American Hebrew Congregations, or the Independent Order B'nai B'rith, or by men who spoke in their own names, or as alleged representatives of various organizations. But with the growth of the Jewish population, the conflict of political ideas and personal ambitions, the development of Zionism and its subordinate currents of opinion, a growing sentiment required that men speaking for the Jewish people be their accredited agents and that their credentials have something written in them by their constituents.

This sentiment was used by the men responsible for the American Jewish Committee to take the control of Jewish affairs from the Union of American Hebrew Congregations, the Independent Order B'nai B'rith and from other responsible and irresponsible "leaders of the people."

The powers of the organizations named seemed to have waned. The new leaders were abler, more influential, more resourceful, than the old. Without a change in the alignment of forces in Jewish life, however, the old organizations could not be displaced. But with the rise of the demand for direct representation in Jewish affairs, the gentle-

men of the Jewish Committee saw their opportunity. They made themselves part of the movement. They seemed to be willing to take advantage of it in order to place themselves at the head of Jewish interests.

But with the organization of the committee by the co-optation of its members by an inner committee, the democratic sentiment was not satisfied. Co-opting members was not sufficient. It was felt that some form of direct election must be devised.

The Kehillah was a local stream that had its source in the general feeling that every individual had the right to a voice in Jewish life. When the New York Kehillah was formed as a reply to the Bingham charges, the American Jewish Committee saw an opportunity to attach itself to an organization that was democratic in form and represented, in theory, the largest aggregation of Jews in this country. Finding it to be inadvisable to get its credentials in any other way direct from the people, it decided to get them from local Kehillahs. Thus it was hoped that in time the committee would for all purposes be the actual instead of theoretical representative of American Jewry.

But, while swimming with the current of democratic progress, a majority of the members of the American Jewish Committee had not freed themselves from their traditional prejudices against the new ideals of Jewish life. They took cognizance of the New York Kehillah, but were averse, it seems, to have it go along without control. They therefore entered the first Kehillah convention, participated in its deliberations and were potent in swaying the convention to their point of view. They were men of large influence and of forceful personality. They maneuvered an alliance with the Kehillah, which was embodied in its constitution. The American Jewish Committee reserved jurisdiction over national affairs, and seemed to grant the privilege of taking care of local affairs to the new Kehillah. The executive members of the Kehillah became members of the American Jewish Committee. An executive committee was provided for, one-fifth of whose number went out of office every year, thus making a change of administration impossible in less than three years. As local leaders in Jewish affairs, the representatives of the American Jewish Committee were elected to office in the Kehillah, and being in both organizations, they felt secure against insurgent movements. They thus acquired dominance over the subordinate body.

This control is generally regarded as detrimental to the interests of a free Kehillah. It is the dead hand of obsolete policy strangling the growth of the ideal of Jewish self-government in our local Jewish life.

Further evidence of a willingness to grant the form but not the content of self-government is evident in the alleged existence of the so-called Advisory Council.

This pseudo-democratic appendix, given a name but no function, which has been the laughing stock of the community owing to its ludicrous endeavors to find out why it was born, was intended as a weak concession to democracy. The council seemed to have been given powers, but in fact had none. It could not influence the work of the executive committee. It had no voice in the framing of policy. It was turned loose in the hurly-burly of Jewish life and told there was much good work to be done.

There is always good work to be done. The seventy-unfortunates of the council knew that. But the council as such had no function in the Kehillah government. It was not advisory or directive. Its advice or direction could be legally ignored and it has been treated with con-

ITEMS OF INTEREST IN THE JEWISH WORLD.

The Czar has permitted the opening of a special synagogue for Jewish soldiers at Odessa.

The Government has permitted the Russo-Jewish colonists to hold a conference.

Over 300 would-be Jewish farmers were denied admission to the National Farm School last year.

The Znamenka Synagogue has been closed on account of its proximity to a Russian church.

The cornerstone of the first synagogue to be erected in Milford, Mass., will be laid next Sunday.

The Federation of the Orthodox Jewish Charities of Chicago, Ill., has finally been accomplished.

A Wilna Jew, Victor Szurmumsky, has also been appointed lecturer of the St. Petersburg University.

A modern school building has been opened by the Schenectady (N. Y.) Hebrew School Association.

Mr. Jackiel W. Joseph, of Indianapolis, Ind., has been appointed Deputy Prosecutor in the Superior Court.

The purchase of 15,000 dunams of land by Jewish colonists in Palestine has been confirmed by the authorities.

Joseph S. Schwab has been appointed a member of the New York State Board of Taxes at an annual salary of \$6,000.

Rev. Joseph Zelsler, of McKeesport, Pa., has been chosen as rabbi by the Congregation Beth Jacob, of Newburgh, N. Y.

Governor Sulzer has appointed Dr. Meyer Wolf, of New York, a member of the New York State Civil Service Commission.

The French Academy of Sciences has elected M. Hadamard a member in the Section of Geometry, in place of the late M. Henri Poincaré.

The Order Knights of Zion, at their annual convention held in Chicago last month, decided to unite with the Federation of American Zionists.

Mayor McBride, of Paterson, N. J., has appointed Rabbi Leo Mannheimer a member of the Board of Education. The term will begin on February 1.

Fines amounting to 45,000 roubles have been imposed on several Jews at Libau in connection with their relationship to alleged missing Jewish recruits.

The Ekaterinodar Court has resolved to ask the Czar to pardon the ringleader of the local 1905 pogrom on the ground that he had fought revolutionary Jews.

The Austrian Hebrew Free Burial Society has purchased the old Methodist Church property on Second street, New York city, on which to erect a five-story orphanage.

Mr. Jules Lax, retired Inspector-General of Bridges and Roads in France, who built the railway across the Pyrenees, has been promoted Grand Officer of the Legion of Honor.

The French Academy of Sciences has awarded the La Caze Prize, of the value of 10,000 francs, to Dr. Wertheimer, professor at the Medical Faculty of Lille, in respect of his physiological work.

M. Hadamard has been elected a member of the French Academy of Science in succession to M. Henri Poincaré. M. Hadamard is connected by marriage with several rabbis of the Paris community.

The Gallician Jews are organizing meetings to protest against an anti-Semitic memorial to the Minister of Justice, accusing Jewish merchants of fraudulent transactions and criminal bankruptcies.

La Tunisie Française, published at Tunis, is printing a series of articles on the Jews in Tunis. It appears from the articles that there is a lack of accord among the two groups known as Leghorn and Tunis Jews.

Sir Charles Henry, Bart., M. P., has been appointed a member of a royal commission formed to inquire into the complaints of delay in the hearing of actions and appeals and crown cases in the King's Bench Division.

Governor Harmon has appointed Mr. Benton S. Oppenheimer, of Cincinnati, O., as a Superior Court Judge, to succeed Judge Harry M. Hoffheimer, resigned. Judge Oppenheimer is 34 years of age and was born in Cincinnati. In 1900 he took up the study of law in Governor Harmon's office, remaining there until 1905, when he was appointed Assistant City Solicitor.

The Jewish agricultural colony, Dombroveni, has obtained a gold medal at an exhibition in St. Petersburg.

Werner D. Amram, a confederate war veteran, died at Philadelphia, Pa., last Saturday night. Mr. Amram was one of the founders and for many years president of the Jewish Maternity Hospital. His son is David Werner Amram, professor of law at the University of Pennsylvania.

During the Parliamentary elections for Alsace-Lorraine the Curé of Haucourt addressed a circular to his parishioners, in which he censured them for having made common cause with the Jews. Dr. Weill, the Socialist candidate, who was aimed at in the circular and was elected to the Diet, brought an action against the Curé. The latter was adjudged to pay a fine of 100 marks and costs.

The Berlin Bar has suffered a heavy loss by the death of Judicial Councillor, Dr. Erich Sello, who was generally regarded as one of the greatest forensic speakers in Germany. In 1881 Dr. Sello was elected a member of the Reichstag, and joined the party of which Lasker, Bamberger and Rickert were the leaders. When the anti-Semitic campaign was at its height he addressed several Liberal meetings and eloquently denounced the movement.

The Jewish Agricultural School at Ahlem, Hanover, has issued a report stating that during the nineteen years of its existence 134 out of the 174 fully qualified graduates are engaged in an agricultural occupation. At the present time there are in the institution 100 boys and 66 girls.

A Jewish student, Walk, so distinguished himself in the recent examinations at the St. Petersburg Military Medical Academy that he became entitled to study at the Academy for the rank of professor of that institution. The scholarship, however, has to be confirmed by the Minister of War, and as the third Duma a few years ago prohibited the entry of Jews into the academy, the practical value of the success is extremely doubtful.

The locum tenens of the Greek Patriarchate in Constantinople, accompanied by some members of the Holy Synod, called on the Chief Rabbi to express to him the thanks of the Greek people for the expression of sympathy and consideration shown to them by his attendance in person at the funeral of Patriarch Joachim III. The new Italian Ambassador, Marquis de Garone, and M. Boppe, First Councillor to the French Embassy, have also paid official visits to M. Nahoum.

Orach Chaim Notes.
The meetings of the Orach Chaim Study Circle will in future be held in the rooms of the Path of Life Sisterhood, No. 1451 Lexington avenue, a few doors below the synagogue. Dr. Hertz will continue his lectures on "The Bible" every Monday at 8.30 p. m. until further notice.

At the regular meeting of the congregation held last Sunday night a committee was appointed to revise the by-laws. It was also voted to have Rabbi Hertz co-operate with a movement to give English lectures on Friday evenings (without religious services) and Sabbath mornings at downtown orthodox synagogues.

A set of resolutions forwarded by members of the South African National Zionists Fund at Johannesburg was presented to Dr. Hertz at the meeting.

Temple Beth-El.
Owing to the absence of Dr. Schulman, who will be in Philadelphia participating in the festivities attendant to Rabbi Krauskopf's twenty-fifth anniversary with Temple Keneseth Israel, Rabbi Solomon Foster, of Newark, N. J., will occupy Beth-El's pulpit Sunday morning and will lecture on "Hear, O Israel."

Kehillah Advisory Board.
The joint meeting of the Executive Committee and the Advisory Council of the Jewish Community (Kehillah) of New York city will be held in the Hebrew Charities Building, 356 Second avenue, on Tuesday evening, January 14, 1913, at 8.15 o'clock.

Holds the Title.

The American Jewish Committee Executive Committee Meeting.

(Communicated.)

A meeting of the Executive Committee of the American Jewish Committee was held on January 1, 1913, in the rooms of Dropsie College, Philadelphia. The situation with respect to the pending immigration bills was discussed, and it was decided to continue to oppose them and to make representations to President Taft in the event that a bill is agreed upon.

A report was presented upon the distressing situation of the Jews in Turkey and the Balkans and on the steps taken in co-operation with European organizations to ameliorate their conditions. In response to the appeal issued by the committee to the American public for contributions, over \$18,000 had been raised and in addition thereto \$5,000 had been appropriated from the Russian Massacres Fund, all of which has been forwarded through the Hilfsverein der Deutschen Juden of Berlin.

The chairman reported that an order from the Supreme Court of the State of New York had been issued directing that the balance of the fund raised by the Committee for the Relief of Sufferers by Russian Massacres and amounting to about \$190,000 be transferred to the American Jewish Committee. It was determined that this fund shall be known as the Emergency Relief Fund, and that it shall be administered in accordance with the following rules:

This fund, to be hereafter known as the Emergency Trust Fund, shall be at all times regarded as held in trust and shall be kept separate and apart from the general funds and other trust or special funds which shall come into the possession of the committee. A separate account shall be kept of it and of all income derived and of all expenditures made therefrom on the books of the committee.

The said fund and the income therefrom shall be devoted to the alleviation of the consequences of persecution of Jews in any part of the world, to rendering them all lawful assistance in the event of the threatened or actual invasion or restriction of their rights and to afford relief from calamities affecting Jews wherever they may occur. No part of the said fund shall be used for the purpose of defraying the general or administrative or office expenses of the committee, nor for any other purpose foreign to those hereinbefore enumerated.

No part of said fund shall be expended except in pursuance of a resolution of the Executive Committee authorizing such expenditure, nor otherwise than upon a voucher bearing the signatures of the treasurer, the president and of the chairman of the Finance Committee, a certified copy of such resolution, attested by the seal of the committee, being attached to such voucher. Provided, however, that in the event that the president shall certify that an exigency has arisen which requires immediate action, and that it has not been practicable to hold a meeting of the Executive Committee to take action with respect to the expenditure of any part of said fund, the written or telegraphic consent of two-thirds of the members of the Executive Committee, that an expenditure not exceeding five thousand dollars (\$5,000) at any one time may be made, shall be deemed the equivalent of such resolution of the Executive Committee, such consents being attached to the said voucher.

Other business was transacted, and, at the conclusion of the meeting, a loving cup, subscribed for by the members of the committee, was presented to Judge Sulzberger by Mr. Marshall.

Bnai Jeshurun Sisterhood.
A well-attended monthly meeting was held last Monday, Mrs. M. E. Shrier presiding, and many important questions were discussed. The secretary's report showed a considerable increase in the activities of the house, and besides alleviating pain and poverty among the poor of the district much time has lately been devoted to the social and educational phase of personal service.

Mrs. Herman Levy, who during her many years incumbency as president had accomplished much for the promotion of the Sisterhood's affairs, was presented with a beautiful gift in token of the esteem of the members. Rev. Reuben R. Rinder addressed the gathering and asked those present not to overlook the importance of the religious training of the children of the district while at the same time attention was being paid to relief work.

A performance of "The Yellow Jacket," given on Thursday, December 19, netted the Sisterhood several hundred dollars.

Young Women's Hebrew Association.
On Sunday evening, the 11th inst., the Ateres Reus will give a dance at the Ellsmere, 126th street, near Lenox avenue.

On the 12th Miss Laura B. Garrett will address the members of the association on "The Message of Euseucios to Young People." Admission will be 10 cents, the proceeds to go toward a fund for a swimming pool in the new building.

Rabbi Abraham Werner, of the Machzike Hadass Synagogue, London, Eng., died last month, aged 75. Rabbi Werner was born in Kovno, Russia, and before coming to London was Chief Rabbi of the Province of Helsingfors, Finland.

The Mohileff (Podolsk) authorities have prohibited the establishment of a society for the promotion of the study of Hebrew. The reason for their action they state to be the opposition to the spread of Jewish nationalism to the disadvantage of the assimilators.

NEWS FROM ENGLAND.

(Exclusive Correspondence to THE HEBREW STANDARD.)

The Passing of Picturesque Extreme Orthodox Rabbinical Figure—Approaching the Appointment of Chief Rabbi—Some Dissatisfaction and More Delay Asked—The Claims of Dr. Hyamson.

December 27, 1912.

The death occurred on December 20 of Rabbi A. Werner, who for the last twenty-one years has been the spiritual guide of the extreme orthodox of the London Ghetto. Dr. Werner, who was 75 years of age, was a most interesting personality and of patriarchal appearance and a pillar of the old orthodox school. Before he accepted the "call" to London he acted with conspicuous success as Chief Rabbi of Finland. At the early age of 20 he was awarded the rabbinical diploma and assumed the rabbinate of a little town in Russian Poland a year later. He was the author of many standard Hebrew works, and had a wide reputation for scholarship on the Continent. His great learning and wide knowledge of things in general, together with his rigid orthodoxy, gained for him a reputation outside Russia, and in 1891, when a large body of East End Jews revolted against the late Chief Rabbi, Dr. Adler, and formed a new congregation called the Machzike Hadass, Rabbi Werner was persuaded to come to London as chief of the new congregation. By nature a peaceful man, the late rabbi did much to minimize the religious differences of opinion, though the new congregation remained entirely independent of the official Jewish community till some five or six years ago, when a way was found by which the congregation should be placed under the Federation of Synagogues and at the same time retain Rabbi Werner's authority over all ritual matters.

The late rabbi, who remained active to the last, was highly esteemed among all classes of Jews and was especially popular in the East End, where he lived a most active life. Notwithstanding his great age he was always ready and willing to assist in everything that concerned the welfare of Jews and Judaism. He was indisputably the greatest "paskon" in England and was one of the oldest "Moreh Haradot." He leaves a widow, who, we understand, is utterly destitute.

There has been a meeting of Jewish ministers in London which shows that great dissatisfaction prevails among the clergy with regard to the appointment of a new Chief Rabbi. The following resolution was adopted unanimously:—

That the Standing Committee of the Conference of Jewish Ministers learns with regret that the honorary officers of the United Synagogues have declined to grant them the interview sought for in reference to the present position of the Chief Rabbinate election.

That in the opinion of the Standing Committee the specific question upon which the interview was sought, viz., the postponement of the election of a Chief Rabbi is a totally different issue to that which was raised by the scheme referred to by the honorary officers.

The Standing Committee protests most strongly to the entire Jewish community against such treatment of the official representatives of its clergy. The Standing Committee requests that no further steps shall be taken to elect a Chief Rabbi until the views of the ministers have been ascertained and considered.

Time is dragging on remarkably in this matter of the election of a Chief Rabbi. It is now over a year and a half since the question of a successor to Dr. Adler confronted the community, but now it seems quite clear that the nominee of the Selection Committee will be Rabbi Drachman. The matter will no doubt be settled in a few weeks now and anything making for further delay is to be regretted. Anglo-Jewry requires a head and a leader, and the matter must now be decided if it is not to drag on forever.

Correspondence over such pen names as "Fairplay," etc., is appearing in the Jewish press here, which seems to indicate that the other Rabbinate candidates have strong and enthusiastic friends. One correspondent, arguing against the prevailing assumption that the choice would fall on Dr. Drachman, urges that such a rumor is especially unfair to Dr. Hyamson. This letter, to which much space is being given in the press here, outlines so many interesting facts that an excerpt may be profitably made from it.

It is pointed out that the Jewish community is grossly mistaken if it thinks that the Chief Rabbinate is a purely titular or representative office. On the Chief Rabbi devolves the responsibility for the ecclesiastical administration of the Jewish congregations, not only in the metropolis, but also in the provinces and the colonies. He is the authority for licensing officials throughout the country. To him are referred delicate problems, too difficult to be settled by the congregations locally. His is the task of averting crises, many of which never come to the light, his the duty of keeping the large Anglo-Jewish community together. For this work rabbinical learning, and secular culture of a high order are essential. And of equal necessity are tact and experience. Knowledge of the details of administration cannot be picked up in a day, or in a week, or in three months, but requires years of patient

training, familiarity with the community and its needs, knowledge of individual congregations, and of their varied individual characteristics in the metropolis and the provinces.

What qualifications does Dr. Drachman possess to discharge these high duties? As far as is known, he has never exercised ecclesiastical functions over the Jewish community of a country, or even of a single town. He is the religious head—like our ministers in England—of a congregation, or perhaps of two congregations. He has not a world-wide reputation as a rabbinical authority. Nor is he known as a secular scholar of the first rank. Has he been especially trained for the high office of Chief Rabbi of the British Empire? Has he made such a brilliant success of his own congregation in New York? What are the renowned achievements that guarantee his success in a new country, the conditions and needs of which must necessarily be strange and unfamiliar to him? Jews are Jews everywhere, but environment counts and differentiates. Is he to be "unanimously" chosen as a policy of despair? If it was a question between Dr. Herz and Dr. Drachman the decision of the issue on the lines of least resistance might be intelligible, if not justifiable.

But we have in our midst one of our own. Dr. Hyamson has lived in England since his early childhood and received his education here. His rabbinical diploma he obtained from Dr. Hermann Adler. His doctorate of law of the London University, which he holds has been publicly declared by no less an authority than Sir Philip Magnus, the member of Parliament for that university, as the highest academical distinction in the world. Dr. Hyamson has served the community for twenty-eight years as minister of important congregations in the provinces, as minister of the flourishing Dalston Synagogue, which, during his term of office, became the pioneer of many useful institutions, and since 1901 as Dayan of the United Synagogue. Everyone admits that his work during all this time has been a brilliant success. As Dayan during the last twelve years he has not limited himself to the discharge of the duties of his office. His spirited defense of Shecheta at the Cotton Hall, a few years ago, prevented a resolution condemnatory of Shecheta being even put to the meeting and won the warm eulogiums of the Jewish press. Dr. Hyamson materially assisted the Manchester Shecheta Board to win their case. The reply of the Board of Deputies to the Admiralty report was largely based on a memorandum he was asked to prepare.

At the request of the late Chief Rabbi he conducted responsible and extensive pastoral tours in Ireland, the North of England and South Wales. And during the last five years before the late Chief Rabbi's death it was Dr. Hyamson who gave the Talmudical dissertations on the Sabbaths before Passover and the Day of Atonement—and those established for him the reputation of a wide and profound Talmudical scholar.

The next debate of the Inter-Club Debating League will be held Sunday afternoon, January 12, between the Excelsior Social and Literary Society and the Emerson Literary Society. The subject is: "Resolved, That we favor the Municipal Ownership of Street Railways."

In a season of many plays nothing in New York has begun to be such a favorite on the dramatic stage as "Milestones," the delightful Arnold Bennett-Edward Knoblauch masterpiece, nearing the second century mark of its marvellous run at the Liberty Theatre. "Milestones" deals with love affairs of three generations, and although the various acts are all set in the same room in the same house, the curtain rises each time upon a different setting, representing the periods of 1860, 1885 and 1912. There is a steady transformation not only in the furnishings of this room and the costumes of the people, but also in the methods of expression, ideas and language.

The Governor-General of Poland has at last taken steps against the boycott of Jews and confiscated several Polish appeals against trading with our emigrants. The Jews have also begun to reply to the boycott by keeping away from Polish businesses.

What Ails the New York Kehillah?

tempt. The council therefore spent its time in futile and exasperating discussions of its place in the economy of life and unable to arrive at a rational conclusion, every man of the seventy, with few exceptions, has been a bearer of unfavorable tidings of the Kehillah to his friends.

Even in matters where success hinged on the good will and co-operation of the community, the Kehillah has seemed not to have the courage or desire to adopt a democratic course.

Nowhere is this more deplorable than in its work for education. The education fund was gathered by Dr. Magnes, who, as chairman of the Kehillah, interested a number of men of large means in the problem of local Jewish education. But when this fund was gathered, it was not organized as a component part of the Kehillah. It was practically segregated and sterilized against interference by the Kehillah conventions for five years. A special committee was appointed, to which was given absolute control of the bureau. The standing committee on education, holding office for one year, was ignored, and the Board of Trustees of the bureau was made up regardless of that committee. This special Board of Trustees was appointed for five years, and one of its first acts was the appointment for five years of Dr. S. Benderly as director. The resolution naming the trustees and giving them full power, as well as the contract with Dr. Benderly, was not even voted on by the Kehillah convention. They were executive acts, binding the Kehillah in legal form for five years against interference with the bureau.

Now, had the bureau adhered strictly to its original programme, it probably could have gone ahead undisturbed, writing text books, formulating methods, etc. But as the community was confused as to the relations of the bureau and the Kehillah, and there had been an implied agreement, as many claimed, that the bureau's fund, at least part of it, was to be used in the direct service of Jewish education, the bureau, in an ill-advised moment, decided to depart from its original programme. It agreed to subsidize a number of Talmud Torahs on condition that they accept Dr. Benderly's methods.

But the subconscious feeling that the bureau was not theirs, that its policy could not be amended or altered by them, operated to create discord. Into the details of this discord we need not go. A deal of the criticism of the dissatisfied had no basis in fact, but the Kehillah should have been disturbed by the fact that in spite of the undesired criticisms, they seemed to strike a popular chord. There was no popular resentment of the mendacious attacks. The public seemed to say: "The criticism is unworthy of notice, but it is not our bureau." And every one of the critics of the bureau felt exasperated beyond words, for no matter how loud he might shout, or how valid his criticism, the bureau was going to do as it pleased. They contributed a large share to the general discrediting of the Kehillah, denying wherever they went its right to the title of communal representative.

It was early recognized that if the Kehillah was to be placed on a permanent basis, it would have to grapple with the Schechitah problem as its first task. No element of the Jewish population would seriously have refused to co-operate in its reorganization, for there is general agreement that the kosher label on meat should mean exactly what Jewish law intended it to mean. This is a practical communal problem. The Schechitah has always been managed by the community through its householders. In Russia it produces revenue for many Jewish philanthropies through the indirect tax it places on consumers of kosher meat. The tax is being paid right here in New York by the consumers to the meat dealers, who contribute in part out of this fund to the maintenance of a number of rabbis and their assistants. These rabbis, acting in an extra-congregational capacity, are the employees of the dealers. They and their subordinates act for the dealers' interests, and only incidentally for the community's. The dealers are thus the controllers of the Kashruth of meat in this city.

How should the Kehillah have dealt with this important problem, of great interest to the community and of vital im-

portance to its own future? Granting that the rabbis employed as supervisors of the Schechitah had been forced to make the best of conditions as they were, as they had developed, here was an opportunity of testing the composite interest of the community. Wherever there is an efficient Board of Schechitah, its strength lies in the fact that it is based upon congregational union, to the exclusion of rabbinical dominance.

But nothing has been placed before the community, which is still merely a pawn in the movements of the Kehillah. As a matter of fact, the Kehillah for reasons unknown to us, has refused or neglected to appeal to the community. Its negotiations have been with the interested rabbis. It has been using diplomacy to get them to relinquish their perquisites. It has had hopes of making amicable terms with the dealers and the rabbis, leaving the community altogether out of its calculations. It would rather consider the subsidized rabbis the masters of the situation than go direct to the people.

It thus followed a course consistent with its entire policy. It avoided stirring up public opinion and preferred relying on conferences in camera with small groups of men. The Schechitah problem is not solved. The method of approach is wrong. It ought to be apparent now to the Kehillah that nothing effectual can be done without a direct appeal to the congregations, and to the larger community.

This, then, is the ailment that afflicts the Kehillah. It lacks the essential attribute of democracy. Nor is this a matter of mere academic importance. It goes to the root of apathy and indifference in the community.

Once the sense of responsibility for Jewish affairs is communal, you have a weapon against every indifferent Jew. The philanthropies of the city are maintained by one per cent. of the Jewish population. The individual has been made to feel that he has not an equal responsibility for Jewish conditions with the men who are so largely the maintainers of our institutions. Without responsibilities duties are not recognized. The men who give are compelled to give more from year to year. The more they give the less others give, and the less others feel that it is their concern. The responsibility should be distributed. The community is demoralized by the swollen individual benevolence of the few.

The Kehillah has never made a test of the proposition. It was organized for that purpose, and yet, in every instance where a test could have been made, it has taken the line of least resistance, where its ability to lead has been more secure against public challenge. It may be said that a majority of the leaders were opposed to the Kehillah ideal when they became a part of the movement, that they expected to stem the tide that seemed to lead to dangerous innovations. They may have felt that for the time being they must compromise with public clamor in order later to control it.

But having given life to a Kehillah, they are bound to let it be true to its functions. They must compromise with their own notions of Jewish policy a little bit further. They cannot hope to maintain a Kehillah which denies the fundamental principle of its being. If a democratic Kehillah is not to their liking, they must destroy it altogether. The present anomalous conditions cannot be justified or continued. If it is not to be the representative of a democratic community, it will sink lower and lower in the public esteem, until even the men responsible for its condition will be reluctant to be known as its sponsors. Does not a sham Kehillah hinder the proper organization of the Jews of this city?—The Maccabean.

The Jew as an Idealist.
With Christmas what can be more fitting than a word about the Jew, and as this is the accepted season when much is made of the quotation, "On earth peace, good will toward men," what is

more fitting than to touch upon the idealistic phase of this great race? America is not yet a land where anti-Semitism flourishes. As race antipathies often rest on quantitative rather than qualitative conditions, it is not necessary to venture the prophecy that the Gentile and the Jew will never clash in the United States as they have in Russia, Germany, France and Roumania. The wider the geographical dispersion, the swifter the social assimilation and the more ardent the immigrant's loyalty to the traditional American ideal, the less likelihood we find of an outbreak of prejudice and antipathy. That the fine portrait of Lincoln by Brenner now adorning the most democratic of American coins is by a recent exile from a Russian Ghetto has a world of significance for both Russia and America. The empire is exiling artists and lovers of liberty; the republic is winning them. When the Titanic sank she carried down many heroes and heroines, but the "I will not leave thee" of an American Jewish matron had a touch of soul in it that forever will challenge and win humanity's homage. The nations of the world, who at first scorned David Lubin, now sit at his feet as he teaches Europe, America and Asia how to gather, collate and interpret data respecting the world's crops—a reform that has a profound ethical as well as economic significance.

In the civic uplift campaigns of the United States carried on during the past decade in cities as far apart as Boston and Los Angeles, Pittsburgh and New York, the mainstays of the reform forces have been of the race that boasts of Amos, the prophet of righteousness and Nehemiah, the city builder. The Boston lawyer with the widest national reputation at the present time, based on professional and extra-professional service for the public, is not a descendant of the Puritans of Boston and Salem or of the Pilgrims of Plymouth, but is a native of Kentucky and is of Jewish stock. The progressive faction of the Democratic party naturally turns to him as a candidate for the Department of Justice in the Wilson Cabinet, and the conservative faction as naturally opposes his nomination. In the same connection it is significant to note that the lawyer for the Pujo committee now probing into the secrets of "high finance" also is a Jew, with the same mastery of principles and details of business that has been shown by the Boston attorney just mentioned.

If America has escaped much of the strife between Jew and Christian that Europe knows even now, perhaps it has been due, first, to a theoretical equality under the law, guaranteed by the Constitution and buttressed by statutory enactments and judicial decrees, and, secondly, to the fact that American environment has permitted the flowering out of virtues and capacities that always are admirable, especially when at the service of a democracy.—Boston (Mass.) Christian Science Monitor.

Peter Wiernik's history of the Jews in America is more and more coming to be looked upon as "a valuable contribution to history." Its spirit of fairness and its manifest desire to do justice to all sections of Jewry in America combine to make the book useful to any serious student. Perhaps the book does not speak the last word on the subject; it cannot very well do this. Perhaps the author has committed sins of omission or commission; what author has not? At the same time he has produced a volume which, until the great work in this field appears, will live.

The London Chanukah military parade, which has become an outstanding feature of communal life in the English capital, seems to have this year produced more than the usual crop of criticisms. Criticisms are, alas! the concomitant of tolerably all Jewish activities, but those that have been passed on the London function are extraordinary and quite deep seated. Under such circumstances, then, it would seem that the parade ought to be subjected to more or less careful revision in the light of the strictures that have been passed upon it. Such an institution is too useful to be lightly suffered to fall into innocuous desuetude, and its organizers and leaders should be anxious to meet the reasonable demands of all participants.

In an open letter to the members of the Lake County Bar Association, of Lake County, Ind., Leon A. Berezniak, a lawyer of Russo-Jewish extraction, presents as clear and unblushing a case of mendacious race-prejudice as we have ever seen. To think that an organization of lawyers will take a Jew's money, presumably because it is not tainted, and then deliberately deny him the rights of membership through a most palpable subterfuge is more in accordance with the practice of Russian bureaucrats than consonant with the habit and ideals of free Americans. Mr. Berezniak was well advised to lay his case before the bar of enlightened American public opinion, and the Lake County Bar Association stands convicted of petty ill will of outrageous unfairness and of unmannerly conduct in the highest degree, which, if the facts were not to hand were almost beyond the bounds of credulity. Needless to add Mr. Berezniak was treated so cavalierly because he is a Jew and because he made his advent in Hammond, Indiana, known through legitimate channels of publicity.

In the December issue of *The Maccabean* the article, "What Ails the New York Kehillah?" by Louis Lipsky, follows the arguments of our recent editorial entitled "The Handwriting on the Wall." Affecting to despise all previous criticisms of our "great and glorious" Kehillah as crude, premature or superficial, the writer in *The Maccabean* with considerable circumstance sets forth that the chief ailment that afflicts the "great and glorious" Kehillah is its lack of democracy. It fails to reveal that attribute of representativeness which has been the gravamen of our complaints and criticisms against it since the hour it was called into existence. We always maintained that the trouble with the "great and glorious" Kehillah was the fact that it did and does absolutely nothing and parades its inactivity under a show of "action." The writer in *The Maccabean* is following in our wake, and his article shows that our strictures have been useful, necessary and opportune. He represents those who are the last friends of the "great and glorious" Kehillah, the Zionists, as he himself puts the situation. If the Zionists will have none of the "great and glorious" Kehillah, it were time that the organization cease to be. The rest of our community is thoroughly disgusted with this conglomerate of self-constituted, undemocratic, unrepresentative "leaders" in our Jewry. Parenthetically we would remark that another part of the same issue of *The Maccabean* affords room for the ventilation of an editorial opinion on the American Jewish Committee, the body which is now made the scapegoat for all the sins of the "great and glorious" Kehillah. We have always had and freely expressed our opinion of the Committee, and would but say that a kehillah which really is a kehillah will have naught to do with it in any form, shape or manner.

RABBI JOEL BLAU

THE entire community will rejoice that Congregation B'nai Jeshurun has at length secured a spiritual guide worthy of its best and greatest traditions. Everyone, too, will cordially congratulate Rabbi Joel Blau on the signal distinction that has come to him: that of leading an important and large metropolitan synagogue, where he ought to have abundant scope for the display of his undoubted talents, and where he can and undoubtedly will labor effectively and efficiently in the sacred cause of our holy religion. In this corner of the vineyard of the Lord, at all events, the Lord's concerns will be well taken care of.

Rabbi Blau's work is more than familiar to the readers of this journal. His weekly discourse which so admirably and Jewishly fills our third column on this page has become a part of their lives. For Rabbi Blau advancement has come within a very short space of time, but it came because he deserved it. He is a man of fine perceptions, of high mentality, possessed of great originality of thought, and, above all, thoroughly in sympathy with the main currents of Jewish tradition. His conservative aspirations have marked his entirely creditable career, and he has ever remained faithful to them at all costs and despite great temptations elsewhere, for worldly preference.

In thus felicitating Rabbi Blau, our joy communicates itself to his new congregation. For he will give sustenance like a faithful shepherd to his hungry and thirsty flock, for a number of years now bereft of a real leader. Rabbi Blau will work in and for the congregation. He has no entangling alliances with matters foreign to the weal of a congregation, and the *eclat* of his entry into office will not be dimmed, we trust, by an abrupt leaving.

We trust, indeed, that the connection thus auspiciously inaugurated will prove satisfactory to both contracting parties, for the weal of Judaism, to the credit of the Jewish name.

AGAIN THE TREATY

THE civil new year has opened and the justifiably decried treaty of 1832 with Russia has gone into the lumber-room of international politics. Russia is no nearer the negotiation of a new treaty of commerce and navigation with this country than she was a twelvemonth ago. One of the first duties of the new administration, apparently, will be to consummate an instrument which will be satisfying to both parties in respect of the trade interests of each, and, if possible, more than explicit on the contention for which our government has so resolutely stood: the recognition of the American passport by Russia when borne by a Jewish citizen of the United States.

The press dispatches published on the opening day of the new civil year point out that a *modus vivendi* has been arrived at by the two governments, by the terms of which the business relations of our citizens and the subjects of Russia will experience no substantial change. We are reasonable and patient with our constituted authorities and see nothing to cavil at in such an arrangement. Commerce will and must undoubtedly go on, and it is but fair that important mercantile interests be not disturbed by the alterations produced on the part of diplomatists.

This does not mean, however, that the treaty of 1832 will be replaced indefinitely by the *modus vivendi* referred to. It does not imply that American public opinion and especially the public opinion of the Jewish citizens of this country will permit our government with equanimity to defer the final, definitive adjustment of the passport problem. Congress denounced the treaty upon grounds which are not far to seek, and which are direct and certain in their terms. If Russia does not choose to adjust the passport difficulty with the United States, that is Russia's business. We, as we have frequently had occasion to intimate, are well able to peg along as a nation without any assistance or mutual relations with the empire of the Czars.

Hence the *modus vivendi*, presumed now to be in existence, is a mere temporary expedient. It is this and nothing more. If it be not promptly replaced by a treaty that is not uncertain on the passport question, or by the complete cessation of relations with Russia, the American people will know the reason why.

The Rev. I. Raffalovich, of Liverpool, was on a visit to this country and Canada recently, and in an interview for *The Jewish Chronicle*, he describes his impressions. He is running over with praise for our excellent charitable agencies at Ellis Island and in Boston, but his remarks on the religious future of Judaism in America are to us of greatest interest. Mr. Raffalovich is extremely pessimistic about the future of our religion for us, although it rejoices us to note that he has a good word to say for the Orach Chaim and Shearith Israel congregations of this city, which, in the welter of our irreligious demoralization, known as "American" Judaism, stand out like beacon lights to guide the true and loyal Jew. But, Mr. Raffalovich was a critical observer. "Practically speaking," he remarks, "there are three Judaisms in America. There is the rigidly orthodox Judaism brought from the Russian villages, which is according to all reports a passing phase. Then there is radical reform, which is already so un-Jewish that it has already ceased to be a menace to Judaism. Then there comes what is called the American Conservative Judaism, which may ultimately prevail, if only its advocates will not be carried away by desires of undue modification, and will be able to retain the poetry of our ancient traditions." Here we have a splendid summary of our lack of unifying religious ideal, which to a Jew from England, where Judaism is nothing if not centralized, must be terribly disheartening. But, then, no where in the world to-day are all shades of Judaism and Jewish opinion so well represented as in our city of New York.

NOW

THE commentators, as might be expected, try to explain away the exaggeration manifest in this text. But the real explanation is psychological. The exaggeration is rooted in the peculiarities of the human soul. When calamity overwhelms us, we imagine that it is the sharpest blow we ever received, or are likely to receive. There is no pang like the present pang. All past misfortunes are swallowed up in the present misfortune. Their sting is so keen as to cause us to look upon past miseries as minor difficulties. As for the future, is it possible that Destiny should hold a still deadlier arrow in its quiver? No—there never was, and there never will be, such a scourge as the present one!

What has been said of present sorrows holds true of present joys. There is no joy like the present joy. In the exaltation of the present moment, the past is eclipsed and the future invested with an air of unreality. The laughter of the moment rings loudest, as the tears of the present are the saltiest. Have we never rejoiced yesterday? We did; but the light of yesterday is as darkness in the brightness of today. Shall we never rejoice tomorrow? Perhaps—but what human being would blithely sing the Song of the Perhaps? "Let us drink and be merry for tomorrow we shall die!"

In a word, our text is a striking example of that outstanding peculiarity of the average human nature, namely—*absorption in the present!* When you hold an object too close to your eye, it grows out of all its natural proportions and shuts out all other objects that are more or less remote. Similarly, the present moment looms up too large before us to the point of blinding us to both past and future. The present moment, the insistent little *Now*, appears to most if not all of us the climax of existence.

In a way, the importance of the *Now* is puzzling. Nothing is so unreal as the present moment. It constantly threatens to become past, it constantly promises to give way to the future. It is like shifting sand, unstable. Imprisoned and wedged in between past and future, it has a pitifully narrow isthmus for its territory; and yet how tremendously huge do its dimensions appear to the eye which is pressed close against it. One is reminded of the Arabian tale about the jinnee that was imprisoned in a bottle which in turn was cast to the bottom of the sea. The unfortunate fisherman hauls up the bottle, breaks the seal, pulls out the cork—and then the jinnee, freed from its age-long prison, grows to frightful size, sailing out in a vapor over the sea and filling the whole world. So does the vaporous *Now*, when suddenly hauled out of the abyss of time, fill our world—every nook and corner thereof!

Happily, there are men who know the spell that will conjure the weird jinnee back into the bottle. Time is on their side, for time relegates the present moment back into the abyss whence it came. The *Now* is its own cradle and its own coffin. It may puff itself up for awhile, but it must shrink back into its original size. Men, therefore, who know the limitations of the *Now*, refuse to unduly worship it. They refuse to allow themselves to be too deeply absorbed in the present. A vision of better things yet to be beckons them on, ever on, and keeps them from tarrying on the narrow isthmus of the *Now*. Such men are not fishermen, who are contented to sit sleepily in one spot waiting for a chance haul; they are explorers and discoverers of unknown regions, to whom life means a glorious adventure, full of perils indeed and mayhap bare of material rewards, yet holding out to the daring the supreme prize more precious than gold and pearls, namely—the thrill of the chase and the zest of discovery!

But when all is said about the limitations of the *Now*, there is a great deal to be said for it. We must not err on either side of the question. We must not unduly worship the present moment, nor must we unduly condemn it. There is an impatience with the present, characteristic especially of the discoverer of better things, of the social reformer, that bodes no good and may result in untold harm. There are so many men of the latter type who in their impatience to hasten along the coming of the Better Day, scorn and wilfully neglect the tasks and responsibilities of the present. In so doing, far from accelerating the realization of their ideal, they retard it. Just think of the man who, believing in the equal distribution of wealth, would neglect to tender relief where such is required, because to his mind charity has no place in the future system of society. Or think of the man who, believing the present faith to be narrow, works for a larger faith to be and in the meantime causes the masses to lose the faith they have.

Nay we must not neglect the present. We must not remain deaf to the immediate appeal of the *Now*. Howsoever alluring the Call of the Future may be, the Call of the present is more urgent. If we scorn present tasks, present faiths, present responsibilities, we are sure never to live to see the Better Day we yearn for. If there is to be such a day—I know not—it can only grow out of Today. If there is to be a larger faith—again I know not—it can only grow out of the narrower faith that is. For the *Now* is a bridge that leads us to what is to be. Narrow though the bridge, we cannot leap over it—we must patiently walk it. For while the future may be a fond object of our thoughts and dreams, the present, and the present alone, gives us an opportunity to work. We may rivet our fascinated gaze upon the vision of things to be, but we must take care of the things that are. The future will take care of itself, if we but take care of the *Now*.

Of course, many women may ask one to judge their dresses and give an expression of opinion as to them, generally look only for a favorable comment, and will feel far from pleased to hear one in an opposite direction.

In society everything is "beautiful," and in society people don't like to tell the exact truth, because, as a rule, people do not want to hear the minute truth. Once, a well-known French courtier had the rashness to tell a fashionable dame that he had discovered a suggestion of an incipient wrinkle upon her beautiful brow. It was the truth, but her answer completely annihilated him. A woman will accept a compliment that she is "beautiful" though she knows that it is untrue, without a shade of resentment.

The Rathenaus, Father and Son

By DR. E. FRIEDEGG.

(Translated by Jacques Mayer.)

(From the Wiener Journal.)

Moses Mendelssohn, who died about 125 years ago, but who will probably figure in the history of philosophy 250 years from now, had—among some other children—a son Abraham. The latter was a man of some importance, for he became the founder of the very successful banking firm of Mendelssohn & Co., and the father of the Felix Mendelssohn, whose genius is hardly inferior to that of Schubert or Weber. Nevertheless, when fifty years of age he was compelled to say of himself, half ironically and half complacently: "Once I was the son of my father, and now I am the father of my son."

With a few variations this sentence might apply to the Rathenau dynasty: The privy councillor Emil Rathenau may justly be proud of his son, and the merchant and philosopher, Dr. Walter Rathenau, could not have been more careful in the selection of his father than he was. But nothing can more excite to anger this patient, well-bred, amiable gentleman than to take him, in any way, for his father. Walter Rathenau desires only to be himself.

The original capital of the A. E. G., as the Allgemeine Elektrizitäts-gesellschaft* is termed for short amounts to about 200,000,000 marks, and Emil Rathenau describes himself as general director of both concerns. As a matter of fact, Rathenau has no contract with the A. E. G. or the B. E. W. (Berlin Electrical Works), the factories do not belong to him, he owns but a very small part of the stock, and yet he controls the business as if he were sole proprietor. In the general meetings he has frequently shown himself more powerful than the entire Board of Directors.

This commanding position of the venerable Privy Councillor does not rest upon his fortune, but upon the influence of his personality. He it was who caused the A. E. G. and its subsidiary companies to take rank with the wealthiest and most influential industrial companies of Europe, and the stockholders hugely respect his ability and his knowledge.

Emil Rathenau is a Berliner by birth, studied in the Wilhelm's Mines the art of machine-building for four years, then attended the Polytechnikum of Hanover and the Technical High School of Zürich. In the beginning of the sixties he was superintending engineer with A. Borsig, the largest German machine manufacturer, after which he spent some years in England. One day he obtained control of Weber's machine factory, which was not a successful undertaking, for shortly after the Franco-Prussian war it was pur-

chased, for a small sum, by a stock company.

In 1876 at the Philadelphia Exhibition he, a man entirely without capital, obtained a knowledge of the telephone and of the American methods of machine construction. Returning to Berlin with the intention of introducing the telephone and Edison's incandescent lamp to Germany, he was forty-five years old, and quite unknown outside of a very small circle. At an audience with Postmaster General Stephan he suggested the introduction of the telephone into the German capital. Herr von Stephan was by no means a short-sighted bureaucrat; on the contrary, it was he who created the very modern postal methods of Germany, but the story of the telephone, as told by Rathenau, appeared to him as something highly fantastic, and he was sure that in Berlin not two dozen people could be found who would take any interest in the invention. Thereupon, Rathenau, with the concession in his pocket, began himself to look around for subscribers. He was quite successful in obtaining them, so successful, indeed, that at the present time there are several millions of people in Germany who cannot live without the telephone. When success had been achieved Rathenau lost his concession, for the postmaster-general then incorporated the telephone with the Imperial telegraphic system.

Almost as hopeless as the idea of the telephone did Rathenau's founding of the A. E. G. and the B. E. W. appear to "people who knew" and reliable experts. Even five years after the A. E. G. had been established its credit was so weak that C. O. D. was demanded for a steam engine which it needed. It was only delivered after Hugo Landau, a director of the concern, had personally guaranteed its payment. And when the B. E. W. began operations, Werner von Siemens, the founder of the famous firm of Siemens & Halske, regarded it as a foolish undertaking, which in his opinion would soon go into bankruptcy.

Emil Rathenau is on thirty directors' boards, is chairman of eight companies, among them the Berliner Handelsgesellschaft, one of the largest German banks, a fellow-director being Prince Karl Fürstenberg.

Dr. Walter Rathenau is on the board of the United Lausitz Gas Works, the Berliner Handelsgesellschaft, the A. E. G., the Mines and Metals Bank, Körting Brothers, the Silesian Electrical and Gas Company, and many others. I believe he occupies more directorial positions than his father, for his friends describe him as the aufsichtsrathenau.†

Thus father and son control a goodly number of German mercantile concerns, and their influence extends over enormous sums of the national wealth.

Walter Rathenau is a technician and a physicist, a merchant and a connoisseur of pictures and music, a chemist and a physiologist, political economist and colonial investigator. These many-sided activities have not made him superficial, but have deepened his knowledge. After being active in his father's gigantic enterprises he showed remarkable executive and financial capacity as business manager of the Berliner Handelsgesellschaft, a post filled by him for five years. He was an active and influential financial man, when his book of essays and sketches appeared under the title of "Impressions." In that book he expressed, in a style of great clearness, many and novel opinions. Among the most interesting of them are some aphorisms dealing with his own and his father's commercial achievements. For example: "Complaints regarding the sharpness of competition are mostly complaints regarding a lack of originality." Or: "He who complains of having too much to do, shows that he doesn't know how to organize. Napoleon would never have declined the conquest of Spain on the ground of overwork. On the other hand, he who has too little to do, proves that he is not needed." This epigrammatic sentence indicates deep thought: "To recognize and to create the demand for something, constitutes the foundation of all business." And this one: "You can recognize incapable people by their desire to crush their predecessors." A really royal pride characterizes the reflections upon fortune-seeking: "I have never met a really great business man or organizer who regarded mere profit as the essential factor of his calling, and I would fain assert that he who is absorbed by the desire for personal gain can never become a great merchant. The dealer or the tradesman depending for his livelihood upon the day's work, must and will at all hazards think of his in-

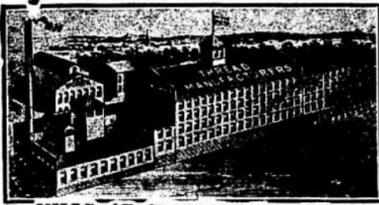

representative and gave the following items concerning the rearing and education of his brother, Hayim Heller: He was born in Bialystok, the son of Rabbi Israel Heller, known under the euphonic appellation of Pinsker Elul. Herr Jacob Braude, of Warsaw, the noted Zionist and philanthropist, was his uncle. In the very first stages of his childhood Hayim Heller displayed marvelous traits and phenomenal qualifications, receiving his rabbinical diploma before ever passing his teens. He went to Berlin, Germany, where he matriculated in the local university, obtaining in a very short time the philosophical degree of Ph. D. Returning home, Dr. Hayim Heller married into a wealthy and prominent family in the city of Lodz. There he visited frequently the local rabbi, the venerable octogenarian, Elias Hayim Meisel, there always having been intimate friendship between the Heller and the Meisel families.

Having inherited a fortune from his uncle Braude, which swelled in the course of time by the dowry and other additions, Dr. Hayim Heller never cared for the rabbinate, devoting, rather, his time to study and research. Rabbi Meisel, however, persuaded young Rabbi Heller to cast glory on the rabbinate and don its mantle. Rabbi Meisel having formerly ministered himself to the Lomza community, it goes without saying that his word turned law, and Dr. Heller was given the position before he ever made the application, written, verbal or otherwise. Rabbi E. H. Meisel, unfortunately, was gathered to his fathers in the meantime, being mourned by all Jews throughout the civilized world. It is a noteworthy fact that the new Rabbi of Lomza is the only university graduate to occupy an orthodox pulpit in the Russian Empire. He, however, is the right man in the right place, Lomza being the gubernatorial seat, and the Jews in some Polish provinces of the Russian Government are accorded rights and privileges and are treated more human than their brethren in Lithuania, Bessarabia, Podolia and Russia proper. Russian-Jewish exchanges related of the governor having headed the committee that met the rabbi at the railway station, Dr. Hayim Heller becoming, in return, a frequent visitor of the governor.

The "connection" between the Emperor and the Rathenaus is not made through the Chief Court Marshall or a minister, but either through Albert Ballin or Admiral Friedrich von Hollmann, who was formerly Secretary of the Navy and is now a director of the A. E. G. In the house of the Privy Councillor (who, like his son Walter, is an unbaptized Jew) one meets all the ministers of State, and their secretaries, whether active or on the retired list. When ten years ago Rathenau's only daughter was married to Mr. Andrea, head of the banking firm of Hardy & Co., the wedding dinner was attended by the highest functionaries of the empire and the nation.

Dr. Walter Rathenau is now forty-five years old, was married, but now lives the life of a bachelor part of the time in a magnificent Grunewald villa, and part of the time in the castle Freienwalde, which he purchased three years ago from the Kaiser, the latter making the condition that it should always be called "Royal Castle Freienwalde."

Under all these circumstances it is not improbable that Dr. Rathenau, who is several times a millionaire, may one day abandon business entirely in order to become German Ambassador to Washington. For the United States he would not need to change his religion. (He would not, in any event, do that; partly out of pride and partly because it's against a family tradition.)—*Wien-er Journal*.

Dr. Hayim Heller, the Lomza Rabbi.
(Translated from the Yiddish of the N. Y. Morgen Journal.)

It was reported recently in the Morgen Journal that Rev. Dr. Hayim Heller, Lodz, became the rabbi of the Jewish community of the city of Lomza, Russian-Poland, that the newly elected rabbi was a combination of both modern culture and scholarly attainments, and that local powers that be extended the arriving rabbi courteous receptions and cordial hospitalities. come, for his physical and mental ability are taken up with the problem of earning his daily bread. This applies to the factory workman and the clerk, with only the difference that petty tradesman preserves an independence usually more apparent than real—and the ability to regulate his hours of work. But even if he obtains some goods on credit and sells them in the same way, he does not, in the real sense of the word, do any more business than the department-store salesman, the telegraph clerk, or a man employed in the humblest capacity on the public highway. He works at the command of and in accordance with the wishes of his creditors. He lacks personal independence. Not every tradesman is a merchant. To have capital, one's own or borrowed, sufficient for the extent of the enterprise planned, united to that inborn capacity which cannot be replaced either by the commercial school, apprenticeship or practical knowledge—these constitute the merchant."

In 1907, Walter Rathenau visited East, and in 1908 South, Africa. He was accompanied by his friend, Bernhard Dernberg, in those years German Colonial Secretary. Rathenau paid his own expenses, though his mission was an official one. Chancellor Prince Bülow had begged him to go with Dernberg, who was apt to be rather careless in his personal intercourse with Europeans as well as Africans. Since he undertook those journeys, Dr. Rathenau has frequently had opportunities to impart his Colonial experiences and opinions to William II. Indeed, for the past ten years the Kaiser has maintained friendly relations with the two Rathenaus. The more than seventy-two year-old Privy Councillor is often asked at nine in the evening to confer "under four eyes" with the monarch, and on the other hand, the Rathenaus are permitted at any hour of the day to have themselves "connected" with the same august personage, for the latter is not averse to the use of the telephone.

BROOKLYN NOTES.

Hebrew Educational Society.

"The Sunday Laws" was the subject of a lecture by Mr. Albert M. Friedenberg on Friday evening, January 3, at the Hebrew Educational Society. He described the provisions in various States of the Union showing how Jews are affected by the legal regulations preventing worldly activities on Sunday. He quoted the late Judge Cooley, who pointed out that the Jew plausibly urged that the laws discriminated against his religion. Rabbi G. H. The ball will be one of the largest social events ever given in Brooklyn, and nearly all the State and city officials have signified their intention of being present.

The society is now entering upon its sixth year and contains 3,500 names on its roster. The result of the work of the society is shown by the building now in course of construction at Howard and Dumont avenues. The building, which will shelter 250 people, will be modern and complete in every detail. It will contain two separate wards, twenty private rooms for the use of old couples, two hospital wards, sitting rooms, a synagogue in all its details, two large sanitary kitchens, which will be kept under strict dietary regulations. This building will cost at least \$70,000 when completed.

Y. M. H. A. of Bayside.

At a largely attended meeting of the Young Men's Hebrew Association, of Bayside, last Sunday, the recently elected officers were duly installed by Mr. D. Drechsler, a director of the association. After the installation Prof. J. Kahn and Messrs. C. Joseph, E. Davis, I. H. Kramer and B. Gross addressed the assemblage.

The officers installed were S. Kramer, president; S. Wachsman, vice-president; M. Flax, treasurer; B. Kahn, financial secretary; A. Cohn, recording secretary; B. Slutsky, sergeant-at-arms, and N. C. Greenfield, editor.

Cohan and Harris will present Douglas Fairbanks in "Hawthorne of the U. S. A.," a comedy by James Bernard Fagan, at the Montauk Theatre, for one week, commencing Monday, January 13. As Anthony Hamilton Hawthorne Mr. Fairbanks will portray a strenuous, happy-go-lucky young daredevil with a romantic strain in his make up and a banking for adventure in his heart. Actuated by a thirst for the exploration of the more obscure kingdoms of Southeastern Europe, Hawthorne and his pal, Rodney Blake, are motoring along the highways and byways of the Old World when romance and adventure extraordinary halts further progress and inadvertently involves the ebullient young American in the turmoil and intrigue of an embryonic revolution that has for its object the upheaval of a government and the dethronement of a King. American pluck and resourcefulness are admirably exemplified by the exploits of Hawthorne and his friend. Love and self sacrifice prove to be the real power behind the throne and romance achieves a real victory. The play bears a message of inspiration, the dominant note being that true heroism is self sacrifice. The great obstacle to being heroic is the doubt whether one may not be proving oneself a fool. The real hero will resist the doubt when it ought to be resisted and obey the impulse at the psychological moment. The delightful love story of the play is powerful in its appeal. It teaches that love is impulse but that true love is impulse wisely directed.

A Walk Through the Dublin Ghetto.

Undoubtedly the best time to see and understand the sights of the Dublin Ghetto is Saturday and Sunday, when the men folk are home to observe the Sabbath and enjoy the week-end recreation. On the whole the Sabbath is noisily kept by the general mass of Dublin Jews. On Friday evening—Erev Shabbos—one may see Hebrews, old and young, cycling or driving home in traps so as to be in time for the "Ma-ariv" service. At the appointed hour they are to be seen walking, mostly in groups, along the South Circular road, then under the railway bridge at Harcourt street station, and into Adelaide road on the other side; one minute more, and the synagogue is reached. Naturally, the attendance on Saturday is much larger, and all the smaller "shuls"—the chief being one in Lower Camden street and another in Lennox street, and two more in Lombard street—are well filled with their respective congregations. On Sunday the various societies hold meetings, lectures or party entertainments as the case may be. The common rendezvous of most organizations is

a house in Lombard street which formerly belonged to the Jewish Literary and Social Club, but which now is the property of the local branch of the Ancient Order of Maccabaeans. This building has a reading room, open to the general Jewish public; here the meetings and entertainments are properly held. Upstairs there are a few rooms in which the society's members amuse themselves with such games as chess, draughts (checkers) and dominoes. An English, Yiddish and Hebrew library is also attached to the reading room; but books are issued to members only.

On the whole, the Jews of Dublin live well and comfortably. It is, however, a pity that so many of them have adopted money lending as a source of livelihood, and—alas! of vulgar luxury. This practice has of late become so extensive that it has brought the Jewish population of Dublin into considerable disrepute, and it is high time that the community itself should resolutely deal with this odious question.—Jewish Times.

Three Sayings

Dear Children:

Rabbi Simeon said: "Be careful as to reading of the Shemaug and the repetition of thy prayers, and when thou prayest, do not regard thy prayer as a mere fixed duty, but as a fervent supplication for mercy before the Omnipresent, as 'tis said, 'For gracious and compassionate is He, long-suffering and abounding in mercy, withdrawing purposed evil.' Yet do not be a reprobate in thine own estimation.

These three sayings also connect with the maxims of the former speaker Rabbi Jose, "How can you escape from the dominion of evil thoughts which are created in a person's mind in a thousand different ways—everyone of his five senses acts as an agent for a different brand of evil thought?" There is only one way, my children, and that is to read the Shemaug. The Shemaug teaches you the unity of the Creator and subjugates all your mental faculties under his dominion. It then takes your heart and your soul and all your powers and concentrates them all on the love of the power of all powers, the cause of all causes, the Providence of the entire universe, the Holy One, blessed be He, whose eye is ever upon you, reading your thoughts and repaying you good or evil, according to the secret longings of your heart in so much as it contracts or is controlled by your eye.

Therefore, be careful, dear children, as to the reading of the Shemaug. Learn the meaning of the words and bear in mind that the peculiar power of the Shemaug when uttered with the right spirit is to lift you up above the world and everything earthly, and to make you commune with your Maker in infinitude.

But we are only human, and as such are liable to err. We feel the earth sinking beneath our missteps, we would fain cling to some support of flesh and blood to save ourselves from falling. They shrink from us and we would perish through our errors, were it not for our Heavenly Father who bade us "Pray not to man, but to Me. I understand thy heart, know what is ailing thee and I, only I, can heal thee."

Therefore, dear children, the silent prayer, in which we repeat eighteen blessings and which fully express all the yearnings of our heart, all the longings of our soul and the very pressing demands of our physical needs.

"If," say the Rabbins, "one repeats the silent prayer long enough for his neighbor to hear, his prayer will not be heeded by the Almighty." By this they impress upon us that to the Holy One, alone, must we pray.

"Yet, do not be a reprobate in thine own estimation." This is the final and most necessary climax to

the great lesson Rabbi Simeon is teaching us.

If we wish to take advantage of the message of mercy and forgiveness that the Almighty has sent to us through His prophets, we must not sink so much in our own estimation as to consider ourselves beyond redemption, as if we can no longer raise our feet out of the mire of our misdeeds, to stand up through the love of the Shemaug or the outpourings of the soul in the silent prayer, for the Eternal is gracious and compassionate, long-suffering and abounding in mercy.

The attacked, however, offered a stubborn resistance, and many of the combatants received injuries. On the approach of a force of gendarmes the Ruthenians dispersed. The authorities in Galicia have issued a statement denying the possibility of a pogrom outbreak.

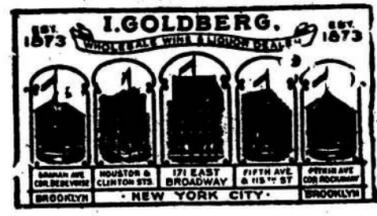
