THE NATIONAL "YAHREZEIT"

בכר את עמך

The Ghetto-Jew is a living dirge, an animate elegy, a walking jeremiad—a Jeremiah minus his poetry and prophecy; to get *him* to observe the "Fast of Ab" is no task at all—he does not require to be reasoned into it. There is no necessity for appealing to *his* logic, *his* national sympathies, or to *his* patriotism, much less to have to adduce fresh arguments in order to induce *him* to observe the National "Yahrzeit." In *his* case it would be but preaching to the already converted, since *he* is already convinced. With *him*, the observance of the "Black Fast" is perhaps more a matter of instinct than logic, and no wonder. For who can feel more the tragedy of the Golus than himself? Regarded as a "stranger" in the land of his birth, the evidence of *his* "Churban" is ever present before him—it is so patent, so complete in every detail and therefore so convincing that *he* cannot help bemoaning publicly once a year, at least, the relentless destiny which rendered him for the last eighteen centuries the "Luftmensch," the fugitive, the legitimate game of every dog of a sportsman. The Ghetto-Jew does not require to work up his imagination on the one day in the year, to transplant himself visionally into Palestine on that saddest day, in order to realize the loss he and his nation sustained by the downfall of his polity and the alienation of his property—he does not need this mental aid to make it possible for him to attune his mind to the mournful commemoration the Black Fast evokes. He sees it at home; and every day in the year; feels it on Passover—the most joyous day—as on the Ninth of Ab! To *him* the picture is vivid enough, near enough, too painfully real, too irritatingly poignant to need the conjuring up of the imagination. The Ghetto-Jew, if anything, is rather thankful for the opportunity the ninth of Ab affords him to have a good cry at the national loss which spelt his *individual* tragedy—the loss in the aggregate which he feels so keenly in the


unit. There is no task at all, no argument or persuasion needed to get the Ghetto-Jew to observe the Fast of Ab.

The task, however, is with the emancipated Jew—and no small task either—to get *him* to acknowledge the claim Tishoh-b'Ab has on his

Jewish fidelity. In *his* case one does require all the arguments that can be advanced, all the reason and logic one can marshal, all the appeals to

his Jewish patriotism, and all the practical proof one can put in evidence, such as the ubiquitous anti-Semitism furnishes day by day, in order to convince *him* of the propriety of keeping this National Memorial on the ninth of Ab; and he would be a Demosthenes who could reason *him* out of his plausible sophistry and induce *him* to observe the Black Fast. For the Western Jew, finding himself no longer the object of restrictive legislation, feeling no longer the pinch of exile in its acute form, being quite satisfied to remain where *he* is, he cannot see why *he* should observe the ninth of Ab—having once persuaded himself that he is an "American or an Englishman of the Jewish persuasion," in possession of a home and a country who has nothing to fast, mourn or pray for. The Western Jew declares himself to be an *American or Englishman first*, and a *Jew only after*—though the unsophisticated crowd in the street emphatically protest against his assertion, and says positively "No!" "You are a Jew from first to last; your American or English birth is but a mere accident which does not count," he insists upon this ludicrous claim in spite of all protest. His native country, he says, is *his* Palestine, and its Capital, be it London or Washington, is his Jerusalem!—with such a Jew it is indeed no easy task to reason him into fasting and mourning for a loss he does not feel.

Yet, withal, it is to *this* Jew that we would address ourselves on this occasion. Let us, however, first assure him that we do not wish to disturb his equanimity of mind or to allure him to Palestine against his will. He is welcome to remain here to enjoy his sweet dream of "American or Englishman *first*" as long as it lasts. But this "American first" was nevertheless good enough to own to his being a Jew *after*; it is therefore to this "Jew *after*" that we would here speak; and we feel not a little thankful to his admission that in the back of him there is still a Jew left to address ourselves to.



CARL STETTAUER

By the death of Carl Stettauer, one of the progressive members of the London County Council for Mile End, which occurred on July 24 after a prolonged illness, the English Jewish community loses one of its most prominent and popular members. There were few Jewish institutions to which his services were not given. Born in 1859 in Bavaria, he settled in London many years ago as a leather merchant. He devoted much time to public service in general and the Jewish community in particular. He held various offices on the Jewish Board of Guardians, which body he represented at an international Jewish conference at Frankfort in 1904. After the terrible pogroms on Jews in Russia he went himself at great personal inconvenience to that country to organize the distribution of relief to the victims. Later he joined the Emigration Committee of the Jewish Territorial Organization, of which Mr. Zangwill is president.

father or mother is concerned in particular; namely, that the soul of his parent is immortal! That to the best of his knowledge and belief his parent was never guilty of any of those Biblical offenses the penalty for which is eternal damnation or excision. (1) Thus the observance of the "yahrzeit" constitutes a sort of testimony borne anniversarily before the tribunal of the Jewish public, in Synagogue assembled, to the Jewish conduct of his parents. The son, as such, is fulfilling the spirit of the Fifth Commandment, which obligation does not end with the death of the parent, but only with the death of the child!

Presuming, now, that we have correctly represented you, sir, in the answer to the first question, and accurately described your reasons in reply to the second, we shall now proceed to tell you, Sir "Jew-after," that the Black fast is, in one sense, also nothing else than a "yahrzeit"—the national "yahrzeit" the children of Israel annually keep for their mother country, Israelia or Judea—for the dead Jewish nationality, whose body and soul are also immortal! The analogy, in the main, is not ours, but Prophet Ezekiel's, which appositeness was demonstrated in the histories of other nations as well as in our own.

Nations, like individuals, come into the world, grow, mature, age, decay, and die. Nations, like individuals, are, while alive, conscious of a soul, i. e., a national soul, which animates, sustains, unites, unifies, and keeps the body politic together. After death or national dissolution the national soul of such nations as did not merit excision or extinction remains immortal—the national spirit still continues to live among the survived remnant; exercises its telling influence over the scattered fragments; makes them cherish the hope of a national revival, and the work for its resurrection. They keep up every national distinctiveness, ever look forward to the day of their national resurrection, which they firmly believe will rise one day, phoenix-like, from its ashes again. Other nations, however, have died completely, never to rise again any more. Their national soul proved mortal; no national spirit was left with the remnant as to insure its revival; it died along with the body; hence there is no national resurrection in store for them! The national souls of such as Greece, Italy and the Balkan States are a fair illustration of the former; those, again, of the Hittites, the Phoenicians, the Assyrians and the Chaldeans may be taken to represent the latter. Greece and the others of her class live at this day again a national life in their resuscitated states—and the historian of the future may possibly have to include Egypt and Poland also in this category, for he would be a bold man who would say that Poland's or Egypt's national souls are absolutely dead, in the face of recent manifestations; while the Chaldeans and the rest are positively as dead as the nail in the coffin—they were evidently cut off from the tree of national life absolutely. Their conduct during the

"yahrzeit," honors three, viz., God, his nation, and himself! He honors God by this observance, since he evinces his belief in His promise; he honors his nation, inasmuch as he avows—albeit indirectly—that the conduct of his nation, while alive, was such as NOT to have forfeited eternal life; and finally honors himself, since he declared himself, by this very act, to belong to a stock, a race, the nationality of which is fit to live again!

The latter, however—who answers the question in the negative—he by his indifference positively insults the "three." God he insults by doubting His word; his nation he insults by casting a reflection upon the character of his nationality—as if he does not consider it entitled to a resuscitation; and himself, finally, he insults, inasmuch as he implies that he sprang from a race whose nationality is not fit to live again!

Let the "Jew-after," who has in him sufficient respect for his God, his nation and himself, ponder well over these words, and not be in too great a hurry to insult these THREE!

JEWES AND SCIENCE

Felix Klein

Specialization has reached such a pitch that chemists not only specialize in certain branches of chemistry but certain branches of these branches. Thus, Weintraub has investigated the chemical and physical properties of an element—boron. Klein has made himself familiar with his investigations into the element selenium, concerning which he read several noteworthy papers at the last Congress of International Chemists.

Nearly 100 years ago Bergelius, the celebrated Swedish chemist, isolated the element selenium from the residues of the sulphuric acid works. For many years it proved nothing more than a mere chemical curiosity—as many other elements and substances have proven. Then came the change. Certain preliminary investigations of other experimenters led Klein to believe that the element possessed remarkable properties, and he set to work to make a thorough study of the subject. His results thus far have amply repaid him for his labors.

Mendeleeff's periodic classification places the elements sulphur, selenium and tellurium in one group, as they show decided similarity in properties, yet neither sulphur nor tellurium promises to duplicate its sister element in the exclusive use to which this will probably be put.

Felix Klein, who is a German by birth, and who received his doctorate from the University of Munich, came to this country about five years ago, and soon after opened a consulting laboratory. Here in his workshop he has been investigating some of the problems the solution of which he is seeking.

Some of the possibilities and accomplishments of selenium have been summarized by Klein as follows:

1. It may replace coal as a heating and power-generating agent.
2. It magnifies minute sounds to almost incredible volume.
3. It renders more acute the sense of hearing.
4. It may be the means of sending invading vessels of war to their destruction, and this by its automatic action.
5. It facilitates the blowing of hard glass.
6. It may solve the problem of color photography.
7. From finding traces of the element in livers affected with cancer, it is probable that nature produces it there in an effort to get rid of the disease.

"It is the most interesting and wonderful substance with which I

have had to deal," said Dr. Klein to an interviewer recently. "It is also the most poisonous. You can see what it has done to my hands."

Dr. Klein's left finger stuck out straight. He was able to bend it with his right hand, but not as a voluntary action.

"It burned the finger so that the nerve was entirely destroyed, so far as usefulness goes," he explained, and then indicated numerous reddish-brown and yellow splotches on his nails and skin.

"When I work with selenium I cannot smell anything for six hours after, but my hearing is much more acute. It also causes a sort of eczema to break out if one experiments with it too long a time.

"This very peculiar chemical body has been somewhat forgotten in the chemical world. Chemists have lost sight of its important physical and chemical properties which might well help to produce some ingenious invention to bring fortune to the inventor and to solve one of our greatest thermoelectrical problems, namely, to transform natural heat into a direct potential power.


"Regarding the transformation of natural heat into a potential power, I must consider coal, which furnishes on an average from 5 to 10 per cent of actual work from the heat value of the coal. A running train receives three-fifths of 1 per cent. of the coal's energy. All the rest is lost. The loss of these gaseous bodies is so immense that it amounts annually to 1,000,000 horse power and about \$50,000,000, besides the difficulty in mining, loss of life, explosions and mining many thousands of feet to obtain material.

"Sir William Siemens, one of the greatest fuel experts, says: 'Raw coal should not be used as fuel for

any purpose whatever, and the first step forward, the judicious and economical production of heat, is the gas retort, or gas producer, in which coal is converted either entirely into gas or gas and coke, as used in ordinary gas works."

"I still further suggest and would like to submit this question: Is it necessary for us to mine thousands of feet to get petrified plants with the absorbed heat value of the sun's radiation—this in the form of coal? Could it not be made possible to utilize the natural heat?"

"Selenium is used in the observation of the transit of Venus and the eclipse of the sun to light and extinguish buoys automatically, to guide and explode torpedoes, for measuring X-rays, and in the glass industry, especially in the manufacture of red glass.

"A remarkable property of a compound of selenium, selenic acid, is that it dissolves gold, one of the very few solvents for gold that we have."

The chances are that many another element will show remarkable properties, provided investigations be undertaken in as thorough a manner as Dr. Klein's.

ITEMS OF INTEREST IN THE JEWISH WORLD.

A Jewish Uplift Society is in course of formation in Latrobe, Pa.

A contract has been let for the erection of a new synagogue in Plymouth, Mass.

A new synagogue is to be dedicated shortly at Thomasville, Ga.

The various Jewish charities of Houston, Tex., have decided to federate.

On the occupation of Dolran by the Greeks a Jew was appointed as the chief official of the town.

The Finnish authorities threaten to arrest all Jews who venture to visit the local summer resorts.

A severe economic crisis is raging at Berdicheff, Russia, a town inhabited almost entirely by Jews.

The late Mrs. C. B. Richard left a sum aggregating \$5,000 to a number of New York city Jewish charities.

Mr. Ephraim Lipscon has been appointed examiner of history to the University of Aberdeen, Scotland.

A meeting was held last month for the purpose of inaugurating a Hebrew day nursery at Montreal, Canada.

It is announced that Superior Court Judge Frederick Spiegel will be the Republican nominee for Mayor of Cincinnati, O.

It is reported that Emperor William is seriously considering the advisability of taking up the cause of the 250,000 Roumanian Jews.

A certificate of incorporation has been granted to the Texas Hebrew Tuberculosis Sanitarium, which will be located at San Antonio.

Rabbi Isaac Brav, of Pensacola, Fla., has accepted a call to the newly organized conservative congregation of McKeesport, Pa.

There will be five large theatres devoted to the presentation of the Yiddish drama in New York city during the coming season.

Of late numerous instances have been reported throughout Russia of the repeated refusals of medical aid to Jews by Christian doctors.

Professor Gabriel Lippmann, the famous Paris chemist, has had the degree of Honorary Doctor conferred on him by the University of Geneva.

As a result of the persecutions of the Jewish students, eighty of them have adopted Christianity in order to enter the Kieff Commercial Institute.

The respective governors report that the emigration to America is rapidly increasing in the provinces of Volhynia, Kieff, Charkoff and Minsk.

The French Academy has awarded 1,000 francs from the Santour Prize to M. Lazare Saineau for his two volumes, "Les sources de l'argot ancien."

"The Merchant of Venice" has been barred from the public schools of Los Angeles, Cal., on the ground that it portrays the Jew in an improper light.

The Galician anti-Semites are actively exerting themselves to introduce into Galicia the boycott which the Russian Poles have declared on Jewish goods.

Abraham Blum, of New Orleans, one of the best-known cotton brokers in the State of Louisiana, died at his summer home at Charlivoux, Mich., last week.

A synagogue was dedicated at Sidney, Nova Scotia, last week. Mayor Gunn presided over the exercises, and Christian clergymen delivered addresses of welcome.

Of the seventy-four Jews arrested last week in the synagogue at Minck, fifty-two were sent to prison for two weeks, one for three months and the rest were all released.

The Czar has bestowed the rank of Hereditary Honorary Citizenship on the musical critic, M. N. Bernstein, and the title of Court Councillor on the Jewish doctor, Spero.

The commanding officer of the U. S. army post at Fort Leavenworth, Kan., has issued orders that in future Jewish soldiers be granted furloughs on all Jewish holidays.

The newly formed General Organization for Jewish Colonization has established a monthly organ which will be called "Der Orient," and which will be issued from Berlin.

The Czar has pardoned a young Jew, Ephroth, who was sentenced by a court-martial in 1908 to penal servitude for life for expropriation, but whose innocence has been established.

The Jewish community of Salonika has placed the Hirsch Hospital and the Jewish schools at the disposal of the military authorities for the reception and care of the wounded.

Plans have been completed for the fourth annual State convention of the Pennsylvania Young Men's Hebrew Association, which will be held at Reading on August 24 and 25.

The Czar has sent his thanks to a Jewish soldier, Noah Shuak, for his bravery in capturing, single-handed, three prisoners who had escaped from a prison in the Turkestan district.

Dr. Charles F. Myers, director of the Physiological Laboratory at Cambridge (England) University, is to edit for the University Press a series of works allied to the study of physiology.

A Russian official, Sturmer, the son of one of the members of the court clique, has been found guilty of extorting money from Jews in the province of Kursk, threatening them with exile.

The Chief Rabbi of Salonika has appealed to the Jewish communities of Vienna, Berlin, London and Paris to protest in a suitable manner against the Bulgarian anti-Jewish atrocities.

Destructive fires have devastated the townlets Bakshiti (Wilna), Chotsh (Poland) and Schereshevo (Grodno). Floods have also done great damage in the Pale towns, Minsk and Kremenitchug.

At Zanevitch (Grodno), two hundred Jewish girls under age have been abducted to a Catholic monastery. With the aid of the police, however, the children were restored to their parents.

Prof. Boris Schatz will soon arrive in New York to make arrangements for an exhibition of the work of the Zazalel School of Arts and Crafts of Jerusalem, which will be held in the early fall.

An appeal is being made for Jewish support for the Metropolitan Hospital of London, Eng. There are two wards reserved for Jewish patients and there is a specially equipped Kosher kitchen.

The Seattle (Wash.) section of the National Council of Jewish women will soon go ahead with the building of a modern settlement house. The cost of the structure will be at least \$25,000.

The growing need for a Jewish orphanage has led to the decision of the Jews of Winnipeg to be the first city to supply a long-felt want in the whole of Western Canada. The movement was set on foot over a year ago, and a temporary building will soon be opened. The orphanage will be built on the cottage plan and \$100,000 will be necessary to finance it.

Mr. S. Herbert Wolfe, a consulting actuary and insurance expert, has been named by Mayor Gaynor as a member of a commission to draw up a pension law for the employees of the City of New York.

Prominent residents in the southern section of Philadelphia, Pa., are planning to erect a new synagogue somewhere along South Broad street. The synagogue will be along conservative lines.

Regina, the thriving Canadian city of the Northwest, is to have a synagogue which is to be erected this year. There will be accommodations for a Young Men's Society and other social organizations.

The annual report of the Montreal Hebrew Free Loan Association shows that in the twenty-one months of its existence it has granted 962 loans to the value of \$43,000. So far there has not been one bad debt.

The eighty-third party of ITO emigrants, numbering 424 people, which sailed on July 17 from Bremen, has arrived at Galveston. This is the largest arrival in the history of the Galveston emigration movement.

A mixed committee composed of Greeks, Jews and Mohammedans has been formed in Salonika to manage the hospitals of the city. A Jew, M. Joseph Bensusan, has been elected vice-president of the committee.

The estate of the late Jacob W. Mack, of New York city, has been appraised at \$259,513. Mr. Mack, who died in April, 1912, left \$10,000 to the Mount Sinai Hospital and \$2,500 each to eight other eleemosynary institutions.

Details of the atrocities at Serris show that the Jews were the worst sufferers. Besides the synagogue and schools 117 homes of Jewish residents were burned to the ground. The Bulgarians accuse the Greeks as the guilty ones.

Dr. Eugen Taubler has been elected to the newly created Ludwig Philippson chair for Jewish history in the Berlin (Germany) Lehrenstalt. Dr. Taubler is editor of the publications of the Gesamtarchiv der Deutschen Juden.

At a trial held recently at Ekaterinburg (Russia) a student confessed he brought proceedings against a Jew and not against his Christian colleague, who had also libeled him, because "it was easy to put a Jew into prison."

At the annual conference of rural community leaders, held at the Massachusetts Agricultural College, Amherst, Mass., last week, one of the principal features was the exhibit of the Jewish Agricultural and Aid Society.

Rabbi I. E. Philo, of Akron, O., who some years ago left the ministry to practice law, has decided to go back to his earlier calling and has accepted a call from the Congregation Rodeph Shalom of Akron, O., beginning September 1.

The seventeenth annual convention of the Progressive Order of the West was held in Cleveland, O., last week. Sixteen States were represented. The order during the past year has added 3,516 new members, and now numbers over 15,000.

An interborough debating league has been organized in Brooklyn, N. Y. It is the hope of the promoters to interest the various literary and debating societies affiliated with the Young Men's Christian and Young Men's Hebrew Associations in Greater New York.

Charles Eiseman, who died at Sioux City, Ia., last month, aged 79, was one of the pioneers in the territory of Dakota. He lived at Yankton for many years and was a member of the first and subsequent Boards of County Commissioners for Yankton County.

The Russian Senate has decided that Jews who reside in the villages are allowed to absent themselves from their permanent residences for a period not exceeding a year. The decision will prove a great boon, as hitherto their departure from the village, even for a few days, had been utilized by the police as an excuse for expelling them.

Eric Randolph, who has lately been delighting London music hall lovers with his fine voice and who is described as the "wonderful new tenor," is the youngest son of the late Rev. M. A. Epstein.

Ethan Allen Weinburg, of Brooklyn, N. Y., who was commissioned as lieutenant commander of the Bulgarian Aero Legion at the outbreak of the Balkan War, has been decorated by the Sultan of Turkey with the Order of the Commandery of the Imperial Medzhlah.

Medjid Bey, the new Governor of Jerusalem, visited the Jewish colonies in Palestine last month, and everywhere the colonists tendered him a brilliant reception. The governor also visited the elementary and technical schools of the Alliance Israelite Universelle at Jerusalem.

Simultaneously with the declaration that Jewish architects from the Pale will not be allowed to attend the Moscow Congress of Architects came the news that a Jew, Nachman, obtained the first prize for his plan of a home for aged nobles in commemoration of the Romanoff tercentenary.

The Jewish institutions which have been receiving aid from the State of Pennsylvania have had their appropriations materially reduced this year. Governor Tener says the course was necessary, as the Legislature has appropriated more money than the State will collect through the next two years.

The Municipal Library at Frankfort has recently been enriched with several valuable gifts. For the Hebrew and Jewish section, Baroness Mathilde de Rothschild has presented a copy of the Pentateuch, with commentaries printed on parchment, and dated 1490, and Baroness Edmond de Rothschild, an illustrated Pesach Hagada of the sixteenth century. Mr. Jacob H. Schiff, who is also a native of Frankfort, has given a large sum for the extension of the American section.

A unique Jewish preacher has appeared in the south of Russia. He is a Russian convert to Judaism, and he preaches in Russian. His appearance in the synagogues creates a deep impression. He tells of the martyrdom of the converts to Judaism and their persecution by the Russian authorities, of the holiness in which the Sabbath is observed by those converts and of their hospitality. This remarkable preacher is already very old, and the Jews display profound respect for him.

At a Russian Cabinet meeting objections were raised to the confirmation of Count Tolstol as Mayor of St. Petersburg on account of his pro-Jewish sympathies. The Premier, however, persuaded his colleagues to confirm the election. In another Jewish matter serious differences arose between the Premier and his colleagues, the former insisting that divorced Jewesses, who, before their marriage, resided outside the Pale, could return there on obtaining their divorce. The Minister of the Interior declined to accept that view, and the matter was referred to the Senate.

During the recent visit of the Protestant Bishop Dr. Desider Balthasar to Huszt, Hungary, the celebrated Yeshibah town in the province of Marmaros, this prelate delivered an address which was nothing less than a eulogy of the many good qualities of the Jews in the district. He bade his audience, which comprised the most intellectual Christians in the town, to respect the Jews there and elsewhere in the country, for they were destined to render great service to the State and to the furtherance of culture.

Orthodox Rabbis at the Hebrew Sheltering and Immigrant Aid Society.

On Sunday last twenty-five of the rabbis attending the tenth convention of the Union of Orthodox Rabbis visited the Home of the Hebrew Sheltering and Immigrant Aid Society, 229-231 East Broadway.

The party consisted of Rabbis B. L. Leventhal, Philadelphia; Solomon E. Jaffe, New York; David H. Ginsburg, Wilkesbarre, Pa.; B. Boehuroff, Malden, Mass.; David H. Bachrach, Providence, R. I.; Elias Inselbuch, Brooklyn, N. Y.; P. Robsky, Paterson, N. J.; Isaac Siegel, Bayonne, N. J.; M. Vernikofsky, Ansonia, Conn.; J. Levenberg, Jersey City, N. J.; D. Gordon, New York; B. Aronovitz, New York; W. Gold, Brooklyn; I. Wenderovsky, New York; I. Davidson, New York; B. M. Payer, New York; A. Flax, Poughkeepsie, N. Y.; Isaac Marcus, New Brunswick, N. J.; Louis Sijver, Harrisburg, Pa.; S. B. Spriner, Boston, Mass.; Raphael Winer, New York; Israel Isaacson, New York; Moses Sobel, New York, and S. H. Glick, New York.

They were received on the part of the institution by Messrs. Philip Hersh, members of the Board of Directors, and J. Massel, honorary secretary, and the Rev. B. Siegel.

Speeches of welcome were made by the Rev. B. Siegel and Mr. J. Massel.

After the rabbis had inspected the building and had closely observed the arrangements for the observance of the dietary laws (kashruth) they were entertained by a repast.

Addresses were delivered by Rabbis Jaffe, Ginsburg, Siegel, Levinberg, Gold, Silver, Inselbuch, Isaacson and Boehuroff.

The rabbis congratulated the institution upon the manner in which the work was conducted and promised to extend to it every co-operation.

In the evening a mass meeting was held in the synagogue of the home. Rabbi Leventhal presided.

The rabbis expressed their pleasure upon the thoroughly Jewish conduct of the home, both as regards the kashruth as well as the manner in which the immigrants were treated.

Dr. Drachman Receives Call to Cleveland.

During the recent visit of Rev. Dr. Bernard Drachman to Cleveland, O., in the interest of the Union of Orthodox Congregations, a strong sentiment developed in favor of endeavoring to secure him as rabbi for the Cleveland community. As a result of this sentiment the Congregation Keneseth Israel, at a special meeting held on July 27, voted to extend him a call to their vacant pulpit. Dr. Drachman, who is at present in Sharon Springs, has the call under advisement, but it is not probable that he will accept the same.

Local Office for Hebrew Sheltering and Immigrant Aid Society.

The buildings of the Hebrew Sheltering and Immigrant Aid Society erected on the cottage plan at Pleasantville, N. Y., are completed, and a city office has been opened at No. 470 West 145th street. The city office is for the convenience of relatives who may desire information concerning the welfare of the children.

At the same address is the placing-out department, which finds good homes for many of the children who have been at the Pleasantville colony. Many communications are received by the society from private families expressing their willingness to adopt and care for an orphan.

Albert Lucas Classes.

The Albert Lucas Association has planned a grand reunion on Sunday, August 24, and for that purpose has chartered the steamer Herman A. Caswell for a sail around Staten Island. The boat will leave the Battery at 9.30 a. m. and the return landing will be made at 8 p. m.

A limit of 150 has been made, and no more than that number of tickets will be sold. A stop-off will be made for three hours at a grove, affording an opportunity for boating, bathing and dancing.

Young Women's Hebrew Association.

The outdoor summer nursery continues to have a full attendance at each session, and the little children of the neighborhood are kept interested each morning with kindergarten games and songs. During the past weeks several outings have been held, among them being those of the Esther J. Ruskey Religious Circle to Hartsdale, the Mothers' Club to Glendale Schutzen Park and the children of the Hebrew and Religious School to the New York Zoological and Botanical Gardens.

Albany, N. Y.

Memorial services were held last Sunday afternoon at the Temple Beth El Jacob to commemorate the ninth Yahrzeit of the late Theodore Herzl, the Zionist leader. The speakers were Rabbis Browne, of Brooklyn, and Hurewitz and Levinson, of Albany, the latter presiding. A feature was an original elegy written for the occasion by Rabbi Levinson.

Tobias Michael Carel Asser, the great Dutch jurist and authority on international law, died at his home, The Hague, Holland, on the 29th ult. Dr. Asser, who was born in 1838, was a member of the Permanent Court of Arbitration at The Hague and the winner of the Nobel Peace Prize awarded in 1911. He received his doctor's degree in 1860 and in 1862 was appointed to the chair of jurisprudence at the Athenæum. From 1862 he took an important part in conferences on international law. In 1875 he became Assistant Secretary of State, and in 1893 was appointed a member of the Council of State, the highest body in the Dutch administration. He received numerous decorations and was an officer of the Belgian Order of Leopold and a Knight of the Legion of Honor.

The measures adopted by the heads of some German universities against Jewish students from Russia are being imitated in Switzerland, though not in so harsh a form as at Leipzig or Munich. The medical faculty at the University of Basle has issued regulations by which, from January 1, 1914, the conditions for students who aspire to the degree of doctor of medicine and who have not

passed the Swiss State examination, will be made more severe. The students who will be affected are nearly all Russian Jews, for the Swiss medical diploma can only be obtained as the result of an examination in that country which Russian Jews cannot have passed, as they only attended the gymnasiums in their own country.



New York is not only the foremost manufacturing State of the Union, but it manufactures and consumes more malt liquors than any other State.

We somehow never get tired of barmitzvahs. We all seem to recognize how farcical the whole performance is, yet that doesn't prevent us from attending the many that we have to attend, and rejoice and make merry on each such occasion. NEWS FROM ENGLAND.

(Exclusive Correspondence to THE HEBREW STANDARD.)

Jews and Stockholders in Russian Companies—The Farewell to Dr. Hyamson—Review of His Career—The Question of Anti-Semitism in England—Death of Carl Slettauer.

London, July 25, 1913.

References frequently made in these columns to the friendliness of practically all the British newspapers in giving space for the discussion of Jewish grievances may be again supported this week. The leading financial daily newspaper in this country is the familiar pink "Financial Times." This is a large twelve to twenty page daily, covering the whole field of finance and commerce. Unlike its principal competitor, the "Financial News," it is not owned or controlled by Jews, still it extends the same sympathy to Jews. Recently it had the following: The very phrase "Jewish Disabilities" will, we fancy, sound as an anachronism to most men in the City (as London's financial district is specifically termed) many of whom will even have a difficulty in believing that Jews suffered civil disabilities during a portion of the nineteenth century in England. The following paragraph taken from "Darkest Russia," an organ published in London in furtherance of political reform in Russia will come as a considerable shock:

A Russian Government Commission, under the chairmanship of the Assistant Minister of Commerce, M. Bark, was appointed some time ago to elaborate rules which would limit the rights of Jews to participate in joint stock companies. These rules have now been drawn up, and a report has been laid before the Council of Ministers. The report recommends that what is now enforced by administrative action should be made a provision of the law, namely, that Jews should not be allowed to form a majority of shareholders in any joint stock company. No Jew should be allowed to become a director or manager of a company or to administer its estates. Further, the commission recommends that the Council of Ministers should be authorized to issue any prohibition it pleases in cases of an exceptional nature—such, for instance, as the formation of a company in places where the presence of Jews is thought to be undesirable. Russia's most cordial friends, among whom we claim to be numbered, continues the "Financial Times," may well express the earnest desire that the Russian statute book may never be disgraced by such legislation. The political publication from which we have quoted states that a rule to the effect that Jews shall not be allowed to form a majority of shareholders in any company is at present enforced by administrative order. It is difficult to believe that such a rule could now be embodied in law just at a time when such efforts are being made to attract foreign capital to Russian enterprises. Would M. Kokowzow, for instance, refuse to allow Jewish investors abroad to put money into a company operating in any part of Russia?

Pleasant and fraternal scenes marked a presentation to Rabbi Dr. Hyamson by the conference of Jewish ministers on the departure for America. The gift was a salver, and in presenting it the Rev. A. A. Green reviewed Dr. Hyamson's life. He mentioned that Hyamson's father was a very great scholar, and this fine old Talmudist used to study with his little boy and teach him and inspire him; and the picture of Hyamson in his parents' home had always appeared to him to form the natural and logical foreground of all the successes he had attained and of all he would ever be worthy of. He had been a very clever boy. He remembered when he was taken round to have his wonderful knowledge tested, and he recalled one cynic who remarked when some one asked what was going to be the future of a boy like this, "He will either be Meshummad or Meshuggah."

(Laughter.) He has been neither the one nor the other, but instead he had justified the best expected of him. At the college his career had always been good; he was always a good student without being a prig; he was a scholar who absorbed everything his teachers had to give him, and when he left to go to Swansea it had seemed to him that there had stepped into the ranks of the Jewish ministry one destined to have a very brilliant career for himself and a sphere of great utility for the cause to which they were consecrated. Hyamson had begun to preach at an early age. His sermons had always been of the very best, full of learning, beautifully phrased and uttered with a feeling which carried conviction to all who heard him, and they breathed a religious spirit even when he was a young man.

He was sure that Hyamson would have to go much further than America in order to go beyond the reach of these sentiments, which tied him here to everything with so much affection and made him take them away in his heart as his friends and his colleagues. Hyamson had been an indefatigable worker; he had always done his duty thoroughly and conscientiously. He had found time in the midst of a busy life to prosecute studies the results of which they had seen and taken pride in. They were all most glad to see not only their old colleague like Hyamson but the younger men distinguish themselves and gaining university distinctions, those distinctions of which they were justly proud and which were appreciated ever by those of their colleagues who, not having had the opportunity to obtain them themselves, were glad to think that the younger men were doing these things.

Addressing Dr. Hyamson, Mr. Green continued that he and Mrs. Hyamson were going away to New York, which was not very far away after all. They could now see no less of some of their colleagues than they did, even if they were in New York. They met each other very rarely, and unless something extraordinary happened they did not get an opportunity of meeting each other in that friendly and informal way. Dr. Hyamson would, he felt, think of them, and they would think of him. He had in Mrs. Hyamson a coadjutor and staunch friend whose affection for him and loyalty to him had won their admiration, and he was sure would be his mainstay in the days to come. They would watch all he did with a great amount of interest. Mrs. Hyamson had told him that she had a spare room all ready destined for the use of any of Dr. Hyamson's colleagues who might come over to America.

The question of anti Semitic tendencies is still being closely discussed in this country, one section of the community agreeing that these evil tendencies are manifesting themselves while the other section is inclined to pooh-poo them. One correspondent on the question expresses himself as follows: I have often discussed this question with one of the university dons at Oxford. I have a letter from him dated May 21, 1913, in which he says: "It is true that in certain quarters and, oddly enough, in a certain section of the Anglican Church, there does exist a certain amount of anti-Semitic feeling in England, and the Marconi 'scandal' has brought it into the open." I have met it at Oxford, and some friends tell me it exists at Cambridge and it often reveals itself when Jewish students apply for scholastic appointments. Its existence is plainly undeniable, and we must admit it, however unpleasant the admission may be.

But having admitted its existence we must be careful not to exaggerate its extent. The Oxford don would seem to think that it was not of great extent. I quote his words again: "But did you observe how anxiously witnesses at the Marconi Inquiry denied the charge of anti-Semitism? And do you realize that in France or Germany they would have gloried in it? If you had been in Paris or Berlin, as I have, you would realize what an enormous gulf divides England from the Continent in this matter of tolerance."

Of course there are always a few prepared to use any means for the slightest gain, and these are ready to stone the Jews if they think they can by this means obtain a single vote. I have no doubt there are in the city of London a number of quite "respectable" Christians who would be glad to clear the city of Jews, but this is not on account of any desire to pose as crusaders for Christianity, but merely because they would like to remove from the city all those possessing more brains than themselves. In a lesser degree this, of course, applies to many other districts where Jews prove themselves more capable than pseudo-Christians.

In politics, too, there are some who represent the increasing number of Jewish members, especially as many of them are showing themselves to be more able and in every way more efficient than their critics. But the City "Christians" and the political "Christians" who would like to raise the cry of anti-Semitism for their own gain are very few, and they have as little chance of success in this country as their little worth to the country justifies and no more.

The two important points which seem to have created some uneasiness are the Indian silver contract and the Marconi affair. But examine these for one moment and it is quite obvious that in the first case Sir S. Samuel was not the object of the attack any more than Sir

There are a certain number of more or less young "bloods" in the House of Commons who are thirsting for notoriety and hungering for a seat on the front bench, and they don't care much how they obtain either. It is fairly safe to assert that no sane person thought that either Sir Stuart Samuel or Sir Rufus Isaacs or Mr. Herbert Samuel ever did anything to justify the attack.

The British Home Secretary, in reply to a question in the House of Commons, has supplied the results of a recent census of the religious persuasions of inmates of His Majesty's prisons in England and Wales. The total number is 18,225; the number of Jews, according to statements made by the prisoners on reception, was 133.

The Jewish National Fund reports an increase of considerably more than 50 per cent. over the corresponding period last year in its collections for the first half of 1913. We regard this success with unqualified satisfaction and have no hesitation in commending the good and important work in respect of Palestinian colonization by the Jews which the Jewish National Fund is doing.

The German societies are vying with one another in their support of the Palestinian colonization movement among the Jews. Besides the subventions and other material encouragements vouchsafed by the AJKO, to which we have heretofore referred, we learn that the Vienna Society for Colonization has made a substantial donation to the Jewish National Fund for its work with the settlement of the Yemenite Jews in Palestine.

And now the Swiss university authorities are following in the wake of their German and Austrian and French confrères and adopting measures to impede the progress of Russian students in their institutions. Of course, the only Russian students that must go to Switzerland, or to any other part of the world outside Russia, for a university training are the Jewish students. So we see that even educated men on the continent of Europe are not immune from the anti-Semitic disease!

Felix N. Gerson contributes a fine poem, "The Jew in America," to *Lippincott's* for August. His scorn and contempt for Russia find a suitable vent in these verses of his, and everyone who loves justice is certain to echo his sentiment consigning the empire of the Czars to be the scorn of time. And what he adds concerning the Jew here is true, too. Ponder these words:

"A new world—with great portals far outflung—
Holding a hope more sweet than time had sung,
To which the Jew, of life's highest quest a part,
A pilgrim came, the Torah in his heart."

Rabbi J. Leon Magnes, in his fourth annual report as chairman of the "great and glorious" Kehillah, said: "Although the Kehillah is but four years old, it has made itself felt in the life of this vast community. Its main achievement is that it has given birth to the idea of a Kehillah or organized community." This modesty is so becoming that it cries to heaven for emulation! Yes, the local Kehillah has given birth to the *kehillah* idea, on the principle that we now know how not to organize and conduct a *kehillah*.

The *American Israelite* comments very sensibly on the recent decision of Governor Sulzer in the Littman case. The outcome of the matter was that justice has been satisfied, and the personality of him who produced this "celebrated case" need not concern us at all. If the Littman case continues to be referred to by "statesmen" for any other purpose except as pointing out an egregious defect in the conduct of the superior militia officer involved, right-thinking people will properly entertain the suspicion that this use of it emanates from a desire to placate Jewish Americans around election time!

The German Jews are much concerned over the growing tendency exhibited by the German university authorities to shut the doors of their institutions literally in the faces of Russo-Jewish students clamoring thereat for admittance. These seekers after knowledge cannot accommodate themselves to existing university conditions in the Russian Empire and must therefore emigrate to more hospitable countries. With Germany and France unwilling to receive them in the future, they have to look to England or America, and in the latter case the distance is an almost insuperable obstacle. So, those German Jews who are Zionists to boot, strongly support the project of establishing a Jewish university in Jerusalem, for Jews can easily wend their way from Russia to the Holy Land. We are much inclined to favor the founding of a Jewish university in Jerusalem, not because we esteem this a valuable adjunct to the Zionist programme, but altogether for its own sake. Just as science ennobles a people, so a university in Jerusalem will be the only place, other than a rabbinical seminary, where the science of Judaism may find a secured home.

The action of the authorities of Temple Anshe Chesed, of Seventh avenue and 114th street, in forming a special religious school class holding three sessions a week, is much to be commended. The purpose of this departure was to counteract the activity of those in charge of the neighboring One Hundredth and Fifteenth Street Presbyterian Church. This took on the shape of daily Bible classes, with moving picture shows and other lures, gratis. Its object will be easily apparent when one notes the fact that no less than 150 Jewish children of the vicinity attended; these "lost souls" must be brought "nigh unto Jesus" at all hazards! Temple Anshe Chesed has acted promptly and, as the events to come will bear out, effectively. But, here was an opportunity, as welcome as it was momentous, for the "great and glorious" Kehillah, with which, if we mistake not, Anshe Chesed is somewhat identified, to move in the premises. The "great and glorious" Kehillah bears the burdens of New York Jewry on its shoulders and is especially zealous in combatting the work of missionaries—if we take the enterprise at its own value! But in this case our "great and glorious" institution was conspicuous by its *far niente* and Anshe Chesed had to meet the issue unaided. But eventually the "great and glorious" Kehillah will treat this episode as if it had done everything, leaving the loyal and devoted Jews who actually performed the labor involved to the reward of their own virtue.

Again the sad day on which we commemorate the destruction of the first and second temples at Jerusalem draws nigh. *Tisha b'Ab* marks the complete ebb of all activity in the Jewish year, thus befitting its mournful character and season. Yet, while we regret the obliteration of the magnificent piles known as the Temple of Solomon and that of Herod, respectively, we rejoice to know that Jewry to-day is pulsating with life. There are probably more Jews on the earth now, in spite of the inroads made in our ranks through the torch, the scourge, the altar and the enemies within our own household, than there were in the days of King Solomon or of the Idumaeen. *Tisha b'Ab* marks the period when our life as a nation irrevocably closed. *Eretz Yisroel* may bloom as the rose of Sharon, the land may in course of time be peopled by an enormous concourse of our brethren-in-faith, our national life as it existed in Biblical times will never be restored. And we as good, observant Jews look forward to a blessed time for the Promised Land again. But this does not mean that we pervert the lesson of *Tisha b'Ab* toward the creation of a latter-day Jewish state.

That was a neat way in which Mayor Gaynor turned the tables on the Rev. Joseph Keevil, the corresponding secretary of the Kings County Sunday Observance Society, who had written to him in protest against the public playing of innocent games, like baseball, on Sundays in this city, in the sight of all the people. Mr. Keevil thought that, even though the participants in them played the games for the game's sake, and not for hire, their occupation in this manner on the first day of the week was a desecration of the day. Mayor Gaynor was not slow to ask Mr. Keevil if he did not believe his "work," in going about the city on Sundays ferreting out violations of the law for pay, was not just as much a desecration of Sunday as the innocent pastime of which he complained. To our mind, it is a much greater desecration of the spirit of the Christian Sabbath, and we make the point that considerations such as these should move our authorities whenever they must deal officially with violations of the Sunday laws of this State by observant Jews.

WHAT WOULD ISAIAH SAY?

הוין ישעיהו בן-אמוץ אשר הוה על-יהודה וירושלם:

"The vision of Isaiah, the son of Amoz, which he saw concerning Judah and Jerusalem." (Isa. i. 1).

WE are in the midst of the "Three-Weeks!" Ask our young Jews and Jewesses about Three-Weeks, and the odds are that they will answer: "Do you mean the book by Elinor Glyn?" Our hopeful-ones, disporting themselves somewhat boisterously along the beaches, certainly know more about the slippery stories of this authoress whose inspiration springs from questionable sources, than about the time appointed for our national mourning. They need to be told that to the faithful Jew this is a time for restraint in eating, dressing and all other enjoyments. Not that it will do them any good. National mourning—when the beaches smile at them and the sun-rays, glistening atop the racing waves, beckons to them? Restraint in food—when oysters and shrimps and other slimy creatures are such a relish? Restraint in dressing—when the fashions are giving members of respectable society liberties which in the time of our grandmothers, and long after that, were only taken by the *other kind*? Subdued pleasures—when the mad measures of the black man's melodies whip white men's blood into a paroxysm of passion?

Anyone reminding Young Israel of the contrast between the conduct demanded, at this season, by Jewish tradition and the behaviour sanctioned by fashion, would of course run the risk of being laughed out of court. Youth has its privileges which it emphasises in a manner that brooks no interference. Older folk must needs sink below the horizon when the bright luminary of youth shines in its own speckless sky. Yet, one cannot help thinking aloud for a few moments preparatory to the above-mentioned sinking process. And the thought that occurs, foolishly enough, to the writer of these peevish lines is: What would happen if the Prophet Isaiah, whose splendid *Vision* lends name and fame to this Sabbath, were to find himself suddenly in the midst of the frisking crowds on the sea-beaches? What would he say? Would not his wrathful voice out-thunder the pounding surf, and ring above the shouting, shrieking men and women?

Of course, this is the idle thought of an old-fogie, you say. But all the same, young man or young woman, consider it for a moment. *What would Isaiah say?* Would he repeat his sorrowful arraignment: "I have nourished and brought up children, and they have rebelled against me?" Would he repeat his old diagnosis: "The whole head is sick, and the whole heart is faint; from the sole of the foot even unto the head there is no soundness in it?" Would he finally give vent to his gathering indignation in the fierce invective: "How is the faithful city become an harlot?"

What would Isaiah say? My young friends, I give you credit for knowing that such a person as Isaiah once existed. You went to Sunday-School once upon a time, and the name has probably remained in the back-room of your mind. But you need to be told what kind of man he was, and what his message was, before you can intelligently answer my query. Now, as far as I can see, Isaiah was chiefly exercised over the decadence of Jewish life in his time, over the fundamental rottenness of the Jewish character as he observed it. He deplored not so much the occasional laxity in morals and religion from which human society will never be free, as the thorough impairment of the very texture of the Jewish soul, the fatal change in the *tone* of society, which was a spreading plague in those days. He not only protested against the obvious crimes: the bloodshed, the dishonesty, the oppression, prevalent in his day; he also decried the small, insidious vices that eat like a cancer into the human heart. And if there be a young man who prides himself in his "up-to-dateness" and thinks it very "smart" to live a gay life, let him but read what Isaiah had to say about those who "continue until night till wine inflame them, and the harp, and the viol, are in their feasts," and if there be a young woman who thinks that such a wonderful phenomenon as she never existed; that no one ever paraded in freakish fashions before the advent of the modern sisterhood, let her but read what Isaiah had to say about the feminine fashions of his time: now he chided the daughters of Zion for their "wanton eyes and mincing steps," and how he ridiculed them by giving a detailed list of the various articles of modish attire!

Oh, yes—such things have been ere this! And from Isaiah's way of dealing with them, there can be no doubt that he would deal with them once more in the same way as before. For what "us old-fogies" complain of in the conduct of the young is not an occasional laxity, but the *general deterioration of Jewish character*. It is not that the young lack this particular form of Jewish idealism which lent to the national mourning of the Three-Weeks its poignancy, but that they lack all idealism. It is not that they do not know of the restraint meet for these days, but that they know of no restraint at all. It is not even that they neglect the traditional aspects of religion, but that they neglect all religion. Frivolity is their life-breath; and frivolity has never been part of the Jewish character. Judaism cannot flourish in an atmosphere of frivolity. Judaism demands earnestness. Judaism stands for right, not for riot. The Genius of Judaism wears, indeed, a serene smile on her nobly set countenance, believing, as she does in joy and cheer; but she objects to the vulgar, *steeple-chase* guffaw that parts the face from ear to ear. This disgusting guffaw is now spread over the face of Jewish Life. *What would Isaiah say?*

A non-Jewish reader of this journal who is very highly esteemed in judicial and Masonic circles chides us with the remark that if it were not for anti-Semitism we should suffer from a striking paucity of material for our editorial comment. In proof of his assertion he displays to us a recent issue, eight of whose eleven editorial items dealt with the prejudice against the Jew in its various phases. Our non-Jewish reader should remember that in a great and populous world where the number of our people totals only twelve million, the office of a journal such as ours is to describe and comment upon the interaction of Jew and non-Jew. This, moreover, because we live in the Exile, and of necessity the Gentile plays a considerable, if not a dominating, part in all our doings except our religious life. In the history of Jewry, unfortunately, this interaction takes on a tolerably anti-Jewish tinge. Anti-Semitism is, in more respects than one, part and parcel of the life of the Jew. Which was to be proved!

The Brownsville bricklayers need not have gone to the trouble of starting their own local division of their union. We doubt the usefulness and the efficacy of divisions in the world of organized labor based upon class or creed or race. They were, of course, well within their rights as men and as Jews in vigorously protesting against the action of non-Jewish bricklayers in endeavoring to

hold their and our race and faith up to public ridicule by means of scurrilous references to Jews in the published programme of a labor outing. Such a publication must of necessity emanate from an official source, and the responsible parties for the affront may well have been punished suitably by the means at command of the labor federation with which the local division is affiliated. But, under present circumstances, by withdrawing from the local and thus not directly reprobating the unwarranted and infamous attack on the Jews, these Brownsville bricklayers of the Jewish faith evade their duty in the premises. Better had it been if they had remained in the local and fought out the issue presented "to a finish." Then, once for all, those persons who in this instance were guilty of a wanton insult to Jews would have received a much needed and, let us hope, a condign lesson for their lack of decency and their failure to comprehend the true principles underlying American life.

Equally with our friends of *The Jewish Ledger*, of New Orleans, we forbear from enlarging upon a discussion of Masonic practice in this place. Yet, our recent remarks anent the Ancient Accepted Scottish Rite of Freemasonry and the part the Jew plays in it seem to have found a cordial approval with our Southern co-religionists. We have neither witnessed the conferring of degrees of the Scottish Rite in the Southern nor the Northern jurisdiction of this country, and so are not prepared esoterically to admit that the distinc-

tion, to which *The Jewish Ledger* refers, exists. We content ourselves with the following reflection, using the example adduced by our contemporary: how can that be rendered non-sectarian which has even a moral, not to consider a divine, reference to certain teachings which the great world of Christendom associates with the highest spiritual and mundane ideals? No matter how transcendent the services of Albert Pike in this particular were, he was unable to guard against the excessive or intemperate use of material by men who did not possess his liberal point of view, breadth of culture, or ability to rise above his irksome surroundings. Here we have the *crux* of the entire matter, and if *The Jewish Ledger* is able to resolve these difficulties, great will be its service to the Scottish Rite indeed.

The death last week, at his home in The Hague, of Tobias Michael Carel Asser, removes one of the greatest of Jewish jurists from our life. Heer Asser was a Jew who never denied his race or origin, who reflected by his works and acts honor on his co-religionists and whose name will be held in high veneration by countless generations of students of international law. He was a prolific writer on the subjects of which he made a special study, and with Alfred H. Fried, of Vienna, also a Jew, received the Nobel Prize for Peace in 1911. In the judicial system of the land ruled by Queen Wilhelmina, Asser's was a name with which to conjure. He reached a very exalted post in it in the course of the seventy-five years of his life and left the indelible touch of his intellect and personality on the jurisprudence of Holland. In common with the Jews of the Occidental world, and with all the people of Holland, regardless of race or creed, we sincerely mourn his loss.

It has been our belief that more good can be done by keeping one's counsel and working diligently, than by trumpeting abroad what has been done, what is to be done and what plans are under consideration.—*The president of the American Jewish Committee at the fourth annual convention of the "great and glorious" Kehillah.*

Good doctrine this, and, of all men and movements, worthy to be heeded by those who first heard it! In this case, however, the old adage, Do what I counsel, not what I do, obtains.

RAGTIME.

Mr. Damrosch, before leaving for Europe, recently gave out an interview in which he said millions upon millions of dollars are wasted upon useless music—i. e., ragtime. All of which money could be applied to better purposes in the musical world. Of course, he meant to the higher, the classical music, such as he devotes himself to.

One may venture to say that more people are receiving enjoyment from the ragtime airs than from the oratorios and kindred works. "*Chaam a son gout*," as the Frenchman says—

"each one to his taste." There is a large class of devotees to the music that Mr. Damrosch supplies—and which is no doubt appreciated by those who attend the concerts which furnish classical airs—but the money spent on ragtime airs is far from wasted.

* * *

With the oratorios and all the higher music, Morpheus claims a great share of the listeners; not so with ragtime. The lively airs which this sort of music affords puts life and action into the feet and the body of millions who wouldn't be moved by the best effort in classical music. Measured by numbers, ragtime gives the greatest enjoyment.

* * *

No one will object to the cultivation of the musical art to its highest degree, nor consider the money expended in this direction wasted. Nor is the money spent for ragtime wasted. We can afford to have both, and satisfy both tastes.

A Journalist of the Old School.

With the demise of Abner Tanenbaum, on Thursday, July 18, at the age of sixty-six, at his home in New York city, the Yiddish literature in America lost one of its prolific, fecund and fruitful writers. Rheumatism was the cause of the great man's departure from this habitation of tears, sorrows and affliction, the pangs and pranks of which he endured with stoicism and resignation for the last few years, continuing, however, his literary work and journalistic labor, writing and suffering, alternately. Wavering between Scylla and Charybdis, the fire of his natural bent of journalism and the frying pan of pain and suffering, Tanenbaum took turns, time and again, yielding to the latter, when hardly pressed, and returning his former self of a journalist, when conditions became somewhat favorable and pangs and agonies would moderate more or less. In the month of June his malady displayed fatal symptoms, and the physicians advised Tanenbaum to go to Sharon Springs. Pneumonia suddenly supplemented the previous sickness, and resulted fatally. The gap left in the ranks of Jewish journalism by Abner Tanenbaum's death may hardly be filled by contemporaneous journalists and men of letters, he having created a literary trend of his own which was never copied nor successfully imitated by other knights of the quill. Tanenbaum's writing was unique, and, if demanded, Tanenbaum would have been granted a niche in the hall of fame of Yiddish literature. In the eighties of the last century, when the Muscovite's brutalities and Russia's cruelties forced thousands of Jews and Jewesses into exile and migration, the bulk of them coming over to this country, Tanenbaum discovered new material, new subjects and new topics to satisfy the taste and to regale the palate of the recent immigrants. Himself of this very branch of the weary wanderers, Tanenbaum having been a native of Schirvind on the Prussian frontier, and a student in the new Russian university in Odessa, he succeeded in becoming the very idol of his kin, who almost swallowed his words and enthusiastically received his writings.

Having acquired the Russian, German and other European tongues, as well as the English, Tanenbaum made it his specialty to study encyclopedias, lexicons and scientific books, the beauties and niceties of which he rendered into idiomatic and savory Yiddish, captivating all elements of the Jewish populace of the United States and Canada. He wrote continuously for fully twenty-five years, contributing extensively to the *Tageblatt*, *Americaner* and *Morgen Journal*, and some articles remained unfinished at the time of his sudden death.

Tanenbaum never wrote any book, firmly believing that a newspaper was the best means and the most economical medium for the diffusion of education and the dissemination of knowledge, both among the laboring masses and the working classes, costly volumes and bulky books constituting but luxurious objects and expensive matter, proper prey and suitable spoil for the wealthy and the opulent.

In addition to secular learning, Tanenbaum was quite at home in religious, Biblical, Talmudic, Midrashic and Rabbinic literature, out of which he wove and spun many a novel, story and reflection. In serial form in the *Morgen Journal*, Tanenbaum wrote but very recently a sketch of the lives and works of Jewish worthies in various times and sundry climes, this masterpiece of his works proving interesting and instructive to thousands of readers here and abroad. Yiddish literature and its adherents do certainly miss Abner Tanenbaum, the supporter of the one and the benefactor of the others. May his soul rest in peace. Amen!





MITCHELL MAY, Secretary of State.

AMENDMENT NUMBER ONE. Concurrent Resolution of the Senate and Assembly, Proposing an amendment to section seven of article one of the constitution, relative to taking private property for public use.

Whereas, The legislature at its regular session of nineteen hundred and twelve duly adopted a resolution proposing an amendment to section seven of article one of the constitution, relative to taking private property for public use; and Whereas, Such resolution has been duly published in accordance with law and the constitution and referred to this legislature for action, therefore Section 1. Resolved (if the Senate concur), That section seven of article one of the constitution be amended to read as follows: § 7. When private property shall be taken for any public use, the compensation to be made therefor when such compensation is not made by the state, shall be ascertained by a jury, or by the supreme court with or without a jury, but not with a referee, or by not less than three commissioners appointed by a court of record, as shall be prescribed by law. Private roads, may be opened in the manner to be prescribed by law; but in every case the necessity of the road and the amount of all damage to be sustained by the opening thereof shall be first determined by a jury of freeholders, and such amount, together with the expenses of the proceeding, shall be paid by the person to be benefited. General laws may be passed permitting the owners or occupants of agricultural lands to construct and maintain for the drainage thereof, necessary drains, ditches and dykes upon the lands of others, under proper restrictions and with just compensation, but no special laws shall be enacted for such purposes. The legislature may authorize cities to take more land and property than is needed for actual construction in the laying out, widening, extending or relocating parks, public places, highways or streets; provided, however, that the additional land and property so authorized to be taken shall be no more than sufficient to form suitable building sites abutting on such park, public place, highway or street. After so much of the land and property has been appropriated for such park, public place, highway or street as is needed therefor, the remainder may be sold or leased. § 2. Resolved (if the Senate concur), That the foregoing amendment be submitted to the people for approval at the general election to be held in the year nineteen hundred and thirteen, in accordance with the provisions of the election law.

Sabbath Desecration.

Editor HEBREW STANDARD:

I have read the last issue of your valuable weekly and can only congratulate you upon the stand you take on the "deliberate and purposeful violation of the Sabbath" in the Hebrew Infant Asylum's name. Jews who allow such public violations of the Sabbath should always be reprimanded and their actions made subject to public disapproval. Let us know who are our friends and who are our adversaries. Those that have no consideration for their fellow religious brethren are to be treated not only as Jews of free-thinking character, but rather as mannerless individuals, because what social customs and habits demand of a civilized human being in society, namely, consideration and courtesy, religious customs and habits demand from us in a Jewish gathering. The one that does not comprehend the moral requirements of the Jewish community in which he moves does not understand the law of profane circles either. Mosaismus—respect for law—Abrahamismus—respect for humanity—go, as a rule, hand in hand and cannot be separated from each other without serious consequences to both. I would like to recommend to the newly organized Sabbath Association to mainly broaden the field of their generous efforts not to private persons that are responsible for themselves and in no way effect the general observance of the Sabbath, but to indulge in the difficult but fruitful work of making public all the names of public institutions that are supported by public subscriptions and contributions and have the audacity to trample upon the feelings of their Sabbath-observing surrounding constituents. These institutions are frequented by exclusively Jewish people and a violation of the Sabbath within their gates is an offense against the cornerstone of our religion, committed by Jews for Jews and with Jews. A point in case is the Educational Alliance, which is controlled by Jews and is situated at the heart of the Ghetto, without harking to clamors from thousands of orthodox Jews, whose children openly violate the Sabbath in the reading room of this institution by giving their written signature in return for every weekly or magazine they are desirous of reading. I have fought, while a rabbi of the above institution, against this public menace, but my warnings to the "reformed" directors were of no avail, and shall try to stop it through the means of the Sabbath Association, which should make her voice heard here and there where such actions have been in practice for years. The coal supply of the Educational Alliance is usually delivered on Sabbath day, and many times worshippers of the so-called People's Synagogue were disturbed by the rough sound that the delivery or shipping of coal into the cellar on Saturdays has caused. These and similar violations of the Sabbath known not only to me but to every Jew in the neighborhood should be called to the attention of your weekly, that stands for a true Judaism, and to the attention of all those faithful co-workers who are engaged in the battle for Sabbath supremacy.





BROOKLYN NOTES.

Federation of Charities Benefit at Far Rockaway.

By means of moving pictures showing the work being done by the Brooklyn Federation of Jewish Charities, a strong appeal for support was made last Thursday night to the people of Far Rockaway, when the pictures were shown at the Idle Hour Theatre in Mott avenue. The theatre was given over to the Federation by John Wolken, proprietor. It is estimated that about 750 persons witnessed the exhibition.

The moving pictures showed strikingly the large field that the Federation is covering and considerable attention was paid by the spectators to the films shown of work in the Y. M. H. A. The Jewish Hospital, which, the officials say, is in great need of finances to fill the needs of the people, also was shown.

Ahawah Sholom Cornerstone Laid.

The cornerstone of the Ahawah Sholom Kings Highway Synagogue, at Seventeenth street and Avenue R, was laid Sunday afternoon. Dr. Madison C. Peters was the principal speaker. Rev. Clifford H. Levy delivered a short address. Rabbi Samuel J. Levinson, Rev. Henry L. Payne, M. Loeb, M. Sheinart and Mrs. Harrison Gray Lyman also spoke.

Dr. Madison C. Peters in his address said: "Such plays as 'Potash and Perlmutter,' which vilify the American Jew, holding him up as a vulgar, conniving creature, the damning work done by Jews themselves, deserve most earnest, organized protest. Let every self-respecting Jew stay away absolutely from such performances. If the American Jew does not protest against the lampooning of his race in vulgar stage offerings by his own people he deserves to be laughed at. Give the warning to managers that you will resent the affront to your dignity and standing as Jews and as loyal Americans. And while applauding these ugly and prejudice-creating caricatures that may be seen nightly in our playhouses Jews argue: 'But there are such Jews.' But would the Jewish managers dare present the characteristics of a non-Jew? Would Jews dare applaud the cheapening sketch of a monk or a nun? We say, 'Hit the box office.' If we must have a Jewish play let it be one that centres about the affection that characterizes the ideal home life of the Jews. Give us a portrait of 'The Mother in Israel,' the noblest womanhood in the world, but

spare us from the imaginary and vulgar, though mirth-provoking for the rabble, Mrs. Abe Potash."

The Kings Highway Congregation Ahawah Sholom has been in existence eleven months. During this time, through the energetic efforts of the Hebrews of that section, the Ladies' Society and Young People's Leagues, it has been able to raise enough money to build the synagogue, which will be completed early this fall. The congregation consists of sixty members, with a Sunday school of seventy-five under Mrs. H. Gottlieb.

Temple Beth Sholom.

Ground has been broken for a new building which will house the free religious school of the Temple Beth Sholom, Bensonhurst. It is hoped that the structure will be completed before October 1, and the building when completed will provide eight large well-lighted rooms for the religious school and a kitchen for the Sisterhood. The rooms are so arranged that they can be thrown open into a large auditorium 45 by 80 feet, and a stage will be provided.

To architecturally conform to the new building alterations are being made to the synagogue proper, which is being raised over two feet.

The committee having the work in charge consists of Messrs. David Cowen, chairman; Al. A. Ehrlich, A. Jarrett, Frank Cohen, L. J. Assenheim and Dr. A. P. Zemansky.

The clergy and other professional men, as well as the general public, who have occasion to use the writing machine will welcome the latest model, "The Multiplex," which the Hammond Typewriter Company has recently placed on the market. CHILDREN'S PAGE.

THE SORROW AND THE COMFORT

Dear Children.

This Sabbath is called "Sabbath Hazone," as we read on this, the most mournful Sabbath of the year, the terrible denunciation of our people by the great Prophet Isaiah, which prophecy begins with the word "Hazone," meaning "the vision."

And on Monday eve we will assemble at our synagogue and bemoan the great national calamity that befell us on this night in the burning of our holy temple, the destruction of our capital city Jerusalem and the ultimate dispersal of our nation to every country in the world.

But weeping and mourning, although they prove that in our hearts there still glows the love of Zion and the hope for its restoration which we at the same time express in our prayers, are still not the entire object of the three weeks' period of our nation's mourning which began on the 17th of Tamuz and ends on Tisha B'Ab or the 9th of Ab. We should also reflect on the causes that led to our misfortune, the condition in which we now find ourselves, and what right we have to hope for a happy future.

To attune the sad thoughts of this unfortunate period to the theme in which I am at present treating of, namely, the Ethics of the Fathers, I have merely to follow the natural order of the lessons I am giving you and therein find a most excellent text for illustrating the causes and conditions of our great national misery, and this will teach us so to live that we will fully justify our most sanguine hopes for our future. This text we take from Rabbi Dosa Ben Horkinas, who said:

"Sleeping long in the morning, drinking wine at midday, childish talk and sitting at the meeting places of the ignorant rabble shorten a man's existence."

The usual explanation of this saying, dear children, is that as our life is really worth living only if we study and practice the teachings of our holy Torah, which one cannot do if he sleeps too long in the morning or indulges in wine at midday and thus makes himself unfit for either the study or practice of our holy law or when he wastes his time in childish and frivolous talk or by sitting in the company of the ignorant rabble these things naturally tend to shorten a man's existence.

Dear children, in the morning of Israel's life, when after forty years of wandering in the great and terrible wilderness in which he was shown the ever-ruling hand of Providence and was taught that he has naught to fear, neither the venomous snakes nor the ferocious beasts, neither the scorching tropical sun nor the cruel inhospitality of the arid desert, naught to fear but his sin, no one to look up to but his heavenly Father. In the morning of Israel's life, when the sun of the divine prom-


