

ITEMS OF INTEREST IN THE JEWISH WORLD.

The Salem, Mass., Y. M. H. A. are campaigning for a building fund.

Jews have been prohibited from conducting military bands in the district of Wilna.

Twenty-three thousand and twenty-nine Jews emigrated from Russia via Libau in 1913.

A congregation to be known as Tiferth Israel has been instituted at Forest City, Ark.

The members of Congregation Beth El, of Knoxville, Tenn., are negotiating for a new synagogue.

A percentage norm has been introduced for Jews at the St. Petersburg Commercial Institute.

There are no less than eight Jews who hold various chairs as professors at the University of Bologna (Italy).

His Excellency the Governor has appointed Mr. Isaac Esther Levy to be a justice of the peace for Gibraltar.

Mr. A. A. Romain has been elected a member of the Town Council of Bethlehem, Orange Free State Province.

A Menorah Society has been organized at the University of Cincinnati. The initial meeting was held on April 3.

Dr. Manfred Nathan, of Johannesburg, has been elected as a member of the General Council of the South African Bar.

The United Hebrew Community of New York this year distributed over 90,000 pounds of Matzoth among 4,000 needy families.

The Governor of Petrokoff has, from his own purse, compensated a few poor Jews whose property had been destroyed during the recent blood libel riots at Lodz.

At the annual graduation ceremony of the university at Cape Town, South Africa, seven scholarships were announced, of which five were awarded to Jewish students.

The members of the Eoff Street Temple, Wheeling, W. Va., have elected Mr. Morris Lazarus as their rabbi. He will graduate from the Hebrew Union College in June.

The Zemstvo Dispensary of Lopushko (Bessarabia) has decided not to distribute medicine to Jews, and the authorities of the hospital at Borisov refuse to treat Jewish patients.

Ex-Mayor Ernesto Nathan of Rome, Italy, will arrive in New York early next month. He comes as the representative of the Italian Government at the Panama Pacific Exposition.

The German Emperor has granted, from the Imperial Fund at his disposal, the sum of 16,000 marks to enable Prof. Dr. Ernst Sellin, of Kiel, to proceed with his excavations at Shechem.

The announcement is made by the "Russkoe Slovo" that Dr. Emanuel Lasker, who is a Jew, has only received permission to stay in Russia so long as he is giving chess exhibitions.

Mrs. Joel Hillman, of Washington, D. C., has announced the gift of \$14,000 as the nucleus of an endowment fund for a Jewish Orphans' Home to be erected in Atlanta, Ga., by District Grand Lodge, No. 5, I. O. B. B.

MM. Rosenfeld and Tchemerinsky, editors of the Warsaw Yiddish daily newspaper, the Fraind (which was suspended during the trial of Bellis for criticism on the case), have been sentenced to imprisonment for one month and two months, respectively.

By the will of the late Abraham Bloch, of Cincinnati, Ohio, substantial sums are left the Jewish Orphan Asylum, United Jewish Charities, Home for Jewish Aged and Children's Home, of Cincinnati, as well as the National Jewish Hospital, at Denver, Col.

Many rich Russian Jews have gone to Palestine to spend the Passover there, while hundreds of young coreligionists have recently settled in the Holy Land. The emigration to Palestine through Odessa has increased fivefold, and now numbers two hundred and fifty per week.

Dr. J. W. Botolin, who was born blind twenty-six years ago, was on Thursday notified by the Cook County (Ill.) Civil Service Board that he has passed, with the highest grade of any entrant, the examination for attending physician of the Tuberculosis Hospital of the Oak Park Infirmary. His general average is 96, despite the fact that he had to dictate his answers to the questions to a school boy only twelve years old.

Last year the Hebrew Immigrant and Aid Society circulated 38,209 newspapers among detained Jewish immigrants at Ellis Island.

For the purpose of further increasing their efficiency, the Jewish charitable organizations in Savannah, Ga., are about to federate.

All but \$2,000 of the \$50,000 building fund of the Young Men's Hebrew Association of Wilkes-Barre, Pa., has been subscribed.

A national convention of the Young Judea will be held in some New England city—probably Hartford—during the coming summer.

Mr. M. Lazarus has been re-elected for the twenty-seventh year in succession president of the Temora (New South Wales) Hospital.

The Lenas Hazedek Congregation, East Boston, Mass., have completed plans for the erection of a new synagogue at a cost of \$60,000.

A large tract of land has been acquired near East Hammanon, N. J., where it is proposed to establish a Jewish agricultural colony.

Mr. Nissim Reuben, who is well known in the Straits Settlements, has been appointed a justice of the peace for the Settlement of Singapore.

A permanent Jewish Ladies' Aid Society has been formed in Somerville, Mass., for the purpose of giving assistance to needy Jews of that city.

Among those awarded diplomas at the closing exercises of the woman's law class of the New York University last week were Misses Helen Friedman, Mildred Herrman, Sarah J. Horowitz and Marie Norden.

Dr. Edward Gudeman, a Chicago chemist, announces a new remedy for the treatment of incipient tuberculosis. He describes the remedy as the inhaling of sulphurous acid gas—the fumes of burning sulphur.

Acting on representations made by the Haham Bashi of Turkey, the Minister of the Interior has dismissed the Governor of Tiberias for his laxity in dealing with the murders of Jews in the neighborhood of that town.

Plans for the new building of the Philadelphia (Pa.) Young Men's Hebrew Association have begun to crystallize after a year's campaign for funds. A building committee has been appointed and plans for new quarters are now being drawn.

The Jewish Chautauqua Society has accepted an invitation from Congregation Brith Kodesh, of Rochester, N. Y., to hold its twenty-second annual assembly in that city December 25-31, 1914. The Programme Committee will hold a meeting to begin plans for this next assembly.

Successful Jewish candidates for municipal honors in New South Wales are Mr. Nat Lewis, re-elected Alderman for O'Connell Ward, Newtown; Alderman Emanuel Yedwoph, for Redfern; Mr. G. C. Hands, councillor for Wingham; P. J. Jonas and L. Goldberg, councillors for Bombala.

In Jaffa an elementary boys' school has been opened, which teaches about 150 scholars, divided into eight classes. The teaching body includes all former teachers of the Hilsverein der Deutschen Juden, with the exception of the German master, who did not go over to the new Hebrew institution.

Work will soon be begun on the new group of buildings to be added to the Mt. Sinai Hospital, New York. The new buildings will cost \$1,500,000, \$1,000,000 of which is already subscribed. Five new structures will be in the group and when completed the Mt. Sinai will be the largest hospital in America.

The ceremony of "Chaltza," which is rarely performed in this country, was observed in Pittsburgh, Pa., last week, when Mrs. Sonia Soren, who had traveled 5,000 miles from Kaslavitz, Russia, released her brother-in-law from marrying her, in accordance with the twenty-fifth chapter of Deuteronomy.

A Trachoma conference was held in Jerusalem on March 31 by the physicians of Palestine. This conference was proposed by Dr. Elias Auerbach, of Haifa, and organized by the Society of Jewish Physicians of Jaffa, and is the first of its kind. Its object is to gain the doctors for the fight against endemic trachoma, to collect and classify the existing statistical material and to bring about concerted action in a number of questions, such as uniform statistics, diagnoses, therapeutic treatment, education of the population, etc.

Last year 160 patients were maintained at the Sanatorium of the Jewish Consumptives Relief Association, Denver, Colo., at a cost of \$106,000.

"Potash and Perlmutter," the play dealing with New York Jewish life, scored a tremendous success when produced in London, England, last Tuesday night.

At the twenty-fourth annual convention of the Independent Order Free Sons of Judah, held in New York city last week, an increase of 3,000 members was noted.

Seventy-six Russian deputies have introduced a bill providing for the abolition of all restrictions against non-Christians in the legal profession in Russia.

The widow of the famous late millionaire, Poznansky, has died at Lodz. She left 100,000 roubles to the sick fund of the workmen of the Poznansky factory.

George Stern, Democrat, has been elected Mayor of Frostburg, Md., a Republican stronghold. Mr. Stern is the third Jewish Mayor to be elected in Frostburg.

The notorious Jew-baiter, Governor Muratoff, of Kursk, last week compelled a Jewess who had been married to a privileged coreligionist (Snobkoff) for over fifty years to celebrate the wedding again as an alternative to her expulsion from the city, in view of the fact that she had lost her marriage certificate.

It is proposed to erect at Aylesbury a statue of Benjamin Disraeli, who from 1847 to 1876 was a representative of the county of Buckinghamshire in Parliament. The project has received the support of Lord Rothschild, Mr. Leopold de Rothschild, Mr. Alfred de Rothschild, Mr. Lionel de Rothschild and other prominent English Jews.

The aged Prince Mestchersky, who is a friend of the Czar, has published in the Grazdanin a strong article in which he condemns the proposal of the Nobles to exclude Jews from the army. He denies the alleged revolutionary activity of Jewish soldiers, and asserts that the army is the best school, both for Christian and Jew, for the mutual body of each other.

Max Mitchell, formerly superintendent of the Boston (Mass.) Jewish Charities, has just been elected president of the Cosmopolitan Trust Company, which he organized two years ago. The company has deposits of over \$2,500,000, and last year made a net profit of \$30,000. Mr. Mitchell came to Boston twenty-two years ago a poor immigrant boy without money or friends.

In the course of an article on "The Jew in Drama," contributed to the London (England) Evening News, Mr. Israel Zangwill remarked that "it cannot be said that the stage Jew has yet shaken off his past." Jews (as seen by the limelight), wrote Mr. Zangwill, "are certainly, as the charwoman of a friend of mine observed, 'a bad lot.' But then, 'Christians is wuss,' she added."

Under the name of Histadruth Zionith Ottomanith, the first Zionist Society in Turkey, has just been formed. The government has confirmed the constitution of the society, the objects of which include endeavors to render more easy the settlement of Jews in Turkey, the development of Jewish immigrants in Palestine, the spreading of a knowledge of Hebrew and of Jewish history, and the strengthening of communal life.

On Saturday, March 21, Sir Louis Mallet, the British Ambassador at Constantinople, gave a diplomatic dinner at the Embassy. The guests included the Haham Bashi and Mme. Nahoum, whom His Excellency had previously informed that he had arranged a Kosher repast for them. This is the first time that a chief rabbi of Turkey has been invited to a diplomatic banquet. The event is the more noteworthy inasmuch as M. Nahoum was the only spiritual chief to receive an invitation.

A largely-attended conference of representatives of industry and commerce, held in St. Petersburg on March 23, unanimously decided to send a deputation to the Minister of Commerce for the purpose of pointing out that the proposed restriction on Jewish participation in joint stock companies would undoubtedly impede the development of native industries, thereby increasing Russia's general dependence on foreign industries, while the arrest of the influx of private capital would threaten the country with unemployment and a new economic crisis.

One of the most revolting crimes in the dark history of Russia is reported in a special dispatch from St. Petersburg. Three Russian youths were said to have outraged and then castrated the daughter of a poor Jewish fisherman in Stavropol on the Volga. The young men, the dispatch declares, dragged the girl to a cemetery, where they nailed her to a cross above one of the graves. Nails were driven through her hands and feet, and even through her eyes. The three murderers were arrested, but their friends in the town released them, it is asserted.

On Friday night there was a tremendous gathering at Temple Emanu-El, where Dr. Silverman delivered a few appropriate remarks. The men then marched in a body to Tuxedo Hall, Fifty-ninth street and Madison avenue, where the Passover narrative was read by Rabbi Aaron Eisenman, after which the following menu was served: Ceremonial Dishes: Charoseth, Hard Boiled Eggs, Wine, Soup: Consomme aux Matzoths, Fish: Boiled Shad, Lemon Sauce, Entree: Breast of Beef, Roast: Chicken, New Potatoes, Salad: Spring Salad, Dessert: Fruits in Season, Nuts, Stewed Prunes, Cafe Noir, Shlivowitz, Ezra (type port), Ungar Port, Apple Cider.

After the meal Mr. Alexander Alexander presided as toastmaster and the following gentlemen responded: Commander Stanford E. Moses of the U. S. S. Texas; Col. Harry Cutler, "N. G. Rhode Island; Lieut. Edward Moses, U. S. S. Washington; the Rev. Dr. Joseph Silverman, Commander Albert Moritz, U. S. N., retired; Herman Bernstein, secretary American Jewish Committee, and Captain Lewis Landis.

Sabbath morning special services were held at Temple Beth-El, where Rev. Dr. Samuel Schulman preached a Passover sermon. In the evening Sedar was given by Dr. Schulman and Judge Aaron J. Levy acted as toastmaster, the following delivering addresses: Capt. Julius Tannenbaum, N. G. N. Y., Rev. Dr. Samuel Schulman, Brigadier General R. K. Evans, U. S. A.; Rev. Dr. Joseph Silverman, Chaplain Smith, Lieutenant Moses, U. S. N., and Major Bloom, retired U. S. A.

A pleasant feature was the presentation to the committee of a handsome silver loving cup on behalf of the Macabean Society, of Fort Totten, the only society of its kind, composed entirely of Jewish soldiers. The cup was received on behalf of the committee by Capt. Lewis Landis.

Sedar for Deaf Mutes.

The Society for the Welfare of the Jewish Deaf held a service for two hundred deaf mutes last Saturday at Savigny Hall, Lenox avenue and 121st street. This was the first Sedar service for the Jewish deaf. There was a sermon and an explanation of the Passover festival, all in the sign language. The Sedar was arranged by Mr. Albert J. Amateau, leader of the work among Jewish deaf mutes.

The Federation of Sisterhoods.

A meeting of the Federation of Sisterhoods was held on Wednesday, April 15, in the trustees' room of the United Hebrew Charities Building, with Mrs. Samuel Elkeles, the president, in the chair. A Membership Committee was appointed consisting of Mrs. William Einstein, the founder and honorary president; Mrs. A. Lederer and Mrs. Percival S. Menken. Among the delegates who submitted papers were the Mesdames Rebecca Kohut and Daniel Guggenheim, and Mrs. Simon Baruch and Miss Sara Schottentfels were among the newly proposed members. Mr. Morris D. Waldman addressed the meeting.

Mrs. M. L. Levenson is vice-president; Mrs. Henry Bodenheimer, recording secretary; Mrs. J. E. Hoffman, treasurer; Mrs. M. C. Phillips, corresponding secretary. The Federation represents 8,000 women.

Needless Duplication.

Editor THE HEBREW STANDARD. There lie before me two circular letters. One is from the Bronx Jewish Maternity Hospital Association of 1525 Washington avenue, the other from the Bronx Maternity Hospital of 830 Westchester Avenue.

I understand that the Bronx Maternity Hospital was organized two and a half years ago under the name of the Bronx Jewish Maternity Hospital. While not sacrificing its Jewish character, it dropped the word Jewish from its title in deference to the wishes of the original Jewish Maternity Hospital on East Broadway, which claimed that the similarity of titles would be confusing to the public. Notwithstanding this, in July, 1913, the third organization was founded with the title the Bronx Jewish Maternity Hospital Association. To my certain knowledge, this similarity of names causes continual confusion in the community.

The two Bronx organizations are entirely distinct, with differing headquarters and differing officers and personnel. Yet they have been formed to do identical work in one limited district. Both are appealing to the same public. The association held a ball on March 7, the hospital held a fair during the first week in April.

Sometimes there are cogent religious principles involved, an overwhelmingly great need or other weighty considerations which make it desirable or necessary for two similar, local, philanthropic organizations to compete for public favor and support. If such considerations exist in this case the Jewish public should be informed of them. Each of the organizations plans to erect a building. Cannot the community, which is called upon for its financial support, demand that, instead of two buildings being erected in the remote future both of which would of necessity be small, poor in equipment, inadequately supported and wasteful in duplicate expenses of upkeep, there shall be a union of forces to secure in the nearer future a larger, more economical, better equipped and more efficient institution? Where Supervision of Kashruth Is Necessary.

Editor HEBREW STANDARD: As your paper is quite interested in what is good and just for the Jewish community, I am quite anxious to know whether there is no compulsion on the part of the so-called kosher butcher to sell such meat which is really that and not otherwise. I recently passed through 114th street, between Madison and Fifth avenues, which is quite a marketing spot for the Jewish people of Harlem, and where there must be about a dozen butcher stores, every one with window printed full of Hebrew letters about kosher meat, etc., which I could see at a glance was not such, as even the poultry was not fresh killed, but packed.

I know quite a few young housewives are misled by these signs, as the butchers sell the meat at such reasonable prices, which lure the inexperienced women to buy meat that they imagine is kosher, yet is the same kind of meat that is sold by Gentile butchers.

If there is such a thing as Orthodox Judaism, why do not the rabbis interfere? Very truly yours, D. FRANK.



NEWS FROM ENGLAND.

(Exclusive Correspondence to THE HEBREW STANDARD.)

The Sephardi-Ashkenazi Question—A Jewish Night at the London Coliseum—Discontent with Roumanian Proposals—Annual Meeting of Board of Guardians—More About the Chief Rabbi's Residence—Rabbi Hillman as Dayan—Maccabean Land Company Formed—Women in Jewry—More Echoes of the Bellis Case.

London, April 3, 1914.

I think I mentioned recently that the Chief Rabbi was to preach shortly in the Synagogue of the Sephardi Jews. It is held in many quarters that this marks a rapprochement between two communities which have now for many years co-operated in a variety of fields. There was a time, however, when Ashkenazim and the Sephardim of England were almost as the poles asunder; and when the latter considered themselves almost closer to non-Jews than their Ashkenazi brethren. In reality there is no reason why the Chief Rabbi and other Ashkenazi ministers should not be heard frequently in Sephardi pulpits, nor, on the other hand, why Dr. Gaster and his ministers should not be welcomed in Ashkenazi pulpits. There is no difference in doctrine between the two sister communities, while in ritual the differences are held by many to be in reality inconsiderable and due entirely to the accidents of local origin.

Dr. Hertz is assured in advance of a welcome in Lauderdale road; Dr. Gaster would receive no less hearty a welcome in any of the Ashkenazi synagogues. The suggestion has been made that this rapprochement between the Sephardim and the Ashkenazi should be followed by similar ones between these communities and the Reform Jews. But here the case is very different. Between the two Orthodox communities and the Reformed Jews there are not only differences of ritual, which are fundamental but there are also differences of doctrine. The view has been strongly expressed in this country that no Reformed minister could be permitted to preach in or participate in the services of an Orthodox synagogue. The case of the late Rev. L. M. Simmons has been quoted to the contrary, but this is held to have been quite exceptional. He was, it is true, a minister of a Reformed congregation, but he was not a Reform minister. In his personal Judaism he was quite Orthodox and he was accustomed to supplement the services at his own synagogue by attendance at an Orthodox Jewish place of worship. To the presence of an Orthodox minister in the pulpit of the Reform Synagogue it might be said that there is less objection, but this is not really so. The ritual of the Reform Synagogue of London, not to mention the Jewish Liberal Synagogue, is now such as to render the participation of an Orthodox Jew in it impossible. Outside of the synagogue, on charitable and other platforms, Orthodox and Reformed Jews can co-operate as heretofore to the fullest extent, but the co-operation must cease on the threshold of the synagogue.

Last Sunday was a great Jewish night at the London Coliseum. This building is the finest and largest music hall or vaudeville theatre in London and was used on this occasion to raise funds on behalf of the Jewish Hospital for incurables. Altogether the performance realized \$7,500. Many well-known music-hall artists appeared by kind permission, of their various managements, and Mr. Oswald Stoll, himself one of the Jewish magnates of the entertainment world, lent the Coliseum. Arthur Boucherier cited Shylock's "Hath Not a Jew Hands," from the "Merchant of Venice." It was the largest Jewish audience I think ever seen in London on one occasion.

Widespread disappointment, although little if any surprise, has been felt throughout Jewry at the announcement that the proposals of the new Roumanian Government for reform of the constitution contain no reference whatever to the disabilities from which the Roumanian Jews suffer. These disabilities would long ago have been swept away had not Roumania refused to fulfill her obligations of common honesty under the Treaty of Berlin, by which the Roumanian kingdom was created, and had emancipated her Jews. More than a generation has, however, passed since Roumania took all the advantage the treaty offered her, while callously ignoring her obligations under it. During the past year repeated assurances were given that the position of the Jews would at length be ameliorated and the splendid response of the Jews of Roumania to the call to arms seemed to give some moral security to these promises. In the issue, however, the Jews of Roumania are to remain as heretofore—aliens without a country.

The annual meeting of the Jewish Board of Guardians was held on Sunday, March 29. Leonard L. Cohen made a special point of Jewish emigration. He pointed out that Jews are going to North America in gradually increasing numbers. "The extent of the emigration is remarkable," he said. "During eight months of last year 10,000 landed in Canada from Europe, 3,000 more than the record for the whole of 1912." Jews, he also remarked, have only slightly benefited by the Old Age Pension and Insurance acts. As an instance in point, he mentioned that of 2,700 cases of tuberculosis among the community only 440 of the patients were insured. "There is a good deal of shyness among Jewish members of Parliament over the introduction of Jewish questions in the House," commented a member of the Board of Guardians, who went on to suggest a deputation to the Chancellor of the Exchequer pointing out that the two acts operated harshly on so-called aliens, who had been resident in Britain for over half a century.

With regard to the official residence of the Chief Rabbi and its East-end situation, a denial has been issued of the statement that the Chief Rabbi had himself expressed a wish that the residence should be in the East-end at Mulberry street, Commercial road. It is understood that the Chief Rabbi would personally prefer some location not in the East-end and this would certainly be in accordance with the more general sentiment of the community here.

Rabbi Hillman has been recommended for the post of Dayan and a meeting of the United Synagogue is about to be held to elect him. Rabbi Hillman is forty-five years of age. He has acted as rabbi in Glasgow, Scotland, since 1908, and is fully qualified to fill the important duties of the high office to which it is proposed he should be elected. Among the conditions laid down by the council is one to the effect "that he shall reside in East London, the situation of his residence to be approved by the honorable officers." As the matter of the disposition of Court Lodge may hereafter arise, and in order to leave it an open question for the moment, the Executive Committee recommend the council to add to the existing conditions that in the event of the Dayan to be elected taking up his residence at Court Lodge, a suitable reduction (to be mutually agreed between him and the honorable officers) be made in his salary.

The Maccabean Land Company has now been registered as a public company. Its objects are: "To purchase, lease, or otherwise acquire lands, forests, or other immovable property in Palestine, and to sell, work, develop and otherwise turn to account mines and mining rights in connection with any such property." The capital is \$260,000.

The part the women play in all kinds of activities here is ever increasing. Especially favorable notice has been accorded in the community press here to Mrs. Spielmann's work in connection with the Union of Jewish Women. It is certain that the ten years during which this body has existed, have, as a result, been years fraught with blessing to the community; and the community owes a big debt of gratitude to many good and zealous and able Jewesses who have piloted the union across the sea of social difficulties through which its course has been steered. The tendency is now apparently towards co-operation with other bodies concerned, with the welfare of women and children, and it would seem that a conference is to be called upon this point. The idea of co-operation is even taking international shape, and a conference of Jewish women—at which the union will be represented—will be held at the time when the International Council of Women meets in Rome. The Jewish gathering will consider matters affecting the interests of Jewish womanhood from the international point of view. There is no question but that a broadening of ideals will come from such taking to-

gether of counsel. But it is not so much in the specific good works of Jewish women that we rejoice, as in the strengthening of the sense of mutual obligation and the general impetus to communal endeavor that come from their example.

It would really appear that we are never to hear the last of the Bellis case. M. Tarnavski, proprietor-editor of the Kievski Myssl, has been condemned to three months' imprisonment, without the option of a fine, for an article which the Kieff Crown Attorney considered as an improper reflection upon the prosecution in the Bellis process. By order of the criminal court before which M. Tarnavski was arraigned 65,000 copies of the incriminated journal seized by the police have been destroyed.

Another announcement from Kieff, however, is of a satisfactory nature. It is to the effect that the so-called patriotic association known as the League of the Two-Headed Eagle (Dvuglavi Ore) has been suppressed as a danger to public peace and order in the Ukraine capital. The sole and avowed object of that Black Hundred Society was the "effective control" of the Jews, or, in plain terms, the harassment and persecution of the Kieff Jewry.

It is easy from the comfortable tripod of an editor to indite a slashing criticism of the four rabbis who journeyed to Albany in their vain effort to intercede with Governor Glynn for the lives of the condemned "gunmen." We hold no brief for these rabbis, nor will we follow the pernicious and un-American example of The Jewish Advocate of Boston, in indulging in more or less scurrilous innuendo concerning the action of our Court of Appeals in the Becker case. These rabbis went to the Capitol as individuals and as Jewish ministers, and their course, fruitless though it was, did credit to them as men and spiritual guides. They represented none but themselves and, in our government of laws and not of men, had the indubitable privilege to seek to bring the yearnings of faith and worship into accord with the inexorable demands of human justice. Their mission was to tell Governor Glynn that, according to their firm belief, Frank Cirofici was not present at the murder and to give this fact careful consideration. They did their full duty and are to be commended for it.

According to The Argus of Mount Vernon, N. Y., Mr. Falk Younker, who is connected with the Metropolitan League of the Y. M. H. A., and who recently occupied the pulpit of Sinai Temple, is the "fired" secretary of the organization in question. For Mr. Younker's sake we hope this is not the case!

In Good Housekeeping for April Dorothy Dix has a paper on Monticello, in which the old anti-Semitic attacks on Commodore Levy and his descendants are reproduced, presumably at the instigation of the protagonist of the agitation for the sequestration of the property. As a statement of facts the article is beneath contempt.

The late Mr. Baron Benas of Liverpool in his ethical will, just published, directs his son to be trained in "the Conservative and Orthodox Jewish Faith." This is a contradiction in terms. If the faith is orthodox it cannot be conservative, and vice versa. At all events, the son, now a well-known Jewish worker in England, qualifies for election as an honorary vice-president of the United Synagogue of America.

In the call for the annual convention of the "great and glorious" Kehillah we note a provision that the membership fee of \$5 must accompany the credentials of each delegate of a constituent body. From the point of view of the practical "leaders" of our "great and glorious" institution this is quite in order. But the average member of one of the constituent societies may well ask, Is the show worth the price?

"Rev." Leopold Cohn, the well-known Williamsburg mes-hummad, is once more the hero of a good "story" in the daily press. It relates to the recent action of the Supreme Court in Brooklyn in reversing the verdict reached in a case in which Mr. Cohn figured as defendant, where the plaintiff's attorney in addressing the jury had reflected on the fact that Mr. Cohn belongs to the Jewish race. What a mockery! Mr. Cohn has tried hard all these years to be a Christian, and still some Gentiles look upon him as a Jew!

What the Lord Chief Justice of England, and his erstwhile career as speculator, in Marconi Wireless shares, have to do with the recent crisis in the North of Ireland is probably known only to the Unionist member of Parliament who made that disgraceful fling at Lord Reading in the House of Commons the other day. English Jews have always boasted that remarks of this nature, so customary in the public life of countries like Austria, Germany, France and even America at times, were quite unknown to Great Britain's statesmen. Do they think so now?

Bulletin No. 2 of the Anti-Defamation League made a better impression on us than did its predecessor. For one thing, we were pleased to note the failure of the managers of the league to specify, with odious particularity, all and sundry sorts of attacks on our people in all and sundry out-of-the-way instances. Then, too, the league gave a more or less summary account of its activity in the general matters with which it has wisely decided to concern itself. On the whole, we see a useful future for the work of this league, and its bulletin may prove to possess distinct use and value.

Hon. Simon Wolf of Washington, D. C., recently published a number of extracts from his diary, kept through the Civil War, in the columns of a local daily journal. The article makes us long for further and more extended passages, giving Mr. Wolf's first-hand impressions of famous Jews and Americans, and his thoughts on important national and Jewish events of the past. For over fifty years now our venerable friend has stood at the nation's capital a stern battler for his people's rights and those of their faith. He should publish his interesting diary in extenso and set to work writing his reminiscences in detail without delay.

Apparently the National Federation of Temple Sisterhoods, a body affiliated with the Union of American Hebrew Congregations, approves of the action of its Boston subsidiary in presenting the Sefer Torah, the Tallith, the Tephillin and the Ark (!) in the form of tableaux. Else it would not publish broadcast the news that these occurred. And some of these tableaux must have been fearfully and wonderfully made! The one for the Passover showed the table bearing the food which is "symbolic of the sacrifices brought daily during the festival." Probably the Matzoth are thereby intended! For the Reformers it must be a "terrible sacrifice" to have to eat them!

The Jewish National Fund has just published "Merchavia: A Jewish Co-operative Settlement in Palestine," by Dr. Franz Oppenheimer, of Berlin, now visiting this country. The English in this interesting and well-printed pamphlet is above reproach, which does not surprise in view of the fact that Dr. Oppenheimer's fame with respect to his ability to control our language traveled before him. Not only is the outward dress of the brochure unexceptionable; the author's account of his relations to Dr. Herzl, to the economic implications of Zionism, and to his Palestinian enterprise is fluently and most interestingly set forth. He wields a facile pen and knows how to picturesquely describe the struggles and difficulties which beset the Palestinian settlers in their devoted effort toward accomplishing their ideal results. Dr. Oppenheimer is, to our notion, quite correct in regarding agricultural work in Eretz Yisroel as the best and most efficacious means for securing the realization of the Zionist programme: permanent settlement of Jews in large numbers in the Holy Land and the restoration of that land without a people to the people without a land.

Montague Glass is a brilliant and successful writer, and the length of the run of his "Potash and Perlmutter" in this city, with the consequent steady flow of large royalties into his pockets, must make his fellow authors turn green with envy. But he has no license or competence that we know of to compare the Jewish business man of America with him of England to the former's detriment. If Mr. Glass opines that the commercial section of Jewry in New York acquires wealth very quickly in contradistinction to its slowness in acquiring culture, and that in London just the reverse, holds good, he utters a statement that calls upon all his resources of proof and logic for its defense. Probably, with the production of "Potash and Perlmutter" in London impending, Mr. Glass is trying to acquire a reputation as a Mexican "athlete" with the theatre-going public of London.

The American correspondent of The Jewish Chronicle, writing from this city, seems to have rather hazy notions about the Frank case. In one of his recent reports we read that Frank has been "twice" convicted, and that this "ordinary criminal case has now become a Jewish issue." Frank, so far as any one knows, has been convicted but once, though his conviction has been affirmed by the Georgia court of last resort. As to his case having been a Jewish issue, that is the last comment Jews would wish to see passed upon it. Under no conceivable philosophy can this cause be distorted into a Jewish case. It is an issue of American justice, centering around the figure of one who happens to be a Jew.

Finally, what shall be our attitude toward the Menorah movement in general? One of cordial and whole-souled aid and assistance. For these young men, preparing for their future life work, are the coming leaders of Judaism and the Jewish people in this country. If Judaism is to be preserved for our posterity, we must put the next generation in possession of the tools to render this preservation possible. So, there can be but one thought and opinion as to the importance, significance and value of this movement; it is grounded upon the highest and noblest Jewish ideals, and participation in it is a veritable kiddush ha-Shem.

Rabbi Samuel Sale of St. Louis holds that no principle of the Jewish religion is violated when Jewish children go to school on Saturdays! This because the local school authorities are rendering a school structure fireproof and seek to make up the lost time, occasioned by the work, by having sessions on six days of the week. Rabbi Sale qualifies by his answer to this sh'ale for a niche in the hall of fame of those who have betrayed their trust, for, if we mistake not, he is a rabbi in Israel, even if of Israel in St. Louis, and such doctrine makes for the destruction of the faith! Extended comment would be useless.

The new sheriff of the new Bronx county, Mr. O'Brien, has thus far given an earnest and conscientious public service which augurs well for his career of usefulness in the distinguished position to which he was elected last November by the suffrages of his fellow citizens. This is a fact which is brought out, too, by his recent appointment of Dr. William Cohn as sheriff's counsel. Dr. Cohn is not only a capable lawyer, LL.B. and LL.M., but is also a noted physician, M. D. His combination of two professions will be very effective in the carrying out by him of his new official duties.

THE SONG BY THE SEA

אשריה לר' כרנאח נאה: לר' אמרוה ולא לכשר ורם: "I will sing unto the Lord; for he hath triumphed gloriously." (Ex. xv, 1) "They intoned this song unto God, and not unto flesh-and-blood." (Tanhuma.)

PERFECTION lies not merely in means and method but chiefly in purpose and vision. A Michelangelo's chisel would have graced any totem-post; still Michelangelo chose a Moses for his theme. Raphael would not profane his brush by painting a sign for a wayside inn. Shakespeare at his best is Shakespeare at his highest. It is all very well for the bantam poet to spend his spurious fire on some petty village celebration; but Tennyson would be known by the liquid lines of his "In Memoriam," and Longfellow by the skipping measures of "Hiawatha." The real prophet would disdain to turn weather forecaster; the future of mankind is the burden of his song. When man reaches beyond the world of touch and take, when he enters the realm of art and religion, of poetry and prophecy, of dreams and visions, the question is always: How far is his reach? how lofty his thought? how distant his goal? how daring his stride, and how noble his aim? The exact answer to this question will determine his share of immortality.

Nothing but the highest theme suits the best singer. Nothing but the finest subject befits the wizard of words. Nothing but the most glowing vision becomes the eye in which the divine fire burns. Nothing but the purest love behooves the tenderest heart. The highest faculties aim the highest. The bigger the soul, the longer its wings. Little souls may be content with little exertion, but generous natures glory in nothing less than full employment. There is an exhilaration, a blessedness, in the rarified atmosphere of the heights which cannot be gotten at lower levels. For the burden we lift, lifts us; the cause we further, furthers us; the thing we create, re-creates us in turn; and, therefore, the higher we lift, the higher we are lifted up, and the more we perfect our work, the more our work perfects us. There are many rewards for the worker at every stage of his work; there are many flowers which the bold traveller may pluck by the wayside; but the grandest reward awaits him at the consummation of his effort, and the laurel garlands the explorer only at the end of the journey.

It is true that failure may attend the noblest effort. The greatest genius is apt to overreach himself. The theme may prove too high for the singer, the goal too far for the daring adventurer. The wings of aspiration may grow faint in midair. The load we lift may crush us. The perils in the realm of the spirit are many, and there are but few who escape them. But even in the face of dismal failure, there still remains the satisfaction that one has gone to the utmost limit of one's capacities; the far-off goal lights up the whole length of the road, and we bask in its light in the very midst of our failures. At all events, there has been throughout our endeavor that correspondence between high capacity and high purpose which lends distinction to all undertakings; and, after all, it is better to overwork than underwork; it is better to try much and gain little than try little and gain nothing.

These thoughts flashed up in my mind as I read the Midrash on our text. The Midrash emphasizes the word standing for "unto the Lord," saying: "They chanted this song unto God and not unto a man of flesh and blood!" At its simplest the meaning of the Midrash is that the Israelites, after crossing the Red Sea and gaining the signal victory over their foes, did not celebrate the greatness of man but the glory of God; did not dedicate these martial strains to any mortal hero but to the immortal God. I fancy that the rabbis may have had in mind the war-poems current among other nations in which the prowess of this or that king is lauded to the skies; and therefore they pointed out that Israel exalted the King of kings who is the true man of war and to whom alone belongs the victory. This, indeed, is the plain meaning of our Midrash; but it needs very little imagination to derive from this the thought above set forth: the highest theme suits the best singer, the highest employment becomes the highest faculty. Homer sings of Hercules, while Moses sings of God. Greece produces art, while Israel produces religion.

Our Midrash then is easily expanded into the much larger meaning bearing upon Israel's work among the nations. Israel's aim is the highest, for nothing but the highest does satisfy Israel's genius. And from this follows the truth of Israel's religion. Israel's religion is true because it satisfies the highest need of the human soul. If the glory of the human soul is its utmost reach then God is the glory of the human soul. Farther than God the human soul cannot reach; hence anything lower than God the soul must not be satisfied with. The burden of Israel's song is God and not either man or half-man. Israel's is the most daring adventure into the realm of the spirit: the Quest of God! We did not stop midway, we were not and shall never be satisfied with any being less than God. Have we failed in our quest? No. Have we reached our goal? We have. We have found God for ourselves and all humanity. Have we failed in our methods? Has our religion not employed the best possible means, in its much-disputed legalism, towards finding God? Perhaps—the point is not worth laboring at. We have sought perfection not so much in method as in purpose. Ours is the high aspiration. Ours is the exalted vision. As in the days of the olden Exodus the far-spreading wings of the Song by the Sea soared up to the heights of God's Throne, so to-day we still lift up our hearts on the pinions of this same Song of Glory. The sea roars, for hatred sweeps over it. Still Israel sings. JOEL BLAU.

conjunction with the second volume. We have looked into the books and find them to be all that their titles indicate. They should be useful to the student of the Bible and especially of the English of the Bible. A discriminating reader will find much within the covers of these books to attract and hold his fancy and interest. We particularly commend, in conclusion, the total absence of all Christological references and implications from these pages. The author in the performance of her task has had the needs of children particularly in mind; her work will be received gratefully by the older generations as well.

REPORTS OF CRIMINAL EVENTS

It is remarkable what space the daily press has given to the details of the execution of four criminals. The minute description and recitals of the events of the electrocution have filled pages. Not only that, the half-tone pictures of the criminals were displayed in elaborate wreathings upon the first pages of many of the morning and evening dailies—even the conservative press has vied with the sensational in spreading the details over their pages.

Lombroso and other eminent writers upon criminology have commented in condemnation of exploiting the doings of criminals, and have gone so far as to say that certain classes of the community should be forbidden to attend the trials of murderers for the reason that the notoriety that this gentry receives in the press has a dangerous influence upon them, and that many a future criminal became so in embryo, because of the undue notoriety that murderers get, in making heroes of them.

There is a morbid class in this as in other communities, who almost apotheosize some criminals by showering attention upon them. Who is there who doesn't remember the nauseous attention paid to the negro murderer, Chastine Cox, and the medical student, Carlisle Harris, who were the recipients of inordinate attention, as the press gave it out—of women of refinement, who so profusely sent flowers to both of them?

TABLE TALK

"The congregation shall judge; and the congregation shall save." According to Talmudical interpretation, one "congregation" shall "judge," and another "congregation" shall "save"—or "try to save." That has just happened in connection with the tragedy enacted at dawn of last Monday. Rev. Dr. Max Raisin, of Temple Shaari Zedek, Brooklyn, has publicly condemned the four boys, while the Rabbi—Goldstein—of another temple in Brooklyn—strenuously endeavored to save their lives. The different opinions of the two Reform rabbis would be of small concern to American Jewry, were it not for the fact that a great and vital principle is involved in the question: "What should be the attitude of the Jewish clergy towards those who are condemned to suffer capital punishment?" Dr. Raisin, in the course of a sermon which he preached on the first day of Pessach, deplored the action of the Orthodox Rabbis Hyamson and Drachman, who, at the request of the Jewish chaplain, aided in pleading with Governor Glynn to postpone the execution. Dr. Raisin, the Reform rabbi, said that "in all his studies of Jewish history it has never yet come to his notice that representatives of our people have at any one time made an attempt to interfere with the due course of the law whenever a Jew, or Jews, happened to be involved. On the contrary, sentiment among us has always been in the opposite direction. We were always supersensitive about the fair name of the Jew, and to save the Jewish honor our fathers would rather see the Jewish vineyard cleared of any of its human thistles and briars. Ours is the pure honor system. It is not for us to shelter, or defend, a criminal simply because he happens to have been born a Jew. In the light of all this how strange must appear the action of several rabbis of Manhattan who went to Albany to intercede with the Governor in behalf of the four men awaiting death for a most heinous crime committed in this city almost two years ago. Aside from the fact that such a step betrays a lack of

confidence in the wisdom and justice of our courts, and in the fairness and ability of our Governor to cope with a very trying situation, it serves to place the Jew in a bad light. For say what we will, those rabbis went to Albany as Jewish representatives in behalf of criminals who happen to be Jews. In doing so they forced into a purely legal case a religious element." If Rabbi Raisin has not been misrepresented his sermon bristles with misunderstandings. It cannot be said, justly, that the Orthodox Rabbis Hyamson and Drachman "attempted to interfere with the due course of law," or that they tried to "shelter or defend a criminal simply because he was born a Jew." The two conscientious, humanitarian rabbis merely urged Governor Glynn to delay the execution. That was not "interfering with the law." Neither did the action of the Orthodox rabbis "betray a lack of confidence in the wisdom and justice of our courts." They only hoped that "delay" might throw more light on an extraordinary case. Rabbis Hyamson and Drachman, who are upholders of traditional Judaism, could not refuse an appeal to plead for the condemned men. Since Talmudic times Judaism has set its face against capital punishment. "Sanhedrin who order an

execution once in seven years, their act is considered pernicious"—(See Makoth.) Rabbi Elizer ben Azariah said: "Even Sanhedrin who do so once in seventy years their act is pernicious." Rabbi Tarphon and Rabbi Akibah both said: "If we were of the Sanhedrin, a death sentence would never take place"; and curiously enough, the most philosophical of modern criminologists and up-to-date ethical humanitarians are also advocates of the abolition of capital punishment. Nobody in New York would, for instance, charge Dr. Felix Adler with "attempting to interfere with the course of the law," and yet he uttered some

thought-compelling words on the same subject in his Easter address, delivered before the Ethical Culture Society. "The old method," said Dr. Adler, "was to regard the criminal as bound by limitations, unable to throw off his fetters. The new method asks that we give him a chance. The old method does not give us a shock in reading of the pitiful appeal of the four 'gunmen,' for whom this is the last day.

They are just boys, and it is true that we, representing society, are going to take their lives in cold blood. . . . No one can look on the criminal without a sense of despair at the imperfection of the methods we have used in dealing with crime and with criminals." Thus speaks the up-to-date teacher of ethical culture, who says that what we need is "theistical imagination." Why then censure Drs. Hyamson and Drachman, who represent "theistical imagination" as taught by "traditional Judaism?" Why blame the two worthy Orthodox clerics for carrying out in practice the command of the Torah: "Thou shalt love thy neighbors as thyself," which, according to Talmudical interpretation, means that this love must be extended beyond the limits of social intercourse in life, and applies even to the convicted criminal. Yes, traditional Judaism goes even much further in teaching us that "the spirit of love must be manifested by according the criminal a decent death." Some unguarded words were perhaps uttered during the dolorous days, and it is also open to discussion whether it would not have been wiser to have asked for "clemency," to commute the sentence to imprisonment for life. But, no doubt, the rabbis had to follow the advice of the lawyers who conducted the defense, and so the rabbis did their best, under very difficult conditions. They tried to rescue life, a meritorious religious act, forming part of the duties of a rabbi. The honor of Judaism is enhanced by a rabbi's humanitarian endeavor, and all that can be said about the adverse criticism was summed up by Dr. Stephen Wise, last Sunday, when he declared that "it is infinitely more important to do battle against Jewish defamers of Israel than against our defamers and slanderers who dwell without our ranks." Dr. Wise has promised to have something to say next Sunday on capital punishment, with especial reference to the tragedy enacted last Monday. It will be a great surprise if he does not advocate the abolition of capital punishment.

"And now for a little poetic fancy. You know, dear Benjamin, how our friends the Reformers (particularly the women) claim that Orthodox Jews who use a ritual according to which men say 'shello 'asani nokhri' (who hath not

made me a Gentile), 'shello 'asani 'abed' (who hath not made me a slave), 'shello asani isha' (who hath not made me a woman), whereas women are instructed to say 'she'asani kirtsono' (who hath made me according to His will), treat women with disrespect—underestimate her.

"But I can picture Rabbi Swiren (now your brother-in-law) as having met your sister and as saying the following morning:

"Would that all my brethren could recite with the same fervor as I now do these benedictions: To have met Hayya Rachel—to secure her as a life partner shall be my purpose, the possibility shall become reality if heaven but will it. Blessed be He that hath not made me a Gentile, though a Gentile might by study learn Torah and becoming a Jew approach her status; blessed be He that hath not made me a slave, though a

slave may by his efforts amass money and win his freedom; but, above all, blessed be He that hath not made me a woman, for in that case I surely could not change into a man, and all thought and hope of a covenant of marriage and lasting union with her whom my soul loveth would be absolutely out of question."

Young Folks' League of Congregation Orach Chaim.

On Wednesday evening a regular meeting of the league was held in the vestry rooms of the synagogue and was largely attended. Rev. Dr. M. Hyamson delivered an address.

Fifth Kehillah Convention.

The fifth annual convention of the Jewish Community (Kehillah) of New York City will be held on Saturday evening, April 25, at 8.30, and Sunday

morning and afternoon, April 26, in the auditorium of the Hebrew Technical School for Girls, Second avenue and Fourteenth street.

The recent expulsion of Jewish traders from various places (especially from the villages in the province of Wilna, and from Simbirsk and Kieff), and more particularly the refusal of the government to sanction the regulations of over three hundred public companies, because they contained no provision for the restriction of Jewish members, have so exasperated the Christian commercial world that the Council of Trade and Commerce last week resolved to send a deputation to the government, to present it with a memorial pointing out that the present anti-Jewish regime was ruining the commerce of the empire and filling the pockets of foreign competitors.

Jewish Communities of Jerusalem Organizing.

The Jerusalem correspondent of the "Zionist Gazette" writes as follows: "Various recent occurrences have again brought the question of the organization of the Jewish colonies of Jerusalem to the front. This organization would form a precedent for joining all the communities in Palestine into an organic whole. If the whole of the Jewish urban communities in Palestine are organized, it would then be an easy thing to create a council composed of representatives of these communities and the country communities. This organization will sooner or later be recognized by the government, which will naturally prefer to deal with a body representing the whole of the Jewish population concerning Jewish affairs. The Jewish community in Jaffa has organized itself in a model manner, and is growing stronger from year to year. Jerusalem and Hebron are the only other Jewish communities which would come into question in organizing the Judean congregations. In Jerusalem, however, in consequence of the composite character of the population and the peculiarities of its various means of gaining a living, the problem of organization appears very difficult. A solution, however, will have to be found sooner or later. If it is possible in the near future to create new agricultural settlements in the neighborhood of the town, to reorganize the Jewish schools thoroughly, and to develop the possibilities of the applied art workshops and the commercial undertakings which, it must be confessed, are rather meager at present, then Jerusalem will experience a revival which will redound to the honor and credit of the Jewish nation."

Zionist Trial in Russia.

A great Zionist trial was held a few days ago in Wilna. The defendants were the brothers Goldberg and the editors

Grünberg and Drujanow, who were accused of having founded a Zionist Committee during the years 1908-1911 for the Zionist organization, which has not been legalized by the government. Besides the accusation of Zionist propaganda and activity a number of curious points were also brought forward. For instance, the public attorney asserted that the secret police had furnished him with statistics showing that the Zionist organization had a capital of 175,000,000 roubles. The prosecution further declared that it has been definitely ascertained that the Zionist organization collect from Russia alone a sum of three to four million of roubles yearly in the form of shekel money. As a convincing proof of this the public attorney brought forward the following "facts." The price of the shekel is 50 kopeks. As six to seven millions of Jews live in Russia, the sum of 3,000,000 roubles is the logical result. The defenders, Messrs. Nemrowsky and Tschichow, answered this argument by informing the public attorney that he had forgotten the fact that the shekel is only contributed by the adherents of the Basle Programme. The trial was different from other Zionist processes in so far as in this case the accusation was not only the selling of shekels, but it was also an attempt to stop the propagation of an idea. The court declared that the tendencies of the Zionist movement were dangerous for the security of State and citizen, and sentenced D. A. Goldberg to a term of four and one half months imprisonment, I. L. Goldberg to three months imprisonment, and the others to two months. One-third of these terms is regarded as cancelled, according to the manifest recently issued. The trial has made depressing impression in Jewish circles.

A dramatization of the Biblical Book of Job, after the manner of the Greek drama, with a chorus and the preservation of the unities, was presented by the Wisconsin Dramatic Society at the Davidson Theatre in Milwaukee last Friday afternoon for the first time on any stage. The dramatization was by Dr. H. M. Kallen, of the Faculty of the University of Wisconsin, a specialist in Biblical history, and the title role of the drama was played by the Rev. Addison A. Ewing, an Episcopal clergyman of Madison.

The third anniversary of the murder of Yuschinsky was last week made the occasion for the holding of a real Russian memorial service at Kieff. A vast crowd assembled, but owing to their threatening behavior the police had to prohibit speeches. As a result of the action of the police, the Two Headed Eagle attacked the authorities, who took proceedings against the paper and advised the Governor-General to suspend it and close the organization bearing its name.



AVOID LAWSUITS!

Dear Children:—Those merchants who acted as a Board of Arbitration thus volunteered their time and services for seven years, until there were found men with the necessary knowledge and vested with the requisite authority to act as a Beth Din or Jewish tribunal. Every week three of the merchants, chosen by lot, sat as arbitrators, as it was between them, and when a case came before them they made a record of the claimant's plea and the respondent's answer, also of the decision that they arrived at.

After the lapse of seven years, when the new Jewish tribunal, at the head of which was the illustrious author of Seder Hadorath, received the records left by these twelve "merchant-judges" in Israel, they were so astonished at the logic and justice displayed by those volunteer Dayanim in the "Pesharoth" they had rendered, that they extolled them in the words of Ecclesiastes: "Who is like the wise? and who knoweth (as well) the explanation (Peshar) of a thing?—May such men increase in Israel."

Rabbi Ishmael now addresses himself to the Dayan or Jewish judge, and exhorts him not to be a sole judge. This exhortation fills us with surprise, as the Ethics of the Fathers is not a Book of Laws, and the law is clearly set down in the Treatise Synhedrin that all civil actions must be judged by three Dayamin, but the fact is that even one Dayan, who bears the reputation of being well versed in the Jewish code, is also eligible to judge a case himself if the litigants are satisfied to accept his sole verdict. Still Rabbi Ishmael gives ethical instruction to that judge, impressing upon him the necessity of forbearing to judge alone, even though he possesses the ability and the litigants have confidence in the justice of his sole verdict, but that he ought to judge with two others in order that to glorify the name of the Lord, to make it manifest that a sole judge there is but One, and none other than the Eternal should judge alone, for He is a true judge. "And when you are judging a case," Rabbi Ishmael says to that learned judge, "do not say to thy two colleagues, 'Adopt my views,' for they are the majority and you are but one; therefore you should respect their views. Nevertheless, you must not think that if it is clear that the two judges are mistaken in the law that you must also concur in their mistaken opinion. The great expounders of the law—

the Magen Abraham and the Turei Zahav—have decided that it is their duty of the learned judge to fully explain the point of the law, that they may be convinced of its correctness."

Thus, dear children, you see that the ways of the Torah are ways of pleasantness, and all its paths are peace; the tendency of all our teaching, all our laws, and all our dealings with our fellow-men is to maintain peace with honor.
