“MY DAY”

Translated from the Yiddish of Shalom Aleicham

“My day does not start until long after the rest of the village has gone off to work—until long after Jacob the smith has opened his forge, and Abraham the pedlar has tied his pack on his shoulders, taken his stout staff in his hand, and gone forth into the land of Goshen, as his forefathers went, here and there before him. If not to the land of Goshen, then elsewhere, as it happens with him. My day does not begin until long after the threshers have carried their flails to the threshing floor, and the laborers have betaken themselves to the fields and the barns and the outhouses.

When the sun is high up in the beavens and the men are preparing to go to their prayers I creep out of my little loft and begin the day, just as if it were absolutely impossible for me to get up a moment sooner.

When the prayers are at an end, and the laborers have returned to their tasks, have taken up once more the tools they had already used for many hours on end, I start my day in earnest. First of all, I have to prepare myself according to the household at which I am going to have my breakfast, according to the place that Lemuel and Shammass got for me the day before. For instance, if I am destined to have breakfast at the table of the same Jacob the blacksmith of whom I have just spoken, the same Jacob whose bellows began to blow and scorch many hours before I was up, I simply wash my face and my hands, and go off without any more ado. It does not matter how one's toilet looks if one has the ill-fortune to come in contact with rude people like Jacob and his wife and children. They know nothing at all of culture or personal refinement. Therefore, it is not worth while wasting one's energy by brushing the down that always manages to stick to one's clothes overnight. I know what they are like. I know what to expect of them, and everything always turns out according to my expectation.

I never get any answer to my “Good morning,” so why should I waste my breath saying it? I walk into the room without a word, take my accustomed seat at the table, and

cause the family will not have their meals without Jacob. And, because, furthermore, it happens frequently that Jacob is occupied in shoeing a horse belonging to one of the wealthy

which he cannot afford to let get cold. In this way, he often keeps his wife and children waiting for hours for their meals. But, why should I, the guest of the day—why

supposing that the blacksmith's wife set before me the coarse black bread, and the sour milk, and the curd-cheese she always gives me for breakfast without the master of the house being present to grace the meal? But, I can and do pay the family out for their shameful conduct towards me. I generally manage to find out a good deal concerning the people into whose houses I am in the habit of coming. I know, for instance, that Jacob's eldest daughter is hideously ugly, like a frog, and looks her real age, twenty-eight or thirty, when she is not washed in the mornings, and when she has not yet had time to comb her hair. Now, with this knowledge at hand, I can revenge myself on Jacob. And, the very next person I meet I tell him all about Jacob's daughter. I tell everything about her—everything. But, there is a point at which I stop. I am not like some of the men of the village, the old men, I mean, who can talk for ever about their neighbors, and who never find a single good point in anybody.

Quite the contrary. I defend Jacob's daughter vigorously, though it is true that she is hideous as Satan himself. It is not her fault that she is so ugly. Therefore, I end up my remarks by saying of her in a pitiful voice:

“Yes, friend, a girl is like a towel. Whoever wishes can wipe his dirty hands on her good name, besmirching it for no reason whatever.” By which I mean to let everybody understand that I have not the least intention of slandering any one, not even the ugly daughter of the rude blacksmith.

Now, it is an altogether different affair when I am going to breakfast at the house of old David the letter-writer. He is a polite man, and knows everything that goes on in the whole world. It is true what the villagers say of him. He really knows what goes on in the Czar's palace every hour of the day, as well as the number and nature of the fishes which swim through the river outside the village with in a given time.

No sooner am I on the threshold of his door than I feel that it was well for me that I took great trouble with my toilet, putting on my best clothes, and holding my right glove in my left hand, leaving the other hand bare, according to the Parisian mode. Inside the door I pause to make a low bow, clapping my heels together in military fashion. I would

not dream of passing the second rafter that is overhead without being invited to come forward. And, I am sure to be invited by David himself in his politest manner:

"Be so kind—do me the favor to come into my humble abode. I assure you I feel deeply the honor you have conferred on myself and my beloved partner in life, by accepting my invitation to share our poor meal—the first of the day."

And, his wife, a tiny little woman, dried and shrivelled up as if she had lived in a tropical country, who wears a red kerchief around her head and a bright blue one around her neck, winter and summer alike—she also welcomes me in the politest phrases, speaking a little indistinctly whistling the words through her teeth.

After having bowed low several times, and having begged to be excused for this and that, I take my seat at the table. I am not offered coarse black bread, and sour milk and curd cheese here. No, indeed! Neither the letter writer nor his wife are rough and rude like the black smith and his family.

The little old woman brings to the table a china coffee pot that steams and hisses and gurgles, so that it is almost a shame to disturb the contents. It is a great pleasure to sit and listen to the coffee steaming before having one's cup filled with the golden liquid.

Ah, they are real cultured folks, the letter writer and his wife. They are almost Germans!

And then, too, there is no rush or hurry anywhere in that house. One can eat slowly or quickly, as one likes. Besides which, one is bound to enjoy the listening to the letter-writer expounding his views on the latest move in politics. I always imagine, listening to him, that he is as intimate with the world's politics as if the earth were a chess board, and he were an expert player. The diplomats are to him no more than chessmen, and he knows how far this man may go without fear of being overthrown, and how far that man has already gone beyond the bounds of success. Above all, the letter-writer seems to know thoroughly how trifling a difference there really is between a successful and an unsuccessful move.

But, what I like most about David is that he is a bit of a heretic. He does not care in the least whether I say grace after food or not. And how good it is to take off one's little fur cap, and to sit at table bareheaded like a "Goy!"

Among the other households of the village where one can feel comfortable, there is the house of the widow, Zelda, whose husband had once owned the largest farm for miles and miles around. At his death his widow took laborers, and worked the land as before, so that she is just as wealthy now as when her husband was alive. She has two sons. Asher, the oldest, who wants to go to America to learn how to speak in public. He does not want to be a "Maggid," but to become a public agitator for Socialism. The younger, Arke, calls himself by the Russian name of Tikon. He whistles in a shrill tone a number of pretty tunes which he learned in Riga.

Zelda is strongly opposed to her eldest son's wish. She will not let him go to America. Neither is she satisfied that Arke should have the feeling that he does quite enough work when he stands in the middle of a field and goes on whistling without an end. She wishes both her sons to be different from what they are. To that end she invites one or more "Yeshive" students to have meals at her house every day of the week. She gives them the best of everything, and tries to keep them at table as long as possible, hoping that her sons might come to learn something of them—a little Talmud or Gamorrah. Indeed, she even goes so far as to imagine that by contact with the students her boys will take from them a little of the spirit which prompted them to throw themselves on to public charity, head foremost, so to speak, in order that they might fulfill the dreams of their lives, and become Rabbonim,

Zelda makes time to argue with the poor students who are her guests, no matter what the hour may be. She seats herself opposite the young men, jingles her bunch of keys, and asks so many questions that it is impossible to swallow two bites without having to say something in between.

That's how it is in all the houses where there are scamps of sons who will not give up their days to hardship, and continual changes, and to having their meal in a different house each day of the week, for the sake of studying the Holy Torah.

The best part of the day is immediately before dinner, when the rabbi goes home from the "Yeshiva" for an hour's rest. Then comes one's chance to tell out the things that nearly choked one all the morning. I come to the place where the students meet outside lesson hours—the empty barn beside the inn, and I feel that I can now talk to my heart's content. The boys know that I have always something interesting to tell them, and they gather around me and listen. This is the hour, too, when we are in the habit of living in luxury for a few heavenly minutes. When we cease to depend for our necessities on the public. We put a half copek each into a box, and Simon the black one, who knows what a bargain is, goes forth and brings us back a pocketful of dainties, such as no one ever dreams of offering us in their houses.

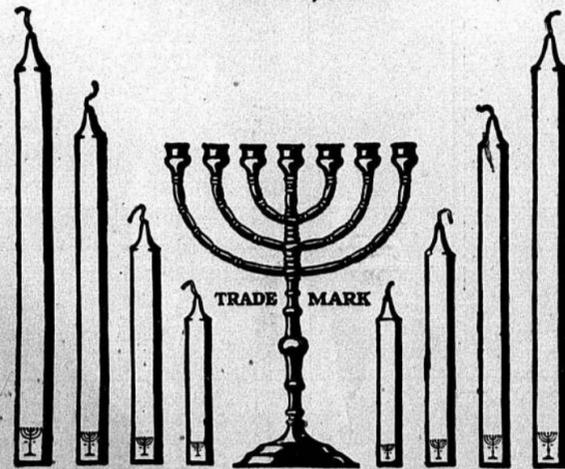

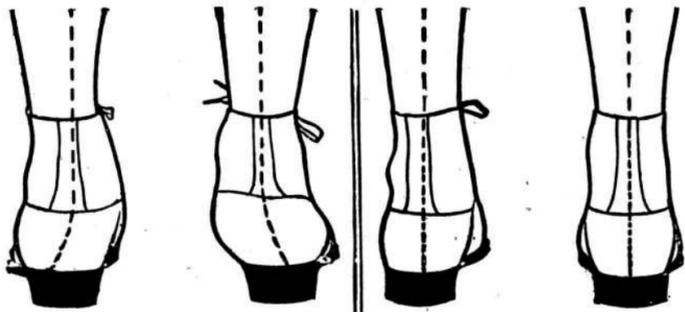

The New Russian Treaty and the Jews

The United States, after the usual ratifications of the peace convention signed at Washington, will again have treaty relations with Russia. But there remains to be negotiated a commercial treaty to take the place of that of 1832 abrogated by America because of the refusal of the Russian Government to recognize the passports of American citizens of Jewish faith.

While the Czar professing a change of heart, or of policy, toward his Jewish subjects, under stress of present circumstances, it would seem that the time is opportune for diplomatic insistence upon the full correction of the conditions which have marred the otherwise friendly relations of the two great nations.

While the iron is hot the administration should strike, if the term can be used of diplomatic negotiations. It may be found easy now to secure that measure of justice for American citizens and that respect for the American flag that was not possible in any of the years gone by and that may not be possible in the years following the war.

Conditions to-day are highly favorable to the successful negotiation of a treaty that will end Russian discrimination against American citizens on the ground of their race and their faith.—*New York Evening Mail.*

Mr. William Saalburg, who died in San Francisco, Cal., last month, at the age of 80, was for thirty-five years editor of the *Jewish Times and Observer*, and retired from active business after the earthquake in 1906. He had the unique distinction of reading his own obituaries when his death was falsely reported about fifteen years ago. Mr. Saalburg's son is a cartoonist, and for some years has been in charge of the Sunday colored supplements of the *New York World*.

ITEMS OF INTEREST IN THE JEWISH WORLD

Sir Francis Montefiore has resigned as honorary president of the English Zionist Federation.

Rabbi Friedlander, formerly of Orange, N. J., has been elected rabbi at Greensboro, N. C.

The Jewish Journal will shortly be issued in the interests of Jews of St. Paul and Minneapolis, Minn.

The Russian Ministry has permitted all schools of commerce to admit many Jews above the norm.

Congregation Beth-El of Knoxville, Tenn., dedicated a handsome new synagogue on September 20.

Congregation Adath Jeshurun of Roxbury, Mass., collected \$2,500 for war sufferers on Rosh Hashanah.

A number of Oriental Jews, who recently arrived in Indianapolis, Ind., have organized a congregation.

Young men to the number of seventy-two of Tarentum, Pa., have formed a Jewish social and literary club.

During the month of August seventy-nine cases were attended to in the Jewish Maternity Hospital of Philadelphia, Pa.

Miss B. Haas, who has been entertained by friends here for some time past, has left for her home in New Orleans, La.

Mme. Ottilie Metzger, the famous contralto of the Hamburg Opera House, has gone to the front in Germany as a Red Cross nurse.

Two companies of Jews are being formed in Montreal, Canada, to be attached to a well-known local militia regiment.

A number of Jewish boys affiliated with the Congregation Mishkan Israel of Jamaica, L. I., have organized a troop of Boy Scouts.

The Winthrop (Mass.) Jewish community, numbering 150 families, have bought a house which they will immediately alter into a synagogue.

Active plans are on foot in Indianapolis, Ind., to acquire an addition to the Jewish Communal Building, which shall be used as a free dispensary.

Eleven young Jewish students are named among the nineteen awarded Pulitzer scholarships for graduates of the public schools of New York city.

The Prefect of Petrograd has prohibited the police from expelling without his permission Jews who arrive there from the theatre of military operations.

December the 13th has been fixed as the date of dedication for the new Chesed Shel Emeth Synagogue now approaching completion at Wilmington, Del.

Dr. Louis Anspacher's comedy drama, "His Son," has been produced with success by Oliver Morosco at Los Angeles, Cal., and will shortly be given a New York hearing.

It is estimated that there are about 5,000 Jewish men enlisted in the United States army and navy. Five hundred and twenty are in the various government forts around New York city.

Harry M. Raphael, prominent in several Pittsburgh (Pa.) clubs and organizations, died last week after a brief illness. Mr. Raphael was one of the five founders of the Zionist movement in Pittsburgh.

Moses Kaufman, who died in Shreveport, La., last month, where he had resided for just forty-nine years to the day, was a well-known and successful merchant of that city. He held various political positions as a member of the Shreveport Charity Hospital Board, the Shreveport Board of Health and the Louisiana State Fair Association.

New York city Jewish charities receive \$3,000 under the will of the late Pincus Lowenfeld, which disposes of an estate estimated at over \$1,000,000. A provision is made for the disinheritation of any child who marries outside of the Jewish faith.

The next annual convention of the Federation of Jewish Farmers of America will be held in New York city on November 29-December 2. Governor Glynn has promised to be present and speak on the Land Bank.

The library of the Dropsie College at Philadelphia, Pa., now totals about 11,000 volumes. Some valuable gifts were received from Judge Mayer Sulzberger and Dr. A. S. W. Rosenbach during the past year.

The Jewish deputies have received a large number of wires from Jews residing in Polish towns ruffled by the German invasion, asking them to use their influence to obtain permission for the sufferers to settle outside the Pale.

Henry L. Straus, one of the best-known Jewish lawyers in Baltimore, Md., died last week. Mr. Straus retired from active practice about sixteen years ago. He was very fond of travel and had made over twenty trips to Europe.

The Jews of Odessa have not only made arrangements for the maintenance of the families of the Jewish reservists, but they have also arranged that the children of parents who are at the front shall receive adequate education during the war.

Mr. Leo B. Forst, who has been a chemist for some years in the employ of the Pure Food and Drugs Bureau of the Department of Agriculture, has been promoted to head the Federal laboratories maintained in Cincinnati, O., by the government.

The official canvass has shown the following elected as delegates at large to the New York State Constitutional Convention: Democrats, Samuel Untermyer and Samuel Gompers; Republicans, Louis Marshall, and Progressives, Oscar S. Straus and Edwin R. Seligman.

The work of organizing the Land Bank of the State of New York is progressing. Thus far only two farmers' organizations have taken advantage of the new law. One was organized by the Jewish farmers of Sullivan and Ulster counties, known as the First Farmers' Savings and Loan Association.

There are twenty-one legally appointed Jewish chaplains in the Austrian army, all having the rank of captain. Every chaplain is provided with a scroll of the law, a Tallith, ten Hebrew prayer books with German translation and ten pairs of Tefillin. The rabbis are also provided with Kosher food.

The death, in action, has been reported of Lieut. Ronald Lucas Quixano Henriques. Lieut. Henriques, who was thirty years of age, was a promising young officer in the Royal West Surrey Regiment. He was the author of a small manual on signalling, which has been used extensively in the British army.

Recently about 300 Jewish travelers from Russia and other countries arrived at Jaffa. The government stopped them from disembarking, with the result that they soon found themselves without food and water. The local Jewish community, however, supplied them with provisions sufficient to last them until they started on their return journey.

The London Lodge of the Independent Order of B'nai Brith has established a hostel for a number of Jewish war refugees. Accommodation is provided for between thirty and forty persons, and those already in residence hail from various parts of the war area, including Paris, Liege, Louvain, Ghent and Antwerp. Among the party are a number of university students.

The Turkish Government has requested the Haham Bashi of Turkey to proceed to the election of a Chief Rabbi of Jerusalem in place of Rabbi Franco, who resigned owing to his advanced age.

Mr. Jacob H. Schiff has been elected vice-president of the New York City Chamber of Commerce to succeed Paul M. Warburg, who resigned because of his selection as a member of the Federal Reserve Board.

A number of Jewish communities have appealed to the Russian Ministry to allow them to use the reserve Korobka funds (Jewish meat tax) for the purpose of opening co-operative stores for the benefit of citizens of all nationalities, as well as in support of the Red Cross. The Ministry has adopted a favorable attitude towards the proposal.

The Co-operative Fire Insurance Company, which is maintained by Jewish farmers of Sullivan and neighboring counties in New York, has now over \$1,000,000 worth of policies in force. The company has had a very successful year and has carried on its work at a cost to its subscribers of about 25 per cent. of that charged by other fire insurance companies.

The death has taken place in London of Mr. Isidore G. Ascher, who was well known as a writer of poetry of no mean order. Mr. Ascher was born in Glasgow in 1835, and he proceeded to Canada, where he became a graduate of the McGill University, subsequently practicing as a barrister. He was the author of several publications and when in Canada he was editor of a magazine.

Following M. Kasso's refusal to admit to the gymnasium the children of a few Russian Jews who went to the war, some of the Jewish communities have decided to appeal to the Premier to abolish the lots system of admission of Jews to schools this year. The Moscow Technical Institute has also appealed to the Ministry for permission to admit Jews above the norm.

The Jewish community of Vienna has organized a comprehensive plan of relief for the many hundreds of destitute families who have become so on account of the war. The various organizations have undertaken to provide free Kosher food for 8,000 persons at the cost of 22 Heller per day. For the sum it is expected that each one will obtain enough bread, a plate of soup and some vegetables. Special committees were appointed for every district of the city to carry the work through.

The Russian papers state that on the Austrians entering Kamenetz-Podolsk, they imposed very heavy contributions on the town, taking as hostages the Mayor and other prominent residents, of whom several were Jews. Owing, however, to lack of money, the Jews together with the Christian population brought some of the valuable articles of the synagogues and the churches. The Jews brought the silver handles and pointers of the Sepher. The Austrians, however, refused to take these articles.

Hyman Rosenschein, who died in New York city last Saturday, was the originator of the New York Sun's famous characterization of "Rosey the Lawyer." He was born in Kempen, German Poland, and came to this country without means or education. He toiled in a sweat shop in the daytime, and at the age of twenty-four began to take up law, studying at night. He was admitted to the bar a few years later and was one of the best-known characters on the East Side until his retirement from the profession a few years ago.

The Poles have carried their latest anti-Jewish agitation so far that even the Catholic priests had to intervene and attempt to arrest the spread of the movement. The loyal appeals made by the rabbis in the Warsaw synagogues and the representations of the Jews to the bishop of the Polish capital and to some of the governors have been successful in impressing the authorities with the trustworthy character of the Jews. Not only the Governors of Petrokoff and Lublin, but also the Catholic and orthodox clergy issued appeals for peace among all nationalities, while the Liberal Poles have begun to agitate in favor of according extensive privileges to the Jews in Poland.

NO ALUM IN ROYAL BAKING POWDER

Jedel and Henry Bodenheimer. The musical programme was in charge of Mesdames Harry Kraft and Charles E. Seligman.

Temple Anshe Chesed.

Special peace services were held at Temple Anshe Chesed on Sabbath morning, October 3, and on the eve of Sukkoth.

On Sabbath morning a peace prayer was solemnly recited before the open Ark prior to the taking out of the Scrolls, and on the eve of Sukkoth a special prayer for peace was offered before the congregation adjourned from the synagogue to the Sukkah. Rabbi Jacob Kohn offered a peace prayer on Sunday evening.

Fully 1,000 people visited the Sukkah during the holiday festival. On Wednesday evening, October 7, the young men and women from the Fellowship House were guests at the Sukkah and on Saturday afternoon, October 10, at 3 o'clock, the children of the Religious School numbering between 250 and 300, have also been invited to visit the Sukkah.

The next time you are taken for a Jewess reply something like this: "No, I am not a Jewess, but if I were I would have a great deal to be proud of in belonging to the race that has given the world some of its greatest philosophers, writers, painters, musicians and philanthropists." Do not show utter ignorance and shameful prejudice such as no educated persons to-day would ever show by being ashamed to be thought a member of the race of which this story is told. When Lord Disraeli, the greatest of English statesmen, was tauntingly asked if he were not a Jew, he replied "Yes, and my ancestors were princes in the House of David when yours were savages in the wilderness." He was known as a "marrying parson," and averaged 700 wedding ceremonies a year, one Lag b'omer about ten years ago officiating at ten weddings during the day. He was the rabbi of the B'nai Shalom Congregation on East Fourth street, for about twenty-five years, and about seven years ago became rabbi of the Congregation Ez Chaim, East Ninety-second street, from which he was compelled to resign owing to illness.

He left a widow, who was Miss Theresa Lichtenstein, of this city, and four children—Justice of the Peace Samson Loewenthal of West New York, Monroe M. Loewenthal, Leo B. Loewenthal and Mrs. Carl Levi.

Funeral services, which were held last Sunday morning, were very largely attended. In addition to religious services there were Masonic services under the auspices of True Craftsman's Lodge, No. 651.

seldom befalls me. Not more than a few times in the year.

Meanwhile, the hours fly by, and the evening sets in, when it is too dark to read and too bright to light candles. In the twilight many of the boys nearly blind themselves trying to read the tattered German,

or Russian, or "Yiddish" novels which they carry about with them all day, hidden in their top-boots. I would not dream of causing so much injury to my eyes for the sake of knowing what is written in the forbidden books. Is it not enough that a man is compelled to read all the things which are written in the books it is necessary to know something about in order to prove that one has studied?

We four—Alter, the bow-legged son of the Shammas, Tevya, whom we call the Tinker because he is fond of amusing himself with tying old tins to the tail of the cat belonging to the innkeeper, and Hirshalle, whose silence has earned for him the nickname of the afflicted—we four get into a corner of the woman's shool, right under the window to have the benefit of the last rays of the sun, and we play a game of cards, using the pack that is well marked in red and black ink, and shows up everything quite clearly, even in the faintest light. We take good care not to be caught playing cards. As soon as we hear the footsteps of the "Sham-

mas" coming up the rickety stairs, we rush forward and ask him in aggrieved voices whether the candles will ever be lit in the Beth Hamedrash or not.

I always feel that the day is at an end the moment we are seated around the table, our books opened before us, ready to start our disputations for the night. What interest can it be to anyone that out of the most trivial phrase there are innumerable arguments and explanations to be drawn? Surely it cannot matter to any living being what some one said about this or that a thousand years ago!

But I take it this way. Business is business. And if I were not studying I should probably be selling pitch out of a big barrel, measuring it out to the peasants with an enormous iron ladle. One has to do something for a livelihood.

The only fault I have to find with this life is that it is so commonplace. Once upon a time a "Yeshiva" student was a rare bird, but now, since the people have betaken themselves doing charitable acts every hour of the day—since true charity and real consideration for the worthiness of the recipient has become a thing of the past, a poor student is a mere everyday matter. He is no more a person of importance than is any wood cutter, or water carrier. If it were not the life of a real student would be much more interesting. And every day of his life would be full of pleasure, and ease, and excitement, as well as work.

Russia and Her Promises.

There was much of the raw material of hope in news from St. Petersburg, or Petrograd, a couple of weeks ago, of promises of fair treatment for Jews in the vast Empire. Before that it had been announced, informally, of course, that political exiles were welcome to come back if ready to fight for Russia. Formally it had been declared that the

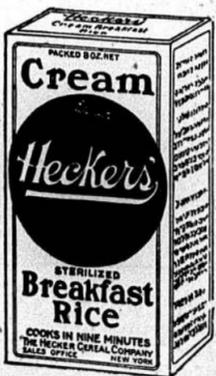

NEWS FROM ENGLAND

(Exclusive Correspondence to the HEBREW STANDARD)

While we implicitly observe in spirit and letter President Wilson's admonition to the American people to maintain a strict neutrality in the present European conflict, we publish the following as a personal and subjective expression of the opinion of one of our regular contributors, and it should in no way be construed as the personal opinion of the editor of this publication, whose opinions are expressed only on the editorial page.—Ed. Hebrew Standard.]

More Jewish Soldiers Enlisting—Interesting Scenes When Jewish Troops Attended New Year Services—Casualties Among Jews at the Front—More Relief for Jewish Refugee Distress—Warm Tributes to Memory of David Wolffsohn—Some Stories—Further Honor for Sir Matthew Nathan—New Synagogues in Wartime—A Letter from Palestine.

London, Sept. 25, 1914.

The eighth week of war is now finishing, and so far as England is concerned the news from the front is satisfactory. There appears to be very little falling off in the flood of new recruits, and from London and other parts of the country comes further news of Jewish participation in the enlistments. A large number of Manchester Jews have enlisted since the beginning of the war. The classification is not quite complete, but I am informed that about 500 men have joined the regular and territorial services. The majority of these have gone to Lord Kitchener's army. New Year's Day services at the synagogues were attended by the newly enlisted men who have not yet left Manchester.

A detachment of about 110 Jewish soldiers, drawn from different training centers, went to Leeds in full uniform on furlough for the celebration of the New Year. The men marched to the Belgrave Synagogue in charge of Corporal S. Goldstein, of the Third Battalion, Yorkshire regiment, where service was conducted by the Rev. M. Abrahams, who is the Jewish chaplain of the Northern command. After the service the men marched to the Jewish Institute, led by the rabbi, and were entertained by A. Feldman, president of the synagogue, and president of the Leeds Jewish Board of Guardians. The Jewish recruiting officer, L. Rosenberg, who was in attendance, took a number of names of recruits for the Seventh and Eighth battalions, Leeds Rifles.

Information is now coming to hand with regard to Jewish casualties in the war. Lieutenant Ronald Lucas Quixano Henriques was killed in action at the beginning of the great battle of the Aisne, which has now lasted well on into its second week. Educated at Harrow, he passed on to Sandhurst for his military training, and was gazetted to his regiment in 1903, becoming lieutenant in 1907. He left for the front upon his return from South Africa on the 12th of August in the best of spirits. Mrs. Henriques received a telegram from the War Office on September 17 announcing that he had been killed in action on September 14, while a few days later she received a postcard, dated September 11, from Lieutenant Henriques. In it he said he "expected to go into action any moment, and that he was just longing to go." He added that his men were as keen as he himself was. Very scanty news, however, was received from Mr. Henriques after he left for the front, but it would appear that he took part in the now famous retirement of the British troops and met his death during their successful advance which succeeded it. Mr. Henriques was the author of a small manual on signaling, which has been used extensively in the army. He also passed well in musketry and mounted infantry courses, passing out second on the list from the famous Hythe Musketry

School with distinction. He was a keen sportsman.

Other casualties include Trooper J. Fierman of the Ninth Royal Lancers, killed in action, while the wounded list includes the names of Lieutenant E. J. Wyler of the Royal Army Medical Corps and son of Julius J. Wyler, of the London Stock Exchange; Corporal H. Norman of the Fourth Middlesex, Lance Corporal E. Phillips of the First Dorsetshire, Private M. Phillips of the First Duke of Cornwall's Light Infantry, and Private B. Silver, Second Kings Royal Rifles, while Pioneer W. Moses of the Royal Engineers is among the missing.

I made some reference last week to the excellent work that is being done by the community in general and by individual Jews in particular in the way of relieving the Jewish refugee distress. The latest news in this direction is that the London Lodge of the Independent Order of B'nai Brith, of which August Kahn, H. M. L. is president, has established in the northwestern district of London a hostel for a number of Jewish war refugees. Accommodation is provided for between thirty and forty persons, and those already in residence hail from various parts of the war area, including Paris, Liege, Louvain, Ghent and Antwerp. Among the party are a number of university students. The hostel was established at short notice in order to provide accommodation for some of the better class of those being housed by the Jews' Temporary Shelter, the magnificent work of which is recognized on all hands. The house was only taken on September 16 and the inmates were received on September 20, the eve of New Year. The house has been lent rent free by Dr. Baker, a Christian gentleman, whose generosity is very much appreciated. Besides the work of members of the lodge and their friends several Christian residents in the neighborhood have given kindly help, and public-spirited assistance has been rendered by several local storekeepers. An English class has been established for the residents and arrangements are being made whereby the children may attend school in the neighborhood.

Many warm tributes have been paid in this country to the memory of David Wolffsohn, who died in Germany last week. Everyone agrees that the loss of so fine a man will be widely felt. One friend of his recalling his devotion to Herzl said that when he received the news of the death of the great Zionist chief he broke down and wept like a child and his subsequent years were a decade of sorrow. It was Wolffsohn's intention to write his memoirs and they would have been of exceedingly great interest, but death overtook him. Arrangements, however, will be made to publish a memoir based upon copious notes of conversations with him made by Dr. Robinson. Further, his extensive correspondence exists and this also will be taken advantage of.

Wolffsohn was always very popular in England and had a strong regard for things English. He had a good knowledge of the English language. Many stories have been recalled here of his kindly nature. One is told in connection with a visit he paid to this country about Christmas time at which period some of the central London thoroughfares are lined on both sides with rows of hawkers in the gutter vending cheap toys, usually, in fact, at 2 cents apiece. After a journey out on this particular morning Wolffsohn entered the offices of the Jewish Colonial Trust with his arms full of 2-cent toys and his eyes with tears. "Whatever have you been buying those for?" a colleague asked him. And he explained that he had seen the hawkers standing in Cheapside, and the memories of his early days had surged up within him so that he could not leave the thoroughfare without making a purchase from every single vendor.

It is reported here that the Turkish Government has requested the Haham Bashi of Turkey to proceed to election of Chief Rabbi of Jerusalem in place of Rabbi Franco, who resigned owing to his advanced age. The ex-Chief Rabbi of Salonika (Rabbi Jacob Meir), is said to be future Rishon le Zion.

When Sir James Dougherty retires from his appointment in connection with the office of Lord Lieutenant of Ireland, Sir Matthew Nathan, now chairman of the Board of Inland Revenue, and one of our most prominent Jewish citizens, will take his place.

Despite the war new synagogues are being opened in this country. The latest has just been established at Sheffield largely owing to the energy and generosity of a local member of the community. In this case an Anglican church has been converted to Jewish use.

The following is an extract from a letter just received from Palestine, dated Jaffa, August 25: "We hasten to send you word of the precarious condition of

things in Palestine. Jerusalem is panic-stricken, fears of an approaching enemy are entertained, and that enemy England of all people; but the Arabs are being embittered against us by the Arabic press, which is sold to the Germans. A military officer said only to-day that Germany has promised Turkey the restitution of Egypt and Salonika if she will give her support against England and Russia in the present hostilities. Cannons have been placed on David's Tower, and a watch tower put near Liftah, and rumors spread that the English are approaching by way of Gaza and Hebron! The cry of "The enemy is coming" may be heard in the streets. Banks and post offices refuse payment, commerce is at a standstill, food is enormously dear, supplies cannot come in without risk, and people are dying of hunger in Jaffa and Jerusalem. Some people are fleeing to Cyprus, hearing that Beirut is as dangerous as this neighborhood, for if a feeling against the English is fanned to a flame they fear the consequences which may ensue."

The Jewish Spectator of Memphis needs a good Jewish headline editor! In its new year's issue the following appeared *verbatim et literatim*: "Rosh Hashonah Begins Next Monday. Sunday Night Ushers in Series of Solemn Festivals." Truly, the Jewish editor-man is a child of impulse, a creature of the fitful wind, as it were.

In minor, miscellaneous ways even the war has its influence. Thus, the council of Jews' College, London, recently voted to postpone for a year the publication of an essay by Dr. H. Hirschfeld, and the awarding of scholarships for graduates to Oxford and Cambridge. And, of course, no public distribution of prizes is to take place this season. All of which is saddening to contemplate.

A word ought certainly be spared by us to express the hope of our readers and ourselves for the speedy restoration to complete health and activity of Professor Solomon Schechter, the head of the Jewish Theological Seminary. We were pained to read that the venerable scholar was compelled to submit to an operation for appendicitis, but were glad to learn that he is making satisfactory progress. We trust that his progress will be steady and continuous, and that he will be with us for many, many years in health undiminished and happiness undimmed.

From our property-clerk's department, which latterly, we are pleased to say it, has not been busily occupied with the duty of tracing "lifts" unaccredited to their rightful owners, the following information is supplied concerning an old, hardened and habitual offender of this canon of Jewish journalistic ethics. In the *Jewish Advocate*, of Boston, for September 25, the new year number of our contemporary, appears "The Jew," a story, by Achi Josef. This tale was first published in the columns of THE HEBREW STANDARD, but one could never tell this from the "reprint" the *Jewish Advocate* supplied! In it the only part missing was the rubric, "Reprinted from THE HEBREW STANDARD."

London Jewry have now in their East End an "oasis," so-called, which is quite on all fours with our Educational Alliance. We refer to the recently-opened Aldgate settlement house, which, utilized by and devoted to the activities of the community, nevertheless is held by its managers to stand for non-sectarian ideals. Here none disputes the contention that the Educational Alliance is, despite its colorless name, to all intents and purposes a Jewish institution, and that it is performing good Jewish work of a high order of usefulness. In due time, perhaps, London's new edifice will meet the same fate: the doubts and tribulations which existed at the inauguration of the enterprise will be succeeded by whole-hearted approval of the practical work and realized activity of the institution.

Rejoice in the Law! The great day of the Rejoicing of the Torah, which we know as *Simchas Torah*, will be here again next Tuesday. Let us observe it with gusto, with all our heart and with all our might. The Torah which God gave to Moses on Mount Sinai is the heritage of the House of Israel: Come, let us walk in the way of the Lord. These thoughts from the magnificent liturgy of the synagogue are not empty words and phrases. They betoken something real, very vital, to us. They speak of Israel's career in ages past, and of the mission of our people in this world of men. We must, therefore, seek to hold up for our lives God's Torah on all possible occasions, particularly on that solemn day of glad some rejoicing on which the Law, as given to Israel, is commemorated.

THE OPPORTUNE MOMENT

WE read in the daily newspapers reports that the present offers that opportune moment to negotiate a new treaty of commerce and navigation with Russia for which our government has been waiting since 1911. A peace treaty, in fact, was promulgated between these high contracting parties only a day or two ago. Without abating one jot or tittle of the views which we have consistently maintained on the subject under discussion in the past, we think that the United States may press home the present advantageous condition of affairs in the world, and secure such a treaty from the Czar's government as will be all that American Jews and all other sections of our cosmopolitan population can demand.

There is no doubt that the war has reshaped for the better Russia's official attitude towards the Jews. Whether or not we credit the reports that the Czar is about to emancipate, or, indeed, has already fully emancipated his Jewish subjects from their mediaeval disabilities, it remains a patent fact that the Russian Jew has taken up his loyal share of the task involved in the war in which his country is now engaged. Some of our co-religionists with the Russian colors have risen or will rise to high military rank, and it is surely to be anticipated that a land which owes so much to their valor and military prowess will be grateful to them and to their brethren-in-faith for the future.

Of necessity, every Jew knows Russia in the past—to his unending sorrow! This does not imply, however, that the cause of the Jew in that vast empire is hopeless or unchangeable for the future. If light appears where previously Cimmerian darkness prevailed, Jews everywhere, keenly interested in the welfare of the Russian Jew, must gladly hail the altered situation.

That our own government may take legitimate advantage of this new state of affairs goes without saying. That it will insist upon its original terms, viz., the due recognition by Russia of all American passports whether or not these are borne by our citizens of the Jewish faith, President Wilson's previous course in the exalted office he so ably and conscientiously administers affords a guarantee. At all events, in the absence of the definite news that a new treaty has been concluded, we pen these thoughts as indicative of what we believe is the sentiment of a large section of America's Jewry, wishing the best for their Russian fellows.

Commissioner of Health Sigismund S. Goldwater, having by his dog-muzzling order acted in a manner that all our citizens will approve, with the exception of that class which idolizes "sport" in ways both proper and devious, *Town Topics*, the representative organ of the "sporting" element in the community, must needs pursue its "time-honored" tactics in abusing him. Our contemporary writes Dr. Goldwater down as "one of those 'cranks' whose secret mania is cruelty to animals," and speaks of him as a "wastrel" and as "a soulless man" because he would crib, cabin and confine, forsooth, the soul of a dog. Does not *Town Topics* know that the human soul is of infinitely higher price than the soul of a dog, admitting for the sake of argument that the latter has such in the human acceptance of the term? Surely the lives of the pedestrians and of the numerous playing children in our streets are worth infinitely more than the avoidance of "pain" to pampered pets and dangerous playmates of the idle and irresponsible rich! For these *Town Topics*, no doubt, desires to be regarded as holding a brief, and we do not envy nor begrudge our contemporary its retainer. We, on our part, hold no brief for Dr. Goldwater, and write as we do, not because the commissioner is a Jew, but because he is a manly man, with good, red blood in his body, who seeks to protect the poor and the lowly, an even more important and certainly much more valuable portion of the inhabitants of New York than those whose special defense *Town Topics* has so "generously" undertaken!

One of the reasons why its contemporaries, ourselves included, now and again grow choleric in perusing the columns or discussing the attitude and editorial views of the *American Israelite* is because it finds room every little while for paragraphs like the following, which appeared in its issue of September 24:

If Judaism could free itself from racial restrictions it would gain adherents much more rapidly and widen its borders by leaps and bounds. Most of the nominal Christians of to-day are in reality monotheists, and were it not for the race obstacle they would find their way in rapidly increasing numbers into the synagogue. It is therefore to be hoped that, as time progresses, the racial separatism of the Jews will come to be less and less emphasized, and in common with all other religious denominations we will throw open our gates wide and welcome all good men and women into our fold, regardless of their racial origin.

This pernicious, destructive and pseudo-Jewish thought stands cheek by jowl almost with the following statement:

The social separation of Christians and Jews, which, on the whole, is increasing rather than decreasing, is more or less one of the forces that are preserving the Jews for Judaism.

It is writing of this sort, unguarded and frivolous, which robs the editorial utterances of the *American Israelite* of that respect to which they, as the expressions of a journal of the age and influence of our Cincinnati contemporary, should ordinarily be entitled. Let us, if we must, take up a position with respect to Jewish tradition and Jewish life that appeals to us as most valid, satisfying and logical of any that we may adopt, and then let us maintain our view soberly and consistently, with full knowledge of its implications and results,

BIDE A WEE!

כיום השמיני עזרת חתיה לכם:

"On the eighth day ye shall have a solemn assembly." (Num. xxix, 35.)

SH'MINI-ATZERESS—the Closing Festival—marks the end of a series of holy days during which the Jew rises to the heights of religious fervor. The derivation and meaning of the word *Atzeress* is somewhat obscure; the rabbis interpret it in the sense of "holding back," and they say that this holy day is so called because it is an invitation tendered by God to Israel to stay yet another day in His sacred court-yards. When, at the end of the long series of festivals Israel is about to depart from the Divine Host, God on this day tells His guest: "Bide a wee!"

If we accept this rabbinic interpretation, there is much more in this Bide-a-wee Festival than appears on the surface. There is a great deal in it of the sympathetic understanding of human nature. Man cannot stay at concert pitch for any length of time. The difficult thing about any effort is not to undertake it but to sustain it. We live and act largely by spurts and spasms. The diastole and systole of the heart are no more frequent than the alternate expansions and contractions of our nature. The receding and forward-leaping tide is repeated in theebb and flow of thought-waves. Only that the heart and the tide obey the laws which determine their movements, while man's nature often yields to whim and caprice, making for the fitfulness of the flame and the tempest in all his performances. No gust of wind is as incalculable as is man's spirit. Where whim and caprice do not enter into his work, the limitations of his finite constitution often cause an unlooked-for termination of his finest endeavors. Eternity never tires of pushing the breakers to and fro; and the infinite God is behind the millennial flight of the stars. But finite man soon flags the moment he lifts up his soul above the stars. The imagination of the poet who tries to touch the high peak of Infinity with the tip of his wings oft droops in midair. The ardor of the orator oft helps him through the first part of his speech, but fails to impell him onward to an irresistible peroration; and so what a wonderful promise of hearts brought under the sway of high resolve ends in yawning mouths and craning necks; the eloquent man spent his passion before it accomplished its purpose. All this because it is impossible for our mortal nature to breathe in for any length of time the rarified atmosphere of the heights.

In religious devotion the same inability to sustain our fervor disturbs the continuity of communion with God. Enthusiasm—if anywhere—has its dangers in the religious life. Enthusiasm in the Greek sense means the mighty inrush of the God into man's soul. Unfortunately, the God that rushes in, suddenly and impetuously, upon our lives, is a God that rushes out of our lives just as suddenly and impetuously. The comet that at very great intervals sallies forth on its blazing course bides with us a short while and then swiftly passes out of sight. Similarly our religious sentiments are not luminous stars steadily pursuing their course with all the forces of eternity behind them, but are like comets, rare visitors on our horizon, or like meteors whose very heat betokens a dead world falling into ruin.

That is exactly the case with most of us when the Fall holidays come. Suddenly we are raised on the crest of religious zeal, and suddenly we allow ourselves to be hurled into the trough. The rushing in and out of the God of Superstition is ludicrous to behold. Religion seems forgotten with the last Amen said at the Synagogue. The last day in the festive cycle brings with it the cessation of the God-passion, of the sense of the Infinite Presence. Therefore did God appoint the day of *Shemini Atzeress*. When man's religious enthusiasm is on the wane, and he is about to leave God behind, to forget all the sublimities, that for a few days had entered into his soul, it is then that God calls him back. It is then that a gentle arm is laid on him drawing him back. It is then that God's voice whispers to him with loving insistence: "Depart not yet for a day—bide a wee!"

It is the everlasting mercy of God that grants to man more opportunities for regeneration than to any other creature. Man can retrace his steps where no created thing can. If—as intimated above—physical nature is steadier and steadfaster than human nature, it is also true that the very waywardness of man is its own compensation. For by this very fickleness of his nature he is enabled to effect a reconstruction of his life, a return to those higher ideals from which he has strayed. If he is not steadfast in good, neither is he steadfast in evil, and he has it in him to go back to God when God calls him back. His doom is not sealed when he is on the point to depart from God. When the leaf is about to depart from the parent-stem, when the petal is about to fall from the mother-rose, perhaps the tree and the bush call out to the departing leaf and the leavetaking petal: "Bide a wee!" And perhaps leaf and petal would gladly stay—if only for a day! But can they? The blasts of Autumn have touched both parent and child chilling their ardor, and they know that their time has come to separate, and never again will the same leaf meet with the same bough, or the same petal blush on the same rose! But when man is about to separate from God, when he is on the point of leaving the source whence his soul derives its force and its fire, it is then that God, knowing that man and his Maker meet with each other in ever-renewed communion, lays His arm gently on His wayward child and softly persuades him: "Bide a wee!"

The Fannie Brice Case

Miss Fanny Brice, to whom we must by force of events recur, sends the following disclaimer for her advertisement which was so offensive to all observing Jews.

Editor HEBREW STANDARD:

Mr. E. F. Albee, general manager of the B. F. Keith circuit of theatres, has shown me his letter in reference to my advertisement in last Saturday's edition of the *New York Journal*. To say that I was mortified is but stating my feelings mildly. I was stunned. I assure you that though I paid for the advertisement I inserted I had absolutely nothing to do with the wording of it, that matter having been attended to by Mr. C. F. Zittell, the vaudeville manager of the paper which printed my advertisement. I am a Jewess and have every respect for my race and my religion, and while in the theatrical business it is customary to work on all holidays, both Christian and Jewish, I did not work on Yom Kippur.

I sincerely trust that if you give publicity to Mr. Albee's statements you will accord me the same privilege and publish this letter in your columns in order that those of my own religious views may learn that I had nothing whatever to do with the wording of the advertisement, and that I am sincerely sorry that I have been made the subject of Mr. Zittell's mistake.

With the publication of Miss Brice's letter we had intended to close the matter and had so informed that lady, but subsequent developments have led us to reopen the case and present the following facts to our readers:

That Miss Brice did not appear on Yom Kippur is quite true, but we learn from a vaudeville actor that in

all likelihood her contract contained no clause exempting her from work on that day. We did read in the current number of *Variety* that "Fannie Brice left the Palace Theatre programme with the initial Monday matinee performance "after a cold grabbed her!" *Variety*, also, informs the world that she was "forced to cancel because of illness." Our readers will recall that General Manager Albee, for the Keith management, wrote in no uncertain manner that the offending advertisement was inspired by and the work of C. F. Zittell, who writes on matters vaudeville for the *New York Evening Journal* under the nom-de-plume of "Zit." "Zit" in his weekly vaudeville review writes that "Fannie Brice's advertisement last Saturday should have read, will appear at Palace every afternoon and eve., EXCLUDING Yom Yippur." Then, in his "Chart," he tells us, "Poor Fannie Brice's voice was in such a condition she could hardly talk." And then, he headlines, "Loss of Voice Hit Vaudeville Hard This Week." We give our readers all the facts, including all the foregoing references to printed statements, for what these are worth.

Follows the sequel! In the *New York Review* appears an article in which we are informed that Fannie Brice is much distressed over her offending advertisement, and that "Zit" is the "malefactor," as it were, who was responsible for the mistake that occurred. "Zit," to do him credit, is not behindhand with his excuses; "excluding" in the copy be-

came "and" in the advertisement, occasioning all the trouble, because, to quote the *New York Review*, again, "It is only fair to Zittell to say that he was in no way responsible for the typographical error which caused all the trouble. It was the mistake of a compositor who got the words mixed." Thus the fox is run to earth, and a poor compositor found who, nameless and "fameless," must be prepared to shoulder the blame!

We wonder how this poor compositor made the word "excluding" read "and," and we wonder how the proof-reader, with the assistance of his copy-holder, allowed the error to get by the proof room. Surely the *Evening Journal* should administer a severe rebuke to such a slipshod typesetter, proof-reader and copy-holder.

Of Course; Why Not?

Much ado is made about the tremendous crowd that filled and was turned away from Carnegie Hall a few days ago, in which exercises—not services—were held by the so-called Free Synagogue.

It was announced that Secretary Bryan would deliver an address. The admission was free. Is it a wonder? When on tour, on the Chautauqua circuit, Mr. Bryan receives a substantial sum for his talks, or lectures, and people crowd in at the rate of fifty cents to a dollar to hear him.

If Mr. Bryan would deliver a lecture at Madison Square Garden, without charging an admission fee, ten thousand people or more would fill the auditorium, and thousands would be turned away, for Mr. Bryan is a public character, and of great note, having been a candidate for the Presidency thrice, and is now Secretary of State of the greatest country in the world; above all, he is a felicitous speaker, and an orator of recognized ability.

forum, and the occupant of the stage is merely a well equipped orator.

Many of those who are held lightly by ties to our religious faith have been detached from its religious houses of worship, and attached to a fad—called a free synagogue.

These free synagogues will, if successful, be apt to do as much injury to the Jewish synagogues and true houses of worship as the "United Cigar Stores" did to the small prosperous cigar dealers whom they ruined in their aggrandizement, by many methods, and notably by hiring stores over the heads of the occupants.

The term "free synagogue" is a sham. There is no such thing. It takes money, yes, real money, to support it just as it takes money to maintain the Jewish synagogue and temple, and the Lyceum innovation cannot live on air, nor can its head and foot.

The City Lad in the Country.

One day the lad visited his uncle, the farmer, in the country. He was delighted with the charming view afforded by many acres of beautiful green fields surrounding his uncle's home. "How happy are the farmers," thought he; "this is so much better than city life." And every day he would be glad to roam through the fields and delight his eyes with the riches of nature. Sowing time had come. His uncle took the plowshare and turned the green field into the most confused mass of earth he had ever seen. The lad was very angry. "What a fool my uncle is!" thought he. On the following day his uncle cut up the field in even a worse manner than the day previous. He began to hate his uncle for persisting in his folly. On the third day he saw his uncle take some pronged instrument and smooth the earth with it, making it all nice and even. "Well, my uncle is right after all," thought the lad. On the following day he saw his uncle take a bag full of grain and spread it upon the entire field. Again the lad thought that his uncle had taken leave of his senses. Three days after that he visited the field and saw little red and green spots sprouting up all over the field, giving it the appearance of a rainbow. "My uncle is a wise man," thought the lad. After this he visited the field daily, and his wonderment increased with the growth of the stalks of wheat as they waved to and fro in the wind like the waves of the ocean. "My uncle is a very wise man," thought he. One day he saw his uncle take a scythe, cut off the stalks, then take a stick and beat them—the ancient method of threshing. The lad was disgusted and thought: "Now I can see that what I thought at first is true—my uncle is a fool and does not know what he is doing." He then saw his uncle take a sieve, put the straw in and winnow it against the wind, and, behold! the wheat was separated from the chaff, and there was almost seven times more of it than when he first threw the grain on the ground. Then the lad perceived that he was the one that lacked understanding—not his uncle. He came to this conclusion because he witnessed the plowing, the planting, the reaping, the threshing and the winnowing. However, if he would have left his uncle in the midst of the process he would have been under the impression that his uncle had no sense in doing what he had done.

The comparison is this—we are all molded of clay, resembling the city lad. Everything is hidden from our view; we do not know what took place before we came into being and what will transpire after we will pass away. All we behold is a disconnected fragment of the seventy years of a man's life, and yet we are judging according to our sight and wondering at the works of the Lord! If we had but lived all the years of the universe then would we have known everything; that the ways of the Lord are just. Not so the fools. Of them does King David, peace unto him, say: "They do not understand the ways of the Lord; he destroys them." In this light we can understand the verse we have taken for our text: "The fool says in his heart, 'The Eternal hath forgotten; he hath hidden his face; and that is because 'he hath not seen the eternity.' If he would have seen the eternity, all the years of the world's existence from beginning to end, then he would know that the ways of the Lord are upright.

My brothers, I have taken this text today in order that the men who enter into a city that is new to them and wish to make laws according to their own shortsightedness should know that this is not a wise thing to do, as such methods turn the wise into fools and fools into wise men ("May He grant wisdom to the wise that he may become yet wiser.")

Russia's Jewish Soldiers.

I read with great pleasure Lieutenant-Colonel Roustam Bek's article in Thursday's *Daily Express* dealing with the promise of equality of rights to Jews in the Russian army. It was the more gratifying to hear such opinions from a Russian cavalry officer, who during his military career came into direct contact with hundreds of Jewish soldiers.

I should like to impress on Englishmen the great significance of this unexpected grant of all economic and political rights to Russian Jews.

Hitherto Russia has been the only country in the world where the Jew has been deprived of all the rights of citizenship. At present, he cannot reside in the most important Russian towns and districts, and only 10 per cent. of Jews can attend the government schools and 3 per cent. the colleges. Under no circumstances can a Jew obtain a government position of any kind.

Yet every Jew is forced to serve for three years and eight months in the Russian army and to risk his life in time of war. He cannot hope for promotion, and has suffered much ill-treatment at the hands of ignorant "feld-felbs," who are promoted over his head because they are Christians. These feld-felbs also envy the Jew for his superior education, and take revenge by drilling him in inhuman fashion.

In the reign of the Czar Nicholas I the soldiers hunted young Jews, whom they caught in thousands, and, after christening them, forced them to join the army for the unheard-of period of twenty-five years. At the end of that time they were dismissed from the army and turned into the streets. Yet, during the wars in which they took part, they often proved themselves heroes.

It is a fact that during the Crimean War an unexploded bomb fell into an entrenchment in the midst of a group of Russian officers and soldiers. Every one fled in fear except a young Jewish soldier, who calmly picked up the missile and threw it back among the enemy, causing them great damage. There are many such instances of Jewish heroism on record.

Every Russian-born Jew loves his birthplace, and always speaks well of Russia wherever he may be, yet he has always been considered an enemy of the Russian government and refused all rights.

Now all is to be different! His rights will be restored, and he will now give his last drop of blood to his country, which is fighting this holy war. He will give more. He will give his intelligence, his education, his wit, his wealth, and the Russian Jews will have the support of all other Jews in the world.

The Czar's promise to restore Jewish rights has had a good effect immediately, many of the successes of the Russian army having been due to the good strategic knowledge of the Polish Jews living on the Austro-Russian and the German-Russian frontiers. They have willingly given all the necessary information to the Czar's army, and often at the peril of their lives have guided the Russians through strategic positions of whose existence even the enemy were unaware.

As a Jew, and one who has served in the Russian army, I have the right to make the following statement:

The restitution of all rights to Russian and Polish Jews is the most important link in the chain of Russian victories, and the ill-feeling of Jews toward Russia has died out with this historic ukase of the Czar.—London (Eng.) Express.

B. Altman & Co.'s Enlarged Store.

The new twelve-story addition to B. Altman & Co.'s store was opened to the public Monday, October 5. With the erection of this addition, the frontage of which is on Madison avenue, New York city, the store becomes one of the largest in the world, occupying an entire block and having a floor area of nearly 1,000,000 square feet. On each side of the store is a spacious entrance, those fronting on Madison avenue and on Thirty-fifth street being especially designed for motor and carriage approach, each having a marquee extending over the sidewalk to the curb.

The Altman store is easily one of the handsomest edifices in New York, following in detail throughout the dignified style of architecture distinctive of the Italian renaissance. Like the original building, the new addition is constructed of French limestone (imported direct from the quarries for the purpose) up to and including the eighth floor, except on the Madison avenue side. Here the central elevation, above the second floor, is of white glazed brick, the corner pavilions at each side being of French limestone to the eighth floor. The four floors above are built entirely of white brick. The great display windows which grace the corners facing Madison avenue and Thirty-fourth and Thirty-fifth streets add a new feature of interest to that historic section of the city, so long exclusive to aristocratic residences.

in the Madison avenue addition. The writing and rest room is sumptuously furnished, the upholsteries being of blue velvet, harmonizing with a carpet of the same rich tone. The panelings and furniture are all of mahogany. Within easy reach of this room are the general offices, the information bureau and the public telephone booths. The executive offices, consisting of the president's room, the board room and an anteroom, are also located on the fifth floor. The walls of these rooms are covered with the same French carved woodwork that adorned the interiors of three of the most beautiful rooms in the late Mr. Altman's residence on Fifth avenue—the library, the dining room and the famous renaissance room.

The entire twelfth floor of the new addition has been given over to the use of B. Altman & Co.'s employees. It is finished throughout in white, with tiled walls and flooring. Large, airy luncheon rooms are provided for men and women employees, the two sections being separated by a cafeteria. Adjoining the luncheon rooms is a spacious modern kitchen, where wholesome food is palatably prepared, to be served at minimum prices. On this floor, too, are the medical offices, a large, specially constructed suite consisting of patients' waiting room, physician's consulting room, surgery and two hospital wards for men and women, with a total of seven beds. A physician, assisted by two graduate nurses, is in charge of this department, the expense of which is borne wholly by the firm.

The welfare work among the employees of B. Altman & Co. is of the broadest and most humanitarian type, following out the plans outlined by the late Benjamin Altman and carried out on an even larger scale by the present president of the firm. For the women and girls em-



To celebrate the opening of the addition in an auspicious manner, immense stocks of new merchandise have been secured, a large proportion consisting of recent importations from the fashion centres of Europe. The president of B. Altman & Co., Michael Friedsam, desires to impress upon the public the fact that the policies of the house remain unchanged. To contribute in every possible way to the comfort and convenience of its patrons, to assure them of courteous attention, and to offer them reliable merchandise at moderate prices is still the chief aim of this old established firm.

The increase of its original floor area by considerably more than 50 per cent. has rendered possible the extension of every department, with incomparably better facilities for the transaction of business. The department for men's wear, for example, has been so materially enlarged that it now extends nearly the entire length of the first floor on the Thirty-fourth street side. From the first floor to the fifth, inclusive, each floor is open across its entire length and width, from Fifth avenue to Madison avenue and from Thirty-fourth street to Thirty-fifth street. Above, the floors are arranged differently, to accommodate the various workrooms, stockrooms, the mail order department, etc.

A handsome suite of retiring rooms for women patrons is on the fifth floor

ployed in the building there is a pleasant recreation room on the eleventh floor, cosily furnished and liberally supplied with books and magazines. A portion of the roof has also been inclosed in order to provide a quiet rest room for women and a smoking room for men employees, the remainder being subdivided into a solarium and an open-air promenade.

In the sub-basement is the complicated machinery which supplies the Altman building with light, heat, ventilation and motor power, and which controls the immense refrigerating plant. The great engines have an aggregate capacity of 3,600 horse-power; the ten boilers a capacity of 3,000 horse-power, with a steam pressure of 160 pounds to the square inch. The coal bunkers are capable of containing 2,000 tons.

One important result of the enlargement of the building is the increased efficiency of the elevator service. There are now twenty-two elevators for the use of the patrons of the store, in addition to five small private elevators, ten elevators for employees' use and two truck elevators of immense size and capacity, making a total of thirty-nine, all of modern type.

The fire-preventing and fire-fighting equipments are among the most complete in existence, including the new automatic sprinkler and signal systems, the latter connecting with the city fire department as well as the firm's own fire department, located in the building; a standpipe system having hose stations so arranged as to reach any part of the establishment, and a supervisory system which acts automatically in the event of difficulty arising in any part of the equipment.

The architects for the Altman building are Trowbridge & Livingston. The construction work has been done by Marc Eldlitz & Son.

The runner-up as a feature is Ruth Royce, the prairie girl, who sang herself into fame at the Palace during the early summer. Joe Welch offers his new monologue, which is crowded with laughs. Mr. and Mrs. Jimmie Barry present their farce comedy, "The Rube," which is one of the real vaudeville hits of the year. Those astounding twins, the Rigoletto Brothers, reveal protean gifts in feats of dexterity, strength and artistic endeavor. They are the most versatile pair living, and that they can follow Schaffer proves their merit. Franklyn Ardell and company present "The Suffragette," and W. C. He would be fiery with indignation at the great insult offered to him, but in reality it is so while it is true that Titus and Nebucadnezzar both destroyed the Holy Temple, still they only destroyed the buildings alone, but they could not injure the Holy Temples which are in heaven, of which those on earth were the counterpart, but it was our sins which corrupted the very temples that were in heaven that gave them the power to destroy their counterparts on earth. Therefore the sages have taught us that the Holy One, blessed be He, created the world by virtue of ten utterances in order that we may see how the evil gradually develops, hardly existing in creation of the first utterance and revealing itself more and more in every creation of the other utterances until it reaches absolute materialism where evil is entirely revealed.

AMENDMENT NUMBER TWO Concurrent Resolution of the Senate and Assembly proposing an amendment to section four of article seven of the constitution, permitting the legislature to alter the rate of interest upon debts authorized pursuant to said constitution. Section 1. Resolved (if the Assembly concur), That section four of article seven of the constitution be amended so as to read as follows: Section 4. Except the debts specified in sections two and three of this article, no debts shall be hereafter contracted by or in behalf of this state unless such debt shall be authorized by law, for some single work or object to be distinctly specified therein; and such law shall impose and provide for the collection of a direct annual tax to pay, and sufficient to pay the interest on such debt as it falls due, and also to pay and discharge the principal of such debt within five years from the time of the contracting thereof. No such law shall take effect until it shall, at a general election, have been submitted to the people, and have received a majority of all the votes cast for and against it at such election. On the final passage of this bill, the other house of the legislature, the question shall be taken by yeas and nays, to be duly entered on the journals of the Senate, shall be: "Shall this bill pass, and ought the same to receive the sanction of the people?" The legislature may at any time after the passage of such law by the people, if no debt shall have been contracted in pursuance thereof, repeal the same; but no law shall be enacted which shall repeal the contracting of any further debt or liability under such law; but the tax imposed by such act, in proportion to the debt and liability which may have been contracted in pursuance of such law, shall remain in force and be irrevocable, and shall be annually collected, until the proceeds thereof shall have made the provision hereinbefore specified to pay and discharge the interest and principal of such debt and liability. The money arising from any loan or stock creating such debt or liability shall be applied to the work or object specified in the law authorizing such debt or liability, or for the payment of such debt or liability, and for no other purpose whatever. No such law shall be submitted to be voted on within three months after its passage or at any general election when any other law or any bill shall be submitted to be voted for or against. The legislature may provide for the issue of bonds of the state to run for a period not exceeding fifty years in lieu of bonds heretofore authorized but not issued and shall impose and provide for the collection of a direct annual tax for the payment of the same as hereinbefore required. When any sinking fund created under this section shall equal in amount the debt for which it was created, no further direct tax shall be levied on account of said sinking fund, and the legislature shall reduce the tax to an amount equal to the accruing interest on such debt. The legislature may from time to time alter the rate of interest to be paid upon any state debt, which has been or may be authorized pursuant to the provisions of this section, or upon any part of such debt, provided, however, that the rate of interest shall not be altered upon any part of such debt or upon any bond or other evidence thereof, which has been, or shall be, created or issued before such alteration. In case the legislature increases the rate of interest upon any such debt, or part thereof, it shall impose and provide for the collection of a direct annual tax to pay and sufficient to pay the increased or altered interest on such debt as it falls due and also to pay and discharge the principal of such debt within five years from the time of the contracting thereof, and shall appropriate annually to the sinking fund moneys in amount sufficient to pay such interest and pay and discharge the principal of such debt when it shall become due and payable.
