I. EDWIN GOLDWASSER

At a recent meeting of the Board of Education Mr. I. He has also been a principal of Evening High School and lecturer for the Board of Education. Mr. Goldwasser is the author of "Method and Methods in the Teaching of English," a text book for teachers, and has also contributed articles to leading educational publications. Outside the school system Mr. Goldwasser is known as vice-president of the Young Men's Hebrew Association, is a member of the Board of Managers of the Jewish Protectorate at Hawthorne and chief of the Board of Experts of the National Council. of a thesis on a certain Talmudic subject. This involved not only a keen knowledge of the literature of the Talmud but a more than ordinary comprehension of the meaning of the symbolic figures employed by the Prophets and Sages. One morning Rob Shimon entered a certain small room behind the Yeshibah which was being left in total disuse, and what was his surprise to see on the table a sheet of paper, very neatly written up in a handwriting which was perfectly strange to him. Meeting of the New York Board of Jewish Ministers.

The first meeting of the New York Board of Jewish Ministers, after the summer vacation, was held at Temple Emanu-El on Thursday, October 15, and was largely attended. Dr. Rudolph Grossman, the chairman, presided.

Dr. M. Hyamson and Rabbi S. J. Levinson were welcomed as new members and responded briefly.

The special topic discussed was the movement for reaching the students in the universities and colleges of New York for real religious work. The report from the Committee on Conference with Student Bodies was received, showing that a mass meeting of the students is to be held later in the season, and that the members of the board are already co-operating with the Menorah Society of the College of the City of New York in their programme for lectures, study circles, etc.

Every member of the board manifested great eagerness to help wherever and whenever he could, and all agreed to be present at the mass meeting when held.

The announcement was made that the board had been incorporated the better to handle funds entrusted to it. The chair appealed to the members to assist him in increasing the Chaplain Fund, which is altogether inadequate for the demands made upon it. Reports of Chaplains Blum and Tintner were presented, showing how actively the work had gone on, even during the summer.

The Committee on Publication was instructed to secure, edit and publish papers read before the board, and it was announced that a paper on "Criminology in Jewish Literature" would be presented by Dr. Pool at an early date.

Jewish Institute.

The Society of the Jewish Institute is now occupied with preparations for its educational work for the new season. The Sunday morning lectures on Jewish literature and ethics at Kessler's Second Avenue Theatre will be resumed on Sunday morning, November 8. Leading Jewish scholars and teachers will take part in this series.

Beginning on November 12 the class in Jewish history will resume its meetings, at the headquarters of the society, 108 Second avenue. Plans are also being made for a series of Sunday afternoon meetings for the young people of the Second avenue neighborhood, at large auditoriums in this section.

The first meeting of the Social Circle of the society, of which Mr. Morris Margulies is chairman, was held at the headquarters last Thursday evening. Preliminary steps were taken for the holding of a large social affair during the coming winter season.

A meeting of the Discussion Club will soon be held, and will be addressed by several speakers, who will deal with various phases of the present Jewish situation in Europe.

Young Judaea Notes.

The Young Judaea organization of Philadelphia has completed permanent organization, under the presidency of Rabbi Samuel Fredman.

The Young Zionists of Brooklyn gave a successful Hebrew dramatic performance at the Novelty Theatre of Williamsburg on Wednesday evening, October 7.

given under experts in the national interpretation of Jewish history, in the philosophy and history of Zionism, in club leadership, in organization, in public speaking and psychology. Classes in New York are being opened at the Young Men's Hebrew Association of The Bronx, the Uptown Talmud Torah, and at the Educational Alliance. In co-operation with Young Judaea, Hadasah is opening a similar group at the Young Women's Hebrew Association. Other groups will be established at Newark, Philadelphia, Baltimore and Boston.

"The Syllabus and Course of Study for Young Judaea Circles" is in press and will appear within a fortnight. Detailed courses of study, particularly adapted for club programmes, are outlined in Jewish history and literature, Zionism, public speaking, music, etc.

The Emanu-El Brotherhood.

Under the auspices of the Wage Earners' Theatre League there was held at the Social House on Sunday evening, Oct. 18, the first of a series of lectures. On this occasion Mr. Elmer L. Reizenstein, the author of the play, "On Trial," spoke on "The Theatre as a Forum." Following the lecture there was a general discussion. Similar lectures along these lines will shortly be announced. Commissioners Adamson, Featherston and Murphy of the various city departments, have consented to speak at the Open Forums which are to be held at the Social House on Sunday evenings during the month of November. The public is invited to attend all of these lectures.

In addition to the numerous efforts on behalf of Jewish students made by Duma deputies, including the president

of the House, M. Rodzianko, and by various deputations, the Institute of Forestry has also joined in the chorus clamoring for the admission of Jews into educational institutions above the norm. So far, the appeal of the Moscow female medical courses has alone been rejected.

Items of Interest In the Jewish World

Adophe Wolfe has been elected secretary of the Oregon Social Hygiene Society.

Students of the University of Omaha (Neb.) have established a Menorah society.

A ladies auxiliary has been organized to assist the Mt. Sinai Hospital, Philadelphia, Pa.

At Lodz 150 Jews have formed a cyclist company, and offered their services to the Russian army.

Mr. Bernard L. Cohan has been made business manager of the Memphis (Tenn.) News-Scimitar.

New hospital quarters at the B'nai B'rith Home at Tonkers, N. Y., were formally opened last week.

A Jewish social club to be known as the "Elysium Club" was organized at Trenton, N. J., last week.

Fifty boys, pupils of the Barnert Memorial Temple of Paterson, N. J., have formed a military corps.

A manual training building is being completed in connection with the Philadelphia (Pa.) Hebrew Orphan's Home.

The Y. M. H. A. of Passaic, N. J., is expected to establish quarters in the new Hebrew Institute building there.

The Union of American Hebrew Congregations reports the recent organization of a congregation in Rockford, Ill.

Shoshannah Chapter, Daughters of Zion, of Cleveland, Ohio, will hereafter be known as Cleveland Chapter Hadasah.

Young Cleveland (O.) Jews and Jewesses have organized a literary and social club to be known as the Assoraho Club.

The new building of the Northern Free Loan Association of Philadelphia, Pa., was dedicated last Sunday afternoon.

Signor Luzzatti, the ex-Premier, is conducting a press campaign in Italy in favor of the emancipation of the Russian Jews.

A Young Women's Hebrew Association was successfully launched at Camden, N. J., last week with sixty-five members to begin with.

During the past year over \$40,000 was disbursed by the Detroit (Mich.) United Jewish Charities. More than 1,000 families were aided.

A number of rabbis were participants in the official tercentenary celebration of the founding of New York city last Sunday, at the Hippodrome.

Owing to the growing work of the Jewish People's Institute, at Boston, Mass., it has been arranged to build a larger and better fitted building.

The death has been recorded of Mr. D. Ansell, who has been long and prominently identified with the Jewish communal life of Montreal, Canada.

The French Socialist leader, M. Herve, in praising the loyalty of the Jews in France, has also expressed the hope that the Russian Jews will receive their freedom.

The newly created Young Men's Hebrew Association, of Wheeling, W. Va., starts out with a charter membership of 50 and hopes soon to have 200 enrolled.

During the past year there were 100 students enrolled at the National Farm School, Farm School, Pa. Cash sales of products raised on the farm amounted to \$12,000.

The Federated Jewish Charities of Baltimore, Md., will soon have their own organ. It is to be called "The Helping Hand," and will be issued monthly.

Articles of incorporation have been filed with the Secretary of State by the Jewish Society of Coney Island, N. Y., which has been organized for general relief work.

The Tsadick of Ostrovtz and the leading Jews of Novoradomsk have been assured by the authorities that they will suppress the local Polish anti-Semitic agitation.

Under the will of the late William Joseph, the United Hebrew Charities, the Hebrew Orphan Asylum, the Montefiore Home and the Mt. Sinai Hospital, of New York city, each receive \$1,500.

Annual Meeting of United Hebrew Charities.

The fortieth annual meeting of the United Hebrew Charities was held in Temple Emanu-El last (Thursday) evening. This meeting was to have been a fortieth anniversary celebration, but the festive character of the occasion was abandoned when the European war began.

The report of the trustees, consisting of a retrospect of the work done during the past forty years, shows that the society not only looked after the needs of the Jewish poor of this city, but has been prominently identified with many of the larger movements undertaken to promote social welfare and has been directly responsible for the creation of a number of charitable institutions, such as hospitals, vocational schools and convalescent homes.

With reference to the past year, they reported that they have continued energetically with the activities in which they have engaged, making as satisfactory progress as circumstances permitted. Early in the year an increase in the demands for relief became perceptible; particularly was this increase noticeable in the number of families applying who had never before been known to the organization. The financial and commercial depression which has prevailed for the past few years began to show its effect; unemployment and irregular employment had begun to exhaust the resources of the working people and community aid had to be sought. Their statistical tables show that whereas during the year 1912-1913 2,466 new families were reported in distress, this year the number was 3,294, an increase of 33 per cent. A careful analysis of the causes which brought these families to their door shows that unemployment was responsible in 735 cases during the past year, as compared with 384 during the previous year, an increase of nearly 100 per cent. Moreover, the hard times necessarily affected the families already under their care. In many cases the wage-earning members of those families suffered loss of employment. It was the first time since 1908, after the panic year, that there was an increase in the number of applications. These conditions made it necessary for the society to augment its relief disbursements as well as provisions for administration, in order effectively to carry on the increased work. It is with regret they must report that, carefully as they administered their funds, they fell short by \$30,300 of the amount necessary to supply the needs of the poor.

The trustees also report "that the outlook for the current year is anything but encouraging. There has been a considerable reduction in the membership list and in donations, and so long as the war continues, the demands for aid are likely to increase day by day. It is impossible at this time to foretell to what extent the resources of the society will be taxed, but overtaxed they surely will be and to a degree, we fear, far beyond last year unless the community gives more generously. To provide against an extraordinary deficiency, the society has already retrenched in every possible way consistent with efficiency."

To Aid the War Sufferers.
A conference of representatives of over fifty different organizations was held at Temple Emanu-El last Sunday afternoon under the auspices of the American Jewish Committee. Louis Marshall was elected chairman, Mr. Cyrus L. Sulzberger secretary and Felix M. Warburg treasurer. A resolution was adopted authorizing the chairman to appoint a committee of five with power to select a national committee of one hundred, on which every Jewish national organization invited to the conference is to be represented by at least one member. The committee of one hundred is to elect from its members an executive committee of twenty-five. Chairman Marshall named as the committee of five Oscar S. Straus, Judge Julian W. Mack, of Chicago; Louis D. Brandeis, of Boston; Henry Fischel and Meyer London, of New York. Chairman Marshall issued a statement after the conference, in which he said: "Representatives of the leading national Jewish organizations and of the important Jewish communities of America have formed a general committee for the relief of the Jews of the several European nations and of Palestine who now or may hereafter require aid in direct or in indirect consequences of the war. All Jews of every shade of thought, irrespective of the land of their birth, are solemnly admonished to contribute with the utmost generosity to this fund which must be gathered to meet this superlative need. The committee recognizes the economic distress which now bears heavily on all. That only emphasizes the obligation of making sacrifices and ennobles every gift the more. "The fund collected is to be administered through such agencies as shall in the judgment of the committee best accomplish an effective and equitable distribution among those individuals and institutions which it is sought to help without waste or unjust discrimination. So far as it shall prove practicable, the committee also proposes to receive and transmit funds from private individuals to their relatives abroad."

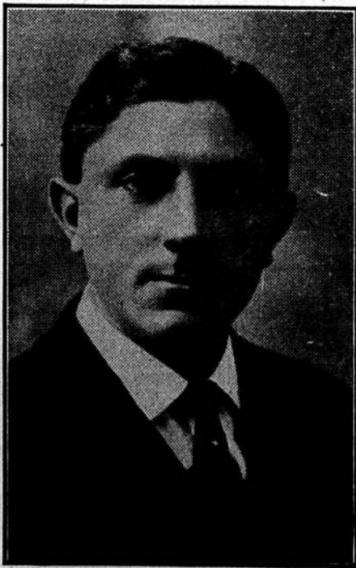

Ireland's New Under Secretary.

"For the first time in the history of Erin a professing Jew is about to be appointed as Under Secretary for Ireland, that is to say to the post of permanent chief of the government administration in Ireland, since he does not retire along with the Viceroy and Chief Secretary for Ireland on the fall of the Cabinet, but retains office until he receives promotion or attains the age limit," says the Marquis de Fontenoy in the New York Evening Sun. Continuing further the Marquis says:

"The new Under Secretary is Col. Sir Matthew Nathan who, for the past three years has been at the head of the Inland Revenue Department and who has been in turn Governor of the Gold Coast, Governor of Hong Kong, Governor of Natal and secretary; that is to say, head of the permanent department of the general postoffice. Before that Sir Matthew won distinction as a soldier, and as an officer of Royal Engineers took part in the Nile expedition of 1885 under Lord Wolsley and also in the Lushal expedition. He is indebted for the handle to his name to his possession of the Grand Cross of the order of St. Michael and St. George.

"Sir Matthew won considerable fame while Governor of Natal by his clever diplomacy in suppressing disturbances among the Zulus, disturbances which but for him would have developed into a full fledged rebellion. He comes from a rather remarkable family. For his brother, Sir Frederick Nathan, after serving as an officer of the Royal Artillery was for many years superintendent of the royal gunpowder factory at Waltham Abbey and of the royal small arms factory at Enfield, both of them government institutions. In fact he is regarded as the leading authority in England on the subject of explosives, and on his retirement three years ago was appointed managing director of Nobel's great explosive manufacturing works at Ardeer in, Ayrshire.

"Another brother is Sir Nathaniel Nathan, who won his knighthood as Chief Justice of Trinidad and who was for many years a supreme court judge in Jamaica. The remaining brother, Robert Nathan, is a distinguished member of the Indian service, was principal private secretary to Lord Curzon during the latter's viceroyalty at Calcutta and is now president and chief commissioner of the Dacca and Patna divisions of Eastern Bengal.

"Sir Matthew, who is unmarried, is a very prominent member of the Anglo-Jewish Association, being indeed a vice-president of that body, and is one of the organizers of the great Jewish Boys' Brigade, which has furnished military training to many thousands of his young co-religionists. He is, like his brothers, a son of the late Jonah Nathan of Pembroke Square, London, whose brother, David Nathan, a member of the London Stock Exchange family of that name, was the father of Ernesto Nathan, former Mayor of Rome, and who visited the United States last spring in connection with the Italian participation in the Panama Pacific Exposition at San Francisco."

M. Gutchkoff, the famous Octobrist leader, has declared that he was greatly impressed by striking proofs of Jewish loyalty. He never believed that such self-sacrifice on the part of the Jews was possible. He felt completely satisfied,

in common with the authorities, that all libels against the Jews which were investigated by him were false intrigues. M. Gutchkoff promised to submit an official report to the Red Cross (of which he is a representative) of the loyalty of the Jews, and he hoped that it would create the desirable impression in the circles with which he was in touch.

Miss Mabel Riegelman, of Los Angeles, who for the past few years has been a member of the Chicago-Philadelphia Opera Company, will this season be a feature of Andreas Dipple's production of "The Lilac Domino." Miss Riegelman's abandoning grand opera was caused by the company giving up its season.

NEWS FROM ENGLAND

(Exclusive Correspondence to the HEBREW STANDARD)

[While we implicitly observe in spirit and letter President Wilson's admonition to the American people to maintain a strict neutrality in the present European conflict, we publish the following as a personal and subjective expression of the opinion of one of our regular contributors, and it should in no way be construed as the personal opinion of the editor of this publication, whose opinions are expressed only on the editorial page.—Ed. Hebrew Standard.]

Jewish Belgian Refugees in London in Increasing Numbers—Appeal by Community Leaders and Organizations—Allen Jewish Prisoners in Concentration Camps—Special Prayerbook for Jewish Soldiers—Jewish Non-Commissioned Officer Receives Commission—The Late King Carol of Roumania—His Views and Actions—Russia's Opportunity for Jewish Betterment.

London, Oct. 16, 1914.

Since the fall of Antwerp, Belgian refugees have been arriving in this country in greater numbers than ever. They include many Jews, the latter in fact exceeding 5,000 in number by the beginning of this week. British Jews are organizing to help them and a big appeal for funds has been issued signed by Leopold de Rothschild, Herman Landau, Otto Schiff and A. M. Woolf. Hospitality has been offered to refugees very freely, but, however much this comes forward it can hardly be relied upon to supply all needs and hence the appeal for donations and further offers of hospitality.

The Union of Jewish Women is offering to make itself responsible for adequate hospitality for the cultured class of Jewish Belgian refugees, whom it will distribute into suitable domiciles where they will be cared for and maintained as long as may be necessary. Generous pecuniary support and personal service have been promised already, but the needs are great, and the union appeals for offers of hospitality and for gifts of money and in kind, such as furniture, bedding, and new, or nearly new, warm clothing in good repair.

Another appeal which is being issued is mainly concerned with the temporary help for Russian victims of the war

here. The Chief Rabbi joins in this with the Bishop of Lincoln, Lucien Wolf, and many others of all churches who are friends of Russian freedom.

There are of course many alien Jewish prisoners interned in the concentration camps in this country. These are being looked after through regular visits by the Rev. M. Abrahams and other Jewish ministers.

Owing to the very large number of Jews who have joined the forces, the chaplain, the Rev. Michael Adler, has issued a special prayerbook in Hebrew and English, which has been accepted for distribution by the Admiralty and the War Office.

A Leeds soldier, Sergeant-Major J. H. Levey, of the 3d Scots Guards, is the first Jewish soldier engaged in the present war to obtain a commission from the ranks. Sergeant-Major Levey, who was a sergeant-instructor at Chelsea Barracks, has been promoted to a second lieutenant, and attached to the Gordon Highlanders.

The death of King Carol of Roumania has recalled to the minds of people here the severities practiced against Jews in Roumania. Jews as a whole can see little in the history of his reign except what is black and reactionary. With regard to King Carol's own particular personal views there is some diversity of opinion, but if, as is said by some, he at times desired to interest himself in better conditions for his subjects that desire was not strong enough to cause him any inconvenience.

Dr. Gaster, who met the late monarch a good deal, says perhaps the best word for him from the Jewish point of view. The Haham met King Carol upon his appointment as lecturer at the University at Bucharest on the Roumanian language and literature in 1882, and eventually received from the deceased monarch the Order Bene-Merenti of the second class. This was three years later. When Jews were banished from Roumania Dr. Gaster had to leave, but he went back again afterwards when the decree of banishment was annulled. On this occasion, in Dr. Gaster's own words, "I found that he was favorably disposed towards our coreligionists but that as a constitutional monarch he had to abide by the will of the people. But he was able to influence that will to such an extent that the Artisans Law was modified in favor of the Jews. I saw His Majesty last year again after the Balkan war. He invited me to come, and I again discussed with him the position of the Jews. I had reason to hope, but other circumstances—internal dissension, the weakness of the Conservative party, and the use which the Liberals again made of the Jewish question as a political platform—brought those hopes to naught. The Jewish soldier who had served in the army would have been given naturalization en bloc. The

King said he would see that the claim of the Jewish soldiers should be recognized, of course on constitutional lines, especially in view of the impending alteration of the constitution. Things have now moved quickly, and the Jewish question is suspended for the time being.

Continuing to say the best word he could for the dead monarch Dr. Gaster proceeded: "He held in great veneration his Jewish teacher in Bonn (M. Bernays), whom he once described as a very strict Jew. He was also on friendly terms with other Jews. He gave my father a large contribution towards the building of the Jewish school 'Moriah,' and remained a subscriber to that institution to his death."

Turning from Roumania to Russia the people here are still waiting and hoping that the Russian government will break down the pale and with it other exceptional laws that burden Jews in Russia. The news that the Russian government had formally promised legislation to remove Jewish disabilities, would be worth more to the Russian cause at this moment, than a crushing victory over the German armies. It would alter at one stroke the whole European outlook. It is not meant merely that it would influence the thinking both of neutrals and of Russia's ally about her; it would do that, for the behavior of any Christian people towards its Jews is among the most searching tests of its civilization. One thinks rather of the effects upon Russia herself. A touch of Jewish realism, less prone than the Slav temperament to comfortable delusions, less fecund in theory, and more apt at organization, is precisely what the Russian parties of progress lack—and that, indeed, is largely the reason why the reaction has repressed the Jews. We do not know how far the Russian government values the intangible asset of the good opinion of its two Liberal allies. If in any degree the new Europe is relieved of the military problems which scourged the old sympathies will inevitably follow natural lines of political affinity. It is certainly strongly hoped here that this question of the Jews may no longer stand in the way of an extension to official Russia of the cordial sympathy which links us to France.

A writer in the London Times, put the matter very pointedly the other day when he said: "The new epoch which the European war has ushered in must have enormous consequences for the Jews. The fate of three-quarters of the people is involved in the issue and the entire conditions of Eastern Jewry may be radically changed if a wave of Liberalism sweeps over Russia. As the wars of the French Revolution led on to emancipation in Western Europe, so this great conflict may induce the disappearance of the ghettos of Eastern Europe." The Times writer above quoted believes that the war is opening out a new epoch for Jews, which may radically change, to employ his own expression, the whole Jewish being, and may answer the prayers and hopes we have nurtured for twenty centuries, or rather that have been nurtured by some Jews during all that long time. He adds: "But of even greater moment will be the current of thought which will be quickened. The French Revolution heralded the rise of nationalities, and among the deeper causes of the present conflict is the maintenance of the liber-

ties of small peoples. The Jews, who at the beginning of the nineteenth century were still denied human rights, were too much bent upon securing civil freedom to feel the national impulse, and it was not till the last thirty years that that call of the age began to move them. To-day, however, when a large part are emancipated, and when the little Hebrew settlement in Palestine has begun to thrill them with pride, they are more likely to feel the effect of the renewed national spirit. The Jew, driven by outward influences to fuller national consciousness, will seek to achieve the destiny marked out for him by age-long tradition, to claim the brotherhood of his nation and to carry it into a new brotherhood with the nations of the Gentiles."

The Grand Duke Nicholas has sent a cordial wire to the President of the Warsaw Jewish community, M. M. Bergson, thanking them for the military hospital erected by them as well as for other proofs of their loyalty.

The annual convention of the Associated Young Men's Hebrew Associations of New England took place at Lawrence, Mass., Sunday, in the auditorium of the Lawrence City Hall.

Rabbi M. M. Elchler, of Boston, Mass., who recently received his diploma as a lawyer, has received notice from the Boston University Law School that he has been awarded the Benton prize for an essay on "Jurisdiction."

Jacob P. Adler, the eminent Yiddish actor, has recently posed for the movies, and his portrayal of the hero in "Michael Strogoff," the well known play of a generation ago, is now being shown in many motion picture theatres.

The Jewish community, of St. Louis, Mo., mourns the death of Nathan Friedman, whose demise is recorded at the age of 70. Mr. Friedman was a director of the Jewish Hospital and active in many philanthropic movements.

A good many persons in the business world are now hoping that the moratorium will soon give way to a *Simchastrium*.

The *Smart Set* for November defines Y. M. C. A. as "a cheap boarding house for poor but deserving Jews." Which, no doubt, is meant to be very, very funny.

In a little Texan town appeared an advertisement of a mushroom congregation coupled with the announcement that "Tickets may be obtained at R—ch's bar." Evidently both kinds of spiritual nourishment are handled thereat.

The *Globe* of this city recently printed some correspondence regarding the discrimination prevailing against Jews among merchants and employment agencies of New York. One of the latter frankly set forth his position to the effect that its clients refuse to take on Jewish employees, and that therefore it must perforce decline to consider all and any Jewish applicants for employment. We have often adverted to this subject in this place, and the newest, brutal form of Jew-baiting has nothing to differentiate it from similar and earlier examples thereof. The statement is made that among the clients of this agency who take exception to Jewish help are Jewish employers, and, if true, this is all the more pitiful. The subject is distressing, but we do not see how any mortal man can do anything to relieve the existing situation. There are some persons whose prejudices are so deep seated and vicious as to be unconquerable, and where these are employers or their agents the poor Jewish employee who is otherwise exceptionally fit must suffer. If publicity were a cure for this evil our columns would ever be at the service of those who suffer. But publicity is not a cure, and education does not seem to be one either. This form of dastardly hatred must make all good Jews and all lovers of their fellow men as well wince. But what good will that produce?

A writer in the editorial columns of *The American Israelite*, preaching on the lack of understanding of Jewish literature on the part of the American laity, says: "Is it not true that organizations devoted to the propagation of Jewish literature are guided by a partisan spirit, or, to put it plainly, that its (sic!) managers are playing politics, bringing inferior literature to the market and stifling activities that the public would welcome?" The query thus propounded must refer to an association that has for its object the popularizing of Jewish literature in this country, which is the Jewish Publication Society of Philadelphia, and we are pleased to return a categorical and unqualified negative to the "poser" of our Ohio contemporary. We hold no brief for the publication society, but it is an infamous distortion of the facts to say that the managers of that organization bring inferior literature to the market and stifle activities that the public would welcome. What activities that the public would welcome has the publication society stifled? Echo answers, none! No such activity can possibly be stifled by the society, for if the public welcomes the activity the society is powerless to enjoin the public from so doing. As to the inferior literature which the publication society has brought to market, we demand a bill of particulars, to speak in the manner of the lawyers, of our contemporary's charge. We fancy we detect the jealous displeasure of the rejected author for the publication society in the words appearing in the responsible columns of *The American Israelite*, although we never suspected anyone on the staff of our contemporary of indulging literary ambitions of this nature. If the publication society is to be attacked, as any association working in and for Jewry may be and is attacked, let us have chapter and verse, details, dates and descriptions of the complaint. Vague, vapid, frivolous and irresponsible denunciation never hurt anyone save the one who produced it.

OVERSTATING ONE'S CASE

WE don't overmuch blame Rabbi Joseph Krauskopf, as president of the National Farm School, when an opportunity suitably presents itself, for urging upon the community the duty of sending all, or nearly all, the many newly arrived immigrants "back to the soil." Our agricultural societies and activities are doing splendid work for the Jews of America, and schools and institutions like Rabbi Krauskopf's deserve communal support. This they are more certain of acquiring and retaining if the number of those to whose service they respond grows greater and ever greater. If, more and more with the passing years, our Russian, Roumanian and Galician brethren who have come to these shores take up the lives of agriculturists the farm schools and agricultural societies will never fail of support and encouragement otherwise. This is the justification for a portion of Rabbi Krauskopf's remarks at the National Farm School celebration last week in Doylestown, Pa.

There is, however, another side to Rabbi Krauskopf's words on that occasion, one, moreover, where he essayed to stand forth as the adviser of world Jewry, with as little of success as on other similar previous occasions in his career, and where, with that confidence which is inherent in those of his own school of thought in Judaism, he donned the prophetic mantle. He claimed to behold in the eventual termination of the present war the impetus which will produce a "tremendous influx of Jews from abroad to this country," whose coming here will necessarily add to the congestion of our cities, whose advent must accordingly be prepared against, and can be best prepared for only through the instrumentality of the National Farm School. Such deliverances are not merely ill-advised; they are extremely damaging to the Jewish cause, and have about all the indicia of careful and judicious thought which belongs to promiscuous conversation.

No man at this writing knows, even well enough to attempt to "prophesy" about it, what will be the outcome of the present war for the world. What effect it will have on the position of the Jews in Europe and correspondingly in America rests equally in the lap of the gods. We can but hope, for the sake of mankind and of the Jews, part of the human race, that the best possible results will flow from it. But until we know more and feel that we may speak with some certainty let us maintain a dignified and consistent silence on the subject. And let Rabbi Krauskopf do as much for the community he professes to serve.

Irish hatred of England has now taken on a new phase. The appointment by the Asquith government of Sir Matthew Nathan as permanent under-secretary for the Emerald Isle has set the pro-Home Rule press of Ireland by the ears. Our distinguished coreligionist's ripe experience in administration and his splendidly successful career in various branches of the British public service go for naught, and the *Leader* of Dublin sums up the situation (as it exists for the pro-Home Rulers and the anti-Protestant faction in Ireland) by headlining that now is "Ireland Governed by an English Jew." Added to this demerit, the *Leader* sees in Sir Matthew a dangerous Freemason and a relative of the Past Grand Master of Italy and enemy of the Papacy. Shocking it is to find that the *Irish World* of this city reprints this diatribe from the *Leader* without editorial or other comment, and thus tacitly gives approval to the thoughts of the wretched Dublin penny-a-liner. Sir Matthew Nathan has now entered upon the most arduous and momentous step in his career, and the fact that he is a Jew and perhaps a Mason (for of the latter there is no positive evidence in our hands), ought not and will not, we are quite certain, have any influence on his activity at Dublin Castle. We always thought there was a true community of misery between the Irish and the Jewish people, and we are profoundly sorry to see journals like the *Leader* and by implication the *Irish World* shattering this delusion, for such it now is. Sir Matthew's people have been the hares too long for them now to become the hounds. Moreover, from our knowledge of the man and his work we feel sure that his administration of Ireland will be informed by that responsibility to the Jews all over the world which now rests upon him. He owes ungrudgingly service to his government, and will render this. He also is under the obligation to his brethren of the House of Israel, who look to him to preserve the glorious heritage of the good name of Jew. He will be neither a repressor nor an enemy of law and order, and will hold the scales as evenly over Antrim and Enniskillen as over the Wicklow mountains.

The appointment of Herbert M. J. Loewe, M. A., as lecturer in Oriental languages at Exeter College, Oxford, is of interest in that it marks the entrance of Jews on the field of teaching Semitics at England's oldest and most conservative university since their resettlement of that country. Semitics at Oxford was heretofore quite the exclusive preserve of non-Jewish "dons."

"The Boy Who Fit In" is the title of a new juvenile work by Miss E. C. Ehrlich, who is now connected with the Jewish Board of Education in this city, which the *Ark* has just published. We have examined the little volume and find that it admirably serves its purpose—to teach our youth something of their religion in the guise of fiction. The story is interestingly told, but why was the author moved to interlard her dialogue with so much of up-to-the-minute American slang, as if this enhanced its verisimilitude?

FEAR AND FAITH

אל תירא אברם אנכי מן לך : והאמין כד :

"Fear not, Abram: I am thy shield." "And Abram believed in the Lord." (Gen. xv; 1, 6.)

FEAR and Faith are two dominant notes of the life of the soul. We hear now the one now the other, with great frequency. Who has not known these frequent alternations of fear and faith? Now our teeth chatter and our face is haggard with dark apprehension, now our lips smile confidently and every feature beams with the reflected light of the heavens. The human heart is a many-stringed instrument, over which a bow passes held by hands other than our own. Too rapidly for our peace and happiness does the Bow touch into sound the dormant chords—can we control its movement, its pace? How gladly would we sustain the triumphant major notes indefinitely; but the bow passes on to the minor notes that wail and weep. How gladly would we shorten the minor notes when they are sustained beyond our endurance; but the Hand that holds the bow is guided by a score written in a mysterious key. Can we write our own score that shall contain a combination of pleasing melodies, and direct the Master-musician to play our own tune? No; and thus the Bow passes swiftly over the strings waking the entire gamut of the human emotions, though the heart threaten to break. But it is when the bow passes and repasses in quick succession over the strings called Fear and Faith that the greatest strain is placed upon this throbbing instrument of joy and pain.

Though they may alternate, Fear and Faith are notes that cannot blend tunefully. Chattering teeth and smiling lips cannot very well go together. The faith that is inspired by fear, whose sole content is fear, is no faith. One cannot lift up his eyes to God while glancing sideways at some dread shape which, springing from the gloom of the soul, sails out into space on its dusky pinions and looms up menacingly on the horizon. Hands folded in prayer must not tremble. So long as fear is present, faith is absent; but the moment faith rings through the heart, bringing the echo of heavenly music into our lives, fear cannot be heard either as overtone or as undertone.

If faith does nothing but cast out fear, it has accomplished enough. In the music of the heart, to be sure, fear too has its well-appointed place. Nothing is out of place in that music. The Ear that listeneth thereto, delighting in it as never in the music of stars and storms, perceives the harmony in the wildest medley of sounds which to our human hearing seems discordant. But while fear has its place on the divine scale, it is always a prelude to faith—and that can be its only function. Study the lives of great men like Abraham and you will find fear present especially in their earlier, formative stages. For fear is a great educator. It is by fear that the child learns the most valuable lessons of existence. It is fear that keeps the chubby little fingers out of the alluring red glare of the fire. It is fear that keeps most men who have never grown up out of harm's way. Fear, then, is God's own alarm-cry whereby unformed or half-formed souls are shocked into the profound realization of His eternal goodness. This alarm call, therefore, is heard ringing through the formative stages of great lives; but when the crisis has passed and the soul is ready to receive the finest intimations of eternity, then God calls out to it, even as He did to Abram, "Fear not; I am thy shield!" How raptly does the soul then listen to the soothing accents of Faith! How joyously does it sing the refrain, *I believe, I believe in the Lord!*

What is true of the formative periods of the individual, is true of the formative epochs of humanity. It cannot be denied that the sole motive running through the religion of ancient peoples was fear. The angry god had to be appeased. Fear of the terrible deity smoked on the altars and shrieked out of the hymns. All the early rites of religion were practically gestures of fear. The imagination, only too fertile, of child-races peopled the world not only with gods but also with demons;—indeed, reading the record of those early days, it is difficult to see in what respect gods and demons differed. Both gods and demons inspired men with fear: the world was turned into a chamber of horrors and life became a nightmare. The attitude of man towards the unknown was one of trembling not of trustfulness.

But shall we therefore condemn religion because it was born out of Fear? The fact is that it has outgrown fear. It would manifestly be unfair to present-day religion to blame it for the shortcomings of primitive religion, just as it would be unfair to any man to reproach him for the blunders of his childhood. The fact is that just as in the individual heart fear is oft a prelude to faith, so in the heart of humanity fear served merely as an overture which was to yield to the real theme of the Song of Man—Faith! Measuring the life of man by the life of God, viewing man's heart as mirrored in the heart of eternity, who shall say that the note of fear was too long sustained? Many of us feel that the note of Faith has scarcely been attacked; that it will yet grow and swell with the coming ages; and we know not—we can only dimly foresee—how resonant it will be in the days that are to be, how mighty to soften if not to drown all notes that seem discordant. Perhaps the day will yet come when the Song of Man will be rewritten; perhaps on that day the human heart will no longer alternate with heart-rending rapidity between Fear and Faith; perhaps Fear will disappear altogether, and with it will go pain and anguish; perhaps when on that distant day the mysterious Bow will pass over the strings of the heart it will find many a dead chord that can no longer be woke into sound.

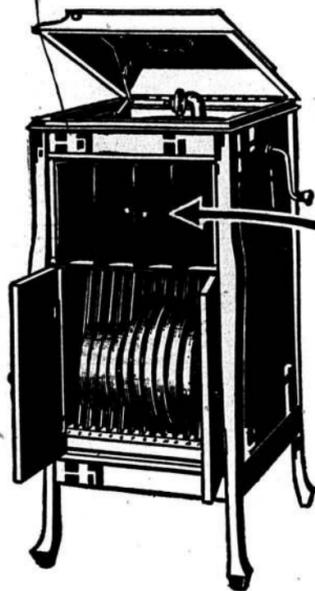

After the war he came North and called on all his creditors and paid them off, dollar for dollar and then went into business here with the small capital he had left. His first investment was when he bought an interest in the Clifton Brewery on Staten Island. This burned down

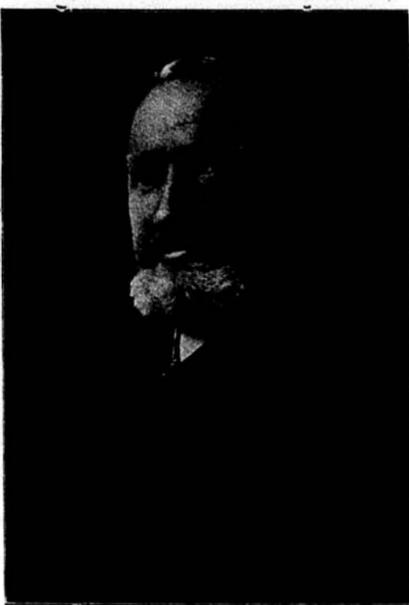

Keep a Good Judge on the Bench.

Judge Bartow S. Weeks has ably demonstrated during his occupancy of the bench, that he is eminently qualified for the arduous and trying duties of a member of our Supreme Court and his unqualified indorsement by all bar associations and many individual lawyers is ample attestation of his fitness and a valid reason why every citizen should vote for him at the coming election.
Judge Weeks, who was born in New York city in April, 1861, was admitted to practice in 1883, and from 1891 to 1897 was an assistant District Attorney. He resumed his practice until 1913 when he was appointed a justice of the Supreme Court, receiving the indorsement of both bar associations. In 1914 he was reappointed by Governor Glynn.
Judge Weeks, who grew up on the East Side, has been interested in many civic matters and our public schools and academies. It may be remembered by readers of THE HEBREW STANDARD, that in 1912 when the Alpha Delta Phi fraternity annulled the charter of its C. C. N. Y. subordinate chapter called Manhattan, on the ostensible ground that it was no longer a fertile field for its activities (but in reality because of anti-Jewish prejudice), Justice Weeks was one of the first to energetically protest against this un-American action.
Many of our eminent co-religionists irrespective of party affiliation have unqualifiedly indorsed Judge Weeks' candidacy and it behooves all right-thinking citizens in casting their vote next Tuesday to bear in mind the necessity of keeping in office such a qualified jurist as Judge Weeks.

The Social Workers' Tuberculosis Association, of Milwaukee, Wis., has started a campaign for 1,000 members through which sufficient funds will be raised to maintain the organization without need of an annual "flag day." It has also been decided to increase the capacity of the sanatorium to thirty patients.

But 249 Jewish immigrants reached the port of Philadelphia during the month of September, less than a third of the number in recent months, and mostly stragglers who had been in one way or other delayed on their way after starting from Russia or Poland before the outbreak of the European war.

The Executive Committee of the Independent Order B'nai B'rith have contributed \$10,000 to a fund for European war sufferers. The fund will be distributed by the officers of the Grand Lodges of the order in Europe. Rameh Lodge, No. 33, and Oriental-Hiller Lodge, of Chicago, have each contributed \$1,000.

A number of Jewish colonists in Palestine, who are of foreign nationality, have applied to be admitted to Turkish citizenship. The Chief Rabbi of Turkey has had an interview on the subject with the Minister of the Interior, who has promised to give it his sympathetic attention.

The Zionists in Lemberg organized a corps of City Guards, under the supervision of the Regular State Militia. The Zionists wear a distinct uniform, brown suits and a leaden Magen David attached to their sleeves and caps. The Zionists organized a similar squad at Bielsk.

The Ministry of Education has cancelled the proposed exclusion of the Jews from a private gymnasium at Petrograd, which passed into new hands, and intended to treat Jews already on the roll as candidates for admission into a new institution.

William M. Bass, who died in Washington, D. C., last week at the age of 65, was probably longer in the government service than any other Jew. He served for 44 years in the Government Printing office, Department of State and Department of Commerce, respectively.

German Tribute to Russian Jewish Soldiers

Under the heading, "The Destruction of Gerdanen and Stalenponen," the correspondent to the "Berliner Tageblatt," writing from Instenburg on the 14th of September, said: "The only ones who did not plunder and who behaved themselves as the Jewish soldiers. * * * In a neighboring house some Russian wounded were lodged * * * the Jewish soldiers who came from the Government of Kovno, and who by their uniforms and general appearance excelled their comrades, nearly all spoke German, and reported much of interest. They had not suffered from bad treatment, but from lack of care. One of them said to me in answer to a question: 'No! we have never taken anything; when we were hungry we always went to the clergy of the village and begged in German for some bread. And our request Mayor Adolph Greenhut has been rejected at Pensacola, Fla., by a two-thirds majority.'

American Jewry and the Zionist Movement.

An interesting by-product of the war in Europe is the compulsory seeking for financial aid from the American Jewry by the Jews of the warring nations. So many of the nations are combatants and hence economically unproductive that societies and associations distinctively Jewish in their aim and clientele are facing suspension of the work. To a neutral country, where the race is strong in numbers, in wealth and in altruistic feeling, the European Jews therefore naturally turn. The nation of refuge for exiles from lands where militarism has been harsh and social ostracism persistent is expected now to come to the aid of needy causes as well as of needy persons and families. Conspicuous among the causes' thus dependent is Zionism, Herzl's vision of a restored home and state for the race in Palestine. It is a plan that has made no appeal to a very considerable number of Jews in the United States, especially those of the earlier migrations. Indeed, it has aroused their opposition. But if the meeting just held in Boston may be taken as indicative of the temper with which the appeal for aid to the Zionistic treasury is to be met throughout the country, then the critics are either growing fewer or they are sufficiently opportunist to see that the present is not the time to oppose any call for aid caused by such extraordinary conditions. Even persons most skeptical of ultimate success of the Zionist plan may be willing to have the experiments already begun in Palestine carried out as completely as their projectors wish them to be, in order that the final verdict may be based on thoroughly tested facts; and it is for funds to tide over these experiments until the whole world constituency interested in them is once more able to come to their support that the American Jewry is asked to aid. A favoring response will accentuate the American primacy that already is appearing in the world Jewry.—Christian Science Monitor.

In Cleveland, O., recently Rabbi Louis Wolsey met Rev. Worth M. Tippy (Methodist) in joint debate on the question of Prohibition, the Rabbi maintaining that it was an infringement of the principle of personal liberty and instead of curing an evil it creates two, that of drinking, and the stealing of an opportunity to get a drink.

Mr. Joseph Solomon, who has just celebrated his 80th birthday at Indianapolis, Ind., has resided in that city for over 60 years. His was the first Jewish wedding in that city, and together with his brother he is the only surviving charter member of the Indianapolis Hebrew Congregation. Mr. Solomon enjoys the distinction of being the second oldest Mason in the State.

Striking evidence of what the authorities now think of Jewish loyalty has been forthcoming at Bielostok. Some 550 Jews offered their services to the Red Cross for the purpose of assisting in the removal of wounded soldiers to the hospitals. At the same time 70 Poles also enrolled themselves, but they refused to co-operate with the Jewish contingent. The authorities thereupon accepted their resignation and refused to dismiss the Jewish volunteers.

TEN TRIALS

Dear Children: "With ten trials was our father Abraham tempted, yet he withstood them all; to render manifest how great was the love of our father Abraham." Rabbi Naphthali Hertz explains this as follows:

"After the Mishna teaches us how the Creator by virtue of ten utterances created a world in which he took delight, and how he punished the first and second ten generations who destroyed the world through their evil deeds, and after having taught us that our father Abraham received the recompense contemplated for all, it tells us here how just the Eternal is in all His ways, and how truly Abraham merited to receive the reward the entire world had forfeited; for the Holy One, blessed be He, tried him with all kinds of temptations, and he withstood them all, and did not question the justice of the Holy One's treatment of him, but received it all with a feeling of love. Consider how He tried him in causing him to suffer in his body, and how he offered his life for the holiness of His name, blessed be He; how He tried him in bidding him to become an exile, and causing him to wander in a strange land without an inheritance after promising him the gift of the land of Canaan; how He tried him with suffering and hunger until he was compelled to leave the land and to go down among a despicable, loathsome people reeking with immorality: how He tried him by depriving him of his beloved wife, who was taken from him by force; how He tried him by making him divorce his second wife, in spite of his affection for her; how He tried him by telling him to drive out his first-born son, which was very much against his will; how He tried him by telling him to offer his beloved son as a sacrifice upon the altar; how He tried him by causing him to bear the bodily pain of circumcising the flesh of his foreskin; how He tried him by the danger of falling into the hands of the wicked kings in order to save his nephew; how He tried him by terrifying him in the vision showing him the troubles that were destined to befall his children. There are no greater trials than these, and because he was steadfast in his love and devotion to the Holy One during all these trials therefore was he justly entitled to receive the reward of all and deserved that the Holy One, blessed be He, should make a covenant with him. And these trials were all written in the Torah in order to make it known to all the coming generations how great was the love that Abraham bore to his Creator, and how faithful and upright he was. And were it not for the fact that He wished us to know all that it would not have been necessary for Him to try him for the Holy One, blessed be He, proves the heart and knows the virtue of each man, and He does not need to try anyone. But the Holy One, blessed be He, does try the virtuous people for the sake of letting the love they bear toward Him become known to the world, for when He sees a righteous man who loves justice and righteousness and fears the Lord, he proves him for many reasons. In the first place, in order that the name of

Heaven shall be sanctified through him, and that men should learn to fear the Lord, for the frivolous people and the greater portion of the masses do not believe that the human soul possesses wonderful powers by which it is able to conquer, through its love and fear of the Lord, the pains of the body and its passions, and subdue them entirely. However, if they see the righteous man bearing with a joyful heart the distress of his soul and his terrible trials, they are convinced that the fear of the Lord and his Torah exalt a man above all his surroundings, and many of the people of the earth repent of their evil deeds and return to the Lord, to fear Him and to go in His ways. For this reason the Lord does not try anyone unless they be absolutely righteous, whom He knows that they will withstand the trial, for should they withstand it the name of Heaven would be profaned, just as the Medrash said, it may be compared to a potter who does not test the cracked pots but only tests the good pots. They compared the trials wherewith the Holy One, blessed be He, tests the righteous to a potter who sells vessels—who upon the arrival of a customer tests the vessel that the customer may see that it is perfectly sound—it is sure that he will not test a cracked vessel, for it would break and the customer would go away without buying, thinking that all the vessels are cracked and broken, but he tests the good ones in order that the customer should buy his wares.

It is thus in the instance, the Holy One, blessed be He, desires that men should buy the fear of Him and the love of the Torah for their own good, and if they do not believe it for their own good, He tries the righteous in their presence and demonstrates how they withstand all temptations so that all may see how good the Torah is and acquire its wisdom.
