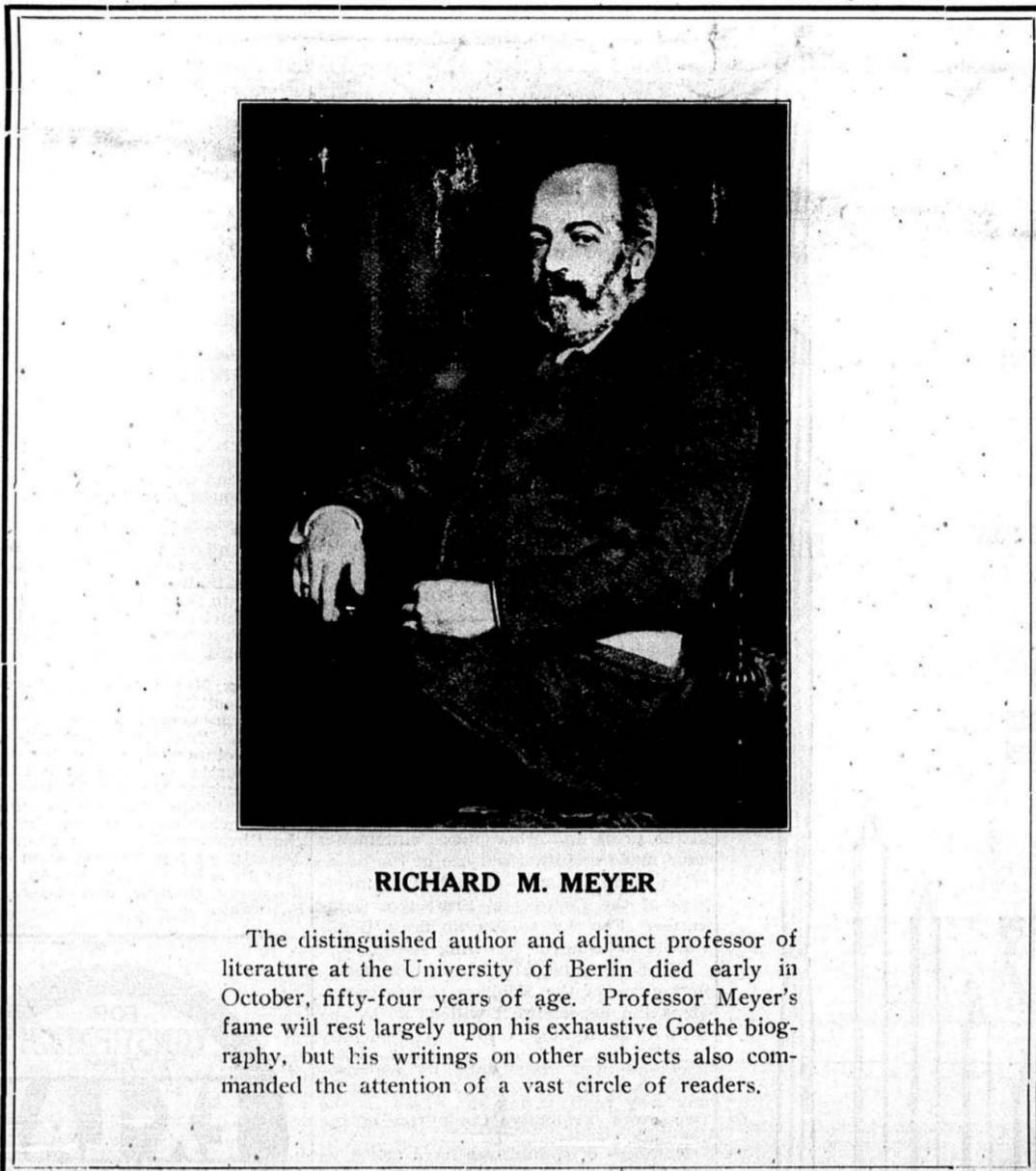
The boy prepared for departure with a lightness of heart that surprised him. "Even the officer now beamed upon him with an indulgence quite paternal.

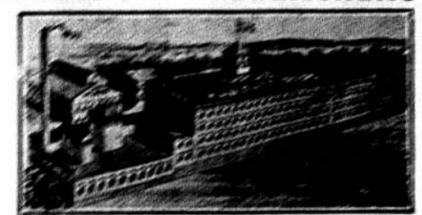

**CORRESPONDENCE.**  
**The Kehillah and the Closed Banks.**  
Editor HEBREW STANDARD:  
Large numbers of committees have inquired of the Depositors' Protective Committee of the Kehillah as to its attitude on the composition plan offered to the depositors for signature. Advertisements in the press and other public statements have made unauthorized use of the name of the Kehillah and of individual members of the Depositors' Protective Committee. For this reason we deem it advisable to issue the following statement:  
Whenever the Depositors' Protective Committee of the Kehillah wishes to address the depositors it will do so in the future, as it has in the past, officially over its own signature. All other advertisements and statements, by whomsoever made, should not be regarded as in any way representing the views of the Depositors' Protective Committee of the Kehillah.  
Numbers of committees have asked us for advice as to whether or not they should sign the offers of composition. They have told us that they would abide by our advice. To our deep regret it is not possible for us to give them definite advice. The composition plan, as proposed by the Banking Department, has seemed to us, after consulting the best authorities on finance, real estate and the

law, to be as good a plan as could be devised in the unfortunate circumstances. But we have absolutely no enthusiasm for the plan; nor do we believe that any plan can be worked out for which any one can have any enthusiasm. The reason for this is that the situation in the various banks is so bad that whatever plan is finally adopted will, in all likelihood, bring but little permanent satisfaction to the unfortunate depositors. What the depositors want and have a right to ask is money. No plan that can be devised can squeeze out money from the banks if the money or its equivalent in assets is not there. At the present time the odium of the entire unfortunate situation rests upon the bankrupt bankers where, in large measure, it rightly belongs. Any person or organization making any promises or guarantees to the depositors of future returns, or assuming responsibility for any plans, may find that in the course of time, if additional money is not available, the odium of the whole misfortune will rest upon them. No sincere organization or individuals can assume such a grave moral responsibility.  
For this reason we cannot advise the depositors one way or the other. Whatever money or other assets may be left belong to them. They are the creditors and practical owners of the bankrupt institutions. It is for them to decide whether or not the plan of composition is as good a plan as can be worked out under the circumstances, or if a better plan can be worked out. Whatever plan is finally worked out—the sooner a conclusion is reached the better—will be a choice of evils. We warn the depositors once again not to place their trust in any plan that promises them large returns.

#### "Liberalism in Religious Thought."

Last Sabbath Rabbi G. Lipkind preached at the Eighty-sixth Street Temple on "Liberalism in Religious Thought," and in the course of his remarks spoke as follows:

"It will be a long time, indeed, before such a universal religion can be formulated as will meet the idiosyncrasies of every frame of mind and shade of thought. We quarrel too much about trifles and lose sight of the great cardinal truths of God and righteousness, and humanity will have to go blundering and quibbling until some great overwhelming revelation will tear the veil from people's eyes and let them see the light of the sun—the light of truth and purity and righteousness.

"In the meantime we have to learn to judge a man, not by what he believes but by the manner in which he lives, not by the mechanical sanctimonious expressions that he repeats by rote, but by the spontaneous outpouring of his soul—by the honorableness of his deeds and the rectitude of his life. If we see a man producing good fruits in his life, a devoted husband and father, an honorable citizen, a loyal friend, though by training and temperament he be predisposed toward different modes of thought and belief—why should we think worse of him because of that? Why should we persecute him, why should we ostracize him? Why should we not make the same allowance for him and extend the same liberality toward him as we expect and demand that he should extend toward ourselves?

"Things that are alive are never really alike; it is only dead things that are all alike. In a cemetery you find everything alike—everything reduced to the same dead level of conformity. Why? Because everything's dead. Uniformity never leads to progressiveness; it more often spells stagnation and death.

"Of course, there are certain vital truths which we must hold on to with a tenacious grasp, which are the fundamental bedrock of life and thought, but there are a host of others which each age formulates for itself and in which we must exercise toleration and evince liberality of thought.

"You will find, as a matter of fact, that the great changes in the theological science of the past have not been at all in the direction of the cardinal, essential truths of religion—the great changes have been rather moral changes—changes of spirit rather than of substance—changes of form rather than of fact. And you will find further that every new change in religion—that every new religion in the days of its youth—was the immediate outcome of some previous progress and advance in human civilization and morality—some higher elevation of human goodness—some enlarged conception of human responsibility, proceeding concurrently with a loftier conception of the divine nature.

But this advance toward a nobler and a purer faith has had to be fought out only in the teeth of the bitterest and deadliest opposition—has had to reckon with the crass forces of materialism, the blind crushing inertia of conservatism, the swordpoint of militarism, the flat refusal of mankind to be drawn upward and onward from that which pandered to their lower nature, which satisfied their self-interest and contracted their horizon of human responsibility.

"For three hundred years, for instance, Christianity was a persecuted religion within the Roman Empire, and during this period all who made public profession of it did so at the risk of their lives. The Romans invented the most exquisite tortures to make the Christians recant, but the more they tortured them, the more devoted was their martyrdom. Saints were dragged at the heels of wild horses; their flesh was peeled piece by piece; they rotted in dungeons; the lions tore them to pieces—and the more they tortured them, the more Christianity triumphed!

"And then a strange thing happened! No sooner was their triumph complete—no sooner was the world at their feet—than Christianity itself turned with a savage yell of triumph against all those of a different creed—than it organized the hordes of Crusaders against the Mohammedans and split barrels of human blood—and especially turned with a savage impulse against that race in whose ranks their saviour himself derived his origin—whose teaching they adored (theoretically), but whom practically they reviled and vilified in their every action.

"But not merely was their wrath turned against those of a different creed—they were equally savage against the

#### Alliance Schools in Orient to Keep Open.

The Alliance Israelite Universelle, an international Jewish philanthropic association, with headquarters in Paris, finds it possible to maintain its 200 schools and institutions in Turkey, Egypt, Persia, Morocco, Algeria and other Levantine countries, according to advices just received by its American office, at 150 Nassau street. The letter received Monday from Paris states, in answer to a number of inquiries from American members, that ways had been found of transmitting appropriations and keeping in communication with every school, and that so far not one had been closed.

The signal honor of D. S. O. has been conferred upon Flight Lieut. Marx, who was one of the three English officers who recently attacked the Zeppelin shed at Dusseldorf. Lieut. Marx is a Jewish officer of the Royal Flying Corps, and himself threw the two bombs which effected the greatest damage. His machine was under heavy fire from rifles and mitrailleuse and was five times hit while making the attack.

different sects of their own creed. The wars of the Protestants and Catholics fill one of the blackest pages in the history of humanity and have proceeded unintermittently through the centuries. Who can forget the massacre of St. Bartholomew when the Catholics waded deep in Protestant blood—or the wars of Bohemia and the civil wars of France for no other cause than a difference of interpretation of Christian doctrine? Everywhere massacre and misery followed the introduction and spread of the Gospel. Was that the fulfillment of the promise which Christianity interpreted to herald the coming of the Saviour: 'And they shall beat their swords into ploughshares and their spears into pruning-hooks; nation shall not lift up sword against nation, neither shall they learn war any more.'

"Thank God, the Jewish race has little to reproach itself for in this regard. We stand for the triumph of Truth, but we have never taken the sword in our hand and rammed the truth down people's throats. If people come to us voluntarily and wish to become converts to Judaism, we accept them—gladly; but we have never gone out desiginedly to seek converts or to make converts. We know that the truth spreads of its own accord because it is the truth—that it is only falsehood that has to be rammed down people's throats—we know that the light must one day overcome the darkness—that reason is a more convincing weapon than force—that while hatred and massacre are abhorrent to God's divine nature and must be wrong, gentleness and charity and peace are reflections from the 'effulgence of God's glory and must be right!'"

Owing to the pitiful state of the Jewish and Polish refugees from the frontier towns, many municipalities have ap-

pealed for government grants to support them. In addition, the well known writer, M. Filosofov, has issued an appeal for the formation of committees throughout Russia, especially outside the Pale (the regions less affected by the war), to assist the Poles and the Jews ruined by the war.

Items of Interest In the Jewish World

Young men of Chester, Pa., have formed a Young Men's Hebrew Association.

The Mt. Sinai Hospital, of Philadelphia, Pa., treated 1,427 patients last year. It was run at a loss of \$7,000.

Only seventy-six Jewish immigrants reached the port of Philadelphia in October, as against 1,044 in October, 1913.

A vigorous campaign to raise a fund of \$20,000 for the erection of a Hebrew Institute has been started in South Boston, Mass.

The Sisterhood affiliated with the Congregation Bene Israel of Natchez, Miss., has joined the National Federation of Temple Sisterhoods.

Jewish residents of Victoria, B. C., have formed an association to co-operate in the founding of a Jewish agricultural colony near Vancouver, B. C.

The Sanatorium of the Jewish Consumptive Relief Society at Denver, Col., is badly crowded and there is a waiting list of sixty-five at present.

The Brooklyn Hebrew Free Loan Association has issued a special appeal for funds. Last year loans totaling \$16,415 were made to 3,340 borrowers.

By the largest majority ever given a candidate on the vote, Col. Ben. L. Rosenbloom, of Wheeling, has been elected to the West Virginia State Senate.

A comedy of New York Ghetto life, called "The New Shylock," has been produced with success in London, Eng. Mr. Louis Calvert plays the leading role.

Amass meeting has been called in Washington, D. C., for the purpose of considering the federation of all of Washington's Jewish charitable organizations.

The will of the late D. Ansell, who died at Montreal, Canada, a few weeks ago, has been filed. It shows bequests to various charities amounting to over \$13,000.

Heer Asscher, head of the famous diamond-cutting firm in Amsterdam, has placed his entire factory at the disposal of Belgium who have taken refuge in that city.

The Federation of Jewish Charities of Philadelphia, Pa., when started twelve years ago, collected \$70,000. The collections have now reached \$205,000 per annum.

In the Home for Aged Incurables at Baltimore, Md., there are three centenarians. They are Mrs. Hester Feldman, 112; Hyman Dabinsky, 110, and Isaac Wiedler, 108.

The official opening of the Jewish Educational Lyceum of West Baltimore, Md., located at 743 West Lexington street, under the direction of the Wide Awake Circle, took place last Sunday.

Measures which have led to the revision of the right of domicile and their expulsion have again been adopted at Petrograd and Kieff. The number of persons affected in each case is, however, small.

The Novae Vremja has printed the following appreciation of services of Jews in the field: "The Jewish soldiers are highly praised; there are many volunteers among them, and no deserters; they are all fine fellows!"

Impressive exercises marked the dedication of the Adler memorial wing of the Children's Hospital School at Baltimore, Md., donated by Mr. Simon C. Adler in memory of his mother, which was formally opened last week.

Charles Israel Newman, Pacific Coast pioneer, one of the "Forty-niners," and a founder of Carson City, Nev., died in New York city on the 4th inst., aged 89. Mr. Newman fought in several of the Indian wars under Major Ormsby.

Plans have been filed with the New York Building Department, for the construction at No. 24-26 West 114th street of a one-story and basement synagogue for the Congregation Kol Israel Anshei Poland. The synagogue will be 53 by 93, and will cost \$75,000.

An example of what can be done toward raising money for a synagogue is furnished by the Rodeph Shalom Sisterhood of Youngstown, O. Last year \$7,100 was netted from a bazaar and recently as a result of a rummage sale \$575 was added to the building fund.

Representatives of the Russian Government who have had large sums placed at their disposal have proceeded to localities near the frontier to examine the situation and to administer relief to the vast number of Jewish and Polish communities who have been ruined.

Figures given out by the Federal Naturalization Bureau show since the outbreak of the European war there have been a great increase in applications for naturalization, the greatest proportion of applicants for naturalization being Russian Jews.

Julius H. Hart, aged seventy-eight and one of the best-known fraternity men of Cincinnati, O., died at his home last week at the age of 78. Mr. Hart was just rounding out his twenty-sixth year as Grand Treasurer of the Grand Encampment of Odd Fellows of Ohio.

The Central Committee for the Relief of Jews Suffering Through the War.

The one cent self-taxation stamps issued by the Central Committee for the Relief of Jews Suffering Through the War have met with public approval. Over 200,000 stamps are already distributed. They are on sale at all the Jewish newspapers in New York city, the organizations with which the executive members of the Central Committee are affiliated and others. The children of the Talmud Torahs and Sunday schools throughout the country are expected to uphold the honor of their school by turning in the largest possible number of books containing \$5.00 and up to \$50 worth of stamps in exchange for the certificates, which the Central Committee will issue. Young ladies and gentlemen are asked to volunteer to canvass the wholesale and retail grocers who will buy the stamps and to turn them to their customers. The office of the committee is 1001 World Building.

The Y. M. H. A. of Memphis, Tenn., has formed itself into a branch of the Central Committee and the Y. M. H. A. of Bensonhurst has pledged each member by an "Enlistment Card" to pay ten cents per week.

American Jewish Relief Committee. Mr. Samuel Dorf, grand master O. B. A.; Hon. Leon Sanders, grand master, I. O. B. A.; Mr. Bernard Semel, of the Galician Verband; Mr. B. Zuckerman, of the Poale Zion; Rabbi M. Z. Margolies, Rev. Dr. Samuel Schulman, and Mr. Daniel P. Hays, have been appointed the committee which, together with Dr. J. L. Magnes, president of the Jewish Community (Kehillah) of New York city, will select the twenty-five New York representatives on the American Jewish Relief Committee for sufferers from the war. The appointment of this committee was authorized at the conference of New York organizations held at the Hebrew Technical School for Girls on Sunday afternoon, November 15.

One hundred and four accredited delegates attended this conference. They represented the New York lodges of the O. B. A., the I. O. B. A., the Brith Shalom, the Western Star Order, the Galician Verband, the Roumanian Verband, the Kehillah, the leading synagogues, orthodox and reform, the Council of Jewish Women, a majority of the mutual benefit societies in the Greater City, and a number of Talmud Torahs. Almost every member of the Vaad Horabonim.

Eastern Council of Reform Rabbis. The fifth semi-annual assembly of the Eastern Council of Reform Rabbis will be held in New York from December 6 to 8. Among the notable features of this conference will be three addresses by Dr. Emil G. Hirsch, of Chicago (Lewisohn lecturer for the year), on "The Philosophy and the Theology of Liberal Judaism"; a lecture by Madam Schwimmer, secretary of the International Council of Equal Suffrage, on "Woman and War," and addresses by Dr. Charles F. Services were also held at the Jewish Theological Seminary.

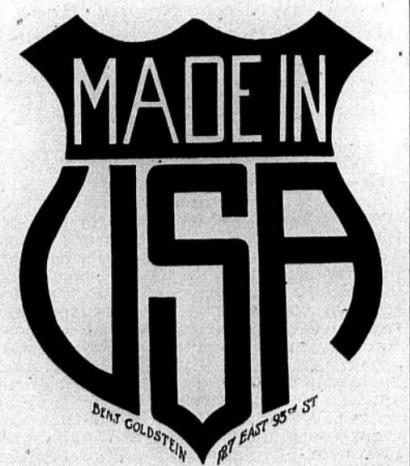

death in a conflagration at the risk of his life; Dr. Rosenbaum, of Koenigsberg; Michael Schwartz, a leader of the Socialist youth; Julius Graf, of Nurnberg; Katz of Berlin and Lucian Kahn of Frankfurt.

Among the generous contributions which made the new septic pavilion of the newly opened Lying-in Hospital and Dispensary in Chicago, Ill., built at a cost of \$85,000, possible, are: Sol B. DeLee, \$20,000; Estate of Nelson Morris, \$5,000; Edward Morris, \$10,000; Mrs. David A. Hyman, \$5,000; Benjamin E. Bensinger, \$5,000; and Estate of Leon Klein, \$5,000. The structure is said to be the most completely equipped of its kind in the city. It is four stories in height and of red brick and concrete. There are thirty beds, supplied by subscription at \$5,000 a bed.

The financial position of the Jewish community at Constantinople, which has never been very brilliant, has become most unsatisfactory in consequence of the universal financial crisis. The receipts from the meat tax have fallen to a fourth of the normal sum, and the taxes on the purchase and sale of movable and immovable property, as well as the marriage fees, have practically been reduced to nil. The philanthropic and educational institutions, which are subvented by the community, will be compelled to close their doors very shortly.

The notorious Berlin Staatsbürgerzeitung, which was for many years the organ of the German anti-Semites, and which had been agitating against the Jews at every opportunity, recently issued a proclamation that in view of the extraordinary devotion and patriotism evinced by the Jews toward their fatherland, it had decided to change its policy and to cease to act as the anti-Semitic organ. This change of policy will be not only during the time of war, but it will be maintained also after peace will have been declared.

The Congregation William Wolf, the leading orthodox institution of San Francisco, Cal., has been forced to vacate its synagogue on Geary street. The understanding at the time of the acceptance of the synagogue from the late William Wolfe was that the same was to be a deed of gift, but unfortunately was delivered subject to a heavy mortgage, which, through business reverses, the donor was unable to release, and now foreclosure proceedings have been brought.

Nish, the capital, pro tem., of Serbia, is filled with nearly all the Jewish inhabitants of Belgrade. They have been installed in the synagogues and Jewish schools and other buildings placed at their disposal by the community. They belong to all classes, and are living on charity, as in their hurried flight they abandoned everything they possessed. More than nine hundred persons are living on twenty centimes a day per head, the amount allowed them by the government.

The French Government is looking after the needs of foreign Jews in Paris. General Gallieni, the Military Governor, has caused placards in Yiddish to be affixed to the walls in the streets of the Fourth Arrondissement, the Ghetto of Paris, notifying Russians, Belgians, Serbs and English who have resided in

They include the Baron de Hirsch Institute, the Hebrew Ladies Relief Association, the Ladies' Hebrew Benevolent Society, the Ladies' Hebrew Aid Society, the Young Ladies' Sewing Circle, the Jewish Endeavor Sewing Circle, the Mount Sinai Sanatorium, the Hebrew Shelter Home, the East Side Day Nursery, the Herzl Dispensary and the Hebrew Free Loan Association.

In Chicago, Ill., Mr. Henry Horner has been elected as judge of the Probate Court and Samuel A. Ettleson has been returned to the State Senate. A number of Jewish candidates were defeated, among them being Rabbi Gerson Levi, who was the Progressive candidate for a seat on the County Board.

## NEWS FROM ENGLAND

(Exclusive Correspondence to the HEBREW STANDARD)

[While we implicitly observe in spirit and letter President Wilson's admonition to the American people to maintain a strict neutrality in the present European conflict, we publish the following as a personal and subjective expression of the opinion of one of our regular contributors, and it should in no way be construed as the personal opinion of the editor of this publication, whose opinions are expressed only on the editorial page.—Ed. Hebrew Standard.]

**Death of Arthur Cohen, British Jewish Legal Leader—Four Thousand Jews in British Army and Proposed Jewish Battalion—Jewish Refugees from Belgium—Louis Kaphan Forms British Colonial Jewish Boy Scouts in England—London's Latest Jewish Play.**

London, Nov. 6, 1914.

Your correspondent regrets to announce that Mr. Arthur Cohen, K. C., died early on November 3 at his residence in Great Cumberland place, London, in his eighty-fourth year. With his death there passes a man who was one of the most wonderful band of brilliant lawyers whose rise to fame shed glowing radiance upon the Jewish position in these islands. He had been in falling health for the last month. Arthur Cohen might not unreasonably have been regarded as the doyen of the English Bar. If we had in England an elected head of the profession like the dean of faculty in Scotland, there can be little doubt that Cohen would years ago have been chosen for the dignity. An unofficial recognition of merit of limited application, however, is that of standing counsel to one or other of the two ancient universities, and Cohen had held the post of University Counsel for Cambridge since 1879. All members of the profession will agree that for many years past his proper place would have been that of a member of the highest tribunals in the land. He was fit to be classed with two other men of his faith, contemporaries but senior to himself, Jessel and Benjamin.

The son of Benjamin Cohen, a member of a distinguished Jewish family to which Sir Moses Montefiore belonged, Cohen was born on November 18, 1830. Educated at University College, London, he had some difficulty in entering at Cambridge, as three colleges declined to admit a Jew. At length, however, by the inter-

vention of an Anglican dignitary, he matriculated at Magdalene and graduated as fifth Wrangler in 1853. Although excluded from a Fellowship, Cohen had for many years been an honorary Fellow. He was called to the Bar by the Inner Temple in November, 1857, winning a scholarship, and soon rose into practice, mainly in commercial and admiralty cases. His appointment as junior counsel to Sir Roundell Palmer at the Geneva arbitration on the Alabama claims in 1872 seemed to mark him for promotion; but Cohen was the reverse of a self-seeker, and he remained at the Bar till the end. He took silk in 1874 and soon rose to substantial practice within the Bar, and frequently appeared both in the Privy Council and the House of Lords. In manner and bearing he was a grand seigneur; his utterance was smooth and persuasive, though he spoke with somewhat of a drawl, and it was difficult not to be carried away, for the moment, by the most fallacious argument in his mouth.

In 1880 he was returned for Southwark with Thorold Rogers, but retired from Parliament in 1888. Soon after his first election he was offered a Judgeship by Lord Selborne, but Southwark had shown itself a fickle constituency, and to oblige his party Cohen declined. It is more than singular that during Mr. Gladstone's government the offer was not renewed. Room might well have been found for him in the Court of Appeal. The most notable appeal in which Cohen was engaged was that of Allen vs. Flood, the famous trade union case. He was counsel in the Venezuela arbitration at The Hague, Judge of the Cinque Ports, a member of the Royal Commissions on Unseaworthy Ships and on Trade Unions, chairman of the Royal Commission on Shipping Rings, a member of the senate of the University of London and a member of the British Academy. He was created a Privy Councillor in 1905. He leaves a son at the Bar.

A legal correspondent well acquainted with Mr. Cohen for many years writes as follows:

"He was a scientific lawyer, in a sense which is now rare and which has become barely possible in these days of codes and statute law. He had a large knowledge and a firm grasp of principles, and he followed them out slowly but tenaciously and logically. Nothing could be more instructive than to notice his handling of a difficult unsolved question in marine insurance or general average. The solicitor who consulted him must not expect a prompt answer, but the opinion, when given, was based on a careful study of all the authorities and calm consideration of the consequences of adopting one or other of conflicting views. The court might generally with advantage have accepted this opinion as its judgment.

"If it fell to him to argue the case, he did not readily adapt himself to interruptions. Let the court, however, permit him to follow out his argument in his own methodical way, it was certain to be closely knit. They do not now make such lawyers as Cohen; it has sometimes been said; and no doubt he belonged rather to the school of Willes and Keating and Blackburn than to our days. His, too, was that which most of these lawyers did not possess—a large basis of culture. He had read little in literature—he had no great taste for it. But he had a distinct liking and aptitude for philosophy. He once told the present writer that he had read diligently Kant's 'Critique of Pure Reason.' Certainly he delighted in finding a philosophical basis for legal rules or principles.

He was keenly interested in international law, public or private. He took a prominent part in the discussion of the Declaration of London, and contributed letters to the London Times on the subject. An interesting paper read before the International Law Association, in which he examined the Declaration, was published in a small volume. It was characteristic of his impartiality, his tendency to append qualifications to his opinion, and his aversion to extremes, that those alike who opposed and those who defended the Declaration appealed to him as supporting their views. The same tendency was to be noted in the paper which he read at the instance of the Eighty Club upon 'Capture of Private Property at Sea.'

"Every lawyer must feel that Cohen found his true place, which was not to be a politician or an advocate, but to sit in an appellate court—by preference the Judicial Committee; to bring to difficult questions rare knowledge and a singularly well-balanced judgment, and to aid in some well-considered, comprehensive scheme of codification."

Turning to other current news, the war, of course, still figures largely. The proposal to enlist a special Jewish battalion is gaining way, although it has been severely criticised by the Rev. Michael Adler. The proposal has the indorse-

ment of many influential members of the community and the analogy of Jewish battalions in France and Canada. In fact, the whole line of enlistment in this country has been to secure that men of similar tastes, inclinations and habits shall be together, and this has given rise to the now current phrase "pals' battalions."

Figures recently compiled show that over 4,000 Jews are now serving in the British army, and the figures are being added to daily. In proportion to the general population Jews would not have been expected to contribute more than say 3,000 or 3,200.

The entry of Turkey into the field of warfare raises many Jewish questions. Jewish interests in Asiatic Turkey are great and numerous, and it is feared that much good work that has been started is doomed or would anyhow be severely hindered. The other complication is the question of Ottoman subjects in Great Britain. These have now become legally "alien enemies" and must register and frequently be interned in concentration camps. For example, in Manchester there are 3,000 Ottoman subjects living. Many of them abominate Turkish rule, in fact. They are chiefly Armenians, Syrians and Turkish Jews. The colony there was established about the middle of the last century. Already there are, of course, many Jews interned in the camps, and the Rev. Michael Adler is doing good work in the way of visiting them. At the Frith Hill camp, which is one of the biggest and where many Jews are, a regular series of services has been arranged, the military authorities showing themselves most helpful and promising every facility to lighten the unhappy lot of our co-religionists who have gathered in the camp.

The Jewish community is coping successfully with the demands made upon it by the large influx of Belgian Jewish refugees. Generous contributions have been made to the fund opened for their relief, and, as an instance of the overseas interest taken in the matter, \$5,000 has been cabled to Leopold de Rothschild from Victoria as a first Australian contribution to the collection he is making. Most of the refugees are being cared for at the Jews' temporary shelter and the disused Union premises in Poland street, though hospitality is also being dispensed in many private houses.

It has been decided to form a Jewish Boy Scout contingent, the qualification for membership consisting in former residence in one of the British oversea do-

minions either on the part of the lads or the parents. The movement is being inaugurated by Louis Kaphan, who has just returned from Canada in company with Sir Robert Baden-Powell. In Canada Mr. Kaphan was assistant scout master of a company of 500 scouts. The contingent will be known as the British Colonial Scouts.

The "New Shylock" had quite a successful first night here at the Lyric on October 30. Louis Calvert played Simon Shylock Ehrlich. The simple conventional sentimentalism of the piece, which is evidently one of the weaknesses that Jew and Gentile have in common, made its every score with the London audience. Though the play is by a Jewish author it is not played by a Jewish or even a Jewish-looking cast, which seems to argue a falling of courage on the part of the producers. They might have forti-

fied themselves by the example of two of the most successful plays of the season—Mr. Zangwill's "The Melting Pot" (with the same mixed-marriage moral) and "Potash and Perlmutter" (still running). It is told of Louis Calvert's distinguished father that when he produced "The Merchant of Venice" among his famous Shakespearean revivals in Manchester, he carried realism so far as to import a real gondola from Venice, and some wit of the period that to make the thing complete he should have had a real Jew for Shylock. Louis Calvert has not done that with "The New Shylock," but at least he has made himself look like a real Jew. The rest of the cast have not even done that. The final reception of the play, if not uproarious, was at any rate firm, and the audience did not go home until they had not only seen the American author but had a little speech from him.

In order to insure the insertion of communications in the current issue of THE HEBREW STANDARD they must be in this office not later than Wednesday 10 a. m. of the week in which they are to appear.

Some of our communal workers are troubled by the existence of more than one relief committee. Surely there cannot be too many of these agencies for good!

In Terre Haute, Ind., the date of a charity ball was recently transferred from a Friday to a Tuesday in order that Jewish supporters of the endeavor, who presumably had made their wishes known, would not have their susceptibilities wounded. We wonder if the Jews of St. Louis would have done as much!

"Ex-Rabbi" Leopold Cohn, of Brooklyn, the man who, according to his advertisement in the *Christian Herald*, "found the Messiah, the Lord Jesus Christ, and is now preaching Him to 300,000 Jews of Brooklyn, N. Y.," has now started a monthly journal, the *Chosen People*, to aid him in his "saintly" and mischievous task. We hope sincerely none of the chosen people will be engulfed in the meshes of the *Chosen People*.

The *American Israelite* opines that "no general conceited (!) movement (among the Jews to succor Jewish sufferers in the war) has as yet been instituted." Our Cincinnati contemporary undoubtedly intended "conceited" for "conceited." But assuming the thought to be as it stands in print, we are sure there is enough conceit about the movements (or some of them, at least) now in process of formation.

Ezekiel Leavitt, of Boston, the editor of the *Boston Jewish Voice*, has written "At Ellis Island," a poem which embodies a strong protest against the laws restricting immigration to these shores, and a "Song," *Koomoh* or "Arise!" set to music. The latter is an inspiring national poem. Mr. Leavitt's paper is shortly to be enriched by a Hebrew page, designed to extend its influence and increase its dissemination. We are glad to note these latest evidences of an unremitting literary activity on the part of an able representative among the small band of American Jewish writers.

In "Hebrew and Babylonian Traditions" Prof. Morris Jastrow, of the University of Pennsylvania, brings out clearly the remarkable Hebraic development of the Sabbath. This day, he shows, was originally a lunar period, as he calls it, a time of doubt and danger, when the favor of the gods was to be sought. In Jewish hands this was later transformed into a season of rational religious devotion. Prof. Jastrow, a first-rate scholar in his chosen field, may be correct in his characterization of the Babylonian views on the Sabbath. Of course, he does not present the orthodox Jewish view on it; but, then, he is a Reformer, and somewhat of an iconoclast so far as Jewish religious traditions go.

In the *Reform Advocate* Rabbi Emil G. Hirsch bids us "fear the Greeks!" This, for the reason that the "Greeks" are endeavoring to substitute for the whole Bible in the public schools a Biblical reader containing many of the noblest passages of the Old and New Testaments. In the course of a lengthy editorial discourse, the learned rabbi of Chicago Sinai Congregation queries:

"How did the Jews of old come to know their Bible? Was it through perfunctory readings perhaps at stated intervals? Indeed not. They became acquainted with it through the prayer book and the synagogue institution. (And, he might have added, were he disposed to be altogether fair, the Orthodox Jews in America still act thus. They furthermore never merely read the Torah, they studied it. (Again he should have added, the Orthodox Jews in this country still do so). And here is the rub.")

Yes, here is the rub! Rabbi Hirsch laments the downfall of the Bible in the present daily life of the Jew in America, and does not castigate the Reformers who have "reformed" the Bible out of the synagogue and the daily life of the Reformed Jew. Not the least among these offenders is the rabbi of Chicago Sinai Congregation, who is at the same time the editor of the *Reform Advocate*. Why must he labor his points in such laborious accents in his journal, the while in his pulpit and in his examples to his "flock" he gives the lie to his assertions? Why refer to past glories in such half-dulcet, half-mournful tones, if in the pulpit and in his life he be sublimely unconscious of them? Inconsistencies like these rob writing of this kind of any little value it may possess.

## THE JEWISH ACADEMY

THIS is a subject which is receiving the thoughtful consideration of a number of prominent Jewish scholars and publicists in this and other countries at the present time. And with good reason. A central organization of this nature, modeled after the celebrated *Academie Francaise*, could do much effective work for Judaism and the Jews. But the present moment is perhaps the most inopportune for its formation that could possibly be selected. So much of the Jewish world is actively concerned in the war now raging that its attention cannot be diverted from this even by a question that may have transcendent importance for Jewry at large.

This touches the second phase of this question, whether or not American Jewry is strong and influential enough to carry on the idea of this academy single-handed. We are certainly powerful and effective in mere numbers and in potential usefulness. We could even call the academy into life and perhaps control its destinies until such time as the dove of peace will again hover near the continent of Europe. But such a course does not commend itself to the friends of the matter.

A Jewish academy to produce the greatest amount of good for all of Jewry must be the deliberate product of the united energies of all the few finest minds of the various Jewish communities scattered over the world. Only then will its sanction be sufficiently broad and distinguished to secure its general acceptance on the part of all the Jews. If the academy be the result of propaganda by American Jews exclusively, or by English, French, German or Russian Jews and no others, its appeal will be circumscribed. The academy must be broad enough to include all divisions of Jewish scholarship and scholarly interests, and this it cannot be if it grow out of the activity of one set of Jews.

Other subsidiary questions, affecting the main issue, need not detain us at this time. The problem whether or not Jewish men of letters shall be invited to join is relatively unimportant. There could well be instituted, once the academy is established, distinct classes embracing different divisions of the science of Judaism. There is, too, in any consideration of the matter, who, what man or group, shall take the initiative in making the plan a reality? But, as the whole subject is quite academic (logically, since we deal with an academy) at this time, we are not troubled by this circumstance.

The *Jewish World* thinks the Jews of England have a duty to perform in the matter of guarding and preserving Jewish interests and institutions during the continuance of the present war. But, our contemporary proceeds, they look to the Jews of this country to assume their natural position of leaders in this cause. That the Jews of the United States were fast becoming the guides and directors of the Jewries of the universe was apparent to any observer of events before the present holocaust descended upon the European continent. This war, however, has clinched their title in this regard for them. The *Jewish World* is concerned to see the hegemony slipping away from Anglo-Jewry, but the natural order of things governs and, as in Bishop Berkeley's day,

"Westward the course of empire takes its way."

From the Bloch Publishing Company we have received two pamphlets which they have just issued. The first of these is, "God Is One: An Historical Pageant of Israel's Loyalty," and claims Milton Marks, Henry Hart and Martin A. Meyer as its authors. In dramatic form this publication essays to prove that "the one thing which has ever marked the Jew is that in all ages he has been loyal and steadfast to his God." It successfully accomplishes its task. The other booklet is, "Delinquent Parents, Four Addresses," by Rabbi Alexander Lyons, Ph. D. These lectures deal with the subjects of juvenile delinquency, crimes against childhood, childlike children and parent and teacher. Rabbi Lyons considers such themes as the eugenic marriage, the solemn rite of confirmation and its attendant pernicious excrescences of gifts, and the place of the teacher in the social fabric. While the style may be called turgid, Rabbi Lyons succeeds in convincing the reader of the importance of the problems with which he is concerned, and of his own deep and expert study of their details.

*Free Poland* is a semi-monthly magazine, which is published by the Polish National Council of America from Chicago, and which is devoted to disseminating the truth about Poland and her people. In an article printed in the issue for November 1 we read: "Poland has always championed the cause of freedom and justice; we say of freedom, inasmuch as she was the bulwark of Europe against the barbarism of the East, because she received the Jews, the Hussites and emigrants of the Thirty Years' War when all the rest of the world would have none of them." The latter portion of the foregoing sentence is undoubtedly correct: Poland was the champion of the cause of freedom in the past! To-day, when it may well be, and for the sake of the human race, it is, indeed, to be hoped, that Poland stands on the threshold of a new era of freedom and liberty for her people, the Jews of that country ought to be included in any general enfranchisement of the Poles. The Polish Jews have been a part, and an important part, of the Polish nation since the time of the Black Death. Under ordinary rules of logic they would share in a new liberalism for their country. But latterly evidences of an unfriendliness towards them on the part of, we regret to say it, the Poles themselves have given the Jewish world cause for much disquiet. *Free Poland* can shed light on the obscure nature of this problem. More than this, *Free Poland* can make propaganda among the Poles to the end that they remain true to their original fair treatment of the Polish Jews.

## EXPERIENCE

וישאלו אנשי המקום לאשתו ויאמר אחתי הוא כי ירא לאמר  
אשתי פן יהרגני אנשי המקום על רכבתי כי טובה מראה הוא:  
"And the men of the place asked him of his wife; and he said, She is my sister: for he feared to say, She is my wife; lest, said he, the men of the place should kill me for Rebecca; because she was fair to look upon"—(Gen. xxvi, 7).

THE story of Isaac shielding himself by alleging that the woman with him was not his wife but his sister is the exact repetition of the story of Abraham's use of the same expedient under identical circumstances. It is curious to note that even the name of the place as well as other details are strikingly the same in both incidents. Under the same conditions father and son acted in the same way. We cannot say that Abraham showed up to his advantage by employing the ruse of misrepresenting his wife; and it is rather odd that Isaac should not have profited by the lesson and should have committed the same mistake as his father.

This suggests the thought that the lessons of experience are seldom learned second-hand. Parents transmit to their offspring many gifts by the mysterious channels of heredity; yet they do not, for they cannot, transmit to them their own wisdom of life. Parents would gladly do so, for they themselves had to pay a heavy price for their own experience, and it was only at the cost of much heartburning, much mortification and much keen suffering that they have been able to fathom the secrets of existence. How much pain and anguish of soul could parents save their children from, if but the latter could begin where the former have ended! But parents know that their offspring must begin where they have begun, must sit patiently at the feet of life as they have done, and must pay for the lessons the same price of toil and tears! Even if the father be such a one as Abraham and the son such as Isaac, the contents of one life cannot be poured into another, the intimate experiences of one soul cannot be conveyed in their fullness and richness to another, and the child must grope its way along the dusty road of humanity subject to the agelong pitfalls and temptations over which the first man has stumbled.

It is true, indeed, that past generations have bequeathed a precious legacy to us, which we are destined to swell and increase in order to hand down a yet richer patrimony to the men and women who come after us. We do not have to learn all the lessons of life over again. The use of the fire was known to our savage ancestors, but we have improved methods and extended the field of application. We do not have to discover fire, nor have we to discover America, nor have we to find out what steam and electricity will do for us. These things have been done for us; and while we improve upon the ways of our forefathers, we lighten the labours of posterity. It were infinitely harsh, it were intolerable, if each generation had to find out everything anew. Instead, the doors of the race-experience are open to all the generations that enter the rich storehouses wherein the wisdom of the ages is garnered. It is furthermore true that the experience of the race not only directs the larger work of mankind along the lines of commerce, industry, science and art, yea, of religion itself, but also enters most actively into the details of the individual life. The past teaches the present. But when all is said about the influence of the dead upon the living, the fact still stands out boldly and incontrovertibly that the finest lessons of experience, those that touch upon the profoundest elements of the personal life of each individual, can never be received from any forbear, but must be learned at first hand by each man and woman.

It appears that this is an unnecessary hardship. One might wish life to be so constituted that the past should be an absolute guide to the present in matters large and small. But such a wish would be unreasonable and its fulfillment undesirable. The trouble with the holder of Aladdin's lamp is that being able to summon at any time the genie, he has no individual incentive; and thus if we possessed the magic lamp whereby to summon at a moment's notice the helpful spirits of the past that they might rescue us from every scrape and smoothe life's rugged road before us, we should lose every power to create, every impulse to engage in toilsome endeavor. And then what would become of those that come after us? How would their life be enriched? Yes, the past cannot teach all to the present, so that the present may have something to impart to the future. Moreover, the best thing about experience is just *this personal quality*, the fact that it must be acquired and re-acquired by each and every individual anew. Life must be wrestled with, for it does not yield up its secrets willingly; and it gives meaning and content to the existence of each and every individual that he must enter the lists himself to gain the rich booty of experience.

This earning of the booty of experience is somewhat of a paradox. For it is seldom that we really earn the boon of experience; rather does experience come to us as an unearned blessing. Experience is mostly the result of trial and error: the worse we bungle, the greater the knowledge we acquire afterwards when consequences manifest themselves. The greater the mistakes we commit, the profounder the lesson which experience teaches. It appears therefore that those who by their mistakes are least deserving receive the largest benefits at the hand of life. Moreover, experience is seldom consciously striven for, it is rather attained as the by-product of our activities. Every lift of our hammer, though it has for its objective some material piece of work, achieves something higher than its highest lift—the uplift of the soul. Thus, unheeded and unearned, does experience enter into our shops, offices and homes to enrich our souls. But it can only come to us through us; and therefore whenever the gates of living breath open to admit a child into existence, the doors of an Academy open where the child is to be sole pupil learning its lessons in its own way.

The various Jewish charities of this city are suffering for lack of funds, at a time, too, when the demands upon them are the greatest in many years, and this demand is likely to increase as the winter advances.

An examination of the list of contributors to the various charitable institutions and an analysis of the list will demonstrate its poverty. It will show that thousands upon thousands of our co-religionists who are able to aid these worthy bodies are not enrolled.

It will further show that the same names, to a large extent, are the enrolled contributors to all the great charitable institutions; that possibly not more than about six or seven thousand of our co-religionists make up the body of those who are paying the annual contributions, for all.

There are about one and a quarter million Jews in this city, and of these only about seven thousand are the regular subscribers to our charities.

Many well-to-do Jews are not found upon any list. If all those who could well afford to do their share in helping to maintain these worthy institutions, would do so, these institutions would be able to successfully cope with the work they have on hand.

Why should so small a contingent of the Jews of New York city be compelled to bear the burden of the support of these bodies, and why

should the rest be permitted to shirk so solemn a duty?

Nathan Barnert, humanitarian and philanthropist, has for years in his innermost heart desired to render some real and lasting service that would be of benefit to mankind, and in the completion of the magnificent hospital structure made possible through his broad charity, this dream of service will become a reality.

Fifty-six years ago there came to Paterson, a young man, who was blessed with but little of this world's goods, but whose soul was afire with ambition to achieve and to succeed. Nathan Barnert, in the gift of the Barnert Memorial Temple, the Miriam Barnert Memorial Hebrew Free School, and the Nathan and Miriam Barnert Memorial Hospital, has created monuments of steel and stone that will last for centuries, but he has builded better than he knew, for in human hearts beating, in undying gratitude, there will for all time live the grateful memory of this man of men, this humanitarian, who took from the fruits of his years of industry the necessary means to create these wonderful structures for human help.

The Synagogue, for religion; the Free School, for education, and the Hospital for the aid to the weary, the foot sore and the wounded. He has indeed bound up the wounds of his fellow men. He has made it possible for them to educate their children and to make their appeals to the God of Israel and on that final day when men stand shoulder to shoulder before that infinite power on high, to face their final judgment, there will be thousands who, if they are given voice to do so, will cry out in their gratitude: "Oh, God of Israel. There is one among us who is deserving of your greatest blessings, for he by his life's work has made our lives brighter and better. He has eased our pains and he has inspired us with the highest of ideals. He has made charity his religion and he has given new hope to thousands of us. For Nathan Barnert, Oh Lord, may we ask your blessing, for he is deserving of your love and consideration."

Monday will be a proud day for Paterson, for its Jewish residents, and Jew and Gentile alike will realize that any community is indeed blessed for having had in its midst a man of the broadness of mind, the charity and the lovable qualities of Nathan Barnert.—Passaic; N. J. News.

Mr. David A. Pareira, who died in Chicago, Ill., last week, was a native of Amsterdam, Holland, and had lived in St. Louis, Mo., for a number of years. He was twice elected to the Missouri Legislature.

The Daughters of Hannah Home for Jewish Infants is making effort to raise sufficient funds with which to open a home in Baltimore, Md., for Jewish infants. Several thousand dollars have already been subscribed.

In the Academy for Higher Sciences in Florence there has been established a special department for the Hebrew language and literature. Professor Umberto Cassuto, a well-known Jewish scholar, was appointed to the position.

Eberhard P. Deutsch, a son of Professor and Mrs. G. Deutsch, of Cincinnati, O., has been appointed to a cadetship at the United States Naval Academy. Mr. Deutsch, who will enter next year, intends to specialize in engineering.

Another rabbi has entered the field of playwright. Rabbi Emanuel J. Jack, of Pueblo, Col., has completed an interesting social drama called "Mission, Omission and Commission." It deals with modern charities and social settlement activities.

At a very large and enthusiastic meeting recently held by the Young Men's Hebrew Association of Jacksonville, Fla., it was decided to begin at once the erection of a building which will be a credit to the institution and an ornament to the city.

At Kovno, which at former times has a population of some 200,000, there are at present some 60,000 people, fully 70 per cent. of whom are Jews, and of these again fully 90 per cent. are old men, women and children. The poverty is appalling.

Mr. Alfred Courlander, a well known journalist and novelist, died in London, England, last month, succumbing to an illness contracted early in the war. Recently he had been the Paris correspondent of the London *Daily Express*, which he joined eight years ago.

The Associated Young Men's and Young Women's Hebrew Associations of New Jersey are considering the employment of a paid field secretary to aid in their work. The National Council of Young Men's Hebrew Associations has offered to donate \$1,200 per annum toward the cost.

Colonel Emanuel Krausz, of the Fifty-second Infantry Regiment of Austria, fell in battle on Serbian soil. Colonel Krausz was fifty years of age and had distinguished himself many times, for which he had received recognition from the Emperor-King. He rose rapidly in the army.

After trying for two years to raise a fund of \$200,000 by the end of this year in order to gain \$25,000 offered by Julius Rosenwald of Chicago, the Brooklyn Federation of Jewish Charities has given up hope of completing the fund. The management attributes the failure to bad business conditions.

The Jewish dentists of Lutzk have published an appeal in the *Novoe Vremya*, begging to be allowed to join the army medical corps. The Odessa Pharmaceutical Society has also resolved to petition the government that Jewish apothecaries should be allowed to serve in the field pharmaceutical corps.

At the fifteenth New York State Conference of Charities and Correction to be held at Utica, November 17-19, Mr. Morris D. Waldman, manager of the United Hebrew Charities, read a paper on "Relief in the Home for Special Classes, Including Widowed Mothers, Deserted Wives and the Feeble-Minded."

Eccentric bequests contained in the will of Henry B. Palethorp, an aged lawyer of Philadelphia, amounting to \$200,000, and made to perpetuate the memory of the "last of the Palethorps," were declared invalid last week by Judge Dallett in the Orphans' Court. Under his will Mr. Palethorp remembered a number of public and charitable institutions, and the bequests were sustained. Among them is one of \$5,000 to the Jewish Hospital.

Five more Jewish soldiers have been awarded the Russian Order of St. George for bravery. One of them (M. I. Tumarkin, of Homel), died from the wounds inflicted upon him in the field, while three others, Ladizensky, Fridland and Tabatznik, are determined to exhibit still greater courage in the field.

The election returns show that two Assemblymen from Brooklyn are sons of rabbis. Nathan B. Finkelstein, who was elected to represent the Twenty-third Assembly District, is the son of Rabbi S. Finkelstein, and Nathan D. Shapiro, who was elected to represent the Sixth Assembly District, is the son of Rabbi Daniel Shapiro.

Governor Glynn has appointed a New York State Committee of Mercy to cooperate with other committees of mercy in this and other countries to aid women and children who have been made destitute by the war. Among the members are Adolph S. Ochs, Dr. Stephen S. Wise, Oscar S. Straus, Aaron Rachevsky, Samuel Lekisohn and J. B. Greenhut.

The Chicago (Ill.) Board of Education has adopted the following rule in order to prevent teachers from being deducted for the observance of religious holidays: "No deduction shall be made from the salary of a teacher of the Jewish faith who may be absent on any day which the Governor of the State of Illinois proclaims a religious holiday for those of the Jewish faith."

Mr. Moses Alexander, of Boise, has been elected Governor of the State of Idaho. Although the regular Republican ticket was generally successful, Mr. Alexander running as a Democrat, was elected by a plurality of over 5,000. He is the second Jew to be elected to the office of governor in this country. Mr. Alexander is a merchant and president of the local Jewish congregation.

The Anti-Defamation League has drafted an amendment to the United States postal laws, which will be submitted to Congress at its next session, providing that no advertising matter, letter heads, circulars, etc., should be sent through the mails by any hotel, summer resort, etc., which indicated a discriminatory policy on its part against any people on account of their religious affiliation.

Municipal Judge Manuel Levine, of Cleveland, O., has been elected Common Pleas Judge for a period of six years. Judge Levine, who came to Cleveland eighteen years ago, an emigrant lad from Russia, educated himself, became Police Prosecutor, climbed step by step to Police Judge and to the post of the newly created Municipal Judgeship, where he introduced many reforms which attracted nation-wide attention.

The Metropolitan season has opened in the proverbial "blaze of glory" and with the entire company intact, and the subscriptions almost equalling last year's high-water mark, everything augurs well for a period of brilliancy. The repertoire for next week includes some interesting revivals. "The Magic Flute" will be given Monday night, with Destinn, Hempel, Schumann (debut), Urlus, Braun and Goritz. Wednesday "Glaconda" will be sung, with Destinn, Ober, Duchene, Caruso, Amato and De Seguro. "Parsifal" will have its usual Thanksgiving matinee, the singers this time being Matzenauer, Sembach, Whitehill, Goritz and Braun. The same evening "Traviata" will be sung by Hempel, Botta and Amato. "Carmen," with Caruso, Amato, Farrar and Alda is announced for Friday night, and "Boris Gudenoff" will be heard at the Saturday matinee, with Didur heading the cast.

The programme of the Symphony Society of New York, Walter Damrosch conductor, for Sunday afternoon of November 29 at Aeolian Hall, will be devoted to an interesting exposition of the development of ballet music in France from 1749 to 1913, ranging from the simple classic ballets by Rameau and Gluck down to the exotic ballet, "Daphnis and Chloe," by Ravel, which will receive its first performance in America. Miss Felice Lyne, coloratura soprano, who won her laurels in London during Hammerstein's opera season there, will be the soloist. The complete programme follows: Excerpts from "Platte".....Rameau Iphigenia in Aulis (Airs de Ballet).....Gluck Air from "The Marriage of Figaro".....Mozart Miss Felice Lyne.....Dallbes Dances from Le Cid.....Masseten Air, "Caro Nome" from Rigoletto.....Verdi Samson and Delilah.....Saint-Saens Daphnis and Chloe (Symphonic Fragment).....Ravel (New, first time in America.)

Mme. Julia Culp is to be the soloist at the Philharmonic concert this (Friday) afternoon. She will sing the "Lament of Ariadne" from one of the earliest of all operas—"Arianna," by Claudio Monteverdi. These early operas were an attempt to do what Wagner did two centuries later, make the music flow from and illustrate the text. It is recorded that, on the first production in 1608, the audience at the close of this lament was in tears. Mme. Culp will also sing four Brahms songs with piano accompaniment. The orchestral numbers will be the Bach suite in D major, which was such a favorite with Theodore Thomas and his audiences; Beethoven's Fifth Symphony, the merry overture to Smetana's "Bartered Bride," and Henry Hadley's tone poem, "Lucifer," its first performance in New York.

There is to be a series of four Sunday evening Philharmonic concerts at popular prices on November 21, January 16, March 13 and March 28. The first one will be a Wagner programme made up of favorite selections from six of the operas and music dramas.

Mme. Alma Gluck will be the soloist at the second of the series.

The second time when they encamped at Rephidim and there was no water for the people to drink and the people quarreled with Moses, thus showing that they did not profit at all by their first experience when the Almighty showed them how quick He could supply them with water, and there was no occasion to be quarrelsome about it. Twice in regard to the manna, once when they were told not to go out on the seventh day to gather manna, because it was the Sabbath "and there went out some of the people to gather," although they found nothing. Another time, when they were told not to have any of the manna till the morning, and some men left it until morning, showing that they did not believe that Providence would supply them with fresh manna every day. Twice in regard to the quails. The first time, when they lusted after the flesh-pots of Egypt; the second time when the mixed multitude among them felt a lustful longing and the children of Israel also wept again and said, "Who will give us flesh to eat?" showing their ingratitude when they were furnished with the manna, which was the most delicious food that ever mortal ate, and had any taste that a person might crave for, and could be prepared in any manner one could desire. Both times the Lord supplied them with quails. The ninth time when they worshipped the golden calf. The tenth time when from the wilderness of Paran they sent twelve men to spy out the land of Canaan, and these men, with the exception of Joshua, the son of Nun and Caleb, the son of Yephemeh, returned and brought

an evil report of the land which they had spied out, unto the children of Israel, making them cry aloud and murmur against Moses and Aaron, and exclaim, "Oh, who would grant that we had died in the land of Egypt! or that we might but die in this wilderness," and when Joshua and Caleb contradicted the evil report of the spies, describing how good the land was, that it was flowing with milk and honey, and how the great Father, who had treated them with such tenderness was powerful enough to bring them into that land and give it to them, the congregation would have stoned them with stones were it not that the glory of the Lord appeared and overawed them.
