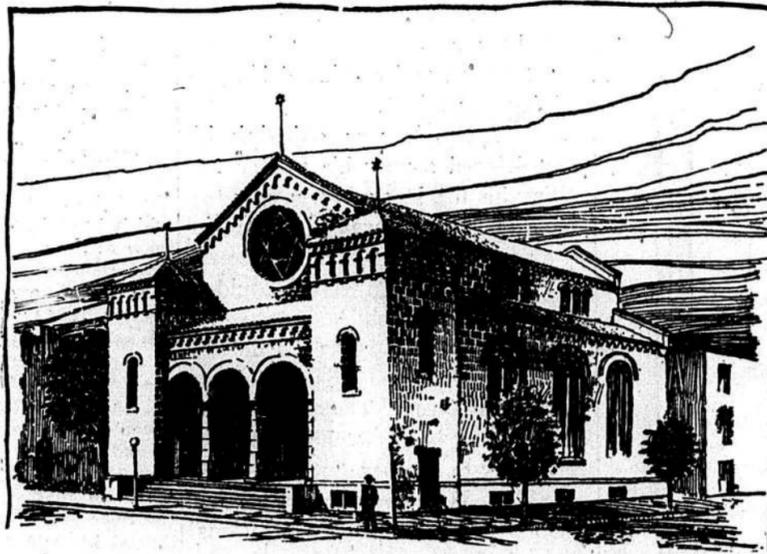

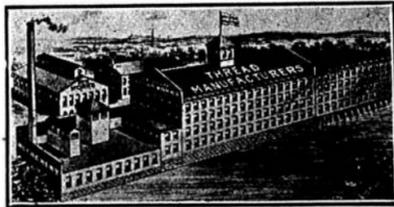

Earl Roberts and the Jews:

Other journals have done justice to the memorable achievements and sterling character of the gallant soldier and gentleman who has just answered the last call. Here, however, we may pay a word of tribute to the broad spirit and sense of brotherhood which happily inspired his relationship with our own community. The late Field Marshal twice came into direct contact with the civilian Jewish population of this country, and on both occasions this took place in the Central Synagogue. At the end of the year 1902 he attended a military service there. He was at the time commander in chief of the British army, and the compliment which he paid to the Jewish troops lost none of its significance on that account. Earl Roberts was greatly impressed by the service, and in a letter which he wrote a little later he expressed his pleasure at his association with the Jewish soldiers, who, as he put it, "share with the comrades of other creeds the spirit of loyalty and patriotism which is so conspicuous in our military forces." His second visit to the synagogue, in the year 1905, was paid in order to unveil the tablet in memory of Jews who fell in the Boer war. Upon that occasion he delivered himself with the direct and soldierly simplicity and sincerity which were so characteristic of the man. "To a commander-in-chief," he said, "all soldiers are the same, whatever may be their form of religion, and it is a great pleasure to me to be able to tell all of you present here to-day that no men fought better in South Africa than your co-religionists. These 116 Jews died in the performance of their duty, and I am confident that every one of their brethren liv-

The Hebrew Conjunctions of "Ad" and "El."

Editor HEBREW STANDARD:

In his sermon on the Sabbath of Penitence Dr. Joel Blau dwells at some length on the Hebrew conjunctions of "ad" and "el," their respective peculiarities and prospective definitions, wondering at the singular course of Prophet Hosea in employing the "ad" at the expense and deterioration of the "el," notwithstanding the fact that the former corresponds to the English "as-far-as," while the latter is the equivalent of the vernacular "unto." The rabbi, however, failed to mention the continuation of the verse at issue, as well as the subsequent paragraph which, when correctly quoted and properly explained, may display a different color and turn to another direction, settling satisfactorily the supposed complications and solving authentically all sophistries. Hosea's admonition runs thus: "Return, O Israel, unto the Lord thy God, for thou hast stumbled through thy iniquity. Take with you words and return to the Lord" (Hosea xiv, 2-3). It must be borne in mind that the "into" has been fathered by "ad," whereas the "to" replaces the Hebraic "el," the reason, however, being significant and the cause turning, indeed, far reaching. There is a Talmudic truism of "The terrestrial kingdom is but a copy of the celestial government" (Berachoth f. 58a), because of which your correspondent craves the indulgence of an ample space in the valued columns of THE HEBREW STANDARD for the reproduction of a story circulated recently about three rabbis and the demised Pope as an illustration for the comprehension and elucidation of the prophetic verses.

An American rabbi, prominent with both Jews and Gentiles, in the course of his vacation went abroad and visited all the principal European cities, Rome inclusive. He repaired to the sanctum sanctorum of the Pope, where he was granted an audience, received by His Holiness, the Pope, and enjoyed the honor of pressing a kiss on the pontifical hand.

Another rabbi, wishing to turn sensational and having invited a host of reporters to his temple one Yom Kippur afternoon, made the Pope of Rome the pabulum of his thoughts and the source for his inspiration, delighting his audience, the reporters included, with tales and stories of the Vatican, the latter's faults, transgressions and misdemeanors, as if a Jewish rabbi, a Jewish synagogue and a Jewish gathering on the most solemn Jewish festival day have no other topic of import and object of significance to discuss but the Catholic Church and the latter's leaders and followers.

And there was fall, and there was winter and there was spring, and there was summer, another year. The time for vacation, recuperation and recreation came to pass. Rabbis of the Reform wing of Judaism especially, as a rule, with a few exceptions to prove it, go to Europe for life's enjoyment and practical enlightenment. One of them went to Rome, and in order to meet, see and behold the very right reverential presence of the Pope, secured a letter of recommendation from one of the American Catholic Cardinals, testifying to the rabbi's wisdom, knowledge and erudition. It goes without saying the rabbi's letter was taken into the inner apartments and read before the Pope by one of his secretaries; the rabbi, however, was merely thanked for his trouble to substitute for the regular mail, by means of which letters of all sorts and transactions are usually sent to people of all stations, distinctions and dignities. Confused and embarrassed as a result of this un hospitable courtesy, cold reception

and ill-treatment, the visiting rabbi had to leave the premises without seeing the Pope, becoming thus the scapegoat for his colleague's nonsensical articulations. Because one rabbi sinned against the Pope the latter would have nothing to do with any of them any more.

Neither would God in heaven face the transgressors, the latter returning but as far as the Godly presence, approaching but at the point of "ad." After, however, having taken "words," namely "Debarim," Deuteronomy, the Fifth Book of Moses, containing, as the latter does, among others, the Decalogue, the observance of the Sabbath and its keeping holy constituting part and parcel of the Ten Commandments, if exactly pursued on the very Penitential Saturday, one may return, indeed, to the Lord, following precisely the meaning of "el."

Items of Interest In the Jewish World

A Jewish Educational Society has been formed in Sedalia, Mo.

A Hebrew Free Loan Association is being organized at San Diego, Cal.

Zionists of Worcester, Mass., raised \$1,400 for relief work at a meeting held last week.

During the past year the Milwaukee (Wis.) Federation of Jewish Charities disbursed \$18,149.

Mr. A. Herz, of Terra Haute, has been named as a director of the Indiana Red Cross Society.

In Chicago, Ill., Mr. Henry S. Waldman has been appointed attorney to the County Treasurer's office.

The attendance at the Chicago (Ill.) Hebrew Institute reached 280,000 last year, as against 113,000 the previous year.

The Ladies Society of Temple Anshe Emeth of Pine Bluff, Ark., has joined the National Federation of Temple Sisterhoods.

A Boy Scout Club has been organized among the boys attending the religious school of Temple Beth Miriam of Paterson, N. J.

In the course of his visits to Grodno and other towns the Czar himself thanked Jewish deputations for the loyalty of their brethren.

A junior branch of the Paterson (N. J.) Young Women's Hebrew Association has been organized with fifty charter members.

The Turkish war has prevented the shipment of most of the articles ordered at the various Bazalel exhibits held in this country last year.

August Seeman for many years superintendent of the Jewish Colony at Alliance, N. J., died last week, aged 82. He was a Civil War veteran.

Dr. J. Leonard Levy was chairman of the committee in Pittsburgh, Pa., last Wednesday in charge of "bundle day" for the Belgian war sufferers.

During the current quarter the United Hebrew Charities of Cincinnati, Ohio, handled 411 cases, as against 278 cases for the corresponding period in 1913.

The Orthodox Congregation Tifereth Israel, of San Diego, Cal., has purchased a lot on Eighteenth street, on which it will erect a modern synagogue edifice.

The Knights of Zion, an organization of all Zionist societies in the Middle West, will hold its eighteenth annual convention on December 31 at St. Louis, Mo.

A committee has been appointed in Providence, R. I., to consider the advisability of erecting a Jewish educational and charitable centre to cost about \$40,000.

Work has been begun at El Paso, Tex., upon the new edifice for the Congregation Mt. Sinai. The synagogue will have a seating capacity of 625 and will cost \$60,000.

Forty Jewish artisans have been expelled from Petrograd on account of their being unemployed, and thirteen Jewish merchants have been fined for visiting that city.

Rabbi Meir Berlin, one of the leaders of the Mizrahi Zionist movement in Europe, writes that he will shortly revisit America in behalf of the distressed Jews in Russia.

A new lodge of the Independent Order B'nai B'rith was recently instituted at Berkeley, Cal. A number of students of the University of California were among the first initiates.

Prof. David W. Amram, of the University of Pennsylvania Law School, will deliver the annual address before the Ontario Bar Association in Canada at Toronto on January 9, 1915.

In Cleveland, Ohio, State Senator Maurice Bernstein has been appointed Judge of the Municipal Court to succeed Judge Manuel Levine, who has been elevated to the Common Pleas Bench.

Phillip Herzberg, for twelve years president of the Baltimore (Md.) Hebrew Benevolent Society, died last week, aged 93. Mr. Herzfeld was one of the oldest Odd Fellows in America.

A telegram from Odessa announces that the Russo-Jewish colonists in Palestine, being subjects of a belligerent State, are obliged to abandon their property and leave Turkish dominion.

Mr. Moses Schoenberg, of St. Louis, has been named a member of the Executive Committee which has charge of the campaign for sending a Missouri relief ship for the needy of Europe.

Mr. Joseph H. Glauber, a well-known charity worker of Cleveland, Ohio, died suddenly last week in Seattle, Wash. Mr. Glauber several years ago in conjunction with his brother, M. H. Glauber, donated the Glauber Memorial Building to the Hebrew Relief Association as a memorial to a deceased brother.

An Appeal from Galicia in Behalf of Its Stricken Jews.

The Committee of the Austro-Galician Zionists in this city has received an appeal from the editor of the *Lemberger Tageblatt*, the following being a translation of the same:

Over 18,000 Galician Jews have been forced to quit their homes for Vienna by reason of the invasion of the enemy. A number of committees of aid have been supporting them, but need is continually increasing, and unless help comes from other countries we are confronting a catastrophe.

An appeal to me as editor of the Jewish daily newspaper now is published from Vienna. Help us! Send us if you can money. Collect it and send it soon, because urgent help is required by many thousands. Thousands are without a cent in their pockets, and fled at the last moment without clothes and linen. Who should help at the last moment if not their brethren in America who need not feel the scourge of this worldly war. Control in measure public opinion in United States in favor of Austria, which is now fighting against Czarism, against master of the pogroms and the oppression of the Jews. The bold fighting of the Austrian army is regarded by us Austrian Jews as fighting for the better future for Russian and Galician Jews. Observe the terrible deeds which the Russian soldiers almost exclusively practice on Jews in Galician cities. Listen to the reports of many shameful acts toward Jewish girls and the plunder and pillage of Jewish business houses and the hanging of Jewish citizens of Tarnobrzeg, where one son was compelled to execute his father in the bloody pogrom contrived by the Russians in Lemberg on September 27; heed of this and you will understand why the Jews fondly cling to the Austrian cause. Enlighten the public opinion in America on this matter.

A War Incident.

There are quite a lot of us in the Jewish Cemetery. We came to pay our last respects to a man torn away from his native land; we were burying a wounded Austrian officer.

When he was brought into the hospital I took particular notice of him, and we had a talk. There are a great number of Jews among the Austrian wounded. They willingly enter into conversation with us and tell us their strange impressions and experiences on the battlefield. Among them I noticed this officer; a thin, sympathetic face, with large black eyes,

demonstrative of deep sorrow. He spoke with difficulty; a severe wound tortured him. His medium of speech with us was broken Yiddish, but I understood him perfectly, and this pleased him very much.

"The 'Yomin Neroim' are approaching. I am told that we are to be sent to Moscow. I think there are no synagogues there, and I have a peculiar longing to pray and weep."

As he uttered these words his face assumed a pathetic expression. I comforted him by saying there are many Jews in Moscow and also synagogues.

"Why, is it true? Are there Jews in Moscow, and synagogues, too? That's very good. I shall pray at least, but only God knows whether I'll live till then."

All at once he started to groan, and the Sister requested me to withdraw. I saw him the next day, and understood that his fate was sealed. He, too, evidently knew this, for he no longer talked with me about the synagogue and Moscow. His lips twitched painfully.

I questioned the doctor as to his state. "He will die in the course of a day. Blood poisoning has set in," he told me.

I approached the sick man. He recognized me with difficulty, muttered disconnected words, and his eyes were aglow. Suddenly he raised himself and attempted to speak to me. He spoke Hungarian, and I understood nothing. All at once he started to speak clearly in plain Yiddish.

"I have to make a particular request to you and your friends 'Chesed Shel Emess.' Bury me in the Jewish Cemetery—this is my last wish."

As he uttered these words his dark eyes filled with tears. His face began to turn black, and he lost consciousness.

Toward evening he passed away. We fulfilled his last wish. There were few people in the cemetery, and there were no tears and no sighs. A decrepit little moldan pronounced *Kaddish* in a low tone over the fresh grave.

Col. Henry I. Kowalsky, at one time legal adviser of the late King Leopold of Belgium and one of the picturesque figures of the San Francisco Bar, died suddenly at his home at San Francisco, Cal., last week. Mr. Kowalsky was commissioned by King Leopold to prepare a brief on conditions in the Congo Free State during the controversy over that country in 1904. In October of that year he delivered to President Roosevelt, together with his brief, an autograph letter from King Leopold in which Belgium's side of the controversy was presented. The letter contained a denial of accusations of cruelty in the Congo Free State.

Professor Hugo Kronecker

Hugo Kronecker, for the last thirty years professor of physiology at the University of Berne, Switzerland, died June 6. Although 75 years old, death surprised him in the midst of scientific activity. He attended the last meeting of the German Congress of Physiologists at Berlin, where, on June 5, he demonstrated experiments which should support the neurogenic theory of the origin of the heart beat. On his way home he stopped at Mannheim, to inspect an apparatus which he installed there for the study of and use in cardiac diseases. His death came there, suddenly, like a flash—perhaps by means of the cardiac centre which he discovered thirty years before.

Kronecker was one of the last of a classical period in German physiology. He was pupil, assistant and intimate friend of the master minds of that period: Helmholtz, du Bois-Reymond and Carl Ludwig. At the same time he was master and friend of many leading physiologists of a later generation and of many countries; he was an international leader in his science.

He was born in Liegnitz, Prussia, from a well-to-do family with scientific proclivities. The celebrated mathematician Leopold Kronecker was his elder brother. After finishing his general education at the gymnasium in Liegnitz he studied medicine in Berlin, Heidelberg and Pisa (Italy). In Heidelberg he came under the special influence of Helmholtz, who introduced Kronecker into the science of physiology. The problem of muscular fatigue, which Kronecker studied first under Helmholtz and which he treated in his thesis, became the source of many important investigations, which he carried out at various times during his scientific career.

In 1865 he became assistant to Traube. This celebrated clinician was the first man to employ experimental physiology for the study of medical problems. It was probably due to the early influence of Traube that Kronecker acquired the inclination to make results obtained in physiological studies available for clinical medicine. On account of a temporary pulmonary affection, Traube sent him to Italy, where he stayed for some time, an incident which left a mark upon Kronecker's future activities. The acquisition of the knowledge and the use of the Italian language was unquestionably a factor in his future intimate relations with the Italian physiologists. He recovered his health and even served in the Prussian wars with Austria and France. In the Franco-Prussian war he received the Iron Cross for bravery.

In 1868 he entered Ludwig's celebrated "Physiologische Austalt zu Leipzig," where he remained until 1876, becoming assistant in 1871, and professor extraordinary in 1874. In 1877 he was called to Berlin to become the head of the division of experimental physiology in the Institute of Physiology, which had recently been organized by du Bois-Reymond. In 1884 he was called to Berne, where he filled the chair of physiology until the last day of his life.

Kronecker's scientific activities extended over more than half a century; his thesis appeared in 1863. But the investigation which raised him to the rank of a first-class physiologist was his work on "fatigue and recovery of striated muscles," published from Ludwig's laboratory in 1872. The careful planning of the experiments, the exactness and skill with which they were executed, and the sharp analysis which permitted the derivation of general laws, put a classical stamp upon this piece of work; its celebrated tracings were the starting point for future ergographic studies. The later work during

* Dr. Meltzer is head of the department of physiology of the Rockefeller Institute. As a physiologist he has few equals, either in this country or abroad. Apart from his own work, which has been of an exceptionally brilliant kind, he has suggested and has given the necessary impetus to many a research which has gone toward making the fame of more than one till then obscure physiologist.—B. H.

his Leipzig period was mainly devoted to the cardiac muscle; some of the results found a permanent place in physiology.

During his long stay in Berne a great many physiological subjects were investigated in conjunction with advanced co-workers or students. The results were usually published under the name of the co-workers. In the last years of his life he was intensely interested in experiments which could throw light upon the origin of the heart beat.

A subject in which he took a great interest in the last two decades of his life was the nature and origin of mountain diseases. The Swiss government, before granting permission to build the now famous Jungfrau railroad, asked Kronecker to pass an opinion whether going up a high mountain in a railway would be accompanied by mountain disease and other disturbances of health. This gave rise to numerous studies connected with this question. Kronecker organized a party of sixty, who ascended the Zermat Breithorn; some of the party were carried up to eliminate muscular action. Circulation, respiration and other functions were then investigated. The problem was also studied in pneumatic chambers with lowered atmospheric pressure.

Kronecker was a master in physiological methods. He invented many instruments which found a permanent place in the methods of experimental physiology.

In the seventies, during Kronecker's stay in Leipzig, Ludwig's physiological institute was an international centre for physiology and physiologists. Many English, Italian, American, Russian, Belgian, Scandinavian and French physiologists received there their training in physiology. Kronecker, who spoke many languages fluently, was of great assistance to them. With his very kind, unselfish nature he was always ready to help them with his rare experimental skill and in every other direction. Many who worked there during that period bear witness that Kronecker was the "soul" of the laboratory. Here he formed strong bonds of life, long friendships with men who became later international leaders in science. I need only mention here Bowditch and Minot, of the United States; Lauder Brunton, Gaskell and Schäfer, of England; Alberto Mosso and Luciani, of Italy; Paul Heger, of Belgium, and Holmgren, of Sweden. Very few men had the happiness of having so many true friends as Kronecker, and few could be a truer friend than he.

Kronecker was a foreign member of our National Academy of Science, of the Royal Society and of many European academies. He had conferred upon him honorary degrees from a great many universities. In England alone he received the degree of LL. D., from the universities of Glasgow, Aberdeen, St. Andrew's and Edinburgh and the degree of D. Sc. from Cambridge.

He had pupils all over the world. Of American investigators who worked under Kronecker at one time or another I shall mention only the following: Mills, Stanley Hall, Cushing, Gies, H. C. Jackson, H. C. Wood, Jr., Cutter, Carter, Busch, Mühlberg, Mays, McGuire, Arnold and Meltzer. * * *

Physiology lost in Kronecker a master and a leader, and numerous physiologists all over the world lost in him a noble and kind-hearted friend.—*Biochemical Bulletin*, vol. III, p. 345.

For the most poetic expression of "hope in England's just cause" in the present war, that we have read, we must go to the lines written by an American Jew, born in Hungary, if we mistake not, educated in part in Germany, and rabbi and teacher by vocation. Here is a "violation" of neutrality with a vengeance! And yet, the literary critics tell us, this is a decadent age for poetry.

Indescribably mendacious is the only characterization that may be made of the wanton attack on Sir Matthew Nathan's official position by so prominent an Irishman as the Dublin Nationalist, Timothy Healy, M. P. He, of all men, ought to know better than to speak in language unbecoming a man, much less a gentleman, of the holder of an office in a co-ordinate branch of the government!

It is pleasant to know that the Jewish Board of Deputies of England lost no time in securing his release from internment as a prisoner of war of an English rabbi who had never exchanged his Galician allegiance to the Emperor of Austria for the benefits of British citizenship. And equally satisfactory to behold is the prompt compliance of the authorities with the representations of the Deputies. England makes no war, the officials were instant to say, against any minister of religion.

A writer in the Jewish Chronicle informs the public that in or about the year 1861 a Jewish rifle volunteer corps was organized in England, at the height of the enthusiasm engendered by the citizen military movement of that day. Shortly after its establishment, however, it was disbanded, for the good and sufficient reason that the members of the organization were quarreling among themselves as to who should be officers and non-coms, and who enlisted privates; Characteristic! Another reason why a Jewish corps is unthinkable!

We regret to announce that only recently a pogrom, a new one, took place in Lemberg, in Galicia. It is stated that the casualty list includes fourteen Jews dead and thirty-eight wounded. Ordinarily facts of this nature are printed in our news columns, and are referred to only in this place for purposes of comment. To-day the situation wears a different aspect. We offer these facts, culled from the New-Yorker Herald, in this place to our readers, and they are at a perfect liberty to comment upon them in any way they desire.

We read in the Jewish World that the existence of the strife, and the facts of almost unexampled Jewish heroism in behalf of Russia have not served to cause the bureaucrats of that benighted land to abandon one jot or tittle of their programme of restrictions and repressions. In one instance Jews are punished for daring to set foot in portions of the Czar's empire prohibited to them because of their race and faith. In another connection we read that, in the case of the Petrograd University, the educational restrictions on Jews are rigidly maintained. In the face of such conditions what have the Jewry of the world, and even civilization itself, to hope from the Russian bear? Israel Zangwill may torture these isolated cases of persecution into a defense of England's ally; we lack his powers of disputation, and also, fortunately, his blatant assurance.

The American Israelite seems to think that, because the situation of the Jews residing in Palestine is so distressing at the present moment, its counsels of perfection in the past against this species of colonization were well-founded. Indeed, our contemporary sees in the Jewish colonization of Palestine an evidence of the activity of the Zionists. We do not so regard it. We think the Jewish colonization of Palestine is a movement which deserved and continues to deserve well of the Jewish people. Jews fleeing from countries of persecution turned, and for aught we know will continue to turn, their faces toward the Holy Land. Those of our co-religionists living in the land there are pressed by economic conditions of no mean order now, largely by reason of the fact that this colonization has not found itself altogether, and by reason of the system of Chaluḳah which obtains there. But we ought not discuss this matter at a time when our help, unstinted and generous, is demanded.

THE PROBLEM OF EVICTIONS

A NUMBER of the justices of our Municipal Court, all of whom happen to be Jews by race and faith, and who reside in districts which embrace the more congested tenement quarters of our city, have undertaken the leadership in the task of dealing with the large number of unfortunate poor persons who, for one worthy reason or another, are evicted from their squalid habitations by landlords who either cannot or will not indulge them in their payments of rent until the fates are more propitious for them. Sad enough are these cases where the law steps in and forces these persons into the merciless streets. Oftentimes their supply of the bare necessities of life, not to speak of the money actually required to keep a roof over their heads, is grossly and woefully inadequate. These justices, then, are combining their mission as humanitarians with their duty as dispensers of human right and justice, and it is gratifying to know that their example has been supported by many worthy and affluent members of the general community.

The difficulty of the situation, however, is altogether accentuated by the hostility which has developed between the occupants of the bench on the one hand and the managers of the organized charitable societies on the other. On the subject of methodized, machine-like charity our views are, we may say it safely, well known, and need not be repeated at large. The justices who have exhibited themselves as critics of the system of organized charitable relief have evoked a responsive chord in our editorial heart. Although the charities deny that their work and action smacks of what is known, for better or worse, as "red-tape," the fact that the extra-judicial appeal has received liberal pecuniary support serves to show that many among us feel as we do in this matter.

But, a danger lurks in the existing condition of affairs. If every eviction case is to be regarded as the occasion for Zedokoh, we can well behold the time when every landlord will resort to the remedy of eviction on the principle, "What's sauce for the goose is sauce for the gander!" Rapacious landlords will find and be quick to seize premiums, as it were, for their evictable tenants. It is just this condition that the justices must guard against. Their charitable instincts are noble and sincere, and should not be suffered to spend themselves uselessly on unworthy objects.

Premier Herbert H. Asquith, of Great Britain, in a recent speech at the London Guildhall, declared "that the entry of Turkey into the war would end in the downfall of the Ottoman Empire not only in Europe—the traditional object of one school of politics—but in Asia." His words are notable. While Jews are grateful to the Mohammedan Government of Turkey for its uniformly equitable, not to speak of generous, treatment of the Jewish denizens of the country, the possibility for the independent creation of a Jewish state as a buffer (in the parlance of European political diplomacy) looms large on the horizon. That is to say, provided the allies triumph and then, equally, provided the conflicting interests of the various victors permit of this outcome of their negotiations. On the whole, we have still a long, long way to Judaea!

The paper, "The Experiences of a Jew's Wife," in the American Magazine, for December, seems to us to be a sincere and straightforward presentation of facts. Slightly overdrawn here and there, we allow, as in the anonymous mother's final hope that her son, whom she has had baptized and is raising as a Roman Catholic, will marry a Jewess and live as a Jew! The statement, however, that Russia hasn't any monopoly when it comes to persecution of the Jews, is but too true when we recall the urchins of the streets and the landlords of apartment houses in the so-called "exclusive" districts of our cities and their suburbs. And yet, this writer offers an explanation of this social anti-Semitism: it results from inherited prejudices, is quite psychological, for that reason, and altogether defies analysis. "For that reason," and because of its psychological character, then, it may never be eradicated, even under the most ideal and the purest conditions of life. The outstanding lesson of the paper in the American Magazine is its argument against the mixed marriage. This is unjustifiable from every point of view, the religious included, and, debate the question as we will, its solution is none other than this. Of course, the writer possessed more than a little moral courage to commit her inmost thoughts to paper, as she has. But the value of her "human document" is thereby greatly enhanced.

Chanukah this year finds more than one Jew practically applying his knowledge of the deathless story of the Maccabees. We refer, of course, to the presence of so many of our co-religionists on the European fields of battle, under the flag of one or the other of the contending belligerents. Thus, the example of Judas Maccabaeus, one of the truly great heroes of Jewish history, is repeated a thousandfold to-day by his successors of a remote generation. But there is a material difference between his efforts and theirs. He fought and won the fight in behalf of the glorious principle of liberty for his own people and freed them from the diabolical oppression of an anti-Jewish tyrant; the Maccabees of to-day, when the Jewish nation has crumbled into dust and Jews live and very often lose their identity as citizens of alien States, are battling for the right of earthly, non-Jewish rulers, whose attitudes towards them and their faith are as various as their own number. Fortunately, our own blessed country is immune from the scourge of war, and here the Jews may hold high the spiritual banner of the Maccabees and prove by their examples and deeds before all the world, that the high ideals of the ancient Mattathias and his sons are as efficacious now as they ever were in the past. The lesson of Chanukah may be best exemplified here in our free and peace-loving land for the glory of Israel and the honor and enduring prosperity of the Jewish name.

LOVE-GIFTS

וישראל אהב את יוסף מכל בניו . . . ועשה לו כחנת פסים: "And Israel loved Joseph more than all his children . . . and he made him a coat of many colors." (Gen. xxxvii, 3.)

THAT coat of many colors—it was the gift of love. It was inspired by the tenderness of an aged parent. Its hues were no brighter than the mutual flash of affection that lit up the eyes of both father and son in the proud moment when the garment was laid around the shoulders of the lad. Yet that gift of love, that bestowal of affection by a visible token, was the cause of much unhappiness, much misery and much moral perversion. What ugly strands were woven, invisibly to father and son, into that coat! One is tempted to place side by side the Joseph's-coat and the Nessus-shirt. In the Greek story, too, a love-gift in the shape of a garment brought suffering to both the giver and the recipient. It was the cause of the death of Hercules. The latter's wife, Deianira, listening to the dying words of Nessus, steeped her husband's shirt in his blood as a love-charm, which caused Hercules such agony that he killed himself. And if Joseph's coat, in the Hebrew story, did not cause death but rather led to a happy ending, it caused, nevertheless, so much agony that the pain of it still cries out to us from the pages of the Bible.

Shall we then say, Beware of the gifts of love? Shall we say not only, Beware of the gifts of the Greeks, the gifts inspired by hatred wherein death and destruction are cunningly concealed, but also, Beware of those gifts which Love, with the best intention to promote the happiness of the Beloved, fondly and solicitously prepares, but wherein, unbeknown to Love, death and mortal anguish lurk nevertheless? Aye, beware! Young man, thou knowest not what pain thou profferest to the maiden of thy choice when thou layest at her feet the gift of love, the gift of thy person, thy life! Young woman, thou knowest not what fatal struggle thou hurlest him into when thou acceptest his gift, and profferest him life-long devotion in return. Husbands and wives, brothers and sisters, friends and companions, ye know not that the bright beam of affection which falls athwart your path may be the sheen of a glittering sword; ye know not that the crimson rose that blooms in your garden may derive its color from the blood of a cherished heart. Beware then of your well-meant gifts. Above all, ye parents, ye in whose keeping are young lives, beware lest your gift turns into gall, and your tenderness into tears.

What then in the larger sense are those parental gifts that are offered as blessings but which unwittingly harbor in themselves possibilities of evil?

One thinks, in the first place, of that great gift of life through which Love wields its creative power. The child that crosses the fateful threshold has every right to expect that it should enter into a heritage of health and wholesomeness. Every child has the right to be well-born; or else Love's gift—the supreme gift of birth—will turn into an unspeakable curse. But when the gates of mortal breath open, they admit into being not only this new citizen of the world that is to be reared into usefulness and moral grandeur, but also an unseen host of long-dead ancestors that march with it in vast throngs and express themselves through it. A child has not only one pair of parents—those immediately preceding it, but an interminable line of progenitors who have contributed to its constitution and character. The immediate parents are channels through which remote—unaccountably remote—influences stream towards the new life, shaping it and largely deciding its destiny. Heredity then is the second gift of love which may prove a boon or a bane. When the child grows mature, will he or she have a reason, when contemplating the body or scrutinizing the soul where-with it was dowered, to bless or curse this mystic gift of heredity? No conscientious parent can possibly evade this question. Only wise selection of one's life-companion, with a view to wholesome ancestry, can to some extent allay the anxieties that the question of heredity arouses.

More mystic still and proportionately less under human control, is the third love-gift from parents to children—the gift of native talent and temperament. Heredity, either immediate or remote, does not explain any child, or does not explain it altogether. Why from a long line of blacksmiths a master-musician should spring—and the case is not impossible—cannot be explained on any theory. The beats of the hammer on the anvil do not offer a plausible explanation. Why from a long line of illiterate peasants a famous pulpit orator should spring—the case is still less impossible—cannot be explained by any hypothesis of Bible-chapters read and olden stories told at the family hearth. Parents oft present their offsprings with love-gifts which it is not in them to give; and the only thing left us is to believe that such native traits as are not grounded in heredity, are direct endowments from God. Happy the child whose inborn gifts lead it to a higher goal of perfection! But what a burden is it to any child whose congenital endowment is not so felicitous!

The fourth love-gift is environment; the fifth—education. Both are conspicuous and fairly well recognized. Education belongs under the head of environment; for what is education but the larger environment of choice spirits, both living and dead, into which the child is placed? Both Education and Environment offer the great advantage of their being absolutely under human control; praise or blame for their quality, therefore, falls absolutely upon men. Education and Environment, moreover, have it in them to correct the shortcomings due to heredity and innate attributes; the more's the pity that here the greatest blunders are made from good intention—here the Joseph's coat and the Nessus-shirt are put to the greatest use. But the sixth, and largest, love-gift still requires mention. Can parents transmit to their boys and girls a vivid sense of the reality of the Divine? Can they hand over to them reverently the God of the Fathers? Giving a child its true God—that is the highest love-gift.

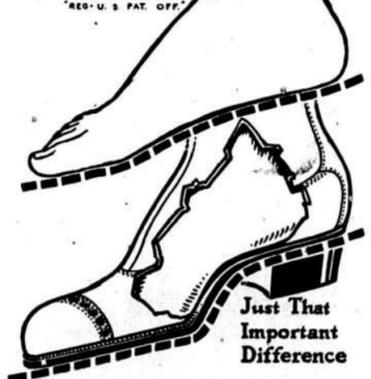

If War Goes to Palestine.

The situation of the Jews of Jerusalem and the rest of Palestine will be pitiable if Turkey is plunged into a relentless war with the Allies.

Syria will be concerned in the war in many ways. It is understood that there are considerable forces of Turkish troops in the country, and whether or not any attempt will be made to employ them in an attack on Egypt they will have to be maintained by the population, for it will be impossible to provision them either by way of the Mediterranean or by means of the land communication from Anatolia. Jaffa will be bombarded if it resists the British and French, and the country may even be the scene of a land campaign against the Turks.

The Jews of Palestine are not likely to be directly molested by the Turks, nor to suffer in case the passions of the Moslem soldiery should be aroused against the Christian population. Of the 100,000 Jews now in Palestine, it is probable that the great majority were originally Russian subjects. They are not, however, Russian sympathizers, and it is not conceivable that the Turkish government would persecute them on account of their political origin.

But, as the returning American consul at Jerusalem has lately stated, the Jews of that city are in a state of abject want. All business is at an end; there are no industries, no tourists, nothing to do. The cessation of all intercourse with foreign countries would interrupt even the benefactions upon which these people are now living and would hurl many of them into actual starvation. —Evening Mail.

At the recent convention of the Federation of Jewish Farmers, held in New York city, a number of Sullivan County farmers reported that raising pigs paid much better than keeping summer boarders.

During the past year the Committee on Immigrant Aid of the New York Section Council Jewish Women besides making a study of the destinations of 16,407 girls arriving from Europe, gave money to 1,670 and other aid to almost 1,000.

Numerous bequests to charitable institutions are made in the will of the late Joseph Gallinger, of Pittsburgh, Pa. Among them are: Montefiore Hospital, \$2,000; J. M. Guskv Home, \$1,000; Jewish Home for Aged, \$2,000; Mount Sinai Hospital, New York, \$2,000; Old Peoples' Home for Jews, \$1,000; Tuskegee Institute of Tuskegee, Ala., \$1,000, and National Jewish Consumptives Hospital at Denver, Col., \$3,000.

After a long and protracted illness Gen. Louis Seasongood, of Cincinnati, Ohio, died at Atlantic City, N. J., last Sunday, where he had gone in search of health. General Seasongood was seventy-four years of age, and had earned his title by the performance of gallant work during the Civil War. He was the owner of large real estate interests in New York and Cincinnati, and his fortune is rated as very large.

Owing to the war it has been decided by the directors of the Jewish National Fund to transfer the head office to a neutral country. Dr. D. Bodenheimer has therefore resigned from the chairmanship of the Board of Directors, and the head office of the National Fund has been transferred to The Hague, Holland, under the temporary supervision of Mr. Jacobus Kann. All National Fund moneys should be sent as heretofore to the established bureau in each country.

Andor Fantl, a merchant from Budapest, who enlisted as a private at the beginning of the war, was sent to the Serbian boundary, where he displayed unusual courage. In the midst of a hail of shrapnel he removed nearly a hundred wounded soldiers from the battlefield with his bare hands to a place of safety. In recognition of this he was awarded a medal by Prince Joseph, his superior. His father was also a soldier, and now both his sons and his son-in-law, all the male members of the family, are fighting at the front.

Harry Yudelson, a noted charity worker in Philadelphia, Pa., died on the 20th ult. He was one of the founders of the Central Talmud Torah, the Jewish Sheltering Home for Aged and actively interested in virtually all the other Jewish institutions in Philadelphia.

One of the oldest Jewish residents of Richmond, Va., Mr. Jonas Marcuse, passed away last week in his eighty-fourth year. Mr. Marcuse had lived in Richmond for over half a century and was the oldest member of the Beth Ahaba Congregation.

An additional appropriation has been made for the Hebrew Institute building at Fort Worth, Tex., thus insuring its entire completion for the Texas Zionists convention, which takes place on December 27.

Mr. Jacob H. Schiff has resigned his membership in the Japan Society. Mr. Schiff's reason for resigning is understood to have been his strong sympathy for Germany in the present war and his inability to reconcile his views to Japan's alliance with the Allies in the European contest.

Mr. Isaac N. Seligman has declined the treasurership of a fund which a number of Municipal Court Justices propose to establish in New York city for the relief of those who are in danger of eviction. Mr. Seligman maintains that the matter should be dealt with by the existing charitable organizations.

Weber and Fields, who are now at the managerial end of the theatrical business, have had New York successes this year, the former with "The Only Girl" and the latter with "The High Cost of Loving." It is rather a coincidence that both these plays are the work of a rising Chicago dramatist, Mr. Frank Mandel.

The Judicial Chamber of Moscow last month considered the appeal of twenty Zionists of Eletz. Six of the accused, including five women, were successful in their appeal and were acquitted. In the case of the remaining fourteen their sentences of imprisonment to various terms (between three months and ten days) were confirmed.

Gutman and Borin, two Russian Jewish soldiers, who have had distinctions conferred upon them, have been recommended for additional honors. The first-named will receive a gold medal and the other has been made sergeant. "I shall never forget you and your courage," was the exclamation of the colonel of the regiment in which Gutman is serving.

Rabbi Theodore F. Joseph, of Allentown, Pa., recently visited Lehigh, Pa., and organized a religious school that will meet every Sunday morning. About fifty pupils will attend, some of them coming from nearby towns. Rabbi Joseph is acting superintendent of the school. He will visit Lehigh every Sunday till the school runs smoothly.

On the outbreak of the war the Austrian police imprisoned a number of Russians at Carlsbad, among them the well-known lawyer, M. Hillerson. Jewish organizations made an effort to obtain M. Hillerson's release, and their endeavors were on the point of proving successful. He declined, however, to accept any favor unless all Russians without distinction of race or creed were released, for he pointed out that he had always fought for the principle of abolition of distinction between races and creeds in Russia.

Although the question has not yet been decided by the Cabinet, it is confidently stated at the Ministry of Education that all Jewish students enrolled in the Russian army will, at the end of the war, be readmitted into the high schools without restrictions. A bad impression has, however, been created at Kishineff by the rejection of the petition of the Zemstvo that the son of Dr. Stern, a distinguished Jewish army doctor (now at the front), and also medical officer to the Zemstvo, should be allowed to enter the local foundation school irrespective of the percentage norm.

CHILDREN'S PAGE

SEVEN CHARACTERISTICS

Dear Children:—"There are seven characteristics of a boorish man, and seven of a wise one. The wise man will not speak before one who is his superior in wisdom or exceeds him in years or in experience, or interrupt another when speaking, nor will he give an ill-considered answer; he will shape his questions and answers in accordance with the matter under discussion, speaking of what first occurs first, and of what is last last; concerning that of which he has not heard, he confesses his ignorance and is ever ready to admit the truth. The reverse of all this, however, is the case with the boorish man."

To understand the above maxim it is necessary for you to know what our sages have meant by the title "Haham" or "wise one" and "Golum" or "boorish man." The "Haham" or wise man, says Rabbi Naphhtali Hertz Wesley, of blessed memory, as understood by the Torah and the sages, is not the astronomer or mathematician nor the scientist, theologian or logician, but the one who is wise in the Torah, for there is no wisdom that emanates from man's own intelligence or understanding. All wisdom originates from the Holy One, blessed be He; He is the Infinite Intelligence who has made wisdom known to man through the prophecy of Moses, peace unto him. This is comprised in the written and oral law; this wisdom is infinite and one must receive it from a rabbi who, in turn, has received it from another rabbi, and so on, until the first human source is reached. Our lawgiver, Moses, on Mount Sinai—this is tradition—and he who has gathered these words of wisdom and has made his actions harmonize with his learning so that he conducts himself wisely, is called "Haham"; but though one has gathered the words of wisdom, if he doesn't act according to his learning, he is not a "Haham" or wise man. The "Haham" is the delight of humanity because all his qualities, words and passions are perfectly attended in harmonious accord, the keynote of which is righteousness. The "Golum" on the other hand is the one who has not properly digested the learning he has received and has not made his actions harmonize with the learning of the Torah—he is yet "the raw material"—"the unfinished product," the unsharpened and unpolished blade." He needs a great deal of learning and a good deal of practice in good deeds before his converse with mankind can afford pleasure to the world.

Before the wise man speaks he is careful not to say a word before one who is wiser than he, or even if not as wise as he; older than he, or even though less wiser or younger than he, but has more experience in that matter, which is the topic of discussion, has spoken his meaning.

When his companion speaks the wise man is silent and listens intently until he has finished his entire argument, no matter how erroneous may be his views, or how illogical his reasoning, he does not allow impatience to betray him into interrupting the speaker, lest confuse his mind and not give him the oppor-

tunity of concluding with some words of wisdom of which he may learn something.

After his companion has finished speaking the wise man does not hasten to answer, but considers well what merit there may be in the speaker's argument and then carefully thinks of what reply he shall make.

When the wise man begins to speak he shapes his questions and answers in accordance with the matter under discussion, not seeking to show off his learning by bringing into the discussion matters that have no connection with it whatsoever.

In the course of his argument the wise man speaks of what first occurs first and of what is last last, thus keeping the issues clear by the orderly arrangement in which he presents his views.

If there is a point which the previous speaker brought up in his discussion which is new to the wise man as he did not hear of it before, he is not ashamed to confess his ignorance.

If after the wise man has spoken, his companions dissent from his views and he sees that their argument is just, he does not allow foolish pride to prevent him from admitting the truth.

The reverse of all this, however, is the case with the boorish man. Knowing himself to be possessed of great intelligence and understanding there is no restraint imposed upon him by the presence of men greater than he in wisdom, years or experience, and when his companion talks he will not allow him to finish, but will attack his argument and make nothing of it; whereas, if he had allowed him to finish he might have learned something. And when he does answer him it is in a hasty, ill-considered manner, without due deliberation; and when, deep in his heart, he knows that he does not know what he is talking about, he seeks to beg off the issue by bringing up matters that have no connection with the subject, his unpolished mind not giving the argument in the proper order in which it should be presented. And if there was a point in the first speaker's argument that is new to him he will carefully refrain from touching upon it lest his ignorance be revealed and his pride hurt. And when he has finished speaking and the fallacy of his argument is clearly proven to him by his companions he will stubbornly uphold his views to the last; although in his heart he knows that he is wrong, he will think it degrading to admit the truth.
