PLANNING FOR UNITED WAR WORK CAMPAIGN

Plans are being perfected for the United War Work campaign during the week of November 11-12, to raise \$170,500,000 for the seven organizations, Protestant, Catholic and Jewish, that are co-operating for the welfare and morale of America's fighting forces. The Jewish Welfare Board, the youngest of the war work organizations, formed particularly to look after the happiness and spiritual guidance of the 125,000 Jews in the army and navy, though it ministers to Jews and Gentile alike, is taking a prominent part in the nation-wide arrangements for the campaign.

Mr. Fred B. Smith, the Y. M. C. A. leader, who recently returned to New York from a conference to perfect plans for the drive on the Pacific Coast, told the leaders of the J. W. B. in New York that the Jewish people were assuming the drive on the Coast, with Mr. Jesse Lilienthal as chairman of the War Work Campaign for that district. According to Mr. Smith, Mr. Nathan Eckstein, of Seattle, made such a powerful appeal in conference there, that he was taken to many other conferences to arouse enthusiasm.

Mr. T. B. Brockman, associate secretary of Dr. John R. Mott, general director of the United War Work Campaign, recently returned from conferences in Oklahoma, Texas, Arkansas and Louisiana. Writing to Mr. Jacob Billikopf, the representative of the J. W. B. in Dr. Mott's cabinet, Mr. Brockman says:

"The representatives of the Jewish Welfare Board on the program of the different conferences gave splendid accounts of themselves. The deepest spiritual note was struck by the Jewish delegates."

A particularly striking impression was made at the St. Louis conference by Rabbi Leon Harrison.

The spirit of co-operation among the seven war work agencies was strikingly illustrated this week when fifty-eight field workers, representing the Tenth Class of the J. W. B. Training School left for their posts at the various camps and naval training stations. The principal speaker at the graduation exercises was Col. William S. Barker, of the Salvation Army, who has had charge of the Salvationists' field forces overseas ever since the first contingents of the American Army arrived in France. Colonel Barker's visit here lasted only seven days, but he gave a whole evening of his time to give the Jewish field workers the benefit of his ripe experience.

"What the boys in our fighting forces need more than anything else," said Colonel Barker, "is inspiration and heart and character in those who are there to help them."

"You will represent the character and ideals and standards of the Jewish faith. If you are to succeed you must sink your individual ideas in the faith and the ideals of the organization you represent."

"You will have two responsibilities, social and religious. The greater of these is the religious. I believe the great popularity and success of the Salvation Army in this war work has come because we have endeavored to be consistent in our religious practices. If you practice what you preach, that is all you have to do. Live up to the principles of your faith and the boys will respect you Jew and Protestant and Catholic alike, but remember that fine buildings, good food and such things will not avail unless you touch the heart of the man in uniform. If you go to him with a heart big with love you can accomplish great things."

Mr. Louis Marshall, thanking Colonel Barker, on behalf of the directors of the Jewish Welfare Board, said that the strength of the Salvation Army with our field forces lay in the deadly earnestness with which its workers approach the performance of their duty.

"We must emulate this spirit," said Mr. Marshall. "Remember that you must be one of them—a brother in reality—and then you will be useful to them. The most important part of your work, in my mind, is the religious side. Above all things, you must have loyalty; loyalty to your faith and to the flag of your country."

NEWS FROM ENGLAND

(Exclusive Correspondence to the HEBREW STANDARD)

Soldiers and the New Year—Jews and Bolshevism—Manchester Jews Meet Lloyd George and Secure Gratifying Response—Medal for Palestinian Judeans—Sir Frederick Nathan and Jewish Lads' Brigades—Unification of Efforts of Jewish War Workers.

London, Sept. 20, 1918.

Everybody has been commenting upon the large number of Jewish soldiers who were seen in London on the occasion of the New Year—everybody, that is, who is not a Jew here. People passing through the East End had some of their old misconceptions rapidly and violently removed by the size and extent of the Jewish fighting forces and widespread comment and enlightenment appears to have been the result. The Jews attending services here included not only Britishers but co-religionists from America, Canada, Australia and South Africa, and some remarkable scenes were witnessed.

It is not to be wondered at, perhaps, that the Jews in this country resent very much the suggestion—based on the alleged Jewish origin of Trotzky and of a few other Bolshevist leaders—that Jews are to be found out of all proper proportion among the Bolshevists. They point out that Great Russia, from the industrial workers of which the Bolshevists draw their main strength, has been under Russian legislation closed for centuries to the Jews. For this and other reasons the proportion of Jews among the Bolshevist rank and file is infinitesimal. In point of fact, the Russian Jewish parties, including of Jewish Labor party—the Bund—though old opponents of Tsarism, are said to be anti-Bolshevik and anti-German to a man. The Social Democratic party and the Social Revolutionary party—the strongest opponents of Bolshevism—include many Jewish leaders. Thus, in the former, Deutsch, Dan Liber, Axelrod, and Martov are all Jews, and in the latter Sternberg, Gotz, Minor, Fundaminsky, and Roubanovitch. Vinaver, who has kept the Cadet party on the side of the Allies against the efforts of its pro-German president, is intellectually the head of Russian Jewry. Sliosberg, who was second only to him in the confidence of Russian Jewry, was actually murdered by the Bolshevists. It may be noted also more than a coincidence that the assassin of Count Mirbach was a Jew, that Dora Kaplan, the woman who shot Lenin, was a Jewess, and that it was a Jew who killed Uritzky, the Bolshevist "Home Secretary." The Russian Jews have in any case little reason to love Trotzky, who, in refusing certain minor concessions to Jewish feeling in connection with the Feast of the Pass-over, told the deputation that nothing Jewish had any interest for him.

Premier Lloyd George a week ago paid a visit to Manchester to deliver an important speech there upon Allies' war aims, etc. Opportunity was taken of this occasion by Manchester Jews to meet him by means of a deputation representing the most important communal Zionists and friendly societies amongst Manchester Jewish organizations, and a very interesting function took place. The deputations consisted of Nahum Sokolow, Simon Marks, E. H. Langdon and Nathan Laske, who is an executive officer of the Board of Deputies of British Jews. An address was presented to Lloyd George signed by this delegation and by other prominent Jews of the Manchester community. It placed on record Jews' gratitude for the interest shown by the British Government in the fulfillment of Jewish national aspirations and expressed confidence that the historic declaration of November 2, 1917, expressed not only the British Government's own considered policy but the permanent attitude of the British nation towards the Jews. Other items were also covered in a general sense.

In his reply Lloyd George said: It is with feelings of the greatest satisfaction that I accept the address which you have done me the privilege of presenting to me. The aspirations which you share with multitudes of your race scattered throughout the world found a natural re-

sponse in the minds of those responsible for the government of this country, because they are in permanent accord with the sentiments of the people of Great Britain. I have today had the honor of receiving addresses from the representatives of three elements most intimately concerned in the establishment of a rule of order and justice in an area which has hitherto been the prey of tyranny and outrage. The fulfillment of the historic hopes and aspirations to which you refer in your address is, I believe, an essential corollary to the necessary enfranchisement of the oppressed peoples of the Near East.

Very interesting accounts have reached this country on the recruiting of Palestine Judeans. In connection with this the medal issued to these recruits is noticeable. It has a design of historic import. When the Romans conquered Palestine and subjugated the Jewish people, a medal was struck showing Palestine as a woman bound with chains, a Roman soldier facing her in the act of piercing her with his sword, the figures being symbolic of the Roman subjugation of the Jewish people. The medal now issued is identical with that struck by the Romans on the occasion above referred to, but it shows the chain which bound the woman broken, and the Roman soldier, with his back towards her, leaving her, symbolic of the return of the national freedom of the Jewish people and of the liberation of Palestine. The inscription on beneath—"Judea Delivered"—is the exact opposite of that of the Roman medal, the motto of which was "Judea Subjugated."

Col. Sir Frederick Nathan, commandant of the Jewish Lads' Battalion, has issued an important appeal to the community in connection with the training of these boys. The Jewish Lads' Brigade was originally founded by Col. A. E. W. Goldsmid in 1895, and has done great work in training the Jewish lads in habits of orderliness, cleanliness and honor, as well as in teaching them the elements of military discipline and drill. In consequence of the war the brigade has lost most of its best and most earnest officers and a large number of new men of this character must be obtained to take their places. That is the main object of Commandant Nathan's appeal. Men with army experience are asked for, as they are valuable, but previous knowledge of military drill is by no means essential and two evenings a week is sufficient time for any one person to spend on the work. The boys are mainly between the ages of 14 and 17. Sir Frederick continues:

"I wish to point out clearly to the community that unless sufficient support is received to make this extension possible, the government will inevitably actively encourage the formation of a rival cadet corps in the centers of Jewish population, and the lads will be brought under non-Jewish instead of specifically Jewish influence. Thus the first seeds will be sown for their drifting away from Judaism. Much of the work of the community in the direction of Jewish education and religious training must prove useless and become nullified if our young boys are to be drafted into cadet corps in which the Jewish element is entirely lacking, and in which they would inevitably be led to disregard the Jewish Sabbath and Jewish laws, as well as to attend Christian service."

As a result of the conference of Jewish war workers, which I mentioned last week, a general council for welfare work amongst Jewish soldiers has been formed. The new body will coordinate the scattered efforts of existing organizations and will add tremendously to their efficiency. It will also form a center or clearing house for all efforts made for the welfare of Jews who are serving in the Army or Navy. There is very much work that it could and must do, and all success will be wished to it.

Sir Adolph Tuck has to report the gratifying news that a generous anonymous benefactor has paid the whole of the deficiency of the year's accounts of Jews' College. It is still regarded, however, that the fact that this splendid institution should be allowed to incur such a big deficiency is none too creditable to Anglo-Jewry. There are plenty of wealthy men and they spend their money freely in all kinds of charitable ways. How such a fine educational institution should have been overlooked is mysterious.

Turkish Troops Rob Jewish Colonists of "Achedrah" and "Zechron Jacob."

London (By J. C.).—When the Turkish troops, driven by General Allenby's victorious army evacuated the Jewish colonies "Achedrah" and "Zechron Jacob," they took along with them all the colonists' cattle and farm implements, according to dispatches from Dr. Eder, a member of the Zionist Palestine Commission, who is now in the recently conquered Turkish territory. Dr. Eder states in his telegram, the colonies were left in a comparatively good state, because the Turkish soldiers were hotly pursued by the British armies, and they therefore did not have sufficient time to destroy the colonies.

What Rabbi Kohn Saw "Over There."

Rabbi Jacob Kohn, of Temple Anshe Chesed, who went to France three months ago as a member of the Overseas Commission of the Jewish Welfare Board, has returned with a story of the men of all creeds working together in the highest spirit of helpfulness at the front. During the Holy Days Rabbi Kohn conducted services at General Pershing's headquarters—for 500 to 600 Jewish soldiers. He held a special service just back of the lines in the ruins of a cathedral. He was at the front at the beginning of the St. Mihiel offensive, and served seventy-two consecutive hours as volunteer orderly in a field hospital.

Dr. Kohn emphasized the need for more Jewish field workers at the front. He said:

"In Paris we have already received thousands of letters from Jewish men, testifying to the need of religious ministrations, as well as from Christian army officers and chaplains telling us that the men are clamoring for prayer books and for Jewish services; that they are willing to co-operate, to furnish the prayer books and to hold services, if we tell them what to do. I was very much impressed with the vitality of Judaism. The boys become inspired with a strong religious feeling while in the battle danger, and those who are away from immediate danger want to satisfy this genuine need for Judaism. Of course, the army encourages every manifestation of Jewish life. I have been told by an army officer that nothing is better for the American boy in the army than constant religious inspiration."

When Dr. Kohn was asked to organize services for Jews during the Holy Days the Y. M. C. A. placed its auditorium at general headquarters at his disposal. "We did some searching, and finally we found an old, neglected scroll of the law which had been in charge of an old Frenchman in the village, who had conducted services many years before," he continued. "We also found a shofar, and, with the co-operation of the Y. M. C. A. authorities, we transformed the auditorium into the semblance of a synagogue."

"The services, as far as possible, were in the traditional fashion, somewhat abridged, but with the addition of the English prayers. There were present from 500 to 600 enlisted men and officers from headquarters and points in the vicinity. In addition to the American Jews there were French Jews, Algerian Jews and British Jews present. I feel that it was the most responsible congregation any minister ever addressed."

"We had a similar service on the Day of Atonement, the men participating even to the extent of reading from the Law and chanting the memorial prayers. On the evening of New Year's Day some of the men permanently stationed at great headquarters arranged a simple dinner at the modest hotel in the town in order to produce as far as possible the home atmosphere. As guests we had Bishop C. H. Brent, Chief Chaplain of the American Expeditionary Forces, and the Mayor of the town. The guests paid a tribute to the spirit of the Jews with the Expeditionary Forces. Chaplain Dougherty was present on the second day of the services and said a few words of greeting to the men."

"On the afternoon of New Year's Day I visited a shell-shock hospital where twenty Jewish men were assembled. A special tent had been set up on the hospital grounds for the services, which was arranged with the co-operation of the hospital authorities."

Liberated Samaria and Galilee Need Much Help.

Dr. Eder and Cavaliere Bianchini, members of the Zionist Palestine Administrative Committee, have made an inspection of the territory set free by General Allenby's recent victorious advance.

They have cabled to the Zionist organization of America that they have also visited Chedera and Zichron Jacob, where conditions were not as bad as may have been expected. The colonies, however, need funds to replace the cattle of which they have been robbed and to restore damaged property as well as to restock their farms which have been denuded during the war. The constantly increasing extent of the liberated territory requires a proportional expansion of relief funds. Considerable assistance will be required for opening up the Jewish colonies in Samaria and Galilee which have been war victims for the past four years, and large sums of money will be required for the repatriation of the exiles who were banished to Samaria and Galilee prior to the liberation of Jerusalem a year ago. The members of the commission pay a very high tribute to the brave Jewish pioneers who stuck to their posts in Samaria and Galilee in the face of all risks and out of their undying attachment "to the sacred soil of Jewish Palestine."

Liberty Loan Campaign at Y. M. H. A.

The Young Men's Hebrew Association, Ninety-second street and Lexington avenue, has organized all its forces for a vigorous campaign for the Liberty Loan. The young men have taken for their goal the sum of \$200,000, and every group in the building has taken a portion of it for its quota. During the three weeks of the campaign every club, class and entertainment gathering is being canvassed thoroughly by eloquent and aggressive speakers. During the last week a team of speakers will tour Harlem under the leadership of Mr. A. Frank.

ITEMS OF INTEREST IN THE JEWISH WORLD

Mr. Meyer N'ssim, M. A., has been elected a member of the Bombay Port Trust.

M. Erlanger has been unanimously elected president of the Lucerne Great City Council.

A congregation has been organized among the Jewish students attending the University of Missouri.

The newly erected synagogue of the Congregation Beth Shalom (Orthodox), at Kansas City, Mo., has been dedicated. The building was erected at a cost of \$15,000.

A permanent congregation has been organized at Corpus Christi, Texas, under the auspices of the Union of American Hebrew Congregations.

Mr. Arthur M. Samuel a former Lord Mayor of Norwich, has been adopted as Unionist candidate at the next general election, for the new Farnham Division of Surrey.

Isaac B. Myers, well known in Memphis, Tenn., labor circles, passed away last month at the age of 58. He was at one time president of the Trades and Labor Council.

Solomon Asher, Philadelphia's pioneer dancing master and well known in the community, passed away last week. He was a Civil War veteran and opened his first dancing school fifty-five years ago.

Mr. Herman Dilsheimer, Sr., of Philadelphia, has been nominated for the Pennsylvania Legislature in the district comprising the Eleventh and Twelfth wards, to succeed the late Henry Gransback.

The epidemic of Spanish influenza now prevailing throughout the country has resulted in the closing of the synagogues in a number of large cities among them Philadelphia, Boston and St. Louis.

Jewish and Greek subjects in Eastern Macedonia suffered terribly during the temporary Bulgarian rule of that country, it has been proved by investigation. Most of the Jews in Seres were deported and many died from hunger.

The Rev. Philip Elte, chief editor of the *Nieuw Israelitisch Weekblad*, of Amsterdam (one of the oldest Jewish newspapers published on the Continent), has died in that city at the age of 74. He was a scholar and author of considerable renown in Holland.

For the first time since the emancipation of the Jews in France, 125 years ago, its diplomatic service has been opened to a Jew, in the person of M. Kahn, consul-general at Shanghai. He has now been appointed minister plenipotentiary to Siam.

Dr. Chaim Weizmann, head of the Zionist Administrative Commission, arrived in London on October 9, and was greeted by Zionist leaders and representatives of the Anglo-Jewish community in London. He brought the thanks of the Jews of Palestine to the British people for their release.

David Hochstein, the well-known American violinist, has just been made a lieutenant in France. Lieutenant Hochstein, after having served with the cannon platoon in the front line, was put into the officers' training school, from which he has just emerged as a commissioned officer.

Louis N. Stein, president of the Stein-Bloch Company, died recently at his home in Rochester, N. Y. Born in Geneva, N. Y., sixty-five years ago, Mr. Stein had been president of the Stein-Bloch Company since the death of his father, Nathan Stein, founder of the clothing business, in June, 1908. Mr. Stein was prominent in business circles of Rochester and was noted for his many gifts to charities.

The position of the Jews at Smolensk remains very precarious and the entire Jewish population is in a state of panic owing to the threats of part of the Bolshevik garrison that they intend to massacre the Jews. Our co-religionists spent many nights in hiding places, but fortunately the other half of the garrison, which is opposed to the massacre policy succeeded in restoring order on the few occasions that the anti-Semites commenced their vile work.

A movement to drive out all Galician Jewish war refugees from Vienna has been started by a powerful group of Austrian anti-Semites. The anti-Semites are trying at first to rob all the above referred to Jews in Vienna of the right to participate in elections. The next step would be to compel all the Galician Jews to leave the capital. The Mayor of Vienna is at the head of the movement, which is also being supported by the large newspapers.

Jesse W. Lilienthal, of San Francisco, president of the United Railroads and a leader in civic affairs, has been appointed chairman of the California State Committee in charge of the United War Work drive to be made from November 11 to 18 by seven war work organizations, including the Jewish Welfare Board.

Mrs. Rose Lowenthal, of Chicago, Ill., secretary to Congressman Medill McCormick, died last week of Spanish influenza. Mrs. Lowenthal had been identified with Illinois politics since the Republican-Progressive movement was inaugurated. In 1912 she became private secretary to Edwin W. Sims. Since then she has been the personal secretary of the present candidate for United States senator.

On the occasion of the death of Chief Rabbi Dr. Gudemann, the Emperor, the Premier, many Ministers, the ecclesiastical chiefs of the Protestant and Catholic Churches, and the Commandant of Vienna, Field Marshal Nossig, sent messages of condolence to the Jewish Community at Vienna.

Rabbi Abram Hirschberg, for the past twenty years minister of Temple Shalom, of Chicago, Ill., has received an indefinite leave of absence and has entered the training school for army chaplains at Camp Taylor. Mr. Joseph L. Baron, a student at the Hebrew Union College, will occupy Rabbi Hirschberg's pulpit.

As a result of the protests of Jews against the indifference and, in some cases even complicity—of the police in the pogroms in Galicia, a police official, Stephen Zazel, was charged at Cracow for having failed to counteract the acts of the rioters. Unmistakable proofs of his neglect to protect the Jews were produced, and army officers went into the witness box to confirm his criminal attitude. Kazel was sentenced to five months' imprisonment. He was also dismissed from the force and deprived of his decorations.

The will of the late Emil Wolf, of New York, who died last January has been appraised by the authorities. Among the beneficiaries are National Jewish Hospital of Denver, Sydenham Hospital, Hebrew Orphan Asylum and Ethical Culture Society, \$22,000 each; Educational Alliance Hebrew Infant Asylum, Hebrew Technical School for Girls, Home for Aged Hebrews, nearly \$8,000 each; Mount Sinai Hospital, \$9,000; Montefiore Home and United Hebrew Charities, \$33,000 each; Emanu-El Brotherhood and Emanu-El Sisterhood, nearly \$4,000 each.

Some time ago the Bolshevik authorities, on the plea that thefts had occurred at the Petrograd Jewish Museum, sealed the building. In error, they also sealed the adjoining residence of the famous Jewish writer, M. Ausky. Our co-religionists set to work to prove that the Bolshevik accusations were false, and succeeded in prevailing upon the authorities to remove the seals and reopen the museum. At the same time, however, the Bolshevik authorities upheld the decree placing the Jewish libraries, including that of the late Baron Gunzburg, under their control.

The *Judische Rundschau* of Berlin, commenting upon the decision of the Polish Government to grant certificates of citizenship only to those who acknowledge themselves to be Poles, states that this decision is virtually a declaration of a war of destruction against Polish Jews, and that the inevitable result of it will be the enforced emigration of Jews from Poland—which appears to be exactly what the Polish Government desires to bring about.

Mr. Isaac Goldberg, of Wilna, a noted Russian Zionist who recently arrived in England on his way to Palestine, has completed the purchase of the site on Mount Scopus in Jerusalem, which he had handed over to the Zionist organization for the Hebrew University. The land was at one time the property of the late Sir John Gray Hill, of Liverpool, former president of the Law Society and a nephew of Sir Rowland Hill, the postal reformer. Sir John took a great interest in the Hebrew University question as well as in Zionist work generally, an interest which has been continued by his widow from whom the land has been purchased.

Under the inspiration of Rabbi Louis J. Kopald these sentiments were crystallized in the form of a memorial, through the voluntary subscriptions of members of Temple Beth Zion to a fund of \$500.

Public Lectures at Central Jewish Institute.

Under the auspices of the Board of Education, a series of free public lectures is now being given on Wednesday evenings at the Central Jewish Institute, No. 125 East Eighty-fifth street.

The Work of the New York Jewish Welfare Branch.

The Jewish population of the city is rapidly becoming cognizant of the existence of the New York Branch of the Jewish Welfare Board through the many activities which have sprung up during the few weeks that the reorganized local board has been in existence.

Before many months, it was realized that there was very little tangible evidence of activity on the part of Jewish organizations in connection with the needs for welfare work among not only the men of the Army and Navy who live in New York, but more particularly among the increasingly large number of unformed men who spend a few days in New York while on their furlough, and also visiting men from the nearby camps.

So far the local board has established six centers, all of which are in active operation, and it is now believed that the number of these units will be rapidly augmented, since there is a decided willingness on the part of constituted Jewish organizations to affiliate. The main unit and the headquarters house occupies a five-story modern American basement house at 89 Park avenue, which is situated a block and a half south of Grand Central Terminal, and which is easily accessible by all of the existing methods of transportation.

Through the courtesy of Mr. Max D. Steuer and the managers of many New York theatres, the Welfare Board is able to provide free admission to some of the leading theatres.

A complete information bureau is conducted under the chairmanship of Mr. Louis J. Robertson, which answers the innumerable questions of the unformed men, through relatives and friends who apply daily.

A social service department, in charge of Dr. S. E. Goldstein, with a corps of assistants, provides material aid to the men in the war hospitals.

The Religious Committee, in charge of Dr. Elias L. Solomon, provides religious services at burials of Jewish soldiers and also undertakes ministrations to the men in the hospitals and camps.

Many of the enlisted men have left behind unfinished business and legal matters, and for such a legal aid committee in charge of Mr. Edgar J. Nathan is doing effective work by supplying the best legal talent obtainable without charge to the men.

Contact with other existing organizations is brought about through a committee on co-operation in charge of Mrs. William D. Sporborg.

To make the facilities of the board known to the men in the service and their friends a publicity committee in charge of Mr. Milton Biow has prepared four-color posters, using a design and supplies through the courtesy of Mr. Louis Wiley of the New York Times.

The first additional unit was established at the building of the Y. M. H. A. at 92d street and Lexington avenue. Here sleeping facilities for a minimum of sixty men have been provided with a canteen in charge of Mrs. Samuel Schulman.

The second unit was established at the Y. W. H. A. at 31 West 110th street where dances are held twice a week for unformed men.

The third unit is known as a Columbia Unit, at 405 West 117th street, where, under the leadership of Mrs. Solomon Schechter, a canteen serving meals in conformity with the dietary laws is already in active operation.

In co-operation with the New York section, Council of Jewish Women, semi-weekly dances for the enlisted men will be undertaken under the leadership of

German Support of Zionism Insincere.

In *Die Grenzboten*, the well-known deputy Schulerat Eberhard, contributes an article on "The Palestine question, and its significance for Germany," in which he describes the aims of the Pro-Palastina Committee as follows:

"Pro-Palastina is not a Zionist nor even a Jewish society, but a body in which members of all the chief political parties of Germany along with representatives of science, art and the press, have banded themselves together in order to procure the moral support of public opinion and of German policy for the carrying out of a comprehensive scheme of colonization in Palestine. The society starts from the fundamental idea to which recent events have given increased prominence that the economic and cultural strengthening of Turkey is of essential and pressing importance for German foreign policy, and that the increasingly successful activities of the Zionist organization completely fit in with this vital interest."

The writer admits that Germany is in a more difficult position in regard to Zionism than England, because she has to take into account the political susceptibilities of her Eastern ally. He frankly regards German support of Zionism as a move to counteract British influence in the East, and confesses that England, by her policy, is securing the friendship and support of Jewish influence throughout the world.

Dr. Mossinsohn to Lecture in Harlem.

What role the Jews are to play in the world as it will be reconstituted by the Peace Congress after the war will be discussed by Dr. Ben Zion Mossinsohn, rector of the Jewish High School of Jaffa, Palestine, at Temple Israel, Harlem, 129th street and Lenox avenue, on Sunday evening, October 20. The lecture will be preceded by a musical program. Judge Samson Friedlander will preside and Rev. Maurice H. Harris will also speak.

A Soldier's Legacy.

The Jewish National Fund Office in New York has received the following letter from Israel Raskin, Washington, who is at present in France: "In this letter you will find my testament in favor of the Jewish National Fund. In the event of my death you have the right to take possession of the money." The will, which is dated June 8, 1918, and is drawn up with three other Jewish soldiers as witnesses, runs as follows: "This is the last will and testament of Israel Raskin, Washington. In the event of my death I bequeath the Jewish National Fund the sum of \$540, plus interest, deposited in the Post Savings Bank at Washington, and I appoint the Jewish National Fund as executor of the testament."

Mr. Mason Reports on Jews in the Far East.

Prominent Jews from all over the country attended the meeting at Cooper Union on Saturday evening, October 12, 1918, at which the report of Mr. Samuel Mason, special representative of the Hebrew Sheltering and Immigrant Aid Society of America to the far east, and who recently returned from Japan and Siberia, was submitted. Mr. Mason was unable to be present, as he was suffering from Spanish influenza. The report was therefore read by the president, Mr. John L. Bernstein, who presided at the meeting.

The meeting was opened with prayer by Rabbi Herbert S. Goldstein, and addresses were made by Hon. T. B. Hohler, counselor, British Embassy, Washington, D. C.; Hon. Chonosuke Yada, Japanese Consul-General, New York; Mr. Louis Marshall, Mr. Isidore Hershfield, Mr. Jacob Massel, Judge Leon Sanders and Lester L. Schmare. Rev. Emanuel Shafer sang "The Spar Spangled Banner" and the "Hatikvah."

In his report, Mr. Mason dwelt upon the situation in Yokohama, the facilities provided for the refugees on their way to America, upon the 1,706 refugees who were assisted to leave for the United States and other countries, the road the immigrants are compelled to travel, the character of the refugees, the influence of the society upon Jews in Japan, the efficient and splendid co-operation received at the hands of the representatives of the United States, Japanese and British governments, as well as from Russian officials, the privileges obtained in Manchuria, the problems of transportation, the cost of operation and the need of the future.

Most interesting was the address delivered by Mr. Chonosuke Yada, Japanese Consul-General in New York. He praised the efforts of the Jewish people for their own brethren, and said that he was pleased that the Jews appreciated what his government had done for the refugees who passed through his land on their way to America. The statement that Japan was happy to fight on the side of the Allies was greeted with great applause.

The address of Mr. T. B. Hohler, counselor of the British Embassy at Washington, created a marked impression, as did that of Mr. Lester L. Schmare, American vice-consul in the Far East.

Mr. Louis Marshall congratulated the society and Mr. Mason upon the splendid work that had been accomplished, and stated his readiness to be of further help in the work that is yet to be done in behalf of the Jewish emigrants in the Far East. He made an urgent appeal on behalf of the Fourth Liberty Loan, and as a result over \$20,000 in bonds were subscribed for immediately. The Yiddish address of the evening was delivered by Mr. Jacob Massel, the honorary secretary of the society, who spoke in detail of the work accomplished by Mr. Mason, and stated that what had been done showed that the organization was on guard to protect the Jewish wanderers everywhere. He closed by expressing appreciation to Mr. Hohler for the Balfour declaration.

Albert Lucas Religious Classes.

On Sunday, October 6, the Albert Lucas Religious Classes commenced their twentieth year of work in two of the largest synagogues of New York City. For nineteen years these classes, organized by Mr. Albert Lucas, have been laboring on the East Side, counteracting the efforts of missionaries and imbibing the Jewish boy and girl with Jewishness and Judaism. The schools are open on Sundays only. There is no tuition charge. The teachers who are highly capable and with years of experience give their services absolutely gratis.

At the Kalyvarea Synagogue, 11 Pike street, twelve classes in Hebrew and in Jewish history were started in the charge of the following: Morris Meister, principal; Anna Greenfield, Anna Charap, Rose Sperber, Florence Glickstein, Laura Glickstein, Sadie Wiener, Florence Brandes, Tessie Segel, Jennie Margolies, Della Fein, Helen Kirsch and Anna Kaplan.

At the First Rumanian-American Synagogue, 89 Rivington street, the classes were started in the charge of the following: Martha Wolf, principal; Dora Wolf, Sophie Margolies, Tillie Machenofsky, Rose Kramer, Celia Frost, Lillian Kohler, Esther Jaffe, Ray Jaffe and Minnie Goldman.

Parents are requested to send their boys and girls from 7 to 16 years of age to be registered in these schools at once.

CORRESPONDENCE.

An English Critic on President Wilson.
Editor HEBREW STANDARD:

The American Jewish press should promptly indicate its emphatic disapproval of the editorial note of the *Jewish Chronicle* of London in its issue of September 26, in which it refers to the reply of President Wilson to the Austria peace note as "hasty" and "unthought out," and fears that it "played directly into the hands of the Prussian military party." It also expressed the hope that the allies "will do something to obliterate the crudities of the American lightning diplomacy."

I trust that Jews of sense and position in England will repudiate these mischievous statements. We in America know how utterly foolish and absurd they are and how totally they misconceive the spirit and the manners of either the President or the Secretary of State, who, quite aside from questions of ability or intellect, are equal in breeding and polish to statesmen anywhere. We thought Germany and Austria had acquired the monopoly of the old sneer about "shirt-sleeves diplomacy."

As to the fear that the President's reply to Austria would play "directly into the hands of the Prussian military party," let the subsequent note of Germany make answer.

The London *Jewish Chronicle*, by reason of its former position as a gatherer of news and an organ of Jewish opinion, from which it has, unhappily, been declining ever since the death of Asher Myers, ought to realize that it still has some responsibility for the welfare of the Jews of England and of English-speaking lands; that its highest function would be the binding of the Jews of English-speaking lands together, and not of using every possible occasion for irritation.

As for its assumption to criticize President Wilson, "it is to laugh." The editor who takes a hurried glance at the troubled waters through his little periscope, and lets fly a hit-or-miss verbal torpedo can himself hardly believe that his vision is as clear as that of the pilot of a great ship of state, whose horizon covers the inhabited earth and whose sources of information are immeasurably beyond the tainted currents, whether they run underground or under-seas.

Accuses Priest of Russian Church in Salem of Instigating Attacks of Jews.

That the priest of the Russian Church of Salem, Mass., instigates the members of his congregation to attack the Jews, and that he, personally, heard

him use the words "down with the Jews" in the course of his sermon, is the assertion of a certain Mr. Golub, himself a Christian, who does not believe that the church is a proper place for spreading anti-Semitic propaganda. Mr. Golub, who does not want his address published, asserts that while in Salem over Sunday, he happened to walk into the Russian Church and heard the priest call upon his audience "to revenge themselves on the Jews." After the sermon, Mr. Golub says, he had an interview with the anti-Semitic priest, and asked him whether he considered it proper to use a church for such un-Christian propaganda. The priest refused to discuss the matter with Mr. Golub, on the ground that he was "defender of the Jews."

The Zionist Organization of Russia received a contribution of a million rubles, which is to be used for the purpose of building a sanitarium in Palestine. The name of the generous contributor is not known. The work of building the sanitarium will start in the near future.

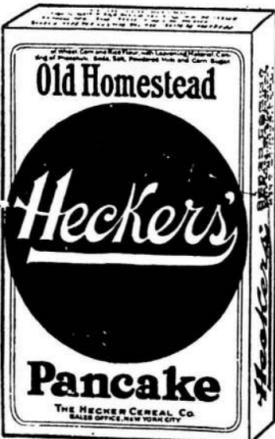

Who Are the Welfare Workers.

Combining many functions—that are all summed up in the word service—the welfare worker, whether he wears the uniform of the Jewish Welfare Board, Y. M. C. A., Knights of Columbus, or any of the other war work agencies, is part of a group that is as democratic as the army itself.

The welfare worker comes from varied spheres of activity, sacrificing personal advantage to patriotic service. Twenty-nine per cent. of the Jewish Welfare Board field workers were earning \$2,100 a year and over before entering Jewish Welfare work.

More than twenty-five different professional and business activities are represented by the workers of the Jewish Welfare Board. The school teaching profession gave 13.2 per cent. of the men in the service.

Of the group 61 per cent. are native-born Americans and 35.9 naturalized, with 3.1 per cent. declarants. Of the naturalized American citizens 27 per cent. are Russian-born and 12 per cent. of other foreign countries.

The ages of the men range from fifty-seven down, with 63.5 per cent. between twenty-one and thirty-one and 30 per cent. above thirty-one.

The roster of welfare workers includes representatives of twenty-two States. New York leads with nearly 57 per cent. of the men.

Listed according to religious home training it was found that 32.2 per cent. of the men are affiliated with reformed Judaism and 33.9 per cent. each with Orthodox and conservative.

Sixty-six per cent. read Hebrew and 54 read Yiddish. Nearly 80 per cent. of the men speak Yiddish and 24 per cent. have been leaders of religious schools.

Free Synagogue Social Service Department.

The plans for the social service department for the year have been formulated, and in addition to the various groups and classes to be conducted by Dr. Sidney E. Goldstein, director of social service, a number of important conferences have been planned and will deal with two important themes: "The Adolescent Boy and Girl in Wartime: Characteristics—Physical and Mental; Dangers—Moral and Industrial," and "The Unmarried Parents and Their Child; the Unmarried Mother and Employment; the Unmarried Father and the Law; the Illegitimate Child and Its Rights."

Echo's From Plattsburg.

On October 2, Beth Israel Temple Sisterhood of Plattsburg, N. Y., held a well attended and interesting meeting. The chairman of the Welfare Committee reported that nearly one hundred young student officers were entertained during the New Year and Yom Kippur holidays, each member entertaining two, three and some even more young soldiers in home surroundings.

CHILDREN'S PAGE

"THERE SHALL BE NO PLAGUE AGAINST YOU."

Dear Children:

Liberty, the first precious gift that the Lord gave Israel, was to be celebrated by them in the following manner: Israel was told to eat the flesh of the paschal lamb on that night when the star of freedom first shone for them. "Es habasar" "the flesh," says Rashi, "but not the tendons and bones." "Almerorim" "with bitter herbs" every bitter herb is called "maror," in remembrance of "Vaymoreru es chayciem." They made their lives bitter. "And thus shall ye eat it, with your loins girded," as if ready for a journey. "And ye shall eat it in haste," "it is passover unto the Lord," therefore shall ye eat the paschal lamb in haste, to symbolize the haste in which the Holy One, blessed be He, passed over the houses of the Israelites which were amongst the houses of the Egyptians, leaping from one Egyptian to another, and allowing the Israelite that was between them to escape unscathed. Therefore perform ye these commandments for the sake of heaven with celerity to properly signalize its name which is called Passover. "And I will pass through the land of Egypt," as a king who passes from place to place, and as he passes through in one instant they are punished (Mechilta). "And I will smite every first-born in the land of Egypt," even the first-born of other nations that happen to be in Egypt. And whence do we infer that the first-born of the Egyptians who were in other countries were also smitten? From the verse in Psalms which says "To him that smote Egypt with their first-born" (Psalms 136) "both man and beast." They who first sinned were punished first. "And against all the gods of Egypt will I execute judgment." The wooden idols rotted away. The metal idols melted and were poured forth upon the earth. "I will execute judgments: I am the Lord," I myself and not through a messenger. "And the blood shall be to you for a token upon the houses where ye are." To you for a token, but not to others for a token. From this we learn that the blood was sprinkled only within the houses. "And when I see the blood," everything is revealed to him, but said the Holy One, blessed be He, I will keep my eyes upon you, and seeing that you are fulfilling my commandments I will pass over you. "And there shall be no plague against you to destroy when I smite others in the land of Egypt." "Velo ichyeh vochem nefel," "against you there shall be no plague," but it shall be against the Egyptians (Mechilta). Thus, if an Egyptian was in the house of an Israelite do not think that this caused him to escape "velo ichyeh vochem nefel" against you there shall be no plague, but it shall be against the Egyptians in your houses. Or if an Israelite was in the house of an Egyptian do not think he would be punished also. Therefore the Torah tells us "velo ichyeh vochem nefel." "There shall be no plague against you." "And this day shall be unto you for a memorial for future generations. "And ye shall celebrate it as a feast unto the Lord." The day that is a memorial unto you that day shall ye celebrate, but as yet we have not heard what day is a memorial. Hence the Torah tells us (Exodus 13): "Remember this day on which ye came out from Egypt," hence we learn that the day they went out is

the memorial day. And on what day did they go out? As it is written, "On the morrow after the Passover." "Offering they went out." Thus we learn that the fifteenth day of Nisan is the feast day, for on the eve of the fifteenth they partook of the paschal lamb and in the morning they went out (Mechilta). "Throughout your generations," not the least of the plural "generations" which is two, making us think it is to be celebrated for only two generations. Therefore it is said, "As an ordinance forever shall ye celebrate it." "Seven days shall ye eat unleavened bread" and elsewhere the Torah tells us "six days shall ye eat unleavened bread." Hence we learn that on the seventh day of Passover it is not incumbent upon us to eat unleavened bread as long as we do not eat any leaven, and how as it inferred that the other six days of Passover it is also optional with us to eat unleavened bread, so long as we do not eat any leaven. Therefore the Torah tells us here "seven days" in order to teach us by the principle of the Torah that if anything is included in a general proposition and is then made the subject of a special statement, that which is predicated of it is not to be understood as limited to itself alone, but is to be applied to the whole of the general proposition. Thus, just as it is optional to eat unleavened bread on the seventh day, so it is optional to eat it during the six days, but we must not think that it is also optional on the first night of Passover, for it is written, "At evening shall ye eat unleavened bread." Thus the Torah established it as an obligation upon us. "But on the first day ye shall have put away leaven out of your house." That means the day preceding Passover, and "rishon the first" really means "the previous day," for we cannot think that it means on the first day of Passover, as it is written "Thou shalt not offer the blood of my sacrifice with leaven," you shall not offer it whilst the leaven is yet on your premises (Mechilta). "for whosoever eateth leavened bread, that soul shall be cut off from Israel."—Hana fesh hahu, "that soul," meaning when one eats it with the knowledge and consent of his soul, but not when one is compelled to do so "from Israel," one should not think that it means he will cut his soul from Israel and go to another nation, for it is said elsewhere "from my presence," and the Lord is everywhere. "And on the first day there shall be a holy convocation. Sanctify it by better food and drink and holiday attire (Mechilta)." "And on the seventh day there shall be a holy convocation to you; no manner of work shall be done on them," even through others. "Save what is eaten by every man, that only way be prepared by you." "Hu levado," "that only" which the Israelites must eat: "hu levado," "that only" which is necessary to prepare on the holiday, but not that which may be prepared before the holiday. "Lechal nefesh," even to the animals in your care, but it is not permissible to cook on the holiday for non-Jews. "And ye shall observe the unleavened bread," if the unleavened bread is in danger of becoming leavened while baking it, smear it with cold water and thus fulfill the commandment. And ye shall observe. Rabbi Yoshiah said, "do not read 'ushmartem as hamatzos,' but 'es hamitzvos.'" "Ye shall observe the commandments" just as you must not let the bread be-

A VOICE IN CONGRESS IN DEFENSE OF THE FOREIGN-BORN CITIZEN.

BY JOSEPH L. TEPPER. WASHINGTON, D. C.—One of the most unfortunate developments of the war in the United States is the attitude of suspicion and distrust by a large part of the population towards the foreign-born citizen in general and the unmistakable hostility and prejudice towards the German-born citizen in particular.

Positive proof of this assertion is not wanting. Shortly after we assumed belligerency Congress passed what is known as the "trading with the enemy act," which required in part that every foreign-language newspaper published in the United States must have translations made of all matter it contains dealing with the war or any phase of it, or if it could convince the Postmaster General at Washington of its loyalty, he could waive that requirement by the issuance of a license. In itself it probably is not an unreasonable requirement during war times. But the fact that only foreign-language newspapers were singled out and placed under the purview of that act, without discrimination whether these newspapers are German and fairly under suspicion or such as French, for whose people we plunged into the conflict, was a gratuitous insult to the foreign-language press.

Aside from this law, the interferences by the postoffice with the foreign language press were many and, in some instances, very irritating. Early in the history of our belligerency I happened to talk to one of the editors of a great cosmopolitan daily published in Italian. It was just at the time when Italy suffered her worst defeats of the war during the great Austrian drive, and naturally every Italian's heart was bleeding. They welcomed this country's entrance into the war and regarded us as their saviors. Said the editor: "We know America is the best friend of our people and we do all we can to arouse among them their patriotic fervor. This morning I received a number of requests from Washington to print appeals for Liberty bonds and other war enterprises and, of course, we responded cheerfully giving all the space requested of us and appeal to our people to do their utmost. We do only what our duty dictates and expect no thanks. But, at the same time, we should not be regarded with sus-

picion and hindered by petty annoyances. For three days our paper was held up and all my time was taken up with statements and with running here and running there." This instance is typical of what most foreign-language publications had to contend with during the first period of the war. Now things are more or less stabilized and the authorities have learned to separate the sheep from the goats. Still, comparatively recently, a great New York daily printed in a foreign tongue an item from an English contemporary, without, as far as it could be ascertained, any similar rebuke to the English newspaper with whom the item originated.

This treatment by Congress and the Postoffice is merely a reflection of the national temper. Numerous inflammatory speeches were made in both houses of Congress against the foreign-language press, literature and their institutions, urging their repression by legislation. The sponsors of this policy are some of the most renowned statesmen in public life. Outside of Congress these evidences of ill-will and prejudice are not wanting, either. So conspicuous a public man as Theodore Roosevelt, himself an ex-President, has time and again in the most incendiary fashion urged the total suppression of every means of public expression by the foreign-born citizen by means of arbitrary and drastic legislation. It should be mentioned, however, that Roosevelt's agitation may be considerably discounted because of its vehemence. His flamboyant and demagogic utterances of late have done much to forfeit the respect and prestige they formerly commanded and in more than one instance were the cause of rebukes from officially-inspired utterances at Washington.

But perhaps the keynote of the national psychology towards the immigrant citizen is struck in a judicial utterance by United States District Judge Charles F. Amidon at the time he pronounced sentence on Rev. John J. Donatana in North Dakota on August 15th last. So well did he epitomize the sentiments of Congress that a few days ago his entire address was ordered to be reprinted in the Congressional Record from The Outlook, and thus made a public document. The following excerpt from that ably-constructed delivery is significant and an ominous warning of the cleavage that may be looked for between native and immigrant citizens who heretofore formed a polyglot but homogeneous nation.

"When we get through with this war and civil liberty is made safe once more upon this earth, there is going to be a day of judgment in these United States. Foreign-born citizens and the institutions which have cherished foreigners are going to be brought to the judgment bar of this republic. That day of judgment looks more to me today like the great Day of Judgment than anything that I have thought of for many years. There is going to be a separation of the sheep from the goats. Every institution that has been engaged in this business of making foreigners perpetual in the United States will have to change or cease. That is going to cut deep, but it is coming."

Amidst this dismal atmosphere the speech of Congressman D. V. Stephens in the House several days ago is like a ray of sunlight on a bleak morning. It somewhat lifts the heavy mist of misunderstanding and ignorance that shrouds the American of foreign birth. Space will not permit the reproduction of his entire address. But note the contrast in the spirit of admiration and confidence in the immigrant citizen in the following lines abstracted at random from his speech to the spleen and venom in that of Judge Amidon's, both of which found an echo in the halls of Congress: "When the war came upon us our many-hued citizenship fused at white heat into the American type and shouldered arms and started for the front. They were Celt and Teuton, Slav and Latin, Greek and Syrian, black and red, sons of all the people making up our citizenship in that great army of liberation that set out under the Stars and Stripes to prove that our government was not a pretense, but in fact one conceived in liberty through the blood sacrifices of our forefathers. One can fancy the spirit legions of Washington leading our boys of today on the battlefields of France. It is a marvelous spectacle to see these adopted sons of many lands offering their lives for the defense of our common country. There are a few disloyal here and there, but they are not confined to any particular group. Such disloyalty is due either to ignorance or a deliberate purpose to serve Germany. This is found as often among old American families as it is among foreign-born citizens."

With logic and justice entirely on his side, Congressman Stephens points to this truism that has so little recognition by the native element, namely, that America is itself an immigrant nation. Its settlement and civilization is young and there is no one but that he can't trace his ancestors who migrated here to some foreign land. He might also have justly added that America owes her greatness to her immigrant population which in the final analysis includes all of its population. Those who came here left because of either, social, political or economic oppression. Obviously, the weak, unaggressive and the timid did not risk the change and by the well-known process of natural election, only those that were daring, brave and sturdy of nature ventured the separation from the family and community moorings. The spirit of fairness and courage of Congressman Stephens in thus coming to the defense of the misunderstood

and abused immigrant citizen, at this crucial time, is beyond praise. Nor can it fairly be attributed entirely to the ulterior purpose of attracting the large number of foreign-born voters in his district. A speech of this sort just now is a double-edged weapon. It loses for the author perhaps more votes than it attracts. He ought, therefore, to be given full credit for desiring to rectify a great injustice to millions of our fellow-citizens.

And when one stops to ponder at the source or cause of this inimical feeling towards the immigrant citizen of the United States, one is completely at a loss to grasp its justification or even a pretense of an excuse for it. The history of the great war is not so old as not to remember the strong current of pacifism in Italy, France and England have had to deal with; the shocking intrigues and disloyalty that were uncovered in France during the trials of Bolo Pasha, Senator Humber and others; the fact that in Canada, Ireland and in New Zealand, all English dominions, conscription has not been enforced owing to the opposition of large elements of its population, in one instance, that of Canada, the opposition of one province, Quebec. Likewise, the labor troubles here were much less than in England. All told, our war machinery worked much smoother and accomplished more relatively than that of any of the nations we are allied with. That, I confidently assert, was made possible primarily because of the whole-hearted solid support of all the people, native as well as foreign born, of this polyglot nation.

True, there were spasmodic instances of shocking outrages by renegades, but these were not all foreigners, and I repeat, England and our other allies who are considered homogeneous nations, had more of such outrages. It is time that our super-patriots realized, like Charles of Spain several centuries ago who could not make several of his clocks keep the same time, that it is infinitely more difficult to make millions of people think alike. And if a few out of a multitude of immigrants do not measure up to the task of citizenship, all the others should not come under the ban of disloyalty. The same indictment can be properly laid at the doors of the dyed-in-the-wool American citizen. It is important that we Jews insist upon that point of view.

Hannah Lavanburg Home Turned Into Hostel for Soldiers.

The Hannah Lavanburg Home was founded by Mrs. Oscar S. Straus and Mr. Fred L. Lavanburg in memory of their mother for the care and protection of immigrant girls upon arrival in this country, providing a home for them, finding suitable employment until such time as they become self-supporting. After this stage, they still remain under the guidance of the social workers of the home, and enjoy all club privileges, such as dances, entertainments, etc.

These activities have now been transferred to the Hannah Lavanburg Annex, 11 Livingston Place, for the duration of the war. Mr. Fred L. Lavanburg has taken over the entire direction of the original Hannah Lavanburg Home and has personally equipped the same. He is now prepared to give seventy-five to one hundred men (soldiers, sailors and marines) a bed, coffee and rolls for 25 cents each, and these facilities will be augmented very shortly. He will also maintain a few reading and writing rooms and entertainments at night in a large assembly room facing Stuyvesant Park. Mr. Lavanburg will be assisted in the management by Mrs. Oscar S. Straus, Mrs. Roger W. Straus and by Miss Ada Loewy, one of the social workers.
