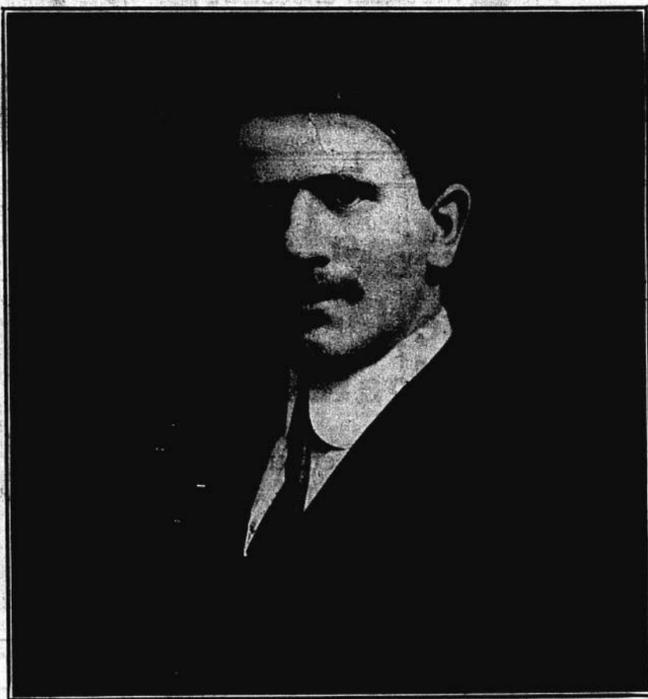

NEWS FROM ENGLAND.

Big Development of Zionist Press in Great Britain—The Michelham Will—Dr. Pazmanik on Russian Jews and Bolshevism—A Jewish National Concert at Famous British Seaside Resort—Anti-Semitism and Reaction in Budapest.

London, Sept. 5, 1919.

The establishment of the Zionist headquarters in London will bring in its train the appearance of a number of new periodicals providing the latest official news and views about the movement for the establishment of a Jewish national home in Palestine. The first of these, the "Zionist Bulletin," has already made its appearance. It is a weekly, issued both in English and Hebrew, from the Central Office, and it is circulated among all the Zionist federations throughout the world, as well as among official bodies and institutions. The former official organ in Hebrew, "Haolam," which was first issued in Cologne, and afterwards in Vilna and Odessa, and then stopped by the war, is to be revived here as a weekly.

More general interest will likely be attached to a monthly journal, the "Jewish Commonwealth," which will reflect the policy of the Zionist administration, and will contain articles dealing with all the broader aspects of the Jewish situation. "Palestine," the organ of the British Palestine Committee founded in Manchester, is to be enlarged and placed upon a commercial basis in view of the greater importance that will henceforth attach to Palestinian affairs.

The will of the late Baron Michelham (of the Stern family of bankers) has been sworn at ten million dollars "so far as can be ascertained at present." Having spent large sums of money during his life on charitable purposes he says he does not make any allocations to charity in his will, but leaves it to the free wish of those who benefit by their inheritances.

Dr. Pazmanik, recently delegate for the Jews of the Crimea at the Peace Conference and a medical man of high repute (specializing particularly in diseases of the brain) has been describing the position of the Russian Jews and Bolshevism. He estimates that there are about two million Jews in Bolshevist Russia and as they belong in the main to the so-called bourgeois classes they have been completely impoverished and economically annihilated. Many communities have been destroyed. Hebrew school and the Hebrew press are prohibited and Zionism is forbidden. The Bolshevist Government refuses to allow money to be subscribed for the maintenance of the synagogue, with the result that the rabbis and synagogue officials are without salaries. He declares, however, that there are no pogroms under Bolshevism and that is one reason why Jews do not struggle so much against Bolshevism in Russia. Conditions in the Ukraine are terrible, however, in this respect. Pogroms that have taken place there put in the shade any that have occurred before in all Jewish history. Dr. Pazmanik declares that the Polish pogroms are child's play compared with those in the Ukraine. At least 40,000 Jews have lost their lives. In one town in three days over 5,000 Jews were massacred and pogroms have taken place in all the towns of Ukraine.

Dr. Pazmanik believes in Denikin and Kolchak, although anti-Semitism, he said, is strong in Denikin's army owing to the lying stories of Jewish sympathy with Bolshevism based on the participation of individual Jews in the movement. Dr. Pazmanik adds also that Zionism has made enormous strides in Russia, where it is the beacon light of the Jewish masses. The yearning, he says, for emigration, especially to Palestine, is enormous. All the old Jewish parties in Russia have now settled down into two main divisions, the Zionists and the Socialists, and the Zionists claim at least 70 per cent. of the Jewish population. They are solid against Bolshevism.

One of the most popular beach resorts in England is Blackpool, in Lancashire. This is thronged throughout the vacation season by especially enormous crowds of visitors and is perhaps particularly well known for its vast numbers of holiday making mill hands. It gives support during the season to every class of amusement and entertainment and its musical offerings are always of a very high order. This is why it is perhaps

interesting to mention that in the Winter Gardens at Blackpool last week a special Jewish national concert was given in aid of charity. Whilst arranged in part for its strong musical interest it was also strictly national, and had the ambition also of a creative and contemporaneous vitality. The main work was a sonata for violin and pianoforte by Boris Levenson, a Russian Jewish composer who has been in Holland, and whose music has obtained some vogue there during the war.

Special interest was added to the performance of the sonata by the reappearance in it of Benno Schonberger, who some years ago was quite a lion in the London concert rooms. The sonata, as is not infrequent with Jewish music, scarcely aims at a high degree of passion, but is content in the fine Mendelssohnian sense, with an easy polish, elegant artifice and a lively poetic fancy. One can hardly recall any other music which so successfully vies with Mendelssohn in his own way. The models in the conception are in the solo movement, not Mendelssohn's himself, but Brahms', and in the rapid writing, the more advanced rhapsodic style of such writers as Medtner. It appears itself rather a subconscious quality of the work that is so finely and distinctly Mendelssohnian.

The touch of Schonberger was marked by a most liquid tone and style which set off the melodic beauty of the opening movement most exquisitely, and his metriculous brilliancy of execution displayed advantageously the composer's abounding artifice in the conciding movement.

The songs also contained a beautiful lullaby of Levenson, and the singer was Mme. Slava Karsavina, of the Petrograd and Moscow opera and the wife of the composer. But Jews, as well as other folks have their folk songs and also a pleasant style in singing them, and one that can be carried over into their original composition, as was amply illustrated in her last set of songs. All Mme. Karsavina's singing was marked by a freedom and breadth of style which displays the Jewish manner at its best, resulting in it possessing at least something of the classic power which Wagner denied it. The ecclesiastical style of the famous cantor Dr. Guzman was often beyond the range of appreciation of the non-Jewish members of the audience, except that they admired its freedom and wholly musical vigor.

A special correspondent in the "Manchester Guardian" in Budapest sends a message dealing with the rival party groups in that turbulent city and also with some weird Jew-baiting scenes. He says that Clemenceau's announcement, which brought the Archduke and the Friedrichs Government down with a crash, put consternation into the hearts of the White Terrorists and anti-Semites, who feel power slipping out of their fingers. A panic excitement prevailed among reactionary elements on receipt of the news. The castle was besieged by all sorts of deputations, organized by parish priests and Christian Socialists, anxious to plead for the Archduke before the Allied generals. The pleas were often nakedly anti-Semitic, urging that if the Archducal regime were overthrown the country would fall into the hands of the Jews of Budapest.

"When I visited the castle," says the correspondent, "in the forenoon a deputation in the castle square was amusing itself with the hunt and torture of the Jewish rabbi and a few companions—helpless, respectable gentlemen who were being kicked and bludgeoned by the deputation. The agonized cries of the rabbi must have been clearly audible to the generals in the room above the square. I watched the frank demonstrations of delight on the part of the priests accompanying the deputation at these proceedings.

"The incident illustrates the naive mentality of the supporters of the Archducal regime. They have not the least idea that what they do is abhorrent to Western civilization minds. It should not be forgotten that the Archducal coup and the consequent terrorism and pogroms have been carried through by a gang of the old regime, officers working in conjunction with the more ignorant section of the priesthood. The worst legacy of the Archduke's brief and dishonorable usurpation of power is the well-organized and widely established anti-Semitic Christian Socialists' party. To the disgrace of this nation it is now so much a force to be reckoned with that decent people whose stomachs are nauseated by anti-Semitism confess to the necessity of including Christian Socialists in any Coalition Government, if only to put a check on anti-Semitism, on the principle of setting a thief to catch a thief. Anti-Semitism is not deeply rooted in Hungary. It is largely the artificial creation of this detestable government, toward which the Entente has shown excessive patience.

The Unity Congregation has sold the Lenox Avenue Unitarian Church property at the northwest corner of Lenox Avenue and 121st Street, this city, a brick structure, on plot 50x80. The purchaser is the Pike Street Congregation (Kalvarier Synagogue), which will use the property for a synagogue.

Sholom Asch Describes Suffering in Vilna.

"The terrible insecurity, the dreadful fear, that reign in Vilna may be read on every Jewish face and in the eyes of every Jew one meets on the city's streets."

That's the way Sholom Asch, Jewish writer and poet, sums up the tragedy of the life of the Jews in the city of Vilna, in a report made public by the American Jewish Relief Committee, telling of his investigations in Europe for the Joint Distribution Committee.

"Of the 60,000 Jews in Vilna, more than 20 per cent. are refugees who had been expelled from Kovno early in the war," he reports. "All of these require help. Altogether 20,000 registered as in need of relief and of this number at least 10,000 are totally dependent.

"People's kitchens are maintained by the Jewish Committee and support is also received from the city administration and the children's home. The committee is functioning very successfully, to the satisfaction of all parties. At Rabbi Rubenstein's I met representatives of all Jewish parties as well as representatives of Jewish labor, such as Niger and Dr. Shabad, all working harmoniously; but they lack the funds to relieve even a part of the misery."

The writer was accompanied by some of the American Mission officers who were detailed to investigate conditions, and in discussing the general economic condition in Vilna, and the circumstances to which many once wealthy Jews have been reduced, he cites the following incident:

"Desiring to have the American officers intimately acquainted with the Jewish representatives in Vilna I had arranged with them to dine at a private Jewish home. I counted on many of my friends, whom, I knew, had been very rich before the war; but in all Vilna, even among the richest Jews, I could not find a single family in position to invite the American officers for dinner. When I made the proposition to one of my friends whom I knew to have been very rich before the war, he reddened with embarrassment and muttered something, shamefacedly, about his house being in the hands of the military. I received similar replies from others. I noticed that they wondered at my naivete. And finally I was compelled to take the American officers to a public restaurant for dinner."

The dread, the uncertainty of what the morrow may bring, was reflected, the report says, in the faces of the members of the Relief Committee, including Dr. Yankov Wigodsky, Dr. Shabad, H. Gordon, Yankov Sheskin, Jaffe (the Zionist), and Niger, the last two of whom had been arrested with A. Weiter, the writer, and all of whom he met at the home of Rabbi Yitzchok Rubenstein.

Americanization Program Launched by Council of Y. M. H. and Kindred Associations.

As an experiment, the Council of Y. M. H. and Kindred Associations, through the co-operation of the Associated Y. M. H. A.'s of New England and its Committee on Americanization and Naturalization, is launching in New England in the cities of Boston and Brockton a program of Americanization.

While at the beginning the program will necessarily be confined to the teaching of English to foreigners and the organization of classes and groups in naturalization, it is ultimately hoped that classes in the fundamentals of ordinances and laws affecting the immigrant and classes which will intend to teach such persons their right under the law. Secondly, that groups to receive legal advice, specialized groups such as trades people and others will also be organized. The person in charge of this work in New England is Mr. Coleman Silbert, who has for many years been active in the Jewish communal work of the Y. M. H. A. The general secretary of the council, Mr. Samuel A. Goldsmith, is projecting this program.

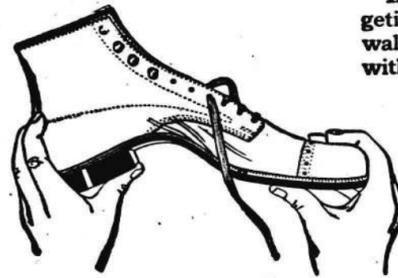

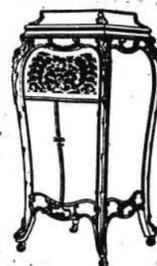

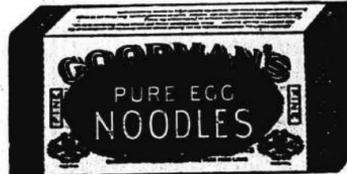

ITEMS OF INTEREST IN THE JEWISH WORLD

A massacre of Jews occurred at Peraslav (Ukraine), in the course of which 326 Jews lost their lives.

A City Council has been formed at Minsk, in which three Poles, three Russians, and three Jews participate.

The Bolshevik Government of the Ukraine has dissolved the Red Shield David Organization, proclaiming it a Jewish reactionary institution.

The leaders of the Jewish masses in Lettland have submitted a memorial to Parliament demanding national-personal autonomy for the Jews.

Rabbi Hyman Levin, for the past ten years in charge of a congregation at Lancaster, Pa., has accepted a call from Congregation Ohev Sholom, Lewiston, Pa.

Jewish residents of Pittsfield, Mass., members of the Congregation E'nai Sholom, dedicated their first synagogue last month. The synagogue accommodates 300 persons.

A new orthodox congregation has been established by residents of the north-west section of Detroit, Mich. Rabbi Harry Z. Gordon has been called to head the new congregation.

At least 2,000 visitors are expected at the annual convention of the Associated Young Men's and Young Women's Hebrew Associations to be held in Providence, R. I., on October 10-13.

In response to the petition of the Jewish deputies, the government has released 16 Jewish hostages who were arrested at Brody after the occupation of the town by Polish troops.

A campaign is on foot to secure the Democratic nomination for President next year for Senator Atlee Pomerene. The campaign is being managed by Maurice F. Lyons, of Covington, Ky.

Israel Maizlich of Lynn, Mass., has arrived in Iowa City, Ia., to assume his duties as instructor of mathematics in the University of Iowa. Later on he will receive a professorship from that institution.

During the recent holidays Dr. Emanuel Schreiber conducted services in Trinidad, Col. Dr. Schreiber for years occupied pulpits in Chicago and in New York, and at one time was editor of the Occident.

M. Krasny, Ukrainian Minister for Jewish Affairs, has announced that his government has decided to execute all rioters who participate in massacres of Jews, and to support all sufferers by pogroms.

The municipal elections at Lida, Poland, resulted in a great Jewish victory. Of the twenty-four seats, sixteen were secured by the Jews. At Troki, seven Poles, four Jews and one Karaites, and at Novovileisk, three Jews were elected.

Mr. Friedrich Ernst, a member of the Executive of the Pest Orthodox Community and President of the Bikur Cholim Society, was assaulted in the streets by policemen. He was so brutally injured that he died seven days after the assault.

Congregation Beth Isreal at Berlin, N. H., has dedicated a new synagogue and at the same time installed Rev. David Aaronson as Rabbi. Rabbi Aaronson, who is a graduate of the Jewish Theological Seminary of America, is the first English-speaking minister in the section.

A series of Sunday morning addresses will be instituted by the Congregation Har Sinai, Baltimore, Md., during the coming season. There will be little ritualism, the main emphasis being on addresses to be delivered by men of national prominence.

Polish police almost succeeded in driving Noah Prilutzki out of Chetchnek on the ground that he was an alien, but the former Jewish Deputy proved to the officials that under the conditions of the Peace Treaty which Poland had signed he was a Polish citizen, and he was allowed to remain.

Rabbi Nahum Ash, of Chenstochow, was assaulted in the street on his way to the synagogue by a soldier who insisted on cutting his beard. Fortunately, a French officer appeared on the scene and saved the Rabbi from this outrage. The soldier was arrested.

On Sunday, October 5, the Congregation Beth Ha Medrosh Hagadol (Rev. C. Hillel Kauvar, Rabbi) laid the cornerstone of its new synagogue at Denver, Col. At the same time work was commenced on the Bessie I. Rude community building adjoining.

The Clairmont Parkway section of the Bronx is to have a large synagogue and Talmud Torah, according to the plans of the Bronx Talmudical Society which has just purchased the building at 171st street and Washington avenue for \$85,000; \$65,000 has been appropriated for necessary alterations.

The Jews of Budapest have formed a guard to protect their coreligionists there against pogroms. Five hundred men were enrolled. A group of Jewish officers has appealed to the War Ministry to suppress the anti-Semitic rioting. The Minister promised to take measures against the pogrom movement.

The authorities of the Kozenitz district issued an order providing for the expulsion of all Jews residing on peasants' land in the villages. The Jewish deputies sent a request to the Ministry to cancel the order, which contradicted the terms of the peace treaty and constituted a revival of old Russian methods.

During the recent fighting between Denikin's forces and the Bolsheviks for the possession of Odessa, the great synagogue in that city was completely demolished. This is reported in the local Jewish paper, "Heint," which also tells that anti-Semitism has assumed a serious aspect in Odessa.

Architects have filed plans for a synagogue to be erected for Congregation Beth El of Borough Park, Brooklyn, on the southwest corner of Fifteenth avenue and Forty-eighth street, on a plot 100x120, to cost \$350,000. The building will be surmounted by a large Gstaad-vino dome and will have a seating capacity of 1,500.

Five Jews were successful at the Boston (Mass.) primaries. Louis Orenberg was nominated for the House from the Fifth district, Coleman Silbert in the Sixteenth and Elihu D. Stone was renominated in the Nineteenth district. Hon. Simon Swig was renominated for State Senator in the Eighth and Senator Samuel B. Finkel in the Ninth Senatorial District.

The new \$700,000 home of the Daughters of Jacob, in 167th street near Finlay and Teller avenues, the Bronx, will open by April, 1920, according to an announcement by the directors of the home. The structure will be five stories high, will cover an entire block and will have accommodations for 600 inmates. The new house will be the largest of its kind in the city.

On the occasion of the visit of Mr. Paderewski to Rawa a banquet was organized in his honor and Rabbi Echiel Moses Rappoport was among the guests. The rabbi welcomed the Premier in the name of the Jews and wished him success. Mr. Paderewski, in reply, appealed to all to stop the conflict between the Jews and Christian Poles. He then conversed with the rabbi, and cordially shook hands with him.

Mr. Morris Alexander, M.L.A., of Cape Town has been appointed a king's counsel. Mr. Alexander has had a distinguished career. He studied at the South African College and afterwards at Cambridge University, where he graduated with first class honors in law. He is a leading barrister in Cape Town and a representative of that city in the Legislative Assembly. Mr. Alexander some years ago married a daughter of the late Prof. Solomon Schechter of New York City.

Herman W. Kastor, who died at St. Louis, Mo., last month at the age of 81, was the founder of the large advertising agency which bears his name. Kastor, who was born in Bavaria, came to the United States in 1855 and served in the Civil War first as corporal and later as lieutenant. After the Civil War Kastor settled in Kansas City and began the publication of the first German language newspaper in that section.

A demonstration of railway workers took place recently in Vienna. The procession, after halting at the Foreign Office, marched through the principal streets of the city. Some of the demonstrators bore banners on which were inscribed the words: "Away with the Jews." Insulting epithets were applied to the Jews and the Czechs generally, and men and women whose physiognomy showed them to be Jews were greeted with abuse. The police intervened, but they were powerless to stop the insults.

Contributions to the Jewish National Fund in the months of July and August, 1919, amounted to 433,466 francs. The countries responsible for this result, arranged according to the amount contributed, are: North America, \$9,064; Argentina, 18,544 pesos; Germany, 120,786 marks; England, £1,359.9.10; Poland, 116,890 marks; South Africa, £826.18.10; Palestine, 406,542 E. P.; Galicia, 91,098 K.; Holland, 5,161 Hfd; Alsace-Lorraine, 10,699 Frs.; Tschechoslovakia, 29,309 K.; France, 9,291 Frs.; South Slavonic Lands, 48,472 K.; German-Austria, 39,910 K.; Switzerland, 4,372 Frs.; Singapore, £160; Italia, 6,509 L.; Belgium, 3,060 Frs. 786 Hfl.; Denmark, 2,071 K.; Greece, 3,035 Dr.; Canada, \$505; Egypt, £103.10.1; Estonia, 6,450 M.; China, £57.13.4; Australia, £2.

Rabbi Dr. Joseph Abrahams, M. A., Senior Minister of the Melbourne (Australia) Hebrew Congregation, has now definitely retired into private life after forty years of communal service. The position at Melbourne is the only pastoral charge he has ever had, he having received a "call" from London when in his twenty-eighth year. Dr. Abrahams has been an influential factor in the promotion of the spiritual welfare of Melbourne Jewry, and a pillar of support to the various communal activities that have come under his control or patronage.

Mount Nebo Temple Notes.
The registration of children for the religious school was completed last Sunday and over 400 children have so far registered. A staff of trained and efficient teachers has been engaged. Rabbi Eiseman is arranging to inaugurate a Hebrew school to meet every Wednesday afternoon. Classes will begin work immediately after the Sukkoth Festival. The Sisterhood, as usual, is arranging the Sukkah and a committee is soliciting fruits, cakes, flowers, etc.

The Sisterhood will inaugurate its season's work with a membership meeting on Monday afternoon, October 6, at 2 o'clock. A social hour will follow the meeting and refreshments will be served. Mrs. David Goldfarb is president. The membership in the Sisterhood is continually increasing. It now numbers 375 women.

The demand for pews in the Temple during the holidays was so large that chairs were placed in every available space to accommodate those who have affiliated themselves with the Temple. The trustees deeply regret that they were unable to fill the demand since many were unsuccessful in obtaining pews.

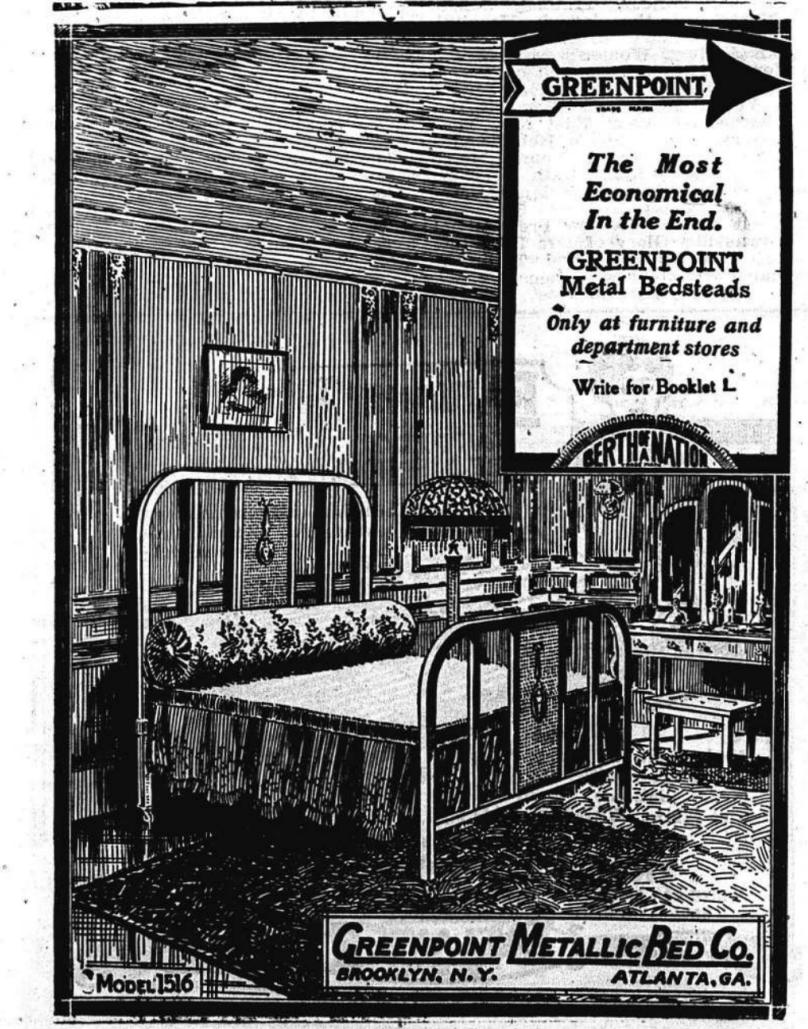

Beth Moses Hospital Nearing Completion.
 The borough of Brooklyn will soon

have another hospital and one moreover, of which the inhabitants of that borough will have much reason to be proud. The Beth Moses Hospital now in course of completion at the corner of Stuyvesant avenue and Hart street, will, according to a statement issued last week, by Mr. Alexander L. Shluger, the executive director, be opened to receive patients on January 1, 1920.

The Beth Moses Hospital, whilst strictly conforming to the Jewish dietary laws, will be a non-sectarian institution and in the admission of patients no distinction as to race or creed will be made.

"The Beth Moses Hospital is to be a great public institution," in the words of Mr. Shluger. It will have 150 beds, but there is sufficient space left to erect another wing for an additional 150 beds, so that ultimate capacity will be 300. Then there will be a dispensary for out-door patients and ambulance service.

The neighborhood in which the Beth Moses Hospital is situated is thickly populated. Within recent years the number of people in the district has increased greatly so that the building of a hospital has become an absolute necessity.

Up to the present \$300,000 has been expended and another \$150,000 will be needed before the hospital is opened. With this subject in view a 10,000 membership drive has been begun. It will last one month.

The officers and members of the Board of Directors are well known communal workers and have given their money to make the Beth Moses Hospital movement a success.

Big Day Scheduled for October 12 at the Farm School.

Preparations and arrangements for the twenty-second annual Succoth Harvest Pilgrimage, which will take place on the grounds of the National Farm School, Bucks county, Pennsylvania, on Sunday, October 12, are well under way, and the event is eagerly looked forward to by hosts of friends of the school.

Brief addresses will be made by the guests of honor of the occasion, including the Governor of our State, the Hon. Wm. C. Sproul; Hon. Isaac Johnson, president judge of the Delaware County Court, and president of the State Board of Public Charities; Hampton L. Carson, Esq., president of the American Bar Association and former Attorney General of Pennsylvania; Dr. Felix Adler, founder and president of the Agricultural Society and professor in ethics, Columbia University, New York. Brief annual reports of the school's work will be presented by Doctor Krauskopf, president and founder of the National Farm School, and by Prof. Bernhard Ostrolenk, director of the school. There will also be an election of officers and members of the Board of Directors, and an award of prizes will be made to the students for progress and efficiency in the various branches of the school's work.

After the program of exercises is completed the visitors and guests will be afforded an opportunity to visit and inspect the 475 acres which comprise the school's grounds, all of which have this year yielded record crops, due to the high state of cultivation of the land. All of the work on the entire farms is done by the students of the school, who, during a three years' course of instruction, receive, entirely free of all cost to them as to tuition, board, lodging and other necessities, a thorough training in the practice and science of agriculture in all of its various branches. There will also be a specially arranged exhibit of the products of the farms, and the visitors will, likewise, be given an opportunity to inspect the various buildings on the school grounds.

A special train will be run from Philadelphia to Farm School on that day, leaving Reading terminal at 10 o'clock in the morning, and stopping at all way stations as far as Jenkintown; returning from Farm School at four o'clock in the afternoon.

30,000 Homeless Jewish Refugees Wandering About as Result of Novgorod-Volinsk Pogroms.

WARSAW (By I. J. P. B.).—A Jewish delegation which has arrived here from Novgorod-Volinsk has furnished a list of horrifying details about the pogroms which occurred there recently.

Not a single Jew remains in the town. Thirty thousand Jews who fled in terror of further outbreaks are wandering about homeless on all the roads leading from Novgorod-Volinsk. They are suffering for want of food, and hundreds are dying as a result of a typhus epidemic which has broken out among them.

In the first of the two pogroms in Novgorod-Volinsk, 500 Jews lost their lives. There is no way of determining how many were killed in the second pogrom, but the number of victims is known to be very large.

The horrors perpetrated in those two pogroms have scarcely been equalled before. Aged Jews, inmates of the Homes for the Aged, were murdered; masses of Jews, even little children, were buried alive. All the streets were littered with Jewish victims, dead and wounded.

THE MORGENTHAU COMMISSION.

An interview with Jewish leaders in Vilna. (Haint No. 184, August 12, 1919.)

Of the interviews I had in Vilna with different Jewish leaders concerning the general situation and the commission of Morgenthau, the following are the most characteristic:

Dr. Shabad.

The president of the Jewish community in Vilna, Dr. Shabad, said: "I believe that the commission of Morgenthau hardly will be of any use. The principal drawback, according to my opinion, is that the leader of the commission is a Jew. In order to manifest his impartiality he might be inclined to kick the beam too much to the other side. I must also object that one and the same persons are both the examiners and the peace makers. The task of the commission should have been first of all to find out the truth about the pogroms and leave it to other people to find the remedy to heal the wounds.

Speaking with Mr. Morgenthau one has the impression that the principal thing is to fight against Bolshevism and therefore it is necessary to create a strong Poland not weakened by inner conflicts and frictions. It seems therefore that the commission was sent not only for the Jewish cause; at any rate that is the impression one gets, but perhaps I am mistaken."

Dr. Shabad said that he was very much astonished at the way Mr. Gibsonson could make a report about the events in Vilna, where he only spent a few hours. He did not make any inquiries nor could he do so, having been nearly all the time in the company of Poles, who invited him to a banquet. He had, indeed, a short discourse with a few Jews, but least of all he touched upon the question of the blood-stained days in Vilna.

Dr. Shabad then spoke about the detailed declarations of Dr. Bogan and the sitting of the board of the Jewish community in Vilna with regard to his signing of certain reports. Dr. Bogan categorically denied all the accusations directed against him in this affair.

Advocate Finkelstein.

"The only thing I hope Mr. Morgenthau will do," said Advocate Finkelstein, "is that he will publish all the material we have submitted to him. This alone will be sufficient to point out the character of the events in Vilna. I hope that Mr. Morgenthau, even if he should try to take the sharp edges off" will not keep the material for himself.

"The discourse with Mr. Morgenthau convinced me that the inquiry produced upon his mind an impression of horror. However, I am not familiar with his character and therefore I do not know how long this impression will last.

"People say that Jews are inclined to exaggerate. Mr. Morgenthau told me that, after what he had learned, the damages of Salkind were much less than \$900,000, as stated by him. But there the question arises whether the robbed goods, the value of which formerly was not so high, might not now cost even more. Morgenthau also examined the commandant of the prison in the Dominican street. The commandant denied that he had summoned Miss Margulis several times a week to an inquiry between 12 and 1 o'clock in the night, that he had kept her eight days without food and then gave her herring and no water to drink. Mr. Morgenthau believes the commandant. I really don't know why we should not believe Miss Margulis. She might be a little bit nervous, but I do not think she is capable of telling lies, at least that is the impression she gave me.

"We have submitted to Mr. Morgenthau the witnesses and protocols about 64 cases of murder and 1,600 cases of robbery. According to our opinion this is only a small part of the cases which happened, especially in the first days when the Poles entered Vilna. But even the above material should be sufficiently convincing. The principal thing is how people were killed and how people were robbed."

As the man who had to deal many years with the Lithuanian-Jewish relations, Advocate Finkelstein expressed his deepest conviction that a prosperous future is awaiting the Jews in Lithuania. Jews represent now 15-17 per cent. of the population. Already they occupy many important positions in the service of the State, though they do not yet master the Lithuanian language. Besides M. Solovevitz, who is the Minister for Jewish Affairs, there are two Jewish vice-ministers, Rosenbaum and Dr. Rachmilovitch, as well as other high Jewish officials. The relations between the Jews and the native population are very good and steadily improving.

Dr. Jacob Wygodski.

The old Jewish leader and Zionist, Dr. Jacob Wygodski, said the following:

"It surely could have been better, but we should keep in mind that after the first information we received about the commission we were afraid that Morgenthau, that, owing to the Jewish Polish conference on the initiative of Namolovski, the friendly relations should be restored and that we have nothing more to do than to shake hands and to acknowledge Mr. Morgenthau

Now that the great autumn holy days have come and gone we hope our people will not forget the synagogue during the remainder of the year. They say here and there that only during the *yomim noraim* have we a thought of the synagogue. Let us disprove by our acts this glib opinion.

Rabbi Nathan Krass owes it to this community to prepare and publish without delay a complete account of his recent European trip. Not only did he see and hear much that is of Jewish interest on this journey; his experiences were both useful and valuable in the great cause of Jewish relief.

This country as well as Great Britain is beholding a periodical recrudescence of anti-alien agitation: Such afflicts us every little while, with the same stock arguments advanced by advocates of this dangerous form of propaganda. Now, however, it should be made clear and plain that this agitation spells a positive disservice to the republic. This fact were clearer if a period of economic stress were now to exist.

Bigotry and intolerance are the signs of danger in the career of a nation or a people. Where they or either of them exists worse evils are sure to be felt. Bigotry and intolerance invade every department of life and engulf all sections of the population in their degrading influence. In the presence of sentiments like these religion ceases to elevate and ring true, men forget the calls of duty and the people gradually but inevitably sink into savagery.

The Federal Council of the Churches of Christ in America proposes to combat race prejudice in the United States, and to this end has just issued an appeal on behalf of the negroes. We find this effort to put a stop to the strained relations between the races highly commendable, and suggest that the Federal Council of the Churches of Christ in America extend the scope of its work of this nature by appealing to the Christians whom it serves to cease entertaining sentiments of prejudice against the Jew. If this be done we promise that Jews will do as much—and more.

Hilaire Belloc may be right in his prediction that a day of tragedy for the Jews of the world because of their "conspiracy" to exploit the peoples of the earth by means of their "cosmopolitan internationalism" is near at hand. In the present crisis of Europe, if not of the world, it were no wonder if Jews became, as so often previously, the scapegoats on which the sins and ills of humanity were loaded. If this be the part Jews are to play, it will result from that conspiracy which the anti-Semites through their own cosmopolitan internationalism are industriously propagating. In this pernicious activity Belloc himself plays the part of the high-priest.

We read in a recent bulletin of the Free Synagogue of Washington Heights: "It is highly possible that, in response to a wide demand, a Saturday morning service, with sermon, will be inaugurated." As this is the uptown Manhattan division of the famous fane launched some dozen years ago by Dr. Stephen S. Wise under the slogan, "Not to innovate but to renovate," with the traditional Jewish Sabbath entirely discarded, does it not look as if we have in this announcement from Washington Heights a confession of defeat? In the spirit of "renovation" the Free Synagogue transferred bodily our Sabbath to Sunday. After many years of trial of this "innovation" a wide demand for a Saturday morning service is discovered. Further comment is superfluous.

We ask the indulgence of our readers for the appearance of the current number as well as the two previous issues of The Hebrew Standard. At present there is a strike on in the printing industry, and we have been compelled to go to press on Mondays, and have greatly curtailed the size of our publication. We do not know how long existing conditions will continue, but until the atmosphere does clear up, we ask the forbearance of our subscribers.

THE AUSTRIAN MANNER.

ALL eye-witnesses of the incident agree that Dr. Karl Renner, the chancellor of the new Austria and the head of the Austrian delegation to the Peace Congress at St. Germain-en-Laye, signed the portentous document which sealed the fate of the outworn monarchy with a smiling countenance and with an unctuous friendliness which disarmed his late enemies. This is typically Austrian.

Austria being no longer the buffer state in Central Europe, having no interest in the outlying sections of the discarded monarchy, remembering that her capital city has been the scene of a malevolent and degrading persecution of Jews by petty municipal officials through several decades, orders the Jews of Galician origin, but residing within her actual though circumscribed confines, expelled. Moreover, the Viennese rabble attacked the Jewish quarter of Vienna presumably to display ocularily the significance of the published decree. All this, too, is typically Austrian.

We do not much distinguish between a Polish pogrom against the Jews, with its turbulent scenes of carnage and misery, and an Austrian proscription of a section of its Jews entailing pitiful distress and abject despair for the proscribed. There is no distinction between these manifestations of a deep and unreasoning hatred against Jews. Only Poland is a new country in the political sense, and the present-day members of its ancient race bear the same reputation concerning their orderliness as their ancestors. Austria is a land possessed of a government which reaches back to a respectable antiquity and which has always prided itself on its absolute, ordered impartiality toward the representatives of the different races under its sway.

The wretched Austrian decree which has produced such immediate, unfortunate consequences ought to be revoked speedily and completely. If the present government of Austria proves refractory in this regard the supreme councils of the Peace Conference, which are still in session at Paris, should pull a laboring oar for the right. If Paris but give the word the smiling Dr. Renner will complacently hasten to accede to even the slightest requirements of the case.

Prominent dignitaries of the Protestant Episcopal Church seem to agree that the declaration, to the effect that a million-dollar fund for the "Americanization" of the Jews is to be raised within this denomination, was unfortunate. American Jews, whether recent immigrants or the offspring of numerous American-born forbears, need no Americanization. They are, always were, and ever will be good and loyal Americans. Doubtless Episcopalians intend the money to be used for proselytizing purposes, since their denomination harbors a few of the "knightly" *meshummodim*, who must be provided with jobs and chances to spend the superfluous wealth of rich but misguided parishioners. Against such a blatantly egregious "drive" for souls Jewry is able to defend itself, as the Episcopalians responsible will soon learn (unless, indeed, previous attempts in this interesting direction have taught them).

Concerning the presence of Jews in Japan in times past there has been considerable doubt. But the existence of several small but active communities in the island kingdom at the present day is absolutely authentic, these having mainly originated among the Russo-Jewish prisoners of war brought to Japan during the struggle with the Czar some ten years ago and remaining in their new environment on its conclusion. The Japanese Jews seem to be contented and, curiously enough, their marriages with Japanese women have resulted in the wives adopting Judaism and faithfully fulfilling the requirements of our traditions. Indeed, the Japanese Jews have unfolded a proselytizing activity that is as uncommon as it is remarkable. Even now they are not altogether without hope that the great masses of the population will adhere eventually to the religion of Israel. If such a result be accomplished we shall see in modern Japan a new kingdom of the Chazars.

Poland cannot be heard in support of reservations to the treaty signed by her representatives at Versailles and guaranteeing absolute freedom of opportunity to all the inhabitants within her borders, for the simple reason that she has formally accepted all the privileges and the responsibilities conferred on her by this instrument. To permit Poland at this time to engraft reservations on the treaty would be to alter illicitly an existing contract to which she has solemnly declared her adhesion. On the other hand, Roumania has not yet accepted a treaty which provides for satisfactory guarantees in respect of their civil, political and religious rights in the case of her minority races. So far as the latter, therefore, is concerned reservations may—though we sincerely hope they will not—be made. Roumania, however, bears an unenviable and thoroughly discredited reputation for her acceptance of treaties, and in her case it is possible—nay, probable—that the dawn of complete equality for all her people has not yet broken. The new law of Roumania touching her Jews is apparently working out so unsatisfactorily that our gravest fears for the future well-being of Roumanian Jewry have been accentuated by recent occurrences.

THE TRUTH OF THE BOOTH.

"Ye shall dwell in booths seven days." (Lev. xxiii. 42.)

COME ye winds of autumn, blow through the rifts in my Tabernacle! And you Light of God, sift through every hole in the helter-skelter roof of my frail booth, and let my soul receive thy rays from sunshine and starshine! Sweet desolation of the year's decline, percolate through my being, and let my aspiration be to mingle my dreams with the floating gossamer and hold converse with the heartening Spirit of the Indian summer! Slowly, gently, with a sigh in the russet leaves of the forest and a murmur in the glistening waves of the river, these days subside into the coming drear of the winter: yet all is joyous, calm, in a helpless but not hopeless sort of way; and Nature dances to her death in her gay many-colored costume.

I wonder what this Spirit, this genial Presence is, whom I feel in the air, and whose breath brushes my cheeks these Fall days? I am sure he is very old, and I can tell by his walk how loose his joints are. Still, he is not like any of the old men I know, with their dissatisfied countenances, their jaded look, and their fear of death lurking in the half-extinct eyes. In fact, his eyes are the eyes of a youth, his expression is that of a child: and I like particularly his laughter—it's so much like the chortling of an infant! I cannot understand this—this combination of youth and age, this intermingling of hoar and dew! This baby-man, or if you will, this man-baby—I have met him often in many moods and garbs; and he is always puzzling to me yet withal pleasing! The ancients called him Nature, and worshipped him and abused him in turns. They feared him and played with him: they were not much different from him! But they did not understand him.

I met him the other day while I sat on a high bluff overlooking river and mountain. He smiled at me his baby smile that spread over his flowing white beard. He was funny—yet the wisdom of the ages crowned his brow. And then I began to understand that Youth and Age are but human distinctions that count little with the vast creative Wisdom. And I called him Wisdom: Wisdom that was from of old, that is and will be! Wisdom that is born without a cry, and dies without a groan: that is born knowing, and dies in laughing innocence—an immense unconcern that makes and understands its own laws; that contains all and faces all; whose work appears like play and whose play is of tremendous seriousness. I believe that the joyous old Pagans saw in him only, or very largely, the playful infant of the whimsical moods, and not the Primal Wisdom all-sufficient and all containing. Contrariwise, to see his seriousness and miss his play, was ever the fault of the ascetic, the devotee of the religion of gloom and doom. To misread nature means to read it either on the playful side or on the serious side exclusively: not to read it as it is—whole, entire, consummate. To read nature aright, on all sides, in its full-orbed character, one must be a Hellene and a Hebrew combined; one must have the Pagan joy of nature and the Semitic insight into moral values. One must see neither the baby nor the man, but the Baby-Man—the whole mysterious Presence.

And may it not be that the Feast of Tabernacles is just the symbol of this full-orbed Wisdom of the World? The toy-booth we build: too serious for mere play but too playful for its high serious purpose, is it not the very image of the World we live in, the Creative Paradox that blends laughter and lamentation into one harmonious song of Life? This Feast is undoubtedly rooted in the early naturalism of the Semitic race; and its character as a nature-festival it preserves even in its later spiritual development. But in and through it Nature becomes moralised, while Morality becomes naturalised. A divorce between nature and morality, or between Religion and the World, always ends in some mental and spiritual perversion; while the difficult union between the two spells True Religion. It spells Judaism. Under the frail festal booth, with its broken sides and incomplete structure, we can best understand the healthy spirit of our faith. A physical structure, not too closely built, so as to let in the far-spreading influence of Divine Wisdom—such is the Succah, and such is the meaning of the Festival of Booths.

Why should we build too hard, enclosing ourselves with false security, relying too much on mere materiality and shutting out the light and might of God? Our Tabernacle derives its strength from its weakness. If we conceive of our life but as a mass of man-made cautions and conventions, of deliberate protective provisions that hedge us about, we must soon learn of what little value these things are on the day of trouble. Still more clearly, if we look upon our body as our real being, we must ere long see that it is but a fragile tabernacle whose only purpose is to let God's light in. Our poor little body, this feeble frame of flesh, what is its worth as a mere work of nature? But how great is its worth as the work of God? Seven days we dwell in the Booth; seven decades we dwell in the body. And when we step forth from the Booth, what mysterious Spirit is this we meet abroad, in the dying autumn? And when we step forth from our abode of flesh, what Great Presence will greet our enfranchised soul?

Nothing is so beautiful as the slow subsidence of autumn days. Nothing is so exalting as the slow subsidence of human lives. And though at the ebb of the tide of life men of little faith fear the future, men of Wisdom face Eternity with ready heart. The kiss of God is upon him, whose last sigh issues from smiling lips. . . .

Behold, God has kissed the fading forest into beauty. Leaves are falling. Lives are falling. All is well in His world.

Jews in Korea.

Mr. Kwanyong Li, a member of the Korean Peace Delegation in Paris, has given to a Jewish interviewer some interesting information concerning the Jews in his country. They are not numerous, but there has long been a Jewish colony in Seoul, the capital, the members of which, in language, in attire and in features, are fully assimilated to the Koreans. They are only distinguished from their neighbors by their names. Most of the Jews are engaged in commerce and are highly regarded as being extremely capable merchants. The Jews enjoy complete equality of rights and take their share in the service of the state. Among them are army officers and privates, magistrates, government officials, doctors and teachers. Anti-Semitism is absolutely unknown in Korea.

MUSIC NOTES.

Mr. Josef Hofmann will give his first recital of the season in Carnegie Hall on Saturday afternoon, November 22.

Mr. Reinald Werrenrath will open his New York season with a song recital in Carnegie Hall on Sunday afternoon, November 2.

Jascha Heifetz will make his first appearance for the season with a violin recital in Carnegie Hall on Saturday afternoon, October 25.

Miss Sophie Braslau will open her concert season with a song recital in Carnegie Hall on Sunday afternoon, November 9. Prior to that date she will sing nine performances of Amneris in "Aida" on the fall tour of the Chicago Opera Company.

Samuel Gardner's first recital of the season will take place at Aeolian Hall to-morrow (Saturday) afternoon, October 11, at 3.15 o'clock.

While still undergoing the process known to us as youth, Mr. Gardner has already made for himself a name among American composers. In 1918 he won the \$1,500 Pulitzer prize for composition. The Flonzaley Quartet conducted his orchestral tone poem, "The New Russia," twice at the Stadium concerts, and he appeared also as soloist. At present Carl Fisher is publishing his fourteen violin pieces.

Mr. Gardner will include in his Aeolian Hall program two of his own compositions. He will feature the Bruch D Minor Concerto also.

Leo Ornstein, at his first recital this season on Saturday afternoon, October 18, at Aeolian Hall, will present an all-modern program, the feature of which will be his own composition, "Poems of 1917," played for the first time here. This suite, written in Ornstein's neo-impressionistic style, is based on the composer's subjective reactions toward the World War. This epic conflict stirred him to the depths and fanned the spark of inspiration into a flame of creative effort.

These poems are miniature tone pictures of different phases of the terrific conflict that invaded an entire world. On his transcontinental tour last year the suite created a mild sensation and was the main topic of discussion in critical music circles.

Debussy, D'Indy, Albaniz, Satie and Scriabine are the other names on an interesting and novel program.

More than 20 of the leading instrumentalists and vocalists who will appear in America during the coming musical season are on the list of assisting artists announced by the Philharmonic Society of New York. Heifetz, Kreisler, Serato, Spalding, and others equally well-known, are among the violinists who will appear with the orchestra this season, while the roster of pianists includes the familiar names of Rachmaninoff, Grainger, Novaes, Godowsky, Samaroff and Ganz, as well as that of the newcomer, Moiseiwitsch, who makes his American debut this winter at a Philharmonic concert. The society's programs also bring forward a group of prominent singers, among whom are Rosa Ponselle, Greta Masson, Marguerite Namars and Margarete Matzenauer. The complete list of assisting artists, which will be announced in detail later, has been so arranged for the Thursday, Friday, Saturday and Sunday series of Philharmonic concerts as to secure a satisfactory distribution of soloists among the various subscribers to the society performances.

The important violinists of the day, the real virtuosi of that instrument, are almost exclusively of the Jewish race. Those in the public eye, led by Elman and Heifetz, are natives of Russia. Now Rudolph Polk, a member of the Jewish race, but born in America of American parents, is about to make his first appearance in this his home country.

Mr. Polk, who is 24 years of age, received his fundamental instruction in this city under such men as Leopold Lichtenberg and Max Bendix. When sufficiently advanced, he placed himself in the hands of M. Henri Marteau, under whom he studied five years, during which period he had the honor of winning the distinguished "Joseph Joachim Stipend."

During the early stages of the war Mr. Polk concertized and traveled very extensively on the Continent of Europe, as long as he could possibly stay over there. He returned to America in time to don his country's uniform, and was honorably discharged early this year. As soon as he got out of the army he married a girl whom he had had his eye on for several years, a daughter of Mr. and Mrs. Adolph Stone of White Plains, N. Y. Immediately after their marriage the young couple went to California, where they occupied a bungalow and where he was able to prepare himself for his coming concert appearances, for during his eighteen months in the army he did not have much chance to play the violin.

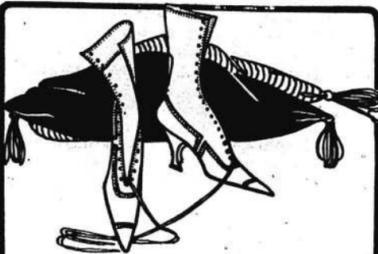
Those who have heard Rudolph Polk play predict a great surprise for the American public, and it is well known that Marteau regarded him as the most brilliant pupil he had during his entire career.

Salvini's Season Opens.
Activities at the Salvini School of Singing have already begun for the season at the attractive location, 206 West Seventy-first street. Private musicales will frequently be given,

while several special concerts in large halls will be included in the schedule. Mr. Salvini has some very promising pupils in his class, and in addition to developing their voices and imparting the fundamental principles of breath control, he dwells upon the importance of accurate phrasing and musicianly interpretation. Mr. Salvini believes that health is a most necessary requisite for every vocalist, and he advocates exercise and fresh air. He lives near Central Park, where he walks or rides on horseback, and his summer school at Edgemere, L. I., is in a beautiful environment. Referring to a recent suburban visit in the vicinity of greater New York he states: "The country was beautiful, the ocean in all its splendor. Myriads of lights over it made an aureole and the rhythmic beating of the waves seemed to sound a hymn to the glory and majesty of nature. I think the sea, with mysteries, depth and overwhelming power, is the most wonderful piece of creation." Samuel J. Pesoa died at his home in New York City last Saturday. Mr. Pesoa was at one time Grand Master of the Independent Order of Odd Fellows for New York State.

Dr. L. S. Rowe, late assistant secretary of the Treasury, and recently named chief of the division of Latin-American affairs of the State Department, is to succeed John Barrett as director general of the Pan American Union if the present plans of a majority of the Latin-American diplomats are carried out. It was learned today that the appointment of Dr. Rowe to the position in the State Department, which he assumed last week, is considered temporary, and he will occupy it only until the election of Mr. Barrett's successor is held.

Indescribable Suffering in Warsaw.
The tortures of the sick in Warsaw because of the utter lack of facilities in the hospitals there are described as terrible by Mr. Bernard Horwich, of the Joint Distribution Committee of American Funds for Relief of Jewish War Sufferers, in a report which reached the American Jewish Relief Committee headquarters here.

He says that the dispensaries, as well as the hospitals, are in a "horrible" condition, and that fully half the Jewish population of 325,000 is dependent on charity.

While the American Jewish Relief Committee is engaged in its series of State campaigns in this country to raise a total relief fund of \$35,000,000 for the coming year's needs, the stories of terrible conditions in Middle and Eastern Europe especially are rousing the campaign workers to redoubled efforts.

Warsaw's Jewish population furnishes but a single example of this great need for relief.

"At the beginning of the war," Mr. Horwich states, "the thousands of refugees that sought shelter in Warsaw were well cared for; but eventually the burden became too great, and this resulted in most severe suffering."

"Now twenty per cent. of the Jewish population is entirely dependent on relief, thirty per cent. is part dependent, while only fifteen per cent. can be classed as well to do, and those of the remaining thirty-five per cent., belonging mostly to the middle classes, are self-supporting."

"The severest suffering is among the former small merchants, their clerks and other employees. The former Jewish public office holders, who were discharged en masse by the Polish Government, are also in a pitiable condition."

"According to my information about 60,000 portions of soup are distributed daily by the public kitchens."

"For the purpose of distribution of the cash relief, and with a view to effecting reliable registration of the poor, the city is divided into eight districts with one central office. Each of the district offices supervises the distribution of the cash relief within the district limits, keeps a register of the poor receiving aid and a reliable record of all proceedings."

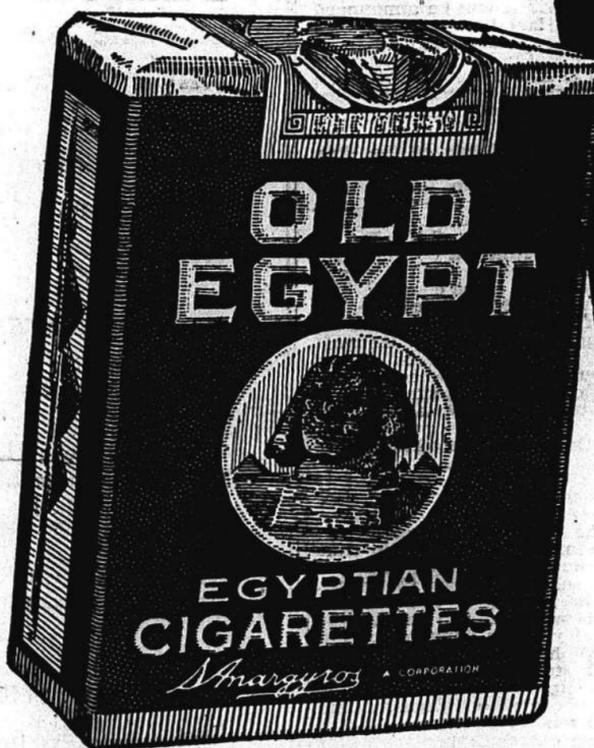

Entire Jewish Community Slaughtered
 in Hungary.
 BUDAPEST (By I. J. P. B.).—Every
 Jew in the town of Dissel, Hungary,
 with the exception of the rabbi, was
 killed in the pogrom which occurred
 there recently. Two Christians who
 lived with Jews were killed by mis-
 take. At the beginning of the pogrom
 the rabbi of the town was arrested on
 the charge that he had attempted to
 bribe soldiers to permit him to flee. He
 was later freed.
 Soldiers sent to put a stop to the
 slaughter themselves took a hand in
 the outrages committed upon the Jew-
 ish population. It is reported that two
 Jewish women drowned themselves
 rather than submit to the indignities
 forced upon them by the pogromists.
 In another Hungarian city, Topol-
 tcha, there also occurred a pogrom in
 which three Jews were killed and 30
 wounded. Almost 100 Jewish shops
 were looted, resulting in damages
 amounting to 40,000,000 kronen.

French Notables Protest Against Pogroms.

A cable received from Paris states that the Committee of Jewish Delegations at the Peace Conference has just made public a protest against the anti-Jewish pogroms in Eastern Europe in the form of an appeal to humanity which has been signed and issued by the foremost men of letters and leading public men of France. This statement bears the signature of such eminent names as those of Anatole France, Pierre Mille, Charles Seignobos, the historian; Henri Barbusse, Victor Marguerite, Michel Corday, M. Aulard, the historian; Emile Cambes, Prof. Larnaude, Albert Thomas, George Duhamel, Ernest Lavisse, of the French Academy, and many others of note.

This appeal was prepared by a number of public-spirited French citizens at the time when the delegates from the American Jewish Congress were still in Paris and co-operating with the Committee of Jewish Delegations. Since then the appeal was sent around to the various notables to have them attach their signatures. The dispatch from Paris shows that this work has now been completed. Mr. Bernard G. Richards, who was secretary to the delegation which represented the Jews of America, was able to give out yesterday the full text of this significant appeal, which is as follows:

In the name of human conscience, in the name of the moral responsibility of all men to their fellow men, the undersigned appeal to the people of the world, and especially to the people of France. A cry of despair and poignant sorrow comes to us from Eastern Europe; Poland, Lithuania, Ukraine, Galicia, Roumania; an entire people appeals desperately to us for help.

The Jews, who have lived in Eastern Europe since centuries, have become the innocent and pitiable victims of all the national, political and social strife.

The ambitious rivalries of governments and parties; all the sanguinary folly of civil wars have now been let loose on the unfortunate Jewish minority with a criminal frenzy.

Compared with the recent atrocities, the pogroms under the Czar, the massacre at Kishenev, were as the play of children.

In more than one hundred towns of Ukraine, frightful pogroms have been perpetrated and thousands of the victims perished under horrible torment.

In Bessarabia, occupied by the Roumanian troops, the military authorities tolerated the ignoble attack against the Jews. In Eastern Galicia a wave of pogroms followed the Polish invasion. In Lemberg the terror is at its height. The horrors of Pinsk, Lida, Vilna add a page of tears and blood to the tragic annals of Jewish history.

In more than a hundred cities in Ukraine terrible pogroms have been perpetrated and thousands of victims have perished. The most terrible days of inquisition have come back because the massacres are accompanied by the cruelest tortures and the most terrible physical and moral indignities. At Proskourou thousands of Jews have been massacred; at Fichtine, Jitomir,

In Ukraine pogroms are still going on and threatening the Jews with total extermination.

Millions of men, women and children suffer unspeakable distress and are exposed without defense to death or dishonor. Whatever the war has spared of the modest possessions of the Jews is systematically being pillaged and destroyed.

A whole people is threatened in its existence in the midst of civilized Europe and when the dawn of the new era gives to the world a charter of liberty and of justice. Thus do these crimes dishonor not only the people who commit them, but outrage the reason and the conscience of humanity.

The undersigned appeal to the people of the world and ask that they lift their voice against the unheard-of crimes of which a people under the heavens are victims.

It is necessary that there be forced committee for the defense of Jews in Eastern Europe and that these committees unite to prompt and vigorous action against the oppressors.

It is necessary that public opinion be aroused by the protestations of the masses and by the powerful voice of the press, at least truthfully and exactly informed.

Let all the representatives of the people in the parliaments of the world raise their voice against these bloody iniquities. The duty is incumbent upon the free peoples and the responsible governments to put an end to these monstrous violations of the rights of man.

We demand the immediate organization of the Committee of Defense, invested with all the authority which is proper for their high mission. The millions of oppressed Jews have no other safeguard but the united moral support of the civilized world, and they have placed their highest hopes in the sacred rights of man to life and liberty.

Lord Curzon Says England Will Keep Her Promises to Jews.

London (By I. J. P. B.).—Lord Curzon, in a conference about Palestine with Professor Weitzmann, declared that England intended fully to keep her promises to create in Palestine a homeland for the Jews.

To Weitzmann's statement that the masses of Jews who were supporting the Zionist aspirations were waiting anxiously for Palestine to be thrown open to them, Curzon replied that he understood their position, and suggested that upon Weitzmann's return after his visit to Palestine, he submit a report on the Jewish situation.

Prince Feisul also, in a recent talk with Professor Weitzmann, assured him that he wished to do everything in his power to effect a friendly understanding between the Arabian and the Jews.

Important Mizrahi Conference Held in North England.

In order to further the activities of the Mizrahi in the north of England, a conference of the North England District Council, which includes the various Mizrahi organizations of Leeds, Liverpool, Birmingham and Manchester, was held at Manchester. The conference was convened by Rabbi I. J. Yoffe, vice-president of the Central Mizrahi. Rabbi Yoffe opened the conference, and, among other things, emphasized the necessity for an official Mizrahi periodical which would keep Anglo-Jewry constantly informed of developments in the movement, and would inculcate a healthy literature with the true Jewish spirit spread among the Jewish masses.

It was resolved to establish a Mizrahi organ for England to be published monthly, and to contain articles in Hebrew, English and Yiddish. A literary committee was appointed to take the necessary steps.

At the suggestion of Rabbi Charney, it was decided to undertake the establishment of an English Mizrahi garden city in Palestine, to consist of about 300 members. The Mizrahi organization in Switzerland is about to open a Palestine Information Bureau for all those who intend to emigrate to Palestine. The bureau will aid those Jews desiring to settle in Palestine to reach the country without unnecessary delay, and will furnish information to all prospective settlers. Switzerland, on account of the facilities it affords for international communication, is considered an ideal place for the location of such a bureau.

A conference was recently held in Zurich between representatives of the World Mizrahi and the Agudas Israel organizations for the purpose of elaborating plans for united activity.

Mizrahi to Send Palestine Commission.

At a recent meeting of the Executive Committee of the Mizrahi Organization of America, it was decided to send in conjunction with the continental Mizrahi organizations a commission to Palestine, to make a general survey of the conditions there. The American Mizrahi Organization will have three representatives on that commission. Nine of the leading Mizrachists of this country have been nominated. The names of the nominees will be shortly submitted to a referendum by the Mizrahi societies, and the three polling the largest number of votes will be designated as representatives on the commission.

It is planned to have the delegations from the various countries arrive in Palestine simultaneously and conduct a joint investigation. Special attention will be given to the existing economic and cultural and educational conditions, and to the commercial and industrial possibilities of the land. The report of this commission will form the basis for the work of the Mizrahi for the general rehabilitation of Palestine and for the cultural and economic development of the country.

Isidor M. Heilbron, D.S.O., D.Sc., Ph. D., F.I.C., has been appointed professor of organic chemistry at Glasgow Technical Institute, Glasgow, Scotland. Dr. Heilbron, who is a native of Glasgow, has been a student of great distinction at the Technical College. He was awarded the James Young Exhibition, and proceeded to Leipzig. As a result of his work at the university there his exhibition was continued, and he took the degree of Ph.D. He was appointed to the Technical College staff in 1908, and is the author of several technical papers. Dr. Heilbron saw considerable service in the late war. He has held the rank of lieutenant-colonel, was a senior staff officer in the Salonika forces, and was three times mentioned in dispatches. He received the Distinguished Service Order in June, 1918; the Greek Order of the Redeemer in August, 1918; and the French Medal of Honor in July, 1919.

A New Cape Town Synagogue. The foundation-stone of a new synagogue at Claremont, a suburb of Cape Town, was laid recently by the Rev. A. P. Bender. The Rev. J. R. Broadhead, minister of the local Wesleyan Church, who was present at the ceremony, expressed his delight at the prospect of another house of prayer in their community. The ideals of the Christian and Jewish faiths, he said, were similar in their relationship to human uplifting, and he hoped that the Divine blessing would rest on their synagogue and its worshippers.

Appreciation.
Editor Hebrew Standard:—Your intention to publish short stories by Edna Ferber, the gifted writer, is commendable. This popular author will surely bring many pleasant hours into the care-worn lives of those of your subscribers who enjoy reading clean and realistic fiction. Enterprise and originality have placed your periodical in a position of leadership. However, leadership always implies responsibility. Your valued paper can do much to mould the Jewish consciousness of your readers. For this purpose, fiction with a Jewish background has lasting value.

Editors of Jewish periodicals should, therefore, encourage authors to write for Jewish publications. In that way there would be created a distinctly American Jewish literature and these editors would be fulfilling a moral obligation toward their readers.

What makes the Old Testament so fascinating? Its short stories about remarkable Jewish men and women. Ignorance is the chief enemy of the human race; therefore, fiction should be made not only interesting, but also instructive. Instruction (of a moral kind) is as much a basic element of fiction as entertainment. Perhaps that was one reason why Sahag Bartevatsi, in the fourth century, translated the Old Testament into the Armenian language. This wise scholar realized man's inborn craving for entertainment. I reaffirm, and with emphasis, that fiction is a valuable and a necessary commodity that strengthens our aspirations and is conducive to the growth of our most cherished ideals. No one can deny that a useful story which uncovers injustice (as "The Octopus" by Frank Norris) is as truly a force in humanity's progress as is steam or electricity. E. A. H. ENDRES.

The American Zionist Medical Unit.
Editor Hebrew Standard:
It is just a year today since the American Zionist Medical Unit arrived in Palestine and started to give their medical help to all poor people in Jaffa and the surrounding colonies, irrespective of race, religion or nationality.

When the unit arrived in Palestine they found in Jaffa not one reliable drugstore or a graduate pharmacist. Jamil Pasha laid his hands upon everything which he needed, and as medical supplies were a good article in wartime, he emptied out Jaffa of its drugs and proprietary articles, and under such circumstances it can be understood what a great help an institute such as a well-supplied drugstore with a graduate pharmacist has been to the population of Jaffa, as not only the poor, who received free treatment and medicines gratis, were the beneficiaries of this institution, but also the better class, who were willing to pay for medicine, were thankful to get their drugs for a reasonable price.

A few days after the drugstore was open the prices of medicine went down from 50 to 60 per cent., and the druggist who remained in Jaffa with a little stock of medicines which the Germans overlooked in their haste became cordial and less exorbitant in his charges. Frequently poor parents were obliged to take the pillow from under their child's head and pawn it to pay for a dose of castor oil or for preparing a prescription, and who knows how far the conditions would have gone had not the unit arrived with their help and supplies?

Three physicians were engaged for clinic and hospital work and two for district work, and the prescriptions were prepared free with the fresh medicines which the unit brought from the United States.

Until three months ago the drug department was located in Tel Abib, but now it is in the center of the poorer district populated by both Jews and Arabs. As the front was freed and an emigration started the unit opened a refugee hospital with twenty beds. At present Jaffa has a hospital of twenty beds and a clinic with four special physicians, including an eye specialist, two dermatologists and specialists for children and for adults. The average number of patients treated in the clinic is 200 a day and the number of prescriptions reaches an average of 100 a day. The chief pharmacist is Dr. Ch. Hausdorff a New York graduated pharmacist and analytical chemist, and as Mr. Hausdorff speaks Hebrew, Arabic and Spanish, the visitors at the clinic are facilitated in their visits. Mr. Hausdorff is well known in New York, where he kept a drugstore at 15 East 113th street, where the Jewish Sabbath and holy days were strictly observed. J. H.

Rev. Dr. H. G. Enelow, who recently returned from France after an absence of over one year was the speaker at the Friday evening services of the Emanu-El Brotherhood on September 26. There was an exceedingly large attendance of young men and women present, and Dr. Enelow took occasion to speak of a number of his experiences with the Jewish soldiers while in France, which proved to be very interesting.

Included in the new activities to be conducted at the Brotherhood during the coming season, will be a class in dressmaking, embroidery and millinery. These classes will be conducted in cooperation with the Board of Education. There will also be a class for those who desire to perfect themselves in reading and writing of English, which will be opened both to men and women. On Sunday evening, October 5, the Celestia Smokler Circle held a memorial service in memory of Miss Celestia Smokler who passed away a year ago.
